## **EXECUTIVE DIRECTOR OF VPC EARNED \$1.1 MILLION WHILE VETERANS REMAIN HOMELESS**

Here we Media Group-Community Newspaper has found through documents filed with the Internal Revenue Service that Susan C. "Sue" Young, founder and executive director of a controversial Brentwood non-profit homeowner's organization that claims to be advocates "honoring our veterans and preserving their land" has received more than \$1.1 million in salary while running the organization out of a posh office in Brentwood. Young, the only employee of a group called the "Veteran's Park Conservancy" (VPC), which is an outgrowth of the powerful Brentwood Homeowners Association, boasting some of the wealthiest and politically active people in the state, banked \$1,135,000 from 2002 to 2013, all while homeless Veterans sleep in front and are forbidden to enter the very property the VPC is "restoring for Veterans."

HMG-CN also determined after reviewing the records that the organization has changed its name and mission statement three times over the past two de-

Young previously oversaw the group called the "Veterans Garden Memorial Foundation." That foundation morphed into the "Veteran's Park Preserve," which was eventually renamed the "Veteran's Park Conservancy."

Documents show that Young contracted with a development firm Netzel Steinhaus & Associates to craft a business plan and conduct a development study. That study recommended that having "Veterans" in the mission statement severely impacted the fundraising ability of the organization, and they recommended Young "add family and community," which Young did later on.

"This does not surprise me," said longtime Veteran's right advocate Bob Rosebrock, "Young and her sham tax-evading organizations are not here for the Veterans, they are here to work for the 'Brentwood Elite.' You have wealthy people donating money to a non-profit to keep Veterans off the land while taking a tax deduction, it's despicable."

## La Mirada Theatre Sets New Sales Records

## AB 2621 Passes California Senate, Targets Child Care Center

A new law that would set a new standard for child care centers in California has passed a major hurdle in Sacramento this past week.

AB 2621, authored by Assembly members Cristina Garcia (D – Bell Gardens) and Kristin Olsen (R – Modesto) state that inspection reports and complaint information relating to child care centers must be made available online, has passed out of Senate Human Services Committee with a unanimous, bipartisan 4-0 vote.

AB 2621, as amended, Garcia, Section 1596.819 added to the Health and Safety Code, relating to child day care states:

"Under the California Child Day Care Facilities Act, the State Department of Social Services licenses and regulates child day care facilities. Existing law requires the department, when it conducts a site visit of a licensed child day care facility, to publicly post at the facility a notice that indicates whether the facility was cited for violating any state standards or regulations. Existing law also requires each licensed child day care facility to make accessible to the public a copy of any licensing report or other public licensing document that documents a facility visit, a substantiated complaint investigation, a conference with a local licensing agency management representative and the licensee in which issues of noncompliance are discussed, or a copy of an accusation indicating the department's intent to revoke the facility's license."

Presently, California law does not provide a resource for parents to find out

about inspection and complaint reports that have been filed against state-licensed day care, pre-school and after-school programs. If enacted, AB 2621 will allow easy access to a comprehensive representation of child care facilities by requiring the Department of Social Services to post confirmed complaints.

Attending the hearing was Julie Garcia, mother to Adam Dash, who was present to share the highly publicized story about her sons' death. According to news reports, Milena Nikodijevic, the operator of an in-home day care facility was sentenced to six years in state prison for the 2012 death of a baby Adam. Adam Dash, an 11-month-old baby, was left in Nikodijevic's care at her Burbank home

Open to girls of high school age, this esteemed award challenges a young


woman to make a difference in her community.

### **C**ERRITOS

Crime in Cerritos continued its downward trend this past week with 12 Part I crimes reported to the Cerritos Sheriff's Station, one less than the previous week. The following is a breakdown of crimes by category: no robberies; one aggravated assault; four residential burglaries; four commercial/ other burglaries; one grand theft; and two auto thefts. Deputies made six felony arrests, six misdemeanor arrests, six warrant arrests, and issued 97 traffic citations. The Sheriff's dispatch center also received 309 calls for service, considerably above this year's weekly average of 266 calls.

## New Summer I-5 Construction Dates Set For Norwalk

Norwalk - Caltrans will implement several construction activities and operations in mid-July on both directions of the Santa Ana Freeway (I-5). The work is part of the \$1.8 billion I-5 South Corridor Improvement Projects to widen the freeway and structures to add one HOV lane and one general purpose lane from the Los Angeles/ Orange County line to the San Gabriel River Freeway (I-605).

Listed below are ramps that will open and close, mainline lane shift locations, and other upcoming summer and fall 2014 construction activities.

Ramps to OPEN: Tuesday, July 15 at 6 a.m. - the southbound I-5 on-ramp at Norwalk Blvd./San Antonio Dr. Late Summer 2014 - the new, fly-over off-ramp at southbound I-5 at Imperial Highway. Ramps to CLOSE:July 8 - 11 and July 14 - 18, from 10 a.m. to 2 p.m. - the northbound I-5 off-ramp at Rosecrans Ave. will close on weekdays during daytime hours. (This ramp will fully close on 7/18 at 7 p.m. for an extended 55-hour weekend closure. See info below). Friday, July 18 at 7 p.m. to Monday, July 21 at 5 a.m. - Extended Weekend (55-hour) Full Closure of the northbound I-5 off-ramp at Rosecrans Avenue.



supporting the plan and President Sophia Tse, Vice President Lynda Johnson and Member Soo Yoo vocally opposing the plan.

Yoo and Johnson had attended a private meeting organized by Cerritos Mayor pro tem Carol Chen last week. HMG-CN learned from two sources that the meeting was held to craft a strategy to defeat the Master Plan and the Bond Measure.

The board also began the formal process of having a \$265 Million General Improvement Bond Measure placed on the upcoming November 4th General Election Ballot. Specific details about the bond will be on the next agenda of the ABC School Board on July 15 beginning at 7 p.m. at the District Headquarters at the corner of 166th Street and Norwalk Boulevard.

Superintendent Dr. Mary Sieu and Chief Financial Officer Toan Nguyen, as well as a cadre of consultants, touted the plan as a "working roadmap" that will help future district officials develop a long-term modernization plan at more than 30 campuses and other aged facilities that have not seen significant improvements in decades.

"In order to maintain outstanding student achievement and enhance the quality of education for all students, and to prepare students for the competitive collegiate and career markets of the 21st Century, the District must maintain, repair, upgrade, expand, and improve its educational facilities," Nguyen told the board and audience. "The Facility Master Plan is a long range planning tool to address the District's facility's needs, nothing more, nothing less, and can be changed, revised or altered at any time, by any future school board," Nguyen said.

"The mission of ABC Unified School District is to develop a great community of life long learners, creative thinkers, and responsible individuals by providing innovative and high quality educational programs in a safe and supportive environment. As a District we need to go from great to exceptional," Nguyen added during his comments.

Nearly 70 people testified before the board about the plan and many of them mirrored the position of Melissa Peterson, a resident of Cerritos, and who is an employee of ABC School District: "Tonight I speak in support of this plan. As a teacher, you feel valued here, but you can only do with have you have to deal with to help teach our kids in class. As a resident and taxpayer, this is going to affect me and my property taxes, but I totally support both the plan and the bond to pay for it."

Ben Ao, a longtime resident of Cerritos and critic of the ABC School Board said he was concerned that residents and voters were not properly informed about the plan or the details of the upcoming bond measure. "I was informed of this plan through private channels; sure better schools make better communities, but I want to caution the school board about transparency, and not doing anything behind closed doors," Ao said Cerritos resident Chung Fu said that the community was not properly informed about the Master Plan. "Look, 98% of the community doesn't know what's going on. You guys decided to put this master plan, before even informing the community. If we were at the World Cup you would get a Yellow Card and someone would be placed on a time out," Fu said. His comments got many chuckles around the crowded district office.

Cerritos Mayor Pro-Tem Carol Chen generated cackles from the audience during her series of comments that she made throughout the night.

It was exclusively reported last week in HMG-CN that Chen led a private meeting in her real estate office to prepare a specific strategy on how to defeat the Facility Master Plan. When it was Chen's turn to speak, she seemed unprepared and rambled past the allotted time, speaking nearly seven minutes.

Board Clerk Maynard Law admonished her for not following board hearing rules. When Chen continued, members of the ABC Federations of Teachers who were seated in the front row told Chen to "sit down and shut up."

Chen handed out a list of "concerns" and "suggestion" about the plan that HMG-CN confirmed was drafted after input with former Cerritos Mayor and relator Grace Hu, current Cerritos Councilman Bruce Barrows, and former controversial ABC School Board members Cecy Groom and Dixie Primosch and Matt Kauble who is a local Republican Party activist.

One Artesia resident who did not want to be identified said, "that list that Chen handed out was nothing more than talking points from the local Republican party leaders, every speaker who came up against the measure basically said what Chen handed out."

Also speaking in favor of the Master Plan was incoming Gahr High School Student Body President Lani LaCroix.

"Our classrooms are too cramped, and we don't have modern equipment at Gahr so it is hard for our students to show our true potential. I am going to be ASB President and I am here to support the Master Plan and to make sure that all of our students excel. Sometimes we need to shut off our air conditioning because we don't have enough electrical power to run our lights at the same time, this needs to resolve once and for all," said LaCroix.

### Johnson Lashes Out

It was past 2 a.m. on Wednesday morning, ABC School Members were still meeting, and tempers were flaring.

However, several hours earlier, Board Vice President Johnson took nearly 40 minutes to pepper questions to school administrators and consultants about the plan that she ultimately voted against.

Johnson told HMG-CN on Wednesday afternoon that she "had a lot of questions about cost expenses, and other concerns, and yes it was a very long night."

Johnson said that she was "not happy" with the district "for not being transparent with the community" about the details of the master plan.

> "Look, we have architects looking into the matter and planners and engineers and when you don't get community support for a master plan you won't get support for the bond," Johnson said.

> Johnson also defended her participation with Chen, Hu, Groom, Primosch, and Yoo at a private meeting where details of the master plan were openly discussed using paperwork that was not public records at the time.

"We all have the right to do what we believe is the best in being able to represent the community and to hear different points of view, and this particular meeting was no exception," Johnson said.

Johnson did not indicate if she would be supporting or opposing the bond. "We all need to hear from the community about the bond, and everyone needs to be heard," she concluded.




the Beverly Hills/Hollywood NAACP and received recognition for Community Service from the city of Long Beach.

accepted campaign loans and bribes in exchange for devaluing property assessments on multi-million dollar parcels.


However, many believe that his court appearance could end up being a short public appearance and they the case could be formally delayed for several additional weeks.

## Inexperience overcomes Artesia Punishers 16-Under squad in Champions Cup

IRVINE-When the travel ball season began last September, the Artesia Punishers team coached by Armando Canizales was a 14-Under squad. But over the past few months, the team was playing in a couple of 16-Under tournaments.

One of those tournaments was the Amateur Softball Association's Champions Cup and while the Punishers won two games in pool play action, they were no match for the (Fullerton) Cal A's, coached by Crystal Aguirre, this past Sunday in a 4-1 defeat at Harvard Park. It marked the end of a frustrating four-day tournament that saw the Punishers commit 19 errors in seven games, including five against the Cal A's.

"On the defensive side, we struggled," Canizales said. "The girls are actually a second-year 14 team coming up to play 16's, which is very critical. At the 16year-old division you can't make the mental mistakes our young team made. It was tough to see them break down that way. But it's something I hope to work on and grow out of it in the near future."

The Cal A's scored in the top of the second inning as Hailee Desmond dou-

bled and scored on a single from Amanda Melodia. It was 2-0 in the next inning after Alexis Honeycutt scored on an error and the Cal A's increased its lead to 3-0 in the fifth on a triple from Warren High School's Megan Narvaez, plating Eryka Springer of Mayfair High School.

The Punishers avoided being shutout when first baseman Attie Landrum (Sunny Hills High School) doubled to the center field wall and came home on a double from centerfielder Amanda Canizales (Whittier High School). Ashley Armas (John Glenn High School) went the distance, scattering seven hits and yielding two earned runs. Four of those seven hits came in the final three innings.

"Ashley's performance this weekend was wonderful," Armando Canizales said. "She's come a long way in the last three months. Her speed, her velocity, her control...I'm speechless on her pitching coming along the way it has."

The Punishers were limited to six hits with right fielder Elisa Peralta (Santa Fe High School) going two for three. Three hits came from batters from the top four in the batting order. Peralta was in the sixth spot while the other hit came from pinch hitter Sierra Eddy (Wilson High School), who batted eighth. "The top of the order is a little healthier than the bottom of the order," Armando Canizales said. "We couldn't make a small adjustment on the drop ball from the other pitcher. We couldn't put hits together. That was the thing. The bottom of the order needs to come up."

The Punishers began pool play action last Thursday with a 9-1 loss to the Orange County Batbusters as Ashley Machado (Warren High School) drove in Alexxis Ponce (Santa Fe High School) in the bottom of the fifth. Later in the day, the team bounced back for a 9-3 win over the (San Marcos) Southern California Breakers as Armas went three for three, scored twice and hit a home run while Allison Castro (Yorba Linda High School) hit a three-run home run

Last Friday, the Punishers blasted the (Oakdale) OBS Monarch 6-1 behind a second straight 11-hit attack. Amanda Canizales went three for four with a triple, a run scored and two RBI. Armas and Ponce each had a pair of hits. But the (Bellevue, WA) Blast did exactly that later in the day in an 11-5 conquest. The Blast scored six runs in the top of the first but the Punishers answered back with all of their runs in the bottom half of the inning.

Last Saturday morning, the Punishers

tied the (Las Vegas) Rage 3-3 with all three of their runs coming in the bottom of the first inning. Armas and Amanda Canizales each picked up two hits and scored once. Then in the afternoon, the Punishers were pummeled by the (Central California) Dirt Dogs 16-3 with all three runs once again coming in the bottom of the first. Devany Esparza (Bellflower High School) had a solo home run while Amanda Canizales went two for three and scored once.

The Champions Cup marked the final major tournament of the summer for the Punishers, which had already qualified for the ASA Western Nationals in Clovis but will not attend due to the fact that it will be missing several players. The team recently came off a third place performance in the Triple Crown Sports Red, White and Blue Tournament where it allowed nine runs in three pool play games and scored 19 runs in three playoff games.

"I see the maturity level from the 16's to my team, and there's a difference," Armando Canizales said. "Their emotions get more in the way than being a little bit more mature and going though that error or that bad at-bat, where my girls kind of hang onto it mentally and don't let it go away."

Evaluation Report was conducted on the campus during the past several months.

Lacy recently told Trustees that she would be quitting her position and abruptly announced her retirement last month. Lacy said she would be leaving after this upcoming school year concludes in May 2015.

Schools accredited by the ACCJC are required to undergo a peer- evaluation to determine areas of improvement every six years.

A spokesperson for Cerritos College attempted to downplay the "warning" in a statement issued to Hews Media Group-Community Newspaper and other media outlets on Monday afternoon.

"A Warning is the least severe of the four sanctions that ACCJC can issue when an institution has not met or partially met standards," said spokesperson Aya Abalon.

A review of the executive summary of the report claims that Cerritos College officials need "areas of improvement" that includes degree and certificate studentlearning outcomes, as well as scolding the Board of Trustees on their "leadership abilities."

"Cerritos College remains fully accredited and continues to provide strong academic programs and resources that prepare students for future careers and transfer to four-year colleges and universities," Abalon said in her statement.

"The recommendations will not impact students earning credits toward degrees, certificates, transfers, and Financial Aid is also available for eligible students," she stressed.

Lacy attempted to deflect criticism and downplayed the results of the report in her media statement the harsh critic of the

"Our programs are strong. The evaluation is a peer-review process that allows the College to determine more ways to increase efficiencies. The Commission's actions remind us that our work to improve campus governance standards must remain a priority in order to better serve our students and the community," said Lacy.

However, an internal memo written by Lacy, sent to members of the Board of Trustees, and exclusively obtained by HMG-CN, Lacy sheds a very different light on the report that directly contradicts her public statement.

Lacy wrote in her memo to the Trustees last late last week: "I am disappointed that the College was placed on Warning, but from the team's exit interview, I had anticipated the action. We have begun to review the report thoroughly and develop strategies to correct the cited deficiencies."

HMG-CN obtained a copy of the Accrediting Commission report that was authored by Barbara A. Beno who is the current President of the statewide watch and review agency. Cerritos College continues to serve our students and community with quality programs and strong leadership," Avalos, who represents a wide part of South Gate and other western portions of the district.

TRUSTEE SALAZAR RIPS ACCJC

Vice President Salazar ripped into the legitimacy of the report in a statement to HMG-CN on Tuesday.

"As the governing body of Cerritos College, Trustees are stewards of its resources both human and financial. Student success is the ultimate measurable outcome and the state's student success score card for community colleges is now a standard," Salazar said.

"The Community College of San Francisco has made recent history in challenging the legitimacy and impartiality of the Accrediting Commission for Community and Junior Colleges," Salazar continued. "Federal intervention overturned the accrediting commission's attempt to harm the college, beginning with undermining its board of trustee's ability to govern. Yet, according to the scorecard, 56 percent of students who entered San Francisco City College in the 2007-08 school year achieved their goal of transferring or earning an associate degree within six years. I bring this up as it is a test case to the questionable composition and methods of the accreditation commission who seem to operate punitively on trustees and administrators that challenge the status quo," she said.

"Student success simply cannot wait and it is in that belief that I campaigned and was elected to serve. Upon being elected, I could not believe that Cerritos College had less than an 8-12 % transfer rate and a rudimentary approach to career pathways in the new economy. This is pure and simply unacceptable, this is why the board of trustee's new leadership thinks out of the box, and calls on national best practices to ensure that Cerritos College will become a flagship community college that takes a lead role in facilitating educational opportunities that will tangibly build a new middle class in our region. We were elected to ensure student success is measurable. I find the findings of the accrediting commission disturbing and again question the composition of their accreditation team and their methodol-

Chen purposely held a private meeting with other local leaders and two elected ABCUSD Board Members to craft a strategy to defeat a proposed \$235 Million Bond to help rebuild aged school campuses including the headquarters of the ABC Unified School District.

HMG-CN was told by a source who attended the meeting that Chen and former Cerritos Mayor Grace Hu talked "hard ball politics and strategy on how to defeat the bond measure." The source said that Chen "controlled the meeting," and that Chen and Hu voiced concerns that they would be "unfairly taxed" due to a large number of both residential and commercial properties they own within the ABC Unified School District. A second source, who works inside the ABC USD told HMG-CN on Tuesday afternoon that "everyone is concerned about what took place at the meeting" with Chen and Hu. Current Cerritos City Councilman Bruce Barrows, and current ABC School Board Members Sue Yoo and Lynda Johnson were also in attendance.

that they would be shared with the newspaper. As of Tuesday at 3 p.m., Johnson did not produce any correspondence about what took place behind closed doors.

Troubling questions linger in relation to the meeting and whether it violated the California Open Meeting Law better know as the Brown Act.

HMG-CN obtained a letter written by Chen in 2011 on Cerritos official letterhead. Chen used her carolchen@yahoo. com email on the letterhead; letterhead printed and paid for by the city of Cerritos.

That by default makes her carolchen@yahoo.com an official city email, which then made the meeting she called an official city meeting. Not allowing the public violates the Brown Act.

Questions also linger in relation to Johnson and Yoo attending and the possible "quid pro quo," translated as "give something, get something" that could have been forged between the two and Chen.

One Cerritos resident questioned why they did not walk out of the meeting once it became clear what the meeting was about. "It is very suspect that Yoo and Johnson stayed at the meeting, something was going on that enticed them to stay."

Hews Media Group-Community Newspaper obtained a copy of that email and published it on line just hours prior to the commencement of the 8 p.m. meeting in a third floor conference room at 183rd Street and Gridley Road real estate office owned by Chen.

Chen sent a personal email with addresses obscured from her individual Yahoo email account on Monday June 30 calling it an "urgent meeting" to seek input on the proposed ABCUSD \$680 million Facilities Master Plan and \$235 million Bond Measure.

When asked, Chen indicated she did not want the press at the meeting.


HMG-CN confronted Chen at the meeting and was repeatedly denied access. Chen on several occasion during the heated interview denied sending out the email or deflecting any and all questions surrounding the meeting.

In her email Mayor pro tem Chen said, "Given the facts I know of current(ly), if the bond passes it will impact/increase your property tax bill hundreds of dollars annually. ABCUSD School Board members Lynda Johnson and Soo Yoo both have reached out to me to get this information out to the public."

Based on the statement by Chen in the email where she said, "I wanted to get this information out to the public," HMG-CN contacted Chen by email to attend the meeting.

Chen's terse one-line reply was, "no media, invited guests only."

Cerritos City Manager Art Gallucci, who was not in attendance, was informed about Chen's meeting on Wednesday in an email from HMG-CN. Gallucci said, "The city was not aware of the meeting until you (HMG-CN) emailed the information to me. This is not a city meeting therefore the city will not be participating in any official capacity." With a cell phone video rolling, HMG-CN captured both Yoo and Johnson arriving at the meeting at the same time carrying paperwork. Chen greeted the two ABC School Board Members with open arms and hugs before they went into a private elevator. Johnson, when asked if members of the media could attend, responded that she was there as a "guest." Earlier in the afternoon, Johnson told the newspaper that she was attending. "I am attending and will take input from attendees, but I am there as an observer









Beno blasted the current Cerritos College Board voting majority that consists of current President Carmen Avalos, Vice President Sandra Salazar, Marissa Perez and John Paul Drayer.

## **CORRUPTION AND CRONYISM: VETERANS PARK CONSERVANCY**

WLAVA for the past two decades. She has been described by Rosebrock as "a woman who has been hell-bent" on stopping the property from "living up to its deeded legacy of providing a quiet haven for disabled and homeless Veterans."

It is the dirty little secret that everyone knows about in Brentwood.

Veterans have been abandoned literally on the side of the road along Sunset Boulevard in West Los Angeles fighting a war that has become heated and volatile led by Young and her VPC organization.

An investigation in June by HMG-CN revealed that cronyism and corruption filtered up to the highest levels in local, state, and even the federal government, all at the expense of mentally disabled and homeless Veterans in Los Angeles.

Powerful real estate developers, unresponsive government bureaucrats, and Sue Young's VPC are strong allies against an army of outspoken critics, almost all of them former military Veterans, who line the streets around the property each weekend, donning protest signs and wearing trademark American military greens.

Hews Media Group-Community Newspaper spent countless hours researching records, emails, and other critical documents that outline how political leaders, led by Sue Young and WLAVA Director Donna Bieter, resorted to the implantation and execution of illegal lease agreements with commercial organizations on the Brentwood property.

It is a web of some of the most powerful people in the country who are catering to the Brentwood Elite and their representative Young, in a decades-old effort to keep Veterans "out of Brentwood," in what one Veteran says is the "biggest land

fraud scheme in U.S. history."

Local and regional media, weekly and daily newspapers, along with LA County Supervisors have ignored the problem for years, not wanting to anger the Brentwood Elite and face the political wrath of the uber-wealthy who reside there.

Those involved include former VA Secretary Eric Shinseki, California Senator Dianne Feinstein and her billionaire husband Richard Blum, Congressman Henry Waxman, LA County Supervisor Zev Yaroslavsky, LA County Supervisorial Candidate Bobby Shriver, WLAVA Director Donna M. Beiter and the powerful Brentwood Veterans Park Conservancy run by Young.

Sources tell HMG-CN that others are also ignoring the Veteran's plight, including KFI's John Kobylt of the John and Ken radio show and Bill Handel who is heard daily on the same station.

Handel's spokesperson has denied any involvement with the property, even though Handel received several emails about the 388-acre property from Rosebrock and interacts daily with Kobylt.

The intricate case centers on the 388acre property, which was deeded to the government in 1888 by John P. Jones and Arcadia B. de Baker to the State of California for the "to be used exclusively by homeless and disabled Veterans."

Under the deed, anything done on the land should directly benefit Veterans and Veteran's health; anything else is illegal and a "breach of fiduciary duty."

But in 2001, WLAVA began leasing land to commercial organizations. These organizations put the donated land to uses that had absolutely nothing to do with providing health benefits to Veterans, a breach of fiduciary duty and an affront to Los Angeles Veterans.

The ACLU finally got wind of this and filed a lawsuit to fight the leases and remove the companies. District Judge John Otero agreed in 2013 that the land, under the 1888 deed, is to be used exclusively by Veterans, and adjudicated the leases in Federal Court as "unauthorized by law and therefore void."

Otero then entered a Federal Judgment against the Defendants, now-former Secretary of the VA Shinseki and Beiter.

Shockingly, Shinseki and Bieter appealed the judgment using the full force and power of the United States and the Department of Justice. One ACLU lawyer called the appeal "morally and legally indefensible."

Newly appointed VA Secretary Sloan Gibson is the de-facto party in the lawsuit now, and is allowing the appeal to continue.

And incredibly, some of the companies with leases on the property are riding the coattails of Shinseki/Gibson and fighting the ruling while the media, newspapers, and politicians sit on the sideline and ignore the saga as a matter of political and monetary convenience.

a public park "for the enjoyment of the entire community," which she stresses on the group's website is to "honor our veterans."

In 2007 when then-VA Secretary R. James Nicholson placed a one-year termination clause on the VPC's 16-acre park lease, Sen. Feinstein immediately wrote a letter on U.S. Senate letterhead on behalf of the VPC asking for the removal of the clause.

Three months later, lightning speed for any similar government action, Nicholson removed the termination clause and signed the 30-year rent-free "sharing agreement" basically giving the VPC a \$1 billion property free as a "public park."

This free public park "gift" rendered the land unavailable for Veterans and VA development. The VPC and Young got what it wanted, a deal to keep Veterans out of Brentwood.

Feinstein, Waxman and Yaroslavsky turned a blind eye and allowed the agreement to be approved.

In 2007, a Los Angeles Times article described how Yaroslavsky stopped a development by Fox Entertainment on the same land. Yet the Supervisor let the VPC 16-acre public park deal go through.

Incredibly, the park is now padlocked and does not allow Veterans to enter while the WLAVA rents the land out for \$1,000 per plate fundraisers. Most of the park is in complete disrepair, with the exception of the \$1 million fence built by the VPC to enhance the entrance appeal into Brentwood.

Drivers around the park often see homeless Veterans sleeping outside its gates.

### **Open Air Amphitheater**

Fast forward to 2014. While the judgment is under appeal, Young and the VPC have arrogantly and defiantly ignored Judge Otero's ruling and recently broke ground to begin construction of a multimillion dollar open-air public amphitheater on the land.

"Sue Young shamefully conned so many innocent people into donating to her 'honoring our veterans' scam that personally earned her over a million dollars while tens of thousands of war-injured and impoverished Veterans have been forced to live homeless and hungry in back-alley squalor," Rosebrock told HMG-CN in an interview this past week.

"Now she is building a theater on our land. She made over \$1 million at the expense of Veterans while stealing their land to benefit her fellow wealthy homeowners. It is reprehensible, immoral, and beyond comprehension. Compounding the dishonor of this egregious activity is that it had been suppressed by the major me dia," Rosebrock said. "Hews Media has fearlessly exposed this scandal and now it's time for the FBI and a Federal Grand Jury to fearlessly investigate Sue Young and her cronies, including an investigation by the Racketeer Influenced and Corrupt Organizations Act, "RICO", for possible criminal violations," Rosebrock concluded. In a recent "Veterans Today" by Rees Lloyd titled "Shame on VA Bureaucrats and Shame on Congressman Waxman," Rees pointed out the following on Young: "Veterans Park Conservancy, is manifestly not a Veterans organization but an organization of wealthy Brentwood residents whose principal agent [in advancing its own interests through arrogant manipulation] has been the politically-connected Sue Young - that is, politically connected to the Westside Machine." Several calls into Ms. Young for comment on the story went unreturned.

The center had been issued multiple citations, but that significant information was never made accessible to the public. Julia Garcia added "Adam would still be alive today had his father and I been aware of the history of violations." Continuing her statement saying "Making complaints and violations easily accessible to parents online will prevent other families from the painful experience and the loss my family and I have suffered."

The operator of the child care center, Twinkle Twinkle Little Stars, had been cited in 2009 and 2010 for multiple violations and had more than twice as many infants than what was allowed under her license, yet none of the parents were. Last month the operator of the facility was sentenced to six years in state prison for the death of Adam Dash.

"It should not take a tragedy like Adam Dash to awaken the department on the need to have validated complaints online," Assembly member Garcia said. "This is where we are today, and it is time for us to hold the Department's feet to the fire."




