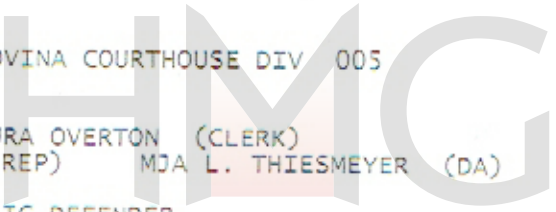
YOU HAVE THE RIGHT TO BE REPRESENTED BY AN ATTORNEY AT ALL STAGES OF THE PROCEEDINGS, INCLUDING THIS ONE. IF YOU WANT TO TALK TO AN ATTORNEY PLEASE TELL THE JUDGE WHEN YOUR CASE IS CALLED. IF YOU DESIRE AN ATTORNEY AND CANNOT AFFORD ONE, THE COURT WILL PROVIDE AN ATTORNEY FOR YOU, AFTER YOU HAVE COMPLETED A FINANCIAL DECLARATION DEMONSTRATING THAT YOU MEET THE FINANCIAL QUALIFICATIONS. IF THE COURT APPOINTS AN ATTORNEY FOR YOU, AT THE CONCLUSION OF YOUR CASE A DETERMINATION WILL BE MADE AS TO YOUR ABILITY TO REPAY THE COUNTY OF LOS ANGELES THE COST OF YOUR ATTORNEY.

YOU HAVE A RIGHT TO PLEAD NOT GUILTY AND HAVE YOUR CASE TRIED BY A JURY. OR, IF YOU AND THE PEOPLE AGREE TO WAIVE A JURY YOU COULD HAVE THE COURT HEAR YOUR TRIAL.

YOU HAVE THE RIGHT TO CONFRONT AND CROSS-EXAMINE THE WITNESSES AGAINST YOU, AND TO SUBPOENA WITNESSES TO TESTIFY ON YOUR BEHALF AT NO COST TO YOU.

YOU HAVE THE RIGHT TO REMAIN SILENT, ALSO KNOWN AS YOUR PRIVILEGE AGAINST SELF-INCRIMINATION. YOU CANNOT BE FORCED TO SAY ANYTHING THAT WOULD INCRIMINATE YOU IN ANY MANNER WHATSOEVER.

YOU HAVE A RIGHT TO HAVE YOUR CASE TRIED WITHIN 45 DAYS FROM TODAY, AND IF THE PEOPLE ARE NOT READY TO PROCEED WITHIN THAT TIME YOUR CASE MAY BE DISMISSED. THIS IS KNOWN AS YOUR RIGHT TO A SPEEDY TRIAL. FOR THOSE OF YOU WHO REQUEST A CONTINUANCE FOR PURPOSES OF SPEAKING TO AN ATTORNEY, YOU MAY BE ASKED TO
