

La Palma City Council Considers Contract With Grant Consultancy Firm

Based on City Manager Ellen Volmert's recommendation, the La Palma City Council agreed to continue discussions to contract with Blais & Associates for grants consultancy management services during its regular meeting last Tues., Nov. 18, 2014.

The proposed agreement with Blais for grant writing is expected to shore up the city's funding from federal, state and/or regional sources.

It will involve an amount not exceeding \$27,000 throughout the end of the current fiscal year which includes a grant research fee of \$400 a month.

"The money will not be taken from the general fund and the grant management services will become part of a long-term financial plan which has been successful

NEW MICROSOFT STORE OPENS AT LOS CERRITOS CENTER

Store Manager, Ramie Javed told HMG-CN in an exclusive tour the day before their grand opening, "we are super excited to be here in this community, the closest store we have is in South Coast Plaza which is 40 minutes away."

La Mirada Resident First Korean-American Woman to Pilot AH-64D Apache Helicopter

Camp Humphreys, South Korea—On a brisk autumn day, a Soldier walks into a classroom at Sookmyung Womens University in Seoul, South Korea. She is in her dress blue uniform which is pressed and clean. Her black hair is pulled tight into a bun. She walks with her chest out and chin up directly to her seat. She waits to be introduced then gets up and moves to the center. She looks into a crowd of glowing, eager ROTC students and begins to speak.

The soldier is 1st Lt. Sarah Jeon, a native of La Mirada, Calif., and a pilot with Company A, 4th Battalion (Attack), 2nd Aviation Regiment, 2nd Combat Aviation Brigade, 2nd Infantry Division.

Jeon is the first Korean-American woman to pilot an AH-64D Apache helicopter in the U.S. Army. The Apache is an attack helicopter and female pilots are few and far between.

The AH-64D boasts two high-performance turboshaft engines and maximum cruise speed of 284 kph. It is equipped with laser, infrared, and other systems (including target acquisition designation sight/pilot night vision sensor) to locate, track, and attack targets. A combination of laser-guided precision Hellfire missiles, 70mm rockets, and a 30mm automatic cannon with up to 1,200 high-explosive, dual-purpose ammunition rounds makes it one of the most formidable helicopters in the world.

A second-generation Korean American, Jeon entered the U.S. Military Acad-

emy on her father's advice and applied for the Army aviation branch because she liked flying. She was the only female among the officers in her class.

"Don't let anyone get in your head," Jeon said. "Don't let anyone say you can't do something."

Jeon was asked to speak at the university to a soon-to-be graduating class of female students. Jeon said she wanted to inspire the group to feel they could do anything they wanted to do and to further strengthen the U.S. and Republic of Korea alliance.

When Jeon was 11 years old, she used to watch a show called "Surviving West Point" on the National Geographic channel with her dad. The show went into depth about the West Point Military Academy's training program and schooling. Her dad told her that he had dreamed of being able to go to West Point.

This inspired Jeon to attend West Point and become an officer in the Army.

Jeon told the female ROTC students that when she arrived at West Point she was "weak" and couldn't always complete certain training events.

But the academy trained her and she got stronger while she was there.

Jeon overcame "many obstacles" that were put in front of her while she was in school. "Female soldiers cannot make excuses," she said.

"If they study, stay in shape and work hard, then everything else will fall into place," she said.

La Mirada Resident Wins Presidential Service Award

Raquel Lizarraga, a La Mirada resident for 27 years, recently was awarded the Presidential Volunteer Service Award [PVSA] for her work on bringing attention to drowning victims.

Alongside Huntington Beach residents, Olin Patterson and William Koon, and Pico Rivera residents, Mike Lopez and Henry Reyes, all were awarded for their volunteer work with the non-profit International Surf Lifesaving Association [ISLA].

The President's Volunteer Service Award program is a way to thank and honor Americans who, by their demonstrated commitment and example, inspire others to engage in volunteer service. The PVSA recognizes United States citizens who have achieved the required number of hours of service over a 12-month time period. The President's Council on Service and Civic Participation (the Council) was established in 2003 to recognize the valuable contributions volunteers are making in local communities and encourage more people to serve. The Council created the President's Volunteer Service Award program as a way to thank and honor Americans who, by their demonstrated commitment and example, inspire others to engage in volunteer service.

Reyes and ISLA's Vice President of Operations, Koon, received Gold awards for accumulating over 500 hours of ser-

vice. Patterson, Director/Co-founder of ISLA, along with Lizarraga, ISLA's Vice President for Development, both were awarded Silver for their 400 hours of service, and ISLA's IT Manager, Lopez received Bronze for his 200 hours. "This is our opportunity to educate and bring to light the issue of global drowning" said Lizarraga.

Upon receiving the award Lizarraga said, "It's an honor to be recognized by the Obama Administration for our efforts to prevent drowning. Drowning is a leading cause of death worldwide with two people drowning every minute." Lizarraga recalled her first trip to Nicaragua, "It was just a few of us, but we had big dreams. Now, we are seeing our dreams become a reality." Lizarraga noted that with over



Cerritos Spark of Love Toy Drive Visits Los Cerritos Center

The annual Stuff-A-Bus first event was kicked off Friday, November 21st at Los Cerritos Center. In collaboration with ABC7 and Southern California Firefighters, The Los Cerritos Center helped Stuff-A-bus celebrate 22 years of collecting more than 8 million toys for children and teens. Spark of Love stuffed ten buses full of toys this year, surpassing the eight buses and 450,000 toys of 2013.

The "Spark of Love Toy Drive" takes place in November and December every year. With love and support of donors and sponsors, kids across Southern California

receive a new toy each holiday season.

Donations of any size are accepted by ABC7 and the Southland's Firefighters Associations to help make a difference in a child's life during the holidays. Residents can drop off a new, unwrapped toy or sports equipment at any local fire station. Firefighters from Los Angeles, Orange, Riverside, San Bernardino and Ventura counties along with City firefighters collect the gifts and distribute them to children in the local communities.

The "Spark of Love Toy Drive Fund" was created in 2004 at the California Community Foundation [CCF] to provide toys or sports equipment for less fortunate families during the holiday season in Southern California. ABC7 Anchor Garth Kemp is dressed as an oversized elf and helps Santa greet all those who donate. Kemp is known for his charity work within the community, donating much of his spare time and effort to the cause of children and animal adoptions. His adopt-

Garth Kemp, also known as Garth-the-Elf told HMG-CN, "we just want to thank the hundreds of very generous donors who came out and donated. We broke last record of eight buses with 10 buses stuffed to the hilt." Kemp added, "if folks weren't able to come out to the Cerritos event, they still have a chance to donate and meet me, Garth-The-Elf. We're holding three more Stuff-a-Bus drives one in Ontario on December 5, Canoga Park on December 12, and one in Anaheim on December 19. Tell everyone you know to join us and help bring joy to a child in need this season."

Over the past two decades, Spark of Love has successfully collected more than

8 million toys. The campaign runs through Christmas Eve, and the goal is to exceed last years' collection.

POST ELECTION COMMENTS FROM ABCUSD BOARD AND OFFICIALS

Following the defeat of Measure AA, board members and district officers commented on the defeat that ranged from the inspirational to the emotional.

What follows are only portions or excerpts from their actual reports.

Superintendent Dr. Mary Sieu: "Election Day was an important day for many schools districts in California.

As a matter of fact there were 113 of them who went out for the bond measures.

I want to congratulate my colleagues in 89 school districts who were successful in passing their bond measure.

I remember a phrase many years ago that goes 'only those who dare to fail greatly can ever achieve greatly.' Although election results were disappointing and we lost on the AA measure, I would like to thank and express deep appreciation to the majority of our school board for first putting the measure and the incredible support from ABC group of employees, PTA District Committee and community leaders."

Board Vice President Lynda Johnson repeated the email she sent out two days after the election: "I want to thank the ABC community for exercising their rights in yesterday's elections. The election had raised the level of awareness on the bond measure in the community. It is time to reflect on the positive effects of the elections. I look forward to collaborating with stakeholders to re-evaluate, review and research on alternative funding sources to be able to provide our students 21st century learning environment."

James Yee, Principal of ABC's Citizens for Responsible Spending Committee, clarified some issues during the campaign period: "Ray Gaer made allegations that some 'No' bond measure people caused 'Yes' campaign posters to be pulled out.

We did not retaliate right away because I wanted to know first the facts. After I inquired with our people I found out that yes there is one from us that removed the Yes sign but he said because it was posted in his property. I also found out that several Yes and even No posters had been pulled out by code enforcement officers simply because they are installed in private properties without permission. So, Mr. Gaer, we will not be responsible for your lost signs, you may ask the code enforcement people."

Armin Reyes lamented the personal sacrifices of teachers that went unnoticed by the community: "It is hard to spend tax payer money when schools are improving despite the recession.

It is hard to spend when there are no layoffs despite the recession.

What people do not know was this was possible because the school board, the staff, administration and teachers have protected the schools and insulated them from the negative effects of recession.

What the people do not know were the teachers who have made sacrifices, suffered furloughs, pay cuts and managed larger classes just to sustain regular school activities despite the recession.

This, the community was not aware of because we failed to communicate."

so far but can still be much better by re-positioning our overall financial capacity," said Volmert after her presentation.

She said that the on-line service, which has gone for about 1.5 years was not that successful. "We have found some points of interest but we have no time to pursue them."

Responding from questions raised by City Council Members Gerard Goedhart and Steve Hwangbo during the Q&A portion following the presentation, Neil Blais of Blais & Associates said, "our clients included Fullerton, Anaheim, Norwalk, and Fontana among others that comprised about 20 cities/agencies in Southern California. Examples of grant secured for Fullerton was the environmental clean-up grant from OCTA worth \$200,000 and for Anaheim, a collection of various infrastructure type of grants totaling to about \$27 million and released to the city in staggered basis."

"Grant writing has become more competitive because of too many applications. Before, there was 25% success rate in the acquisition of grants but lately, it had trimmed down to just 10 to 15 %," Blais said.

"Success is pretty much dependent on how compelling is the candidate's project and meeting deadlines for submission of requirements. Moreover, the grant-giving entities usually try to spread out the money among successful recipients. So for those applicants who are willing to settle for less than the maximum amount they do have the advantage."

Hwangbo asked, "Are follow ups part of the \$27,000?" Blais replied, "No, my company will not be dealing directly with grantors, but of course, we will be guiding you through the process especially on research. Research is of utmost importance in securing a grant and we have 12 associates doing just that special function."



CIF-SOUTHERN SECTION DIVISION IV WATER POLO FINALS

CERRITOS FALLS TO RIGHETTI IN ANOTHER DEFENSIVE TUSSLE

IRVINE-As the Cerritos boys water polo team was preparing to face Righetti in the California Interscholastic Federation-Southern Section Division IV finals, the game plan was simple for head coach Paul Park. He stressed defense, and a lot of it against the division's top ranked team.

That game plan work throughout the first 30 minutes of last Saturday afternoon's match. But the Warriors scored three straight goals in a span of 41 seconds in the first overtime and doubled up Cerritos 8-4 at the William J. Woollett Aquatics Center. Cerritos was seeking its

fourth boys title and first since 2008 while Righetti, which had fallen in the Division IV finals the past two seasons, took home the championship for the first time since 2002.

"It was a tough loss, but you know what, we played hard," Park said. "We kept them to three goals [in regulation]. Honestly, I really couldn't expect more from these guys."

Cerritos had lost to the Warriors in the semifinals the past two seasons and by one tally. Last season, the Dons were the second ranked team, as was the case this season, while Righetti was third. But the Dons were up for anything early on and trailed 1-0 after the first period on a Lukas

Sheckherd penalty shot at the 3:16 mark.

The Dons (21-11) tied the contest with 2:37 remaining in the half when senior Angel Alcalá found sophomore Alex Alcalá. The score would stay 1-1 at the half and already, the match was on pace to finish as one of the lowest scoring CIF-SS finals ever. Entering last Saturday, there had been 13 championship matches in which both teams combined to score fewer than 10 goals.

"I was definitely confident our offense would come around," Park said. "But Righetti...that's what they're known for. They've been a defensive juggernaut all year. I don't think they've let any team score double digits on them. I knew it would be a tough match. But for us, our focus was defense, defense, defense."

Righetti regained the lead with 4:15 left in the third period on another Sheckherd goal but three minutes later, senior Dominick Nevarez tied it up. The Warriors would take a 3-2 lead with 10 seconds left in the stanza on a Nick Hurdle tally after Angel Alcalá missed a potential goal with a man advantage.

After both teams missed numerous six-on-five chances in the fourth period, the Warriors were set to win in what would have been the second lowest combined scoring finals ever. But Angel Al-

cala scored with 51 seconds remaining in regulation, just 12 seconds after Righetti was called for their seventh exclusion.

But the Warriors (31-4) took the lead for good with 1:51 left in the first overtime when Terry Franklin scored after the Dons were called for their sixth of eight exclusions. Half a minute later, Justin Murillo made it 5-3 before Nevarez brought the Dons to within one with 70 seconds left in the first overtime.

Another penalty shot from Sheckherd 27 seconds later gave the Warriors that two-goal cushion again and Franklin iced the match with 1:32 left in the second overtime.

"In the end, I think they had a little bit of a deeper bench and we got a little bit tired in overtime," Park said.

Cerritos, which fell to Righetti 12-8 back on Oct. 11, outshot the Warriors 23-19 but had two players foul out of the contest. With only four seniors on this season's squad, the Dons will still be looking good to make a return trip to the finals next season, possibly against Righetti, which loses seven out of 17 members.

"We have a good group coming back," Park said. "These guys like to work. So, we'll always be working hard."

Trio of area teams usher in new head coaches as many questions arise

The 2014-2015 girls basketball season will see a new head coach on the sidelines for Cerritos, John Glenn and Valley Christian, but that alone will not be the only headlines. Can Cerritos build on a banner season that produced 21 victories? Can Norwalk get back to that Suburban League championship form of two seasons ago? Can Whitney win without the graduation of two of the best players ever in school history? Those questions and many more will be answered by the time the middle of February arrives.

ARTESIA PIONEERS

3-23 overall last season, 1-11 in the Suburban League, tied for sixth place.

The Pioneers struggled for the second straight season but did manage to make tiny steps. Scoring was a problem but the biggest issue all of last season were the high number of turnovers in every game. Still, there's reason to be optimistic about this season despite just three players returning.

"We were happy with the fact that there was indeed an improvement in the record," said Artesia co-head coach Dan Galvan. "We improved in a lot more things in terms of progress. Some of the positives were that we learned to play a little bit together and despite not having the natural skills, they were quick. They kept looking for positives. We had Norwalk at the half and we beat John Glenn and we had La

Mirada on the ropes for a little bit."

The backbone of Artesia's offense last season was Onica Yu, who comes back for her final season after leaving the team in the final week of last season for a family emergency. Her game has stepped up, but so has that of fellow senior Keina Harris and junior Zharia Simmons. If all three of them are on their game, they can all average in double figures.

Galvan says the team is deeper than last season because of the experience of the junior varsity players who are now on varsity. The top newcomers will be senior Celeste Martin, juniors Angela Castro, a foreign exchange student from Mexico who will be a backup point guard and Taryn Davis, a transfer who will be starting at the post and sophomores Cynthia Calderas and Nyla Williams, a transfer from Narbonne.

"We are building," Galvan said. "We have nice group of freshmen, a couple who will probably be on varsity and serve as a nice role coming off the bench as they learn."

For Artesia to be more successful than last season, it needs to get help from its bench players as the Pioneers got 106 points from seven different non-starters last season. But limiting the foolish turnovers is first and foremost for the Pioneers, who have not had a winning record since the 2006-2007 campaign.

"It will still be a problem but I don't believe it will be as glaring a problem," Galvan said of the turnovers. "But we still have the same issues."

Despite winning at least 20 games for the first time since going 20-10 in the 2004-2005 season, the Lady Dons didn't win the Suburban League. And this is coming for a team that possessed probably the most talent in the league. A pair of losses to Mayfair by a combined seven points cancelled those dreams. But former Cerritos junior varsity and freshmen/sophomore coach Marcus Chinen replaces Ariel Adams and hopes to take the Lady Dons to the top of the league. Chinen was most recently the junior varsity coach at La Habra and Kennedy High Schools.

"Right now it's very, very exciting being a new coach here," Chinen said. "I was in this league two years ago at the lower levels. But coming back here is going to be a big challenge. I know we have a tough season; I like to play a tough pre-season which will lead into hopefully a successful league season."

Chinen is very familiar with seniors Taylor Hirata and Alyssa Movchan, two of the most prolific players in school history who played for Chinen in the summer league prior to their freshmen seasons. Those two are dynamic in various ways and league opponents will have problems covering them. Hirata has the potential to average double digits in scoring while

Movchan will be making a serious push to be the league's most valuable player.

"I look at them for leadership," Chinen said. "I expect them to be my leaders and help me out a little bit with the players I'm not familiar with. But I'm looking forward to [the season]. It's going to be a fun season."

But if opponents think they can slow down Hirata and Movchan, then they'll have to deal with junior Tatiana Fominyam and sophomore Iodefoma Okoli, two inside forces, as well as up and coming star Cailey Vitug, who scored at least eight points in seven games last season as a freshman and also has the potential to reach double digits. Chinen said that Fominyam and Vitug, who have started to take the ball to the basket more, could be the other two starters. The top newcomers to varsity will be junior Ala Tui, sophomore Bethany Huang and freshmen Tracey Nakamura and Kalea Trias.

With the exception of 2010-2011, when Cerritos finished in last place, the Lady Dons have fallen either one or two spots short of a league title five times since last winning it all. And before that, Cerritos finished in second or third place seven straight times since claiming the 1999-2000 league title. It's obvious Cerritos is a major force in the league, but so has Mayfair and Norwalk recently.

"I'm sure any [of the top three] teams in the Suburban League have the capability of taking the league title," Chinen said. "I keep telling these girls that we have to take it a game at a time. We have to limit our turnovers, we have to play smart and if we do that, I'm sure we'll have a successful season."

After winning a combined 42 games the previous two seasons, Gahr stumbled a bit last season with a squad of four seniors, three juniors, one sophomore and four freshmen. The team tried to gel and get that chemistry going but it didn't happen until the second half of San Gabriel Valley League action. But what hurt the most, according to head coach David Garcia, was the fact that the Gladiators were not selected as an at-large playoff team af-

ter advancing to the California Interscholastic Federation-Southern Section Division III-AAA finals the year prior.

"Yes, I was disappointed that we did not make the playoffs at 12-14," Garcia said. "With all of the young girls that I had last year, it was kind of hard for them to adjust with the seniors. It wasn't until the second half of league that they really started to have the chemistry as a team."

But now, Gahr can build for the future with three talented sophomores in Lauren Magano, Breanna Smith and Miranda Ta'amu, who will definitely be the top offensive and defensive threats this season. Smith and Ta'amu have the ability to score over 10 points a game while Magano, who had to step up as a point guard last season, shined at the end of the season, starting in four games and scoring 28 points in eight of the last nine games of the season.

"She was the biggest girl we had, so she had to start," Garcia said of Ta'amu. "Still, on this year's team, she has figured out that she's the captain. So now with one year under her belt, she's being looked at by the other nine girls as the leader. This year I expect big things from her."

Garcia said that by the time league play begins in January, Ta'amu has to understand that she will be a dominant force and must average 10-15 points a game. Rios and Smith will be solid on defense but the biggest surprise could come from junior Angelica Soltis and her sister, sophomore Alana Soltis, both of whom transferred from Cerritos.

Last season ended a streak of eight straight playoff appearances. That will change this season as the Gladiators aim for second place with first place going to Lynwood, as has been the case every season this century.

"That's our goal this year, to be real respectful in our league, because I know last year, teams beat us and I'm okay with that," Garcia said. "We've gotten that out of our system. So now, we don't have the same team that we had last year. We're a totally different team."

The Linda Parra era at John Glenn is over and for the first time since 2002, the

Lady Eagles will have a new head coach. Former Glenn standout Christina Hernandez, who played from 2004-2007, takes over a program that has had three straight losing campaigns, winning 20 games in that time. But Hernandez is excited about the challenge of coaching a varsity team for the first time, and doing it in a setting that is true to her heart.

"I think ultimately, my first goal when I started coaching, was just to give back to the program," Hernandez said. "The program gave me a lot when I was here in my development as a young woman and the biggest thing with me was giving back to the community and giving back to where I came from because it had given me so much."

Instead, everyone is contributing and everyone has their own individual strengths. That's what Hernandez is working into the game plan. She added that the girls wanted to start right away in the spring once last season ended and she knew what the team was going to look like as soon as last season ended. The newcomers will be seniors Seayanna Crawford, Mary Diaz, Carolina Hernandez, Heven Hinojosa, Amanda Lopez, and Jazmin Torres and sophomore Saurianna Harrison.

"The fact that they are seniors has pushed them and motivated them because they only have one more year together," Hernandez said. mer mentor and dean of Suburban League girls basketball, Richard Drake, for giving her the freedom to be a coach alongside of him for many years.

“Considering the year before we lost some really strong seniors, we had a lot of sophomores becoming juniors having to step up and take that leadership role,” Osongco said. “We had seniors on last year’s squad. Unfortunately it was their first year on varsity. It was a different year, but for what it was worth, we still were able to make the playoffs. I don’t think it was a bad year.”

Make no mistake, this is a team not to sleep on as it returns five senior starters plus three other seniors. While Osongco hasn’t tabbed a set starting lineup, Jackie Aldana and J’Nae Harrison are probably the two most solid players. Aldana has been a starter since she was a sophomore and Harrison, who is crafty inside the key, can easily score 10-15 points a game. Osongco said they are trying to develop their leadership roles and she is looking for surprises out of her returning players. Arely Lopez is coming back from an ankle injury from the fall league.

“I’m very blessed in that sense, however, again just like our days have been with each other through spring of last year into summer to fall, my expectation as a coach has also grown,” Osongco said of the experience of her team. “I do expect more out of them. I think we’re in the process of them trying to meet [those expectations]. They understand; it’s now them doing it and taking ownership of this team.”

After Valley Christian had a breakout season, winning 10 more games and losing nine fewer contests from the previous season, the Lady Crusaders welcome their third coach in the past four seasons. Dominic Freeman takes over but is no stranger to the area, having been the head coach at Lakewood the past three seasons. Freeman said he was attracted to the new job by V.C.’s culture, morals and values.

“It’s definitely different from where I’m coming from; from the Moore League and obvious Lakewood where we had some success there,” Freeman said. “Coming into a school like Valley Christian, I knew I was getting myself into a position of rebuilding like I did at Lakewood. That’s another attraction that drew me over here.”

The Lady Crusaders lost the bulk of their scoring to graduation but return two solid starters plus half a dozen core players that should give the team its first winning season since 2010-2011. Senior Hailey Garcia could very well double her scoring average while senior Kate Vande Vegte scored a season-high nine points in the first and last games of last season.

“Both of those young ladies bring a lot of leadership qualities that we desperately need,” Freeman said. “And they bring a lot of intensity every day. That’s some-

thing that we need, quite frankly.”

Look for senior Alex Fenderson and junior Katy Feller to also be big scorers while senior Nicole Parker brings a lot of tenacity on defense. Sophomore Cheyenne McKinnie, a transfer from Long Beach Jordan, and freshman Jai’lynn Parham are the two lone varsity rookies.

V.C. tied for second place in the Olympic League last season, a monster improvement from finishing fifth and fourth the previous two seasons. Winning league, or at least finishing high again, is definitely not out of the realm with six seniors.

“Me being new to the Olympic League, and all of my life I’ve been in the Moore League, I’ve definitely been doing my research and I still haven’t seen all of these teams and [who is] returning,” Freeman said. “We had a second place tie last year and I definitely want to build upon that and shoot for first place. That always should be the goal.”

The honeymoon is definitely over for Whitney and head coach Jeff Day as the program moves on without Rachel Nagel and Reyna Ta’amu, arguably two of the best players in school history. The Lady Wildcats were one play away from potentially earning a spot in the state tournament and the fact that the graduating group of last season lost in the quarterfinals three seasons in a row is what stings Day the most. But he is quick to say that the theme of this season is ‘don’t talk about the past’. That also includes the 10 players he thought he would have on varsity this season but are not playing basketball for various reasons.

“We were in one of the tougher divisions,” Day said. “Honestly, I thought we

went where I expected us to be. I hoped to go farther. But when you get that far, you’re going to come across some good teams. Rosary was the last place team in their league, but [the Trinity League] is probably the best girls league around.”

Whitney returns just four players but the leader of the team is clearly sophomore Nicole Lee, who was groomed into the starting role for this reason as Day knew he would be graduating Nagel. In fact, Day calls Lee, the team captain, a “mini Rachel” and she will be asked to carry a big load with the lack of depth on the team.

Senior Jihee Lee and junior Annika Brandes combined to score 35 points last season. But the three senior newcomers to varsity-Tushara Govind, Tania Ruiz and Shiraya Thompson- have not lost an Academy League contest as junior varsity members the past three seasons, something Day hopes to continue. Junior Chloe Olvera and freshman LiMei Vera, whom Day says is fundamentally sound, are two other new players.

“With the exception of really Nicole, we have four spots up for grabs,” Day said. “Tania is probably locked into a spot because she’s a center. We don’t have a lot of depth at the post. I have about nine or 10 girls and eight of them are competing against themselves for playing time and their playing against themselves to get better.”

Whitney has not lost a league game since 2010 but going wire to wire again this season will be easier said than done. St. Margaret’s, which was Whitney’s lone league threat last season, lost seven or eight of the nine players on its tea, but Crean Lutheran and Downey Calvary Chapel figure to be much better.

“My goal as a team is to win league,” Day said. “Anything else we do in the preseason is all about trying to get better. We’ll take our whacks playing some bigger schools.”
