



Montebello Residents Cry Foul at Latest City Council Meeting

A special meeting of the City of Montebello Successor Agency that occurred on August 10, 2015, has many residents upset and questioning whether the meeting was legal.

When asked, Montebello residents told the Montebello Community News they had only received notices in their mail the day of the meeting.

But Francesca Tucker-Schuyler told the MCN that the meeting needed only a 24-hour notice and that it was posted online Thursday August 7 and outside City Hall by 2 pm.

The notice said, "Call and Notice of a Special Meeting," but the Montebello City website listed the August 10 meeting

West Nile Virus Activity Confirmed in Cerritos

The Greater Los Angeles County Vector Control District (GLACVCD) has confirmed West Nile virus activity in a mosquito sample collected from Cerritos on July 28. The mosquitoes were collected near the intersection of Briarwood Street and Kay Avenue (in the southeastern area of Cerritos). GLACVCD staff have surveyed the area and posted signs in nearby public areas.

GLACVCD has identified West Nile virus activity in multiple communities in Los Angeles County in the past month. So far this year, GLACVCD confirmed West Nile virus-positive test results for 31 mosquito samples, one chicken and one dead bird.

West Nile virus is a mosquito-transmitted disease that can cause debilitating illness and death to humans as well as birds, horses and other wildlife. Twenty percent of infected people will exhibit flu-like symptoms, and one in 150 people infected will require hospitalization. There is currently no cure or vaccine for the virus.

GLACVCD recommends that resi-

Lincoln Fire Burned Over 300 Acres



The "Lincoln Fire," blaze ravaged over 300 acres in the Montebello area and parts of the Montebello Hills on Sunday, August 16, and is raising concerns about emergency communication in the city of just over 62,000. Residents were forced to take to social media for any news of the events as they occurred and how to proceed. Of great concern was the proximity of the fire to the active above ground oil drilling in the Montebello Hills. On the afternoon of the fire and in an interview with the Los Angeles Times, Montebello Fire Department Deputy Chief Dan Amador said, "all oil field operations have ceased at this point. Everything is shut down." Yet in a tweet later that day, Montebello Police Department later stated that the oil field had not been closed down. This had La Merced neighborhood residents, many longtime home owners, confused and frightened, many without power for hours and unable to leave because of traffic congestion. Transient Arturo Miallan Aguilar allegedly started the fire and is being held in lieu of \$20,000 bail.

Charles Pell Awarded California Lawyer Attorney of the Year Award as Criminal Prosecutor

That case was one of the largest cases involving a criminal enterprise in a complex tax scheme where multiple convictions were successfully obtained in United States District Court history.

Moody's Places Central Basin Municipal Water on Review for Downgrade

In another blow to the embattled water agency, Moody's Investors Service has placed Central Basin Municipal Water District's debt, its Aa3 Certificates of Participation, under review for possible downgrade.

The review comes one week after HMG-CN Publisher Brian Hews published a scathing Op/Ed, citing mismanagement and a dysfunctional board as reasons that CB should be taken over by LA County.

The District's Certificates of Participation, Series 2010A, and Adjustable Rate Refunding Certificates of Participation, Series 2008B, amount to \$48.4 million in total debt outstanding.

The certificates are secured by a senior lien on CB's net water revenue.

Moody's cited several reasons for the

LA PALMA APPROVES PROPOSAL FOR TRANSFER OF SCHOOL PROPERTY

La Palma City Council directed the City Manager on Aug. 4 to prepare a Resolution that would authorize Staff to submit a petition, for a transfer of the territory within the city limits north of Houston, from the Fullerton Joint Union High School District to the Anaheim Union High School District “for the purposes of high school education.”

The Council adopted the Resolution on Aug. 18, approving a proposal for the transfer of the territory and authorizing the City Manager to transmit the proposal to the Orange County Committee on District Organization.

The Council also directed staff to send letters to residents north of Houston and to the Fullerton District inviting them to attend the Aug. 18 meeting. This action followed a study session that presented the history and progress on the school choice issue along with options for additional action.

Actions discussed, in addition to the petition, included discussions with the affected districts and potential 2016 legislation. All such actions are not mutually exclusive. For example, a meeting with the Fullerton District is scheduled for August 26.

La Palma City Manager Ellen Volmert said, “The districts are each organized on the basis of a substantial community identity. Both districts were organized in the late 1800’s, and their current borders do not support a community of identity relative to La Palma that developed much later in the mid-1960’s to mid-1980’s.”

Volmert also reported, “The proposed transfer creates a much more logical community along City limit lines and recognizes a very close knit community which is the smallest by area of any in Orange County and only has one public high school within its borders.”

No facilities are in the proposed transfer area and there are none proposed to transfer.

“The Districts are substantially similar in demographic make-up and there is therefore little or no impact on the ability to educate students in an integrated environment. A transfer of about 1% of the territory within the original District will not promote racial or ethnic discrimination or segregation,” said Volmert.

Cheryl Clancey is a single mom of a teenaged daughter who has lived in the City since 1971. “I told my daughter that I had read that La Palma is one of the best places to live, and she asked me, ‘then why can’t I attend my local high school?’ and I

had no answer for her.”

Clancey said her daughter has to take a public bus, since transportation is not provided by the school district, and it will be difficult for her to participate in after school sports.

La Palma resident Michelle Jones agreed. “My husband and I were raised in La Palma, and we chose to make La Palma our home when we married and to raise our children in this great city. And although we were fortunate to attend our local schools within the city limits, our children will have to take a bus to Buena Park High when they could walk to Kennedy High. It’s not right.”

Any increase in costs to the state as a result of the proposed reorganization will be insignificant and otherwise incidental to the reorganization. The amount of territory and number of students is insignificant relative to the size of the Districts and while there is no known cost to the State, any such cost would be incidental and insignificant.

Next steps will be for Staff to develop more detail and information for the petition itself and to meet with Orange County Education staff to finalize the process to be followed.



Area Cities Celebrate 69th Anniversary of India's Freedom

The Indian Independence Act 1947 was as an Act of the Parliament of the United Kingdom which partitioned British India into two independent dominions of India and Pakistan. The Act received the royal assent on 18 July 1947, Pakistan came into being on August 14, and India on August 15.

The cities of Artesia and Cerritos marked Saturday, August 15th as the official 69th year of India's independence from British rule. After years of struggle, bloodshed, civil disobedience movements and mutinies, India was formally declared independent in 1947, ending almost 200 years of British colonization.

Thousands of native born Americans and India immigrants turned out to Artesia Park for a day long festival. The mega event was hosted by McDonalds and Toyota. Downey Animal Shelter Under Investigation by LA County

LA County Supervisors have called for an investigation into conditions at the Downey animal control facility.

The facility is located at 11258 Garfield Ave in Downey.

The investigation was prompted by photos taken showing dogs being kept in feces covered enclosures.

Supervisor Don Knabe, who called for the investigation, wants to make sure a plan is set up so that the shelter is cleaned up and maintained properly.

Animal welfare advocate Laura Jones posted the photos and videos of animals lying in enclosures riddled with feces at the Downey shelter.

The director of the animal control department said her agency is moving to fix the situation, partially blaming the problems on short staffing.

Earlier in the year, the supervisors set aside \$4 million for upgrades at LA County shelter, including the Downey facility.

Official said some of that money would go to replace current kennels at the Downey shelter with stainless steel enclosures that are easier to clean.

The plan is to tear down and replace the Downey shelter but officials say that could take five years.

An internal review cited several problems at the shelter including kennels with no cooling system and cramped medical facilities.

Groundbreaking for Rancho Los Amigos Rehab Facility

The official groundbreaking for Rancho Los Amigos state of the art rehabilitation pool and therapy rooms took place on Wednesday August 19, 2015.

The new \$418 million facility will be a Wellness & Aquatic Therapy Center, outpatient facilities and a new inpatient expansion, fitted with earthquake safety equipment. "Rancho Los Amigos supports patients in need of rehabilitative services with cutting edge technology and innovative medical practices," said Supervisor Don Knabe of the Los Angeles County Board of Supervisors. "It has consistently been ranked by U.S. News & World Report as one of America's best hospitals. Imagine how much more we can accomplish on behalf of our patients after we expand patient facilities, upgrade aging buildings, improve Rancho's technological readiness and beautify the campus."

Rancho Los Amigos has long been a staple in the Downey community and is considered the jewel of Los Angeles County's Department of Health services. The new and renovated facilities will place Rancho in the nation's top premiere rehabilitation centers.

Mayor Pro Tem Alex Saab stated, "Rancho Los Amigos National Rehabilitation hospital is rated among the top 10 best rehabilitation hospitals in the U.S. This morning, we were honored to participate in the groundbreaking of the new facility which will feature state of the art buildings and therapy rooms to help those

with spinal cord injuries." Saab continued, "the City of Downey appreciates all the miracles that happen at Rancho every single day and we are proud Rancho calls Downey home."

Phase one demolition began in March 2015 and will finish construction in 2016, which will house the new Wellness & Aquatic Therapy Center, campus entry plaza, parking garage addition and warehouse buildings. The second phase will be comprised of facility renovations, refurbishing the historic Harriman Building and seismic safety equipment. Phase two is set to be completed by 2020.

Knabe, working alongside the Department of Health Services, is advocating federal legislation to expand their partnership with the U.S. Department of Veterans Affairs to provide more health care to veterans. If passed this will provide better access and faster care to veterans, alleviating the long wait times at other VA

facilities, and will also allow veterans the choice of a non-VA medical facility. "The demands on Rancho will be increasing as more veterans are referred to this amazing hospital," said Knabe. "We must expand our state-of-the-art facilities so that our clinicians can continue to provide outstanding care for people with a life-altering illness, injury or disability, including our national heroes who have suffered casualties serving their country," Supervisor Knabe said. "This groundbreaking will throw a spotlight on the pioneering work that has been accomplished at Rancho for more than 125 years. The campus upgrade and enhanced technology will provide the means and infrastructure for Rancho staff to continue changing lives."

KIEHL'S AND amFAR RIDE FOR A CURE

This is the sixth year that Kiehl's and amfAR have joined forces to ride for a cure for HIV and AIDS. Over the last few years Liferiders have traveled more than 12,000 miles to support amfAR's efforts, as of 2015 over \$1,200,000 has been donated to amfAR funding seven cure related research projects.

Liferide 6 is a twelve day motorcycle ride that began August 4th in Denver, Colorado and ended August 15th in San Diego, California. "There were some grueling 300 mile days" says amfAR Chief Executive Officer Kevin Frost, "The AIDS epidemic has been the greatest health threat not only to the gay community, but to the Nation - that has ever existed. A cure for AIDS is possible, and I believe that we will see it in our lifetime. amfAR has the will, the commitment, and the know-how to get this done, and to truly make AIDS history."

Starting in Denver, Frost and Kiehl's President Chris Salgado led a group of celebrity motorcycle devotee across the Rockies and through the desert, and then onto Southern California. Kiehl's hosted special meet and greet events at each of their retail stores along the way raising a total of \$250,000 to support AIDS research. To date, Kiehl's has donated more than \$1.2 million to amfAR. amfAR Global Campaign Chair Sharon Stone made a special appearance at Liferide's stop in Santa Monica, Wednesday, August 12, accepting the check for Kiehl's donation to amfAR.

Celebrity Liferiders included Jay Ellis, Gilles Marini, Vanessa Marcil, Teddy and Melissa Sears, Conrad Leach, Chris Kael,

Grant Reynolds, Kristy Swanson, Timothy White, Tricia Helfer, and Ben Cohen.

Frost met with Dr. Paula Cannon, Associate Professor of Microbiology at the Keck School of Medicine at the University of Southern California, where she leads a research team that studies viruses, stem cells and gene therapy. Cannon said, "there has never been a more hopeful time in the world of AIDS research. New breakthroughs lend to new understandings of the challenges that must be overcome in order to find the cure." Cannon went on to say there is growing confidence that, with the right investments, challenges can be overcome and by New Years Eve 2020, amfAR hopes to announce that a cure has been found. A volunteer group of leading HIV / AIDS research scientist called 'Cure Council' has been established to direct the research, ensuring that correct investments are being made.

"For the past 30 years, AIDS research has been a marathon, but in the last couple of years, it has become a sprint," said Frost. "It's a reflection of the enthusiasm that scientists feel about the research to find a cure."

Under the supervision of Salgado's enthusiasm Kiehl's has been able to collaborate artists, celebrities, athletes and universities to raise substantial funds and awareness for top three causes: HIV/AIDS, the environment and children's well-being. This commitment awarded Salgado with AdWeek's Brand Genius award, in 2011. In 2012, Salgado received the Angel Award from Project Angel Food, which feeds individuals suffering from HIV/AIDS and cancer in Los Angeles and in 2013, Salgado received the Leadership Award at TWO x TWO for AIDS and Art, a massive fundraiser for amfAR and the Dallas Museum of Art.

Most recently, in 2014, Salgado was honored with the Hope Award at the Ovar-

ian Cancer Research Fund's Legends Gala. Salgado has personally supported amfAR since 1994, and his desire to contribute combined with his love of motorcycles inspired the creation of Kiehl's Liferide. Frost recalled the day Salgado walked into his office and asked why he should support amfAR, Frost told him "If you want to be part of the generation that sees HIV / AIDS cured within this generation, then you should lend your support to amfAR."

Emmy winner Vanessa Marcil, combined her love for motorcycles with her philanthropic efforts, including racing in the Grand Prix last year to raise funds for the Miller Children's Hospital, riding her motorcycle for "Path" to raise awareness of homeless families, and of course the Kiehl's Liferide for amfAR. Marcil has worked with AIDS orphans in South Africa and is a longtime supporter of Sojourn, a domestic violence shelter. Marcil commented, "I've lost many friends to AIDS. They were incredible people who made the world a better place. I was invited to Ride for a cure last year. Chris was our leader.

He said, "How do you want to be remembered?" Those words and his commitment changed my life forever. I'm humbled and honored to ride for a cure."

"Melissa and I ride to raise money, to draw attention to the importance of continued HIV and AIDS research," noted Teddy Sears. "We are making noise for the cause, and to see an end to this disease." Sears is a current cast member of "Masters of Sex" on Showtime and in the upcoming film "Nine Lives" starring Kevin Spacey and Christopher Walken; he will also be featured as the new 'Flash'.

Grant Reynolds, Producer and host of Discovery Science's "What Could Possibly Go Wrong?" is a veteran Liferider. The former U.S. marine Sniper has rode thousands of miles to help raise money for research and stir the public's awareness and need for a cure. "I'm riding for a cure because I've invested close to seven years riding all over the USA raising not only money but awareness of HIV/AIDS. And we are so close to a cure... I can't stop now."

as a "Special Council Meeting."

One longtime resident who attended the meeting said: "This is a borderline illegal meeting. The Montebello residents were given no notice to attend this very important meeting that involves millions and millions of dollars."

Three Council members attended, Mayor Jack Hadjinian, Vice Mayor Art Barajas, and Bill Molinari.

Councilwoman Vivian Romero was vacationing in Mexico and Councilwoman Christina Cortez was unable to attend because of work obligations.

Longtime resident and civic leader Michael Popoff said, "I tried to change my schedule so I could attend this meeting and at least comment on the matter but with only three hours to change my work schedule, I just couldn't do it. I don't understand why this matter could not have waited for a regularly scheduled council meeting."

Only about ten people sat in Council Chambers for the meeting, five were professional financial consultants.

On the agenda - the only item on the agenda - for the meeting was, "The Successor Agency will consider approval of refunding various bonds of the former Community Redevelopment Agency of the City of Montbello."

According to Schuyler, the city will

realize a savings of \$5.10 million.

Several community members questioned that claim.

First Southwest Company, LLC, an investment firm with offices in Santa Monica, was selected to serve as financial advisors on the project. Their national headquarters are in Dallas, Texas.

But, when questioned about the process, the Council and Tucker-Schuyler acknowledged that the contract for financial services had not gone out to bid.

Tucker-Schuyler told the MCN, "we have used First Southwest for many years, they won the bid to be the city's Financial Advisor a few years ago, they have refinanced multiple bonds for the city."

During the public comment portion of the meeting, resident Anna Areola complained about the many cancelled meetings of the Oversight Board to the Successor Agency.

This Oversight Board supervises the actions of the City of Montebello Redevelopment Successor Agency in winding down the Redevelopment Agency in Montebello.

The Oversight Board made the bond recommendation. But the Council approved the refinancing of these particular set of bonds, this meeting was to finish up necessary paperwork.

The Oversight Board members include Vanessa Delgado, candidate for Montebello City Council and an executive with a Real Estate Development company. She was appointed to the Board by Councilman Bill Molinari.

The Montebello Community News was the first to report that Delgado moved to Montebello just a few months ago and bought her Spanish Style home from Tom Calderon, the disgraced former Assemblymember awaiting trial on federal corruption charges with his brother former State Senator Ron Calderon.

The Washington Blvd. project, one of the flagship renovation projects in the City, has recently come under a microscope by officials looking at the contract bidding process, payments to vendors, and the mysterious resignation of City employee Wendell Johnson who, as first reported by this newspaper, worked for the city for four months yet received a severance of \$35,000.

The severance was approved by Mayor Lilia Leon, Mayor pro tem Tina Baca Del Rio, and Councilmen Ivan Altamirano and Joe Aguilar, with the support of City Attorney Eddie Olivo by hastily adopting a new City Ordinance that approved the large severance payment to Johnson.

Altamirano's properties are located at 2566 Kurt, 5532 and 5534 Jillson in the City of Commerce.

HMG-CN has confirmed that all three properties are within 500 feet of Washington Blvd, with some as close as 200 feet.

Under FFPC laws, an official who owns real property within 500 feet of a property that is the subject of a "government decision" - for example approving the Washington Blvd. project - is presumed to have a conflict of interest and may not vote in the decision unless the official obtained a favorable FPPC advice letter stating the official does not have a conflict of interest.

If Altamirano wanted to vote on the project, and knowing his property was within 500 feet of the project, he should have obtained a FPPC advice letter stating he did not have a conflict of interest or recuse (excuse) himself from the vote.

Altamirano did not obtain the FPPC letter and did not recuse himself actually voting on the project several times, placing him in violation of FPPC 18704, which carries substantial monetary penalties.

"It's just politics as usual in Commerce," said one resident. "I have seen (Commerce Councilman Hugo) Argumedo follow the rules and recuse himself from voting. Leon, Baca Del Rio and Altamirano do not care about this city or any penalties because they have their Sugar Daddy (Citadel Outlet Mall owner) Steve Craig to hold fundraisers and bail them out. Craig bailed out Baca Del Rio a few years ago with a \$26,000 fundraiser and he will probably do it again for Altamirano."

FPPC spokesperson Jay Wierenga told HMG-CN, "any violation of the Political Reform Act can lead to a fine of up to \$5,000. Penalties are generally based on a number of criteria, such as any previous violations by the respondent, complexity and type of case, cooperation of those involved, similar cases and the penalties imposed on those similar cases."

Emails into Councilman Altamirano went unreturned.

dents follow the "Three D's" of West Nile virus prevention to protect themselves and their families:

- Dump/Drain - Eliminate or report standing water on your property because that is where mosquitoes breed.
- Dusk/Dawn - Avoid outdoor activities when mosquitoes are most active.
- Defend - If you are outdoors when mosquitoes are biting, wear long pants and long-sleeved shirts and apply insect repellent containing EPA-registered active ingredients such as DEET, Picaridin, IR3535 and Oil of lemon eucalyptus.

review and possible downgrade including low debt service coverage levels; changes in management and consequent differences in previously discussed outlook and long range plans; and lack of information regarding future year financial projections.

Moody's is waiting for additional data from City management that is currently in process and will be available shortly.

If the requested information is not received, "Moody's will take appropriate rating action, which could include the withdrawal or change of the Aa3 rating."

In September 2014 Moody's upgraded its rating for CB to a "stable outlook," signaling the district was improving financially.

The new rating was given to the district's proposed \$8.5 million bond refinancing issue.

"The stable outlook relates to the litigation settlement with one of the district's primary customers and the expectation that the district will restore debt service coverage and cash reserves to historic levels," said a written release from Moody's.

CB GM Tony Perez was instrumental in the turn around and improved rating of CB.

Inexplicably, days after the new rating, CB President Bob Apodaca and Directors Leticia Vasquez and James Roybal voted to fire Perez.

The firing was allegedly ordered by Pacifica Service's influential President Ernie Camacho.

Camacho had stated that he intended to see Perez fired for his role in exposing the \$5 million in no-bid contracts Pacifica received from CB between 2008-2012.

Those contract extensions have been extensively reported in this paper.

Camacho has also contributed thousands to Apodaca, Vasquez and Roybal's campaign coffers.

Valley Christian's junior class to play a key role this season

When a high school's junior varsity team goes 10-0 in back to back seasons, it's easy to see why the varsity squad should have a banner season. Valley Christian head coach Woodie Grayson is hoping for that as he improved his win total by two games last season. The Crusaders graduated over half of their team last season and while the numbers may still be down by V.C. standards, a lot of those players from the undefeated lower level team are now varsity rookies and ready to make an immediate impact.

"The numbers aren't what they typically would be around here," Grayson said. "But the more people I talk to, other than obviously St. John Bosco and [Long Beach] Poly...I think numbers in general are down. But for us, we've been pretty consistent. This is my third year here and the numbers are about the same as my first year."

OFFENSE

V.C. scored over 30 points in all of its seven victories and could be even more explosive this season. Senior quarterback Jesse Smith assumes the duties behind center, replacing the tandem of Will Brines and Jack Struiksma. But the strength could come in the backfield, led by senior running backs Robert Downs, Quaid Kawana and Matt Sigala, who was primarily a fullback in 2014.

"Obviously Robert is probably our most electric guy," Grayson said. "He can do a lot of things in the backfield. He can handle the ball and we can flex him out and throw him the ball. Being able to move him around a little bit this year will probably be more of what you'll see than last year."

But the running game gets a little better with the addition of junior Dominic Paul, who carried the ball 40-45 times a game on the junior varsity team. He will rotate with Downs in the backfield to give the Crusaders what should be a healthy one-two punch. Paul helped the junior varsity team average close to 50 points a game last season.

Senior Trent Berkenkamp and juniors Michael Polk and R.J. Van Kampen return as the top wide receivers along with senior Anthony Wesley, who played on junior varsity two years ago but did not play last season, mainly focusing on track.

"Coming out of spring ball and going into the summer, we started to be able to identify that we're probably a little bit more balanced, especially with Trent coming back," Grayson said. "Jesse had a really good spring and even a better summer. I expect us to throw the ball better than

we have in the past. But we'll still have a strong run game. On paper, we're better."

The offensive line will be held down by junior left tackle Ravon Chambers, sophomore left guard Robert Chatman, who was the best lineman on the junior varsity team last season, junior center Zach Krosschell, junior right guard Eric Schoonover and senior right tackle Roger Ramos, whom Grayson said can play every position on line. In addition, junior Austin Minnema will give Ramos a battle for right tackle.

"Even though we lost our best lineman last year, Joe Castanos, who is now at Whittier College, I think overall we'll be better up front because all of those guys coming back have experience," Grayson said.

DEFENSE

It's easy to see why the Crusaders won seven games and could have easily won nine. The defense allowed 20 or fewer points six times. The same linemen on the offensive side will be on the defensive front as Grayson stresses the importance of an ironman team. Sophomore Tevita Makaanfi gives V.C. even more depth on the line. Berkenkamp and Downs are slated to be the top cornerbacks while Van Kampen will be the free safety and Paul the safety. Joining the secondary will be seniors Jacob Gisbert, Rodney Lear and sophomore Quory Smith. The big question mark on defense will be the linebackers, where the Crusaders graduated Garrison Coley, Rick Pena and Kyle Westra, all of whom combined for 175 tackles, two and a half sacks and two interceptions. That part of the defense will be spearheaded by Kawana, junior Jalen Hines and sophomore Samuel Talavera.

SCHEDULE

The Crusaders dropped Duarte and added Laguna Beach as their first opponent. The teeth of the schedule occurs when the team has consecutive home games against backyard neighbor Mayfair and longtime rival Ontario Christian. Then V.C. goes on the road against small school power St. Anthony. Last season, V.C. lost to Mayfair by two touchdowns and fell to St. Anthony by three points.

"You never want to say a game is going to be easy," Grayson said. "We don't really know much about Laguna Beach. Their numbers are probably more like ours. They probably don't have a big roster. But it's an unknown. We could go down there and be walking into a hornet's nest."

Two seasons ago, the Crusaders hosted Maranatha on the final game of the regular season with the Olympic League title on the line and the same could happen again this season. In 2013, V.C. opened with a 14-0 first quarter lead before Maranatha answered back with 28 unanswered points and held on for a 31-28 win. Maranatha is the only current league team in which V.C. has a losing record against (2-3). Valley Christian is 5-0 at home against Village Christian since 2004 with three of those victories taking place during homecoming. The last time V.C. defeated Ontario Christian at home was 2011, and that was a four-point victory.

"We're really excited about this year because we think that we can be better than we did in the past two years," Grayson said. "Talent-wise, this is probably our best team. The great thing about those first two years for me was just the amazing leadership those two teams had and I don't know that we found someone to step in that void yet. Hopefully they will."

John Glenn's season lies in the emergence of its sophomores

Vince Lobendahn didn't waste any time last season coming in as John Glenn's new coach to set the tone that the Eagles will come out to fight hard in every game and for opponents not to overlook the struggling program. Glenn went 2-2 in its first four games and could have been 4-0 heading into the Suburban League opener. Part of that early success can be attributed to the 22 seniors on the team.

But on paper, the 2015 season looks as if the Eagles are almost starting all over again. Even though Glenn returns only six players from last season's team, Lobendahn agrees with the notion of starting over, but not 100 percent completely.

"I think by the film, you could see that I wasn't a pushover in every game, the first four bigger than the last five," Lobendahn said. "In the end, I thought with the Artesia game we came with a different deal. Our rushing game was the focus and we were able to get 2,200 yards rushing and it hadn't been that way here in awhile. I think [we] threw 180 yards total in offense."

"And that was my goal, too," he continued. "I wanted to try and save some turnovers. I was really proud of the way we went out defensively and offensively and scheme-wise. You weren't just going to come up and punk us on the line both sides of the ball."

He added that he enjoyed some good times against La Mirada, a 59-15 loss, especially matching their first drive of the game with La Mirada's first drive. But as the new season approaches, the team will carry at least 14 sophomores and a lot of them will be starters. The good news, as far as the future goes, is that Glenn will have around eight seniors on the opening day roster, meaning a lot of players will get a lot of varsity experience for the next season or two.

OFFENSE

Last season, the Eagles ran, ran and ran the majority of time. This season, Lobendahn says the option is going to be the focus. He wasn't too happy with what he saw from his wing players last season. The team scored 116 points and was held to single digits six times. However, against Magnolia, Pioneer and Santa Ana Valley, the first three games of last season, the combined first half score was 10-10.

"It's hard to get rid of that old behavior, mannerisms of a losing program," Lobendahn said. "It still even exists for me today with consistency in practice and consistency for events. I have to be on the podium to say, 'hey guys, a consistent program is a daily work and earn deal'. Nobody gets to be a champion by totally

having a one-year turnaround."

Senior Hector Sanchez will be the starting quarterback with junior Gabriel Martinez and sophomores Joshua Duarte and Carlos Manriquez slated as the backups. The backfield will be very young, led by sophomore running backs Gerardo Godoy and Carlos Pulido. Senior Elijah Cendejas could also join the team as a fullback. The top two wide receivers are projected to be seniors Nathan Lopez and Anthony Vargas with sophomores Gabriel Felix and Tajin Golightly as the tight ends. Possibly in the mix will be senior tight end Chris Parades and junior running back and wide receiver Miguel Ochoa, two of the six returning players.

The line will be occupied by sophomore left tackle Demitri Hernandez, junior left guard Andres Solis, junior center Andrew Vasquez, junior right guard Enrique Gonzalez and right tackle Alfredo Hernandez.

Lobendahn said his expectations are to be consistent, limit turnovers, control the clock and make opposing defense stop offense. If the Eagles can do that, expect more games to be closer than the average margin of defeat which was 23.2 points per game.

DEFENSE

The Eagles, who allowed 40 or more points five times, will run a 3-5-3 defense with Gonzalez, Solis and Demitri Hernandez projected to be on the line, Felix, Godoy and Alfredo Hernandez as well as junior Carlos Corona as the main linebackers and Lopez, Manriquez, Pulido, Vargas in the secondary

SCHEDULE

Magnolia and Pioneer are repeat opponents and Glenn split with those schools last season with the combined score being 17-14. The Magnolia game was tied going into the fourth quarter and the Eagles scored the winning touchdown in the fourth quarter against Pioneer. Glenn and Pioneer have faced each other the past six seasons with each team winning twice on the opponent's home turf. On paper, this has the makings of a strong start. But Lobendahn doesn't quite see it that way.

"At Glenn we're trying to change the program," Lobendahn said. "What I look for is how we commit to ourselves as a team. I can't look outside and see those records because if we're not practicing up to par, I don't care what their record is. I still feel my kids need to earn what it's like to be a winning program, and I want it. I want to get that four [win] in the off-season, get a five or six [win] season and have something out of that."

The Suburban League hasn't been too kind for Glenn over the past 17 seasons, going 18-90 during that time. The Eagles have not won a league contest on the field since getting past Artesia 26-20 on Nov. 4, 2011. They haven't won a home league contest on the field since posting a 34-20 victory over Cerritos on Nov. 12, 2010.

"These kids that I have, the 30 or so players that will be here, are going to be good and hard-working kids," Lobendahn said. "But they were with me last year. They are freshman team kids, guys that bought in, or if not, they were guys who started to smell the success and wanted to come out with us."
