



La Mirada and Central Basin Partner on Major Recycled Water Project

The City of La Mirada and Suburban Water Systems is teaming up with Central Basin Municipal Water District (CB) to expand CB's recycled water distribution system into the city.

Construction is scheduled to begin in January 2018.

The project will measure over five miles and is expected to supply between 650 and 750 acre-feet of recycled water to La Mirada.

CITY COUNCIL VOTES TO KEEP SKY KNIGHT AND SHERIFF'S STATION

After a marathon 4.5 hour Council meeting mostly taken up by debates to cut the Sky Night Helicopter Program and Cerritos Sheriff's Station, the Cerritos City Council decided not to cut the Sky Night program and the station.

Councilman Mark Pulido made the motion to save the Sky Night program, seconded by Councilman Jim Edwards. The motion passed 5-0.

Public Safety Manager Daryl Evans told the Council how valuable the helicopter program is, "the helicopter orbits the area so they can stop the suspects from fleeing, they are easier to find because they are the eye-in-the-sky,

Course Catalina Educates Future Scientists

AVALON –The youngsters eagerly hiked nearly three miles roundtrip to Catalina's Ben Weston Beach, frequently stopping on the trail to ask about plants and bugs and how they fit into the Island's ecosystem.

They dug through the sand at the beach in search of tiny insects they'd never seen before, and they seriously sniffed a twig of coastal sage to understand why it's sometimes called "cowboy cologne."

The 7th grade students from Haskell Middle School in Cerritos spent a day exploring the wonders of Catalina thanks to the Catalina Island Conservancy's "Course Catalina." Over the past 19 years, this science-based program has brought

classroom lessons to life by giving hundreds of pre-teens an opportunity to spend a day experiencing the Island.

Dr. George Boone, an orthodontist who became a real estate developer and a leading Southern California philanthropist, launched the program. His son, Nick Boone, is the administrator of the Boone Family Foundation and has continued to support Course Catalina.


"I love coming here with them and seeing them experience all that Catalina has to offer – from the boat trip to hiking through the wildlands," he said. "It's wonderful to see how Catalina and its beauty can have such a profound effect on them."

The student's teacher, Elizabeth Ortega, said that "seeing all of this firsthand – nothing can come close to that in helping them understand science. Several of these

Bruce Barrows Wanted to Cut Sky Knight Helicopter Program for Political Payback in 2012

Safety has been a big issue in Cerritos, brought to the forefront by Councilwoman Carol Chen's questionable no vote denying Cerritos residents the chance to approve a

sales tax for the City and fund the Cerritos Sheriff's Station.

Cerritos Council candidate Bruce Barrows, a long-time Chen ally, holds the same view as Chen, once dangling Cerritos resident's safety, the Sky Knight helicopter program, as a political football to advance his personal agenda.

In June of 2012, as documented in HMG-CN, then Mayor pro tem Bruce Barrows was involved in an incident where he physically assaulted Cerritos resident Jay Gray after a Council meeting.

Gray told Hews Media Group-CommunityNews in an exclusive interview at the time, that Barrows "grabbed me" and "threw me" and "yanked at my jacket and neck tie" after the meeting in dispute of Gray's public comments about various city priorities for the upcoming fiscal year budget.

Barrows later appeared before the Los Angeles County District Attorney's Office for an "Office Hearing" regarding

it is very important deterrent to crime.”

After Evans completed his presentation, questions were opened up to Council.

An angry Mark Pulido said, “I have been opposed to this cut from the beginning, the overhead support that Sky Knight has provided has served not just as coverage for emergent situations but as a deterrent to crime. I do not want to take this way and put up an open sign for criminals.”

The small crowd in the chamber applauded loudly to Pulido’s statement.

Councilwomen Chen was “very pleased to look at the major cost centers of the City. This is one of the areas we

have to look at. In her atypical usual questioning pattern, Chen questioned the number of helicopter responses outside the City. Are there any responses outside of the City, do we get reimbursement?”

Evans indicated it is covered under mutual aid; various police departments will share those types of assets. “We have used helicopters from other cities and vice-versa. A majority of the crimes in Cerritos are property crimes, which will be subordinate to other crimes. Sky Knight is smaller with lesser capabilities so as soon as another helicopter is available they bail out. Other cities using Sky Knight is very minimal.”

Public comment was then allowed on the agenda item with several residents voicing concern over losing Sky Knight; no residents spoke in favor of cutting the program.

Marlene Rafay cited recent crime, where a helicopter was involved; she implored the Council to keep the program and the Sheriff’s Station.

Sally Havice slammed Councilwoman Chen saying, “to take the attitude that they are flying over other cities and to be reimbursed is ridiculous. Why don’t we join up with other cities, even if they can’t pay the entire amount, maybe they can pay part of it so we can keep the program.”

Cerritos resident Jay Gray asked, “What is more important, museum cars or Sky Knight? Magnolia Power Plant or Sky Knight?”

Resident and Council Candidate Anantha Ramachandran said, “we need to prioritize the budget items, we need to keep the Sky Night but look at other major costs. In the future how do we do that, sharing costs?”

Councilman Edwards then spoke passionately about the helicopter program

and indicated he did not want to cut the budget, he made a motion to keep the program.

Pulido made another impassioned speech and seconded Edward’s motion.

Chen then said, “This is not just an issue about safety it is about the budget. Chen blamed redevelopment, and repeated what Mayor Ray indicated earlier, that the City is looking at other cost cutting measures. She again blamed the discussion of budget on Cerritos staff and that ‘no information has come back to us.’

Chen backtracked on earlier comments and “wanted to look at the Magnolia Power Plant,” and “that we would not be discussing helicopter program. We don’t need to cut Sky Knight.”

Solanki agreed with Pulido and Chen as did Ray. The motion passed 5-0 to keep the Sky Knight program.

Council then moved on to the agenda item discussing the Cerritos Sheriff’s Station with Evans once again outlining the consequences of converting the station.

Pulido thanked Evans, Cerritos Sheriff’s Station Captain Nunez, and his staff, and reiterated that he was completely against the conversion. “We have never had a conversation at this level about the station, I have a greater appreciation of what we have here.”

“Folks feel so comfortable in the City, it is beyond me that we are considering what would be an irreversible decision.”

Pulido made a motion to oppose the conversion, but Council had to listen to public comment.

Cerritos Chamber CEO Scott Smith said, “Cerritos is a great place to have a business, great schools, great residents. I am here for my over 300 members, they all want to keep the station. On behalf of

the business community please consider this decision carefully.”

Anantha Ramachandran indicated that the City will make over \$2 million more in sales tax in 2017. “I have talked to the City, they said we will make more money. Let’s use that and pay for the station. Then we can look at other budget cuts.”

Cerritos resident Mel Cortez, who was wearing a “nosalestax” t-shirt, somehow advocated for the Sheriff’s station, and blamed the CCPA deficit, even though Cerritos has sent RFP’s out to operators to take over the iconic theater. He also chided the Council for the museum and the power plant.

Edwards subsequently seconded the motion to oppose converting the station “until the next Council is elected.”

Ray commented “it was our fault that we did not get the sales tax on the ballot.”

The tax did not get on the ballot because Councilwoman Chen inexplicably voted to deny Cerritos residents a chance to vote on the sales tax increase.

Sources are telling HMG-CN that Chen’s no vote was meant to not take away the focus of “her” candidates on the ballot, Bruce Barrows and Chuong Vo, and to keep the number of resident going to the polls as low as possible so the vote is “split.”

Councilwoman Chen, who vehemently argued to close the station and helicopter program only a few months ago, then made an argument to keep the station praising Captain Nunez, Evans, and staff.

“At this point I will support the motion, and allow this to remain at the current model.”

The motion passed 5-0.

allegations of criminal misconduct of Penal Code 242 where Barrows reportedly settled the case along with Gray.

Barrows never minced words to anyone about his outrage that HMG-CN “dared to publish the assault story because it was a lie.” That statement was refuted by his meeting with the D.A. and final disposition of the case.

Barrows later took his anger out on HMG-CN at the June 28, 2012 Council meeting, and did so holding the Sky Knight helicopter safety program hostage just “to get back at the HMG-CN.”

Barrows threatened to endanger Cerritos resident’s safety and cut the Sky Knight if Council did not cut the City’s advertising budget with HMG-CN.

At the June 28 meeting, Barrows told Councilman Mark Pulido, an outspoken Sky Knight supporter, “Mark this is to address your Sky Knight issue. I would like to have the council eliminate the city print advertising from the budget. If you

do not vote to eliminate the city’s print advertising budget, I will not vote for Sky Knight.”

This and other statements are on the City’s website recorded on video.

After much debate, Barrows again chimed in and for the second time said, “if we don’t cut the print advertising budget I won’t vote for Sky Knight.

Councilwomen Carol Chen echoed Barrow’s statements saying, “cut print advertising or I won’t approve the Sky Knight funding.”

At the time, then Councilman Joseph Cho commented at the meeting “why are we talking about such small items when we have bigger things to talk about.”

Not wanting to cut the Sky Knight program, Pulido relinquished and voted to cut HMG-CN’s advertising budget to save the program.

Now the program is under scrutiny once again by the Council, mainly because of Chen’s no vote denying the sale tax initiative on the ballot.

The Council will discuss the safety of Cerritos and the plight of the Sky Knight as well as the Cerritos Sheriff’s station during their Feb. 9 meeting.

NORWALK SHERIFFS MAKE ARREST IN MYSTERIOUS STRAY BULLET THAT INJURED GIRL

A man accused of firing a bullet into the air that wounded a 12-year-old girl in Norwalk was in prison today as a result of a detective's hunch and ballistic evidence that tied his handgun to the crime, authorities said.

The girl was injured about 8:15 a.m. Nov. 28 in the 14000 block of Jersey Avenue, the sheriff's department reported.

Andres Ruiz, 35, of Norwalk, was arrested in January and has since pleaded no contest to a charge of discharging a firearm in a grossly negligent manner, with a special allegation of great bodily injury, a sheriff's statement said. On Feb. 2, Ruiz was sentenced to serve 52 months in state prison.

"The bullet fell from the sky and struck the girl on her forehead," a sheriff's statement said. "The impact

of the bullet caused extensive non-life threatening trauma to the girl's eyebrow and eyelid."

The girl was taken to a hospital for treatment and is continuing to recover.

"Initially, it was unclear how the girl was injured," the statement said. "Witnesses did not see or hear anything that would have explained the unforeseen injury. However, after a .40-caliber bullet was found inside the girl's backpack, the authorities were alerted."

A break in the case came on Jan. 24, when the Norwalk Station received a call about 9:50 a.m. regarding gunshots heard in the area of Gard Avenue.

"Patrol deputies responded to the area and located expended shell casings in the street," the statement said. "Based on witness statements, deputies detained a suspect near the scene. The suspect was in possession of a loaded .40-caliber handgun."

Zooming across a black-and-white checkered finish line at 140 miles an hour in a 400-horsepower car is not unusual for La Mirada High School sophomore Ryan Vargas, who's been racing since he was 11.

"Growing up, I always loved monster trucks, demolition derbies and Thomas the Tank Engine," Ryan said. "When my dad took me to a NASCAR event at Irwindale Speedway, I found out that kids could actually race cars and saw it as an opportunity to do something I loved."

Since then, Ryan has tied for national championships in the Bandolero division in 2014, set five track records across Nevada, California and Arizona, and earned Rookie of the Year in 2015 at The Bullring at Las Vegas. In 2016, he competed in 27 races, placing in the top five 12 times and top 10 25 times, along with reaching fifth place in the California state standings.

Most recently, he was awarded the Wendell Scott Trailblazer Award by NASCAR, which recognizes a high-performing minority or female driver contributing on and off the track in the NASCAR Whelen All-American Series.

"I'm just really, really thankful," Ryan said. "Being selected to receive this amazing award is such an honor in my life and in my career."

Racing cars also gave Ryan an opportunity to raise awareness of Down syndrome. In November of 2016, Ryan met a family whose son, Zachary, was born with Down Syndrome. When Ryan found out the family was involved with the nonprofit organization The Upside of Down, he decided to support the cause.

When I saw Zachary playing with my old monster truck cars, I wanted to give him the experience that I have when I'm racing cars," Ryan said. "I want to support their cause to make people aware of Down syndrome and grasp hold of what to expect when they have a child with Down Syndrome."

If he's not at a race track, Ryan's spending his time maintaining a 4.0 gpa and studying for two honors classes and a pre-Advanced Placement course. After school, he's practicing and competing on La Mirada High's track and field team. This is all on top of finding racing sponsorships and funding, which typically go toward new tires and fuel for every race.

"I know racing takes a lot of effort and time from me and my parents, and I'm always going to work my hardest because I know my parents are doing the same for me," Ryan said. "My parents are working overtime to support my racing and I can't be more thankful for their support."

Ryan wants to eventually move up the ranks in NASCAR, and if he's unable to reach the top tiers, he'll still find a career working with automobiles.

"I love cars - I always have as a kid and I still do now," Ryan said. "That will never change."

SLOW-STARTING CERRITOS GIRLS SQUAD RELEGATED TO SHARING LEAGUE CROWN WITH MAYFAIR

None of the current members of the Cerritos High girls basketball team were born when the program last finished with an undefeated league season. That came back in the 1997-1998 season when Cerritos was a member of the Mission Valley League.

The next two seasons, Lady Dons shared the league crown before winning the whole thing outright in the 2007-2008 and 2014-2015 seasons, but with 11-1 league marks. Cerritos had an opportunity to go unblemished in all 12 league games when it hosted Mayfair High this past Tuesday night. But poor shooting early on and the inability to make timely free throws cost

the Lady Dons as Mayfair held on for a 67-65 win. Cerritos trailed by as many as 13 points and even by 11 points with 1:40 left to play. But the Lady Dons simply ran out of time.

"I don't know what is about this year, but this year is a little bit different," said Cerritos head coach Marcus Chinen. "Last year, it seemed like we were almost comfortable at home and away, we kind of faltered a little bit. This team is different. When we go away, they play a little better."

Defensively, the Lady Dons came out strong, forcing half a dozen turnovers in the opening quarter. But they were unable to turn those miscues into points and converted on four of 18 field goals in the opening stanza as the Monsoons built a 21-11 lead. Cerritos was able to cut its deficit to four points late in the second quarter after a three-pointer from sophomore Lindsay Fujihiro and trailed by five points at halftime. But the Lady Dons would go into the break shooting 31 percent from the field and missing six of 14 free throws.

"We just didn't execute and take advantage of their turnovers," Chinen said. "We just couldn't score. [Senior] Ifeoma [Okoli] got into foul trouble early and that's a big difference right there, when you have to take that big presence off the court."

Cerritos would get within four points again less than two minutes into the second half before the Monsoons, who had lost at home by two points to Cerritos on Jan. 11, increased their lead to 11 points following Sarah Clausen's basket off of one of her three offensive rebounds in the third quarter.

The Lady Dons, though, began to

rev up its shooting and went on a 19-10 run that ended 65 seconds into the fourth quarter. But Mayfair would respond with a 9-0 run and held a 62-51 lead. That's when senior Cailey Vitug took over. After being held to 12 points in the first half, Vitug hit three straight three-pointers in a span of 40 seconds and just like that, Mayfair was clinging to a 63-62 lead with 32.9 seconds left.

But Ayah League, who had 10 points in the fourth quarter, iced the game with four straight free throws before Vitug's last three-pointer at the buzzer ended the game. Vitug, in her final regular season home game, scored a career-high 31 points on 11 of 21 shooting from the field. She also had four rebounds and three steals. In her last four games, Vitug has scored 75 points.

"We try to get her to go to the basket and she tries to draw the contact," Chinen said. "And a lot of times, she doesn't get the contact. That's one of the main things we try to work on her this year. She didn't shoot the ball very well in the first half. But in the second half, when we really needed it, she was able to come through for us."

Senior Teresa Torres added eight points while Fujihiro and Okoli each pitched in with seven points. Okoli also had eight rebounds and three steals while Fujihiro had four rebounds and three steals.

The loss to Mayfair also snapped a 12-game winning streak as the Lady Dons will enter next week's California Interscholastic Federation-Southern Section playoffs with a 17-9 record. Last season, Cerritos was 17-11 and finished in second place in the league with a 10-2 mark, both losses coming to Mayfair.

"I think, through the girls and just speaking to them and watching their body language, I'm sure it hurts a little bit and they're disappointed," Chinen said. "But you know what, we're co-Suburban League champs and I'll take it. We put one up there (pointing to Suburban League girls basketball champions banner) and I'm hoping that in the playoffs, whoever goes to the playoffs from the Suburban League, I hope we all have a great turnout as far as all of us going far in the playoffs."

Following the game, the Cerritos boys stayed within a possession or two with the Monsoons throughout the first quarter. But Mayfair outscored the Dons 22-8 in the second quarter en route to a 74-58 win. The Dons end the regular season at 13-14 overall and 8-4 in league play, good enough for third place.

The last Cerritos lead came at 10-8 midway through the opening stanza on a three-pointer from junior Vincent Biscoe. A downtown shot from junior Dorian Harris with 3.8 seconds remaining made it an 18-16 Mayfair advantage. Another trifecta from Harris brought Cerritos to within two points again 40 seconds into the second quarter. After that, it was all Mayfair, who went on a 19-5 run the remainder of the half.

Harris came off the bench to post a career-high 19 points and also grabbed six rebounds while junior Destin Flucas added 14 points and eight rebounds.

The basketball playoff brackets will be released Sunday afternoon with wild card games, if necessary, beginning on Tuesday for the boys and girls and first round games on Wednesday for the boys and Thursday for the girls.

YOUNG VALLEY CHRISTIAN GIRLS SOCCER SQUAD SURGING TOWARDS DEEP RUN IN PLAYOFFS

Following her team's 1-0 win over Arroyo High in last season's California Interscholastic Federation-Southern Section Division VI wild card game, Valley Christian High head coach Kim Looney sent a message for the 2017-2018 season. Looney said to back in two years to watch her team because the players she'll have will be amazing.

She was already giving praise to the nine sophomores and three freshmen that were already playing like upperclassmen. Maybe she was a year too early because those young players have developed into a championship-type team this season.

After finishing in third place in the Olympic League the past two seasons with a combined overall record of 17-23-8, the Lady Crusaders have bounced back in a big way. Heading into the final regular season game at Heritage Christian High on Feb. 9, V.C. was sporting a record of 15-3-3 and 7-0-0 in league action. V.C. has won its fifth outright league crown in the past seven years and ninth overall in the 16 seasons that Looney has been the program's coach. Looney is also in line to go through her third unblemished league season. Overall, V.C. has won 14 girls soccer league titles.

What makes this season somewhat unique is that the Lady Crusaders have not been scored upon in eight straight games and 11 times overall. V.C. has allowed 16 goals thus far, which would be reminiscent to the 2002-2003 season when that team allowed 12 goals and posted 17 shutouts, including seven straight at one point. But Looney compares this season's team with another one.

"No, because we went out in the quarterfinals that year," Looney chuckled. "This team actually seems a lot more similar to my 2009 [team] in the sense of the feel that I have with them. They were on a 13-game non-losing streak. The team back in 2002...it was filled; it was stacked. And we are stacked this season. We are attacking from all different sides of the field in the game."

Unlike previous seasons when Looney would already have a number of juniors to replace graduating seniors or a number of sophomores to fill in the void of the juniors from the previous seasons, she says this team has been waiting and has had to do their time. Looney had to build this season's team, which now has eight juniors, five sophomores, five freshmen and two seniors.

The strength of the defense begins with the tandem of junior Destinee Montenegro and freshmen Cassidy Samuelson in goal. The latter was the starting goalkeeper in December but has since been playing on the junior varsity squad. Montenegro has played in all seven league games. In front of them is a solid defense headlined by junior defenders Carli Domino, Marysa Garner and Caitlyn Wind, among others. Adding to an already solid defense is freshman defender Emma Spresney, who has fit the mold perfectly, according to Looney.

"With those two, because Destinee has still worked with us, I have two solid keepers," Looney said. "And then Cassidy is coming up with us during playoffs. Carli is an outstanding defender, probably one of the best defenders in our league. Marysa has been in that defensive spot since she was a freshman and Caitlyn Wind has been in that defensive spot [as well]. They know what to expect, so they're going into their third year."

"When you have someone solid in the goal and you have a solid defensive line, good things are going to happen because defense wins championships," she added.

In the past, V.C. has had a history

of getting off to very slow starts, then turning it up by the time league play comes around. But not this season, as the team has not lost since a 3-1 setback to St. Margaret's High on Dec. 16. Since then, the Lady Crusaders have gone 12-0-2. In fact, all three losses have come in succession in a span of six days.

During the 2004-2005 season, the Lady Crusaders jumped out to a 5-0-1 start, then lost three straight games before finishing as Division V co-champions with a 17-3-3 mark. The program has won more than 17 games twice since that season. The first came two seasons later when the program was Division V co-champions again at 18-8-4 and the other came in 2008-2009 when V.C. finished 20-9-2 and lost in the Division V finals.

"I had 20 on the roster when we started and now 19," Looney said. "We have been blessed not to have major injuries. That's not something that we're used to. That's why I took 20 on my roster, because we tend to have [major] injuries. Just to be able to work at practice each day with almost two full squads says a lot when we go into games, because we're able to work on so many different things."

Offensively, the Lady Crusaders have been paced by freshman forward Janna Dunk and sophomore midfielder Kennedy Wesley. The former is the younger sister of 2013 V.C. graduate Jahdai Dunk. The younger Dunk leads the team with 13 goals, including five at Maranatha High on Jan. 20, which set a new school record. Janna Dunk admitted she never expected to be leading the team in scoring in her high school rookie season and said she expected to be the leader by the time she was a junior or senior.

"The season has been great," Janna Dunk said. "We haven't only bonded just as a soccer team, but we've bonded as friends and it's been way more than I ever imagined. I thought it was going to be maybe a little nerve-racking because I'm a freshman and it's probably going to be hard to really get to know people. But honestly, it's been amazing."

The younger Dunk has memories of watching her older sibling play all four of her high school seasons on the varsity squad and even shagged balls during the pregame warm-ups. Janna Dunk would even go to every practice and pondered the thought of playing for the Lady Crusaders by the time she reached high school.

Wesley, who is a member of the Under-17 Women's National Team, is one goal behind Janna Dunk. Together, those two have helped the Lady Crusaders score 66 goals through the first 21 games. Even with her commitments with the national team, Wesley has missed just two V.C. games.

"Last year, we had a few more upperclassmen than lowerclassmen and most of us thought that would probably be better for us," Wesley said. "But I think this year has definitely been a lot better. The freshmen that came in are unbelievable. They have helped drive our team."

Even with all of the shutouts and high scoring games a couple of times, Looney doesn't want her team to let up. In that Maranatha game when team was up 5-0, Looney still needed her team to clean up in a few areas and be more disciplined in certain areas. Every time, the team has risen to every challenge.

"What Janna gives to our team is speed and athleticism, and she can finish in front of the net," Looney said. "All of these kids on my team have different gifts. That's Janna's. Am I excited that she's a freshman and I get her for four years? Absolutely, I do. She's a great kid. But that doesn't diminish the rest of them.

"Kennedy is an athlete that we haven't seen come through our system," Looney continued. "I compare her to the likes of Hayley Haagsma [and] Lynzi Bullick. She is that caliber of a player. But what is really cool about Kennedy is she's played a lot of soccer in her life and she's very humble about it."

Should V.C., ranked second in the Division VI poll, run the tables and win the school's third CIF-SS championship, it would finish with what might be a school record 21 wins, not including the potential for more in the Southern California Regional championships. Looney, who currently has compiled a 236-121-49 overall record in her tenure at V.C., has had a pair of 20-win seasons.

"As for the month of January, our team goal from the beginning

of the season was to win a league championship," Looney said. "We never said anything about shutouts. We never said anything about having a perfect 8-0 [league record]. We never said any of those. We just wanted to be league champions because it stunk to be in third place two years in a row."

"I think the biggest difference is our relationships off the field have strengthened so much from last year, and that has really translated onto the field," Wesley said. "Our captains this year have also taken a lot more initiative about what's going on on the field and communicating with everyone during the games. Everything has just improved from last year. It's definitely a lot more fun."

WHITNEY BOYS BASKETBALL GETS IMPORTANT WIN TO KEEP FAINT PLAYOFF HOPES ALIVE

DOWNEY-With four games remaining in the regular season heading into its road game at Calvary Chapel Downey High last Thursday night, the Whitney High boys basketball team knew that there was very little wiggle room as far as its postseason chances were concerned. The Wildcats needed a win in the worst way against a team below them in the Academy League standings.

Whitney rose up to the challenge and rallied in the final minutes to escape with a 60-53 win over the Grizzlies, scoring the final nine points of the game.

"At first I thought we were okay," said Whitney first-year head coach Wade Morris. "And then, it's their senior night and they started fighting. So I had to get involved emotionally and it seemed like most of the calls were going their way. We weren't getting any calls. We just had to get after it emotionally."

Despite a high volume of shots not going in early (five of 21 from the field in the first quarter), the Wildcats were able to lead 15-5 in the opening seconds of the second quarter. Part of the reason can be attributed to the strong effort on both sides of the glass as Whitney grabbed 14 rebounds in the first quarter, eight on the offensive end. Senior Peter Kang would have half of those offensive boards and finished the game with eight in the game.

But Calvary Chapel Downey would slowly work its way back in the game and outscored the 'Cats by one in the second quarter. Whitney would open another 10-point lead, this time with 6:23 remaining in the third quarter before the hosts reeled off nine straight points in less than three minutes. It was at that point that Morris would sum it all up in one word.

"Energy," Morris said. "That's why I stuck in energy guys. I stuck in energy guys and they couldn't do it. So then I stuck in my five that always play together and just got on their behinds and said, 'let's go'. That did the trick."

The Grizzlies took their first lead with 90 seconds remaining in the stanza on a basket from Jose Campos and the teams would trade baskets for most of the fourth quarter. A three-pointer from Campos opened up the fourth quarter and gave Calvary Chapel Downey their largest lead of the game at 39-36.

Probably the biggest play of the game came 91 seconds into the fourth quarter when junior Daniel Sou had his fourth steal and scored to give Whitney a 41-39 lead. That came 16 seconds after hitting a three-pointer. Later in the quarter, his second downtown shot of the stanza (third

in the game) ties the game at 51-51.

The game was finally sealed with 13.8 seconds remaining when junior Heaven Flores had a steal, scored, was fouled and hit the subsequent free throw to put the 'Cats up 57-53. He then scored the next three points on free throws to finish with 17, his most since scoring 20 against Brethren Christian High back on Jan. 6.

"Heaven is incredible," Morris said. "He was upset because he wasn't getting any calls and I say, 'hey, just tough it out'. He listened and he toughed it out. This guy's courage going to the basketball is incredible."

Senior Ben Barnett added 12 points and had six rebounds while Sou finished with 11 points. At the time of the win, Whitney had evened its overall mark at 13-13 and was 4-5 in league play and Morris was confident his team could upset either Crean Lutheran High last Saturday, Sage Hill High this past Tuesday or Oxford Academy on Feb. 9.

"Hope is eternal," Morris said. "So, I believe that we can win two out of three games. We have to play perfect against Crean [Lutheran]. We have to play perfect against Sage [Hill] and against Oxford. But I believe these guys can do it. They can get it done."

Unfortunately, the 'Cats fell to the first two teams and needed to beat their arch rivals from Cypress just to tie Oxford Academy for fourth place. Either way, this season has been an improvement over last season when Whitney was 8-12 overall, 3-9 in the circuit and finished in fifth place.

Prior to the game, the Whitney girls basketball team, one of four teams in a scramble to finish anywhere from second to fifth place, came up short in a 31-25 decision. Both teams combined for two field goals in 16 attempts in the first quarter with Whitney leading 3-2.

But the Lady Wildcats were outscored 12-1 in the second quarter and never recovered. A three-pointer from senior Nicole Lee drew the visitors to within three points (25-22) with 6:20 left in the game. Two minutes later, sophomore Christine Hamakawa scored to make it a one-point game. But Whitney was held scoreless the final 3:07 of the game.

An acre-foot is 326,000 gallons of water or the amount an average sized California household uses in a year. The expansion is part of Central Basin's focus on securing regional water reliability while reducing dependence on imported

water supplies.


"The best way to describe an acre foot," said CB Board President Phil Hawkins, "is the amount of water it takes to cover a football field one foot deep."

CB's recycled water system will be extended from south Santa Fe Springs into the City of La Mirada. Specifically, the recycled water expansion will connect to CB's existing recycled water pipelines at Bonavista Avenue, continue east on

Gannet Street, north on Biola Avenue, and would travel north and east through the City of La Mirada.

The system expansion will serve landscaped facilities for an estimated 20 sites, including parks, schools, landscaped street medians, a memorial park and City Hall.

The project is currently undergoing CEQA environmental compliance as part of the project design aspect. CB is

working with Aspen Environmental to review the environmental compliance. Tetra Tech, an engineering firm based in Irvine, is working under CB's direction to conduct the engineering design for this project.

Tetra Tech recommended that a pump station and reservoir is needed to deliver recycled water at the necessary water pressure for the sites.

Design and environmental review is scheduled to be complete by August 2017. Both processes are necessary prior to breaking ground.

Overview of the Central Basin Recycled Water System

Currently, CB's recycled water system is comprised of of two distribution systems, four pump stations and over 80 miles of pipeline.

The distribution systems are responsible for the delivery of treated water and include the Century Distribution System and the Rio Hondo Distribution System. The pump stations include the Rio Hondo Pump Station, Hollydale Pump Station, Cudahy Pump Station and Cerritos Pump Station. CB obtains recycled water from the San Jose Creek Reclamation Plan and from the Los Coyotes Reclamation Plant.

students have a real passion for science." Their passion showed. They peppered the Conservancy's educational staff with questions about the Island's plants and animals. They learned about how the Conservancy and its partner, the Institute for Wildlife Studies, worked together to bring the endangered Catalina Island fox back from the brink of extinction. And they hiked to Ben Weston Beach, where they shed their shoes, rolled up their pants

and dashed into the surf.

There, they also completed a short class and workbook on Catalina Island's ecosystem and explored a salt grass and salt bush under a field microscope linked to an iPad. Too soon for the youngsters, the lessons at the beach ended, and they had to hike quickly back to the bus. Joshua Mahar summed up the day for his classmates.

"This is way better than any other field trip I have ever been on," he said. "You can do way more things out here. It's just pure nature, and you get to experience it!"




