BARROWS AND HIS ATTORNEY THREATEN HMG-CN OVER ARTICLE

Barrows now says he did not retract his defamatory statements when emails from his attorney clearly show he did.

It is becoming apparent that Cerritos City Council candidate Bruce Barrows has recognized that he is in an extremely difficult position related to the defamatory and libelous statements he made slamming Hews Media Group (HMG) and Publisher Brian Hews.

HMG received a letter from a second law firm hired by Barrows, Long Beach based Cameron and Pearlson, who threatened HMG with further action "if you do not cease publishing articles about Barrows."

COUNCIL CANDIDATE CHUONG VO RETRACTS DEFAMATORY STATEMENTS MADE ABOUT HMG-CN

Emails between Vo and Hews show Vo lied in Facebook post, Vo joins Barrows in defaming HMG-CN.

Once again ethics and honesty have taken a backseat in the race to secure a prized Cerritos City Council seat in the upcoming April 11 election.

Hews Media Group-Community News reported last Friday that perennial candidate Bruce Barrows libeled and defamed HMG-CN Publisher Brian Hews in a blistering email sent to his campaign base that was laced with Donald Trump like insults and several accusations that Barrows knew were false.

Barrows has stated he will retract his statement "the next time he sends a campaign email."

Cerritos resident Elayne Shiohama also participated in the Barrows attack against Hews, with sources telling HMG-CN that Shiohama is angling for a paid Commissioner appointment if Barrows is elected.

Now Cerritos residents can count Torrance Police Detective and council candidate Chuong Vo, and Vo's campaign manager-who will not admit he is Vo's campaign manager-Cerritos Commissioner Brad Beach, as additional participants in

the libel and defamation campaign meant to discredit and irreparably harm the reputation of HMG-CN.

Vo recently posted on a Facebook page inflammatory and false statements that were very similar to those contained in Barrows' libelous email.

The members-only Facebook page is called Cerritos One Press; at the time of the post both Vo and Beach were administrators of the page.

Administrators of a Facebook page have complete control; since it is closed Facebook page they can accept or deny members and they can add and delete

In an email Beach said, "I was asked to help vet new members (for Cerritos One Press) since I know a lot of people here from growing up in the City."

HMG-CN asked to be allowed into the group and was denied; HMG-CN was told that several other Cerritos residents were also denied

In the defamatory statements, posted on or before Jan. 21, 2017, Vo stated, "So the local community newspaper and owner Brian Hews is trying to influence the city election again to get his candidates and friends in office. [Hews is also] railroading other candidates that won't give him money. Don't believe everything you read in the newspaper, Brian Hews lied about candidates in his newspaper. And he is doing that again about me because I will not buy advertisements in his newspaper."

The post, which alleged extortion by Hews, solicited several extremely negative comments that were seen by every member on the Facebook page.

In a long-winded comment, ABCUSD Board Member Lynda Johnson even got in on the action hurling several unsubstantiatedclaims about Hews and HMG-CN.

The post was up for several days, with Beach and Vo, in their administrator roles, allowing the Vo post to remain visible.

Hews was alerted of the libelous statements by a member of the page, retained an attorney, and immediately sent a letter to Vo and Beach demanding

Within two hours, Beach claimed he had no part in the page other than to "vet members", while Vo quickly removed the

The letter read in part, "the content of a recent post on Cerritos One Press accuses Mr. Hews of engaging in the practice of extortion. Specifically, Mr. Vo in the post stated: "he is doing that again about me because I will not buy advertisements in his newspaper."

The letter went on, "Scrutiny of the meaning of "that" appears to refer to be based on the charge that Mr. Hews is "lying in his newspaper about candidates."

"Such reckless comments have apparently ignited events leading to a series of negative statements resulting in direct economic harm, and potential irreparable harm, to the credibility and reputation of Mr. Hews and his publications."

The letter ended, "be cautioned that the continued maintenance of the disparaging comments may result in litigation and joint liability. My suggestion is that Facebook post be deleted immediately to avoid further adversary action, and that Mr. Hews be admitted or unblocked to inspect the removal of the defamatory statements."

Within two hours, Beach wrote back claiming he had nothing to do with the page, "I did not create this Facebook page, and am only a member of the page. I was added as an administrator when the page was first created to vet new members and to make sure that new members lived in Cerritos."

The Vo post was sent to Hews on Jan 21, Beach indicated he was "removed as an administrator earlier this year," but would not give a specific date when asked. Consequently Beach knew about the post for several days after Vo posted and did not remove it.

And other comments on Facebook by Beach show he, like Vo, is on a campaign to discredit

One hour after Beach's email, responded and agreed to remove the post, "thank you for your letter. Although I believe I did nothing wrong, I have removed the post from the Facebook account."

Vo ended with a defiant tone, "I will not grant access to a private Facebook account to Mr. Hews. This email will serve as proof that the post has been removed from the Facebook Group you described. I can also meet with Mr. Hews to have him look at the Facebook group on my phone."

Hews stated, "Vo said he did nothing wrong? Vo is a police officer and he knowingly lied and defamed me in his Facebook post, which generated several negative comments, he deleted the post two hours after we

he lied."

Hews then produced emails between him and Vo that corroborate Hews' assertion that Vo knowingly and maliciously lied to damage HMG-CN's reputation in his Facebook

In his post Vo stated, "so the local

community newspaper and owner Brian Hews is trying to influence the city election again to get his candidates and friends in office. [Hews is also] railroading other candidates."


"To the contrary," Hews said, "I offered Vo free space for his candidate's statement."

On the morning of Thursday January 12, nine days before Vo's defamatory post, Hews offered all candidates, including Vo, the opportunity to publish candidate's their statements at no cost in HMG-CN.

If the candidate's statement were an advertisement, it would cost in excess of \$500, that does not count the additional publicity, HMG-CN reaching over 160,000 readers per week.





The City Council recently certified the results of the General Municipal Election held on March 7, 2017.

John Lewis was elected to the City Council representing District 1 and Andrew Sarega was elected to the City Council representing District 2.

The term of office for both is four

This was the first election by which members of the La Mirada City Council were elected by-district.

Districts 3, 4, and 5 will elect representatives to the City Council in 2019.

Steve De Ruse, Ed Eng, and Larry Mowles also serve on the City Council, as each was elected to an at-large four year term in March 2015.

Ed Eng was selected to serve as Mayor at the March 28 City Council Meeting.

GROW AN ABUNDANT TOMATO HARVEST IN A POT

By Melinda Myers

Harvest and enjoy the garden-fresh flavor of tomatoes right outside your kitchen. Grow them in containers set on your patio, balcony, deck or stairs. You'll enjoy the convenience of harvesting fresh tomatoes just a few feet away from where you prepare your meals. And your guests will enjoy harvesting fresh tomatoes to add to their salad or sandwich.

Tomatoes need warm air and soil to thrive. Containers give you the ability to jump start the season. Plant tomatoes in containers earlier than in the garden and leave them outdoors when it's warm (but bring them inside whenever there's a danger of frost.) Protect your plants with the help of season-extending products like cloches, red tomato teepees or garden fabrics. These will help warm the soil and air around the plants, reducing the number of days to your first harvest.

Select flavorful and disease-resistant varieties for your container gardens. Consider 'determinate' tomatoes that are more compact and generally less than four feet tall. But don't eliminate your favorite indeterminate tomato. Just provide a strong

tall support for these plants that continue to grow six feet and taller throughout the season.

Grow your tomatoes in a sunny spot that receives at least eight hours of direct sunlight. You'll grow the biggest harvest and reduce the risk of disease.

Fill your container with a quality welldrained potting mix. Add a slow release organic fertilizer to your potting mix if needed. This type of fertilizer feeds the plants for several months. Give the plants an additional feeding midseason or as directed on the fertilizer package.

Check soil moisture daily, water thoroughly and often enough to keep the soil slightly moist. Maintaining consistent soil moisture means healthier plants and fewer problems with blossom end rot. This disorder is not a deadly disease, but it causes the bottom of the first set of fruit to turn black.

Reduce your workload by using self-watering pots like the Gardener's Revolution® Classic Tomato Planter (gardeners.com). These pots have a 5-gallon reservoir for holding water that moves up into the soil to the plant roots as needed. This means you'll be filling



the reservoir less often than you would and increase productivity by growing normally water other planters.

Stake or tower your plants to save space, increase air circulation around and light penetration into the plant. You'll further reduce the risk of disease vertically.

So start gathering your favorite tomato recipes now, as soon you'll be harvesting armloads of tomatoes to use in salsas, salads, sauces and of course BLTs.



VALLEY CHRISTIAN COMES UP SHORT IN FINAL INNING AGAINST VILLAGE CHRISTIAN

Village Christian High's baseball team won the Olympic League last season and is currently on top of the circuit this season. But Valley Christian High first-year head coach Roger Penticoff doesn't consider Village Christian High better than his

In fact, he considers Valley Christian one of the top teams in the league, and after his team nearly rallied to knock off the other V.C. Crusaders, this one from Sun Valley, it's easy to see why Valley Christian is considered a threat.

Valley Christian rallied twice from tworun deficits and had the bases loaded in the bottom of the seventh inning before falling to Village Christian 6-4 this past Tuesday evening. Valley Christian dropped to 9-6 overall and 2-3 in league play.

"I had no issues with the heart that these guys have," Penticoff said. "They hit the ball well; they played good defense. We just let a couple of opportunities get by us and it hurt."

Village Christian got to junior starter Brett Garcia in the first inning for a pair of runs as Michael Choi singled home Connor

Rodriguez and Josh Argarin scored on a wild pitch. Garcia would throw 27 pitches in the inning which would lead to a high pitch count towards the end of the game.

But Valley Christian would come back in its half of the frame. Senior shortstop Travis French doubled to left field and with two outs, came home on a double down the right field line from senior right fielder Kyle Bowie. Three pitches later, he would tie the game when sophomore second baseman James Stirton was safe on

The game remained tied until the fourth when Jake Whisenant and Nick Rolls hit back to back doubles. In the next inning, Garcia walked Rodriguez to lead off the frame and after moving on a wild pitch and a groundout, scored on a sacrifice fly from Argarin.

Garcia would help himself out in the bottom of the fifth when he launched a two-run home run over the left field fence with senior center fielder R.J. Van Kampen coming in before Garcia. Just two innings earlier, Valley Christian had a chance to take a 3-2 lead when Garcia singled and stole second in between the 11th and 12th pitch thrown to Bowie, who would eventually strikeout after seeing 13 pitches from Tobias Plotkin.

"At the time, I wasn't thinking about sending Brett," Penticoff said. "Brett is my pitcher and I'm figuring I really don't want him running the bases. But throughout that entire at-bat, they made one move to Brett. So, I'm thinking, okay, I'm just going to

"Kyle's at-bat was just phenomenal," he continued. "I couldn't ask for anything more from him. He battled, battled, battled and ended up striking out. But again, he put a lot of pitches on that putcher and I'll take that all day long."

With Garcia's pitch count approaching 100 entering the sixth inning, he went out there and avoided further damage when he got a pop-up and a groundout after Whisenant singled with one out, moved to second on an error and advanced to third on a wild pitch. Garcia finished the game scattering four hits and striking out three. But he did issue half a dozen walks.

"He gutted it out," Penticoff said. "This wasn't Brett's best performance. [He threw] too many walks, but he got big outs when he needed to get big outs. He is a battler out there."

After Village Christian scored twice in the seventh inning on a run-scoring single from Argarin and a run-scoring double from Choi, the hosts still had enough to make it interesting. With two outs, French singled, Van Kampen doubled and Garcia was issued an intentional walk. Eric Oseguera then got Bowie to strike out on a 2-2 count. French, Garcia and senior starting catcher Christian Bosse all collected a pair of hits. The game was a far cry from the league opener on Mar. 14 when Village Christian won 12-2.

"I think we can play right with them as we proved today," Penticoff said. "If we cut down our walks today, we win this game."

The two teams will meet tonight for the third and final time in the regular season with Valley Christian as the visiting team. Valley Christian will then host St. Anthony High on Tuesday night. As for the remainder of the league season, Penticoff is confident his team can remain on the heels of Maranatha High and Village Christian, both of whom are tied for first place.

"Maranatha, to me, is loaded," Penticoff said. "They are good one through nine and they have three excellent pitchers. In my opinion, they are the team to beat. Will we compete? Well, we're going to give it our best. R.J. is going to be throwing on Friday at Village. We get our chance at Maranatha again and we'll see what happens. But they're loaded."





Paul R. Pearlson, who is famous, or infamous depending on one's view, presented an "incredibly tortured argument" that challenged a California state law that protected the confidentiality of people who took the AIDS virus test, wrote the two-page letter to HMG.

Pearlson asserted that the two stories involving Barrows Bruce on Propositon H and Article IV of the Cerritos City Charter, with Prop. H mandating a four-year waiting period after serving consecutive two four-year terms, "false and was refuted by the city of Cerritos."

The Pearlson demanded letter that HMG publish the letter that City Attorney Mark Steres of Alshyre and Winder wrote in opposition to HMG's article.

The letter, which is basically Steres' biased opinion legal on the ruling of Article IV, "was to be published immediately after any articles HMG concerning Barrows."

In his first letter to refute HMG-CN's article, Steres cited then Attorney General Bill Lockyer's opinion in 2004 that stated Prop H. was a twoyear ban.

After a second article was published about Article IV, which included the results of two judicial decisions on Article IV fifteen vears earlier, Steres then proceeded to refute the two judges who handed down a favorable ruling for Prop H. proponents.

Steres once again leaned on the AG's opinion; an opinion that did not cite the two judicial decisions that occurred years

earlier.

According to the Attorney General's own website, "The attorney general's opinions are advisory, and not legally binding on courts, agencies, or individuals."

Proposition H told HMG, "if those against Prop H. thought it was only a two-year ban, why did they spend \$50,000 to fight

Steres to do that."

The second part of the Barrows/ Pearlson letter attempted to refute the article published last week that Barrows defamed HMG Publisher Brian Hews.

Pearlson stated, "HMG also continues Chris Fuentes, one of the authors of to falsely assert that Mr. Barrows had supposedly made libelous and defamatory statements against you and also falsely asserted that Mr. Barrows'

Hews stated, "I have emails from Patrick Stacker that said, and I am quoting, I'm counsel for Bruce Barrows on various matters....we are working on a retraction...Bruce is going to retract it but he is going to do it in his normal email blast whenever that might be in the near future. I think he has 10 days after the request to be honest with you. Do you think he legally has to do it sooner?"


For background, Barrows, in an email to his campaign base, stated, if we were to believe the false headlines written by "Fake News Hews" in the Los Cerritos Community News, it would be easy to believe that the City Clerk and the City Attorney allowed me to run for City Council illegally. Nothing could be further from the truth. However it seems that this paper specializes "Fake News", maliciously creating lies and falsehoods, and refusing to print a retraction even when proven wrong. They (may be again fined) for using a[n] ex-employees email address [Jerry Bernstein] to attack residents."

The statement perpetrated several lies:

and lies," Hews said, "that's what he does, he assaulted Jay Gray after Gray questioned him at a Council meeting, he withheld funding for Skyknight if council did not cut HMG-CN's print budget, he sends out a defamatory emails and then denies it and retains an attorney to try and scare me. He will do anything to anyone, he's a politcial bully."


