PIONEER PROMENADE PROJECT: PIONEER BOULEVARD WILL RETURN TO FOUR LANES

HMG-CN INVESTIGATION:

COMPLAINT: MONTEBELLO CITY MANAGER TUCKER-SCHUYLER, TWO EMPLOYEES COLLUDED IN JCS IN CONSTRUCTION FRAUD

Last year, an exclusive Hews Media Group-Community News investigation found that the City of Montebello paid nearly \$500,000 from 2013 to 2016 to an obscure construction company, JCS Construction (JCS), using sole source no-bid contracts – while fabricating documents using sham companies with false names and addresses and suspended state contractors licenses – so JCS could win the lucrative jobs.

HMG-CN found that JCS was a sole proprietorship based out of a home in Hacienda Heights owned by David Magallanes who is the pastor of Scattering Seeds Fellowship in Whittier.

The business did not have a website or a social media presence.

The company could not be found on L. A. County's business name registration page, "DBA," or in the state's database of corporations.

Even more suspect, the "Agreement Log" that lists all contracts with the City did not list JCS as a contractor.

Finally, some of the bids JCS submitted to the City contained numerous grammatical errors and misspelling of very simple words.

In spite of this, the City paid JCS \$53,000 in 2013-14, \$121,000 in 2014-15, and a massive \$320,000 in 2015-16.

The investigation resulted in a whistle-blower lawsuit against Magallanes who subsequently acknowledged that he had submitted multiple bids after some of the work was completed for his projects.

The lawsuit focuses on the three contracts HMG-CN uncovered that were submitted by JCS, and two other companies, Brown Construction of La Habra and CAT Contracting of Montebello

"The bids were not real, I was asked if I could make some bids up for the city. Those bids were done after the jobs were completed," Magallanes said.

Magallanes would not say at the time who told him to submit the fabricated bids.

City Manager Francesca Tucker-

'ROBO-CALL' FRIGHTENS RESIDENTS WITH QUESTIONABLE CLAIMS ABOUT ARTESIA RECALL

Thirteen seconds into the recording residents finally recognized it was a political robo-call and not an actual emergency call.

A disturbing Artesia recall "Robo-call" was sent to all Artesia residents this past Saturday recorded using the same urgent voice that is familiar to everyone when the state broadcasts a message over the Emergency Broadcast System.

Many Artesia residents were livid, as they thought the call was for an actual emergency.

Under California Fair Political Practices Commission (FPPC) laws, "paid telephone calls" are required to have a disclaimer indicating the committee that paid for the call.

The FPPC site states, "paid for by [committee name] is the basic disclaimer required on most campaign communications."

No disclaimer was given during the recording, which was recorded using an internet call service and a one-time phone number based out of Long Beach.

The call is an indication that some Artesia recall proponents, and their reported campaign consultants, are willing to do anything to reach their goal of recalling Mayor Ali Taj, and Councilmen Miguel Canales and Victor Manalo.

The main proponents of the recall are residents René Trevino and Dorothy "Dody" Kane who are receiving assistance from Cerritos residents Melinda Kimsey, her partner Jerry Bernstein, and Artesia businessman Guralp Sood.

The call did not try to conceal the sender saying, "this is a public safety announcement from Artesian's for Artesia Now."

On July 27 of this year, Kane invited friends to join "her Facebook group" Artesian's for Artesia Now.

The affiliation could land Kane in legal hot water with the FPPC, and could warrant an investigation if a complaint was filed.

The recording started using the

CITY ORDINANCE REGULATES USE OF LEAF BLOWERS

Under City ordinance, the use of leaf blowers in any residential area and in commercial areas within 400 feet of any residential area in the City is restricted to the hours of 8 a.m. to 5 p.m. Monday

through Friday, 9 a.m. to 5 p.m. on Saturdays and 11 a.m. to 5 p.m. on Sundays and legal holidays. The City ordinance regulating these hours was designed to protect residents from excessive noise caused by such equipment.

Leaf blowers also should not direct debris onto adjacent parcels or lots. Such debris should be removed and disposed of to prevent dispersion.

PIONEER PROMENADE PROJECT:

PIONEER BOULEVARD WILL RETURN TO FOUR LANES

Three items took center stage on Monday's Artesia Council meeting and all had to do with the Pioneer Promenade Project.

The council was to consider ceasing all work on project and make immediate changes to the Pioneer Promenade plans including unverified safety concerns.

"I want to share a bit of history on this project that actually began in 2014," stated Mayor Ali Taj, "toward the end of 2014, the Council was united with several downtown merchants to take advantage of monies received for redevelopment and beatification of Artesia."

The original project was to be completed in four stages. Pioneer Project completed the first two stages of which was the extension of sidewalks, planting trees and furniture, with the final phases being the construction of a pedestrian median that would house several dining options, bicycle racks in a pedestrian friendly space.

The Council hoped that these additions and improvements would bring more people into the city and enhance the various events and street fairs.

"The last phase was to have private investors come in and complete the Project," continued Taj, "unfortunately these investors were scared away by the public disapproval of the project. Where we stand today is an issue that has escalated."

In 2016, a ribbon cutting and fanfare was heralded to welcome the modernization of the streetscape. Then-Mayor Victor Manalo stated, "the Council and I are all in one accord when it comes to this project. We know that one of the main purposes of the Council is to promote social, economic, environmental and cultural community. Not just the present, but for our future." The core mission of the City Council is to provide services and infrastructure to facilitate those services, Manalo continued, "what you see here is the result of years of planning and budgeting by various Staff members and City Council."

The dining and pedestrian promenaded was already in the process of being built when residents and business began to express concerns and dissatisfaction.

In February of 2016, a small group of disgruntled business, shop and land-owners gathered at Paratha Grill. They stated that the flow of traffic had been stunted by the reduction of the traffic lanes and it was hurting their business.

Many businesses in Artesia conduct their business using cash as a large part of their revenue so it is difficult to ascertain if the median hurt businesses at all.

They also addressed public safety and fire access. The City assured business owners that the Los Angeles County Fire Department had been included on all projects reviewed the plans and approved them.

But that small group remained steadfast with their complaints.

Fast forward to the council meeting of September 11th, a standing room only crowd packed the Council room. "The central median cannot remain the way it is now," said Taj, "If we had been able to complete the project six months ago - if our investors had not been scared away, we would be in a completely different situation, at this point we need to take action."

Councilman Miguel Canales defended the original decision of the downtown project saying "I am never going to back down from slowing down traffic on Pioneer Boulevard. There is nothing wrong with having less carbon dioxide, there is nothing wrong with having more air to breath or having fewer vehicles drive down our city streets. The problem seems to be the concerns for emergency vehicles. There is a lot misinformation and miscommunication out there."

"The vision that I had for downtown Artesia, began when I was on the Planning Commission, over ten years ago," commented Councilman Victor Manalo, "I could see the opportunity to take a walk out in the evening, stroll down the Boulevard and have coffee or ice cream and enjoy a beautiful downtown. I believed we were on that road toward that goal to create that vision. We had plans and the plans have not come through."

Resident Sonia Lopez, who is a lifetime resident, addressed Council saying, "I have been on Pioneer Boulevard when there was a fire engine behind me and they could not get through. There was no place for cars to move either to the left or to the right. I was told that the fire department had been given some type of remote where they could turn all the lights green. But when there are ten cars in front of the emergency vehicle, they still have to wait for movement. And those few minutes could actually be the difference between life and death; I think it is a good idea to restore the two lanes going north and two lanes going south."

Another resident, Brandon Madrid, quoted a letter he received regarding emergency vehicles response times, possibly causing loss of property or life.

Madrid said the letter stated the downtown project had been approved by the Los Angeles Sheriff's and Fire Departments and that the improvements did not cause safety concerns.

Madrid made a verbal public request that copies of these approvals be made available to all residents of Artesia.

"At this point we I believe we need to put the two lanes back, we cannot leave the street as it is," said Taj, "we did not anticipate the public concerns that have been expressed."

The motion was made and seconded to cease all current work on the project, return an extra lane to the North and South bound streets, until further directions and assessments can be made.

Commerce Council Fires City Attorney Eddie Olivo

In their regular council meeting Tuesday night, the Commerce City Council fired long-time City Attorney Eddie Olivo. The report was made out of closed session.

Olivo has been the city's attorney since 2013.

This is the second go-around for Olivo, in 2008 council voted to terminate his contract.

The action was initiated by then-Councilwoman Rosalina Lopez with a vote of 3-1.

EGP reported in 2008 that Olivo's appointment in 2007 helped spark a recall election during which recall campaigners alleged that not only did two members of the council use public funds in a self-serving way, they also hired an attorney with a questionable past.

Olivo's past association with a former public official convicted of corruption meant that he could not be trusted, the recallers said.

Lilia Leon, who ran to replace then-Mayor Tina Baca Del Rio, presented this as one of the reasons Del Rio and Councilman Robert Fierro needed to be recalled.

Fierro survived the recall, but Del Rio lost her seat.

HMG-CN has learned that Arnold Glasman's firm will take over City Attorney duties, Glasman is the City Attorney for Hawaiian Gardens.

FORMER LAKEWOOD HIGH SCHOOL TEACHER ARRESTED FOR HAVING SEX WITH A MINOR

A 52-year-old former Lakewood High School woman was been charged with having sex with an underage girls from 2008-'11, Los Angeles County prosecutors announced today.

According to prosecutors, Mary Jahn began having a sex with a 15-year-old female student in July 2008 continuing through July 2011.

Jahn was charged with nine felony counts: four counts of sexual penetration by foreign object, three counts of lewd acts upon a child and two counts of oral copulation of a person under 18, according to authorities.

Jahn was a teacher at Lakewood

High School at the time of the reported crimes.

Prosecutors said the the now-adult victim alerted authorities about the sexual abuse earlier this year. Long Beach police officers arrested Jahn on Wednesday after an investigation.

Jahn is scheduled to be arraigned this afternoon at the Los Angeles County Superior Court, Long Beach Branch.

If convicted as charged, Jahn faces a maximum possible sentence of eight years and four months in state prison.



MOVIE REVIEW CIVIL RIGHTS ICON IS SUBJECT OF NEW DOCUMENTARY

A new documentary entitled "Dolores," produced by several community leaders including legendary musician Carlos Santana, about the life of long-time civil rights and labor leader Dolores Huerta, had its Southern California premiere at the Nuart Theatre in West Los Angeles Sept. 8 where Huerta, Santana, veteran actor and activist Martin Sheen and other dignitaries answered questions and discussed the film with hundreds of ticket holders who waited hours in line to see the movie and to meet Huerta in person.

"People can make a difference," said Huerta. "Even the most discriminated against can make a difference so long as the people keep engaged."

Santana said, "Passion for something you believe in can compel you to do important things and can ignite that same emotion in everyone to be capable of doing even greater things."

"Dolores" is a documentary that celebrates a hero, but it's no hagiography. Its subject wouldn't stand for that," wrote Los Angeles film critic Kenneth Duran after viewing the film in Northern California.

"That would be Dolores Huerta, a legendary activist who at age 87 defines indefatigable, a woman whose experience shows what a life of total commitment means — as well as the price it demands.

The film chronicles Huerta's life from childhood to the present, and depicts in vivid detail when she was jailed, seriously beaten, mocked by commentator Glenn

Beck and given the Presidential Medal of Freedom by President Obama.

Yet she doesn't have the name recognition of her close collaborator, Cesar Chavez. So director Peter Bratt was determined to change that with this powerful, informative and heartening documentary.

Huerta was the co-founder, along with Chavez, of the United Farm Workers union. She is also the person who came up with that organization's celebrated slogan, "Si, se puede" — yes, we can — someone whose tireless activism has extended to feminism, the environment and the political process.

Although numerous on-camera voices are complimentary, including Gloria Steinem, Angela Davis and playwright Luis Valdez, the film's tone is set not by them but by Huerta herself.

She's a clear-eyed and tough-minded truth-teller who has no hesitation about recalling her life exactly the way it was.

"You can't make change unless you're willing to give something up," said Huerta.

In addition to being an iconic political organizer, Huerta is also the mother of 11, and what makes "Dolores" unusual is how much screen time it gives to her children as they talk with heartfelt and moving candor about the difficulties of having a parent who, as one of them says, "really didn't

belong to us."

Outraged at injustice even as a teenager, Huerta met Fred Ross, a legendary community organizer, and by the age of 25 was the political director of his Community Service Organization.

Ross introduced her to Cesar Chavez, and though he was initially wary about her, they jointly formed what became the United Farm Workers because "unless you and I do it, it will never happen," said Chavez.

Working in backbreaking conditions for wages as low as 90 cents an hour, the Central Valley's farmworkers certainly needed a union, but organizing them was a challenge because they were poor, often did not speak English and were not citizens.

Huerta, however, did not hesitate. "It was such a calling, I felt it so strongly," she says, adding with potent simplicity, "this is the reason I live."

The farmworkers struck in 1965, and Huerta's example, her organizational skill and her sheer force of belief were key factors in the struggle and had the additional benefit of encouraging women to join the union.

One of the farmworkers' first high-profile allies was then presidential candidate Robert F. Kennedy. Huerta was one of the people with him the night he was assassinated.

"Dolores" has extremely moving footage of that event and also underlines Huerta's key role as a union strategist in planning and executing a key farmworker march on Sacramento and a nationwide boycott that saw an estimated 17 million people stop eating grapes.

As impressive as all this is, "Dolores" never lets us forget the human cost that had to be paid, letting Huerta's children and the woman herself comment frequently on the impact her actions had on her family.

"She was off and running" — that's one daughter's rueful comment about one of her mother's departures. A son reveals that it took her 10 months to realize he'd dropped out of high school.

"The movement became her most important child," another daughter says, adding, "there are scars there because of that."

"Dolores" also deals with even darker periods in Huerta's life, providing video of a life-threatening beating by the San Francisco police. Three of her ribs were broken and it took her months to recover.

Painful in a different way was the aftermath of the death of Chavez, when she was unaccountably passed over for the leadership of the union she had helped to found.

The unexpected thing about "Dolores," finally, is that if its political story makes it important, its human story makes it involving.

"You can't make change," Huerta says, "unless you're willing to give something up," and this fine documentary shows the truth of that from both sides of the coin."

Huerta is one of the most important, yet least known, activists in the fight for racial, class and gender equality in American history. Although she was an equal partner co-founding the first farm workers union with Cesar Chavez, her enormous contributions have gone largely unrecognized.

Director Peter Bratt hopes that after viewing his film, the perception of Huerta will change forever. Movie watchers will be able to view the documentary themselves in the next few months. This may be the most important film you see in 2018.

GAHR MAKES IT A BAKER'S DOZEN AGAINST CERRITOS, LIMITS DONS TO SINGLE DIGITS AGAIN

Sometimes in a blowout loss, the final score tends to be a bit misleading and really doesn't tell the whole story. Such was the case when Gahr High blasted longtime city rival Cerritos High 48-0 last Friday night at Hanford Rants Stadium.

Both head coaches agreed that Cerritos, which has now lost 13 games in this rivalry, is better than the final score indicated. But, the fact to matter is this was the seventh shutout (third worst) in this 13-game losing streak to the Gladiators with the Dons being outscored 554-56.

"I think that's a much improved football team," said Gahr head coach Greg Marshall of Cerritos. "I thought we would pressure them a little bit more early but we didn't get to the quarterback. Thank goodness we played some secondary this week; we haven't been playing very well in the secondary. So, that was a positive sign."

"The rivalry adrenalin wears off after a handful of plays," said Cerritos co-head coach Barry Thomas. "So, what you saw in the first quarter is what I believe we're capable of. It's just putting it together and tonight, we ran out of bullets. We got out-hit in the second half."

Thomas was referring to the first quarter and had to be pleased with what he saw. On Gahr's first drive of the game, Cerritos senior defensive back Christian King picked off senior quarterback E.J. Gonzalez in the end zone, stopping a nine-play drive that began back at Gahr's 27-yard line.

Cerritos (0-3) couldn't do much with that and after punting for the second time, it took the Gladiators five plays to get on a board, a six-yard run from junior running back Micah Bernard. Three plays into the

ensuing Cerritos possession, Gahr senior cornerback Jeremy Matthews intercepted a pass from senior Colby Nielsen and the Gladiators parlayed that into a five-yard touchdown run from junior Michael Childress almost three minutes into the second quarter.

Despite another Nielsen interception, the Dons were hanging right with the Gladiators (2-1) until the final 74 seconds of the half. First, senior running back Ugonna Olumba scored from 18 yards out. Then senior cornerback Miles Johnson returned a blocked punt for a touchdown with 17 seconds remaining to seal the game and send the hosts into the locker room with a 27-0 advantage.

Even though Gahr had a four-touchdown lead at the break and even though Bernard had piled up 142 yards on 12 carries in the first 24 minutes, Marshall was still concerned about his defense going up against a Cerritos offense that has former Gahr offensive coordinator Jon Nielsen helping the Dons in a similar position. Colby Nielsen completed his first six passes for 47 yards and ended the game 16 of 25 for 104 yards with senior wide receiver Eric Baker hauling in seven of those for 58 yards.

"I've seen that game before," Marshall said. "Especially, once they get going, it's hard to stop them. I thought defensively we did a good job. They know what they're doing in their passing game and we have to be more disciplined. It took a little bit of adjustment. They rolled out and did a couple of things different.

"I know that offense, obviously," he continued. "So, I know what defenses we need to be in and we needed to do those things. Now, the key to that was we were able to stop the run game with five in the box."

"He's going to get better, even better from

here because he hasn't even scratched the surface of what's he's capable of as far as his pre-snap read and his post-snap reads," Thomas said of his signal caller. "He's getting where he's supposed to be. Colby's going to be fine."

Cerritos was in no hurry to go away that quick as King intercepted a Gonzalez pass on the second play of the third quarter and returned it to the Gahr 45-yard line. But the drive stalled and when Gahr got the ball again, Childress caught a 17-yard touchdown pass from Gonzalez. Gahr's next score would be a 66-yard punt return down the Gahr sideline from senior free safety Aaron Hawk and Bernard capped off the scoring with a 53-yard run with 2:49 remaining in the third quarter. Bernard outgained Cerritos with 214 yards on 15 carries in just three quarters while Olumba added another 68 yards on six carries.

"Actually, he played pretty well last week," Marshall said. "This week, he was hurt and he wasn't even going to play. So, he didn't practice; he said he was a little off. He didn't play up to his capabilities because he didn't [have a full week of] practice.

"I didn't think they were going to play that defense," Marshall added. "They played a soft shell on us. That's why it was very important we were able to run the ball because if not, we were going to be in trouble because they were sitting back there."

On defense, the Gladiators were paced by senior cornerback Brad Harbin (five tackles) and five other players with three tackles a piece. That defense limited the Dons to 21 yards on the ground. Meanwhile, Cerritos safety Ryder Eddy led the Dons with 10 tackles while King had four and a half tackles and the two interceptions and senior linebacker Matt Fernandez added

four tackles.

"Getting Christian King eligible was huge, obviously," Thomas said. "He's a smart, talented football player. Ryder came to play tonight with big hits and his hustle... Ryder is Ryder. If we can play consistently for four quarters, I think we'll be alright."

Cerritos moves on to host Beverly Hills High tonight in a battle of winless teams, Gahr will visit Artesia High (3-0), hoping to retain the Silver Milk Barrell for the fourth year in a row and eighth time in the last nine seasons. Even with Gahr's dominance over the other two ABC Unified School District schools that field a football program, the debate will continue as to whether the Cerritos-Gahr rivalry is just that. Since 1998, Gahr is now 14-6 over the Dons and is 13-6 over the Pioneers.

"Of course it is," Marshall said. "Heck yeah it is; without a doubt. You get nervous as hell for these games, especially this week because offensively we've been struggling. I knew they were going to throw the football and we hadn't played well in the secondary. It's always fun to play those guys. They play hard and I thought they had an opportunity to do some things."

"Since I've been here, it hasn't been a rivalry," Thomas said. "I'm going to be honest with you; it hasn't been. I'm a [Long Beach] Poly kid and [Long Beach] Wilson's not a rival. You have to win some to be a rival. It's a big game because it's in your city between two schools in the same city. But, I don't consider it a rivalry until we can make more noise. Hopefully we can turn it around."

HOLMES, SCHWIEGER POWER VALLEY CHRISTIAN TO EASY SWEEP OVER DOWNEY

From the first server of the match, it was evident that the Valley Christian High girls volleyball team was going to have its way with visiting Downey High this past Tuesday night. Senior setter Megan Lim and junior outside hitter Aubrey Schwieger combined for the first five points of the match.

After that, the Lady Crusaders put together an all-around attack that included the one-two punch of Schwieger and senior outside hitter Madison Holmes, plus timely serving in a 25-11, 25-12, 25-18 victory. It was V.C.'s third sweep in 10 matches this season and put the team two games above .500.

V.C. raced out to leads of 5-0 and 13-3 in the first set, 6-1 and 15-6 in the second set and 9-3 and 13-5 in the third set. In fact, the Vikings did not score more than two straight points until the third set.

"Last week, we kind of got outplayed in the beginning of sets," said V.C. first-year head coach Jeff Ornee. "I felt like we were down probably eight, nine, 10 points in the beginning of sets and it's really hard to come back from stuff like that. So, our focus today was to start

every game strong and I felt we did that, especially in the serving game.

"We're not tall, we're not super athletic, we're not going to out-jump a lot of teams," he continued. "But I think we can out-serve and out-ball control teams and I thought we did that tonight."

With the Lady Crusaders up 8-3 in the opening set, a serve into the net put the ball in the hands of senior libero Hannah Buckley, who promptly recorded three straight aces. She would have four aces in the set plus the two Lim had in the opening moments. In addition to the six aces, Holmes and Schwieger combined for 11 kills in the set. Also getting into the offensive action were senior middle blocker Anneka Bakker (two kills, one block) and junior opposite hitter Candice Palmer (one kill, one block).

It was more of the same in the second set with Holmes and Schwieger each getting two kills early, plus a Holmes block and Schwieger ace. Once again, those two dominated the set, accounting for 16

points with Lim serving two more aces and Buckley and Palmer an ace each. When the match had ended, the Lady Crusaders had served 21 aces.

"It's a huge emphasis," Ornee said. "My goal for this team was to be the best serving team and the best passing team. We're still a long ways away, but I think we're making progress anytime we get out there. I think we have a solid serving squad and we're just going to continue to improve as far as the season goes."

Downey led for the only time in the match at 3-1 in the third set. But following a kill from Holmes, Schwieger reeled off seven consecutive points, including four aces. Shortly after that, Buckley added three more of her team-high eight aces. Schwieger would collect six kills in the set to lead V.C. with 18 while Holmes finished with a dozen kills. Those two, as they were last season, will be a vital part of V.C.'s offense this season.


"It's huge," Ornee said of the two power hitters. "It's repeating from last

year; our same outsides who kind of held us down last year. They've only improved over the offseason, getting better and [being] a little bit more healthy. So, we're going to ride them until they break and hopefully, they don't break. They're our offense and I think every team we play knows they're our offense. It's just up to them to stop them and so far, they haven't been able to."

V.C. visited St. Anthony High on Sept. 14 and will host their own tournament, along with Bellflower High, on Saturday where it will face La Mirada High, Lancaster Baptist High and Westridge High in pool play action. Then, the Lady Crusaders will open defense of their 2016 Olympic League championship against Village Christian High on Tuesday. Village Christian finished in second place last season, three games behind Valley Christian.

"Village was the toughest competition last year," Ornee said. "I'm not sure exactly how many seniors they graduated, but they're always a tough squad. Again, it's going to come to the serving and passing and just being solid from the outsides."

CERRITOS GIRLS VOLLEYBALL CONTINUES DOMINANCE OVER NORWALK SCHOOLS

There are four schools that the Cerritos High girls volleyball team has dominated for nearly two decades and half of them are located in Norwalk. The Lady Dons began their final season in the Suburban League by knocking off host Norwalk High last Thursday 25-18, 25-15, 22-25, 25-21, then easily swept John Glenn High 25-9, 25-11, 25-17 this past Tuesday.

The win over the Lady Lancers was the 33rd in the past 39 meetings and started with the Lady Dons jumping out to leads of 8-4 and 12-5 in the opening set thanks to three aces each from junior defensive specialist Sidney Pasion and senior outside hitter Amber Han. The lead would eventually grow to nine points (18-9) following an ace from senior libero Kea Minami, the eighth ace from Cerritos along with 14 kills.

In the second set, Norwalk tried to stay close in the opening minutes, reeling off three straight points thanks to two aces from senior defensive specialist Valerie Zavala. But a double hit violation allowed Pasion to serve four straight points and give Cerritos a lead it would not relinquish the rest of the set.

The Lady Dons (4-0 overall, 2-0 in league) were seeking their second straight sweep over Norwalk and were looking good with leads of 7-4 and 11-7 in the third set. But trailing 19-18, a net serve gave the ball to Norwalk senior defensive specialist



Julia Sanchez and from there, a kill from junior middle blocker Pricilla Martinez and a Sanchez ace put the Lady Lancers up 21-19 before Cerritos called a timeout.

Norwalk (6-3, 1-1) seemed to have the momentum in the fourth set, leading 6-2 after three straight aces from senior setter Danielle Gomez. However, the Lady Dons battled back and clinging to a 21-20 advantage, junior outside hitter Samantha Oh had a pair of kills around a block from senior middle blocker Muna Okoli, her second of the match, for the final surge.

Oh led everyone with 14 kills while Han (13 kills), senior middle blocker Kelly Amalu (10 kills, two blocks) and sophomore right side hitter Nicole Blue and Okoli each pitched in with eight kills. Norwalk was led by senior opposite hitter Elexus Moralez and sophomore outside hitter Alejandra Macias with eight and seven kills respectively.

Cerritos will participate in the Valley Christian/Bellflower Tournament on Saturday, facing El Segundo High, Oaks

Christian High and Trinity Classical High in pool play action before visiting Artesia High on Tuesday. The Lady Dons will then host Bellflower High on Thursday in the first of five straight home matches. Norwalk will compete in the Whittier Tournament today and Saturday before visiting Glenn on Tuesday.

In other girls volleyball action, Artesia dropped a 25-11, 25-20, 25-10 decision to Mayfair High this past Tuesday in its league opener. The Pioneers (4-4, 0-1) will face Brea Olinda High, Gahr High and Long Beach Wilson High in pool play action of the V.C./Bellflower Tournament and will also host La Mirada High on Thursday. Norwalk will compete in the Whittier Tournament today and Saturday before visiting Glenn on Tuesday.

Emergency Broadcast System voice saying, "Saturday 4:27 p.m."

There was a 4 second pause, then loud sirens with a message after saying, "this is a Artesia Public Safety announcement from Artesian's for Artesia Now. The Los Angeles Fire Department..."

It was a full thirteen seconds into the recording before some residents recognized it was a political robo-call and not

an actual emergency call.

"The Los Angeles Fire Department... told the (Artesia) City Council a year ago do not remove lanes from Pioneer Boulevard because it will delay fire trucks and keep them from saving lives. The Artesia City Council did it anyway. Come to the city Council meeting on 9/11 and tell the City Council that they failed to protect us, let's take back our City from greedy politicians."

There is some question about the statement that the LACFD told the City Council not to remove lanes.

HMG-CN has learned from a high-

level source that the City had 6 meetings with the LACFD in 2014-'15 prior to the Council's approval of the Pioneer Boulevard project.

The LACFD made safety recommendations and the City made revisions to the plan.

HMG-CN called the LACFD last week and is awaiting response.

Emails into the proponents went unanswered as to the time of publication.

Cerritos resident Melinda Kimsey commented, "another request, stop sending me, Melinda Kimsey emails and text messages."

Schuyler, who was the only Montebello employee to comment said, "I don't deal with the bids, I don't get involved in the details — staff does."

That statement from Tucker-Schuyler was apparently the last straw for Magallanes as one month later he took action.

HMG-CN has obtained a complaint filed by Magallanes in the Superior Court

of Los Angeles on Aug. 25, 2017.

The cross-complaint is for "equitable indemnity," a claim when one party has been ordered to pay damages to another party as a result of a third-party's wrongful acts.

Magallanes complaint names as the third parties, the "cross defendants," City Manager Tucker-Schuyler, Montebello Assistant City Manager Danilo Baston, and Information Systems Manager David Tsuen.

With the complaint, Magallanes is stating that if he is ordered to pay money

then Tucker-Schuyler, Baston, and Tsuen should be responsible for the money.

The complaint read, "in the event (Magallanes) is found liable for damages (Magallanes) is entitled to indemnity from (Tucker-Schuyler, Baston, and Tsuen) to the extent that the wrongful acts of (Tucker-Schuyler, Baston, and Tsuen) caused Plaintiffs' damages."

In effect, Magallanes is saying Tucker-Schuyler, Baston, and Tsuen colluded with him in acts related to the fabricated construction bids.

"If any sums are found due to Plain-

tiff, this Court should find, declare and determine that the liability is solely of (Tucker-Schuyler, Baston, and Tsuen)."

Is is an astonishing filing by Magallanes and one that has placed the City and taxpayers on the line for Magallanes' actions.

Equitable indemnity cases include the entire range of possible award of damages from no right to any indemnity to a right of complete indemnity.

FIGHT TO END POLIO

Rotary's ongoing fight to eradicate polio throughout the world has been underway for more than 30 years. Rotarians around the globe will join in the observation of World Polio Day on Tuesday, October 24, which honors Dr. Jonas Salk, who led the team that developed the first polio vaccine.

In conjunction with the World Polio Day observation, La Mirada Rotarian Paul Milward will be riding 100 miles in the Rotary Ride to End Polio at El Tour De Tucson race in Arizona, which raised \$11.3-million last year to end polio.

"My father suffered from polio, and I strongly believe that no one should have to suffer from this terrible disease," says Milward. La Mirada Rotary is currently accepting donations on his behalf towards ending polio. Checks should be made out to the La Mirada Rotary Club and mailed to P.O. Box 248, La Mirada, CA 90637-0248.

Rotary's overall polio fundraising goal for the 2017-2018 Rotary Year is \$50-million plus a \$2 match by the Gates Foundation up to \$50-million per year for each \$1 contributed. As a result of the Bill & Melinda Gates Foundation match, a \$10 individual contribution becomes \$30 for the fight to end polio.

Rotary's program to eliminate polio is working. Since 1988 health experts indicate the 16,000,000 children worldwide have been saved from the paralysis caused by polio. Thus far in 2017, there have been just eight cases of polio reported globally. Five were found in Afghanistan and three in Pakistan, areas where some people have historically resisted immunizations.

The Gates Foundation recently gave \$37.5-million to UNICEF to support critical polio eradication activities in Afghanistan, Pakistan and worldwide. Rotary International contributed \$17.5 million to UNICEF for key polio eradication activities in Afghanistan, Pakistan and other areas.

CLOTHES FOR KIDS

La Mirada Rotary's third major fundraising project is much closer to home. Rotary's Clothes for Kids project is intended to provide some \$125 in warm clothing for approximately 40 local children.

Each year, Rotary works with local schools and other institutions to identify children in need of assistance. In some cases, there are multiple children from the same family. Community volunteers, including Sheriff and Fire Department personnel, assist the children with shopping for clothing on their lists at Marshalls department store.

Following the shopping portion of the morning, the children are taken by

bus to the La Mirada Activity Center for a holiday party. Each child receives a gift from the Rotary Club.

"The Clothes for Kids project is a special tribute to the memory of Eileen Wade, a longtime member of the Rotary Club of La Mirada, who championed the project for many years," says Dr. Wayne Wong, a La Mirada dentist who worked with Wade for years on the project. "We appreciate the generous support the community has provided to this project

for many years."


Space Shuttle was conceived, is now a full fledge museum to the aerospace history.
