The Artesia Chamber of Commerce located in Artesia, California is holding a "State of the State" luncheon that is causing a firestorm of controversy in and around the tiny Southeastern Los Angeles County town.

The Chamber has booked embattled Assemblywoman Cristina Garcia (D-Bell Gardens) as the guest speaker at the July 31 luncheon.

Garcia is currently under investigation by the California Legislature for sexual-harassment and groping allegations levied by a former staffer.

But apparently that does not matter to the Chamber President Sahlia Patankar or its Board, who claims Larry Caballero as a member, an outspoken advocate of Garcia.

Caballero's local Hubert Humphrey Democratic Club endorsed Garcia at the height of the harassment allegations.

The allegation began back in February when Daniel Fierro, a resident of nearby Cerritos, told POLITICO that Garcia groped him at the annual Assembly soft-

ABC BOARD APPROVES BOND RESOLUTION DURING HEATED MEETING

The ABC Unified School District held their regular Board meeting this past Tuesday night but it was far from regular, as the Trustees considered striking an item from the infrastructure bond "resolution" that excluded Project Labor Agreements.

The exclusion stated, "that the Board does not plan to build and maintain its bond-funded capital facilities under a Project Labor Agreement (PLA)."

A PLA is when the government awards contracts for public construction projects exclusively to unionized firms.

The PLA requires all contractors, whether they are unionized or not, to subject themselves and their employees to unionization in order to work on a government-funded construction project.

It is essentially a comprehensive pre-hire collective bargaining agreement. The basic terms and conditions for labor are established in advance for all organizations involved in the project.

A typical PLA includes no-strike, no lock-out agreements, and also includes procedures for quickly settling any problems or disputes that might arise during the project.

Critics always point to their anti-competitive nature, but PLA's never restrict bidding solely to union contractors, projects are available to any contractor who

Many hospitals, doctors and administrators recognize the benefits of dog therapy. Dog therapy has proven to lower blood pressure; improve cardiovascular health; release oxytocin endorphins; diminish overall physical pain and the simple act of petting a pooch produces an automatic relaxation response, reducing the amount of medication some people need.

Tenent Healthcare is one such facility, "Patients are not the only ones who benefit from the visits," says Jessica Chen, Manager, Communications /Southern California Group, "staff members and visitors often look forward to the visits too."

Benji, a four-year-old, mild mannered Jack Russell Terrier, has been visiting patients for the last six months at Fountain Valley Regional Hospital. Benji was certified in January 2018 through Alliance

of Therapy Dogs [ATD], a national organization whose mission is to share smiles and spread joy.

Owners and trainers Michelle and Anthony Tran adopted Benji when he was just five weeks old.

"Funny story," says trainer Michelle Tran, "we were at the Asian Garden Mall celebrating Chinese New Year and a lady just randomly came up to us with this tiny puppy in her hand and asked if we wanted the dog. It was meant to be!" Michelle goes on to talk about Benji's training process, "we have always worked with hand signals in Benji's training and he is a very obedient dog."

"What inspired us - was when we noticed Benji playing with one of our cousins who has Down syndrome," said doggy daddy and trainer Anthony Tran,

CERRITOS CITY COUNCIL APPROVES BALANCED 2018-2019 BUDGET

The Cerritos City Council/Successor Agency approved a \$127 million combined financial program for fiscal year 2018-2019 on June 28, 2018 with a total City funds surplus position of \$1.4 million. The budget emphasizes public safety; maintenance of trees, facilities and infrastructure; and quality community services and programs. The new fiscal year began on July 1, 2018 and concludes on June 30, 2019.

The City's overall financial position remains strong with considerable assets and a reserve, as evidenced by a report released earlier this year by Senator John Moorlach, which ranked the City of Cerritos No. 20 out of 482 California cities for financial soundness.

Approximately \$13.5 million has been allocated toward capital improvement projects, which are focused on the health, safety and welfare of residents and the re-investment in facilities and infrastructure throughout the community. Among the capital improvement projects are sidewalk, curb and gutter rehabilitation; arterial street slurry seal; traffic signal modifications, rehabilitation of residential streets; and various other projects.

In making public safety a priority, the Department of Community and Safety Services has been allocated approximately \$26.6 million for community participation, recreation services, law enforcement and code enforcement. The Community and Safety Services budget includes approximately \$16.5 million for the ongoing priority of law enforcement and safety services.

The budget also includes funds that will allow the City to continue offering quality community programming at the Cerritos Senior Center at Pat Nixon Park, in addition to cultural programming, excursion opportunities, sports and fitness programs and recreation classes.

The Community and Safety Services budget includes approximately \$4.5 million for recreation services. More than 1.6 million people are served by the City's parks and recreation programs every year. Cerritos has 25 parks and recreation facilities, plus classes, special events and excursions.

The Community Development Department, which includes advance planning, building and safety, current planning and geographic information systems, was allocated \$6 million for its operations.

Approximately \$19 million has been designated for the Public Works Department, which includes engineering, traffic circulation management, parks maintenance, sewer maintenance, facility maintenance, landscaping, trash collection, recycling and custodial services.

The Department of Water and Power includes the City's water division and the electric utility. The department's approximately \$15 million budget will cover items necessary for the operation of the Magnolia Power Plant, Cerritos Electric Utility and water operations, including utility maintenance, power expenses, operational charges and administrative fees.

The Department of Administrative Services will receive approximately \$16 million for its operations, which include communications, finance, human resources, management information systems, support services, water billing and the Cerritos Library. The department's budget includes costs to maintain the City's water billing system, provide internal support to other departments and continue to provide valu-

able amenities and services at the Cerritos Library.

The Theater Department will receive \$8 million for the operation of the Cerritos Center for the Performing Arts (CCPA). The Theater Department budget encompasses theater administration; business management; marketing and management of the CCPA performances; operations and security; special event services; and ticket office personnel.

The CCPA's 2017-2018 Season generated nearly \$5.5 million in ticket sales revenue. This coming season, in addition to similar expected ticket sales revenue, the CCPA will receive nearly \$200,000 in sponsorship donations from Los Angeles County Supervisor Janice Hahn, Aria Apartment Homes, Triangle Distributing Company, the Cerritos Auto Square, George and Bev Ray/LeFiell and Yamaha Corporation of America. CCPA Associates donate approximately \$130,000 each season in support of the theater. CCPA patrons and performers generate significant revenue not only for the theater, but for surrounding local businesses as well.

The CCPA will present eight daytime educational performances in the 2018-2019 Season. These programs, offered to nearly 10,000 K through 12 students from ABC Unified and surrounding school districts, aim to enhance education through high-quality arts experiences. The CCPA thanks Los Angeles County Supervisor Janice Hahn for her generous \$110,000 donation in support of the Arts Education Program.

LA PALMA'S FLACHMEIER WILL NOT SEEK RE-ELECTION, CITY SEEKING COUNCIL CANDIDATES

LA PALMA, Calif. – A General Municipal Election will be held in the City of La Palma on Tuesday, November 6, 2018, to fill two City Council seats. Elections for the La Palma City Council are held every two years and terms for the City Council's five at-large seats are staggered. Therefore, all five council seats are not up for election during the same election year.

The filing period for nominations began Monday, July 16 and, pursuant to California Elections Code, has been extended from August 10 to August 15 due to Council Member Kathy Flachmeier's decision as an incumbent to not seek election.

Flachmeier was appointed to the City Council by unanimous vote this year, filling the unexpired term of former Councilman Steve Hwangbo.

Flachmeier has lived in La Palma

since 1987. She has a bachelor of arts and master of public administration degrees from Cal State Long Beach. She worked in the construction industry for 18 years and as an instructor of construction management at Cal State Dominguez Hills before retiring in 2017.

Flachmeier was sworn in Jan. 16, and her term of office expires Dec. 4.

PUBLIC HEARINGS TO DISCUSS 91 AND 605 FREEWAYS

Interstate 605 (I-605) and State Route 91 (SR-91), the San Gabriel River Freeway and Artesia Freeway, are major north-south and east-west transportation routes located within LA County and are integral to the Southern California freeway network.

To improve traffic flow along the freeways, the Los Angeles County Metropolitan Transportation Authority (Metro) and the California Department of Transportation (Caltrans) District 7, in collaboration with the Gateway Cities Council of Governments (GCCOG), the City of Cerritos and the City of Artesia, are proposing improvements along westbound SR-91 between Shoemaker Av and the I-605/SR-91 Interchange, and at the I-605 northbound exit to Alondra Bl.



At eight years old Bob Baker saw a puppet show, more than eighty years later, that experience has grown into a cultural landmark.

A 1962 cult classic entitled *The Mask* was shown at the Bob Baker Marionette Theater in Los Angeles. The show promised haunted dolls and manifestations by macabre marionettes.

GHOULA and 3D Space hosted the evening on July 7th for one night only, screening the immersive nightmare in a theater where puppets and performers interact with the patrons.

Each attendee received 3D glasses; within the movie there were signals when to put the glasses on. The glasses transformed the theater into a complete immersive experience.

A preshow featured the enchanted Bob Baker marionettes and a dream-like solo performance by master puppeteer, Eli Presser.

The Los Angeles Times said Presser actually looked a little like a marionette when he spoke, "with long, slender limbs and loose, delicate gestures, pointing to that strange dual consciousness as a kind of metaphysical opportunity, a portal through which the puppeteer and his audience gain access to another world."

After the movie presentation, the Marionette Theater's party room was transformed into a ghoulish gallery of "haunted" dolls.

This one-of-a-kind paranormal exhibit featured a personal collection from Presser himself and was the first time these 'toys of terror' have ever been on public display.

The group of haunted dolls went from a paranormal collector who could not bear their haunted actions to the Dearly Departed Tours & Artifacts Museum.

The museum saw their paranormal activity and gave them to the Bearded Lady's Mystic Museum. They were returned to Dearly Departed because "they were haunted."

GHOULA obtained the dolls which came wrapped up inside a cardboard box. A strange symbol was drawn on the top of the box, with some saying that the symbol was drawn to keep the evil contained in the box.

One doll in the collection was 'King Friday' from the popular Mister Roger's Neighborhood television show. The doll was said to be the prized possession of a child involved with a poltergeist case. The puppet was supposed to have floated above the child's bed.

Since 1963, the Bob Baker Marionette Theater has been part of the Angelino Community. Utilizing over 2,000 handcrafted puppets, the organization provides patrons a unique theatrical experience educating, celebrating and rejuvenating puppetry and the allied arts.

ARTESIA PUNISHERS 16-U GROUP BEGIN POOL PLAY WITH A SHUTOUT WIN, END WITH A BLOWOUT LOSS

CHINO HILLS-It doesn't happen a lot in the world of travel softball where a first-year team plays in as few as two tournaments since the beginning of June and still qualifies for a season and summer-ending championship tournament. But that's what is starting the Artesia Punishers 16-Under team, coached by Joe Fletcher, as his team kicked off the United States Specialty Sports Association Far West National Championship with three pool play games earlier this week.

The Punishers split a pair of games this past Tuesday at Big League Dreams in Chino Hills, blanking the (South Central Los Angeles) Southern California Monarchs 6-0 in the morning, then falling to the (Brawley) E1 Prospects 5-4 early in the afternoon. Then this past Wednesday morning, the Punishers were crushed by the (Fontana) Southern California Ruthless-Eklund 13-4.

"The tournament we won almost a month ago, we came from behind to do it," Fletcher said. "The next tournament, we were down, came from behind to rally before coming up short. The girls...they fight, and they stay in there. They made some adjustments with their at-bats in terms of where they were in the box."

The story of the game against the Monarchs was pitcher Katherine Serna (St. Paul High), who returned to the Punishers last week and threw a three-hitter, striking out nine and walking one in five innings of work.

Serna retired 11 of the first 12 batters she faced, walking only Leslie Houston with one out in the top of the second inning. She would get all the run support she needed in the bottom of the first as the Punishers pushed across four runs.

Brittany Litwa began the bottom of the first inning by walking center fielder Mikala Fletcher (Downey High) before shortstop Robbie Gallegos (St. Joseph High) reached third base on a throwing error. A walk to right fielder Krista Guzman (Schurr High) and a single from left fielder Emily Rodriguez (El Rancho High) made it 3-0 and two batters later, a sacrifice fly from second baseman Alondra Gonzalez (Legacy High) increased the margin to 4-0. The Punishers were aided by two errors in the frame as Guzman came home on the second one.

Guzman led off the third with a single, moved to second on a wild pitch and came home on a base hit from Rodriguez. Two pitches later, catcher Racine Ruacho

(El Rancho High) doubled and after a pop-up, Rodriguez scored on a sacrifice fly from first baseman Savanna Cervantes (El Rancho High).

The Monarchs made it interesting in the fifth when Houston and Jasmine Smith each singled and Litwa reached on a fielder's choice. But Serna preserved the shutout by striking out the final two batters she faced.

"She played with us in January and February a couple of games," Joe Fletcher said. "When we broke for high school, her family decided to pursue and look at other options. That happens in softball. She came back, and she's played [before] with a couple of girls on our team in rec ball and some other teams.

"So, she was done with her [travel team's] season and was looking to play," he continued. "We knew she was a very good pitcher and she's actually a second-year 14. But she's a high-quality pitcher and she showed that today. She can control a game."


It would be a completely different story in the second game as the E1 Prospects scored four times in the top of the first inning and held on for the one-run win. The Punishers would score four unanswered runs and had the go-ahead run on second base in the bottom of the fourth.

"[The E1 Prospects] were coming right off a game," Joe Fletcher said. "They were swinging and seeing pitches. I took over the pitch calling; normally the catchers call the game. Sometimes it's a different look. She just wasn't sharp, and they took advantage of it. But after that, we gave up one run and we kind of got it back under control. It's just that we waited too late to put together some hits."

Down 5-0, the Punishers got things going in the second when Rodriguez, Ruacho, Gonzalez and Cervantes all singled. However, Rodriguez was called out for leaving first base too early and Cervantes was doubled up after a sharp line drive out by third baseman Briana Moran (Huntington Park High).

Two innings later, and with one out, Rodriguez launched a solo home run over the left center fence. Ruacho then singled and one out later, Cervantes had a base hit before Moran was walked to load the bases. Melody Cardoza then walked shortstop Emily Corona (Garfield High) to make it 5-4.

"We had a runner leave early and she would have scored," Joe Fletcher said of missed scoring opportunities. "That's a run that we lost. We had another runner in the fourth inning where there was a passed ball and she didn't read it right.

That's another run. If you take those two runs, we win 6-5. We, as much as anything, kind of made life a little more difficult on ourselves than we should have. But sometimes that happens, and you have to fight back from that."

But after giving up a base hit to Brianda Rodriguez with two outs in the second, which made it 5-0, she allowed one hit and walked two over the final 13 batters she faced.

This past Wednesday, the Punishers were shorthanded as three players missed action because of summer school. As a result, the team managed a pair of runs in the top of the third and fourth innings while yielding eight in the bottom of the fourth.

"That's going to be a little bit of a challenge," Joe Fletcher said this past Tuesday on the final pool play game. Unlike other therapy dog organizations, ATD has a unique testing process. The assessment is designed to make sure that owner and dog have a good relationship with each other and that the canine has the right temperament for therapy work. An Observer monitors the relationship between owner and pet, including visits to a medical facility.

"It's really nice. I have dogs too and I miss my dogs," says patient Antonia Ruiz, "I have two English Bull Dogs. Benji was so nice, he lay down on my bed and it just touched my heart."

Benji loves treats, hiking, squeaky toys and people. His favorite facilities to visit are senior facilities, hospitals and visiting the Los Angeles airport, "We have special passes," says Anthony, "we go into the super secret passage ways and Benji greets all the airline staff and passengers who may be feeling a little anxious about flying."

Visits to the hospital are handled by the hospital's Volunteer Department, Patient Experience Division. Therapy dogs are so appreciated by Tenent Healthcare that they honored all their pups this year through a National Puppy Day.

Kenny Hahn, was recognized as the father of the paramedic program." It was very controversial at the time, but was eventually accepted and embraced.

Special guests included Brendon McDonough the sole surviving Granite Mountain Hotshot; Randolph Mantooth, Kevin Tighe, and Mike Stoker of the Emergency! TV Series.

Inside the museum visitors can see photos of what it was like to fight fires before there were fire hydrants, when water bags had to be handed person-to-person.

The museum has a display of everything from a horse drawn steam engine, fire apparatus dating back to the mid 1800s; motorized fire engines from every decade to the world-famous Engine and Squad 51 vehicles.

The vehicles are complemented by a vast collection of photographs, tools, early paramedic equipment, uniforms, firefighting gear, helmets, badges and documents. Artifacts on display from LACOFD's past are fire service artifacts such as helmets, turn-out, uniforms, badges, nozzles and alarm equipment.

One section of the museum is dedicated to the Granite Mountain Hotshots who died on June 30, 2013 while battling the Yarnell Hill fire, northwest of Phoenix, Arizona.

LA County Fire Chief Daryl Osby called the opening of the museum a particularly auspicious day for the LA County Fire Department both past and present.

"When you think about the LACFD, they are the premiere fire department

in the world. And for us to have a museum to fully capture our history is monumental."

"On behalf of my City colleagues and myself, this is a great day for Bellflower," says Mayor Dan Koops, "This journey began well over a decade ago. The partnership that we have had with the LACFD is a model for what cities can do when you strive to work together."

The museum is located at the Mayne Event Center in Bellflower and is open Wednesday through Saturday 9:00am to 2:00pm.

ball game in Sacramento.

Fierro said that Garcia appeared drunk came up and started stroking his back, then squeezed his butt, finally attempting a "reach around" to grab his crotch.

Garcia later took an unpaid leave of absence saying, "any claims about sexual harassment must be taken seriously, and I believe elected officials should be held to a higher standard of accountability."

The first investigation concluded in May with the Assembly Rules Committee finding the groping charges "unsubstantiated," but three other harassment issues "substantiated."

Fierro filed an appeal, and the investigation was re-opened, but, contrary to her statement and past actions, Garcia did not take a leave of absence.

She was stripped of all committee assignments by Assembly Speaker Anthony Rendon (D-Lakewood), only able to vote on Assembly bills; and even that was controversial.

Garcia walked away from voting on

two bills, one to place child sex trafficking and other heinous abuses in the violent felony category; the other prohibiting a person convicted of domestic violence, who could own a gun after ten years, from ever owning a gun.

And once again the Chamber shrugged her controversial votes off.

During the entire harassment investigation period, Garcia was alleged to have committed lurid acts both inside and outside the legislature.

Staffers claimed Garcia drank and bragged about having sex in her office, forced staffers to play "Spin the Bottle," and had a "Keerator" in her office.

Garcia also admitted to calling former Speaker of the Assembly John Perez a "homo" and using racial slurs against Asians.

A HMG-CN investigation found that the self-proclaimed #MeToo advocate took \$7,000 from Hustler's Larry Flynt, a man who once said, "I've always felt that feminism is an excuse for ugly women to march."

Despite all the explicit allegations, a current sexual harassment investigation, and the fact Garcia can only vote and cannot influence the passage of Assem-

bled bills, the Artesia Chamber invited her to speak at the "State of the State" luncheon.

"The Assemblywoman will be discussing the latest updates on new laws and possible legislation that impacts our business community," the Chamber's promotional flyer states.

"Interesting," said one resident who did not want to be identified, "how can she

talk about possible legislation when she is not in on the discussions? This is a stunt by the Chamber to give Garcia publicity, shame on them."

Several emails and texts into Chamber officials for comment went unreturned. HMG-CN could not locate Chamber President Shaila Patankar who no longer works at Hanmi Bank in Artesia.

will accept the terms of the PLA.

The Board meeting included heated exchanges, two controversial votes, and even a tirade from one of the Board members.

At public comment, all but one speaker supported removing the exclusion of the PLA from the resolution.

Ernesto Medrano from the LA/OC Building and Construction Trades Council spoke in support of the Bond and for the PLA.

"Please delete or strike out that section that excludes the PLA-Community Benefits Agreement, workers want to work locally and we should hire locally."

Adam Elliot from the Local 582 Plumbers and Pipe Fitters Union was next to speak supporting the bond and against the exclusion of the PLA.

"This community deserves those man-hours on the job, they are going to pay the taxes, they should get the benefit, you need to back the PLA."

Richard Hathaway, a member of the Facilities Committee, wanted to remove the exclusion, "if you take it out, you can discuss the issue, you are not agreeing to have one so you can include it later. You will see more security, better educational facilities for STEAM and STEM, and property values will go up."

Chris Martinez from the Local 803 Carpenter's Union spoke in support of the bond and against the exclusion of the PLA, "we all want to work local, the Union is not asking a PLA be required, we are asking for a fair shot at working local."

One resident spoke of the minor contribution homeowners would make given the tax formula for the bond. The formula is based on the assessed value of your home, not the market value.

"The median assessed value of home in the ABCUSD is in the \$300,000 range, so median taxes would go up \$150 per year, \$12.50 per month."

His house was worth more than \$300,000 but that did not matter. "Over 10 years I will pay \$3,500 but my house value will rise much more than that."

James Yee was against the bond measure calling it "premature." Yee cited the enrollment policy that should tabulated before the bond is put up for a vote. Yee speculated that the enrollment study "would necessitate combining schools."

Yee also cited that 15% of the students

come from outside the district. One district official told HMG-CN it was closer to 10%. "Senior citizens and families are outraged," said Yee.

The outside number would be lower, but construction of new homes in the ABC is almost non-existent and a major factor why children come from outside the district.

Board discussion ensued with VP Letty Mendoza quickly moving to amend the resolution and remove the exclusion of the PLAs; Board member Chris Apodaca immediately seconded the motion.

Sophia Tse spoke up and, in an overt political maneuver - Tse is rumored once again to be running for Cerritos Council - moved to change the language of the exclusion to state "using the lowest responsible bidder" even though current state law and district policy already mandate awarding a project to the lowest responsible bidder.

Grumblings came from the audience which elicited a response from Tse, "I am union my brothers and sisters."

Mendoza wanted to keep her original motion intact, but Ernie Nishii seconded Tse's motion.

Apodaca spoke up and said, "the best practice here is to strike the motion, we already take the lowest responsible bidder. Let's remove the exclusion and move on."

Board member Nishii spoke next saying, "we can't come back with the same language, let's include the lowest bidder statement."

Even though the district is required by law to take the lowest bidder, Nishii was adamant for redundancy in the resolution, "we are not paying by the word," he stated.

Clerk Olga Rios supported Mendoza's motion to strike the language, joining Apodaca.

The Board voted on Mendoza's motion to strike the PLA exclusion, the motion passed 5-2 with Tse and President Soo Yoo voting to exclude PLAs.

The motion was then made to include Tse's redundant "lowest bidder" amendment.

On a vote of 4-3, the motion predictably failed to pass, with Tse, President Soo Yoo and Nishii voting yes.

Nishii then made the point to lower the amount of the bond to \$227 million, cutting the amount by \$31 million. The initial \$258 million was recommended by a district ad-hoc committee.

Board member Maynard Law was not in favor of cutting the amount, "we have

already cut \$100 million from the initial amount, one of our major goals is to make school's safe, we had 1,100 people work on this plan and it a solid plan, things that we need. We need to move on the full amount."

Apodaca echoed Law's statement, "our plan is about needs, not shiny things, we should not change the amount. It warms my heart that our Union brothers and sisters and residents who know the value of the bond spoke up tonight ready to pay the average \$150 per year."

President Yoo once again spoke about the lowest bidder addition to the resolution, evidently not understanding that both California law and district policy dictate that the lowest responsible bid must be awarded.

"We lost the 2014 bond, it is a different climate and culture, what kind of confidence are we giving our voters if we do not include the lowest bidder?"

Soo asked ABC attorney Robert Ainslow, who "was confused" at Yoo's question, finally explaining that the lowest bidder inclusion "will not appear on any documents that voters will see."

"You are going to follow California state law for the bidding process," Ainslow said.

VP Mendoza echoed Law and Apodaca, "the \$258 million is our needs, not a wish list. Our kids will have classrooms that will be up-to-date, that's what they need, if we do not improve our schools, families will go elsewhere. And I want the men and woman in the audience who spoke to work on our schools, I saw the passion. If we approve less than \$258 million what are we telling our kids?"

Nishii once again argued for a lower amount, which would lower the tax amount placed on residents by a nominal amount, instead of \$50 per hundred of assessed value, it would be \$35 of the assessed value, but the bond would be cut from \$258 million to \$178 million.

Sophia Tse followed Nishii with the same argument, claiming she was not playing politics. She stumbled on her math computations, and launched into a tirade for over four minutes screaming loudly while pounding the dais.

Contradicting her entire argument, at the end Tse said, "I support the \$258 million."

President Yoo once again delayed the vote on removing the PLA exclusion saying, "taxes and Unions are taboo in Cerritos," echoing the old neo-con views that are prevalent in Cerritos and validating the moniker that ABC means "All About Cer-

ritos."

Yoo, who owns a tutoring business in Cerritos, with some claiming conflict of interest between that business and her Board position, concentrated on the voters of Cerritos when she spoke.

"I am disappointed in our Board members, we focused on PLA, what happened, I don't have the confidence to continue."

Apodaca interrupted and called for point of order to stay on the subject and "stay focused on the matter at hand, don't chastise those in the audience or your fellow Board members who you are supposed to be leading at this moment."

Finally, after two hours and forty minutes Board member Law made the motion to approve the bond at \$258 million dollars.

But a vote could not be taken until after additional public comments.

Long-time Cerritos neo-con and self-proclaimed campaign consultant Matt Kauble, who questionably waited until after the PLA debate to comment, sided with Yoo and said "your problem is not with Cerritos voters but with Artesia voters as well."

"You have three trust issues: corruption, incompetence, and whether the Board listens to the district. Nobody trusts the government around here."

Echoing his neo-con values Kauble then said, "you have created an extra hurdle by removing the PLA language...voting to get it out you might have cost the votes you need."

Public comment was done and a vote was taken: the motion passed 7-0 to remove the exclusion of PLAs.

This is a summary of the above entitled Ordinance No. 18-866 of the City of Artesia. This summary has been prepared and published in accordance with the requirements of Government Code Section 36933.

On March 12, 2018, the City Council of the City of Artesia adopted Ordinance No. 17-859, by a 4-0-1 vote, amending Subsection (b) of Section 9-2.3453 (Specific Plan Zones and Zoning Map Designations) of Article 34.5 (Specific Plan Zones (SP)) of Chapter 2 (Zoning) of Title 9 (Planning and Zoning) of the AMC to acknowledge the City Council's adoption of the Artesia LIVE II Specific Plan and establish the Artesia LIVE II Specific Plan (SP 16-02) Zone. Ordinance No. 17-859 also amended the City of Artesia Zoning Map to change the zoning classification of the subject property covered by the adopted Artesia LIVE II Specific Plan from General Commercial (C-G) Zone to Artesia LIVE II Specific Plan (SP 16-02) Zone. Ordinance No. 18-866 repeals Ordinance No. 17-859 in accordance with Elections Code Section 9241, effectively rescinding the Council's adoption of the Zoning Code and Map Amendments for the Artesia LIVE II Project.

On March 12, 2018, the City Council of the City of Artesia also adopted Ordinance No. 17-860, by a 4-0-1 vote, approving a Development Agreement between the City of Artesia and Artesia LIVE II Development, LLC to ensure the orderly development of the Artesia LIVE II Project and the reimbursement of public expenses that would be incurred by the City as a result of the Project. Ordinance No. 18-866 also rescinds the approval of the Development Agreement for the Artesia LIVE II Project granted by the City Council under Ordinance No. 17-860.

CITY OF CERRITOS
ORDINANCE NO. 1021

AN INTERIM ORDINANCE OF THE CITY OF CERRITOS EXTENDING THE MORATORIUM ON NEW OR EXPANDED SELF-STORAGE FACILITIES AND THE ISSUANCE OF BUILDING PERMITS, USE PERMITS, AND OTHER LAND USE ENTITLEMENTS RELATED THERETO WITHIN THE CITY FOR AN ADDITIONAL TEN (10) MONTHS AND FIFTEEN (15) DAYS.

WHEREAS, the Cerritos Municipal Code does not provide specific regulations or standards with regard to the regulation of self-storage facilities within the City of Cerritos, separate from other warehouse uses regulated under warehousing regulations within the Cerritos Municipal Code; and,

WHEREAS, warehouse uses, and thereby self-storage facilities, are currently conditionally permitted in the following zones: (1) Industrial (M) Zone; (2) Industrial/Commercial (MC) Zone; (iii) Industrial Commercial-One (MC-1) Zone; (iv) Industrial Commercial-Two (MC-2) Zone; and, (v) Area Development Plan One (ADP-1); and,

WHEREAS, over the past few years, the City of Cerritos has seen a substantial increase in inquiries related to the development of new self-storage facilities, the expansion of existing self-storage facilities, or the replacement of an existing use to accommodate a new self-storage facility use, as self-storage facilities typically generate substantial rent income for the respective property owner with minimal overhead or administration costs; and,

WHEREAS, in order to address the City's concerns regarding the potential overconcentration of self-storage facilities within the City of Cerritos, and potential economic impacts of permitting self-storage facilities, it is necessary for the City to assess the potential impacts these uses may have on the City's overall economic growth, and to consider adoption of regulations based on such assessments; and,

WHEREAS, pursuant to Sections 36937 and 65858 of the California Government Code, to protect the public safety, health and welfare, a City Council may adopt as an urgency measure an interim ordinance prohibiting land uses that may be in conflict with a contemplated General Plan, Specific Plan or Zoning proposal that a legislative body, planning commission or planning department is considering or studying, or intends to study within a reasonable time; and,

WHEREAS, the Cerritos General Plan's goals and objectives encourage the City to preserve, promote and protect the existing high-quality physical development that characterizes the City and quality of life within the City of Cerritos, while encouraging the attraction and retention of land uses that generate revenue for the City of Cerritos; and,

WHEREAS, the Cerritos General Plan also encourages compatible land uses to locate in appropriate areas of the City; and,

WHEREAS, the Cerritos Economic Development Strategic Plan recommends that the City of Cerritos strategically focus on business retention resources so that the City does not prematurely erode its existing economic strengths, including maintaining a high sales tax base, employment labor force, and a strong business base; and,

WHEREAS, permitting new self-storage facilities, or allowing for the expansion of existing self-storage facilities, prior to the adoption of new self-storage specific regulations may result in (i) a current and immediate threat to economic growth by having an over-proliferation of self-storage facilities in commercial and industrial zones, thereby reducing sales tax-generating land uses, (ii) substantial aesthetic conflicts between unregulated self-storage uses and other regulated commercial/industrial uses and potential increases in visual blight, (iii) adverse impacts to public health, safety and welfare as they relate to traffic and parking impacts; and,

WHEREAS, the City Council of the City of Cerritos wishes to establish comprehensive regulations for the establishment, use and operation of self-storage facilities, so that the public welfare is protected, economic vitality is maintained, and the aesthetics and visual qualities of the City are preserved and protected; and,

WHEREAS, in accordance with Sections 36937 and 65858 of the California Government Code, on June 14, 2018, the Cerritos City Council adopted, by unanimous vote, Ordinance No. 1020, establishing a forty-five (45) day moratorium on new self-storage facilities, the expansion of existing self-storage facilities, and the issuance of building permits, use permits, and other land use entitlements related to self-storage facilities; and,

WHEREAS, the City Council desires to ensure that, during the pendency of the assessment for the formulation and implementation of comprehensive regulations, new or expanded self-storage facilities within the City are prohibited, so that the regulations produced by the City's assessment will be fully effective; and,

WHEREAS, during the forty-five (45) day moratorium period, the City commenced reviewing the Cerritos Municipal Code and assessed industry standards for self-storage facilities, as well as trends of other local municipalities, for research purposes; and,

WHEREAS, the moratorium will expire on July 29, 2018 and the City requires additional time is to continue reviewing potential economic impacts of permitting self-storage facilities and to consider adoption of regulations based on such assessments; and,

WHEREAS, California Government Code Section 65858(d) requires the City Council, ten (10) days prior to the extension of the moratorium or any extension thereof, to issue a written report describing the measures taken to alleviate the condition which led to the adoption of the moratorium; and,

WHEREAS, pursuant to Section 65858 of the California Government Code, to protect the public safety, health and welfare, a City Council may adopt an ordinance to extend the moratorium, for an additional ten (10) months and fifteen (15) days; and,

WHEREAS, the City Council of the City of Cerritos wishes to extend the moratorium on self-storage facilities, as adopted by City Council Ordinance No. 1020, for a period of ten (10) months and fifteen (15) days to allow reasonable time for the City to continue to assess self-storage facilities and the potential impacts of permitting these facilities within the City.

THE CITY COUNCIL OF THE CITY OF CERRITOS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. The City Council finds that the facts set forth in the recitals above are true and correct and hereby adopts the recitals as findings in furtherance for this ordinance.

SECTION 2. The City Council further finds that potential adverse impacts from new self-storage facilities or the expansion of existing self-storage facilities within the City, as stated herein, present a current and immediate threat to public health, safety and welfare, economic vitality, and visual aesthetics of the City. Therefore, the City Council declares that this Ordinance is necessary as an urgency measure under Government Code Section 65858 to address the threats to public health, safety and welfare, economic vitality, and visual aesthetics of the City.

SECTION 3. The City Council hereby extends Ordinance No. 1020 for an additional period of ten (10) months and fifteen (15) days, thereby extending the moratorium on the establishment, development, construction and/or operation of new or expanded self-storage facilities within the City of Cerritos, because such uses, as unregulated, are in conflict with the City's General Plan, the Cerritos Economic Development Strategic Plan, and the contemplated zoning regulations and development standards that the City Council, the City Planning Commission, and/or City's Planning Department is considering or studying or intends to study within a reasonable time from the adoption of this Ordinance.

SECTION 4. Notwithstanding any other ordinance or provision of the Cerritos Municipal Code, no person shall establish, develop, construct, or operate a new self-storage facility, and no application for a business license, building permit, conditional use permit, or any other entitlement authorizing the establishment, development, construction, and/or operation of any new or expansion of an existing self-storage facility shall be approved by the City as of the date of this ordinance.

SECTION 5. Pursuant to the provisions of Government Code Section 65858, this Ordinance shall be adopted by four-fifths vote of the City Council, shall take effect immediately upon its adoption, and shall upon adoption extend Ordinance No. 1020 for a period of ten (10) months and fifteen (15) days.

SECTION 6. Pursuant to California Government Code Section 65858(d), the City Council hereby approves and issues the attached 10-day report describing the measures taken to alleviate the condition which led to the adoption of the moratorium.

SECTION 7. The City Council hereby finds that pursuant to Section 15378(b)(5) of the California Environmental Quality Act (CEQA), this Ordinance is an organizational or administrative activity of the City that will not result in direct or indirect physical changes in the environment, and therefore not a project. Additionally, pursuant to CEQA Guidelines Section 15061(b)(3), this Ordinance is exempt from CEQA review because there is no possibility that the extension to the moratorium may have a significant effect on the environment, because it prohibits the issuance of a building or use permit, or any other entitlement for self-storage facilities. Furthermore, even if the Ordinance is considered a project, the proposed moratorium extension is categorically exempt under CEQA Guidelines Section 15308, because it is clear that the extension to the moratorium will not create an environmental impact and the action will assure the maintenance, enhancement, or protection of the environment through the eventual adoption of regulations and development standards on self-storage facilities. Accordingly, no further environmental review is necessary. Furthermore, as the Ordinance is an administrative procedure related to uses and regulations identified in the Cerritos Municipal Code, and given that the proposed Ordinance is not related to a specific project, the Ordinance (i) by virtue of its location, will not impact a sensitive environmental resource of hazardous or critical concern; (ii) will not have a cumulative impact on the environment through successive projects of the same type, in the same place, over time; (iii) does not have any unusual circumstances that will have a significant effect on the environment; (iv) does not impact a scenic highway; (v) is not located on a hazardous waste site; and (vi) will not adversely impact a historical resource. Accordingly, none of the exceptions to categorical exemptions set forth in the CEQA Guidelines, Section 15300.2, apply to this Ordinance.

SECTION 8. The City Clerk shall certify to the passage of this ordinance and cause the same to be posted as required.

CALIFORNIA GOVERNMENT CODE SECTION 65858(d) – 10-DAY REPORT REGARDING THE CITY OF CERRITOS FORTY-FIVE (45) DAY MORATORIUM, ADOPTED BY CITY COUNCIL ORDINANCE NO. 1020, ON NEW OR EXPANDED SELF-STORAGE FACILITIES, AND PROHIBITING THE ISSUANCE OF BUILDING PERMITS, USE PERMITS, AND OTHER LAND USE ENTITLEMENTS FOR SELF-STORAGE FACILITIES WITHIN THE CITY OF CERRITOS

BACKGROUND

On June 14, 2018, pursuant to California Government Code Sections 65858 and 36937, the Cerritos City Council adopted Ordinance No. 1020, establishing a 45-day moratorium on new self-storage facilities or the expansion of existing self-storage facilities, and prohibiting the issuance of building permits, use permits, and other land use entitlements for these facilities within the City of Cerritos. City Council Ordinance No. 1020 was adopted in an effort to protect the public health, safety, and welfare, to assess the potential impacts that self-storage facilities may have on the City's overall economic growth, and to consider adoption of regulations based on such assessments. The 45-day moratorium is set to expire on July 29, 2018, and in accordance with California Government Code Section 65858(d), at least 10 days prior to the expiration of the 45-day ordinance, the City is required to issue a written report describing the measures taken to alleviate the conditions which led to the adoption of the 45-day moratorium.

MEASURES TAKEN TO ALLEVIATE THE CONDITIONS THAT LED TO THE ADOPTION OF THE URGENCY ORDINANCE

1. The City of Cerritos, in consultation with the City Attorney's Office, has commenced its assessment of potential impacts of permitting these uses, including economic, fiscal, and public health, safety, and welfare impacts.
2. The City of Cerritos has commenced an assessment of other cities' regulations or prohibition of self-storage facilities, by posting a request for information on the League of California Cities Housing, Community, and Economic Development (HCED) ListServe.
3. The City of Cerritos has obtained Municipal Code excerpts from other local jurisdictions pertaining to the regulation or prohibition of self-storage facilities throughout the State of California.
4. The City of Cerritos has started reviewing the existing Cerritos Municipal Code regulations related to self-storage facilities and has commenced the process of amending the Cerritos Municipal Code to establish regulations that are specific and applicable to self-storage facilities, separate from other warehouse uses.
5. The City of Cerritos has also begun reviewing other City of Cerritos plans or documents that may need to be amended following the amendments to the Cerritos Municipal Code, such as the General Plan.

CONTINUED NEED FOR THE MORATORIUM

While the City has commenced its assessment of self-storage facilities, additional time is needed to continue researching industry standards, regulations of other cities, and the potential impacts of permitting these uses in Cerritos, in order to formulate and develop comprehensive regulations for future City Council consideration that will be fully effective in the City of Cerritos. The establishment of regulations for self-storage facilities requires amendments to the Cerritos Municipal Code, which are subject to review and approval by the Cerritos Planning Commission and Cerritos City Council at duly-noticed public meetings. The proper completion of these tasks cannot be completed within the initial 45-day period which ends on July 29, 2018. Therefore, the need for the moratorium remains and it is recommended that the City Council adopt an ordinance extending the existing moratorium for a period of ten (10) months and fifteen (15) days.
