RESIDENTS ANGRY AT CERRITOS LIBRARY VOTE SET THEIR SIGHTS ON LCCN AND ABC SCHOOL BOARD

A group of angry Cerritos residents, who use several anonymous Facebook pages to frequently lash out at any residents or local area politicians who disagree with them, circulated a message on social media calling for a protest at the ABCUSD School Board meeting this past Tuesday night, only 5 spoke at the meeting.



Jane Yim, who has a fake Facebook page, wants to financially injure LCCN.

Their anger started after a 4-1 vote during the November 8 regular Cerritos City Council meeting, with Councilman and former teacher Jim Edwards voting no, that gave Bellflower Unified School District students free access to the Cerritos library.

The city of Cerritos has both the ABCUSD and the BUSD within its borders.

The group alleges that the Council was unethical in their vote, not following City Council rules regarding agendas

Every year since 1981 the White House Historical Association has had the privilege of designing the Official White House Christmas Ornament.

When Jacqueline Kennedy established the White House Historical Association in 1961, she envisioned an organization that would educate and inspire Americans, particularly children, to take part in our shared history. Twenty years later, the Association launched an initiative to celebrate that history by offering unique annual Christmas ornaments to the public. All sales of the ornaments benefit the Association's mission of education and support for the historical preservation of

White House art and artifacts.

Since their introduction, the ornaments have become a sought-after and beloved collector's item for millions of families around the country, providing an opportunity for admirers of the history and the elegance of the White House to share the traditions and stories of holidays past with the next generation.

Carrie Kurata Management Analyst for Cerritos Library gave HMG a special tour of their collection of White House ornaments that is housed on the first floor in the Local History Museum room.

The extensive collection was donated by Julie and Don Knabe, former Los An-

ABC SCHOOL BOARD PRESIDENT VOTE CATCHES SOME OFF GUARD

In a surprise vote that brought yet another Cerritos-based president to the ABUSD, the ABC School Board passed over current Vice President Leticia Mendoza, who lives in Artesia, instead voting to install second-year board member Ernie Nishii as president of the school board for the 2018-'19 year.

This vote marks three out of the last four years a board member from Cerritos has served as president; the ABC serves Cerritos, Artesia, Hawaiian Gardens, and Lakewood.

Voted in as vice president was former clerk Olga Rios; voted in as clerk was long time board member Sophia Tse.

The surprising maneuver started when nominations were open for president, at which time Chris Apodaca nominated Mendoza.

But Mendoza only managed three votes, her own Rios' and Apodaca's.

Nominations were once again opened

STORM BRINGS ALMOST TWO INCHES OF RAIN

A huge Pacific storm brought record rainfall for downtown Los Angeles and other areas, with nearly two inches of rain measured by midafternoon, according to the National Weather Service.

Rainfall measured at USC hit 1.90 inches, beating the previous record of 1.01 inches set on Dec. 6, 1997, the NWS said in a tweet.

The storm also caused mandatory evacuations in Riverside and Orange counties for people living in the Holy fire burn area, shut down the Grapevine stretch on the 5 and caused mud flows, rock slides and flooding.

A Southwest Airlines flight landing at Hollywood Burbank Airport could

not stop and went off the end of a runway onto to the tarmac. Several people watched the plane but most said they were not panicked, no injuries were reported.

ABC 7 reported that an FAA spokesman said Southwest Flight 278 rolled off the end of runway 8 while landing at the airport shortly after 9 a.m. It ended up in an area called the Engineered Material Arresting System (EMAS).

EMAS is a safety system designed to stop planes if they go off the end of a runway, according to the FAA. Wheels from a plane sink into soft material to stop it.

The plane flew out of Oakland around 8 a.m. with 112 passengers and five crew members.

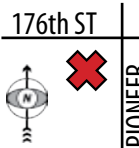

PETCO DONATES \$25K TO GERMAN SHEPHERD RESCUE IN HONOR OF WW II VETERAN

Downey resident George Johnson is a WWII, Korean War and Viet Nam War veteran, and is 93 years young.

He retired from the United States Navy and is a decorated veteran of World War II, Korea and Vietnam, "while I was deployed during WWII, my then-sweetheart sent me a 'Dear John' letter. I was heartbroken, but I found peace through my four-legged best friends," wrote Johnson in his submission.

Each year, the Petco Foundation invites people who adopted pets to share the story of how their adopted pet changed their lives during the annual Holiday Wishes campaign, giving the organization that they adopted from a chance to receive a grant award. The story by George Johnson won the German Shepherd Rescue of Orange County in California a 2018 Holiday Wishes award.

Johnson always had a fondness for white German Shepherds. His long-time companion Velabit, had passed on and he was in need of an another four legged friend. "I called the German Shepherd Rescue of Orange County and asked if they had an older white German Shepherd for me," said Johnson, "I talked with their director, Maria Dales, and she told me they didn't, but she'd watch out for one."

The Foundation called Johnson saying they had found a white German shepherd named Sam, who was days away from being euthanized because he was an older dog. In an interesting turn of events, Sam had been given up by his owner, who was a Navy man and had been deployed. "It was meant to be," said Johnson, "the two of us could grow older together - Sam and me."

A volunteer from the rescue drove all the way from California to Arizona to get Sam, "When I met him it was love at first sight. Sam sniffed me a little and gave his

approval as well," laughed Johnson.

In Johnson submission to Petco he writes:

"I have someone to love, someone to talk to, and someone to look after—and best of all, Sam won't send me a "Dear John letter. He sticks pretty close to me, never more than three feet away, so I know he's looking out for me, too. I've received a few medals, ribbons, and commendations during my naval career, but this dog fills my heart more than all of them put together. We like working in the yard; he's very good at digging holes. Usually we stick pretty close to home, but Sam LOVES going for rides. He pulls himself in the car one leg at a time to get into the backseat for our adventures. Riding brings him such joy.

I spent 30 years in the Navy and I'll never forget that Sam's previous owner is in the Navy defending our country. I am honored to be Sam's caretaker and companion, and I don't know what I'd do without him. He's my best buddy and we share experiences and secrets. I think we've added years onto our lives by being together: Sam is now 13, and I'm 93. In dog years, we're about the same age!"

Because of Johnson's rescue for older dogs and his commitment to his adopted Sam who he describes as his very best friend, the German Shepard Rescue Foundation was given a grant by Petco of \$25,000 in his honor.

Johnson is from the greatest generation and he has done many heroic things, he rescued several men in his sinking ship during WWII, and he continues to inspire others every day.

SHERIFF'S STATION OFFERS PARKING LOT FOR ONLINE SALES EXCHANGES

The Lakewood Sheriff's Station is offering its parking lot and lobby as a safe location for buyers and sellers to meet to complete online transactions through apps such as letgo, OfferUp, CraigsList and others.

Person-to-person online sales, which involve snapping a picture of your item, posting it online, and having someone agree to buy it for your asking price, are easy and convenient, but also come with risks. While the majority of the people using these apps are honest people, allowing a complete stranger to come to your home or other location to pay for and pick up the item can be a threat to your security.

Here are some tips to increase your safety when meeting people to buy or sell items:

- Meet at a reasonable time of day, preferably during daylight.
- Don't meet alone or with children present. Have someone accompany you.
- Don't hand over the item until you have the cash in hand.
- Avoid meeting at your home. If the item is too large to transport easily, consider placing it in the garage or on the porch/entry way. First, meet in a public place (bring a friend) to see proof of identity. If you're comfortable, allow the person to follow

you home. If the buyer has brought someone, keep them together in your presence. The less they see or have access to your home and personal belongings, the better.

- If you agree to meet at a neutral location, consider a well-lit area with people around and possibly video surveillance cameras, such as the Lakewood Sheriff's Station lobby or parking lot. Don't meet in an area that's unfamiliar or uncomfortable to you. If the other party is not willing to meet you in a place you feel safe, don't meet.

- When purchasing items, inspect them for accuracy and be sure you're getting what you want. It's okay to change your mind and not purchase the item(s).

- If a deal seems too good to be true, it usually is. There are a lot of stolen items sold online. Drug users may sell things at extremely discounted prices just so they can get money for a fast high. Contact your local law enforcement if you think something is stolen.

- Be careful with your money. Don't open your wallet and pull money out in front of the seller. Have the exact amount agreed upon in a specific pocket.

Residents in single-family homes can recycle their Christmas trees beginning Wednesday, December 26 through Friday, January 11 by placing them at the curb for pick-up by 7 a.m. on their trash collection days.

The trees will be composted or used for the Los Angeles County Sanitation District's daily landfill cover.

Trees to be recycled should not contain any lights, tinsel, nails, metal stands or decorations, and should not be placed in bags.

Trees more than 4 feet tall should be cut in half. Flocked trees will be accepted.

Businesses in Cerritos or residents

living in apartments or condominiums can place trees next to their trash bin for collection.

PORT OF LONG BEACH AWARDS \$1 MILLION GRANT TO RANCHO LOS CERRITOS

Rancho Los Cerritos won a \$1 million grant last week from the Port of Long Beach to improve water quality in and around Long Beach, which is part of a larger voluntary environmental mitigation grant program the port commission started last year.

The grants is aimed specifically at storm water capture and treatment and will compliment Rancho's goals to upgrade the property while maintaining its historical nature.

The commission's program commits the port to spend \$46.4 million to improve the health of children, seniors and other populations living near the harbor.

The plan calls for a comprehensive drainage design system for the entire site, including permeable surfaces, water basins, rain gardens and filter strips using a reservoir that can hold up to 10,000 gallons of water.

Water from the reservoir will be filtered, sterilized, and used as irrigation on the property; the system will increase water retention from the 40 percent to 95 percent when completed.

In addition to the retention system, the grant will be used to better protect the property during major storms. System flow will guide the runoff to the property's arroyo, where it will collect in a pond using a fountain for aeration, and treated with biofiltration.

"The generous support from the Port of Long Beach will allow the rancho to be a leader in water recapture in Long Beach and beyond," Kevin Kayse, rancho board chair, said. "It's a game-changer."

The students are part of a larger community with a rich cultural identity. The goal is to empower the children to rise out of poverty by becoming educated leaders in their community as 'women and men for and with others'.

President and Founder of The Hollywood Museum, Donelle Dadigan, was joined by LA City Councilman Tom LaBonge, Captain Elaine Morales of the LAPD and representatives from the offices of Council Member Mitch O'Farrell and Senator Kevin DeLeon together as well as special guests from the cast of "Happy Days" actors Anson Williams [Potsie], Don Most [Ralph] and America's mom, Marion Ross, [Mrs Cunningham] for a special day at the Hollywood Museum.

The tour will be followed by a lunch in the festive atmosphere of Mel's diner and then each student will receive Christmas stockings to take home and share with their families.

CAROTHERS HAS CAREER NIGHT AS CERRITOS POSTS FIRST WIRE TO WIRE VICTORY AGAINST CITY RIVALS

In a rivalry that has been clearly dominated by Gahr High over the past 10 seasons, the Cerritos High boys basketball team not only won its second straight annual tussle with the Gladiators last Friday night, but did so in an unconventional way. The visiting Dons scored the first six points of the game and never trailed as they knocked off Gahr 74-60.

In the past, these two city combatants have traded leads in their games together, but on this night, Cerritos led 40-18 at the half and Gahr was unable to score consecutive baskets until midway through the third quarter, after the Dons had built a game-high 27-point lead.

"We knew in the second half that they were going to make a run," said Cerritos head coach Jonathan Watanabe. "There's too much pride between the two schools to not keep fighting throughout the game. Just with our young group, it's different. But we're still learning. We have a long way to go; you haven't anything yet."

Cerritos was up 14-7 after the first quarter as junior Gavin Carothers scored six points and grabbed three rebounds. But he wasn't done with what would be his best night in the first five games as a varsity member. Carothers added another five points, two rebounds and two assists in the second quarter. But it wasn't just the scoring that was setting the tone in the first half.

The Cerritos defense was causing fits for the Gladiators (3-2 overall) in the first 16 minutes, who went scoreless for over two minutes on three different occasions and caused numerous turnovers throughout the half.

"I thought the first half was awesome," Watanabe said. "In the second half, we kind of let up a little bit. So, we just have to keep putting four quarters together and keep getting better. That's what it's all about."

"They told us to keep the intensity up and they wanted us to go faster because they told us they can't keep up with us," Carothers said.

Cerritos (3-2) shot 50 percent from the field in the first half and at one point, was true on six straight field goals in the second quarter. But towards the end of the third quarter, the Gladiators made things interesting. Back to back three-pointers from junior Jason Hardrict, his only points of the first half, made it 49-28. Then in a span of 69 seconds, Gahr got baskets from seniors Justin Stephens, Ryan Young and sophomore Moses Dollar, the last on a steal, and just like that it was 52-35. A three-point play from ju-

nior Ethan Woon left Gahr trailing by 16 points after three quarters.

"They battled; they could have easily folded at halftime," Watanabe said of Gahr. "But they're going to battle and that's what we want. That's why it's a rivalry. You come out here and play and battle. It's fun; that's what it comes down to. You want to be tested, and our group needs to be. You have these tests right here to get better."

The Cerritos lead dipped to a dozen points after a steal and basket from Hardrict with 3:49 left to play. But sophomore Alex Archer scored consecutive baskets, then senior Tim Huang scored three straight points to push the lead back to 20 points with 2:26 remaining in the contest.

Carothers led everyone with a career-high 21 points, four points better than his last outing against Diamond Ranch High on Nov. 24. He also pulled down 10 rebounds along with three assists and two steals.

"He played awesome, not just scoring, but he was making great passes," Watanabe said. "He was making the right decisions and he was doing a lot. He has all the potential in the world and he's still at the beginning stages. He was way more to grown."

"I just came out confident before warm-ups," Carothers said. "I was just working on myself, getting my mind right and just came out quick."

Senior Aditya Suresh quietly added 11 points along with five rebounds and three steals while Archer chipped in with 10 points and eight rebounds. Junior Jagger Uy would also have nine boards as the Dons defeated Capistrano Valley High 39-37 this past Monday in pool play action of the prestigious North Orange Country Championships. The Dons will also play La Habra High and Esperanza High in pool play action before moving into the playoffs tonight.

"It's a lot of fun," Carothers said of his first varsity game against Gahr. "I like the intensity out there and I like the crowd; the crowd is a bit part of it."

Stephens scored 17 points and Young added 12 points as the Gladiators knocked off Montebello High 67-57 this past Monday in first round action of the El Rancho Blue Pride Classic. That tournament runs through Saturday. Gahr will then compete in the Gahr/St. John Bosco Classic next week.

at which time Sophia Tse nominated Nishii; a seemingly previously decided majority quickly voted Nishii in as president.

Nishii texted HMG-LCNN after the vote saying he was "very surprised" then said in a later statement, "I am honored to be selected to be President during this critical time in ABCUSD history. The past years have seen amazing leadership from our superintendent and our immediate previous presidents, Chen, Apodaca and Yoo. With this strong mandate and continuing support from all of my fellow board members we can be confident to faithfully implement the vision of OUR community. We can address all challenges head on through our open transparent engagement with

all sectors of our community. Through this, and the platform the new facilities and new resources will provide, we can enable ABC to be not only an exemplary district in Los Angeles County but also an exemplary district in the State of California. Thank you for the opportunity to serve."

HMG-LCCN asked Tse to comment on why she voted against Mendoza, then nominated Nishii.

Tse wrote in an email, "I support both Ernie and Letty for the Board president position. Letty would have been a good president but I chose Ernie as president when I considered who was better in leading us regarding our upcoming oversight committee decisions and guiding us through the facilities construction for the district."

In an email to HMG-LCCN, Olga Rios, who's sister was just ousted as an incumbent from Hawaiian Gardens City Council, wrote, "I congratulate Ernie on being elected President. We began our journey on this board together and, in a short time, he has demonstrated extraordinary leadership. His efforts in the BB campaign were outstanding, as well as his overall involvement across the district. I am confident that his unwavering dedication will continue to move our district forward."

Later during public comment, a group of Cerritos residents fighting the Cerritos City Council for issuing free Cerritos Library cards to Bellflower Unified students, lashed out at Rios for a speech she gave in favor of issuing the free cards.

Rios called the resident selfish and discriminatory among other derogatory things. During public comment, the residents called on Rios to resign.

and meetings.

That was a massive pivot from earlier arguments that criticized Council for simply giving the free access to BUSD children.

But a review of the video of the meeting shows that the Council did follow the rules regarding agendas and meetings, affirmed by City Attorney Mark Steres.

Steres commented during Council debate, "this type of decision is called a legislative decision, and the question was brought up again whether you want to put this (free library access question) on the agenda. There was concurrence to put it back up on the agenda, and so it is back on the agenda, so now it is a free and open question to revisit again."

"So we are free to take action" remarked Mayor Mark Pulido, "that's correct," said Steres.

Councilman Jim Edwards attempted to intervene using a staff report technicality saying, "adding schools (for free access) was not on here, this was a report to receive and file or direct staff."

"But the direction of direct staff could be to direct staff to add or subtract from the policy," Steres told Edwards.

"That is the direction of the motion, to add an additional category of free library cards, so it is within the scope of the staff report and what is in front of the Council to direct staff to expand the policy to add that motion."

The Council discussed and debated the item further finally calling to approve the motion, which passed on a 4-1 vote.

But the residents ignored, or did not watch, the justification by Steres and

turned their attention to the November 19 City Council meeting.

A little over ten residents spoke against the free access for BUSD students, but they all failed to protest against other groups who have free access.

It was revealed later by HMG-LCCN that Cerritos offers free access to several other groups including ABCUSD students and employees, Cerritos College students and employees, Cerritos city employees, anyone who works in Cerritos, and anyone who owns property in Cerritos.

In 1992, the City even voted to give anyone who stays at the Cerritos Sheraton free access.

After the anti-library residents were finished, ABC Board Clerk, now VP, Dr. Olga Rios spoke.

Rios slammed the residents saying that the arguments made against giving BUSD cards were, "elitist, discriminatory, and incredibly selfish. I hope that using national-style scare tactics won't work here, throwing around big numbers I hope only makes people question their credibility. I hope it makes people think about what their underlying motives are."

Rios continued, "I wonder if these same people stand outside the Cerritos Auto Square or the Cerritos Mall asking non-residents to shop in their own town? No they don't mind non-residents spending money."

Seeing that they had another target, the angry group of residents launched the drive to attend Tuesday's ABCUSD meeting on their fake Facebook pages.

The board meeting featured the appointment of a new president, vice president and clerk, and is a normally tranquil affair with only presentations to the outgoing president - in this case Soo Yoo - and the nomination and appointment of

the new officers.

Yoo will likely have several friends and family members attending the transition- members who were forced to watch the angry residents eschew normal meeting guidelines to voice their anger at Dr. Rios for simply expressing her opinion.

After reading last week's HMG-LCCN article on the November 8 vote - and the protests by Cerritos residents - Charlie Ara, a Cerritos resident himself, commented, "The Hubert Humphrey Democratic Club and I led the fight 30 years ago to let students in all ABCUSD schools have library cards. Like the fight for a Martin Luther King Jr. Holiday, we have worked hard to bring Cerritos into the 21st Century.

"Looks like a small group is pushing Cerritos backwards."

One local resident commented, "so you can't speak your mind without these people attacking you? It is like the article last week in this paper wrote, Trump style divisive politics using fake social media pages has entered into Cerritos, its pathetic."
