It was standing room only at the Albert O. Little Community Center this past week when two new elected officials and one incumbent was sworn in for Artesia City Council seats.

Retiring long-time Councilwoman and Mayor Sally Flowers was feted by several national, state, and local field representatives for her years of service.

Newly elected Councilwoman Melissa Ramoso was sworn in by California Street Treasurer John Chiang, Councilman Rene Trevino was sworn in by Mayor Flowers, and Councilman Ali Taj was sworn in by newly elected Los Angeles County Sheriff Alex Villanueva.

Villanueva did not swear in any other elected officials in Los Angeles

RESIDENTS USE SCARE TACTICS

NUMBERS REFUTE RESIDENT CLAIMS CONCERNING CERRITOS LIBRARY CARDS

A group of angry Cerritos residents, who have been using several anonymous Facebook pages, are circulating false messages on social media in an attempt to mislead residents after the Cerritos City Council, on a 4-1 vote, allowed Bellflower Unified students to have free Cerritos Library cards.

An annual card from the library cost \$100.

The residents argued that the initial 4-1 vote was illegal and then used blatant scare tactics saying that "all 12,000 Bellflower Unified students will sign up for free cards and cost the City \$1.2 million."

Their first argument, that the Council vote was illegal, was disproven by City Attorney Mark Steres, who indicated at a Council meeting that the vote was completely above-board.

Defeated, the residents then took to social media in several questionable posts writing that "all 12,000 Bellflower students would sign up for free cards and cost the City \$1.2 million."

In a typical social media post fashion, no back-up was provided, a clear move by the angry residents to discredit the four who voted for the cards and advance their political agenda.

Mayor Mark Pulido, Mayor pro tem Naresh Solanki, and Council persons Frank Yokoyama and Grace Hu voted for the free cards.

Resident Elaine Shiohama even wrote falsehoods.

Shiohama was found by HMG-LCCN in 2014 - along with other Cerritos Fine Art and Historical Commission members - spending thousands flying across the country staying in hotels and eating fine meals just to choose artwork for the City.

Shiohama wrote on Facebook, "This is essentially a gift of \$1.2 million to the BUSD district from the city. It is not fiscally responsible to give a gift of this size especially since not long ago the residents were threatened with budget cuts that would have restricted library access."

For the past ten years the Peace Club of Tracy High School has gathered goods to ship to our military troops overseas.

"We have been donating care boxes to the troops for many years," says Pat Alviso, Peace Club Advisor, "The idea was actually brought to our attention by students and every year we send out close to 90 care boxes.

The club has been working for weeks to get boxes filled to ship overseas to our troops to help them through the holidays."

The care boxes are packed full of snack items, stationary, DVD's and CD's, batteries, sunscreen, chapstick and just about every other item essential to everyday needs.

All the schools across the District have contributed to the care boxes; Carver Elementary kindergarten classes pitched in; Hawaiian Elementary held a fundraiser; the ABC Adult School and the District all donated items as well as individual donations from parents, students and teachers.

A contest was held and the group that gathered and contributed the most was the Infant Center at Tracy High School.

The Peace Club is a voluntary group that meets during their lunch break to discuss alternatives to violence through peacemaking and negotiations, "We talk about global issues and local issues," adds Alviso, "we also want our students to understand you can be against war and violence, but still support our

troops."

Names and addresses of soldiers in Iraq, Afghanistan and different areas in the Middle East are requested from the ABCUSD or from those students who have family stationed overseas.

"It's a very difficult time right now," says Alviso, "many of our students are dealing with DACA and immigration issues and so we try to explain to them this is not about a particular political party, it is about justice and fairness and caring about fellow human beings."

The Peace Club is currently working with a family in Long Beach, whose father is a military veteran and is facing deportation, "We are not just talking about these issues, we are teaching students how to deal with them and what they can do to make a difference."

Alexandra Mendiola, senior and President of the Peace Club, "I came from a different high school and was having some issues, but the Peace club helped me fix some things in my life and helped me to change for the better." Mendiola added that the Club will be going out to help the homeless during this winter season, stating that blankets, warm socks and food items are needed.

If you would like to donate items such as soccer balls, hacky sacks, puzzles, games, books, DVD and of course letters, are always welcome, "Letters and cards to our soldiers stationed in other countries means so much to them," says Alviso, "just to let them know we miss them, and want them to come home safely means so much."

The American Legion Auxiliary's marquee Girls State program, first presented in 1937, is one of the most respected and coveted experiential learning programs presented in the United States.

The program epitomizes the ALA's mission to honor those who have brought us our freedom through our enduring commitment to develop young women as future leaders grounded in patriotism and Americanism.

Each summer, approximately 16,000 young women participate in weeklong ALA Girls State programs across the nation.

To be eligible, young women must be a legal inhabitant of the United States. Participants must provide a copy of their U.S. birth certificate or their U.S. government-issued documentation verifying they are in the United States legally, e.g. green card or visa.

They must have completed their junior year in high school and have at least one more semester remaining before graduation; be keenly interested in government and current events; have high moral character; show strong leadership abilities; demonstrate above-average scholastic achievement.

Every American Legion Auxiliary Girls State program operates with the same patriotic values through a nonpar-

tisan curriculum where students assume the roles of government leaders, campaigning in mock parties often called 'Federalists' and 'Nationalists' to become mayors and county and state officials of their ALA Girls State.

The program is a weeklong immersive learning experience, often held on a college campus where girls live in cities within a dormitory like setting.

The young women become knowledgeable of the democratic process and how our republic form of government works at the state and national levels.

The American Legion Auxiliary Girls State Class of 2018 were on hand when Department of California Girls State Chairman Tammy Sollazzo and Western Division Girls State Chairman Anita Biggs presented American Legion Auxiliary Lakewood Unit 496 Chairman Maryanne Erdmann the first ever Girls State 80th Anniversary Recognition Award.

Erdmann has been instrumental in changing the lives of young women from area schools for over 30 years as Girls State Chairman for Unit 496.



But a simple examination by HMG-LCCN of the individual categories for Cerritos library card holders show that the angry resident's claims of "costing millions" is patently false.

Cerritos allows residents and certain other categories to obtain free cards, even allowing people who stay at the Sheraton Cerritos to have a free card.

Property owners, employees of the City, Cerritos Colleges employees and students, people who work in Cerritos, ABCUSD employees, resident and non-resident students, and active duty military personnel who are permanent or tem-

porary residents of California can get a library card without charge as well.

The numbers show that out of the 19,640 library card holders, 16,454, or 83% are Cerritos residents.

There are almost 50,000 residents in Cerritos meaning that over 33,000 residents, or 66%, do not take advantage of one of the most prestigious libraries in the nation that is right in their backyard.

And in another scratch-your-head type number, nearly 12,000 out of the 19,640 cards holders are over 18.

But in what will be a surprise to many, including the angry residents, of the 19,640 library cards only 295, or 1.5%, are actually paid, meaning 98.5% of the library cards are free.

Delving deeper into the numbers show that the policy to give Bellflower

students cards will not affect the library, a fact that the angry residents could have found with a little research.

Of the 295 paid cards (1.5% of the total), only eight, or 2.7%, are classified as child or young adults.

Given those numbers, only five additional children from Bellflower would sign up for free library cards.

Finally the residents' claims of "the sky will fall if we allow Bellflower students into our library" are once again refuted by the students who attend ABC but are not residents of Cerritos.

The numbers show that only 532 non-resident students in the ABC system have free library cards: 312 from 18 different ABC elementary schools; 58 from the middle schools; and 101 from high schools obtained a free card.

Council approved expanding this educational resource to Bellflower USD students.

A library card changed my life. At the age of 2, my grandmother and parents brought me to the Las Palmas and Memorial libraries in my hometown of San Antonio. I quickly fell in love with reading and I am pleased to support any effort that gives our students this gift. I am sure many of you have similar stories.

So last night I took my children to the Cerritos Library. We brought the required paperwork and my children now have the privilege of using this wonderful educational facility. I encourage all BUSD parents to take their children and fill out the forms today. I brought my drivers license, utility bill within the last 60 days, and their reports cards. The report cards must include their date of birth, or you can bring a copy of their birth certificate. My son was SO excited about this, he even told his teacher about it at school today.

And by the way, a Cerritos Library card is available without charge to anyone who lives or owns property within Cerritos, people who attend school or work in Cerritos, ABCUSD employees and students, Cerritos College employees and students, and active duty military personnel who are permanent or temporary residents of California. Visitors who check in to the Cerritos Sheraton for a night can bring a hotel confirmation and get a library card without charge as well.

CPUC TO CONSIDER TAXING TEXT MESSAGES TO FUND PROGRAMS

A proposal suggested last month by the California Public Utilities Commission (CPUC) considered whether text messaging services are part of the Public Purpose Program (PPP), and can therefore be taxed.

Apparently, that answer is yes.

This past Wednesday it was announced that the CPUC is set to vote in January 2019 on the proposal to tax text messages. State regulators say the money would be used to support the

PPP, that provides telecommunication services to the poor.

It is unclear at this point how much users would have to pay per message. The wireless industry and business groups are of course fighting the plan, stating it could cost phone users an extra \$44 million a year.

The PPP stems from the 1996 Telecommunications Act requiring the FCC to establish support mechanisms to ensure that schools, libraries, health care providers and low-income, rural, insular, or residents in high-cost areas receive access to affordable telecommunication services.

Carl Guardino, President and CEO of the Silicon Valley Leadership Group, did not mince words.

"This is a bad practice when hard-working Californians are already feeling taxed to death, not every new idea needs

a new tax to fund it, the CPUC is sitting on \$1 billion in PPP funds already."

Other media outlets were reporting that the extra money collected would be used to supplement the state's LifeLine program. LifeLine is a state program that provides discounted home phone and cell phone services to eligible households; LifeLine discounts help consumers lower the cost of their phone bills.

Business groups estimated the new charges for wireless customers could equal about \$44.5 million a year, but that isn't all of the program.

A controversial part of the program will allow the CPUC to tax retroactively, up to five years; critics are already lining up against that proposal saying it is unreasonable, warning that it would set a dangerous precedent by allowing companies to tax retroactively.



retired, and incumbent Marianna Rios' seat was up for re-election.



HAMAKAWA'S HOT HAND HELPS WHITNEY WIN CONSOLATION CHAMPIONSHIP, NORWALK GRABS SIXTH PLACE

The Whitney High girls basketball team had the easiest scouting report it could get on Paramount High as the two met for the consolation championship of the 21st annual Glenn/Norwalk City Classic last Saturday afternoon. The two would meet again this past Tuesday in a non-league contest at Paramount, but the first meeting had more at stake.

Behind a dominating second quarter performance from senior Christine Hamakawa, the Lady Wildcats outscored the Pirates by 22 points in the stanza and cruised to a 52-35 victory. Hamakawa, who scored a game-high 24 points, hit seven three-pointers in the second quarter as Whitney erased a 7-4 deficit with 70 seconds left in the first quarter to take a commanding 32-11 halftime lead.

"I thought it was a great tournament," said Whitney first-year head coach Rachel Nagel. "After the first game, we came up short and I didn't feel we played the best game we could play. We still had three games left to play in the tournament, so it was an opportunity to play games back to back and get a lot of experience. I was glad to see that the girls played hard and were able to get out with those three last wins of the tournament."

Hamakawa, who missed on both of her attempted shots in the opening quarter, hit three outside shots in a row to put her team up 17-7 midway through the second quarter. Following a basket from Vanessa Castaneda, Hamakawa hit four more three-pointers. The only other field goal Whitney would get in the stanza came from sophomore Kim Hosada, who completed a three-point play with just under two minutes left.

Hamakawa would begin the second half with her last perimeter shot before the Pirates scored six straight points. It was only the second time this season Hamaka-

wa, who averaged close to 11 points last season, scored in double figures and just the third time a Whitney player has scored at least 20 points in a contest. Hamakawa, who was named to the All-Tournament Team, had been struggling most of the season, scoring five points or less four times, but whatever she ate last Saturday morning seemed to work.

"I'm not sure," Nagel chuckled about what Hamakawa ate before the game. "She's a great shooter as it is. So, it was nice we got her a few open looks. I thought our ball movement was great and she was just getting loose against the zone and then once she started to catch fire, it was like, 'alright, just keep feeding her the ball'. I thought everyone did a good job of finding her and realizing that she caught fire."

Junior Janelle Ho and senior Justine Wu each scored seven points while Hosada added five points. The 35 points yielded tied for the sixth fewest given up, and the third time in the past five games.

"I think we stepped up our defensive effort [after the first quarter] and that helped lead to easier buckets for us," Nagel said. "At first we were a little stagnant and kind of letting them operate. But once we increased the ball pressure, we were able to get some rebounds, a couple of steals here and there and that led to the offensive end of getting easier buckets."

Earlier in the tournament, Whitney (9-3) fell to Montebello High 47-38 before bouncing back to easily defeat Compton Centennial High 63-35 last Thursday and John Glenn High 48-17 last Friday. Wu posted a game-high 20 points against Compton Centennial coming off the bench on eight of 10 shooting from the field and four for four from the free throw line. Senior Valaree Villegas scored 12 points and Ho added 10 points plus six rebounds and three steals. Against Glenn, Wu and sophomore Makenna Yokoyama each scored 10 points while Hosada added another eight points and grabbed eight rebounds off the

bench.

"I think Justine is just a great energy player for us," Nagel said. "I think she is a leader out there; she does a great job of getting to the basket, getting contact, getting to the free throw line. But even on the defensive end, she's always hustling back and forth, stopping the ball, guarding one of the better players."

Whitney, which knocked off Paramount 47-42 this past Tuesday, will visit La Serna High on Saturday before facing San Fernando High on Wednesday in pool play action of the Savanna Holiday Classic. The Lady Wildcats will also play Oakland-based McClymonds High on Thursday in the tournament.

Co-host Norwalk High went 2-2 in the tournament after falling to Fountain Valley High 47-32 last Saturday afternoon in the fifth place game. The Lady Lancers (4-4) never led in the game, falling behind 11-4 within the first five minutes of the game. They got within five points twice in the second quarter and again 32 seconds into the second half on a basket from sophomore Brianna Flores. After that, the Barons scored the next 11 points to put the game away.

Senior Priscilla Martinez led Norwalk with 12 points off the bench while Flores added 11 points. Senior Destiny Goodloe, who was named to the All-Tournament Team, added seven points and scored 43 points in the tournament. Norwalk also defeated Gahr High 55-28, lost to Santa Fe High 48-33 before defeating Mary Star of the Sea High 44-33. The Lady Lancers visited Paramount this past Wednesday and will host California High tonight before going to Fullerton High on Monday and hosting Glenn on Thursday.

Finishing in 11th place was Glenn, which knocked off Lawndale High 39-29 last Saturday morning in the tournament's third of eight games for the day. The Lady Eagles were barely challenged as they led 10-2 after the opening quarter and 25-12

at the half.

"Today's game is hard to judge because Lawndale was kind of depleted," said Glenn head coach Ruben Guerrero. "They were down to four players, so it's really hard to judge. But it was actually good experience for our younger players to get in there and get a lot of extra time. That really helped them."

"I think overall this tournament...we saw our deficiencies and we also saw what we're good at," he continued. "And we're just trying to figure out a way of how to put that all together more consistent on a game to game basis."

While Lawndale started with five players but finished with four, Glenn had eight of nine players score, led by seniors Denise Cardenas (nine points, five rebounds) and Berenice Santana (eight points, four rebounds), both of whom came off the bench. Sophomore Karina Flores grabbed 10 rebounds as all nine players had at least four rebounds. But Glenn shot 22 percent from the field, something Guerrero said the team needs to improve on.

"Some of those shots taken are ill-advised," Guerrero said. "It's one of those things that we're trying to teach them shot selection and not every shot is a good shot. Sometimes they get it and sometimes they don't."

Glenn (5-6) also fell to Fountain Valley High 57-39 before getting past Edison High 40-32. Junior Dominique Harrison, who didn't play against Lawndale, scored 13 points against Edison and 10 points against Whitney while sophomore Cynthia Almanzar, who had six rebounds against Lawndale, added 12 points against Edison. Almanzar was named to the All-Tournament Team.

"Her play is still kind of spotty," Guerrero said. "Even though she doesn't play like a first-year varsity player, at times she looks like a first-year varsity player. The good thing about Cynthia is she's played a



CERRITOS GIRLS SOCCER HOLDS OFF GAHR TO REMAIN DOMINANT AGAINST CITY RIVAL

Before this past football season when they did not play each other, Gahr High had pretty much owned the city rivalry against Cerritos High on the gridiron. But in the winter, and on the soccer pitch, it's a completely different story in girls soccer.

Visiting Cerritos scored twice in the first 18 minutes, then held off a late Gahr rally to come away with a 2-1 victory this past Tuesday night at Hanford Rants Stadium. The Lady Dons have now won five straight against the Lady Gladiators and eight out of the last nine meetings (the 2013 contest was a 1-1 tie). Since 1997, Cerritos owns a 12-3-1 mark against Gahr, outscoring the Lady Gladiators 55-16 in the process with seven shutouts.

But all wasn't happy with Cerritos head coach Rob Adams, despite his team improving to 5-1-2. The Lady Dons had eight shots in each half and eight corner kicks in the game but still came away with two goals.

"I'm not really discouraged by that," said Cerritos head coach Rob Adams. "I'm a little disappointed that...we would like to make better progress in finishing off games like this. We have to figure out a way to get a little distance going. We have to mature more."

Four minutes into the contest, sophomore midfielder Marisa Couto fed a pass to junior midfielder Maya Tydor who scored her first goal of the season. Then in the 18th minute, senior defender Julia Couto assisted on a goal from junior forward Shamara Barsana, who snuck in her third goal just past Gahr senior goalkeeper Ashley Correia at the near post.

Cerritos held Gahr without a shot in the first half and seemed to have a handle on Gahr's best player, sophomore forward Nicholette Palomo, who has scored four of the five goals for the Lady Gladiators.

Ten minutes into the second half, Palomo spoiled the shutout bid, then the hosts proceeded to take three more shots at Cerritos junior netminder Shelby Dykes. The Lady Dons had a chance to ice the game with 11 minutes remaining, but Barsana couldn't get off shot after she broke loose from the defense and raced all by herself towards Correia.

"Gahr had a one-dimensional attack and yet we gave them opportunities in the one dimension," Adams said. "That's the part we need to mature about. In other girls soccer action, after three straight ties, followed by two consecutive losses, Artesia High picked up its first win of the season, a 2-0 decision over Whittier

High this past Tuesday. The Lady Pioneers will face Estancia High on Saturday in the first game of the Best in the West Tournament, then either San Gabriel Mission High or Rialto High later in the day. Artesia will also host St. Joseph on Tuesday and Norwalk High on Thursday.


