Lakewood Council Votes to Transition to Voting Districts

At its Tuesday Jan. 12 meeting, the Lakewood City Council reviewed its legal options under the California Voting Rights Act (CVRA), which strongly encourages cities to create council district seats, each representing a portion of a city, instead of having each council member elected by the entire city, which Lakewood has done since its incorporation in 1954.

The CVRA makes it relatively easy for lawsuits to succeed against cities that maintain citywide council elections. And if a city loses a lawsuit, the city pays the attorney fees for the party bringing the suit, which can run into the millions of dollars. No city or other jurisdiction has won in such a suit, and over 150 California

'Large Disturbance' Planned for Los Cerritos Center

Hews Media Group-Cerritos News has received a memo from the Torrance Police Department's Special Investigations Division to the Los Angeles County Sheriff's Department Operation Center alerting them of a potential large planned disturbance at the Los Cerritos Center this Saturday, January 16, at some point between 2 p.m. and closing, which is 8 p.m.

The Los Cerritos Center is located in Cerritos off the 605 freeway and South Street.

A supervisor from the Torrance Police subsequently informed the Sheriff's that this past Saturday, a large group of approximately 300 juveniles converged on and created a disturbance at the Del Amo Fashion Center in Torrance.

Mall security was quickly overwhelmed while numerous fight broke out and shoppers panicked. Security requested mutual aid from surrounding law enforcement agencies and, after several hours, order was restored. The disturbance caused Del Amo to close several hours early. Investigators reviewed social media content and determined that the disturbance was planned.

Re-Routed Trucks Creating Noise Nuisance on 166th

At an August 2019 Cerritos City Council meeting, Sundance residents spoke at public comment complaining about the constant truck traffic traveling down Bloomfield after exiting from the 91 freeway.

One resident produced a sound meter he used to measure the noise that indicated the DB levels were between 70 and 90 DB's.

"Under federal guidelines," he asserted, "anything over 70 DB's requires hearing protection."

HMG-LCCN published a small article about the complaints, which, as the old saying goes, "opened the flood gates."

The problem was traced to the closures in and around the 5 freeway that was forcing trucks traveling westbound on the 91 freeway to exit on Carmenita, driving north on Carmenita to Alondra.

Trucks going eastbound are forced to exit on Bloomfield, turning north to Alondra.

Residents who live along Carmenita between Artesia and Alondra and in Granada Park near Bloomfield and Alondra were fed up with the noise and vibration and wrote HMG-CN demanding something be done about the traffic.

HMG-CN subsequently received a statement from the city indicating that the city of Cerritos was going to explore options to mitigate the noise from trucks.

The city looked at two options, the first was the development and implementation of a city ordinance to reroute and/or restrict truck traffic along Bloomfield Avenue.

The ordinance would restrict the traveling of trucks on Bloomfield Avenue to certain hours only.

The feasibility of rerouting trucks from Bloomfield Avenue to alternate routes was also being considered.

The city retained the services of a sound engineering consultant to review different options available for the purpose of mitigating vehicular noise in the area.

The City Council ended up adopting the ordinance to restrict the traffic, declassifying the Bloomfield truck route and classifying a truck route on Shoemaker from 166 north to Alondra.

Norwalk City Hall, like Cerritos, has been hit with a COVID outbreak.

COVID cases began to spike on Dec. 17 when the city reported three cases in the Social Services department, eight in Transit, two in Community Development, two in Public Service, three in Public Safety and one case in the Recreation

The Lakewood City Mayor and the entire City Council have called on patients and residents to express their gratitude and appreciation to the doctors, nurses, and staff of Lakewood Regional Medical Center who have worked tirelessly during this pandemic.

"Here in California we are in the depths of a deadly virus. Our hospitals are overflowing with CoVID patients, ambulances are being delayed or diverted to other hospitals – sometimes in other counties, beds are hard to find and people are tragically dying at record levels in LA County," said Mayor Rogers.

CoVID deaths have risen from 20 people a day this past summer to 150 per day this winter. There have been 28 Lakewood residents die from CoVID thus far and over 4,000 confirmed cases. This is hitting Lakewood Regional Hospital very hard.

"Like other hospitals in the region, Lakewood is getting hammered by new patients every day," remarked Rogers, "the hospital normally holds about 100 patients



a day, but LRMC currently has over 200 in-hospital patients per day. This increase is entirely due to the increase of admissions that are seriously ill with CoVID."

The medical staff is working long hours under stressful conditions, Rogers adds that they are doing their best to heal these patients with all of their compassion, care and expertise. These Lakewood heroes are really on the frontline with the pandemic and deserve our gratitude.

With this in mind the City of Lakewood is launching a 'Thank You Campaign' for patients and residents to express their appreciation to those who are struggling bravely in the battle against this virus.

Allergic Reaction to Vaccines Extremely Rare

As vaccines to protect against COVID-19 continue to roll out, the CDC has documented a small number of reports of severe allergic reactions from some recipients. A report from the CDC, published Wednesday (January 6) finds that most of these rare events occurred in those with a history of allergic reactions.

As of December 23, nearly 1.9 million doses of Pfizer-BioNTech's vaccine had been administered across the country, according to the report, with 21 verified cases of anaphylaxis that followed, a rate of 11.1 per million doses. Four of the individuals did not have a medical history

1 Person Killed in Long Beach House Fire

One person is dead following a house fire in Long Beach late Wednesday night.

Firefighters responded to the 1000 block of Marcellus Street at about 11:30 p.m. and reported heavy fire coming out of a one-story house, according to Capt. Jack Crabtree with the Long Beach Fire Department.

It took 24 firefighters approximately eight minutes to put out the fire, according to the Long Beach Fire Department. The Red Cross is assisting displaced residents.

One person was found dead inside the home and another managed to escape the flames, Capt. Crabtree said. That person was looked over by paramedics but did not need to be taken to the hospital, according to Capt. Crabtree.

of severe allergic reactions. Among those who did, seven had experienced anaphylaxis in the past. Epinephrine, the drug used in Epi-Pens, was given to 19 of the patients, and four were admitted to the hospital. Follow-up information was available for 20 of the patients, all of whom have since been discharged from the hospital or have recovered from their reaction.

Everyone who receives the vaccine is advised to stay put for 15 minutes to monitor any harmful side effects, while it is recommended that those with a history of allergic reactions wait half an hour. The report found that the median time to onset of symptoms was 13 minutes.

Representatives from the CDC say that the risk of an allergic reaction from the vaccine is worth taking, given how deadly COVID-19 continues to be, as the US surpasses 360,000 total deaths.

Compton Billboard Sets Guinness World Record

Bulletin Displays, LLC, one of the largest independent and locally owned billboard companies in L.A. County, made history last month when they erected the tallest statue ever put on a billboard.

Present at the building of the board were representatives from the Guinness Book of World Records.

Bulleting President Mark Kudler had the distinct challenge to erect the largest 3D cutout onto a freeway bulletin board. This particular sign is only one of 52 bulletin boards scattered along the freeway by the company, for Dusk to Dawn Urgent Care and Dr. Eugene Allen.

After graduating from law school, Kudler joined the family business and began to redesign and restructure freeway signage. Bishop Guillory, Ombudsman General of the United States, commented, "Mark had the vision to proceed with his dream; you brought it to Compton where these boards have been a great revenue generator for the City."

Dr. Allen is a native of Mississippi and a child of the Deep South, "My upbringing has taught me to be humble and thankful." He spoke of losing both his parents at a young age, being raised by his grandmother and his first job as man of the house, learning to pick cotton.

The good doctor unveiled a billboard with a 3D, 15 foot tall sculpture of himself to replace a cardboard cutout. "This isn't just to bring attention to our urgent care facilities, as you can see we have several billboards along the freeway, but I want this to represent that, even in times like these, you can still achieve great things."

Allen has had his business in the city of Los Angeles and surrounding communities for 18 years. "My whole goal, outside of taking care of patients, is to take care of the community, whether that is talking with the kids or donating to a good cause or giving away 1,000 turkeys during the holidays," added Allen.

Brenda Olmos vice Mayor of Paramount said, "I come here with at heart full of happiness for Dr. Allen, for those of you don't know me I work in the health care industry and what I can say about Dr. Allen is that when he is asked to do something, he never says no. It is always how much can I give, and how can I support."

The billboard can be seen at 1120 W. Artesia Boulevard, Compton. Representatives from the Guinness Book of World Records verified and confirmed the record breaking statue.

Whittier Councilwoman Attended Trump Riot Rally

Controversial Whittier City Councilwoman Jessica Martinez attended the rally prior to the invasion of our capitol but denies she went into the building.

Martinez announced her intent to participate in the rally on Twitter alongside multiple tweets questioning the legitimacy of the presidential election and branding Republicans who accepted the result as "traitors." On Wednesday morning, she also uploaded a clip of video footage from the rally.

There is calls to censure Martinez, County Supervisor Janice Hahn also added her voice to those calling for Martinez's censure.

"Any attempt to delay or prevent the peaceful transfer of power is a threat to our democracy and there must be consequences," Hahn said Friday in a statement.

Martinez' former actions do not square with her denial that she was at the rally.

In six tweets posted, she responded to tweets saying Somalia-born Rep, Ilhan Omar, D-Minneapolis, "can go back wherever she came from and REALLY be a victim" or saying about U.S. Sen. Elizabeth Warren, D-Massachusetts, "President Pocahontas? She needs a Wigwam not the white house."

This proved ineffective as six cases were reported that week.

"My plea to our residents is that they stay home if possible," said Councilwoman Margarita Rios. "They should practice safety, wear a mask, do not risk exposure to anyone who may have COVID, schedule an appointment with your doctor if you don't feel well."

Three cases are reported in the Social Services department, with at least one case confirmed at the Norwalk Senior Senter at 14040 San Antonio Drive.

The COVID case was confirmed by an employee in the Social Services department who wished to remain anonymous.

They stated that Senior Center employees continue to obey CDC guidelines such as wearing masks and

social distancing."

"PPEs are available and distributed to both staff and visitors to City facilities, as needed. We have also issued multiple rounds of reusable face coverings to all employees," said Wosick.

On Jan. 6, Norwalk provided their fifth round of free COVID testing to city employees. 146 employees participated in the testing.

If a department reports a case, it receives additional cleaning and is sanitized. Still, the department is not shut down, according to Wosick.

"The City has implemented a telecommuting policy as part of our COVID social distancing efforts. Qualified employees can work from home for a portion of their schedule," Wosick said.

The city has practiced transparency with its employees via text and email when a department reports a positive case. Norwalk residents have received no notice when a city employee tests positive.

The anonymous source also stated that their superiors are being transparent with their employees when somebody tests positive.

"Employees were notified via text message, the public has not been made aware of the cases within the social services department."

The Norwalk Senior Center has been closed to the public since Mar. 13, 2020. Still, they continue to prepare and deliver meals to seniors who would otherwise have no means of food.

"We have essential services we have to meet, services that residents rely on," Rios said.

Norwalk Mayor Jennifer Perez expressed that the city is doing everything to protect its employees.

"City hall is open by appointment only," Perez said. "Offices and workstations have been prepped for "The City does not anticipate publishing employee medical results in any public format," Wosick stated.

The COVIDs vaccine was given to the Norwalk community hospital for first responders. It is undetermined when the vaccine will be given to the general public.

"It's my understanding of the vaccine that it's in tiers. Some specific responders will be able to receive the vaccine first," Rios said. "I have not received the vaccine yet. If it is made available to me, I will take it."

Norwalk has not experienced any city employee deaths from the virus.

HMG-CN Opinion: Sicknick's List for Domestic Terrorists

There is chatter among lawmakers that anyone who is arrested for invading the capitol on Wednesday should be placed on the no fly list, good idea, provided they don't go to jail first.

HMG-CN proposes another method of watching the domestic terrorists; create a national watch list, much like Megan's List, which shows sexual offender's pictures and place of residence, so people can see where the terrorists live and know who they are.

Call it Sicknick's List in honor of the U.S. Capitol Policeman Brian Sicknick who died at the hands of the terrorists on Wednesday.

The anticipated opening of Stay Gallery back in October 2012 was successfully launched with a two day celebration of Downey's cultural diversity. It continued to be a new and edgy venture, with many supporters and fans for eight years. Then the pandemic hit.

ore than ever the Anaheim White House restaurant gives back to the community by helping to break the cycle of hunger and poverty during the coronavirus pandemic.

The restaurant has served more than 5 million meals to children and families in Orange and Los Angeles counties through their nonprofit, Caterina's Club, founded by owner Sir Chef Bruno Serato in 2005. They also have been helping the at-risk homeless and teaching the restaurant business to local high school students for several years now.

Chef Bruno has known hardship firsthand in both his career and lifetime. It was just 4 years ago, that the Anaheim White House went up in flames thoroughly destroying his business and costing more than \$2 million in damages. As a young boy growing up in Italy, his family struggled with poverty.

"Bruno grew up poor," said Caterina's Club Associate Executive Director Iris Castillo. "He often received hand-medowns from friends and neighbors, and his family often struggled to put food on the table.'

This gave him perspective and led him to always have a heart for children, a natural part of his kind and compassionate nature that led him to always provide for the less fortunate, said Castillo

"Whether it be one of his employees or a stranger that looks hungry, his heart hurts serving more than 3,000- 4,500

when he sees need in people," she explained. "His philosophy and favorite quote are, 'No child should go to bed hungry.' He's always had a heart for children and will stop at nothing to help as many as he can.'

Chef Bruno's desire to help others was inspired by his own mother, who once visited the Boys and Girls Club of Anaheim down the street from his restaurant. It was there she noticed a 6-yearold boy eating potato chips for dinner because his family could not afford a proper meal. She immediately insisted that Chef Bruno make some pasta for the child. Soon, they realized there were many more hungry 'motel children,' and Chef Bruno began making pasta for 72 children, 5 nights a week.

This simple act of kindness gave birth to the "Feeding the Kids in America," program which is part of Caterina's Club. Today, "Feeding the Kids" has expanded to provide more than 25,025 children a week with a nutritious hot meal, according to www. caterinasclub.org. But today it is to not only provide warm has grown to mean more to many more during COVID-19.

"Our Feeding the Kids program has been deeply affected by the pandemic," said Castillo. "The program's most marked changes have been the sheer numbers we are serving and the shift from feeding homeless and low-income children to feeding entire families.'

Prior to the COVID-19 outbreak, Feeding the Kids was yet meaningful as a nightly

children every night with a hot pasta with protein and vegetable sauce dinner at 90 sites in 29 cities throughout Orange and Los Angeles counties. Since March. this has grown to 96 partners in 30 cities, according to Castillo.

"Since COVID-19, Orange County is now considered the second most economically impacted community in the country," she said. "COVID-19 has changed not only the number of meals we provide, but who we provide them to. We now serve an estimated 38,000 to 75,000 families each week."

Castillo explained that this includes providing 5,730 to 15,500 ready-made family meals for pick-up at up to 96 program partner sites. And it includes making weekly pantry and grocery in the dark environment of items available for parents while a motel, are provided with adapting to ongoing program needs

"In all, we anticipate serving an unprecedented 2 million meals by the end of 2021," she said.

"Caterina's Club's mission meals, but also give affordable emergency housing and assistance, and job training to homeless and low-income families throughout Orange County," Castillo said. "This mission is supported by a vision where we create a modicum of consistency in the lives of homeless and severely low-income children through something as simple dinner. Quite simply, we strive

to provide every child [with] the resources, love, and encouragement they need to be healthy, safe, and educated."

"Over 98 percent of the children we serve receive the federally funded lunch but have limited access to evening or weekend meals, and most have parents working at more than one iob," she explained. "Since the program's inception, we have provided more than 5.4 million pasta dinners."

But Chef Bruno was frustrated that feeding the children was not enough, so Caterina's Club began a second program called "Welcome Home," where qualified families, living the necessary resources to

Furthermore, Caterina's Club's Welcome Home program also offers emergency and homeless preventative outreach to families at risk of eviction, a service which began in 2017. Through this, families are assessed and can qualify for financial rental assistance and case management services. Help can also include a 3-day notice intervention, storage fee relief, and utility assistance.

"These families [usually] struggle to stay in their rented residence and [struggle to] keep their belongings, dignity, "Since children," said Castillo. inception of this program's arm, we have helped 31 families with emergency and preventative 82 assistance, translating to individuals remaining in their homes and off the streets.'

It has also been Chef Bruno's desire to help teens in Anaheim learn about all aspects of the restaurant industry. In 2016, he started the Chef Bruno Hospitality Academy where students learn everything from cuisine, nutrition, restaurant service and administration aspects of the restaurant business.

The Hospitality Academy has partnered with the City of Anaheim's Career Readiness Initiative P21 and the Anaheim Union School District since its first fall semester. Ever since, it has increased instruction from two high schools in Anaheim to six high schools. They nclude Anaheim High School, Cypress High School, Katella

High School, Western High School, Oxford Academy, and Kennedy High School, according to Castillo.

"To date, more than 300 AUHSD students have participated career mentoring and/or in internships with the Anaheim White House/Caterina's Club," she said.

A new component of the Hospitality Academy began last year with eight students interning over the course of 12 weeks at The Anaheim White House Restaurant. Culinary and back restaurant skills as well as front restaurant operations are taught to them over a three-month period. Each intern is also gifted a \$225 monthly scholarship. In 2021, Chef Bruno will increase the number of interns from eight to 12 to extend the opportunity to more students, according to Castillo.

The Anaheim White House was crafted by Dosithe Gervais and considered a national historical landmark in 1909. It was owned by the Waterman family and was a mansion for 50 years to the Dr. Truax and his wife, Louise. In 1981. Jim and Barbara Stovall purchased the home and drew up new plans for the restoration as "The White House Restaurant."

In 1987. Chef Bruno Serato. an Italian from San Bonifacio, Verona, took over the ownership of the Anaheim White House Restaurant bringing with him his signature Northern Italian Steak House cuisine. In 2017, the restaurant suffered a devastating fire destroying the building, however, plans to rebuild

commenced almost immediately. By 2018, the Anaheim White House re-opened its doors.

"The rebuilding after the fire was a challenge, as it cost a lot more money than expected to rebuild, but gratefully the community and local supporters came together and donated funds that aided tremendously with it," said Chef Bruno. "Business was great, my customers love dining at my restaurant, and then the pandemic hit a year after reopening my doors."

"Restaurants everywhere are fighting lockdowns doing the best they can to survive," he continued. "We lost 4 to 5 months of business, including the holiday and convention season, which is essentially our bread and butter. After getting shut down for the second time in 2020, we decided to offer a take-out service. However, the demand was not enough for us to remain open." The Anaheim White House restaurant employs 45 workers.

Chef Bruno's hopes for the future are "prosperity for everyone after this virus, and to open the

White House doors so I can do what I love most - cooking. making people happy when they dine at my restaurant, and most importantly, feed every hungry child in the world.'

High school football season growing shorter as coaches begin focusing on potential later start

The second week of the CIF-Southern Section football season would have been tonight. Instead, the reality of no high school football in California for the remainder of the month and well into February is setting in for those involved.

The latest youth sports guidelines were released by the California Department of Public Health this past Tuesday and to no surprise, all but four counties in the state remain in the purple tier. Once this month is over, four football games will have been lost with up to six regular season games still up in the air. As the number of COVID-19 cases and deaths continue to rise, there are mixed opinions as to if there will be any high school football games before the early part of April, which is when the divisional championship games are slated to be played.



for the fall sports began on Nov. 2 and at Cerritos High, the Dons were doing that

for four and a half weeks, according to first-year head coach Brad Carter, before the state shut down youth activities last month. He said the team was conditioning Monday through Thursday and there were 50-60 players a day getting in shape for what they thought would be a complete 2020-2021 football season.

"It was tough getting them cleared and everything, but we had a really good turnout," Carter said. "And then unfortunately in December we had to shut down again because of the threat of the virus. We went back to virtual training...and we've been doing that since the first week of December, sending the kids workouts. We meet with the kids twice a week on Zoom. So, that's kind of where we're at."

When there was conditioning, Carter said that there was a lot of enthusiasm amongst the players and they, along with the coaches, were excited about the possibility of playing this winter. He added that since the recent shutdown, the coaching staff and players tried to stay positive.

"Obviously, they understand the situation," he continued. "Everything the coaches have been voicing to them is stay ready for our time. We don't know when that time is; nobody knows. Hopefully, it's February or March. If not, hopefully by August at the latest. But we're not really trying to predict the future. We're just staying ready as we can until we get the green light."

Carter, who like other coaches have had to change their own calendars multiple times since July, is hopeful that the middle of February will signal the return to conditioning, then practice, followed by the games. The CIF-SS pinned March 12 as the last date for regular season football games with the playoffs beginning the following week and the divisional championships slated for April 9 and 10. There won't be any state championship bowl games this season.

Carter said he is adjusting his calendar to what he 'hopes will happen', but at the same time not plan too far ahead since everything is still up in the air and things have been changing on a week to week



mode.

"We've already been told by [the ABC Unified School District] we're in virtual conditioning until January 31 at the earliest," Carter said. "Right now, it's kind of a week to week operation. That came out last week. I know we're not doing anything on campus in the month of January. I'll be shocked if we do it the first couple of weeks of February."

Since the CIF-SS is not going to change the ending dates of the fall season and the beginning dates of the spring season, Carter believes that the CIF-SS might eliminate the four-week playoff period to allow schools the opportunity of playing more games if the first game isn't until March. The 605 League is scheduled to play only three games this season-Feb. 26, Mar. 5 and Mar. 12.



Artesia High head football coach Olmstead Don and his staff have would spent this past week preparing for tonight's home opener against Chino High. Al-

though he is frustrated that he can't see the players in person, he indicated that he tries to remind the players that there is a bigger picture that can't be overlooked.

"There are people who are losing loved ones; that have loved ones in hospitals that they can't see that are going to die," he said. "There's a lot bigger picture than just the game of football."

While Olmstead admitted that he misses being out there running around and see the season he thought the Pioneers would have, the school has seen quite a few kids get sick. He added that those kids are doing well now and are fine, but it could have been a scary time back then.

Olmstead said when the pandemic broke out last spring, he didn't think COVID-19 was here because he didn't really know anybody who had it. Now, it's a different story when he sees students and/or their families get it as it hits a little deeper.

"I still want to play; I still think our kids need to play," Olmstead said. "I just don't know when that is going to be. All those things that we thought were going to happen might have to be pushed back just because we're not in a good place right now from any aspect of playing football."

Since conditioning was shut down last month, Olmstead has been having the players breaking down college and the NFL games, just like ESPN's and former NFL star quarterback Peyton Manning breaks down what Josh Allen of the Buffalo Bills does. "It kind of gives the kids a different perspective that even the guys in the NFL are still doing the same stuff we're doing," Olmstead said. "The first play they run, they run zone and it's the same play we run. I've been trying to connect that so the kids can have something to relate too and maybe have a little more knowledge watching the game than they did two months ago. [This past Tuesday] we watched a replay of the [NCAA] National Title game from last night." Olmstead is hoping that the Pioneers would be able to get at least the three league games in with the best case scenario being five or six games, depending on what the CIF-SS wants to do with the playoffs, or no playoffs. The worst case scenario would be the obvious-that there

wouldn't be a football season at all. He added that while he has not heard of the possibility that the CIF-SS would slightly alter its football calendar, he finds it hard to imagine that they haven't thought of that.



During the summer, John Glenn High first-year head coach David Cruz predicted that the 2020 high school football season would not even happen. The way that it's looking now, Cruz might be spot on with that prediction. The Eagles would have visited Long Beach Cabrillo High tonight before hosting two straight games, including the Mayor's Cup tilt with city rival Norwalk High on Jan. 29. As of now, that won't happen.

"I guess I could see the writing on the walls," Cruz said of his prediction. "I knew that we weren't going to get through this anytime soon. They were talking about the numbers going up and I could see it. I really thought that maybe in March, we might have a chance to play sports. But, if you're looking at where we're at now and how many cases and how many deaths...I was telling my wife [this past Monday] I can't believe how many people on Facebook start off their posts with, "I say this with a heavy heart". Since Facebook has been created, I've never seen so many people passing as I have this last month.'

Cruz, who is also one of the school's two athletic directors, acknowledges that everyone wants sports to start, but he doesn't think we're anywhere near to that happening. He pointed out that David Clifton, the athletic director at Oxford Academy, told the other 605 League athletic directors that the Anaheim Union High School District, in which Oxford Academy is a part of, won't allow any of its schools to conduct any conditioning until every zip code in the district falls below 10 percent. Right now, that figure is way above 25 percent. Clifton also told the league athletic directors that he's doubting whether or not that they will be able to practice in July.

Cruz continued by saying that the Norwalk-La Mirada Unified School District is following what the other nearby school districts are doing and that it isn't going to be the first to jump into anything.

Besides football, the first league event for the other fall season sports are as follows: boys and girls cross country (Jan. 27), girls volleyball (Jan. 29 for the second round) and boys water polo (Feb. 2).

"Of the AD's we're talking about, we're more optimistic about cross country," Cruz said. "But you get into a pack; what kind of starting line are we going to have to have if we do compete? Are we going to have to shuttle them off to the side after they finish because they have to have social distancing? I just don't know if we're going to be able to put that together in time. I just don't see it happening." As it relates to Glenn's football program, Cruz said it's tough being limited to Zoom just because of all the difficulties the teachers are experiencing. The same is happening with the football players and he continued by saying there's no guarantee the players are going to be on their cameras and you can't see all the players' cameras. He calls the situation an uphill battle. Through the classes and the Zoom sessions, Cruz tries to find at least one motivating factor in the class and treat it as

Given the CVC, trucks coming from the south, exiting from the 91 freeway, would be allowed to turn north on Shoemaker, taking them past Whitney High and Wittman Elementary.

Dr. Sieu and other teachers and staff were very concerned about the new traffic and expressed those concerns in the letter.

Cerritos staff spoke with traffic and court officials, including a traffic commissioner, for advice on the changing of the truck route; they indicated it could be problematic to change the Bloomfield truck route.

They also indicated that the Shoemaker route could ease truck traffic in the city, but traffic study should be done similar to what was performed on Bloomfield.

The City Council was given three choices in the staff report:

Take no further action and leave 1. the emergency ordinance intact

Wait for further information from 2. the courts and commissioners and advise the City Council accordingly

3. Declassify the new truck route on Shoemaker.

The last choice would presumably open the Bloomfield route up again.

The City Council decided to declassify the new truck route on Shoemaker, pass the ordinance restricting truck traffic to certain hours, and placed electronic message signs reminding the trucks of restricted hours.

But evidently that is not working.

The city has received numerous complaints of commercial trucks operating off designated truck routes or ignoring the message signs.

The city is trying to mitigate the traffic, handing out 303 citations while issuing 319 warnings in 2019-2020.

But it is not working according to Sam Hooper, who's house is near the corner of 166 and Bloomfield.

Hooper sent an email to the city in July writing, "Soon after limiting truck traffic on Bloomfield large trucks are routinely traveling on 166th street. Basically all day and more often during peak hours. Because our house butts 166th Street at Bloomfield, we have more truck traffic noise than we ever had in the 40 years my family has lived in Cerritos. Why is this happening? Please advise.

Daryl Evans, Community Safety Services Director for Cerritos replied, thanked Hooper family for alerting the city, and assured him that addressing "quality of life issues was a priority" for City staff.

"In an effort to abate the problem, the City will direct additional enforcement of its truck route ordinance along 166th Street," wrote Evans, "additionally, the city will deploy one of its newly acquired message board signs on 166th Street in the near future for the purpose of alerting commercial truck drivers that 166th Street is not a designated commercial truck route."

A notification was also sent out in the city's Neighborhood Watch Weekly Message, posted July 31, 2020. Numerous residents subsequently contacted the city and expressed similar concerns as Hooper.

In the beginning of August the city directed traffic enforcement deputies on 166th Street and found there was a problems with trucks skating around the Bloomfield blockage; in just two months, deputies issued 138 citations and 91 warnings to commercial truck drivers.

"We are still educating drivers," Evans said, "and with the pandemic we have had a huge increase in truck traffic while simultaneously experiencing staffing issues but those issues were due to deputies forced to take vacation, we are over that now."

cities and school districts have now transitioned to district elections, many doing so to prevent a costly lawsuit.

After deliberation, the Lakewood City Council voted unanimously to avoid the costly legal challenge and passed a Resolution of Intent to create district council seats starting with the 2022 and 2024 council elections.

The transition process will include the hiring of an expert demographer who will help the city hold a series of public meetings, likely beginning in April of this year, with the goal of finalizing maps for council district lines by October 1 of this year.

The theory behind the California Voting Rights Act is that when council members are elected citywide, there tend to be fewer minority group members elected, and that requiring voting by district creates more opportunities for minority group members to be elected, especially if they represent a particular region of a community that has a high population of a minority group.

While the Lakewood City Council currently has two minority group members, that fact alone does not prevent the city from losing in a lawsuit under the CVRA.

At Tuesday's meeting, City Council Members expressed appreciation for having members elected by and responsible to the entire city under Lakewood's current system, but also expressed hope that council members in the future would continue the tradition of looking out for the interests of the entire city, even if elected only by one area of it.

a normal classroom situation. He's been teaching the players the X's and O's, strategies and basic fundamentals.

"I'm trying to get my guys to understand the game of football, so when we get out there, the only thing that we'll have to do is condition them," Cruz said. "I'm sure most of the coaches are doing that. But it's an uphill battle because you have to focus on one thing, and it can't be physical. These kids are getting so weak because they can't touch a weight."

Cruz went as far as taking a survey with just his team and a handful of them have any type of weight equipment or access to them. So, the majority of the team have been doing body weight-type exercises and running.

Another problem facing Glenn stems in the numbers department. Even though Cruz has just over 40 players in his football class, the school does not have a big enrollment and a lot of the football players are active in other sports. Cruz says that if they begin practice, he is sure he will have more students. However, because of the condensed athletic seasons for the 2020-2021 year, baseball, basketball and wrestling, for example, will begin their seasons right at the end of the football season, if there is one. Cruz is concerned that if football were to start up in the beginning of March, he may lose many players to the spring sports because most of the football players are involved in other spring sports.

"I was telling [co-athletic director] Linda [Parra] that I think, at Glenn, since it's a small school, we may have to concentrate on some of those other sports that we can compete in," Cruz said. "Because, if they decide to have all the sports, Glenn is going to have to pick and choose which sports we're going to have."

Today, a slew of high schools throughout the state will be participating in what is called the 'Let Them Play' rally in hopes of sending a message to state officials to reopen youth sports in the state sooner than later. Carter, Cruz and Olmstead have all indicated that their schools/football programs will not participate in the rally.

"Like I said, I think my kids have a little different perspective on this stuff because some of them have [COVID-19] and we've talked about it," Olmstead said. "So, I think they kind of know the realization and how serious it can get. I don't think we would participate in that."

"As a school, there's no way Linda or I will ever promote that," Cruz said. "Now, whether or not the kids get involved in that, that's something different. But we're not trying to spearhead or steer kids for that. It's against my beliefs anyway. To me, it's kind of selfish. I can understand students that are juniors and seniors that have been waiting their entire life to play high school football and now they're not given the opportunity. But not when I'm seeing so many people pass away." Carter said he received an email last week about the rally and the football team has joined one Facebook movement. Other online movements have been the Golden State High School Football Coaches Association, which is a statewide movement, and a Southern California High School Football Coaches Association. "There are a few movements that me and my coaching staff have been joining," Carter said. "We're also trying to get our players and families involved. We're not doing an organized rally ourselves. I know there's a really big rally [today] at the capital in Sacramento and I know they're trying to really organize an organized movement that route."
