## ARTESIA'S ELECTRIC BUS SERVICE BEGINS

The city of Artesia held a ribbon cutting ceremony on July 14 to officially launch the first completely free all-electric bus service in Southern California.

Mayor Rene Trevino welcomed residents and city staff saying, "Today we welcome the city's new electric transit service. This project began in 2008, and after years of hard work, we are thrilled to present to our residents convenient access to parks, shopping centers and the

city's vibrant downtown area at no cost."

The new system will produce zero emissions and will connect riders to the city's points of interest, including the new trail and eventually the new Light Rail Line, which will connect Artesia to Union Station in downtown Los Angeles.

This bus will allow riders to visit the diverse collection of businesses and restaurants. The project has been made possible by a \$588,000 federal appropriation and returned funds under

## Area Cities See Uptick in Illegal Fireworks, Citations

Fireworks displays marked the 245th birthday of the United States' independence throughout Los Angeles County this 4th of July. City and Fire officials pleaded with the public to attend and not shoot off their pyrotechnics.

The use of illegal fireworks soared last year, with shows canceled because of the coronavirus pandemic. There were approximately 6,000 calls about illegal fireworks to the Los Angeles Police Department on July 4, 2020, a 72% increase from the previous year.

Los Angeles County Fire Department firefighters responded to 39 incidents directly related and sparked by fireworks the week before and the week after the holiday last year, including a fireworks explosion in Baldwin Park that left two dead. There were 14 people injured in incidents county fire crews reported, including hand injuries that caused disfigurement or amputation.

Joel Hockman, Bellflower Public Safety Director, tweeted during the weeks leading up to

Bassett Unified School District (Bassett) was established in 1898. The district serves the communities of La Puente and Baldwin Park, encompassing around 8 square miles. The area is absent of hills and valleys; residents call it "Pancakes" or the "Flatlands." The Eastside 13 did not Walkout in this neck of the woods and face 66 years in prison. They marched for

better conditions in schools and spearheaded a movement. Just ask Moctesuma Esparza.

In the early 2000s, under Bassett's Board and Superintendent Robert Watanabe, someone placed a call to George Pla of Cordoba Corporation. He delivers. At the time, Bassett served approximately 6,000 students at 4 elementary schools, one magnet school, one academy, one high school, one continuation high school, and an adult school.

Cordoba supported Bassett and took the lead in developing a needs assessment study, otherwise known as a Facilities Master Plan, a common tool used by districts and companies to sell bond measures, kind of like nation-building; brick by

## Deported Marine From Artesia Back in the U.S.

ARTESIA (CBSLA) — Hector Ocegueda, a Marine Corps veteran who was deported to Mexico following a misdemeanor crime nine years ago, now has American citizenship and is back with his family in Artesia.

"I feel at home. This is my home," Ocegueda said. "When they deported me, I cried when I crossed the border. Now, I cry out of joy. It's the total opposite. I feel good. I feel like an American."

The 53-year-old Ocegueda left Mexico as a child and was forced to return there after a DUI conviction.

Ocegueda spent nearly the last decade living in Mexico, but on Friday was able to return home to Artesia.

His citizenship oath was administered in Los Angeles last Friday.

Under U.S. law, immigrant veterans with honorable standing can become citizens if they meet certain requirements.

As part of the process, Ocegueda was scheduled for an interview in L.A. but authorities wouldn't let him cross the

border due to his deportation order.

So, Ocegueda sued and asked for his interview on the border or that he is allowed to enter the U.S. for the purpose of having his interview.

The latter was granted and that's what brought Ocegueda to the moment of finally returning home.

Ocegueda served in the Marines from 1987 to 1991 and was honorably discharged.

During his military service, he was stationed at Camp Pendleton & Japan.

Under President Joe Biden, U.S. officials are working on removing barriers for noncitizen military members and veterans to gain eligibility to become American citizens.

The ACLU estimates there are dozens of other veterans in a similar position as Ocegueda. Ocegueda, who had a drug problem and went through a treatment program, said his goal now is to go back to become a nurse assistant and work with veterans.

# Earthday.Org Wants to Make it a Plastic-Free Summer



**THE PANDEMIC** has led to a surge in pollution from disposable products like plastic face masks and hand sanitizer bottles. Earthday.org is drawing attention to the harmful effects of plastic using the *End Plastic Pollution* campaign to help people understand the impacts of plastic pollution on human health and the ecosystem.

As summer gets into full swing, the United States just celebrated its 245th birthday.

Although we may be an independent nation, we are still very dependent on plastics. Our food comes packaged in plastic, many will use plastic plates and cutlery as summer events begin to open back up and unfortunately leave plastic and cardboard strewn about that can easily find their way into our oceans.

The plastics ending up in our oceans have dire effects on marine life. Plastics can easily be mistaken for food by marine animals and often lead to disease. In fact, 89% of reefs containing plastic show signs of disease. Such exposure can result in suffocation, starvation, entanglement and often death.

As part of the study, published in the journal *Science*, researchers analyzed more than 124,000 corals from 159 reefs in Myanmar, Thailand, Indonesia and Australia. Nearly everywhere they looked, they saw plastic. "We came across chairs, chip wrappers, Q-tips, garbage bags, water bottles, old nappies," Joleah Lamb, a marine disease ecologist at Cornell University and lead author of the study, tells Yong. "Everything you see on the beach is probably lying on the reef."

Smithsonian Magazine reports further investigations are needed to determine precisely how and why plastics make coral susceptible to different diseases. But generally speaking, it seems that plastic debris slices open the skin of the corals and exposes them to pathogens. Plastic debris can cause physical injury and abrasion to coral tissues by facilitating the invasion of pathogens or exhausting resources for immune system function during wound-healing processes.

It is in our homes, our oceans, our food, and everywhere we go. This month, EarthDay.org, is drawing attention to the harmful effects of plastics in our environment and wants to make this July plastic-free.

The End Plastic Pollution campaign helps people understand the impacts of plastic pollution on human and ecosystem health and how everyday actions can lessen the problem.

The campaign draws attention to the harmful effects of plastic in our environment, harming marine and human health, littering beaches and landscapes, clogging waste streams and landfills and empowers people to make a difference.

Every day, we use millions of tons of plastics, and with it, we are steadily filling our oceans, rivers, land, and bodies. Scientists tell us that we are eating up to 5 grams of plastic every week, equivalent to the weight of a credit card.

## Newly Restored *Our Lady of Angels* Now on Display

Nepomuceno Ricardo Vejar was born in San Diego in 1805. In 1837 he and Ygnacio Palomares received a land grant for the Rancho San Jose. Vejar became one of the wealthiest men in Los Angeles and purchased the neighboring Rancho Los Nogales where he built a large new adobe.

One of the rooms in his new home was dedicated exclusively for worship and was ultimately consecrated by the Catholic Church to become the first church in Pomona.

According to his son Ramon Vejar, Ricardo bought paintings, wooden sculptures and other artifacts from Spain and Italy to adorn his chapel.

Closer to home he is reported to have acquired art for his chapel that had once hung in the California Missions.

Some of these paintings from his chapel are now part of the collection of the Autry Museum.

The adobe was abandoned in the 1880s and was left to the elements until it was acquired by the City of Pomona in the 1930s. In 1939, the adobe was restored in a joint project of the City of Pomona, the Historical Society of Pomona Valley and the Works Project Administration. Since 1940, it has been open to the public as a museum on life in the Spanish and Mexican ranchos. It was listed on the National Register of Historic Places in 1971. Of the more than 400 sites in Los Angeles County that have been listed on the National Register, fewer than ten received the distinction prior to the Ygnacio Palomares Adobe.

Little is known about the origins of Nuestra Senora de Los Angeles, 'Our Lady of the Angels'. The work is not signed, but it is a Baroque painting in the Spanish colonial style.

Experts tell us it is from the early 19th century and was most likely painted in the workshops of Seville Spain, which produced sacred works to be shipped around the world to Spanish outposts.

After the death of Vejar in 1882, the painting and many of the artifacts from the chapel went to his son Ramon. Unfortunately, a fire in 1918 caused significant damage; since then, additional candle smoke, smog and time have hidden many of the details of the painting.

In 1940 the painting was donated to the Palomares Adobe Museum in Pomona, 'as is' by Miss Estella Vejar, Ramon's daughter.

Carl Von Bargen, Chairman for the Native Sons of the Golden West was key in awarding two very generous grants toward the restoration of the painting,

"This painting represents exactly what the Native sons was created to do. With an ever-changing population, it was only a matter of time before the colorful history of the Gold Rush and early-day statehood would soon be forgotten. Civil War veterans began seeking grants for public lands, thus the organization was born in California and our mission is to preserve the state's history."

Today, thanks to the generosity of many and the skill of the artists at Fine Art Conservations Labs, the Historical Society of Pomona Valley were able to restore this historic treasure and view it as Ricardo Vejar did when it first arrived in the New World.

## L.A. Health Recommends Mask Indoors Starting July 17

With increase circulation of the highly transmissible Delta variant, the Los Angeles County Department of Public Health has strongly recommends everyone, regardless of vaccination status, wear masks indoors in public places as a precautionary measure. In the week ending June 12, Delta variants comprised of nearly half of all variants sequenced in Los Angeles County. The Centers for Disease Control and Prevention (CDC) noted that Delta variants are now responsible for about one in every five new infections across the country, up from approximately one in every 10 the week before.

Public Health strongly recommends people wear masks indoors in settings such as grocery or retail stores; theaters and family entertainment centers, and workplaces when you don't know everyone's vaccination status. Until we better understand how and to who the Delta variant is spreading, everyone should focus on maximum protection with minimum interruption to routine as all busi-

nesses operate without other restrictions, like physical distancing and capacity limits.

Fully vaccinated people appear to be well protected from infections with Delta variants, however people with only one vaccine dose of Pfizer or Moderna are not as well-protected. The smaller number of COVID-19 infections identified in people who are fully vaccinated have been mild illnesses.

For masks to work properly, they need to completely cover your nose and mouth and fit snugly against the sides of your face and around your nose. If you aren't fully vaccinated, your mask is one of the most powerful tools you have to protect yourself and other unvaccinated people. This is especially true when you are in an indoor or crowded outdoor space. If you are not fully vaccinated and work in a setting where you have sustained close contact with others who are not fully vaccinated or whose vaccination status is unknown, consider wearing a respirator for additional protection.

# Youth Donates 175 Books to Local Shelter

Krishan Parikh is an incoming junior at Whitney High School and a Life Scout in the Boy Scouts of America, Troop 72.

"I am an avid reader, and I like to keep up with local events, reading the newspaper to keep myself aware of the things happening in our community," stated Parikh, "for my Eagle Scout Project, I coordinated a recent book drive and I would think it would be a positive item to share!"

In order to become an Eagle Scout, a Life Scout must conduct a service project. Parikh chooses to collect gently used books and donate them to a local youth shelter. Through the help of his community, local ABC USD schools, neighbors and other scouts, he collected over 175 books and donated them to Jovenes Inc, a homeless shelter for youth located in Los Angeles.

"The organization was in the process of creating libraries in their locations, specifically at Mariposa Shelter, where I delivered many fiction and nonfiction books for the young women," remarked Parikh. He was able to provide cook books, engineering books, business and mathematics career type books. For the young men's shelter, he was able to collect and deliver comic books.

The entire project took him about a month, with the collection piling up in his garage, "It got crowded and dusty, but we were able to still clean and sanitize each book to minimize the risk of spreading CoVID."

After completing the project, he was inspired to help his community further, so he created a way to continue to collect gently used books for donations, "I

# Biden Admin.: \$50M for COVID Efforts in Underserved Communities in California

As part of the Biden-Harris Administration's ongoing efforts to respond to the COVID-19 pandemic, the U.S. Department of Health and Human Services (HHS) through the Health Resources and Services Administration (HRSA), awarded nearly \$50 million in American Rescue Plan funding to 30 HRSA Health Center Program look-alikes (LALs) in California to help mitigate the spread of COVID-19, particularly as the country faces new variants.

LALs are community-based health care providers that provide essential primary health care services to underserved

communities and vulnerable populations but do not otherwise receive HRSA Health Center Program funding.

This funding will also enhance health care services and infrastructure in California.

"The Biden Administration remains committed to ensuring our country's most vulnerable communities get the resources they need and can access the quality health care they deserve," said HHS Secretary Xavier Becerra. "Health Center Program look-alikes are key players in the Administration's efforts to address health inequities and support those disproportionately affected by COVID-19."

# CA. Approves \$35 Million for Guaranteed Income Program

California lawmakers this week approved the first state-funded guaranteed income plan in the U.S., which would give \$35 million for monthly cash payments to qualifying pregnant people and young adults who recently left foster care.

The votes -- 36-0 in the Senate and 64-0 in the Assembly -- showed bipartisan support for an idea that is gaining momentum across the country. California's plan is taxpayer-funded, and could spur other states to follow.

Local governments and organizations will apply for the money and run their programs. California lawmakers left it up to local officials to determine the size of the monthly payments, usually between \$500 and \$1,000.

A guaranteed program gives money to people with no rules on how to spend it.

The idea is to reduce the stresses of poverty that cause health problems & make it harder for people to find and keep work.

"It changes the philosophy from 'big brother government knows what's best for you,'" said state Sen. Dave Cortese, a Democrat from San Jose. "We've been very prescriptive with that population as a state and as counties go. Look at the failure. Half of them don't get their high school diplomas, let alone advance like other people their age."

Recently, guaranteed programs have been making a comeback, announced in New Orleans; Oakland, California; Tacoma, Washington; Gainesville, Florida; and Los Angeles -- the nation's second largest city which has a plan that will give \$1,000 per month to 2,000 needy families.

## Grants available to low-income residents

Using special federal and other housing funds, Lakewood administers a program that offers grants of up to \$3,000 and interest-free, deferred-payment loans of up to \$18,000 for low-income residents to repair and rehabilitate their homes.

To qualify, your home must be a single-family, owner-occupied dwelling in Lakewood. The family must meet the income limits set by the federal government, which are \$66,250 for a resident living alone, and \$94,600 for a household of four. # ESPN'S Stephen A. Smith's Racist Comments Should Get Him Fired

Has anyone reading this paper heard what Stephen A. Smith said this week about the Los Angeles Angels' Shohei Ohtani.

It’s a well-kept secret; the Los Angeles media barely covered Smith’s rant, the only print newspaper, besides HMG, to write anything was the Los Angeles Times, but they only put the story up online not in their print newspaper.

(If what Smith said was about a Dodger player, you could guarantee the L.A. Times would have published a full-color eight-page special section slamming Smith.)

In a segment on ESPN's morning talk show "First Take," Smith said this past Monday that Ohtani, the L.A. Angels sensation who has drawn comparisons to Babe Ruth, couldn't be the face of the sport because he uses an interpreter.

“I understand that baseball is an international sport itself in terms of participation, but when you talk about an audience gravitating to the tube or to the ballpark, to actually watch you, I don’t think it helps

that the number one face is a dude that needs an interpreter, so you can understand what the hell he’s saying in this country,” he said on the show.

After that, Smith then doubled down on his xenophobic rant and "clarified" his comments in a video Monday afternoon, saying that he was "talking about the marketability and the promotion of the sport" — drawing more ire on social media, including from his fellow colleagues.

"In the United States, when you're a superstar, if you could speak the English language, guess what, that's going to make it that much easier (and) less challenging to promote the sport," Smith said.

Some of baseball's brightest and most talented stars — Fernando Tatis Jr., Ronald Acuna Jr., Vladimir Guerrero Jr., — don't speak English as their first language, but that did not stop Smith.

Smith said that if Bryce Harper was doing what Ohtani is doing, "we might be talking about baseball five days a week."

and including the 4th of July, Bellflower Deputies and Community Service Officers wrote 111 illegal fireworks citations. Included were sales, possession and lighting. Residential property owners have been sent citations. The northwest portion of Bellflower was more active than usual this year.

During his comments at a council meeting, Councilman Sean Ashton suggested that it may be time for the city to move away from the controversial Independence Day tradition. Many churches and non-profit organizations often sell Safe & Sane fireworks during the week of the 4th of July as a means of fundraising. Unfortunately, the city has been plagued by a steady increase in the use of illegal fireworks. Ashton mentioned the city has previously tried to curb the trend with an uptick in patrols and increased fines, which can total anywhere up to \$3,000 depending on the number of violations. Downey Fire Department responded to nine fires, including one house fire.

Last week HMG noted that law enforcement officials in Lakewood reported a busy night on July 4, with 75 citations issued for illegal fireworks. The highest amount in years. "This year, Lakewood devoted even more resources and new efforts to combat illegal fireworks," City Manager Thaddeus McCormack said. "That included new street banners and public education on the dangers that illegal fireworks pose to veterans, pets and their neighbors. A team of sheriff's deputies and six civilian community safety officers responded to 187 calls from residents about illegal fireworks, with some incidents generating multiple calls. The city and sheriff's personnel will review this year's results, assess what steps worked best, analyze what other cities tried and determine if Lakewood should try anything new next year.

The City of La Mirada Public Safety Team, consisting of several deputies, Public Safety Officers and Code Enforcement Officers, proactively enforced fireworks regulations by canvassing the community. Between the hours of 5 p.m. and 11 p.m., 72 calls were dispatched for fireworks violations, compared to 54 calls received in 2020. This year, the Public Safety Team issued 32 administrative citations for fireworks violations.

Fireworks illuminated the sky across Southern California as the region celebrated the Fourth of July, with loud bangs ringing through the night sky. Although

fireworks are illegal in the city of Los Angeles, and many other municipalities, that didn't stop residents from putting on a show for their neighborhoods.

Although the vast array of fireworks made for stunning views, health officials issued a warning as the powerful blasts leave the air filled with a smoky haze. The South Coast Air Quality Management District said poor air quality is likely in areas throughout the South Coast Air Basin, as fireworks, both large, sanctioned shows and those of the personal "backyard" variety, are known to emit high levels of particulate matter and metal air pollutants, all of which can contribute to negative health effects.

seemingly erupted out of nowhere. "The people are dying of hunger!" one woman shouted during a protest highlighted by the Times, "Our children are dying of hunger!" Other chants included, "We want freedom."

"Never seen images from Havana," Alexandre Krauss, Senior Advisor EU Parliament, tweeted. "Thousands are mobilizing across Cuba demanding the end of the communist dictatorship while screaming 'we are not afraid... we are not afraid.'"

The Associated Press reported: Police initially trailed behind as protesters chanted, "Freedom, enough and unite." One motorcyclist pulled out a U.S. flag, but it was snatched from him

He then continued his rant insisting "that English isn't hard to learn (it is) and said that he hasn't watched a single Angels game all season." How can you be an analyst if you have not watched Ohtani play?

The racist commentator then left nothing on the table, "when Barry Bonds was smacking home runs, or Mark McGwire, I was transfixed on the tube."

I guess taking banned substances to hit home runs is OK with Stephen...as long as they speak English.

His apology, just like his racist personality was half-hearted; he didn't specifically apologize to Ohtani or the Asian community.

by others. ... Cuba is going through its worst economic crisis in decades, along with a resurgence of coronavirus cases. Rallies across the country were held (Times Square, Miami) and including one in Downey outside of Porto's Bakery to support the people of Cuba. Mayor Claudia Frometa added, "The people of Cuba have been under an oppressive communist regime for 62 years and the people took to the streets all across the island today, Sunday, July 11 to protest the oppression and demand their freedom."



# Fullerton Council Approves 59 Affordable Housing Units

A plot of vacant land at 1600 W. Commonwealth Ave. in between Euclid and Brookhurst in Fullerton, could become a 59-unit affordable three story housing complex that includes a mix of one, two, and three-bedroom of affordable low income apartments.

The project would provide homes for people making between 30% and 60% of the area median income, which is \$134,500.

The non-profit Pathways of Hope, is a co-developer and will serve as the coordinator for social services at the property.

The other is National CORE, a non-profit behind three other affordable housing projects currently in the works in Orange County.

At public comment, residents said they support bringing a low-cost housing project to the city, but wanted that homes

to remain affordable.

According to the staff report, 12 apartments are for people earning 30% of median, roughly \$40,000 annually; 12 for those at 40%, \$53,000; 19 units for residents at 50%, \$76,000; and 15 for people at 60% of the median income, \$79,000.

The lowest rent would be \$712 per month for a one bedroom; the most expensive three-bedroom apartments \$2,018.

The complex would feature a 2,400-square-foot community center, a pool, a playground and a outdoor seating with 91 parking spaces.

The vote to approve was 3-2 with Councilman Fred Jung and Mayor Pro Tem Nick Dunlap supporting a different proposal.

Mayor Bruce Whitaker and Councilmen Ahmad Zahra and Jesus Silva voted yes.

South Korean fried chicken chain Mom's Touch is the latest chicken company to start in greater Los Angeles, joining the ranks of notable places like Kyochon, Bonchon, and BBQ Chicken.

Mom's Touch quietly opened at the Gardena Plaza on the corner of Normandie Avenue and Redondo Beach Boulevard, and ownership already has plans for future spaces in Long Beach and in the City of Industry next year.

Fans will know Mom's Touch from its menu of fried chicken sandwiches, chicken fingers, and chicken wings. All of the chicken is marinated for 24-hours in a Cajun spice blend that includes red pepper, cayenne pepper, and paprika before being hand-battered and deep-fried.

The chain's signature chicken sandwich gives diners a choice of skin-on thigh meat or breast meat, and comes with lettuce,

onion, pickles, and sweet-savory "special" sauce on a brioche bun.

The special sauce can be swapped out for a garlic sauce or a Sichuan-inspired "fuego pepper" sauce.

The chicken wings come in a half-dozen different flavors including a few wild cards, like the "cheesy onion" and "apple zing," while the chicken fingers are served with a choice of sauce; barbecue, ranch, chipotle mayo, or a Louisiana-inspired one with cayenne pepper. **CHAMPIONS CUP****Artesia Punishers 14-U and 16-U Teams Struggle at Champions Cup**

IRVINE-The Artesia Punishers 14-Under travel softball team, coached by Andy Macias, and the 16-Under squad, coached by Leo Amaya, participated in the prestigious Champions Cup showcase tournament last weekend with both teams not faring too well. The 16's, with all games played at Harvard Park, went 0-4-1 in pool play action before falling to the [Encino] Victory USA 9-0 this past Sunday morning in the first game of the single elimination playoffs.

The scores of most of the six games may not reflect it, but the Punishers had some flashes of good play and in some situations, were on the verge of putting together some rallies and potentially coming away with a victory. Against the Victory USA, the Punishers loaded the bases in the bottom of the first and third innings by nearly identical situations before a strikeout and a pop-up respectively ended any scoring chances. Then there was the first game last Saturday against the [Hollister] Cal A's-Heen in which the Punishers had a 2-0 lead after the second inning, surrendered two runs in the top of the sixth inning to fall behind, then tied the game in the next inning. However, right fielder Madison Morgan (Valley Christian High) singled with two outs and on the next pitch, was thrown out at second on a controversial call.

"There were some good moments for sure," Amaya said. "I had Madison steal and the blue called her out. It was a judgement call; I understand that. Who knows? If she's safe and we get a base hit, she scores and we win. Today, we had the bases loaded twice and we couldn't pull through."

The 16-Under Punishers began the Champions Cup with an 8-2 loss to the [Rancho Penasquitos] So Cal Mavericks last Thursday, immediately followed by a 5-0 setback to the Corona Angels. In the first game, the Punishers grabbed a 1-0 lead in the top of the first inning, only to see the Mavericks tack on five runs in their half of the inning. The Punishers had just three hits, coming from Alicia Amaya (Bellflower High), Mikala Jacobsen (Cypress High) and right fielder Jessica Lopez (Los Osos High).

Against the Corona Angels, left fielder Jazmine Macias (La Mirada High) went two for three with a double and Amaya went one for three for the only hits the team would get. The Angels scored four runs in the top of the fourth inning, all with two outs.

The lone game played last Friday night was against the [Nampa] Team Idaho Dirdogs and the game was put away in the first few innings. Team Idaho scored three times in each of the first two innings and added one more in the third for a 7-4 victory.

The Punishers would collect four hits through the first three innings and strand four runners, none getting to third base. But in the fourth inning alone, they would get four hits and score all their runs. Macias singled to left on an 0-2 count, stole second and scored when Lopez reached on an error, who would move to second on another error. On the next pitch, pitcher Sara Pinedo (El Modena High) singled to right and one pitch later, catcher Autumn Herbig (Kennedy High) doubled

to the right field gap. The final run came when Morgan grounded out to bring in courtesy runner Kayden Lopez (Garces High).

"Our girls don't give up and I just told them we have to get in [the game] and get base hits," Leo Amaya said. "I'm not looking for home runs; I'm just looking for base hits. We talk about it all the time and that's what happened."

The best chance for a win in the tournament was against the Cal A's as

both pitchers were embattled in a seven-inning duel that saw both Pinedo and Mariah Sequera combine for 12 strikeouts, allow 13 hits and walk one. But it was how the game ended that had many associated with the Punishers wondering if they were robbed. With the Cal A's up 3-2 Kayden Lopez saw six pitches before doubling to the right field gap to lead off the bottom of the seventh. Left fielder Nathaly Ochoa (Bellflower High)

**TRIPLE CROWN SPORTS 16-UNDER WORLD SERIES****Consistency Missing From Artesia Punishers 16-U Gonzales Team in Pool Play Action**

ESCONDIDO-Days after the Artesia Punishers 16-Under travel softball team coached by Leo Amaya struggled at the Champions Cup in Irvine, the same happened for the program's other 16-Under team. The Vince Gonzales-coached squad was participating in the Triple Crown Sports World Series and went winless in all four pool play games at Kit Carson Park.

The team fell to the [Minden] Nevada Hotshots 7-3 and 12-3 to the [Victorville] E1 Prospects-Robinson this past Tuesday. However, the Punishers were off to hot start against the [Vista] Frost Elite-Engels this past Wednesday afternoon, building a 5-0 lead heading into the fifth inning. That's when the lack of consistency of finishing a game set in and the Frost Elite batted around, scoring six runs in the fifth on their way to an 8-5 victory.

"You never blame it on the umpire; the little strike zone seemed to adjust that last inning," said Gonzales said. "Not only that, I believe our pitcher simply ran out of gas and just couldn't finish the game. That's something that's not just her, but collectively as a team, we lack that killer instinct. We've lost several games recently; just that lack of experience of having that killer instinct and just learning how to finish a game. That's something that we've struggled with early in the summer."

Center fielder Destiny Avila (St. Anthony High) began the bottom of the first

inning with a first-pitch single to left field and after two consecutive strikeouts, third baseman Vanessa Carranza (Downey High) tripled down the right field line. She would come home on the next pitch as pitcher Celeste Quintanilla (Legacy High) was safe on an error.

Two innings later, Katia Wilkem walked Avila and with one out, surrendered a base hit to catcher Briana Zarate (Legacy High). Wilkem would then walk Carranza and with two outs, first baseman Ava Barela's (Warren High) single to left made it 4-0. The Punishers tacked on their final run in the fourth when right fielder Destiny Chavez (Port of Los Angeles High) singled to right, stole a pair of bases and came home on a Zarate single.

Meanwhile, Quintanilla seemed to be in control early on, throwing 35 pitches through the first four innings while striking out three, allowing three base hits and not allowing a runner to get to third. But in the fifth, the wheels came off and she gave up a single to Brooklyn Mills before walking three of the next four batters. Then with two outs and score 5-1, doubles by Chloe Filar and Peyton Justice put the Frost Elite in front 6-5 and signaled the end of the day for Quintanilla.

"They came out firing on all cylinders, and I expected them to do that because even in the previous games and last night's game, we were tied in one and winning 3-0 in the other," Gonzales

then sacrificed her over before a double from Jacobsen on the next pitch tied the contest. Morgan would follow that with a first-pitch base infield single. But on the next pitch thrown to Pinedo, Morgan took off for second and appeared to have beat the throw from Cal A's catcher Jessalyn Casillas. But five seconds after Morgan reached second, the field umpire called her out to end the game.

"That was a pitcher's battle for both [teams]," Leo Amaya said. "Both pitchers were really good. Strikeouts on both teams, pop-outs for both sides. It was just our girls couldn't hit."

"Her performance was really good," he later said of Amaya. "Every time I threw her in there, she pitched really good."

Following the game, the Punishers jumped out to a 3-0 lead before falling to the [Camas, WA] NW Rampage Silver 7-3. In the top of the second inning, Alicia Amaya singled to right and third baseman Anaiyah Yniguez (Bellflower High) was hit by a Katy Kutch pitch. After a pop-up for the first out, Kayden Lopez singled to right to plate Amaya before stealing second. Following a strikeout, Jacobsen reached on an infield single while bringing in a pair of runs.

The Punishers would get three more hits the remainder of the game and had the leadoff batter reach in the fourth and sixth innings, but to no avail. The Punishers stranded four runners in the game and had eight flyouts.

"They have to hit to win games," Leo Amaya said. "I know I keep on repeating myself every single time. But if you don't hit, you can't win. If you don't score, you can't win. They know they have to start practicing more on hitting instead of fielding as much."

This past Sunday, the Punishers were never in the game against the Victory USA in a 9-0 game. Down 1-0 after half an inning and with two outs, Herbig and Jessica Lopez both singled to the right field gap and Isabella Serrato walked Alicia Amaya to load the bases. However, a strikeout would end further damage. In the third inning, Jacobsen was robbed of a base hit when left fielder Kira Palmer made a remarkable diving catch. One out later, Herbig and Jessica Lopez each singled again and Amaya was walked to load the bases. It marked the third time in the tournament the Punishers loaded the bases. But a pop-up ended that chance.

In the final three games of the Champions Cup, the Punishers were shorthanded as half the team was competing in the Surf City Tourney's Summer Showcase in Fountain Valley 13 miles away. There, the Punishers would fall to the [Sacramento] Firecrackers-Leles/Neal 14-0, knock off the [Fresno] Central California Fury 13-5 and edge the [Salinas] MB Athletics-Abraham 7-5 in succession last Saturday. The next day, the Punishers fell to the [Chino] Southern California Athletics-Briggs 1-0 before knocking off the [San Diego] Power Surge-Strandberg 4-3.

"That was one of my mistakes as well, trying to get just the nine girls here and give [the other team] 12, which I should have kept 12 here and give nine over there," Leo Amaya said. "That is pretty difficult, but we tried our best to do it."

This was the 13th year that the 16-Under age group, which had 42 teams, has participated in the Champions Cup. The only other season that an Artesia Punishers 16-Under team played in the Champions Cup came in 2014 and lost its lone playoff game.

There wasn't as much game drama with the Artesia Punishers 14-Under team as they lost all four games played by a combined score of 33-9. This was the first time any Artesia Punishers 14-Under team had played in the Champions Cup and the

ninth year the tournament had had this age group.

"The results weren't what I wanted," Andy Macias said. "Most of the players, they normally make the plays when we play in friendlies and stuff. When it came down to the Champions Cup, nobody performed. There were a lot of errors and my key players were not hitting."

Last Friday, the Punishers, one of 24 teams from this age group, dropped a 9-4 decision to the [Los Alamitos] Team Freeman despite getting 10 hits and that was followed by a 5-2 setback to the [Fremont] Lady Wolf Pack. The Punishers would rally from a 2-0 deficit to score all their runs in the top of the fourth inning against Team Freeman. Lilly Gonzalez (San Pedro High) would go three for three and score a run while Alexis Phipps (Kennedy High) would go two for three and scored once.

Against the Wolf Pack, Gonzalez and Kaitlyn Macias (La Mirada High) had the lone hits as the Punishers fell behind 3-0 before scoring twice in the top of the fourth. Phipps also was walked three times and scored once while Gonzalez had the other run.

"That one, the girls were excited to be there and not only were my players hitting, most of them were hitting and running the bases properly," Andy Macias said of the first game. "To me, I think our best game was the second game against the Lady Wolfpack because we were competing with them for a while. We were doing pretty well, then they caught up."

The final game of pool play action was last Saturday afternoon against the [Whittier] Explosion Berouty/Roman and this one was a runaway early in a 9-0 decision. The Explosion scored twice in the bottom of the second, four more the next inning, once in the third and twice in the fourth in their 10-hit attack. Carissa Galvan was throwing a no-hitter until pitcher Elisabeth Truchin (Torrance High) led off the top of the fifth with a single to left, stole second and moved to third on another base hit. The Punishers had four base runners in the game but was hampered in the beginning with their starting second baseman, starting shortstop and starting pitcher beginning on the bench due to a violation of team rules.

"That brings the team down because the players I had staying on the field were a little disappointed because those key players put a lot of pressure on the other players," Andy Macias said. "I know it brought the coaches down as well when we were getting ready for the game because we're trying to figure out what we're going to do when were [putting the lineup together] and we don't have our key players there."

In the single elimination playoffs later in the day, the Punishers lost to the [Yorba Linda] Monarchs 07 10-3.

said. "I know we can score. But it's just a matter of playing consistent defense behind our pitcher and learning how to finish a game."

Avila and Zarate each went two for three in the game while three other players accounted for the other three hits the team would collect. In fact, after Zarate's second hit, Jessica Nelson retired the next six batters before Avila laced a two-out single to center.

"Obviously, you have to crawl before you can walk and I'm willing to take some bumps and bruises with her," Gonzales said of Quintanilla. "And that's when we're going to learn how to battle through any type of adversity, is having to face it. I wanted to give her that opportunity."

Following the game, the Punishers

saw the [Ripon] Top 9 Sports race to a 6-0 lead in the bottom of the first by sending 11 to the plate and eased to a 9-4 victory, pushing the Punishers to a fifth place finish in their pool.

The Punishers tried to make it a game in the top of the second when shortstop Karissa Avila (Downey High) reached on an error and catcher Rose Guerrero (Cerritos High) singled to left. Two outs later, a walk to Chavez loaded the bases before another error allowed pitcher Isabella Lara (Buena Park High) to be safe at first and clear the bases. The fourth run came in the fourth when Guerrero smacked a solo home run over the left field fence. The Punishers were held to five hits in the game.

The Punishers would face the Hawthorne Firecrackers on July 15 at the Lakeside Complex in the first of the double elimination playoff games. The Firecrackers were outscored 34-7 in their four pool play games. The Punishers would need to win as few as three games to advance to the Bronze Championship game, which is slated for Saturday morning at the Poway Sportsplex.

The final tournament of the summer for the Punishers will be the C4 Nationals from Aug. 1-8 at the Big League Field of Dreams in Chino Hills. That tournament is a five-game guarantee and over two dozen college coaches are expected to be in attendance.

"We kind of know what our strengths are; we know we can hit," Gonzales said. "We know we can put up runs, obviously. We just need to continue to build both our pitcher's confidence and continue to play solid defense. Just like the old cliché is defense wins championships, obviously if we keep that clean, we can definitely compete with the best teams out there in the nation. That's going to be our goal."

**Burlington Moves In**

The 100,000 square-foot eyesore at 9200 Whittier in Pico Rivera is going to be looking good in a few months. After the Home Depot closed in 2018, the lot sat unused and ugly, but no more.

Burlington Coat Factory, which sells all kinds of jackets, but also other items much like a Ross Store, is moving in.

"This is great news," City Manager Steve Carmona told HMG-CN. "Our home depot has been vacant for years, and we lost a significant amount of sales tax due to Home Depot relocating. Our Council and staff have been very active in attempts to secure national tenants at this site. Burlington and Chase Bank have now been confirmed, and others will be announced shortly. In addition to more tenants, the Center will get a much-needed facelift. One more exciting development is the owner (TRF) is funding a consultant to study the creation of a Business Improvement District for Whittier Blvd. If it is determined to be viable, you will see an even more dramatic change along this corridor. The City Council has placed this corridor as one of its priorities in its Corridor Revitalization program."

Marco Zapien, Pico Rivera Chamber of Commerce President, said the new store will be a great anchor, "The lot is on Whittier Blvd., it's a huge space," he said, "now it's going to have a large retailer, good for the city."

brick, lined with mortar, Cordoba leaves something to show for its work, they are a nationally recognized infrastructure firm much like Telacu.

In November 2004, the first wave in the set hit Bassett; residents of Bassett Unified voted to authorize the issuance of \$23 million in public school bonds.

The Megataxers had a big hand in the passage of the measure.

Principle and interest of Current Interest Bonds (CIB) are paid quarterly or semi-annually over the term of the bond, can be refinanced after 10 years, cost is usually 2:1, term is usually 10 to 25 years, and repayment begins the first year.

A Term bond (Term) refers to a bond that matures on a single, specific date in the future. At the time, the bond's face value, the principal amount, must be repaid.

On the other hand, principle and compounded interest are paid at maturity with Capital Appreciation Bonds (CAB). They are the worst of the worst: they cannot be refinanced, the term of the bond can be as long as 40 years, and repayment is deferred for several years. The cost ratio varies from 4:1 up to as much as 16:1; a \$1 million dollar bond cost taxpayers up to \$4 million at maturity

In 2004, Bassett sold nearly \$12 million in CIB's maturing between 2006 and 2027 and \$773,000 in CAB's due between 2016 and 2018. For the \$773,000, Bassett paid \$1.5 million just in costs; the accreted value to taxpayers will be close to \$2.5 million.

Paul Solano was president of the Board of Education at the time.

Cordoba became the service firm for Bassett, supervising the improvement of existing facilities that included exterior plumbing and restrooms, commercial

doors and related hardware, and fire alarm systems at multiple locations. The firm employs experts in federal, state, and local infrastructure, with unfathomable and unimaginable experience in construction management. Just ask Leon Panetta.

In July of 2006, the Board sold \$6 million in Term and CIB's due between 2009 and 2030; a \$614,000 CAB was sold, the accreted value to taxpayers would be over \$2.1 million, four times the price.

Another CAB, due between 2032 and 2043, valued at \$4.21 million, was sold, which will stick taxpayers with an accreted value of \$25.6 million, over five times the price.

Paul Solano was still President of the Board of Education, while James Ballard was Assistant Superintendent of Business Services.

On November 7, 2006, the Megataxers worked their network and convinced residents to authorize the Board to issue another \$20 million in bonds; the total was now \$43 million.

In July of 2007, the Board sold Term and CIB's totaling nearly \$19.4 million due between 2008 and 2027. Another \$1.2 million in CAB's was sold and due between 2032.

Cost to the taxpayers would be over \$5.7 million for the CAB's.

The authorization came on the heels of a Bassett Unified study projecting declining enrollment, losing nearly 1,000 students over a decade.

In 2008, the Board sold \$1.5 million in CIB's along with another \$3.53 million in CAB's with maturity dates between 2025 and 2037; cost to the taxpayers will be \$11.51 million.

All told, the Megataxers had hit tiny Bassett with nearly \$47 million in bonds from 2006 to 2008, creating long-term debt over decades along with selling with CAB's totaling \$10.2 million, costing

taxpayers \$30 million.

In mid-2014, the Board, relying on the advice of Lalo Trujillo of Mission Trails Advisors, LLC and the Director of Finance at the city of Pico Rivera, proceeded to refinance the outstanding debt.

He restructured Bassett's debt by issuing Series A Refunding Bonds for \$8,690,000 and Series B for \$6,415,000 with significantly reduced interest rates.

Paul Solana was again President of the Board.

By the time of the Unity Conference in San Diego, California in October of 2014, things were looking very promising.

**New Round of Debt**

On November 4, 2014, the Megataxers once again convinced residents of Bassett to authorize \$30 million in bonds.

Within a few months, the Board sold another \$10 million in CIB's due between 2016 and 2044.

Undeterred, three years later, the Board issued \$20.1 million in CIB's due between 2018 and 2046.

Bassett had officially become a casualty of the Megataxers; a very high debt burden with experts saying they are borrowing to continue to make debt payments rather than building or repairing their aging infrastructure.

Then Bassett's enrollment tanked.

According to the California Department of Education, the average daily attendance at Bassett is now less than 3,500, down from 6,000 in 2004.

The amount the state pays for each student currently stands at \$12,498, meaning Bassett has lost over \$31 million in revenue.

In November 2019, the Bassett Board approved Resolution 06-20 for another tax measure scheduled for the primary election on March 3, 2020; the Board subsequently changed it to November 2020.

The minutes of the meeting reflected the motion passed but did not mention the change of election date to November 3, 2020.

Immediately after the March 3, 2020 primary, Governor Gavin Newsom declared a state of emergency and started to place California on lockdown. Nonetheless, nearly sixty school districts in thirty counties started to prepare bond resolutions.

In L.A. County, Bassett was the first in line. Dolores Rivera told the County Registrar-Recorder that she sent "an original, adopted Resolution" for the November 3, 2020 election when the minutes do not reflect that.

She also sent a Tax Rate Statement showing the true cost of the next bond to be \$96 million.

Coincidentally the entire amount of debt sold since 2005 was \$94.5 million.

Bassett had called the experts to solve their debt problem; they had called the Megataxers.

in the rapid removal of the language about barring students without masks from campus.

"I clarified the local responsibility, which is consistent with all the prior rules in effect since last year," the governor said. "As it relates to enforcement, it's always been the local responsibility."

The governor's underlying goal is to get all students back on campus for full-time, in-person instruction.

School administrators must now contemplate how to keep students and staff in line, even though L.A. County might mandate masks, especially since vaccinated people no longer have to wear masks in many other situations.

Adding to concerns are increasing coronavirus infections from the Delta variant — and the fact that students younger than 12 are ineligible for vaccines, and not all older students are getting shots.

So now, education leaders faced a more nuanced situation, where they would have to explain their local policy on enforcing masking to constituents.

Dr. Mary Sieu, Superintendent of ABCUSD, told HMG-CN, "The health and safety of our students is our first priority, we don't yet know what the COVID-19 safety protocols from the L.A. County Department of Health will look like for our schools, but it's likely our students and staff will have to continue wearing masks when indoors when they return to school this fall."

Proposition A through the Los Angeles County Metropolitan Transportation Authority. A contribution was also given from the Artesia General Fund of over \$100,000.

"The project could not have been possible without the dedication of City Council, City Manager and City staff.
