## LCCN Exposé Spurs FPPC Complaint Against Central Basin's Michael Gaultieri

On February 6, 2024 Los Cerritos Community News published an OP/ED outlining how the new majority consisting of Central Basin Municipal Water Board Members President Michael Gaultieri, VP Juan Garza, and Directors Leticia Vasquez-Wilson and Martha Camacho Rodriguez removed Art Chacon as president and removed him from crucial MWD seats, comparing the moves to the 2013-2016 CB Board years that ended up triggering a California State audit.

It took only a short time for the new CB Board to prove LCCN right.

HUNTINGTON BEACH-In 1987, Hoosiers, a movie about a small-town Indiana basketball team that defied all odds to win the state championship, was released. While the 2023-2024 Cerritos High boys basketball team has 19 members, and the state playoffs begin on Tuesday, it felt like a Hollywood-script ending for the Dons last Saturday night.

Playing for senior Ethan Soriano, who passed away shortly before the regular season began a little over three months ago, Cerritos carved its way through the 605 League, then won all five games in the CIF-Southern Section Division 4AA playoffs, including a come from behind 60-51 win over Yeshiva University of Los Angeles (YULA) in front of a standing

room only scene at Edison High. It is the first divisional championship for the Cerritos boys basketball program after the program had never been to the semifinals before Mar. 16.

To make this win even more special is the fact that the Dons improved to 22-10 and Soriano's uniform number is 22.

The team will now take a trip down Interstate 5 to face University City High on Tuesday in the first round of the CIF Division III Southern California Regionals.

The Centurions, seeded seventh for the regionals, defeated Rancho Buena Vista High 72-57 in the CIF-San Diego Section Division II title game. U.C., which is on a seven-game winning streak, is 24-8.

Her freshman season at Artesia High is still not over but it's safe to say that defender/midfielder Briana Remigio just took her biggest shot of her young soccer career, and the biggest shot in school history.

With just under five minutes left in the second overtime period against Maranatha High in last Friday night's CIF-Southern Section Division 7 championship game, Remigio booted a penalty kick through the right side of the net for the only tally in a 1-0 win.

It's the first girls soccer CIF championship in school history and comes two years after the program won just five games. The Pioneers will now host Bernstein High on Tuesday in the first round of the CIF Southern California Division

V Regionals with a potential semifinal game on Thursday against either Bell Gardens High or Mar Vista High, leading up to the finals on Saturday. Bernstein defeated Stern High 5-1 last Friday in the CIF-Los Angeles City Section Division IV championship game.

"I'm very happy that we made it very far and I'm just super excited that I won this for everyone," said Remigio. "Not only for myself, but for my whole team, my family and for my friends who are always here to support me."

"This is a lot of years of hard work and a lot of struggles," said Artesia head coach Hugo Umana. "But you know, trust the process. Trust the process."

"I feel that we've always played the best soccer in our league, and we've always played the right way," he later

## GOP Supreme Court's Protection of Trump is Both Partisan Election Interference and How Democracies Die

The anger filled my body as I read the news on Wednesday that the GOP controlled Supreme Court—of which three justices were personally appointed by Donald Trump—had made it just about impossible for Trump's criminal trial for his attempted coup to take place before Election Day.

This is what election interference looks like. Alarmingly, it also potentially helps usher in the end of our democracy.

Assuming we still have elections in the future, Democratic presidential candidates going forward must pledge to expand the SCOTUS to end the GOP's judicial tyranny that has stripped women of fundamental rights, weakened voting rights, struck down laws to save lives from gun violence

and now protected the 2024 GOP presidential frontrunner from being held accountable for his crimes before the election.

Delaying Trump's Jan 6 case to help him win the 2024 election was clearly the plan of the GOP Justices all along. How can I say that? Simple, after the December 1 ruling by federal Judge Tanya Chutkan that Trump did not have immunity to commit crimes to overturn the 2020 election, Trump's lawyers appealed to the US Court of Appeals which automatically stayed the criminal case.

In response, Special Counsel Jack Smith swiftly filed an application with the SCOTUS on December 11 asking them to take the case directly since he understood that a case of this magnitude would ultimately be decided by the nation's top court. Smith argued in his petition to the

Supreme Court that the speedy resolution of Trump's claim of presidential immunity is of urgent national interest and a decision was needed "promptly" to ensure the Jan 6 trial could occur.

In response, Trump argued for a delay, with his campaign stating, "There is absolutely no reason to rush this sham to trial except to injure President Trump and tens of millions of his supporters." His lawyers made a similar argument in their opposition to Smith's application.

What happened? The GOP SCOTUS did exactly what Trump asked and refused to expedite the case. The result was the US Court of Appeals heard the case and rendered a decision on February 6, rejecting Trump's claim of immunity to commit all the crimes he wanted while in office.

Trump's team of course appealed seeking to extend the delay of Trump's Jan 6 case so that the American public would be deprived of hearing the facts in federal court of Trump's crimes. And most importantly, prevent Trump from being convicted of felonies for his attempted coup before November's election.

Despite the obvious urgency of this case given the man who attempted a coup was the likely 2024 GOP presidential nominee, the GOP justices delayed for nearly three weeks a decision on whether to grant Trump's request to hear the case and further delay this case.

That brings us to the Supreme Court's decision on Wednesday to hear the case. In announcing they would take the appeal, the GOP Supreme Court claimed they are "expediting" the case. They aren't. Oral argument is scheduled for two months from now during the week of April 22. There is no reason for this delay given the issue of Trump's immunity has been briefed and argued by his lawyers in both the district court and US Court of Appeals.

In fact, the court's claim this is "expedited" is undermined by how they recently handled the appeal of the Colorado Supreme Court decision that disqualified Trump from holding office for engaging in an insurrection in violation of Section 3 of the 14th Amendment. In that case, the court agreed to take the appeal on January 5. Was that hearing two months later? Nope, it was about 30 days later on February 8.

Based on the oral argument in that case, it's clear the GOP Court will protect Trump and rule he's not disqualified from holding office.

If you want an even better example of how quickly GOP Justices will move when they sense a chance to help Republicans gain power, then check out the infamous Bush v. Gore decision. On December 8, 2000, the Florida Supreme Court ordered the immediate manual recounts of under-votes for the office of president in all counties where such recounts had not already taken place. The Bush campaign then im-

mediately petitioned the GOP controlled U.S. Supreme Court for a stay of the recount order—which was granted the very next day.

Just two days later on December 11, the US Supreme Court heard oral arguments. And only one day later on December 12, the five Republican Justices joined forces to effectively award Florida's 25 electoral votes to George W. Bush, thus, naming him the winner. Al Gore officially conceded the following day. That entire appeal process took less than a week.

Interestingly, in Bush v. Gore, three of the current GOP justices worked as lawyers on Team Bush: Chief Justice John Roberts together with Justices Amy Coney Barrett and Brett Kavanaugh. That means these three know first-hand how quickly the Supreme Court can move.

When it comes to Trump's appeal, don't rule out that this 6 to 3 GOP court will find Trump is immune from prosecution in this case, although in a narrowly worded decision so that he can't actually send Seal Team Six over to shoot them or anyone else. But even if they end up affirming the lower court's ruling that Trump can be prosecuted, he will have at least three months from the decision that will likely be rendered in May or June to prepare his defense in the Jan 6 case—which takes us to the fall. Will a criminal trial of the GOP presidential nominee actually take place in September just two months before the election? Possible, but unlikely.

That's exactly what the GOP Justices want. They—like Trump—see the recent polls that show Trump will lose badly if he's convicted of felonies before election day. For example, a late December NY Times poll of key swing-states showed Trump going from a four-point lead on Biden to a 10-point deficit if he's convicted. That's a huge 14-point swing.

That's why this is partisan election interference. The three Trump Justices along with "Justice for rent" Clarence Thomas and the reactionary Samuel Alito have deprived voters of seeing Trump tried before the 2024 election for his attempted coup. And by doing so, they have brought our democratic Republic closer to ending by enabling a fascist, wanna be dictator to win in 2024. (In reality, the three Justices Trump appointed and Clarence Thomas—given his ties to the Jan 6 coup via his wife Ginni—should recuse themselves given the obvious conflict of interest!)

You should be angry—very angry. But now we must channel our anger into defeating Trump. As I've repeatedly said, we can't count on the courts, Jack Smith or anyone else to save our nation from Trump. It's up to us. And come November 5, 2024, we will do just that!

## Hahn Extends Pool Season, Knabe Park Pool Will Get New Lights

Los Angeles County Supervisor Janice Hahn announced this week that the public pool at Don Knabe Regional Park in Cerritos will be getting extensive lighting installed in coming weeks. This is part of Supervisor Hahn's work to extend the pool season through the end of October.


"We all know that the warm weather doesn't end in August and our pool season shouldn't either," said Supervisor Hahn. "I am keeping our County pools, including the pool at Knabe Park, open through October and we are installing new lighting so people can swim in the evenings."

The Don Knabe Community Regional Park Pool Lighting Remodel Project will include installation of underwa-

ter lighting, upgrade of existing deck lighting, security lighting and emergency lighting. Construction will start March 4th and will be completed before the pool opens in May.

The LA County Department of Parks and Recreation manages 30 pools countywide with 25 of them previously open just ten weeks out of the year under the standard pool season which ran from June 15 to August 21st.

After speaking to constituents who were disappointed pools closed so early, Hahn pushed to extend the ten-week pool season to a six-month pool season. This year, County pools will be open from May through the end of October and the Department of Parks and Recreation has hired and trained additional lifeguards to keep the pools staffed.

## Los Angeles County Program to Help Buyers Purchase Their First Home

Qualified borrowers will receive down payment and/or closing cost assistance through the new loan program.

The Los Angeles County Development Authority (LACDA) announced its new Home Ownership Program, HOP120.

The loans will assist moderate-income homebuyers earning 120% of the Area Median Income for Los Angeles County in the purchase of their first home.

HOP120 provides a second mortgage loan for first-time homebuyers with assistance up to \$85,000, or 20% of the purchase price, whichever is less.

The loan provides down payment and/or closing cost assistance and is secured with a Deed of Trust and Promissory Note.

The loans are 0% interest loans with deferred payment. Repayment is required when the home is sold, there is a transfer of title, or the home is no longer owner-occupied.

Eligible properties must be in unincorporated Los Angeles County or participating cities.

Eligible properties include single-family homes, townhomes, and condominiums with a maximum purchase price of \$850,000.

The LACDA started accepting HOP120 applications on February 26, 2024.

To apply for the Program, applicants must use an LACDA-approved participating lender who will submit the application on their behalf.

Interested homebuyers are encouraged to visit [www.lacda.org](http://www.lacda.org), and click on Home Ownership at the top of the page for additional details such as the lists of participating cities and lenders.

"HOP120 expands homeownership opportunities to families who are positioned to purchase a home but held back by the upfront costs such as down payments and closing costs. The LACDA aims to remove some of those barriers and help Los Angeles County residents invest in their future and plant roots for their family," said LACDA Executive Director, Emilio Salas.

The upgrades will give residents and staff more access to online permitting and licensing and faster response times for service requests.



### Reset your clocks on March 10

Daylight saving time begins on Sunday, March 10. Set your clocks forward one hour and replace smoke alarm batteries. Check the units to ensure they are functioning properly.

A typical smoke alarm has a lifespan of approximately 10 years. A properly functioning smoke alarm can greatly reduce the risks of death and/or injuries in the event of a fire.

### Program fights fraud, notifies homeowners

In an effort to ensure accuracy and protect property owners from real estate fraud, the Los Angeles County Department of Consumer and Business Affairs offers an Enhanced Homeowner Notification Program, which notifies residential property owners throughout Los Angeles County when documents are recorded against their property.

Under the program, owners are alerted within five to 30 business days after certain documents are recorded on their property, including those that

pertain to an ownership change, show loans taken against the home, or a Notice of Default or Notice of Sale.

Document copies are sent to homeowners to review for accuracy and legitimacy, giving owners the opportunity to take adequate steps to deal with an impending foreclosure or real estate fraud.

The service emails owners within two days of a document's recording and follows up with a hard copy of the document in the mail.

### Library Study Room names updated with community input

The Cerritos Library Study Rooms now feature the names of three women celebrated for their contributions to medicine, math and science, including Marie Curie, Katherine Johnson and Chien-Shiung Wu.

Local community members suggested renaming three of the Study Rooms for women as they were all previously named for men.

The Cerritos City Council approved a project to seek input regarding renaming the rooms or retaining the men's names.

Based on the results of online community voting surveys, the Study Rooms now display the names of Nikola Tesla and Jules Verne in addition to Curie, Johnson and Wu. The adjacent Access Plus Room retains George Orwell's name.

The library's Study Rooms can be reserved for studying by small groups of students in junior high school and above. The rooms can be reserved in person with a valid Cerritos Library Card at the library's Reservation Desk up to one week in advance and for up to two hours.

### Recreation Services seeking volunteers

### Cerritos Library announces free seeds program

Beginning in April, Cerritos Library patrons ages 13 and older will be able to pick up free seeds from a new Seed Library.

The Seed Library offers seeds for native California plants such as wildflowers, sunflowers and a pollinator mix of flowers, along with a variety of vegetable, fruit and herb seeds.

Patrons may select up to four seed packets per month. Seeds and packets do not need to be returned to the library.

The project is supported in whole or in part by the U.S. Institute of Museum and Library Services under the provisions of the Library Services and Technology Act, administered by the California State Librarian.

The Seed Library will be located on the first floor of the library, near the Circulation Desk.

### Free document shredding offered on March 23

The City of Cerritos is offering a paper shredding event from 8 a.m. to noon on Saturday, March 23. The event will be held in the parking lot of the Cerritos Senior Center located at 12340 South Street.

This is a secure way to dispose of paperwork that contains private information.

In addition to the shredding event, each participating resident will have the option to obtain free fresh compost. Residents must bring their own rigid container, no larger than 35 gallons, to

hold the compost.



said. "Again, it's trusting the process and continuing despite maybe having some bumps in the road, but we still persevered. The system worked and we continued to this day and it's what we have right now."

Artesia (19-3-3), which had dominated the scoring chances throughout much of the contest, took one shot on goal in the first overtime session, which was a free kick from the 19-yard line by freshman forward/midfielder Kamila Salazar after Ella Klop was issued a yellow card. Still scoreless after 90 minutes, the teams switched sides and the Pioneers took two more shots, which were saved by Mia Madarang.

But with 4:49 left before the game would be decided by penalty kicks, sophomore forward/midfielder Yuliana Ortiz was pushed from behind in the penalty box and Umana summoned Remigio to take the penalty kick.

"I was just very, very nervous," said Remigio. "My chest had this very heavy feeling in it. Coach wanted me to take it and I knew that I could not fail him. I always practice [shooting towards] the right, so why change it up?"

The Pioneers, ranked 10th in the division, controlled the first 30 minutes of the contest, both in field possession and shots taken. The second place team from the 605 League peppered Madarang for half a dozen shots, four of which she saved. Meanwhile, the Minuteman, ranked fourth in the division, didn't take their first, and only shot of the half, until the 31st minute. That would come off one of two corner kicks they would take.

Artesia continued to attack the Maranatha defense in the second half and took four more shots while the Pasadena visitors finally began to get into more of

an offensive mode. In the 60th minute, Klop took a shot from the left side that clanked off the far post. That would be the best chance the Olympic League's third place team would get in the game. The next best chance came with six minutes remaining in regulation when Maddie Knott's long range shot from the right side barely missed the upper left corner of the net. Knott would account for four of the team's five shots taken.

"It's kind of the story of our season where we dominate, dominate, dominate, but sometimes we struggle to put [opponents] away," said Umana. "That was the case in this game. But, if you look at the statistics, each game that we scored in,

we've won. So, statistically speaking if we score, we win."

After no fouls were called against either team in the first half, Maranatha was called for its first of 11 fouls in the 45th minute while the Pioneers first infraction, which was a hand ball, was called five minutes later. They would be whistled seven times in the second half, the first four coming in a 10-minute span.

"I think the refs did a great job; they're the best refs we've had all season," said Umana. "I think the difference on their end was they were tired. I think we were prepared, and it started from the summer running cross country with the

team itself. So, we were fit. Our strength and conditioning group prepared us for this as well."

The Artesia girls soccer program began in the 1996-1997 season and the next season, it went 11-9-0 but finished in fourth place in the former Suburban League. At that time, only the top three advanced to the playoffs. The Pioneers finally made their playoff debut during the 2008-2009 season and finished 10-10-2. After that, the program went through seven straight winning seasons, advancing to the playoffs each time, including a quarterfinal appearance in the 2012-2013 season.

However, the program went the opposite direction after former head coach Octavio Marquez stepped down to take over the boys soccer program following the 2015-2016 season. Artesia would go through four losing seasons and missed the playoffs four times since then. This season, the Pioneers posted 17 shutouts, four by 1-0 scores and all three losses were by a combined 10-0 score with all three ties ending scoreless. Two of the three losses came to league champion Cerritos High.

"Last year we missed the playoffs, and we actually had a decent team last year," said Umana. "But things didn't happen the way [we wanted]. But I really feel things happen for a reason because we have a new, revamped group this year. We have eight freshmen and six sophomores, four juniors and one senior."

"Since the very beginning, even coach [Umana] said that he knew there was something special with this team," said Remigio. "I have a lot of trust in him, and I felt like he was right. Also, I want to thank all the staff that pushed us and helped us and also our families who are always supporting us."

longtime Cerritos head coach Jonathan Watanabe. "We're not here without him, and Sori is here with us. This is our 22nd win of the season. There's no question... [we've won] 15 in a row; he was born on June 15. There are so many signs to tell us that he is here with us. This group deserves this. We've been through so much adversity...it's nice to have this fairytale ending, but we're still not done. We have state playoffs, but we will enjoy this one."

"But this one, as I said last week, is not just for our current players," he continued. "This is for all our coaches, all our players, all our families who have helped to build all this. And most of them are here tonight. I talked to [former Cerritos head] coach [Ian] Desborough yesterday. So he knows exactly where we are. I'll have some good news to tell him tomorrow when he wakes up. This is not just a one-year thing or not even just a two-year thing. This is a 53-year project that we've been working on to get here."

The Dons, ranked third in the division, were facing a squad that was ranked 13th in the division and had upset top-ranked Price High 47-44 in the semifinals. YULA, a school not known as much in the southern part of Los Angeles County or Orange County, was founded in 1979.

Cerritos led once in the first half, and it came 20 seconds into the contest compliments from senior Tobenna Ozoagu with the assist coming from senior Luke Rigor. Other than the game being tied at 17-17 after junior Jaden Ribac hit a three-pointer, it would be a one or two possession game until Judah Robin's basket with 1:49 left in the half made it 26-20. The Dons would trail 29-23 at the

half, but felt they were in a good spot, considering they have seen this script before.

"Oh, they're good," said Watanabe. "They got here for a reason. They play good offense; their defense is exceptional. They're probably the best defensive team we've played all year. So, we had a lot to handle, but we were able to fight through it."

"We didn't know YULA before this," said Ozoagu. "But hey, they're a hell of a team. They're in the finals for a reason. I have to give all props to them."

The halftime statistics weren't looking dandy for Cerritos as it shot 25 percent from the field and had a dozen rebounds while the Panthers were 13 of 27 from the field and had grabbed 21 boards. The Cerritos starters combined to go four of 21 from the field.

"Obviously it's frustrating when my shots aren't going in when I'm getting to my spots," said Ozoagu. "But it goes back to a team effort. [Senior] Shay [Pema] turned it up in the third quarter and we just chipped away. We just played together and that's what we do as a team. It's not a one-man team; not like these other team. We're a whole team."

YULA increased its lead to a game-high eight points with nearly five minutes gone in the third quarter before the Cerritos defense took control of the game. Over the final 2:15 of the stanza, the Dons went on a 10-0 run as Pema scored the first 9 points, including a pair of three-pointers. The Panthers would attempt just three shots during this time as Cerritos led 37-35 heading into the fourth quarter.

"We've been doing it all year," said Watanabe. "We've been playing playoff basketball since two years ago, game one. I told these guys we have to play

this [way] so when we get to the playoffs, it's the exact same thing. So we're just out here playing ball. I think we've been down in almost every one of these games, and in then in the third quarter, we're able to make some adjustments and then grind it out."

YULA would score the first four points of the fourth quarter before the Dons responded with three free throws to take a 40-39 lead with 5:53 remaining. Alex Gabbay would then make one of two free throws 12 seconds later before the Dons went on a 13-2 run to put the game out of reach. Ozoagu would score six of those 13 points. The final five points of the run came from Pema, first a steal and basket, then he took a pass from Ozoagu and scored, was fouled and hit the subsequent free throw.

The Panthers tried to get back in the game but could only get five free throws in nearly a minute and a half to trail 53-47 with 1:33 left to play. But a three-pointer from junior Benson Cho 11 seconds later sealed the deal. In the second half, Cerritos was nine of 21 from the field while YULA was seven of 21 and while the Panthers were three of 13 from beyond the arc, the Dons connected on eight long range shots in 23 attempts.

"It goes back to what Coach Wat says, play possession by possession," said Ozoagu. "As soon as the jitters went away, we played our game and played defense."

Gabbay led the Panthers with 15 points while Yishai Rosenblatt added 11 points and eight rebounds. Jaden Azeroual led his team with 10 rebounds. For the Dons, Pema had 17 points, five rebounds and two steals, Ozoagu had 16 points and five assists and Cho pitched in with 14 points and half a dozen boards.

"We have a lot of guys," said Watanabe. "We have all our pieces that fit well

together. The thing about our team is that we're so unselfish. All our guys feed off each other, so Toby will drive it, kick it out to Shay and Shay will knock down the shots. You have [senior] Osi [Agaranna] scoring inside, Benson slashes to the bucket, Luke can rebound and knock down shots. It is a whole team effort and I think that's probably the reason why we're here."

"This is what we play for," said Ozoagu. "This is what I do all that for. This is what we spend hours in the gym for; hours in the weightroom, for this championship right here. This cements us in history. Like I said before, it's all for Sori. I just feel great. To see the love and the amount of people here...there's no better feeling."

The Edison gymnasium was nearly packed for the Cerritos girls game against Oak Park High for the Division 3AA championship prior to the boys. Cerritos occupied just about four sections of the bleachers and when the girls game concluded, the YULA fan base, which was big for a school of nearly 500 students, packed the other two sections, more than Oak Park did, and were singing, chanting and waving the Israeli flag at times.

"It was unbelievable," said Watanabe. "The fan support was awesome. It was awesome for the semifinal game, and I didn't expect anything different [tonight]. It sold out on the second day. Our parents were calling me going, 'coach, the game is sold out and I didn't get my tickets yet'. Luckily, they were able to open up more seats. I don't know how many people were here, but it felt like the whole school was here, plus all our alumni and coaches. It was a great environment to play in."

**CIF-SOUTHERN SECTION DIVISION 3AA GIRLS BASKETBALL CHAMPIONSHIP****Cerritos' Planned Blackout Turns Into a White-Out For Oak Park**

HUNTINGTON BEACH-All week long at Cerritos High, the school was promoting its students, faculty and others to pack Edison High, the site of the two CIF-Southern Section basketball championship games involving the Dons. The school was also asking everyone to wear black for both the girls and boys games.

That was the easy part and was accomplished to the point that by the time the boys game started, it was standing room only. Unfortunately for the Cerritos girls, Delaney White of Oak Park High ruined the party as she scored 25 points, grabbed 12 rebounds, had six assists and three steals in helping her team to a 71-41 win over Cerritos in the Division 3AA title game last Saturday night.

"I think it was a hard fought game," said Cerritos head coach Marcus Chinen. "We had a few mistakes in the very beginning; we hung with them for a little bit. Going through the first half, we were right there. I think if we would have made a couple more shots and [made] a few stops, I think the game would have been a little different."

Oak Park, the defending Division 5A champions, also claimed a CIF title in 2001 and were finalists in 2012 and 2019 while the Dons fell to La Salle High 45-33 two seasons ago in the Division 3AA championship game, the only other time the black and gold had advanced to a divisional title game.

The game was tied three times in the first quarter and the Dons (23-10) had a one-point lead twice. But when White hit a pair of three throws with 14.7 seconds left in the stanza, it gave the Eagles the lead for good at 11-9. White was already off and running, scoring all but two points in the

opening quarter. While Cerritos contained her a bit in the second quarter, it would be Lindsay Gould and Helena Koubek who dominated the next eight minutes, each scoring seven points as Oak Park, the top-ranked team in the division, began to pull away.

The Eagles opened the stanza on a seven-point run to make it 18-9. Then with 3:30 remaining in the half, Koubek converted a three-point play to increase the margin to nine points. By the time the half ended, the Dons found themselves down 32-19 and searching for answers as to how to come back in the game. Both teams shot 30.8 percent from the field in the half, but Oak Park was perfect on all eight free throws while the Dons were two of 11 from the free throw line. The Eagles were also owning the glass, outrebounding Cerritos 24-18.

"[I told them] stick with it; stick with the game plan," said Chinen. "We weren't going to change anything. We just needed to get stops. That's a very good team. Their point guard is a very good point guard and I think had we executed a couple of more plays correctly, then again, it would have been a different game."

Not making things better was the fact that, six-foot senior Onyeka Nwanze picked up her second foul at the 3:31 mark of the second quarter. Knowing that she couldn't pick up another foul before half-time, she attempted just one more shot but still went into the locker room with half of the 18 boards.

"I just had to not play with the fear of having multiple fouls," said Nwanze. "I just play hard and play for my team. If I just keep thinking about my fouls, then I'm going to foul out because that's what's going to be on my mind. I just know I have to give it my best because I'm a senior and this is going to be my last shot of a CIF

[championship]."

The second half began the same way the second quarter did, with the Eagles scoring the first six points. Cerritos would break its scoring slump just before the five minute mark when sophomore Cameron Lacorte nailed her second long range shot. But that was quickly responded with a three-point play from White and a trifecta from Gould, making it 44-24 with 3:42 remaining in the quarter. Even though the Dons would go on their longest scoring streak of the game, thanks to a basket and free throw from Nwanze and a two-pointer from junior Ambar Multani, Chinen knew a 15-point deficit late in the quarter was going to be too much to overcome.

"I would say later in the third quarter, it was getting away from us," said Chinen. "But then again, I was telling them we had to stick with the game plan. We still have to rebound, we still have to execute, we still have to play defense. Some of them had foul trouble, but they had to go and play through it."

"I feel like we needed to keep our energy more up," said Multani.

Staying with the *déjà vu* theme, Koubek scored the final points of the third quarter with 24.4 seconds left, then saw White add six points and Gould another three-pointer in the first three minutes of the fourth quarter, making it 57-31. Moments later, after a three-pointer from junior Miya Scammon, the Eagles went on their fourth run of the game, this one 7-0 and all coming from the free throw line.

"That was key for them; all those little runs, and we just couldn't stop them," said Chinen. "Again, we just had to tell the girls they couldn't change anything on defense. They still had to play solid defense throughout those little runs."

Koubek scored 15 points and had 15 rebounds while Maya Deshautelle and

Gould added 14 and 13 points respectively. Nwanze led the Dons with 18 rebounds and 16 points but was seven of 20 shots from the field while Multani pitched in with nine points and seven boards. A lot of the missed shots from Nwanze were easy lay-ups under the baskets or missed offensive putbacks.

"It was a little disappointing, but I didn't get frustrated," said Nwanze. "I just knew that I had to keep myself level-headed and just keep going at it. They're going to fall in if I keep trying hard."

While the season isn't quite done, as Cerritos visits Louisville High on Tuesday in the first round of the CIF Southern California Regionals, it is coming to a close for six seniors-Chloe Bonilla, Mailee Dizon, Abby Hizon, Faith Lacorte, Mia Rivera and Nwanze, Dizon and Rivera have been consistent starters, as is Nwanze, who was injured last season but managed to score over 1,000 points for her career.

"It's been great playing at Cerritos," said Nwanze. "The community is great, the parents make you feel like you're part of the family, and it's great to have that support. That's why I always play my best every game because I know how many people are cheering me on. I hope I can continue to do that the last couple of games we have, and I hope I can pass on that spirit to the rest of the girls on the team."

"She's huge for the program, and hopefully people who look at that and say, 'hey, I'll be the next Onyeka; I'm the one who's going to step in,'" said Chinen. "I know right now there's big shoes to be filled. I hate to lose her, but I know that is the cycle and she's going to have to go on. But I know she's going to do good things in college."

In a season of firsts for the La Mirada High girls basketball program, the Matadores just added another win to its resume this past Tuesday in the CIF Southern California Division V Regionals. Denied a chance of playing in the program's first CIF-Southern Section Divisional championship game when the Matadores lost to Colton High 43-42 in the 5AA semifinals on Feb. 17, they bounced back in a big way against Gardena High.

La Mirada broke the game wide open with an 18-0 run to begin the second half and knocked off the Panthers 55-35 in the first round game. The Matadores, seeded eighth in the division, will travel to top-ranked Montgomery High on Thursday. Montgomery, which defeated Temecula Prep 88-27 this past Tuesday to improve to 22-11, is located less than seven miles from the United States/Mexico border.

"I'm proud of the girls; we've worked hard, and they came out playing like they should be, tonight," said La Mirada head coach Victoria Luong. "They executed exactly what we worked on."

When they weren't trading a plethora of turnovers in the opening minutes, both teams traded basket for basket until senior Jirah Domingo drained a three-pointer with 2:11 left in the opening quarter. It would be the beginning of an 8-0 run and by the time the stanza was over, the hosts had a 12-8 lead and never looked back.

Domingo would hit another basket from beyond the arc early in the second

quarter, then a two-pointer over a minute later to increase the lead to 17-9. Then with 3:31 remaining in the half, she completed a three-point play for a 20-11 lead. After India Cage scored Gardena's last points of the half with over three minutes left, freshman Jordin Shaw hit a three-pointer and junior Nayeli Tamayo concluded the scoring in the half with her only basket of the game.

"They struggled a lot with nerves like we have been in previous games, and I think finally, they got the hang of it," said Luong of the second quarter. "[Junior] Jael [Arreguin] made numerous turnovers in the first quarter and I think after that, we just let it go and just played what she knows."

To make sure the CIF-Los Angeles City Section Division V champions wouldn't get back in the game, the Matadores began the second half on an 18-0 run with Domingo scoring the last seven points. That came after Arreguin scored seven straight including a coast to coast basket following a steal.

"The girls were just on it today," said Luong. "We've been undefeated at home [all season], so we've got to protect that, and they did an amazing job."

La Mirada's last basket of that run came with 3:38 left in the third and although Gardena would score the last seven points of the stanza, plus the first two of the fourth quarter, a 21-point lead was still comfortable for the Matadores. The Panthers continued their momentum, going on a 7-2 run after Shaw scored

following a steal from Domingo. But with 4:38 left to play in the game, and La Mirada up 47-29, all the hosts had to do was control the clock.

One move that Luong made, which paid off, was insert junior Simran Sahota into the starting lineup for Tamayo to add extra presence on the boards with junior Emily Gonzalez. While the latter had four rebounds in the opening quarter, she picked up three fouls in the first half. Meanwhile, Sahota picked up the slack and grabbed six rebounds in the second quarter.

"We watched film, obviously, and we knew what to expect and we knew [Gardena] had massive rebounds against Fremont [High] in their championship game on Friday," said Luong. "We knew we had to step up on our rebounds and the bigs had to make a difference."

Domingo led everyone with 25 points, had six rebounds and four steals while Arreguin added 12 points, five rebounds, two assists and two steals. Sahota and Gonzalez ended with 10 and eight boards respectively as the team picked up 42 rebounds.

If La Mirada can pull off the upset against Montgomery, it will face either fourth-seeded Immanuel High or fifth-seeded Sage Creek High on Saturday in the regional semifinals. Immanuel won the CIF-Central Section Division IV championship and defeated Rosamond High 62-23 this past Tuesday while Sage Creek, the CIF-San Diego Section Division III finalists, knocked off Escondido

High 60-44 in the opening round.

"I always tell the girls, especially in the playoffs, we take it one game at a time," said Luong. "So, we don't what them to assume anything based on anything. Now we'll focus on Montgomery and do our best."

In other girls basketball action, Cerritos High, playing in its second ever state playoff game, upset second-seeded Louisville High 47-44 this past Tuesday in a Southern California Regional Division II first round game. The Dons (24-10) will travel to {Sherman Oaks) Notre Dame High on Thursday. The Knights, seeded 10th in the division, upset Poway High 58-50 this past Tuesday. The winner of this game will face either third-seeded Hamilton High or 11th-seeded Santa Margarita High on Saturday.

**BOYS BASKETBALL**

The dream season for Cerritos ended when the Dons came up short against University City High 68-65 in a Division III first round game this past Tuesday. The loss snapped a 15-game winning streak and came three days after the Dons (22-11) knocked off Yeshiva University of Los Angeles in the 4AA championship game. Senior Luke Rigor led Cerritos with 17 points while senior Shay Pema added 13 points and junior Benson Cho chipped in with 10 points.

"Next year is going to be a little different as far as how [the CIF-SS] is going to rank the teams," said Chinen. "And we're going to work really hard. We lose Mia and

Mailee and Onyeka. It's going to be tough replacing our seniors who are there every day at practice, encouraging our girls to try to get each other better. Now, we're going to be leaning on our juniors and our sophomores, and even our little freshman. She came in and played a hell of a game too, tonight. And that's impressive."

Gaultieri conducted a meeting - with eight CB employees attending – that included the CB VP Juan Garza.

In the meeting, LCCN was told by sources that Gaultieri, who is GM of La Habra Height County Water District (LHHCWD) with his sidekick Garza next to him, brazenly announced that he is negotiating a professional services contract with the LHHCWD Board of Directors that would allow him to keep his Central Basin seat.

Gaultieri is retiring from his GM position at LHHCWD in May; Gaultieri knows under the CB Board of Directors Administrative Code that his retirement will force him to resign his seat on the CB Board.

The negotiations between LHHCWD and Gaultieri are illegal under Government Code 1090, a law that addresses

conflicts of interest for public officials and employees.

The illicit negotiations would hand Gaultieri thousands annually in taxpayer monies; he would keep his PAID appointment to the CB Board, he would get PAID for attendance at CB meetings, he would get PAID for attendance at the Metropolitan Water District meetings, and he would get PAID for his new position as a LHHCWD consultant.

Section 1090 states, “[the law] prohibits an employee from participating in making government contracts in which the employee within the agency has a financial interest. Section 1090 applies to virtually all state and local officers, employees, and multimember bodies, whether elected or appointed, at both the state and local level.”

“Making” a contract includes final approval of the agreement and involvement in preliminary discussion, planning, and negotiations.

Gaultieri is going all in with his maneuver, not violating 1090 once but violating it multiple times.

Violations of Section 1090 can result in the voiding of contracts, criminal, civil, and administrative penalties, and a ban on holding public office.

And the LHHCWD Board could be in legal hot water; most agencies require a twelve-month cooling-off period between retirement and returning as a consultant or lobbyist; and LHHCWD ratepayers will wonder why the board is paying Gaultieri.

In addition, the LHHCWD Board is attempting to fly under the radar, calling his consultant agreement a professional services contract not subject to California Contract Laws, which require the contract to go out to bid; that might not go over well with FPPC investigators.

Seeing that the contract negotiations violated Section 1090, the eight employees present at the meeting where Gaultieri said he was staying on the CB Board told some

one about the incident; that person or persons then filed the complaint anonymously.

The anonymous person wrote in the complaint, “Michael Gaultieri, as General Manager of the La Habra Heights County Water District, is negotiating a professional services consulting contract with the LHHCWD board of directors so that he can continue to receive compensation from LHHCWD, the Central Basin Municipal Water District and the Metropolitan Water District of Southern California upon his retirement scheduled for May 2024.

“If the LHHCWD requires consulting services, they should go out to bid for these services, or there should be a one-year cooling off period upon Mr. Gaultieri’s resignation/retirement before he is hired as a consultant by the LHHCWD.

“By negotiating this professional services contract while he is the current general manager, he is in violation of Government Code 1090, which prohibits public employees from engaging in contracts wherein they have a financial interest.”

Emails into CB Board members, LHHCWD Board members and CB attorney Victor Ponto of Santa Ana based Burke, Williams and Sorensen went unreturned.

It was in Martinez’ car where the alleged sexual assault and battery took place between Valdivia and Ms. B.A.

The lawsuit alleges that while Valdivia was alone in Martinez’ vehicle with B.A., he sexually assaulted and battered her inside the car. Valdivia’s conduct was especially violent and intimidating because he showed her his firearm and intimidated that he would use it.

“As long-time friends or associates of Billy Valdivia, both Graciela Ortiz and Efren Martinez knew, or should have known about these problems with his record, they should have done a background check. Martinez and Ortiz called the complaint a frivolous, politically driven lawsuit filed by an anonymous party.

The statement continued, “The attorney for Martinez and Ortiz has demanded a complete dismissal of this “politically motivated, frivolous and misguided piece of litigation.” The demand to Mr. Scully goes on to clarify that the allegations in the lawsuit are false, inaccurate and without legal authority.

“We unequivocally denounce the victimization and abuse against any individual in our communities. This is clearly a politically driven attack and we are disgusted that malicious actors are taking the trauma of this victim and weaponizing it for their own gain. They have clearly not considered that they themselves are re-victimizing this individual by pursuing erroneous and frivolous litigation. Both of us have hosted thousands of volunteers in our years of community work and we have never allowed or condoned the type of abuse described and we had absolutely no knowledge or involvement.

“Mr. Scully’s attempt to smear the reputation of Martinez and Ortiz to these circumstances which occurred nearly three years ago is wrong and not legally authorized.

“We are being named in this misguided lawsuit against us when we know that the true motivation is to attempt to derail our efforts to serve our local residents at the State and School District levels. This is nothing more than dirty politics at its lowest level.”

Apparently the LAUSD did not think the lawsuit was frivolous placing Ms. Ortiz on leave pending an internal investigation.

“That’s the way it is in the weekly newspaper world,” said LCCN publisher Brian Hews, “people threaten me all the time when I publish legitimate fact-based document-backed stories, they threaten lawsuits and try to discredit me. Central Basin Director Juan Garza is the latest to threaten me several times, he did not like I discovered he worked for over a year with La Luz Del Mundo, leaving three months before Naasón Joaquín García pled guilty to heinous sex acts with minors.”

Apparently the LAUSD saw the lawsuit article; according to reports the LAUSD has removed Ortiz from her job as an LA Unified counseling administrator pending a confidential investigation which led to the school employees union withdrawing its endorsement over Ortiz for the March 5 election.

The lawsuit was filed by “B.A.” and alleged sexual assault and battery, negligence, intentional infliction of emotional distress, and conspiracy. The attorney for Ms. B.A. is Thomas Scully, based out of Culver City.

The lawsuit alleges the crimes occurred in connection with a commercial space that was turned into a political campaign office in Huntington Park in late 2020 and early 2021 by a man named Billy Valdivia.

Ms. Ortiz was the primary person in charge of the campaign, organizing the volunteers and instructing them on what to do, including interactions with Valdivia, “an employee and authorized agent of the political campaign.”

Current Assembly candidate Efren Martinez was allegedly a good friend of Valdivia at the time, as witnessed by the complaint stating that Ortiz and Martinez hired Valdivia as a coordinator of the volunteers and that Martinez gave Valdivia

Pursuant to state law, City Council adopted a 1-year moratorium on issuing any use permits for such tattoo/body art establishment to assess whether the operation may conflict with the City's zoning laws, and to evaluate public safety, health, and welfare concerns associated with such an establishment. Currently, under the City's zoning laws in Title 22 of the Cerritos Municipal Code (the "Development Code"), tattoo/body art establishments are not expressly a permitted use, permitted accessory use, or conditionally permitted use. While the Development Code has a process to evaluate proposed comparable uses, the City previously had no occasion to apply comparable use analysis for tattoo/body art establishments, and there are no standards or regulations for such establishments or businesses in the Development Code. 
