## Unknown Respiratory Illness Hitting Canines

Dogs in seven states have been infected; ten now in L.A. Symptoms include coughing, fever, and lethargy.

A unknown respiratory illness is sickening dogs across the United States and continues to spread while veterinarians try to determine its causes and the best methods for treating it.

According to veterinarians, the symptoms are similar to kennel cough, an upper respiratory infection, but can last much longer and, in some cases, prove fatal.

**What are the symptoms?**

The infected dogs

Congresswoman Linda T. Sánchez (D-CA) joined city of Norwalk Mayor Ana Valencia and other community leaders for a ribbon cutting ceremony to launch #ParkConnect, a project that will create

opt-in, no-cost Wi-Fi Zones across the city.

In partnership with city officials, Sánchez secured \$1.7 million for the project. The ribbon cutting at Hermosillo Park marks the first of many no-cost Wi-Fi Zones to be installed in parks across Norwalk.

"I am honored to be here in Norwalk today to celebrate the #ParkConnect project coming to fruition," said Congresswoman Linda Sánchez. "Today, internet access is needed for almost everything, from connecting

## Project FoodBox Provides Fresh 'Produce as Medicine' for Those in Need

The project partners with the Los Angeles Regional Food Bank and others; to date, they have delivered 100 million pounds of food.

With more people realizing that food is medicine, one Orange County program is serving up fresh produce and other nutritious staples to those in need in the community.

Project FoodBox, which serves Los Angeles, San Diego, Riverside, San Bernardino, and Imperial counties, accomplishes this by bringing fresh produce directly from the farm to the doorstep working with local family farms throughout California and the Pacific Northwest.

"Our goal is to serve all 58 counties in California and expand throughout the U.S.," Steve Brazeel, founder and CEO of SunTerra Produce said.

Project FoodBox got started during the pandemic, and is thriving today providing "food as medi-

cine" to those in need.

SunTerra is a family-owned minority grower and produce distribution company that operates Project Foodbox.

"Born out of the food bank box program, we execute prescriptive, fresh fruit/veg-based food-as-medicine programs for healthcare providers throughout California," he said.

When Project FoodBox was launched to respond to the COVID-19 pandemic, SunTerra Produce was chosen as a contractor under USDA's Farmers to Families Food Box Program in May of 2020.

SunTerra Produce working ladies are proud of their work providing nutritious produce and food to those in need as part of Project FoodBox. The program, which started during COVID-19, now supplies food banks and is partnering with Medi-Cal plans throughout California including in Orange County.

"When that program ended, we forged part-

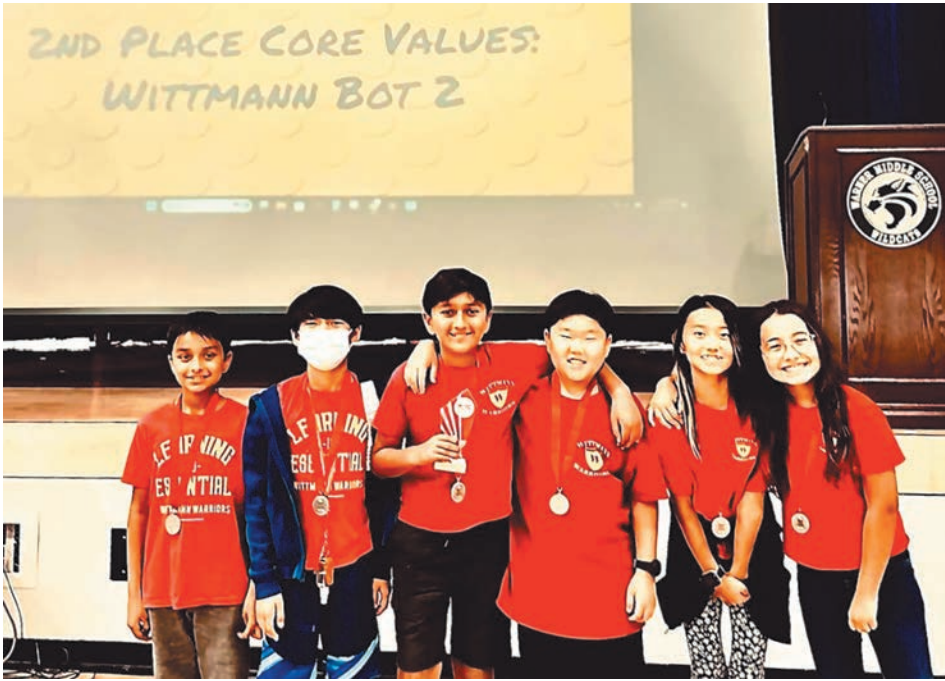

## La Mirada Accepting Applications for Vector Control Representative

La Mirada is seeking residents interested in serving on the Greater L.A. County Vector Control District (GLACVCD) for a term beginning in January. Applications are due Friday, December 15. The selected applicant would represent the La Mirada on the GLACVCD Board and provide information to the City Council about GLACVCD activities and programs. GLACVCD is a public health

agency that is a result of legislation incorporated in the California State Health and Safety Code. The GLACVCD provides ongoing mosquito and vector control for its residents.

The Trustees serve a minimum of two or four year terms without compensation, but do receive an in lieu travel expense of \$100 for attending each regularly scheduled board meeting. The regularly scheduled board meetings are held on the second Thursday of each month, starting at 7 p.m. at District headquarters in Santa Fe Springs.

# Bellflower City Manager Retires, City Council Appoints New City Manager

BELLFLOWER, CA — After 12 years of dedicated service as the City Manager of Bellflower, Jeffrey L. Stewart has announced his retirement from the city, effective January 2, 2024. Stewart’s leadership has been instrumental in shaping the city’s growth and development during his tenure.

The Bellflower City Council, during its Regular Meeting on November 13, 2023, officially named Ryan Smoot as the successor to Jeffrey Stewart. This decision comes after careful consideration of Mr. Smoot’s qualifications and experience in municipal management.

Ryan Smoot has a longstanding history with the City of Bellflower, having first joined as a Management Assistant in 2009. After a brief hiatus, during which he contributed his skills to the City of Villa Park as the Assistant to the City Manager, Mr. Smoot returned to Bellflower in 2013. Over the years, he demonstrated exceptional dedication and leadership, serving as the Assistant to the City Manager from 2013 to 2016 and concurrently as the Acting Economic Development Manager from 2015 to 2016.

In 2016, Mr. Smoot took on the role of City Manager for the City of Lomita. However, with the impending retirement of City Manager Jeff Stewart in Bellflower, the City Council identified Mr. Smoot as a strong candidate for the position. Following a thorough interview and negotiation, Mr. Smoot has accepted the responsibility of becoming the 14th City Manager of Bellflower.

develop a cough, fever, lethargy and loss of appetite. Some dogs will develop pneumonia. and some veterinarians have reported seeing blue and purple gums in those cases.

Dogs with kennel cough may show some of these symptoms, such as coughing, lack of appetite, fever and lethargy. If it is kennel cough, the symptoms usually clear up in one to three weeks. With the latest respiratory illness, however, veterinarians are reporting that dogs can have symptoms for six weeks or more.

Where has this been reported?  
The illness has been found in at least seven states: Colorado, Massachusetts, Oregon, Rhode Island, Illinois, Maryland and Wyoming.

It’s unclear how many dogs in total have been infected, because there is no official count of the cases.

The cause is not clear.  
It’s unclear what causes the illness. Researchers are still running tests to learn more about the illness. There is some disagreement on whether the illness is caused by a virus or by bacteria.

Some veterinarians in Oregon hypothesize that it could be viral, because the dogs they have treated have not responded to antibiotics.

“I’m open to it being either, and I’m open to it being something we’re not even thinking about,” said Dr. Kurt Williams, director of the Oregon Veterinary Diagnostic Laboratory at Oregon State University’s Carlson College of Veterinary Medicine.

Senior veterinary pathologists at the New Hampshire Veterinary Diagnostic Laboratory of the University of New Hampshire believe the illness is being caused by a bacteria, based on what they had seen in his area.

Researchers strongly agree that dogs are most likely to develop the illness when they have been around other dogs.

Veterinarians in Colorado are saying that all of the dogs they have treated for the illness have spent time in places with high concentrations of dogs, such as boarding facilities, doggy day care centers or dog parks, meaning there could be an increase in cases as more owners board their dogs or send them to day care during the holidays.

“We’re really hoping just with getting the word out there that people are less inclined to do that,” she said. “The veterinary community as a whole is kind of scared,” said Williams.

What should owners do?  
Don’t panic, and isolate your dog if it is showing symptoms.

Dr. Stephen Kochis, the chief medical officer for the Oregon Humane Society, said he did not want people to be alarmed by the new illness, because the overall number of dogs with respiratory illnesses had not increased. If dogs are showing symptoms, there are steps owners can take to be proactive, he said.

“All of us have gone through Covid,” he said. “I would say if your dog is showing signs of respiratory disease, isolate them in the home, call your vet, get them seen.”

## New Option for Senior Drivers' License Renewals

I recently received a most unwelcome “birthday” card from the California DMV informing me that I would need to renew my driver’s license by my birthday.

Any driver age 70+ must select a testing option. The good news is that the DMV is now offering an interactive eLearning Course to meet this requirement instead of in-office or remote knowledge test.

After filling out the online application and paying the \$41 fee, if eligible you are prompted to select the remote exam or the eLearning Course. I strongly recommend the latter, which is what I did.

The newly offered eLearning Course has seven interactive modules to complete on your computer, tablet or mobile device.

Each module has a quiz, which is not a pass/fail test, and is available 24/7. It takes approximately 45 minutes to complete, although there is no time limit. I found it very user-friendly and even fun with interactive features like moving an on-screen car with your finger to make a correct turn from its little on-screen lane.

After completing the course, you must still go in to a DMV office, provide required identity and residency documents, have a photo and thumb print taken, complete a vision screening and then be issued your temporary license to use until your permanent one arrives by mail.

The DMV’s website states: “The course is the ideal option for people who have trouble with renewal exams.” This time I found my trip into the DMV stress-free without having to worry about taking a test there. I definitely recommend you select this option the next time you receive a birthday renewal notice from them.

nerships with the California Association of Food Banks, OC Food Bank, Second Harvest Food Bank of Orange County, Los Angeles Regional Food Bank, and others to continue to deliver farm-fresh fruits and vegetables directly to food banks and community organizations every week,” explained Brazeel.

“To date, we have delivered 5 million (100 million pounds),” he said.

With two main focuses, Project Food-box partners with food banks directly – sourcing and delivering farm-fresh fruits and vegetables to dozens of food banks across the western U.S.

“On sourcing, we partner with farmers to reduce farm-level food loss by utilizing sizes/grades not popular with retailers,” he added. “[We do this by] finding market inefficiencies/temporary over-production, removing additional upstream costs, eliminating redundant packaging, lowering food miles, etc.,” Brazeel explained. “It’s a true win-win solution,” he said.

SunTerra Produce partners with Elevated Foods, establishing additional grower partnerships based on environmental sustainability, which help reduce waste and make more produce available to those in need.

Recently, Elevated Foods was awarded \$32 million in funding to help transition growers to this more sustainable and regenerative practice as defined by both the USDA and NRCS, according to Brazeel.

As part of a 5-year plan to reimagine Medi-Cal, California recently launched CalAIM, creating the opportunity to improve care and outcomes for millions of Medi-Cal enrollees.

One of these community supports is

medically-tailored-meal (food-is-medicine) programs.

“As a community support provider, we work within the guidelines and programs outlined by our healthcare partners. Food-is-Medicine interventions are relatively new, and we expect programs to adapt and update over time,” he said.

names as defendants the state Workplace Conduct Unit, the Senate Rules Committee and Don Wilcox, Archuleta’s chief of staff. The original lawsuit was filed March 2021

Shortly after the lawsuit was filed, LCCN learned from several sources that the Jane Doe in the Archuleta harassment lawsuit was the senator’s former District Director Friné Medrano.

LCCN attempted to contact Medrano several times in 2021 without response; since the 2021 article, Medrano has not contacted LCCN to refute the sources’ identification.

Medrano alleged whistleblower retaliation, intentional infliction of emotional distress and various state Labor Code violations.

In a statement Archuleta said that the allegations are “completely and categorically false.”

“My entire career, I have supported the right of every Californian to feel safe, valued and protected in the workplace,” the statement read. “While I would never knowingly mistreat or disrespect a female employee, I believe in their absolute right to come forward and be heard if and when they believe that standard has been violated.

Every voice has value. That’s why, from the beginning, I fully and wholeheartedly cooperated with the Senate’s independent investigation into the events in question and was prepared to stand by the outcome. It’s unfortunate for everyone involved that those independent proceedings were interrupted by this lawsuit.”

One source told HMG-CN that Medrano could be seen at several public

events attempting to grab Archuleta’s arm and hand, with Archuleta immediately admonishing and brushing her off.

I told Bob she [Medrano] was trouble,” said one source, a close friend who who attended several Archuleta public events.

Another source told LCCN that the “Rubio sisters are mad that Archuleta did not endorse a family candidate, and now they want to take his seat.”

In 2018, Medrano ran for the 58th Assembly district but lost to perennial candidate Cristina Garcia; she also ran for Downey City Council in 2016 and lost.

Of interest is that Medrano was selected as a delegate by Archuleta in January 2019, included on a slate that beat Cristina Garcia’s slate.

Also on her Linkedin account, Medrano listed herself as an employee at Archuleta’s office.

Archuleta said, “the lawsuit manufactures a whole new layer of gratuitous allegations, which were not raised until litigation was chosen as the way to go — and which are completely and categorically false. I look forward now to disproving those allegations in court.”

In court papers filed Tuesday with Judge Joseph Lipner, WCU attorneys maintain the unit is not liable for the lone cause of action filed against it alleging failure to prevent discrimination.

The WCU is a division of the Legislative Counsel Bureau and was created to provide advice and investigation services to the Legislature related to workplace misconduct.

A hearing is scheduled for Jan. 30, 2024.

Not much was expected coming into last season as Gahr had won a combined 18 games the previous four seasons. For the fifth time in the last eight seasons, Norwalk posted a winning record and for the sixth time during that span, the Lancers reached double digits in victories. However, Norwalk has exited the playoffs in the first round seven times since the 2013-2014 season, leaving head coach Ashley Baclaan wondering what it takes to move farther in the postseason. In fact, going back to the 2007-2008 season, the Lancers program has reached the second round three times.

“It’s always a tough one to exit out of the playoffs,” said Baclaan, who needs four more victories to pass Richard Drake (2007-2013) in that category. “I think the girls tried their best, but unfortunately, we got rattled and couldn’t execute as we wanted. Anaheim was a great team and played awesome.”

While the Lancers graduated four starters last season, the one who is back was their leading scorer. Senior Keilani Ganancial was a Mid-Cities League first team member and has the potential to be the league’s most valuable player this season if she puts up the same, or better numbers. She may have to because Norwalk doesn’t return much after her.

The offseason was rough for Norwalk because of the graduation of eight players off a team of 14 and its gymnasium was torn down with a new one already under construction. Baclaan said the offseason training was minimal to none.

“Keilani will bring her game as it comes,” said Baclaan. “She’s a constant presence for us and I just look forward to seeing her excel in her final season. I know she’ll bring a leadership that will have all the new and young players coming up ready to compete to their best abilities.”

Justine Abat, who scored 15 players, and varsity rookie Rhean Pascual are the only other seniors while juniors Janii McGarrah and Celine Zavala join Abat as the only returning players. The Lancers will field two new juniors and five new sophomores as Norwalk will field one of its youngest teams in recent years and because of that, Baclaan says, ‘everyone is just working and building together’.

Norwalk will have a full schedule of 14 non-league games, its annual Glenn/Norwalk Tournament and 10 Mid-Cities League contests, all of which will be on the road with some of its league games being played at Glenn.

“We’re approaching the season as it is,” said Baclaan. “With months of working around no true home facility, I think the girls have adjusted well and are just moving forward day by day. Plus, they usually like the early

bus rides to get out of class and be together.”

Baclaan concluded by saying that the expectations are always for growth and that every year will have their road blocks and surprises.

“We just try and have the girls play within the moments and keep moving forward with any outcome and lessons,” she added.

For the seventh straight season, V.C. will have a new head coach and for the second time in three seasons, Dan Leffler assumes that role with last season’s head coach, Ariel Sanchez, remaining as an assistant. When Leffler took over two seasons ago, it was because the head coach at that time had left a week before the season started. Leffler was also the athletic director and admitted he had no intentions of coaching. But he says this time is much different.

“I stepped down from the AD position in June,” he said. “My youngest daughter graduated from Valley in May and plays college soccer in Boston. My wife and I have been travelling to the East Coast this fall to watch her play. The girls basketball program at Valley Christian has a rich tradition and I plan to devote the time and dedication needed to make our program relevant again.”

V.C., which lost 14 of its last 15 games last season, has one returning senior, and its Jada Thompson. Leffler says she brings leadership to the team, is the team captain and will start in the post. Sophomore Jocelyn Tani, who is the leading scorer of

the returning players, is also projected to be in the starting lineup joined by sophomores Aniyah Peoples and Gracie Verhoef and freshman Hannah Burgoyne.

The Defenders will be young with six sophomores, three freshmen and two juniors, along with Thompson but Peoples, Tani and Verhoef played a lot of minutes as freshmen last season while Burgoyne and freshmen Jenna Vankampen are two potential stars for the future.

“Jenna brings a ton of athleticism to our squad,” said Leffler. “Hannah is a sharp-shooting guard that has played a lot of basketball. Hannah is a fierce competitor, has an incredible work ethic and loves to be in the gym working on her game.”

In eight Olympic League games last season, V.C. reached 40 points once, and that was a 41-40 win at Maranatha High. Leffler says the expectations for this season are to crack the top three in league and make the playoffs. He’s also hoping to finish at least 13-13, which would be the most victories for the program since going 22-10 during the 2016-2017 season.

Since the 2010-2011 season, Whitney has produced one star player after another, or one solid team after another. The result has been 11 winning seasons out of the past 13, and one that wasn’t ended up a 14-14 campaign. Over the past 13 seasons, the Wildcats have finished in the top three in either the Academy League or the 605 League and the prospects of the program’s third straight league crown and seventh in the past 14 seasons are there.

“The offseason was a lot of work,” said head coach Myron Jacobs. “I choose to focus more on the younger girls and the girls

who return from last season who didn’t play much. I thought me and my coaching staff did a great job in the offseason setting expectations and making my girls a little bit tougher and physical.”

This is a fun team to watch and be around with, and it starts with the big three-senior Kylie Wang, junior Haylie Wang and sophomore Mady Macaraeg. Kylie Wang was the 605 League’s Most Valuable Player and was the HMG-Community News All-Area Player of the Year while Haylie Wang and Macaraeg were first team All-League members. If their statistics were solid last season, expect those numbers to grow this season. The sisters didn’t play with the team that much over the summer because Jacobs wanted them to play 17-Under AAU basketball. That move paid off as Jacobs said it was like looking at two different players, improving their game ‘big time’.

“The two girls will be ready to put on a show when it’s time to come,” said Jacobs. “Mady has gotten better [also], improving on her jump shot and on the defense. Mady is a kid that can give you a double-double every night as a guard and make it look easy.”

He is quick to say that the Wildcats have more weapons than the sisters and Macaraeg. Senior Alyssa Troung and juniors Rachel Moyher and Allie Yamaguchi are the other returning players with Troung and Yamaguchi expected to be in the starting lineup with the big three. Jacobs says the non-big three have improved on both sides of the ball and will be ready before the season opener.

Freshmen Cheyanne Cheung and Alyssa So are the next wave of potential Whitney greats. Jacobs says So is a ‘walking bucket’ who can hurt opponents from the three-point arc and attack the rim with confidence. Cheung is a ‘very athletic forward’ who can rebound, block shots and play really good defense.

Unlike last season, Jacobs didn’t go too crazy when putting his schedule together. But the Wildcats will be ready for the league competition they will get from Cerritos and Pioneer High by playing Crean Lutheran High, Orangewood High, Sonora High and Troy High. The ‘Cats will also participate in the prestigious Nike Tournament of Champions in Phoenix just before Christmas.

“I think we are coming off a good fall league winning 13 games and only losing three, and the games we lost were good opponents,” said Jacobs. “Fairmont Prep, who we lost to by 14, and Brentwood, who we lost to by 10, are Division 1 schools who have really good athletes and talent. We are right there; we just need to get over the hump.”

Jacobs says his expectations are the same every year-to develop players win the 605 League and go deep in the playoffs.

## ANOTHER FIRST QUARTER SURGE SENDS CERRITOS TO ITS FIRST TRIP TO DIVISIONAL FINALS

For the third straight game in the CIF-Southern Section Division 12 playoffs, Cerritos High blanked its opponent in the opening quarter, then watched first half leads of 14-0, 35-6 and 28-0 evaporate before holding onto a victory. Fortunately for the Dons, they never trailed in any of those games, thanks to a constant offensive push and stellar defensive plays.

Cerritos built a 28-0 lead over Coachella Valley High last Friday night, then saw it dwindle to a one-possession contest before putting the Thermal-based team away in a 42-28 win at Dr. Hanford Rants Stadium, earning the program's first trip to the divisional finals. The Dons, who have won six in a row and improved to 8-5, scoring over 35 points in four of those wins,

will host second-seeded Yucca Valley High on Saturday at Artesia High.

"I'm extremely excited," said senior linebacker Jeremiah Bagaygay. "I can't wait to come out next week. We should all be proud of my teammates right now. We weren't expecting to win this game, but we came out and showed the [number one] team what's up.

"This game means a lot," he later added. "There were a lot of unfortunate events happening around school and this means a lot for the school and the community. I just really wanted to go out there and play my heart out."

He was just one of several key players who would have a big hand in the outcome, and it started in the second quarter. With the Dons up 14-0 on the strength of senior running back Josh Park, who scored a 15-yard

touchdown run late in the first quarter and a four-yard touchdown scamper in the middle of the second quarter, Bagaygay picked off Derek Calderon on the next play after Park's second touchdown and returned the rock 25 yards for a 21-0 lead. Later in the stanza, he recovered a fumble, setting up a nine-yard touchdown run from senior quarterback Julian Morales. Just in the first quarter alone, Bagaygay had four tackles, a fumble recovery, an interception, and a sack. He ended the game with half a dozen tackles.

"My brother said we needed to get Bagaygay going," said Cerritos first-year head coach Demel Franklin. "So, we put him on kickoff returns and we had a package for him on offense. We didn't get to that, and I made him a captain. I was just trying to do anything I can to motivate him, and it paid off."

The lead seemed to be what the Dons needed as they were facing their third straight challenge in the postseason. A 14-0 halftime over fourth-seeded Fillmore High in the first round was soon a 14-12 advantage entering the fourth quarter. A 28-0 first quarter lead and 35-6 halftime lead over Western Christian High a week later ended up being a 55-44 victory.

Against the Fighting Arabs, the 605 League champions had 168 yards in the first half while containing their Aaron Ramirez, who entered the game with over 2,000 yards on the ground, to 45 yards on 11 carries. On top of that, Calderon had five straight plays of negative yardage.

"I thought it would go more back and forth," said Franklin. "I knew we could score on them because we had some advantages. I knew we could score; I didn't count on them scoring that quick. That was not fun."

"It happened to us against Yucca Valley on Oct. 6," said Coachella Valley head coach Bill Johnson on the early deficit. "We actually got down really heavy in the first quarter. We rallied to be down by 11, then had a shot to get it down to four. We've gotten ourselves into holes and rallied back and in these playoffs, we've been down in both games and rallied back to win.

"There were three lead changes in our first round [win], there were three lead changes in our quarterfinal [win]," he continued. "We just got behind and [our] offense put [our] defense in some holes here and made it easier for Cerritos to get out by as much as they did."

But limiting a team that had scored over 500 points this season for the second straight

week was not going to be easy. Miguel Rodriguez returned the second half kickoff 92 yards for a score and after Cerritos was forced to punt after a three and out, Ramirez got his groove going and scored from seven yards out. Later in the stanza, Calderon connected Rodriguez for 25 yards and just like that, it was 28-21.

The Dons would score on the ensuing possession, going 57 yards on nine plays, ending with sophomore quarterback Justin Sagun finding junior wide receiver John Lim for 17 yards and entering the fourth quarter, the Dons were up 35-21.

On Coachella Valley's first drive of the final stanza, a Calderon 41-yard touchdown pass to Ramirez ended a nine-play drive that

## CERRITOS UP FOR FOURTH STRAIGHT CHALLENGE AS DONS PLAY FOR SCHOOL'S FIRST FOOTBALL CHAMPIONSHIP

LONG BEACH-In a season of firsts, it would only be fitting that Cerritos High would enjoy another first before the hardest week of practice in school history. The Dons advanced to the semifinals for the first time when they defeated Western Christian High in the quarterfinals, then advanced to the CIF-Southern Section Division 12 title game for the first time last week with a two-touchdown win over top-seeded Coachella Valley.

As Cerritos prepares for its next task, squaring off against second-ranked Yucca Valley High at 7:00 p.m. on Saturday at Artesia High, the team added one more first to its resume. This past Monday, the Dons attended the 47th CIF-SS Press Conference and Luncheon at The Grand in Long Beach, an event for the coaches, some players and school personnel of the 32 teams participating in the 11-man and 8-man football finals. Cerritos was represented by first-year head coach Demel Franklin, senior linebacker Jeremiah Bagaygay, senior linebacker and safety Gabe Gaudi, senior running back Josh Park, junior cornerback wide receiver Ruben Castro, junior linebacker Nathaniel Crawford, principal Dr. Patrick Walker and athletic director Todd Denhart.

The Dons, who have been on an emotional roller coaster over the past quarter of a century that has included 11 head coaches, five trips to the playoffs since 2000, four winning seasons (not including the 3-1 Covid spring season of 2021) and three winless seasons, including the 2012 campaign in which Cerritos cancelled all six league games. Now, it is one win away from a CIF championship and a nine-win season, which would tie the 2001 season for most wins in a season.

"I had heard whisperings of the program being shut down and my son wanted to go there," Franklin remembered. "I [asked], 'are you sure'? He said, 'yeah, I like the environment; I want to play there'. When I started coaching there [at the lower levels], you started to kind of see they are really heavy on academics and my coaching style is in your face and I didn't know if that was going to work."

The Dons are riding a six-game winning streak into their meeting with Yucca Valley. The three-time defending 605 League champions have scored 244 points during the streak after putting up 105 in their first seven games. The offense is centered around the Mount Rushmore of Cerritos running backs. They are senior Dikshanta Adhikari (144 carries, 804 yards, five touchdowns), Park (97 carries, 668 yards, 13 touchdowns), junior Josiah Ungos (115 carries, 527 yards, four touchdowns) and sophomore Justin Sagun (48 carries, 305 yards, two touchdowns). The rest of the team has combined for 305 yards and seven touchdowns.

Sagun is also the quarterback, though he has thrown for 544 yards and nine touchdowns while the other signal caller, senior Julian Morales, has passed for 452 yards and five scores. Cerritos took a major hit a few weeks ago when junior wide receiver Ruben Castro injured his collarbone. He is done for the season, but leads the team with 45 receptions, 570 yards and five touchdowns. Adhikari and Park are targets to catch the ball, as is junior John Lim, who has caught nine passes for 143 yards and a pair of touchdowns.

"We all want yards, so we're always determined to get the ball and make sure we get the most yardage we can," said Park.

The Cerritos defense has come on strong as of late, dismissing the fact that it has

faced two straight teams that scored over 475 points and will see another one in Yucca Valley. The Dons have held six opponents to under 20 points this season. Leading the charge on this side of the ball are Crawford (107 tackles, two sacks), sophomore linebacker Tyler Ky (97 tackles), Bagaygay and Gaudi (81 tackles each) and sophomore linebacker Jacob Hoosac (63 tackles). Bagaygay also leads the team with half a dozen sacks while senior linebacker and lineman Moises Mendoza has three sacks.

The path to the finals includes defeating Fillmore High, the fourth-ranked team, Western Christian, which had upset fifth-seeded Victor Valley High in the first round and Coachella Valley. The combined record of Cerritos' playoff victims is 24-12.

"I've been realizing every game we've been having season-ending injuries," said Franklin. "Dislocated elbow, broken this, broken that. So, we're missing guys. We missed Ruben Castro this past weekend and he is so dynamic on offense and defense and having to try to replace him on both sides, also as well as special teams...you lose three starters. Just plugging the holes and getting through it, I'm just so proud of these kids."

"I think it was teamwork," said Park of the win over Coachella Valley. "We all wanted to make sure we go to the finals; we were all determined."

Yucca Valley enters the contest at 10-3 and won all seven of its Desert Valley League games. The Trojans, who have scored 553 points, defeated Hacienda Heights Wilson High 49-21 in the first round, Buena Park High 35-0 in the quarterfinals and Santa Fe High 35-13 last Friday. Yucca Valley enters the contest on a 10-game winning streak after falling to Rancho Christian High 40-13, Valley View High 35-33 and Granite Hills High 63-21 to begin the season. This will

be the farthest west the Trojans have travelled this season, having previously gone to Banning, Cathedral City, Desert Mirage and Temecula for road games. This will be their first road game since Oct. 20. Yucca Valley has reached the finals before, but not since 1996 when it got past Cathedral High 22-19 in the Division XI championship game.

Quarterback Michael Ramos Jr. has passed for 1,483 yards and nine touchdowns opposite five interceptions. But the offense lies in the running game where Yucca Valley has gained 3,165 yards and scored 51 touchdowns. Myles Harper is the one to slow down, or stop, as he has rushed for 1,704 yards and scored 27 times. Next would be Malachi Harper (82 carries, 633 yards, five touchdowns) and Stephon Rogers (61 carries, 357 yards, five touchdowns).

The leading receiver is Javin Hudson, with 57 catches for 946 yards and 11 scores while on defense, Myles Harper leads the way with 146 tackles while Brody Herrera has 108 tackles and four and a half sacks. Hudson also has six interceptions and Joseph Natzel another five sacks to the team's total.

"We just have to trust what we see with our eyes," said Franklin. "We study a lot, we go over stuff a lot and as far as scoring 500 points, we don't look at that. We just know they've never played us. I know what my boys can do, and we've been waiting for this moment. We've worked since the spring for this moment."

"I think we can run through them, just like we did the past three games," said Park. "Our defense is pretty good, and I think our defense will stop them.

included Calderon being sacked by sophomore linebacker Bailey Crawford for a 13-yard loss. But the home team answered back on the next possession with five straight runs from Park and junior running backs Dikshanta Adhikari and Josiah Ungos totaling 46 yards, a 12-yard reception to Adhikari, then two more Park runs of three and 19 yards, the last being the final touchdown.

“What I saw was we kicked it off and they ran it in, which gave them juice, and then my team got deflated,” said Franklin of the second half adjustments. “If we give up a touchdown, that’s what we need to work on. We get deflated and then they kept the foot on the gas and the next thing you know, it’s 28-14.”

“We were just not playing well, and we just talked to the guys about it’s going to come within,” said Johnson. “It’s not going to come from a schematic change. We got the opening kickoff return and took it to the house and that just electrified the guys. we were able to make some changes and start to exploit the back end.”

The Fighting Arabs, who finished in second place in the Desert Valley League and had won five straight games since falling to league champion Yucca Valley, would have two more chances to make the game closer. However, Calderon would be intercepted by sophomore Jayden Bagaygay and Lim on consecutive possessions.

While Calderon finished the contest completing 20 of 30 passes for 221 yards, including seven straight to begin the second half, he was hurt by the three interceptions. Ramirez, who was Cerritos’ 100 percent focus, according to Jeremiah Bagaygay, finished with 150 yards on 24 carries. No other Coachella Valley rusher gained more than six yards on any carry.

“He’s fast and very shifty,” said Bagaygay. “But I just had more faith in our guys than theirs and I knew we could get the job done.”

“You see, they have a running back,” said Franklin. “I saw him on film, and I thought he was small. I saw him before the game, and he wasn’t that big. But man, he’s electric; he breaks tackles, he’s quick and he’s way bigger than I thought. The first half looked good. The second half, they must have had a great speech and some adjustments because they gave us all we could handle.”

While the defense slowed down Ramirez to 150 yards, Park posted a career-high 146 yards on 22 carries while Adhikari had 86 yards on 20 touches. Defensively, junior linebacker Nathaniel Crawford led everyone with 13 tackles and a sack while sophomore linebacker Tyler Ky had 10 tackles, Lim had nine and the interception and junior line-backer Devyn Chantha added seven tackles.

“Hey, he’s so emotional and last year, he had to wait,” said Franklin of Park. “Remember, he was behind another guy who was really, really good. So, he has been waiting for this moment, and I’ve been telling him there will be a time when we need [him]. This is when we needed him.”

“We knew they had a strong run defense, and we like to run the football,” said Johnson. “I can look at the previous games and see that they really didn’t give up very many 100-yard rushers. They were very successful in stopping the run and without having to add extra bodies to the box. We thought we could have done better than what we did.”

**SUMMARY OF ADOPTED ORDINANCE NO. 2023-613**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS, CALIFORNIA, ADDING CHAPTER 5.97 TO TITLE 5 OF THE HAWAIIAN GARDENS MUNICIPAL CODE, IMPOSING REGULATIONS ON MOBILE FOOD VENDING**

On November 14, 2023, the City Council of the City of Hawaiian Gardens adopted Ordinance No. 2023-613, setting parameters for the operation of mobile food vending operations (also called food trucks) within the City by adding Chapter 5.97 of Title 5 of the HGMC. The Ordinance provides responsible companies and individuals who engage in the operation of mobile food vending with clear and concise regulations to prevent safety, traffic, and health hazard, as well as to preserve the peace. A business license will be required to operate a mobile food vending business in Hawaiian Gardens, as well as any and all permits for mobile food vending required from the Los Angeles County Health Department. The operation of a food truck will be allowed Monday through Sunday between the hours of 8:00 am and 9:00 pm. A food truck may not park in one spot in the public right-of-way for more than two (2) hours. Similarly, a food truck cannot remain in the same place for more than one (1) hour unless the food truck is located within two hundred (200) feet of a restroom to ensure that these facilities are available to an operator and its employees.
