Deputy Peralta stated that he obtained this information during the interview on 6/6/11 as well as phone conversations with **Redacted**

The following information was discussed at the 6/6/11 meeting with Deputy Peralta and omitted from the police report:

- . A phone call from David Armenta stating that **Redacted** had just left his house
- . David Armenta threatened **Redacted** to stay away from **Redacted** at the L.A. Fitness Gym on 5/26/11. There were several witnesses present.
- . During the month of February, 2011, David Armenta aggressively stated to **Redacted** n to stay away from Maria
- . A crank call received on **Redacted** cell phone which appeared to be from a teenager stating , "Don't **Redacted** the Mayor."

When the above information was discussed with Deputy Peralta he stated that he was unable to change the report. He stated that he was instructed by his supervisor, Detective Avila, to prepare the report as such. He also stated that the report, as is, could help him obtain a restraining order.
