The inaccuracies that where noted were the following:

Redacted had previous confrontations with other men over Redacted

- Redacted is unsure if there is any other males involved with Redacted

Deputy Peralta stated that he obtained this information during the interview on 6/6/11 as well as phone conversations with Redacted

The following information was discussed at the 6/6/11 meeting with Deputy Peralta and omitted from the police report:
