



## La Palma Mayor Shanahan Delivers 'State of City Address'

La Palma Mayor Steve Shanahan delivered the communities annual "State of the City" address this past week by reminding residents, civic and business that "Building a Brighter Future for La Palma" takes effort and cooperation from everyone.

To make his point, Shanahan presented a mini flash light with a tag that read, "Here's to your bright future."

Shanahan began his comments by standing in front of an image of the "La Palma Eternal Flame" that sits in front of the civic center and told those in attendance that "the torch burns continuously since it was put there in 1972 and the past generations are those who sacrificed to keep La Palma the City of Vision."

Shanahan delivered praises to "the great partnerships" between the local government and private businesses that helped the City "stand on its feet even with the recession and loss of redevelopment dollars three years ago."

Among the partners he singled out was the California Joint Powers Insurance Authority, where the location of the address took place. The mayor stressed that the CJPIA is one of the biggest sub-district

## Cerritos Art Commissioners Attend Lavish \$8,000 Miami 'Sculpture Symposium'

Hews Media Group-Community News has confirmed through a public records request that commissioners of the Cerritos Fine Arts and Historical Commission went on a lavish trip to Miami Florida, spending over \$8,000 to attend the 2013 International Sculpture Symposium that took place between November 30 and December 4.

The commissioners who attended were Janet Beach, Dolores Iglesias, Elaine Shiohama, and Julietta Williams.

One commissioner, Nora Benzon, who is an appointee of Mayor Mark Pulido, choose not to attend.

The show was touted as "bringing together artists, collectors, curators and art enthusiasts for panel discussions, keynote addresses, optional tours, a reception, and a multi-day iron pour by the Iron Maidens, an international sculpture group."

The four stayed at first-class accommodations paying an average of nearly \$200 a night, racking up \$3,200 in total accommodation fees.

One former commissioner who did not want to be identified commented, "the Cerritos City Council is constantly saying we have no money, we have no money, why are we sending commissioners, a group that meets every other month, on trips to Miami to look for artwork?"

A deeper review of the travel reports

submitted by the four commissioners show that two of them paid a lower air fare cost of \$382, while the other two commissioner's air fares were dramatically higher at \$651 and \$743.

Further examination showed that the spouses of Williams and Iglesias attended and participated in various activities but the spouses only had to pay back the City partial costs of the trip.

Williams stayed five nights for a total of \$900, but her spouse was only charged for one night at \$180.

Iglesias stayed for four nights for a total of \$720, but her spouse was not charged.

Beach, who represents City Councilman George Ray on the Commission, also had her \$413 registration fee paid for as well as hotel room at \$190.97 per night at the Hyatt Regency Miami. Beach also turned in receipts totaling \$109.39 for meals.

Shiohama, who represents Councilman Bruce Barrows on the Commission, also spent four nights at the Hyatt Regency Miami and had the same room rate as Beach, records show and also had taxi fares of \$66 and meal expenses totaling \$164.51.

According to the City of Cerritos official website, the Commission main purpose is to "assist the City Council in administering the Art in Public Places Program."

Also stated as their priority, according

## Central Basin Water Candidate Stinnett Demoted From Commerce City Job

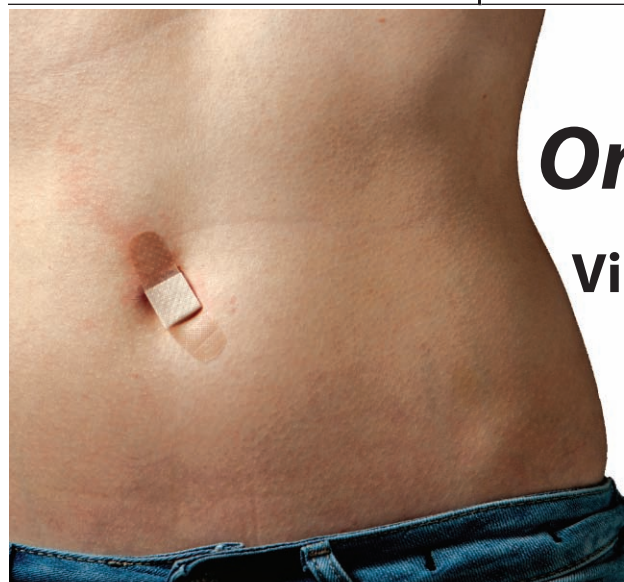
Hews Media Group-Community News has confirmed through a public records request that Jason Stinnette, who is running for election for the Division 3 Seat on the Central Basin Municipal Water District, was demoted from the position of Public Information Officer in the City of Commerce to a Media Specialist back in November 2013.

HMG-CN has reported in the past number of months that the controversial Stinnette has been attending Central Basin Board Meetings during regular working hours.

In light of that, HMG-CN requested the pay stubs for Stinnette from January 2013 to the present under the Freedom of Information Act.

The records confirm that Stinnette was paid \$41.82 per hour, earning over \$1,600 a week as the Public Information Officer

# HG Councilman Gomez Confirms Run for ABC School Board

Hawaiian Gardens City Councilman Mike Gomez told Hews Media Group-Community Newspaper that he will be a candidate for the ABC Unified School District Board of Education in November

of 2015.

Gomez made the announcement to HMG-CN during a community meeting held at Fedde Middle School last week to discuss the soon to be implemented district voting boundary elections that will take effect during the next ABC School Board election, some 18 months down the road.

Due to a recent agreement, the ABCUSD will be divided up into seven smaller individual voting blocs in order to legally meet the requirements of the California Voting Rights Act. One of the new districts will include in entire city limits of Hawaiian Gardens.

"I have enjoyed being on the Hawaiian Gardens City Council, but I now believe that I can become a strong voice for our community as an elected member of the ABC School Board," Gomez said.

Gomez was first elected to the Hawaiian Gardens City Council six years ago, and was reelected to a second four year term.

It is expected that Gomez is going to face several opponents in the 2015 campaign for ABCUSD. One rumored candidate is Sue Underwood, who is the current city clerk of Hawaiian Gardens, as well as Olga Rios who is an Ivy League educated attorney who was raised in Hawaiian Gardens.

1984: Novel or Frightening Reality?

“I can’t in good conscience allow the U.S government to destroy privacy, internet freedom and basic liberties for people around the world with this massive surveillance they’re secretly building” (Snowden).

This quote by Edward Snowden, a former NSA contractor, summarizes what many Americans are thinking about today and it is a hot topic in our society.

Luckily, the novel I chose to read and research was *1984*, by George Orwell. After reading it, I asked myself: Does technology really help or hurt us?

After carefully researching, I now have a clearer understanding of the answer.

George Orwell presents the negative side of technology through three main areas: the public, military, and the government.

The common public are influenced the most by technology. It affects both our physical and mental health. I conducted an interview with my dad, who represents the older generation. One of the questions I asked was “How many hours are you on your phone?” The result was very startling: over 70 % of the people surveyed said they were on their phone one to five hours a day. I believe that we need to go back to the basic freedoms of our country. People should not live in fear of a government constantly watching its people. This is the case in 1984; the citizens constantly live in fear of Big Brother, the totalitarian government ruling their lives.

In many ways, American society is becoming much like the society in the book. In fact, many people have called this novel prophetic because of its eerie similarities to today’s culture. Even though it is so evident and obvious, so many of Americans are oblivious to the fact that technology is negatively affecting us. Now that I have presented you with what my research has provided I will leave you with one question: What do you believe?

CERRITOS RECAP

There were 17 Part I felony crimes reported this past week, one less than the previous reporting period. Also mirroring the previous week, there were no reported robberies (very good news). The following is a breakdown of crimes by category: no robberies; three residential burglaries; two commercial/other burglaries; five vehicle burglaries; five grand thefts; and two stolen vehicles. Deputies made 14 felony arrests, 9 misdemeanor arrests, one warrant arrest, and issued 116 traffic citations. The Sheriff’s dispatch center also received 289 calls for service, down from the 324 received the previous week.

On Sunday afternoon two leg braces were stolen from a residence in the 19100 block of Jacob Avenue. It could not be determined how the suspect entered the home. On Tuesday between about 11 to 11:30 a.m. a suspect entered an unlocked rear door of a residence in the 17500 block of Mapes Avenue and stole a ring. A gray Hyundai was seen in the neighborhood and may possibly be connected to this burglary. Also on Tuesday a suspect entered an unlocked rear sliding door in the 17600 block of Alora Avenue sometime during daytime hours and stole a small amount of cash. It’s rare when cops patrolling in black and whites observe these types of crimes in progress, but alert residents often do, so remember, “If You See Something, Say

Something.”

The commercial/other burglaries involved losses from storage sheds. On Monday a lock was cut to remove four bags of recyclable items at a residence in the 18600 block of Del Rio Place. On an unknown date last week a suspect cut a lock at a unit in the commercial storage facility in the 16500 block of Valley View Avenue and stole a guitar and keyboard.

Of the five vehicle burglaries reported last week, only one occurred in a residential area. In the afternoon last Thursday a passenger window on a Hyundai was shattered in the 13400 block of Village Drive and a bag with a calculator, books, and earphones was stolen. There were no details available at this time, but another vehicle burglary was reported last Wednesday at Regional Park. During the early evening last Thursday two vehicle burglaries were reported at the school in the 12300 block of Del Amo Boulevard. # Why Dentists Use Mini Implants

By now most everyone is aware of dental implants and their place in dentistry. Titanium implants are used throughout the skeletal system to replace hips, knees, etc. In dentistry large body titanium implants are now the number one alternative for replacing extracted teeth. However, large body implant dentistry is a significant financial investment and many people choose other alternatives like fixed bridges, removable bridges, or just leaving the gaping holes unrestored (what a shame) for financial reasons.

Another class of implants is the small diameter (about a tenth of an inch) or mini implant. How and why are mini implants used in dentistry? For years these implants have been used in narrow spaces too small for standard sized implants, other anatomic restrictions, to retain removable bridges and dentures, or for cost savings. I will focus on denture appliance retention and

cost savings.

Mini implants are excellent for keeping dentures and partial dentures from flopping around in the mouth. They eliminate the need for adhesives while allowing the



denture to literally snap onto the implant attachment. The denture appliance stays put until it is removed and cleaned. Sometimes mini implants are used as temporary stabilizing anchors during prolonged dental treatments or orthodontic correction. They can be removed with quick healing of the implant site.

Mini implants are about half the cost of the larger diameter implants and can be placed by most trained dentists in one visit. Often the denture can be immediately attached to the implants. How are they placed and what should I expect afterward's?

Implants are placed after carefully planning the proposed implant sites. Al-

though one is wide awake the area is locally anesthetized (like for fillings) and pilot holes placed. The receptor area usually has no feeling after the gums are numbed. The implants are directly threaded into

place, placement angles confirmed, and the attachments placed on the implants. Since I do not peel away the gum tissue there is little soft tissue invasion sutures are not needed. The gums around the implants will be tender for a day or two until healing begins. Tylenol or Advil may be taken.

If the implants are secure enough your dentist will be able to convert your "removable denture" into a "retained denture" at the same time. This is a wonderful choice for people unable to afford fixed implant/bridgework, elderly or medically compromised individuals, and younger active denture wearers who like to scuba dive or surf.

With the help of many T.G.I. Friday's, this event is rapidly growing.

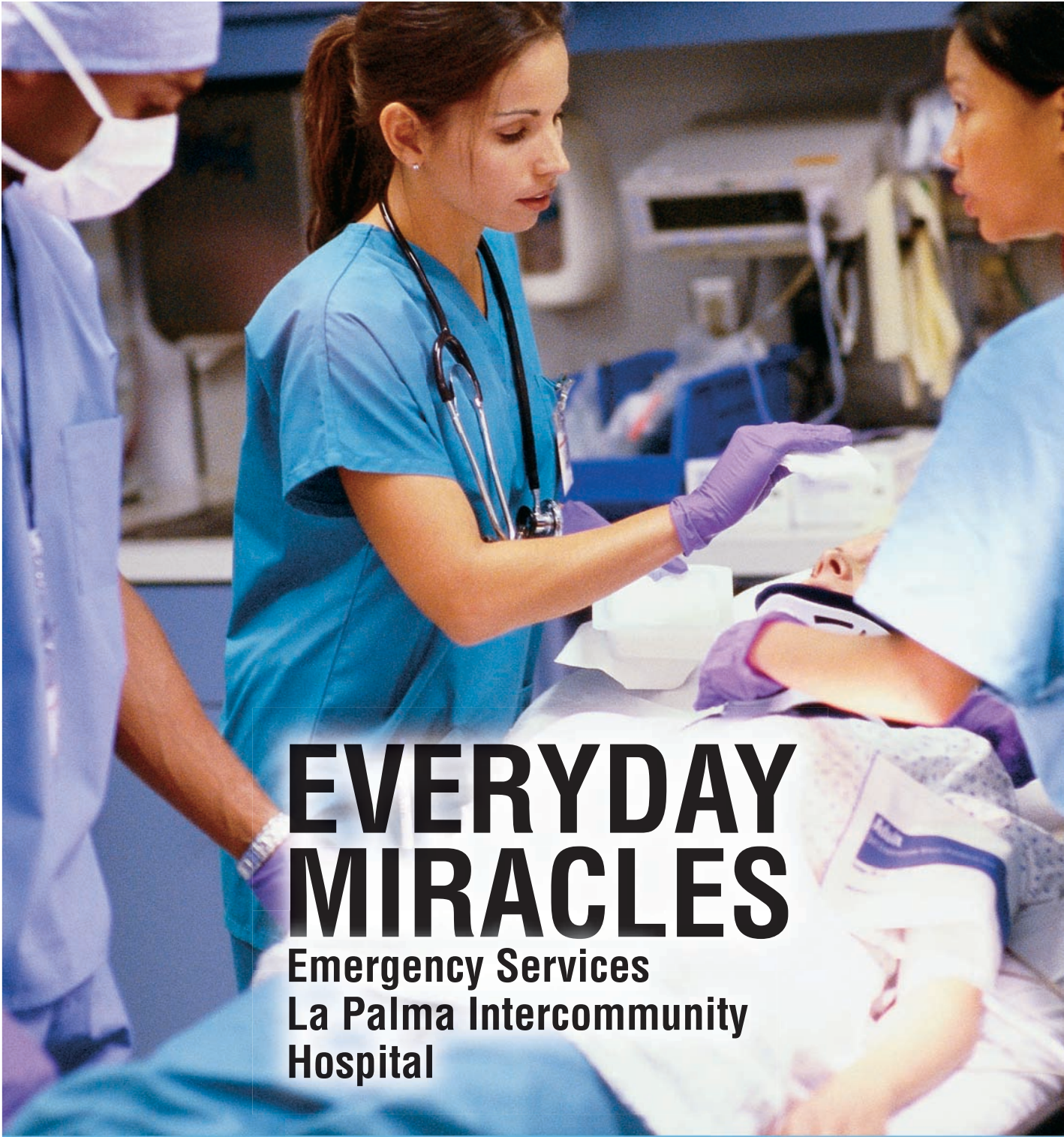

Presicci, school board member Betty Ferraro, along with district officials Edward Sussman and Stan Hanstad, G.O.O.D was born. Founded in 1989 this program offered counseling to youth, their parents and siblings to create a proactive and positive approach to removing gang activities.

“Our purpose is to promote public interest with the three-pronged approach” declared Martha Sodemani, GOOD President “We aim to educate, prevent and intervene ‘at risk’ youth, while combating gang activity in Downey. Working with the City, the DUSD and local churches we implement workshops and strategies regarding the dangers of gang involvement and drug use at the school level.”

Maintaining an annual budget of \$30k, GOOD supports free sports and recreational programs, issues scholarships and the national program for elementary children called “Kids on the Block”.

The program also sponsors a community policing program increasing onsite campus Police supervision, afterschool & summer sports programs and youth career programs providing employment for students.

An affiliate of GOOD is the renowned “10-20” Club. This organization is geared specifically to youth between the ages of 10 and 20 years of age. Founded by former major league baseball pitcher Darrell P. Jackson, of the Minnesota Twins, this outreach program provides services specifically developed to meet the needs of local school districts, courts, and probation departments in order to educate youth about the hazards of making wrong choices.

The 10-20 strives to teach positive choices and the changes that prepare for a brighter future.

GOOD led the way, with an anti bullying campaign at the beginning of the 2013-2014 school year. As part of the annual Cyber Safety Focus, DUSD designated the week of September 16th as Anti-Bullying Week. GOOD provided elementary and middle school classrooms with “No Bullying Zone” posters and prevention packets. The poster had such a positive impact on the students, that the same information will be distributed in the high schools and in each City park.

The city of Downey has originated an app for iphones entitled ‘My Downey’. “Basically you take a picture of graffiti that you might find within the city limits” says Sodemani “ and it will automatically go the city, with the precise location, and the graffiti in removed within 24 hours.” The idea behind this new addition is to discourage tagging and the claiming of gang territory

Sodemani was recently approached by a young woman at the annual GOOD luncheon. “This young lady said that 21 years ago she was in a very bad place,” says Sodemani “ she told me GOOD helped her break the cycle that she was trapped in. Today that young lady is the CEO to yet another program, helping to alleviate the corruption of our youth.”

agencies that provide liability protection to more than 120 member cities in the region, with an estimated \$200 million in investment portfolio.

“I am so pleased that this highly successful agency is actually part of our community,” Shanahan stated.

Next, he cited the La Palma Community Hospital as a platinum sponsor of the city and for being named one of the top 100 hospitals in the nation. Mayor Shanahan credited existing businesses like Chase Bank, Mobil, Walmart, Tesoros, Regus, Nitoria USA and CJ Foods for contributing greatly in the present and future revenues of the city.

“Our Economic Development Plan calls for maintaining a climate that will keep these great revenue contributors in the community. We will also be working hard to attract potential businesses,” he stressed.

Shanahan also cited smaller businesses such as a new Korean Barbecue restaurant and the operation of a long standing and very popular McDonalds.

He said that La Palma was recently approved as being one of the 60 cities who’s long-range Property Management Plans were approved by the Department of Finance after the elimination of Redevelopment Agencies in 2013.

Shanahan also revealed that although existing commercial properties constitute only 18% of the city’s total land area, they are still able to contribute 65% of the total collective revenue into the city’s coffers.

He said that Action Plan by the City Council is made up of strategies that will help ensure “a brighter future for the city.” Among these includes a new digital billboard on 91 Freeway to take effect in 2015 and that will generate \$230,000 in revenue annually for the city.

Another strategy, he said, “is to lease some of the city’s real estate properties to commercial entities.” Other strategies, according to the Mayor, are the SCORE workshops offered to would-be-entrepreneurs to encourage the entries of small scale enterprises, and the walkabouts that remove barriers to existing and future businesses in the city.

Shanahan gave due recognition to the valuable support of the City Employees that average to 10 years in residence. “Their dedication to their tasks helped see us through tough and easy times.”

Shanahan closed by saying, “La Palma’s General Plan which the City Council, due to be adopted June 30 of this year will serve as the blueprint to a bright future.”

from Jan.-Jul. 2013.

In August 2013, Stinnette received a raise to \$43.93 per hour, an increase of 5%.

“That, in and of itself is outrageous, Mr. Stinnette does nothing for the city except publishing the newsletter once per month. Stinnette is very good friends with Commerce council-members Tina Baca Del Rio, Ivan Altimirano, Lilia Leon, and Mayor Joe Aguilar, in fact he heavily supported their campaigns, it is no wonder

they turned a blind eye to his job performance,” said Mike Alvarado, a resident of Commerce.

Three months later he was demoted to Media Specialist and his salary was cut 23% to \$33.92 per hour.

“They (the council-members and Mayor) must have finally figured it out, when this newspaper brought everything to light,” Alvarado said.

Stinnette is running against current Division 3 incumbent Art Chacon in the upcoming November 2014 General Election.

HMG-CN emailed Stinnette with no response at the time of publication.

to the website is for “creating a cultural legacy for future generations through the collection and exhibition of high-quality art pieces that reflect diverse styles, chronicling history through the collection of artifacts, documents and memorabilia that will acknowledge the past and creating programs and activities that will further these goals.”

The commission has come under scrutiny by Hews Media Group-Community Newspaper in the past regarding travel practices.

In August 2010, Councilmembers Carol Chen, Bruce Barrows, and former Councilman Jim Edwards took a trip with five Fine Arts and Historical Commissioners to visit the Loveland Sculpture Show in Colorado. Like this trip to Miami, travel and hotel fees totaled over \$8,000 over just a three day period.

During that trip to Loveland, the group

dined at The Canyon Chophouse spending over \$375, including \$40 steaks, and \$38 crab cakes. On another night they spent over \$260 for dinner eating wild salmon and prime rib. Six other meals averaged \$100 each.

In May of 2010, Chen, Barrows, and Edwards traveled to Las Vegas staying at the Aria. Receipts show a \$348 dinner on May 23 and a \$379 dinner on May 24. Meals included a \$50 steak, a \$54 mixed grill plate, three \$40 filets and \$18 French fries.

In 2011, when Carol Chen was Mayor, council-members took a total of ten trips. In March, they again flew back to Washington D.C. and later traveled to Sacramento. In May, Barrows went on four trips, one to Palm Springs and three to Las Vegas, with Chen attending two. In Palm Springs, staying at the Waldorf, they dined on Foie Gras, \$40 crab legs, \$26 Dover Sole, Ahi Tartar and \$26 in desserts.

# Vasquez holds off Warren in Gahr debut, Gladiators remain in first place

The last time Destiny Vasquez pitched in a meaningful high school softball game, her then-Norwalk Lady Lancers had been blown out of the California Interscholastic Federation-Southern Section Division II playoffs. That was May 14, 2013 in an 11-0 wild card loss to Oaks Christian in which Norwalk was held hitless.

This past Tuesday, Vasquez made her Gahr debut after sitting out due to CIF-SS transfer rules and after a shaky start, she became the newest Gladiator to provide late inning dramatics. The junior second baseman and pitcher went two for four and drove in a pair of runs, including the eventual game-winner as host Gahr rallied to defeat Warren 6-5 in a key first round San Gabriel Valley League contest.

Vasquez also pitched the final three innings, yielding four hits and three runs, one of which was earned. She struck out two and threw 45 pitches as she picked up her first win since May 7, 2013. Last season, Vasquez had an earned run average of 2.64 and struck out 83 in just over 74 innings of work for Norwalk.

“I was excited to come back,” Vasquez said. “I was stoked. I’m glad I could finally help my team.”

Warren jumped out to a 2-0 lead in the top of the third as Alyssa Hanks smacked a first-pitch, two-run home run off of junior Deidra Genera. Gahr would get one of those runs back in its half of the frame when junior first baseman Celeste Gonzalez singled in junior third baseman Sabrina Quarles.

That came with the bases loaded as longtime Warren head coach Mary Starksen opted to walk both freshman third baseman

Malia Quarles and freshman catcher Alyssa Kumiyama for the second time within the first three innings. Quarles and Kumiyama are the third and fourth hitters in Gahr’s lineup followed by Gonzalez and Vasquez, who batted .516 last season at Norwalk. The No. 3-5 hitters are all batting over .470 as part as Gahr’s ‘pick your poison’ lineup.

Still, Warren pitcher Courtney Sheldon was dodging one bullet after another as the Gladiators stranded seven base runners through the first three innings.

“I think we were getting to that pitcher and we were leaving runners on base,” said Gahr head coach Shawn Quarles. “To me, when that that happens, especially with this team, it’s just a matter of time until something gets through. That’s just how the game works.”

In the bottom of the fifth and Warren up 3-1, Starksen decided to have Sheldon pitch to Malia Quarles, who hit a line drive to third base for an out. But two pitches later, Kumiyama singled to right and scored when Vasquez singled to center. That was followed by a two-run double from sophomore center fielder Alyssa Cuffia.

“I was kind of surprised but she’s a good coach and I knew they did their homework,” Shawn Quarles said of walking two of his top hitters. “I think it was a smart move and I think it paid off. When she did pitch to them, she almost lost a third baseman and Kumi got two hits that went to the fence.”

In the sixth inning with one out, Kumiyama and Gonzalez had base hits before Vasquez brought home Kumiyama to make the score 6-3. It was a key hit as the Bears would rally for two runs in the top of the seventh.

“I knew [Sheldon] was going to come in on me,” Vasquez said. “My dad kept on telling me to hit it up the middle.”

When Vasquez replaced Genera to begin the fifth, she surrendered a one-out hit to Hanks, then walked Ashley Machado. Two batters later, Hanks scored on a base hit from Neddie Gutierrez. But Vasquez retired the six of the next seven batters she faced.

“I wanted to make sure that we kind of eased her into it and I thought she did good,” Shawn Quarles said of Vasquez. “I thought Deidra did a heck of a job. There was just one pitch she left up and those were the two runs. But other than that, I think our pitching did well. It’s really good to be able to have two pitchers like that, to be able to rotate them and keep them strong and healthy.”

“I had confidence in my team,” Vasquez said. “I wasn’t nervous at all. I’m not going to give up on my team because I know they’re not going to give up on me.”

Gahr (10-8 overall, 3-0) snapped a 10-game losing to streak to Warren and won for the second time against a team with a winning record this season. The Gladiators visited Paramount on Apr. 10 and will close out the first round of league action on Thursday at Dominguez. After that, Gahr will be on a two week hiatus before visiting Warren on May 1.

“We are on a mission,” Shawn Quarles said. “We really wanted to win that Whittier Christian game [on Mar. 27]. I think at that point, the girls kind of got on the same page and really banded together. I think we wanted to take things a little bit more seriously and finish out the season strong.”

# Norwalk wakes up late with one big inning, sweeps season series with John Glenn

Norwalk was three outs away from losing to city rival John Glenn for the first time in 19 games. But the visiting Lady Lancers took advantage of a tiring freshman pitcher by sending 15 batters to the plate in the top of seventh and scoring 11 runs in a 16-10 victory.

The 26 runs are the most in this rivalry since Glenn’s last win over Norwalk (14-7) on Apr. 23, 2004. The Lady Eagles have been involved in the three highest scoring Suburban League games, all coming in the last three seasons. Last season, Cerritos beat Glenn 13-11 and the year prior, Mayfair slammed Glenn 25-3.

Glenn freshman Ashley Armas had

thrown 100 pitches through six innings but the first nine batters in the top of the seventh saw a combined 13 pitches and the onslaught began when senior left fielder Jennifer Vasquez reached on an error.

“I think the kids believed in themselves,” said Norwalk head coach Tony Aguirre. “They said, ‘we have a chance’. We were chasing five runs with three outs and we told the kids it was one batter at a time. Once one hit, then the next one hit and it just got contagious all the way around the lineup.”

After an out the next five batters all had singles before junior shortstop Jazmin Guzman’s base hit brought in a pair to make it 11-10. Later in the inning and with two outs, senior pinch hitter Erica Perez had a

bases-loaded triple down the left field line to put the game out of reach. Perez was one of three batters to have two hits in the inning. All three of those hitters were the bottom three in the lineup.

“She just bombed that thing,” Aguirre said. “She laid right in that thing and it was gone. She came off the bench and produced.”

“Their bottom [part] of the lineup was making hits that they shouldn’t be hitting,” said Glenn head coach Albert Enriquez. “We focused on [their] one, three and five. That’s all they had. They had Jazmin, Jenny and [senior designated player] Sammy [Lujan].”

scored three runs in the top of the first but the Lady Eagles, minus sophomore pitcher Destiny Enriquez who has a fractured bone on the left side of her left foot, bounced back with five runs in the bottom of the second. Glenn batted around and got key two-out doubles from Armas and junior second baseman Jackie Mojica. The hosts would add one more run in the next inning before Norwalk crept back with single tallies in the fourth and fifth innings.

But Glenn seemingly thought it had wrapped up the game with four runs in the bottom of the fifth, again batting around. The big blow was a bases-loaded, two-out double from Armas, who went three for five. Three of those four runs came off of freshman Sam Navarette, the third Norwalk pitcher used through the first five innings. Senior Amanda Benes, who started but didn't last two innings, was brought back

in to finish the game. Sophomore Serena Nicolas pitched two and a third innings before Aguirre replaced her with Navarette.

"We need to work on pitching a little more," Aguirre said. "Our pitchers aren't hitting their spots that we need them to hit. That's another thing that's hurting us."

Mojica and senior shortstop Valeria Ortega each went two for four and drove in a pair of runs as the Lady Eagles, who bounced back to slam Artesia 12-1 this past Wednesday, are now 6-8 overall, 1-2 in league. Albert Enriquez had high hopes for his team this season and thought his team could make a serious run at a playoff spot. But with his daughter sidelined for the rest of the season, he now has to alter his defensive lineup.

"We didn't expect losing our No. 1 [pitcher]," he said. "We have our catcher playing third base. I honestly believe with

Destiny here...we do have a better chance. [Our] team can hit."

"Offensively [we] came in and did what we've been doing all season long," he added. "If we played like this [on Wednesday], we beat them on Wednesday also. It's the nature of the beast."

Glenn pounded out a season-high 18 hits as six players had at least two hits. Junior right fielder Paola Martinez went three for five while Benes went two for two as Norwalk's record is somewhat puzzling to Aguirre. Of the 52 runs Norwalk has scored this season, 25 have come either in the sixth or seventh innings.

On Mar. 26, Norwalk was trailing Mayfair 9-1 entering the bottom of the fourth before scoring four runs, then another three in the sixth before losing 10-9. Two days later, Norwalk saw Mayfair build a 10-3 lead heading into the seventh before the

Lady Lancers scored three runs.

"I would say it's misleading because we've had opportunities in games to win and we keep doing this last minute thing, scoring five or six or seven runs at the end when we should be taking care of it earlier," Aguirre said of his team's record. "But in the last three or four games, we keep coming from behind."

"I think we can build off of this because the girls know they believe in themselves and they can score when we have to," Aguirre continued. "But we shouldn't get that far in the hole. We have to take from here and go forward."

Glenn will host Artesia today, then face La Mirada next week while Norwalk travels to Bellflower today before playing Artesia next week.

# GLENN BASEBALL CONTINUES TO ROLL, SOARS PAST ARTESIA

Victor Sanchez is making a strong case to become one of John Glenn's best baseball pitchers of all-time, if not the best. The junior left-handed hurler worked five innings and yielded only a first inning run as the Eagles cruised past host Artesia 9-1 this past Wednesday.

Sanchez improved to 5-0 and lowered his earned run average to 0.66. As a team, the Eagles increased their mark to 10-2 overall, 3-0 in the Suburban League. Glenn is off to its best league start since 2008 when it swept Norwalk and Artesia to begin the season. Ironically, Glenn has opened the 2014 league slate with those two schools.

Glenn tied the game in the top of the second on a groundout from senior designated hitter Faustino Colon. In the fourth,

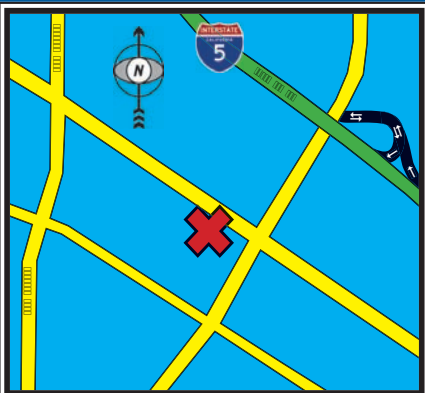
