9 //// I, Francis Bradley, ID# 3703, do on oath make complaint, say and depose the following on this
10 22nd day of July, 2014: that I am a peace officer employed by the San Diego Police Department
11 (SDPD) for over twenty-nine years. I have been assigned to Sex Crimes Investigations Unit for two
12 years. During the course of my duties, I have learned the following information based upon my
13 discussions with the named witnesses, John Doe, (A known and identified victim whose name has
14 been withheld to protect his identity), witness Elizabeth Ducote and by having spoken to and read
15 the reports of SDPD Officers Sara Schnider #6669 and Phillip Konz #5240. All references to dates
16 refer to the current calendar year unless otherwise stated. All events referred to herein occurred in
17 San Diego County unless otherwise stated.

18 //// On April 4, 2014. Officer Schnider was dispatched to investigate a possible sexual assault of a
19 twenty-six year old male at the Keating Hotel located at 432 F Street in the city of San Diego,
20 California. The reporting party, John Doe reported he came to San Diego with a friend known to
21 him as Skyy Fisher. The previous night they shared a room together at the Keating Hotel room
22 number 3-C. Each had a separate bed in the room. Doe stated he is not gay and believed Fisher
23 was also heterosexual male. Doe woke up in the morning at approximately 0730 hours and found
24 Fisher orally copulating his erect penis. Before Doe could react, Fisher stopped orally copulating
25 Doe, jumped into his bed and gave the appearance he was sleeping. Doe noticed he was missing his
26 underwear and shorts he had wore to bed. Doe looked around the room and located his shorts but
27 not his underwear. Doe was angry, put on his shorts and left the room. Doe went to the lobby and

1 got his car from the valet. Fisher came to the lobby and they argued. When the valet brought Doe's
2 car up they both got into the car. Doe punched Fisher when he was sitting in the car. Fisher got out
3 of the car and Doe drove off with Fisher chasing him down the street. Witness Elizabeth Ducote
4 stated she saw Fisher running in the street and it appeared he was chasing after Doe and Doe's car
5 as Doe drove away.

6 / / / / Doe called the San Diego Police Department and reported the crime and met with SDPD
7 Officer Schnider. Doe submitted to a Sexual Assault Response Team (SART) exam and evidence
8 was collected by a SART nurse.

9 / / / /On April 18, 2014, I spoke to Doe and showed him a Department of Motor Vehicles
10 photograph of Skyy Fisher. Doe readily identified the photograph of Fisher as the person he knew
11 as Skyy Fisher and the person who sexually assaulted him in the hotel room of the Keating Hotel on
12 April 5th. During our meeting, Fisher called Doe and the phone call was recorded. During the
13 phone call Fisher apologized to Doe for what he did to him. During the phone call Fisher admitted
14 to Doe he hid Doe's underwear as a prank. During the phone call Fisher admitted to Doe he didn't
15 know why he orally copulated him.

16 / / / /On May 21, 2014, SDPD Laboratory Criminalist 2 Dave Cornacchi #8815 conducted
17 Deoxyribonucleic acid (commonly known as DNA) testing of the evidence collected in Doe's
18 SART kit and determined there was male DNA on Doe's penile swab not related to Doe.

19 / / / /On May 27, 2014, I executed a search warrant (number 46874) at Skyy Fisher's residence
20 located at 2201 North Locus Avenue in Compton, California. At the residence I collected a mouth
21 swab from Skyy Fisher and later impounded the swab into the San Diego Police Headquarters
22 Property room. On June 10, 2014 Criminalist Cornacchi, an expert on DNA confirmed the DNA
23 collected on Doe's penile swab matched the DNA I collected from Skyy Fisher.

8 named defendant for the specific crime of violations of Penal Code section 288A(F)(1) P.C. Oral
