Candidates File Election Papers in Commerce and La Mirada

Three seats open in La Mirada, two in Commerce.

Seven candidates have filed for three open La Mirada City Council seats for the upcoming March 3, 2015 election, according to Anne Haraskin City Clerk for the city of La Mirada.

Six candidates have filed for two open Commerce City Council seats, according to the Commerce City Clerk.

In La Mirada, incumbents Stephen De Ruse and Larry Mowles will attempt to retain their current council seats with the third seat opening as a result of councilman Steve Jones' retiring.

The five other La Mirada candidates are Tony Aiello, Edward Eng, Dale Nowicki, Michael Saenz and John Sarega.

In Commerce, incumbent Denise Robles will attempt to retain her seat, with another seat opening due to Councilmember Joe Aguilar's retirement.

The five other Commerce candidates are Hugo Argumedo, John Diaz, Oralia Rebollo, Sonia Rodriguez, and John Soria

HMG-CN reached out to all candidates asking for bio's this week, with some, but not all, responding to the dead-line request.

In Commerce, the well-known and popular former Commerce councilman Hugo Argumedo and Councilwoman Denise Robles responded, while La Mirada's Aiello, De Ruse, Mowles, Nowicki and Saenz sent bio's via email.

The KNX 1070 Newsradio On Your Corner Toy Drive that took place this past Friday Dec. 12 at Mimi's Café at the Cerritos Towne Center netted, according to KNX, the largest number of toys donated in four years.

This despite torrential rain and the broadcast time frame cut by four hours.

Listeners were invited to a live broadcast at Mimi's and they generously dropped off a few hundred toys for KNX's effort in conjunction with sister TV stations, CBS 2 and KCAL 9.

The toys will be distributed locally to less fortunate children by the California Highway Patrol.

Los Cerritos Community News was the exclusive print media sponsor of the event and published advertising four weeks prior to the toy drive to help drive donations to the event.

It appears, by all accounts, the promotional campaign was a great success.

The event started at 1 p.m., not its usual 5 a.m. because of the rainy weather in the area.

KNX completely took over the back room at Mimi's setting up a mini radio station where KNX anchors Jim Thornton and Diane Thompson broadcasted from 2-7 p.m.

The KNX Business Hour, hosted by Frank Mottek, broadcasted from 1-2 p.m.

Residents in the area enjoyed walking in the back room to give their gifts to

KNX representatives and watch Thornton and Thompson broadcast the latest news and events.

Howard Freeman, Marketing Director at KNX told LCCN, "our KNX listeners in the Cerritos and Artesia areas really came through for kids this holiday season. With the support of Los Cerritos Community News, Walgreens and Mimi's Café in the Towne Center we collected a few hundred toys for the California Highway Patrol's 'CHiPs For Kids' program. Judge Issues Injunction Against Marijuana Dispensary in Bellflower

Judge Margaret Bernal of the Los Angeles County Superior Court issued a Preliminary Injunction restricting the operation of a marijuana dispensary known as the Bellflower Patient Group that has been operating at 16203 Clark Avenue, according to a release sent out by the Bellflower City Manager December 11.

The press release further states, "the Preliminary Injunction prohibits Bell-flower Patient Group, its principal, and the property owner, from causing or allowing the operation of any dispensary, cooperative or collective or any other unlicensed use at the location. Specifically, the order prohibits selling, serving, storing, keeping, or giving away of marijuana at the property or at any other property under the Defendant's control."

The Bellflower Municipal Code does







Student musicians from three Norwalk-La Mirada Unified School District high schools plan to practice day and night through the holidays in preparation for the 2015 Tournament of Roses Pasadena City College Parade Honor Band.

The band, composed of Pasadena City College's Lancer Marching Band and 200 gifted high-school musicians from around the state, has marched in the New Year's Day parade since 1930.

"The Tournament of Roses Parade is a time-honored tradition that really makes New Year's Day special," said Interim Superintendent Ginger Shattuck. "The selection of our students really speaks to the caliber of our performing arts programs here in Norwalk-La Mirada Unified."

Chosen from the Norwalk-La Mirada School District this year were:

Norwalk High School: Jennifer Sanchez, junior, on alto saxophone, John Glenn High: Josie Vazquez, senior, on tenor drums, La Mirada High: Jacob Rosales, senior, on tuba; Sean Parra, junior, on snare drum; Robert Stauffer, junior, on bass drum; Cristina Navarrette, sophomore, Flag Line Pageantry

The NLMUSD students have played their instruments for at least five years and have been taking music instruction at their respective schools, as well as playing in their high schools' bands and other music programs, according to their instructors.

"These students will practice for this specific experience for no less than 75 hours, and will have marched about 40 miles before the six miles that matter on New Year's Day," said Geena Biondi, director of music for La Mirada High School — which has four students in the honor band — and a veteran of the PCC Official Tournament of Roses Honor Band.

Frank Hinojoz, Band Director at John Glenn High School has worked with student Josie Vasquez for two years, said. "I am very proud of her and the honor she has earned." Besides hours of practice and miles of marching before the big day, student musicians will also attend fittings for uniforms and shoes and will perform with the band at Disneyland on Dec. 27, according to the PCC Tournament of Roses Honor Band organization.

To join the honor band, students must compete against hundreds of high school musicians, said Norwalk High School band director Doris Doyon whose student, Jennifer Sanchez will play with the band.

"Jennifer was one of about 40 saxes that auditioned. I am extremely proud of her for doing this. I worked with her a bit on her audition but she largely took initiative on her own."



CRIME SUMMARIES Dec. 8-14, 2014

EDITOR'S NOTE: The crime summaries are sent in to HMG-CN by the respective cities, HMG-CN publishes the summaries as a public service.

Cerritos

There were 15 Part I felony crimes reported in Cerritos this past reporting period, a decrease of four over the previous week. The following is a breakdown of crimes by category: one robbery; one aggravated assault (occurred in October); two residential burglaries; five commercial/other burglaries (one was an attempt); two grand thefts (both occurred in November); four vehicle burglaries; and no auto thefts reported. Deputies made three felony arrests, seven misdemeanor arrests, and issued 101 traffic citations. The Sheriff's dispatch center also received a total of 339 calls for service, a substantial increase over this year's weekly average of 267 calls.

Robbery:

Rodriguez last statement as Mayor was "I just want to be remembered as a man who did a good job."





Towne Center Dome Building Getting Facelift

As of a few weeks ago, residents in and around Cerritos, have noticed scaffolding around the dome building in the Cerritos Towne Center. The building, owned by the law corporation Atkinson, Andelson, Loyda, Ruud & Romo, was built less than five years ago and is a noticeable structure among those in the surrounding area.

job, a process that includes grinding off the old paint, applying primer, and painting over the primer with a topcoat of new paint

The job does not include repairing the actual the dome structure.

The repainting process will only be done on the rings and beams supporting the dome and the two concentric walls surrounding it, excluding the top part of the dome, where the scaffolding does not reach the thin arches.

"The process is regular," explains Teodoro Pandoro-Magana, the Project Superintendent, "when you paint on metals or panels, after four years or six

The dome is made with interconnecting arches held together with several rings and supporting beams. The dome has two walls around its base, with one larger in radius than the other. All of these are almost entirely made with metal.

Recently, the paint on the metal has started to peel and form bubbles on the surface after the years of exposure, prompting the scaffolding and repair.

The property owners hired Century Building Solutions to do the repainting

years, the paint will start to have bubbles appearing on the surface. It happens with iron, steel, everything. Our job is to scratch off all the old paint, and after that, we're going to put on a layer of primer, and then a topcoat."

The project was started almost a month ago, though progress was slowed by rain and unfavorable conditions in the last week. Without any further delay, the job is expected to be done by Sunday, December 20th.





Gahr dominates Cerritos again behind Carlyle brothers, Harris

The sequel to the Cerritos-Gahr boys basketball showing was pretty much similar to part one, which was played on Dec. 6 in the championship game of the annual Cerritos-Gahr Tournament. Gahr blasted the Dons 81-42 in that game and last Friday night, the two fierce city rivals met again in their annual tilt which always falls six days after their own tournament.

Host Gahr went on a 12-0 run over a three-minute span in the opening quarter and never looked back in a 91-58 victory. It marked the eighth straight time the Gladiators had defeated the Dons with two of those games coming in the finals of the Cerritos-Gahr Tournament. Since 1999, Gahr now owns a 9-7 regular season, nontournament record against Cerritos.

"We were just trying to have fun," said Gahr senior guard Gregory Carlyle. "We knew it was a rivalry game and we wanted to bring energy to the game and just bring it to them. Playing a team twice, the second time after beating them the first time, we knew that [Cerritos] would come out stronger. We tried to bring the same intensity and try to do it again."

Gahr was leading 5-4 just 67 seconds into the game when it went on its 12-0 run before the Dons (3-2) scored the next five points. But a basket from senior point guard Malik Smith and a steal and bucket from junior guard Justin Smith closed out the first quarter as Gahr was up 21-9. A

pair of free throws from Cerritos junior guard Evan Leonard bought the Dons to within eight points again at 25-17 with 5:35 left in the half. But the Gladiators pulled away and had a double-digit lead the remainder of the game.

Part of the reason for Gahr building a 47-27 halftime lead was its perimeter shooting. Senior point guard Jeremy Carlyle sank four downtown shots in the first half while his brother Gregory added three more. On top of that, senior forward Darrell Harris was true on three three-pointers in the half. As a team, the Gladiators were 16 of 35 from beyond the arc.

"We just had to keep being relentless because we knew if we did what we do, it would work," Gregory Carlyle said. "We just kept playing and doing the same things and not let up.'

The Gladiators (5-0) were up 54-31 following a three-point play from sophomore forward Marvin Bragg before Cerritos went on the first of two 6-0 spurts in the second half. But in the end, it was just too much Gahr, which ended the third quarter on a 10-0 run and ended the game on a 14-2 run.

Gregory Carlyle led everyone with 21 points and was eight of 16 from the field. His brother and Harris each added 17 points while Bragg pitched in with 14 points. Harris also led Gahr with nine rebounds and Gregory Carlyle had five assists along with four of the team's 13

Leonard led Cerritos with 19 points while senior guard Andrew Bui added 14 points. Both teams began the prestigious 20-team North Orange County Championships this past Tuesday night with pool play action at Servite and Sonora High Schools. Cerritos faced JSerra and then

Cerritos girls soccer has no problems with Gahr, remains hot to begin season

What a difference a season makes. The Cerritos girls soccer team opened up last season losing six of its first seven games with a tie sprinkled in there. The Lady Dons fielded a squad with just two seniors and had a young squad that was riddled with injuries.

But now, Cerritos has come full circle and is letting many out there know that this season's team is ready to make some noise. Cerritos blanked Gahr 5-0 this past Monday afternoon to improve to 5-0-1, its best start since going 6-0-1 just two seasons ago. In addition, the Lady Dons have already scored 24 goals while posting four shutouts. Last season, Cerritos found the back of the net 24 times and only three players scored those 24 goals during a 4-16-1 campaign.

"Well, we have new girls and some of the new girls who were injured last year, learned what we want even though they were on the bench," said Cerritos head coach Tony Montalvo of the quick turnaround. "I think that's what is making the difference."

One of those injured players from last year is already making a huge impact and could threaten some school records by the time this season is over, or when her high school career is done. Sophomore forward Tobechi Udeh, who tore her right meniscus in mid August of 2013 and sat out all of last season, scored in the first minute and again in the seventh minute on a pass from

sophomore midfielder Lauryn Bautista. Udeh has already scored 13 goals and is only beginning to get her feet wet as she becomes one of the best players to have come through the program.

"I think she was a player we missed last year because we didn't have a good striker last year,"



M o n - talvo said. "[Senior forward Erika] Lizarraga and [sophomore defender Danica] Castro are the other two players who are incorporating into the team and making a difference on the team this year."

Cerritos had several opportunities to blow the game wide open in the first half, taking eight shots on goal but missing about three or four because players would hesitate once they approached Gahr sophomore goalkeeper Destiny Corletto. The Lady Dons led 2-0 at the break and didn't score again until the

67th minute when senior midfielder Juliana Sierra, just called up from the junior varsity team, scored her first goal of the season. Three minutes later, she made it 4-0 on one of six shots the visitors took on Corletto in the second half.

The final goal came from Lizarraga, who notched her second of the season. She was one of the three players who scored last season.

"I think the girls were overconfident in the first half," Montalvo said.

"Since they scored two early goals, they thought they could go 10-0 in the first half and that really concerned me a lot. So I talked to them in the second half and told them exactly what I wanted."

After getting washed out last Saturday in the Best in the West Winter Soccer Classic, the Lady Dons will get pool play action started against Bell Gardens

and San Gabriel on Saturday from Santa Fe High School. The tournament will resume on Monday before the team takes the rest of the month off.

As for Gahr (0-3), who is going through its eighth different head coach since last going to the playoffs following the 2002-2003 season, it visited El Rancho this past Wednesday, weather permitting, for its last scheduled game of the month.

"I'm pretty sure [the Suburban League] knows what we're doing right now and they're going to be ready for us," Montalvo said. "But I want to do my job and I want the girls to do their job."
