Vasquez is a "party plaintiff" in the whistleblower case.

In addition, CB sources told HMG-CN that the FPPC and investigators are looking into whether Vasquez actually lived

# **Bellflower Adopts 45-Day Moratorium on Massage Parlors**

# **NLMUSD Board to Review Projects for First Round** of Bond Issuance

The Board of Education, during a study session on Jan. 15, directed staff to prepare three to four proposals that package potential projects with the District's first Measure G bond issuance this summer, which will range between \$52 million and \$70 million.

The public meeting provided board members with an overview of the District's \$600 million Facilities Master Plan, a long-range planning tool outlining facilities needs, the required next steps in regard to state laws, bond financing and a list of potential first projects.

Staff will provide the detailed proposals at a public study session Feb. 2.

"The Facilities Master Plan was never meant to prioritize projects, but to simply provide insight into our needs for updating, renovating and revitalizing our facilities," said NLMUSD Interim Superintendent Ginger Shattuck. "When we return for the study session next month, we'll provide potential options and plans for the first round of projects. The Board of Education will make the ultimate decision on what happens next."

Voters approved Measure G in No-

vember so NLMUSD could renovate, repair and update its schools.

During the Jan. 15 meeting, District staff presented a list of potential first projects that included: security fencing; roof replacement; playfield/playground upgrades; air conditioning systems in school offices and multipurpose buildings; furniture replacement; drought-resistant landscaping; lunch shelters; and digital marquees. In addition, staff members presented options for construction of high school stadiums and performance/media centers.

Board members asked staff to return with proposals that cluster projects ac-



cording to the following: projects that will fit within the funding scope for the first issuance; projects that are needed most; projects that logically should happen first to set up for future projects; projects requested by the community and staff; and projects related to technology.

"There are a lot of needs in terms of

renovation and new construction at our schools and sites across the District," said NLMUSD Board of Education President Jesse Urquidi. "Now comes the challenging task of deciding what happens first. At the end of the day, it's our priority to ensure that we get the most for every dollar so that we can provide students with learning environments that are safe and engaging."

The next bond study session will take place from 5 to 6 p.m. Feb. 2. If needed, the Board of Education will hold a second discussion at 5 p.m. Feb. 23.



TRANSIENT OCCUPANCY TAX (HOTEL BED TAX)

**Proposed Adjustment to Transient Occupancy Tax** (Hotel Bed Tax)

A measure has been placed on the March 3, 2015 Cerritos General Municipal Election ballot asking voters if the Transient Occupancy Tax in Cerritos should be increased from 6 percent to 12 percent.

What is the Transient Occupancy Tax (Hotel Bed Tax)? The Transient Occupancy Tax (hotel bed tax) is charged on the cost of guest rooms in hotels such as the Sheraton Cerritos Hotel. Only people staying at a hotel in Cerritos would pay the tax. The hotel bed tax increase would assist in the recovery of expenses for providing general City services, including Sheriff, library and park services. Based upon the amount of hotel bed tax collected in fiscal year 2013-2014, the proposed increase to 12 percent would bring the City's total bed tax revenue to an estimated \$914,200 a year.

Stewart's mission was to create and maintain efficient and economical programs that support the City.

"Bellflower Boulevard is becoming a success," states Stewart, "I spoke to the owner of Johnny Rebs last week and he is grossing almost a million dollars a year." The restaurant is such a success that a second restaurant will be opened in Huntington Beach. The newly opened Fronks restaurant is bringing just as much revenue. Stewart explains ,"both of these places have been successful additions to

the City."

#### "Obviously there is a process," notes Stewart, "but we working on a couple of new sites, and will be approaching Council in the next few weeks requesting proposal to fill some of the vacant buildings on the Boulevard."

One of the roles of a City Manager is to maintain viability of the City organization supporting morale and productivity while balancing personnel, departmental, organizational, and community demands with the City Mission.

Stewart has been able to do just that, "When I interviewed for this position, I noticed a disconnection between the counter, the public and how they interacted with one another," Stewart explains "We have brought that into alignment, and the city is well on its way to bringing into compliance many of our properties and making sure our zoning codes match what is happening within the City, and I am really proud of that."

The City Manager works under the broad policy guidance of the City Council, performing high level administrative, technical and professional work in directing and supervising the administration of the City.

With the addition of the soon to open Golden Corral, Stewart hopes to bring in regional and national attention to Bellflower Boulevard.

by purchasing 17' of right of way allowing for the widening of the Boulevard from one lane into two.

Stewart states, "through a perfect storm of circumstances we were able to obtain the funding for Public Works to widen the street. And it helped fund the financial gap between the developer and the property owners."

The Golden Corral restaurant will generate 1,600 trips a day from customers, making it a target spot for Bellflower and surrounding areas.

A new LA County Fire Museum will break ground later this year with the completion expected in 2016.

New condominiums, the addition of mixed use establishment's, aspirations for the Railway Museum and the addition of two more movie nights and one more street faire will make Bellflower a point of destination.

Stewart is most proud of being able to put Bellflower on equal footing with the surrounding cities with the quality of development.

"I feel good that our city is in the game now. We have reestablished the Boulevard," Stewart notes "I can't take credit for all the improvements -I give that to my predecessor, but I have been able to harness the resources to move a bit faster"

# **End of Year Crime Statistics**

Here is some very good news on the crime fighting front as 2014 comes to an end.

There was an almost 16 percent reduction in the nine categories of Part I crime tracked by the Cerritos Community Safety Division, including a nice decline in residential burglaries.

As regular readers of this weekly summary know, the Cerritos Sheriff Station deputies have made reducing residential burglaries their primary crime fighting focus over the past two years.

Deputies, aided by alert residents who have been willing to call when they see suspicious activity in their neighborhoods, made several good arrests of professional thieves who make their living preying on bedroom communities like Cerritos.

In 2012 there were 285 reported residential burglaries in our City and this past year the total was 183, a reduction of about 36 percent in two years.

# ACADEMY LEAGUE BASKETBALL Whitney boys put a scare in league frontrunner, fade in second half

If anything, the Whitney boys basketball team put league-leading Crean Lutheran on upset alert in the first half of its Academy League tilt last Saturday. The host Wildcats led throughout most of the first quarter and were down by no more than four points in the second quarter.

But Whitney struggled in the second half, hitting on only six field goals during that time and eventually lost to the Saints 60-44. Crean Lutheran entered the game as the ninth-ranked team in the California Interscholastic Federation-Southern Section Division IV-A poll as selected by its advisory committee.

"After our first opening week, we had two lousy games against Oxford Academy and St. Margaret's and since then, all I've been preaching is don't worry about the score," said Whitney head coach Ruben Guerrero. "Just play hard and be consistent at playing hard from beginning to the very end. And we're on the track for that, but it seems the third quarter is lousy for us right now."

The Wildcats (5-11 overall, 0-4 in league) had lost to Oxford Academy by 11 points before losing their next two league games by an average of 24.5 points. But against Crean Lutheran, which has just one loss on the season, the hosts led by four points twice within the first 77 seconds and again with 2:20 left in the first quarter on a bucket from freshman guard Heaven Flores.

The Saints took their first lead of the game as time was winding down in the stanza when Brett Kittelsen scored the last of his nine points through the first eight minutes. Although both teams combined to score 17 points in the second quarter, sophomore guard Ben Barnett tied the game at 24-24 with 46.1 seconds remaining. Seven seconds later, Tim Ghita gave Crean Lutheran a lead it would not relinquish the rest of the way.

In fact, the Saints began the second half with five straight points and after Flores connected on a free throw, the visitors from Irvine went on a 6-0 run to lead by 12 at 37-25.

"I told them when we came out from halftime. I don't care what the score is right now," Guerrero said. "To me it's 0-0 and [they] better start off the way we did in the first quarter. The energy was flat from the beginning and I called a quick timeout to try to get them going. It took them a little long to get going and eventually they picked it up. But it was too late."

Senior forward David Lu led Whitney with a career-high 10 points while senior guard Antony Thomas added eight points and grabbed nine rebounds. Lu became the 10th different player to reach double figures in scoring in a game this season as well as the 10th different player to lead his team in scoring in a game.

The Wildcats visited Brethren Christian this past Wednesday and will travel to Calvary Chapel Downey tonight to wrap up the first round of league action. Whitney will host Oxford Academy on Tuesday. Guerrero said the way his team played in the first half should send some message to the league as to not sleep on Whitney.

"Hopefully it says something to them," Guerrero said. "Hopefully it lets them know that if they're going to play us, it's going to be work. If they're going to beat us, it's not going to be easy."

Prior to the game, the Lady Wildcats were also in a close game with the Saints

throughout the first half. But Whitney managed only five points in the second

half and succumbed to Crean Lutheran 33-16, giving the Saints their first ever victory over Whitney. The 16 points are the second fewest Whitney (6-8, 2-2) has scored this season but the team has held its first four league opponents to less than 40 points.

Whitney never led in the game but kept the game close early on as the Saints led by no more than three points until Jordan Bishop scored on an offensive rebound with 1:09 left in the half. That was followed by a steal and basket from Annalynn Benson.

The Lady Wildcats, which had won 42 straight league games before falling to Sage Hill last Thursday, scored one point in the third quarter and that didn't come until the 2:13 mark. At that time, Crean Lutheran was leading 20-12.

Whitney, which turned the ball over 27 times leading to 17 steals from Crean Lutheran, was led by senior Shiraya Thompson's six points. It marked the first time since Dec. 17 that sophomore Nicole Lee, the team's leading scorer this season, did not lead her team in that department. Lee did grab five rebounds and have three steals while senior Tushara Govind had five thefts.

# OLYMPIC LEAGUE BASKETBALL Valley Christian boys rally from huge deficit but fall short against Village Christian

It was looking pretty bleak for the Valley Christian boys basketball team early in the second quarter against Village Christian this past Tuesday night. Valley Chris-

tian was trailing the ninth-ranked team in the California Interscholastic Federation-Southern Section Division I-AA poll by 17 points.

But, three of Village Christian's starters all picked up their third personal foul before halftime and were relegated to becoming cheerleaders for the final half of the second quarter. That's when Valley Christian made a courageous rally, which came up short in the end, 69-67. Valley Christian, which didn't take its first lead until the fourth quarter even led by three points with 1:49 left to play. But Village Christian went on an 8-3 run to thwart any upset bid.

"You have two good teams and both teams are going to make runs," said Valley Christian head coach Bryan Branderhorst. "We talked about that, even yesterday. There are going to be moments of adversity and things and you have to bounce back from those things. When you have a lot of guys who can make plays, there are going to be momentum swings.'

Valley Christian trailed by six points after the first quarter but also missed half a dozen free throws, which would be a major theme in the game. Village Christian then reeled off the first nine points of the second quarter to lead 30-15. But the

fouls were beginning to pile up for University of Southern California-signee Bennie Boatwright (game-high 20 points), Clifton Powell (14 points in the first quarter) and Kahlil Simplis (11 points).

Valley Christian would go on a 17-0 run with those three on the bench and just like that, the game was tied at 34-34 after junior power forward Vaj Rice connected on a free throw with 20.3 seconds left in the first half.

But Village Christian opened the second half on an 8-0 run and led by half a dozen points before the hosts closed out the final 1:47 of the third quarter with a nifty 9-3 run.

"The thing is, they don't drop off a lot in talent," Branderhorst said of Village Christian. "So, they were still coming. Certainly that was an important part in the game. It's unfortunate we could never get any of those guys on the bench for the fifth foul. But they play a lot of zone and try to hide those guys. And so it's hard to really pick on those matchups."

In this game of runs, it was Valley Christian's turn to make another one early in the fourth quarter and when Rice scored with 5:42 left in the contest, he had given his team its first lead at 55-53. That was followed by an offensive rebound and basket from junior power forward Ronald Massey, who was fouled with 5:01 left. Although he missed the free throw, a technical foul was called on Chris Love and junior point guard Stedman Bryant made both free throws. Rice ended the scoring spree with another basket to put Valley Christian up 61-53 with 4:52 remaining.

But Valley Christian went cold from the field the remainder of the game, missing its next four shots before sophomore forward Aaron Purnell drilled a three-pointer at the buzzer.

Rice came off the bench to score a team-high 17 points and grab seven rebounds, five on the offensive side. Bryant added 15 points while Purnell pitched in with 11 points. But Valley Christian was 18 of 31 from the charity stripe while the visitors from Sun Valley missed four free throws.

"It's a big deal; it's a really big deal," Branderhorst said. "We just try to tell the guys to relax and knock them down. But certainly we left a lot of points out on the free throw line tonight and we missed a couple of bunnies around the rim. We just have to keep getting better."

Valley Christian, ranked fourth in Divi-

"We still believe that playing well wins and playing well matters," Branderhorst said. "It's not about adding up your talent. If that was the case, we wouldn't even play the game. Earlier, the Valley Christian girls found themselves playing catch-up for most of its game but faded really fast in the fourth quarter and lost to Village Christian 41-31. The setback puts Valley Christian, which has now lost two in a row, at 10-10 overall, 1-2 in league.

The Cerritos boys and girls basketball teams will be off today from the Suburban League and while the respective coaches will do some scouting, they'll also enjoy life at the top of the circuit. The boys had no problems with host Artesia in a 63-43 win this past Wednesday night while the girls cruised to another win of over 20 points.

The boys limited the Pioneers to three points in the second quarter as they led 31-12 at halftime behind the stellar play of senior guard Henry Buycks and junior guards Evan Leonard and Brandon Yoon, all of whom combined for 22 first half points.

Artesia tried to make it close in the third quarter with the scoring of senior post Dontae Smith, who scored eight of his 12 points in the stanza, and junior guard Semaje Chatman, who grabbed five of his eight rebounds in the quarter.

But the Dons (11-10 overall, 5-1 in league) went on an 11-0 run in the middle of the fourth quarter to put the game away. Leonard finished with 21 points, six rebounds and two of the teams' 10 steals. The last time Cerritos ended the first round of league play with a 5-1 mark was 2011. That season, the Dons went 8-4 in league play but advanced to the quarterfinals of the California Interscholastic Federation-Southern Section playoffs. If La Mirada beats Mayfair tonight, there will be a threeway for first place.



First place will

still be on the line when Cerritos travels to La Mirada on Wednesday as the second round begins. The Dons upset the Matadores 78-69 on Jan. 12.

Artesia freshman post Gary Williams also scored 12 points and pulled down seven rebounds and the Pioneers (10-9, 2-3) cleaned up the glass 34 times. Artesia will visit Bellflower today before returning to action at John Glenn on Jan. 30.

Before the boys took to the court, the Lady Dons barely broke a sweat in a 63-26 rout over the last place Pioneers. Cerritos, the eighth-ranked team in Division II-A, improved to 14-6 overall and 6-0 in the league. It's the first time the Lady Dons have gone through the first round on league action undefeated since 2008 and the fourth time this century. In addition, the six league wins have come by an average of 24.2 points.

Cerritos led 20-12 after the first quarter, then scored 20 more in the second quarter while Artesia was held scoreless. Senior guard Alyssa Movchan scored 10 of her game-high 17 in the first half while sophomore guard Cailey Vitug added seven of her 10 points in the first 16 minutes.

The Cerritos defense forced Artesia (4-15, 0-5) to turn the ball over 27 times and the Pioneers attempted 12 shots in the first half. Freshman Riley Woolf came off the bench to lead Artesia with seven points.

In other basketball action, the Gahr boys team improved to 15-4 overall and 3-0 in the San Gabriel Valley League following a 67-47 road win at Downey this past Wednesday. The Gladiators, who are ranked third in Division III-AA, will host Dominguez tonight and Lynwood on Wednesday.

#### **BOYS SOCCER**

Artesia routed Cerritos 5-1 this past Wednesday to win for the fifth time in 17 games this season. The Pioneers got two goals from sophomore midfielder Francisco Sierra and solo tallies from junior forward Steven Espinoza, sophomore forward Jorge Pantoja and sophomore midfielder Jose Ortiz. The win was Artesia's 25th straight over Cerritos, which had just snapped a 54game winless slump in league action when it edged John Glenn 3-2 on Jan. 16. The last time Cerritos won a league game was Feb. 1, 2010, a 2-1 home triumph over Glenn. Since then, the Dons had gone 0-52-2 before the win over the Eagles.

Valley Christian routed Village Christian 11-2 this past Tuesday as sophomore forward Clay D'Amico found the back of the net seven times. The 11 goals are the most the Crusaders (5-7, 3-0) have scored in a league game since blanking thenleague foe Brethren Christian 11-0 on Feb. 4, 2000.

#### GIRLS SOCCER

The middle of the Suburban League continues to stay tight as Artesia and Cerritos played to a 2-2 tie this past Wednesday. Artesia had a 2-0 halftime lead on a pair of goals from freshman midfielder Brittany Llanes, who leads the team with nine goals. Cerritos got a goal from sophomore forward Tobechi Udeh midway through the second half and the equalizer in stoppage time.

Artesia stands at 6-4-5 overall, 1-2-2 while Cerritos is 10-3-3, 2-2-2 and both trail La Mirada and Mayfair, who each are 5-0 and play each other today. Norwalk could improve to 2-2-2 in league play with a home win over last place John Glenn to-day while Artesia visits Bellflower, which is 1-4 in league action.

Bauman, Chair of the Los Angeles County Democratic Party who told HMG-CN he was "emphatically not supporting him (Portantino)."

In the days after publishing the story, several other officials have come forward to HMG-CN saying they did not endorse Portantino.

HMG-CN will publish those names in a separate story.

The "Team Portantino" email to HMG-CN stated, "we are writing to request that you immediately retract the false and misleading story that ran in Los Cerritos News last week asserting that a campaign website with fabricated endorsements was posted for public review."

The email indicated that the website was not public and that Portantino's campaign "did not know about it."

Sources told HMG-CN that a few city councilmembers told them that Portantino would go to local meetings sending officials to the website, even pulling it up on his phone, to show them all these "impressive" endorsements.

In addition, the bottom of the website stated, "paid for and authorized by Anthony Portantino for Senate 2016, ID# 1334175."

The email went on, "the draft homepage of the "mockup" was private and password protected. No one on Team Portantino knew that the long dormant satellite pages, including the one in question, were in any way available to the public or that they could be accessed without a password."

The HMG-CN investigation found that the website was indeed publicly accessible for a very long time and easily found by a "Portantino Endorsements" Google search.

HMG-CN Publisher Brian Hews said, "the page was public. Google crawled it and cached the site meaning it was public. I did a Google search, found it, and took screenshots. If it was private at the time, the search would have produced a login or password page. After the story published, Portantino pulled the site down and now a Google search of "Portantino Endorsements" takes you to a login page."

"Further," Hews stated, "after seeing the site, my website company said that was very elaborate for a mock-up. Website mock-ups use stock pictures and "Greek text." If the site was a mockup, they went through a lot of trouble to fabricate text that was very specific to the campaign. It is unheard of to pay a web designer to find pictures and related photos and come up with copy that's going to be thrown away."

The threatening email to HMG-CN contained several other demonstrably false statements.

In response to the story, Portantino initially claimed the web page was from his aborted 2012 run for State Senate.

In the email to HMG-CN, Portantino indicates the website is "years old."

However, the website in question contains Portantino's 2016 Campaign information.

Further the website also contains the current titles of individual politicians indicating it was created well after 2012.

Alan Lowenthal, who served in the State Senate until 2013 is listed by his current title of Congressman.

Still others, like Laurie Collins, are listed as "former." Collins only recently retired from the Santa Monica Conservancy.

The email then asserted, "these facts clearly and indisputably disprove the thesis of your story and establish, to the contrary, that the Portantino campaign never finalized, launched, promoted or intentionally posted the campaign website you reference. Again, the only person promoting and distributing this page is you (HMG-CN), not Team Portantino."

HMG-CN contacted a experienced publishing executive in Northern California who said, "what they have provided is an incomplete and unauthenticated series of allegations explaining how the page your story exposed came to exist and their incompetence in managing their affairs to avoid damage to Portantino's reputation."

The email then took on a more threatening tone, "moreover, to minimize the harm already caused by your inaccurate reporting we request that you immediately retract the false story. Should you not do so, you will be perpetuating a story with knowledge of its falsity and in reckless disregard for the truth. While we recognize that it is uncomfortable for a publication to admit inaccurate reporting, in this case making an honest disclosure of your error is the right thing to do, both legally and ethically. We encourage you to do so."

"There is nothing to retract," said Hews. "We acted in good faith based on the public endorsement page. Our allegations were reasonably drawn by the content of that page, backed up by the officials who came forward to refute the endorsements, and we have more coming."

in her district when she ran for the seat in 2012.

A letter from an investigator from the FPPC obtained by HMG-CN asked for several items related to the whistleblower case

The investigator requested the "Agenda Packet, Agenda and Minutes for the October 9, 2004 meeting concerning the Oui Tam case."

He also requested "the date of the board vote to wave attorney-client privilege regarding the Qui Tam case."

Two other items that the investigator asked for, seemingly unrelated to the Qui Tam case but items that might point to a residency investigation, were "the date Vasquez was elected to the board and the date Vasquez took office."

Sources inside CB confirmed to HMG-CN that the FPPC asked for documentation signed by Vasquez attesting to her residency in Lynwood.

#### **Illegal Vote Investigation**

In Oct 2014 HMG-CN exclusively obtained a legal opinion written by Paul Chan of the Los Angeles law firm of Bird-Marella, slamming CB Director Leticia Vasquez' October 9, 2014 vote to waive attorney-client privilege so the whistleblower lawsuit filed in 2013 can go forward

Chan was hired as legal counsel for Buchalter-Nemer, one of the defendants named in the whistleblower lawsuit.

Among other things, the opinion clearly warned Vasquez that she was financially conflicted, and should she or any of the 'legacy' Board members (Bob Apodaca, Phil Hawkins or Art Chacon) take a vote to waive privilege, they would be liable.

Chan said in the opinion, "We write to advise you that if the current board votes to waive the attorney-client privilege it is our view that such a waiver would be ineffective and that Leticia Vasquez' participation in such a vote would violate California law."

Chan went on to say, "Miss Vasquez has a direct personal and financial interest in advocating and voting for the district to waive its attorney-client privilege and is in violation of California Government Code 87100 which states, "no public official at any level of state or local government shall make, participate in making, or in any way attempt to use her official position to influence a governmental decision in which she knows or has reason to know she has a financial interest"

Vasquez stands to make over \$2 million if successful in her lawsuit, filed against the very agency she was elected to serve two years ago.

According to a recent CB audit, the lawsult has cost the agency over \$270,000 in fees as of June 2014.

"She would only come by the house about once a week," a source that wanted anonymity said in an email sent to HMG-CN, "her family members live there, she does not, you need to investigate this."

Some accused Vasquez of living with her boyfriend, now husband, attorney Ron Wilson who lives in Central Los Angeles. Past Issues

Vasquez has been a lightning rod since she was elected as a CB Director in 2012.

Joining Directors Roybal and Apodaca, she formed a new majority and fired COO Chuck Fuentes and Assistant GM Ron Bielke, both who were looking into the now infamous \$2.5 million "slush fund."

In Feb. 2013 HMG-CN exclusively reported that Vasquez, who campaigned on ridding the troubled water district of corruption, received extremely heavy financial support from two individuals with substantial criminal backgrounds, Angel Gonzales and Rick Mayer.

Gonzales, who plead down from a felony to a misdemeanor was convicted on political corruption charges and Mayer is a convicted felon.

Vasquez declared paying her political campaign manager Gonzalez \$4,000 before the actual June 5, 2012 election and owing him another \$18,399. Documents also showed that some of the \$31,146 she amassed came from the same special interest groups that she vigorously campaigned to root out. Tom and Ron Calderon gave \$2,250 while Vasquez' own mailer criticized Tom Calderon for taking money from the CB-MWD.

crative work because of their close ties to Vasquez, telling Los Cerritos Community Newspaper in a series of interviews, "the District apparently has added yet another lawyer and for some unknown reason some sort of media relations specialist, whatever that means."

CBMWD Director Phil Hawkins was even more outspoken telling LCCN, "the very first board meeting, after she was elected, I said her whole plan was basically to hire all her (Vasquez) campaign team, friends, and relatives and put them on staff so they would be ready for her next campaign, and it is all coming true now."

Hawkins went on to say that, "for no reason they fired our attorney, COO, and assistant manager, now its time to fill those positions with her cronies." **Pacifica Services** 

When Vazquez voted to fire Fuentes and Bielke earlier in the year, the firing stopped an investigation by the two into 8 no-bid contract extensions worth over \$5 million given to Pacifica Services and its CEO Ernie Camacho.

The vote was 3-2, with longtime member Bob Apodaca, who is related by marriage to Pacifica's CEO Ernie Camacho, Vasquez and James Roybal voting to terminate.

had not voted to fund.

According to sources familiar with Pacifica and the CBMWD, that is when the process to fire Perez started.

#### **Stop Pacifica Lawsuit**

In August Vasquez, Roybal and Apodaca along with retired GM Art Aguilar, purposely attempted to sink their own District's case against Pacifica Services.

At a Special Board meeting attended only by Roybal, Apodaca, and Vasquez, the three inexplicably fired its legal counsel, Grant Burton, who has been successfully litigating the District's case against Pacifica.

Director Phil Hawkins, who represents the Cerritos area, stated that the "Roybal Three" have "no logical reason" to fire Burton and his firm Cohen & Burge LLP.

"Grant retired recently after more than 20 years with Metropolitan Water where he served as their in-house litigator. He has shown to be successful in proving CBMWD's case to the court. Grant is the best of the best and he was winning our case as evidenced by the court rejecting Pacifica's request to throw the case out on December 30th. This shows we have a great case against Pacifica, the firing makes no sense at all, unless you look at the contributions," Hawkins told HMG-CN in an interview.

#### Vasquez Shakedown Meeting

In March 2014, HMG-CN was first to report that Vasquez sent a "personal friend" to represent her to secretly negotiate a "yes" vote for settlement in favor of the Pacifica Services lawsuit.

Sources inside Pacifica confirmed that Vasquez' representative met in Pasadena at least twice to broker the vote from Vasquez.

CB's suit against Pacifica was potentially worth upwards of \$5 million to the agency. According to sources, Pacifica may not have possessed the necessary California State License to contract with public agencies while doing work for CB. If that was the case, fraud may have been committed by Pacifica and CB could sue for the entire \$5 million.

#### Leaked a Federal Subpoena

Sources are also telling HMG-CN that Vasquez is under investigation for allegedly leaking a federal subpoena related to former GM Art Aguilar.

HMG CN obtained through a public records request copies of a Central Basin Municipal Water District subpoena given to the Metropolitan Water District during public comments by political activist Lorraine Cervantes, that showed the subpoena Cervantes gave out was altered.

Cervantes, a good friend of CBMWD Director Leticia Vasquez, told HMG-CN

That vote is now the subject of the FPPC investigation on Vasquez.

#### **Residency Investigation**

The other items requested by the FPPC, the date which she was elected and the date she took office, point to a residency investigation, confirmed to HMG-CN by sources inside CB.

Since early 2013, HMG-CN has published several articles on CB about Vasquez and two other board members, Bob Apodaca and James Roybal.

Posting the stories in print and online garnered major attention in Vasquez' district and especially in the city of Lynwood where she resides.

Several residents who said they lived very near Vasquez told HMG-CN via email, phone, and posting comments on loscerritosnews.net that they rarely saw her at her house in Lynwood.

#### **Pay-to-Play**

With her new-found majority, she started handing out contracts to benefit longtime personal associates including Maurice Chenier, the law office partner of her husband Ron Wilson, and another close personal associate Jasmyne Cannick.

Chenier was hired as a special attorney and Jasmyne Cannick as a media consultant by the CB in early 2013 raising ire from Directors Chacon and Phil Hawkins.

CBMWD Director Art Chacon suspected that the two were awarded the lu-

According to California State Conflict of Interest disclosure filings, Roybal, Vasquez and Apodaca have accepted tens of thousands of dollars in campaign donations from Pacifica Services and another firm MLJ Property Management that is located at the same address as Pacifica in Pasadena.

HMG-CN confirmed that MLJ is the first initials of Ernie Camacho's three children, Michael, Lisa and Jeffery, who gave \$5,000 each to Roybal and Vasquez. **Removed New General Manager** 

In July 2013 Vasquez, Roybal and Apodaca formed a committee to "evaluate" new CB General Manager Tony Perez immediately after Perez suspended contracts with Pacifica.

Perez determined that the 8th amendment effective June 25, 2012 provided no additional board approved funding and that since November 2012, Pacifica was being paid for work that the elected board

that she "went down to the courthouse and got the documents," a statement now confirmed to be an obvious lie.

According to sources inside CBMWD, only two people were given the original subpoena; Director Vasquez and Director James Rovbal.

Only Vasquez knows Cervantes. Vasquez and Cervantes previously worked together.

Vasquez refused to answer direct questions about how Ms. Cervantes obtained the forged subpoena.

"We'll see where this investigation goes, said CB Director Art Chacon. "We got that letter from the law firm saying that her vote was illegal, yet her Roybal, and Apodaca voted to waive the attorney client privilege for the whistleblower lawsuit, now the FPPC is asking for documents related to that vote. This does not look good for Vasquez."

According to staff reports, a new State law took effect on January 1, 2015, which changes how a City can regulate massage establishments.

Reports from other California cities show the enactment of prior State laws has had an unintended consequence of the proliferation of illicit massage establishments that are fronts for prostitution and may also be involved in sex trafficking.

The proposed ordinance would impose a 45-day interim moratorium on the issuance of any permits, licenses, tax certificates, approvals, or entitlements for new massage establishments or the relocation of massage establishments as defined in the Bellflower Municipal Code.

Staff stated it was urgent the City undertake a review of current massage regulations in order to determine how current City regulations may need to be revised in order to be consistent and compliant with State law, while still providing local control with ample regulations for the establishment, use, and operation of businesses offering massage services.

The City of Bellflower had two massage establishments in 2008 and currently has 20 such establishments. The City regularly receives complaints of illicit activity occurring at some of these establishments, therefore requiring a higher level of examination and enforcement. The City has found that a number of local massage establishments have advertised or received online reviews of adult entertainment which strongly suggest illegal and illicit activities. The City has initiated action through the citation process against these establishments, owners and operators. The over-saturation of these establishments have been found in violation of the law, changing the character of the neighborhoods and impacting surrounding businesses. Staff was directed to study appropriate modifications to the City's massage and zoning ordinances in order to mitigate any negative effects from these massage establishments. Pending the completion of these studies, Staff will establish appropriate operational and zoning regulations. This was met with a unanimous agreement from the Mayor and City Council.
