# *HMG-CN INVESTIGATION:* CENTRAL BASIN PRESIDENT BOB APODACA INVOLVED IN CALDERON CORRUPTION CASE

An investigation by Hews Media Group Community News has identified the "elected public official at a local agency" cited in the latest court filing by U.S. Attorneys related to the Calderon corruption case who was hired as an employee of Senator Ronald Calderon's staff in 2007 and 2008 as current Central Basin Municipal Water District (CB) President Robert "Bob" Apodaca.

Several sources are "100% sure" that Apodaca is the elected public official, one telling HMG-CN that "he told me several times that he worked for [Ron] Calderon in 2007-2008."

Ron Calderon is accused of accepting \$80,000 in bribes from a medical company owner to influence legislation. Thomas Calderon is charged with money laundering. Both have pleaded not guilty.

# La Palma Council OK's Central Park Playground Upgrade



The La Palma City Council voted 5-0 the to replace the city's 21-year-old Central Park playground equipment in the total amount of \$235,372 during its May 5th regular meeting. The amount includes the installation of unitary rubberized surfacing for the cost of \$64,144. The other components of the project are the purchase of new playground equipment at \$117, 328 which was considerably reduced from the previous \$179,345, and the installation of the playground equipment by Tot Lot Pros at the cost of \$53,900 from the original contract of \$56,100. "This is a good investment in the CORE plan," said Mayor Pro Tem Gerard Goedhart. The contract was approved amid the financial challenges the city is facing. La Palma's Community Services Director Mike Belknap said, "We were able to reduce costs by eliminating or changing some of the item related to the forest theme such as log climbers and steps while at the same time maintaining the key component for the overall play experience." The six to eight weeks time-table of the project, according to Belknap, is being finalized although he said, "we expect to open the new playground to the community in early July."

# *HMG-CN INVESTIGATION:* Water Replenishment District problems Generate Huge Legal Fees

A Hews Media Group-Community News investigation has revealed that the Water Replenishment District, based out of Lakewood, California, has spent nearly \$10 million since 2012 on legal fees, with one of the biggest recipients, Latham & Watkins of Los Angeles, billing almost \$2 million in less than three months in late 2014.

# *EXCLUSIVE:* Lynn V. Dymally Files Sexual Harassment Lawsuit Against Carson Councilman and WRD Director Albert Robles

Hews Media Group-Community News exclusively learned and obtained a complaint this past Tuesday May 12 filed by former Water Replenishment District Director Lynn V. Dymally against current Carson Mayor and WRD Director Albert Robles for sexual harassment and other violations.

The online article, posted at 6 p.m. Tuesday, was picked up by several major television and online organizations beginning Wednesday night.

The 11 page complaint filed in Los Angeles Superior Court by Dymally's attorney Jason Buccat based out of Culver City, slams Robles with Sexual Battery (Civil Code 1708.5), Harassment (Civil Code 51.9), Gender Violence (Civil Code 52.4), and Intentional Infliction of Emotional Distress.



2015 that will take place from July to August this year.

The Mayor proudly announced after accepting his new responsibility, "on behalf of the Lakewood City Council and the entire Los Angeles County, I do hereby welcome the athletes, coaches, staff, volunteers, families and spectators of the Special Olympic World Games to our city and hereby proclaim July 21-24, 2015 as 'Lakewood Host Town Days' in the city of Lakewood, CA," Wood added, "Lakewood is proud to be a 'Host Town' in partnership with the city of Cerritos and The Church of Jesus Christ of Latter Day Saints which has graciously volunteered to create a local organizing committee to make this possible."

As a host town, Lakewood will host athletes from the countries of Turkey and Slovenia in pre-game celebration that will include opportunities for recreation, entertainment and cultural exchanges.

The city joins as many as 100 communities across Southern California in welcoming delegations of over 7,000 Special Olympic athletes from 177 countries around the world.

David Montgomery from the organizing committee said that about 120 athletes from Uruguay are coming to Cerritos. He also said that some 200 athletes from Cerritos and Lakewood would be housed in Cal State Long Beach dormitories during the four days in summer.

For the athletes' transportation needs, Montgomery said some ABCUSD bus lines would be mobilized temporarily for the event. During the pre-game celebration, the visitors will be taken to a number of historical, cultural and entertainment venues in various cities including the Orange County Fairgrounds in Costa Mesa where a total of 1,500 athletes from several LA and OC host cities will converge.

"We are raising about \$15,000 in Cerritos to cover certain expenses including meals for the visitors which includes valuable help from LA County Supervisor Don Knabe," Montgomery said. "Those who wish to donate can go online for Special Olympic World Games website with link to Cerritos.

The Special Olympics World Games is the world's largest sports and humanitarian event for children and adults with intellectual disabilities. It was founded in 1968 by Eunice Kennedy Shriver.

The Special Olympics is held every four years with the previous event held in Athens, Greece. For this year's event in Los Angeles, athletes will compete in the large stadiums of UCLA and USC. The games can be seen live in their entirety on ESPN according to the head of Cerritos-Lakewood organizing committee.



# Two Norwalk-La Mirada Schools Receive California Gold Ribbons

Two Norwalk-La Mirada Unified schools have been designated as California Gold Ribbon Schools – the state's highest award for academic excellence – giving the district a win for both applications submitted.

The awards, which have temporarily replaced the California Distinguished School awards, go to secondary campuses that successfully implement new academic content and performance standards for all students, including English learners, as demonstrated through model programs chosen by the schools.

Norwalk-La Mirada collected the award for Los Alisos Math-Science Technology Magnet and Benton Visual and Performing Arts (VAPA) Academy. Both campuses were recognized as model programs in their distinct areas and for their use of best practices to boost enrollment, parent involvement, improve achievement and reduce absenteeism and disciplinary issues.

"This recognition underscores the value of Norwalk-La Mirada's commitment to our middle school magnet pro-

grams," Interim Superintendent Ginger Shattuck said. "The Middle school years represent a time when some students can begin to lose interest in school, so giving them many opportunities to discover their passion can keep them fully engaged."

The Gold Ribbon program is intended to run for two years, providing the state with an interim way to recognize excellence while California adopts new statewide assessments in math and English language arts (ELA) aligned with the California Common Core.

The former assessments were used to generate the state's Academic Performance Index score for each school – a figure that helped establish eligibility for the Distinguished Schools program.

California dropped its ELA and math assessments in 2014 while it tested a new system that went into effect this spring. The state also put the API on hiatus while it builds a new model for determining school success that is broader than the test-score driven tool previously used.Unlike the Distinguished Schools program, Gold Ribbon applicants nominate themselves. Both systems include site visits by a team of educators as part of the final determination of winners; both also rotate annually between secondary and elementary schools.

Eligible schools are to show model programs that improve student performance under the Common Core for ELA


Los Alisos principal Mike Garcia says there are multiple measures of success for the program.

when, "he/she acts with the intent to cause a harmful or offensive contact

with an intimate part of another, and a sexually offensive contact with that person directly or indirectly results."

A person is liable for Sexual Harassment when there is a business, service, or professional relationship between the plaintiff and defendant.

Finally, Gender Violence is described in the Code as a physical intrusion or physical invasion of a sexual nature under coercive conditions.

The complaint also named 10 "Does" and stated, "plaintiff is informed and believes and based thereon alleges that each of these fictitiously named defendants is responsible in some manner for the occurrences here in alleged, and that Plaintiffs damages as herein alleged were proximately caused by their conduct."

The incident occurred at the American Leaders Water Conference in Washington D.C. that took place in November 2013.

According to the complaint, Dymally began feeling very uncomfortable when they checked into the hotel and Robles had ordered adjoining rooms with a common door.

The complaint goes on to state, "early morning on Nov. 3, 2013 Dymally was returning to her room after dinner with Robles and others when Robles forced himself on to Dymally so hard that it pushed her back into her room and onto the bed. Robles began to grope Dymally and proceeded to try and rip her clothes off. Dymally attempted to stop him however Robles was too strong and proceeded to get on top of her and try to have intercourse with her."



setter Ben Wassink came up with a huge block of Chavers before Fredrick had an ace after Najera had called a timeout.

"Corey is an outstanding player," Kwak said. "He's going to play [NCAA] Division I ball. What Ben did for us was just a bonus. We told him Corey might try to hit down a little bit because he's going to out jump [Ben] and [Ben] is a little shorter. I just told him to time the block well."

But in the fourth set, V.C. was unable to catch Gahr while trailing by a point five times after Gahr held a 10-6 advantage. Davis would lead the Crusaders with 20 kills while Fredrick added another 17.

The match also marked the return of Kwak to the gymnasium his alma mater, where he helped the Gladiators with a CIF Division II championship in 2000.

"It brought back a lot of memories," he said. "Just being in the gym and hearing the same chants and cheers that I heard when I was here...it's just good to see that Iris is doing something great here and keeping it going and keeping the same traditional stuff that we've been doing. It opened up the floodgates of emotions for me when I walked in."

Apodaca is now under a much larger federal microscope as an important connection in the federal corruption case of Ron and his brother Tom Calderon.

And the disclosure will certainly have Central Basin officials as well as other area politicians demanding a recall of the embattled Central Basin President.

Sources inside Central Basin tell HMG-CN that since Ron and Tom Calderon were indicted, the FBI has interviewed Apodaca five times and also subpoenaed all of his Central Basin personnel records.

The FBI investigation could also lead to an Apodaca indictment in a "pay-toplay" scheme for steering no-bid contracts to Tom Calderon and his Calderon Group and receiving kickbacks in the form of paid salary as a staffer for Ron Calderon.

It also shows intent to commit fraud by Ron and Tom Calderon using Apodaca as the middleman.

When contacted by HMG-CN, U.S. Attorney Spokesperson Thom Mrozek said, "the U.S. Attorney's office cannot confirm or deny that Apodaca is the elected public official at a local agency named in the latest court filing."

The HMG-CN investigation also found Apodaca in violation Fair Political Practices Commission (FPPC) rules of filing a "Form 700 Statement of Economic Interest." The FPPC rules require public officials to "disclose income which may be materially affected by their official actions."

Apodaca was paid while he worked for Calderon in 2007 and 2008, and was



Los Cerritos Community Newspaper also a Director at Central Basin, but a public records request via the Freedom of Information Act by HMG-CN revealed Apodaca did not file any Form 700's from 2007-2009.

Inside sources who worked at Central Basin during 2007-2008 told HMG-CN that, "Apodaca was working for and getting paid by Ron Calderon and everyone knew it, but since he was a Director, no one said anything. Ron and Bob [Apodaca] go way back to Bob's days while he worked at Coors, they have been good friends for years."

"According to a confidential source," the U.S. Attorney court filing stated, Ronald Calderon continued to pay Apodaca, "even after other members of his staff complained that the local official [Apodaca] rarely showed up for work."

Prosecutors allege that Ron Calderon kept Apodaca employed in a pay-to-play scheme because his brother Tom, "feared that his company, the Calderon Group, would lose its consulting contract with the agency [Central Basin] where the local official [Apodaca] worked" if the Apodaca was fired. Tom Calderon had a \$130,000 annual consulting contract for years with CB.

But after months of missing work, Apodaca was fired by Gil Cedillo, Jr., who was at the time working for State Senator Ron Calderon as his District Director.

Ironically, Cedillo Jr. was subsequently hired as a Business Development Director as a favor to former CB Director Rudy Montalvo with only Apodaca objecting.

HMG-CN published exclusive articles on Cedillo Jr.'s overblown pay, documented three martini lunches, and showed that CB paid \$22,000 to pay for his education at Asuza Pacific.

The revelations by HMG-CN forced Cedillo Jr. to resign.

Records show that after the firing, Apodaca proceeded to vote no on all Calderon Group contracts with Central Basin.

Apodaca chose not to comment in an email sent to CB PIO Joseph Legaspi.

Former Central Basin Candidate Tom Malkesian, who came in second place behind Apodaca in the 2014 election told HMG-CN, "the latest round of allegations are a huge disappointment, especially in light of the current drought. Our elected officials should be held accountable for their actions."

law firms, Harris & Associates and Latham & Watkins, are both currently in dispute negotiations related to legal fees with WRD. Harris & Associates, who held a fundraiser for current WRD President Sergio Calderon during his election campaign, resigned in 2014.

The sources place the amount in dispute with Latham & Watkins at \$1.4 million.

Online documents suggest that disputes exist, with no checks paid to Harris & Associates since April 2014 and no checks paid to Latham & Watkins in 2015.

In that time, WRD has racked up over \$1.7 million in legal fees, just over \$191,000 per month, not counting Latham & Watkins \$1.9 million at the end of 2014.

The staggering total amount is well over \$260,000 per month, paid using funds from WRD ratepayers; and WRD recently raised their rates by 5.6%.

Sources are also telling HMG-CN that current WRD Director Albert Robles was instrumental in bringing Latham & Watkins into WRD at the end of the Proposition 218 fiasco, much the same way Robles, as a Carson City Councilman, brought the high-powered law firm into the Carson Football Stadium negotiations.

Cerritos, Downey, and Signal Hill sued the WRD in 2010, saying it violated Proposition 218 procedural requirements in setting its rate for pumping groundwater. Bellflower joined the case in 2011 after a Los Angeles Superior Court agreed with the cities and ruled the district violated the procedural requirements.

WRD recently agreed to pay \$9.1 million to settle the Proposition 218 lawsuit brought by the four cities.

The lawyers WRD hired is a blue chip listing of Los Angeles firms routinely charging upwards of \$600 an hour for their services.

The list includes Albright, Lee & Schmit; Alston & Bird; Harris & Associates; Latham & Watkins; Leal-Trejo; Sheppard, Mullin, Richter & Hampton; Tafoya & Garcia; and Anthony Willoughby.

Leal-Trejo, Harris & Associates, and Alston & Bird benefitted the most during the three-year billing period.

Over \$3 million was paid to Leal-Trejo, \$2 million to Harris & Associates, and \$1.3 million to Alston & Bird. In one month, Alston and Bird racked up \$152,000 in fees while Harris and Associates billed over \$180,000.

Months before Harris and Associates resigned, the law firm billed WRD over 700,000 in an eight month span.

Anthony Willoughby was paid in what was listed in WRD's check register as a "lump sum" totaling \$89,000 in 2012.

The Latham & Watkins amount of \$1.9 million was paid in October, November and December of 2014.

A Cerritos official, one of four cities involved in the Proposition 218 lawsuit, told HMG-CN, "we were doing fine with other law firms, then WRD brought in the 'big gorilla' Latham & Watkins. Latham brought in 'experts' and high paid attorneys to fight against us that generated huge fees, and the ironic thing is that those fees will be paid by WRD ratepayers."

An article by the Los Angeles Times indicated that Latham & Watkins, which helped coordinate Vernon's battle against disincorporation, was paid nearly \$7 million in by Vernon in 2011.

"The law firm is running the city," one Vernon councilman said at the time.

John Van de Kamp, the former state attorney general who was Vernon's ethics advisor, said he also believed the firm's rates at the time were too high.

The article went on, "neither Latham & Watkins nor [Vernon] city administrators would provide detailed legal billings or answer other questions about the services for which the firm was charging."

Calls and emails into Latham and Watkins about the WRD fees were not returned.

HMG-CN contacted Dymally who said, "as a life-long community leader and role model, I would be remiss if I do not stand up against the injustice of sexual assault and harassment women encounter in the workplace. That being said, 75% of Americans believe women should not return to the traditional roles in society. One in five firms with revenue of \$1 million or more is woman-owned. This number grew 2000% between 1977 and 2012. Only 18% of American women are in leadership positions and women are paid 77 cents for every dollar a man makes. The gap is larger for single mothers and women of color. This gap was 59 cents in 1963 when President Kennedy signed the Equal Pay for Equal Work Bill. The Shriver Report states, "if women in the US were paid equal to their male counterparts, the US economy would produce \$447.6 in additional income." However, women are poised to become the majority of the U.S. workforce for the first time
