HMG-CN EXCLUSIVE: **MONTEBELLO MAYOR HADJINIAN'S FRIEND GAVE \$10,000 TO PAC OPPOSING** FERNANDO CHACON ONE MONTH AFTER HADJINIAN APPROVED PROJECT

Hews Media Group-Community News investigation has revealed that Protect Local Jobs ("PLJ"), a political action committee based out of Los Angeles that is spending thousands to defeat Montebello City Council candidate Fernando Chacon, received \$10,000 from a company owned by Jason Kashanian, a.k.a. Jason Kachan, and son of Sam Kashanian, a good friend and business associate of current Montebello Mayor Jack Hadjinian.

The documents were obtained from the L.A. County Registrar/Recorder's Office in Norwalk. The company donat-

ing the money was 2113 Whittier Blvd. corruption figures. LLC.

Hadjinian approved a controversial Montebello development owned by Kachan in July 2015, a lot where the French Café once stood. One month later, the \$10,000 was donated to PLJ to defeat Chacon.

Sources are telling HMG-CN that the property approved for development was rezoned from C-2 Commercial to PD (Planned Development) and can be sold for considerably more than it was worth prior to the zoning change.

PLJ and Hadjinian

PLJ's past and present associations read like a Who's Who of Los Angeles'

The list includes indicted former State Senator Ron Calderon and his brother Tom Calderon, who is also under indictment; disgraced former Bell Gardens City Councilman Mario Beltran; convicted felon Ricardo "Ric" Mayer and his political partner, felon who plead down to a misdemeanor, Angel Gonzales.

Additional associations with PLJ include indicted L.A. County Assessor John Noguez, who swore Hadjinian in as Mayor, and Kindee Durkee, who embezzled \$10.5 million in campaign funds

Ron Beilke's Hard Fought Campaign Concludes

As 10 candidates prepare for Tuesday's November 3rd Santa Fe Springs City Council election, only one candidate can truly claim the title of being a new and fresh set of eyes. Ron Beilke readily admits that he's only been a resident for three years, but as he sees it, that's a good thing.

Although Beilke's quick to point out that he's friendly and respects all current council members as well a few staff members, he makes it very clear that those relationships are not "cozy."

"I am happy to make crystal clear that

I am not aligned with any other council members past or present, city staff or even vendors doing business with this city," states Beilke, "if elected my vote will come with no strings attached and completely dictated by the wants and needs of the residents I'd represent."

Beilke feels that "independence" is what the community needs given the small town nature of the city and the influence of many well-entrenched business leaders.

The path Beilke took to being a candidate is best described as non-typical. Whereas all nine other candidates running boast long-ties to the community with most See **BEILKE** page 8



The Albert & Bettie Sacchi Foundation will be recognized with the Golden Dreams Award for its generous financial support for the battle against children's cancer.


Los Angeles County Supervisor Don Knabe will be recognized with the Dare to Dream Award for his support and efforts to improve the health of children throughout Los Angeles County.



Re: Chen Chen Wants Control of ABCUSD Board of Education to Derail Improvements

Dear Editor:

Evidently, former school board member Cecy Groom has forgotten that all of the current information she does not know is a matter of public record and available to any resident who calls or goes in to the Fiscal Services Department at the school district.

For Ms. Groom's benefit, the school site allocations for 2015-16 total \$17,340,265 which does not include salaries, benefits, deferred maintenance, nutrition services, transportation, health screening, nurses, warehouse, special education, after school activities, district office, and other district wide required functions.

Teachers were dipping into their own pockets during the recession and also accepted furlough days, larger class sizes, and reduced benefits in order to preserve district programs. Except for their personal financial loss, most to the cuts have been restored.

As a board member during the last modernization, I am surprised that Ms. Groom does not remember the bond money and how it was spent, since that took place on her watch. However, I have all the audit reports from the bond years and I will meet with her any time at any place (District Office?) to give a refresher course on the bond. Maybe we can invite the local press to sit in.

It seems that the folks who used deceit, deception, misstatements, scare tactics, and straight up falsehoods to scam the public and cheat our kids are continuing to take victory laps. They also seem to have found a way to make it profitable as well from the campaign filings and hidden agendas.

In still another long term consequence of this shortsightedness, there will be a state bond initiative to build and upgrade schools on the 2016 ballot. If passed, and they usually do, school districts will be eligible for matching funds from the state if they have a passed local bond as ABC did back in 2000. This will be a windfall for all the school districts around that passed bonds but alas, our district will get to watch from the sidelines this time.

Finally, bond payments are fully state and federally tax deductible, and a premium school district adds ten to fifteen percent to the market value of the homes. Gavin Riley Cerritos

ABCUSD Spotlight on Teaching and Learning: Advanced Placement Learning

As part of ABC USD local control accountability plan, one of the main goals is to increase the number of students that have access to advanced placement courses and the advanced placement courses themselves. The District also is attempting to increase the diversity of the students who will be taking advanced placement courses in the future.

The spotlight and focus at the ABC USD board meeting, October 20, 2015 was on the Pre-Advance Placement pre-AP academy that was held during the summer of 2014.

Carol Castrol, Supervisor of Curriculum and Professional Development introduced the pre-AP program reiterating the three goals of the district: To increase the number of students enrolled in the AP program; Increase student access and preparedness for AP course work and to increase the diversity in AP courses, to reflect the population of the district.

Data gathered from the 2014-2015 year showed 72% of students in AP class passed the course with a C or higher; enrollment increased from 1,814 to 1, 931; there was an increase in number of students that took more than one AP course and an increase in the AP course offering across the district with the addition of AP music theory.

Artesia High School began their pre-AP courses three years ago, beginning with AP Biology. Artesia High School Principal Sergio Garcia told the board," This past summer we offered fifteen separate courses and had over 300 students attend. Out of 225 participants 183, were first time attendees." Each academy was a total of 20 hours throughout the summer.

They included in class lectures, discussions, labs, pre-testing, post-testing and online assignments. Progress showed that 85% of students were currently passing AP classes with a C or higher.

Cerritos High Summer AP School Principal Carey Lin noted they offered 17 courses. A pre-academy poll was taken where teachers filled out a survey and reported student progress for the first quarter. 80% were doing exceptional well or above expectations. Lin noted staff believed this to be due to the additional counselor support to meet one on one with students.

AP Teacher Grace Ahn brought in additional teachers to speak and present to students for academic and psychological support, "We focused on being practical with the kids. We wanted to provide them with skills and services that could b e applied throughout the school year." This year a new program has been added called Advance Power, this is a one on one study session for the AP Exam.

Dr. Gina Zietlow, Gahr High School Principal, commented "This is a program that we have really focused on at Gahr. It is at the heart of many of our teachers." Being in the first year Gahr chose AP courses of Calculus, History, English, Government and Physics to focus on. AP coordinator Sue Em, noted 90% of students successfully completed the AP courses, "I had the opportunity to interview the kids that took these courses, and found that it boosted the students' confidence."

Many comments from the various teachers and testimonials from the high schools noted that they believe there will be an increase in enrollment for summer 2015.

employed in the city, Beilke purchased a home in the newly developed Villages at Heritage Springs in August 2012, moving in around Christmas.

Beilke describes his journey that landed him in Santa Fe Springs as "fate". He says he and daughter Pat were driving along Telegraph Rd. one Sunday afternoon when he fell in love with the city that he found both quiet and peaceful which perfectly complimented the stage in life he was at. "Even though Santa Fe Springs is surrounded by much larger cities on all sides, I felt I found my little piece of paradise here in The Villages...I was ready for a change," noted Beilke.

Within a year of moving into The Villages, Beilke felt the need to step up and help his community as it transitioned from a builder-controlled homeowner's association to a resident-lead Board of Directors. Beilke admits that the changeover was difficult and a lot of egos were bruised and challenges were made for control, but in the end the community maintains a strong financial footing and improvements are being made regularly to enhance the neighborhood and increase property values. Beilke currently serves as President of two of the community's three associations including the Master Board.

Beilke set his sights on running for council as a result of issues both he and his HOA had with the city. Beilke claims to have addressed the city council during three meetings. The first was to complain about the foul odors that in his words "destroyed about 8 months of his life" after storage tanks leaked on the old refinery property on Florence Ave. from an industrial waste water recycling plant that was permitted to operate just blocks from residential homes.

The second time Beilke spoke at a council meeting was in protest to the city's approval of apartments to be built within the walls of The Villages without clarification on many key issues, such as how much the HOA would be compensated to provide amenities to the 150-unit apartment complex.

Beilke's most recent visit to City Hall was in response to the council's unwillingness to overturn the Planning Commission's approval of a trash recycling facility on Norwalk Blvd. just north of The Villages.

Beilke says his decision to run for council does not stem alone from his past grievances with the city, rather he claims his main concern is the future of undeveloped property that exists, especially around his community.

"When I tell people that we need to stop attracting businesses like the ones the city has been allowing in as well as putting an end to proliferation of more and more warehouses, people applaud," notes the candidate. According to Beilke, residents want good paying office jobs that will attract restaurants to build and people to shop in the community, not warehouses that bring us more and more big truck traffic!

Beilke says he's optimistic about his chances on Tuesday. I've knocked on a couple thousand doors and everyone has been very nice and supportive. He adds that some residents complain that nothing ever changes in the city and that they're tired of the same old ways of doing business. He says that he points out that he can promise that will change if he's elected.

from 1998 to 2010 and is serving 8 years in federal prison.

NAME OF FILER

The discovery ties Hadjinian to PLJ, the Calderons and Mario Beltran, who sources tell HMG-CN is running Hadjinian's campaign.

PLJ History

PLJ was created in 2014 from another PAC called Saving Local Jobs. Yolanda Miranda was selected treasurer. Immediately after that, the PAC turned its sites on Chacon and the Montebello City Council campaign, with Saving Local Jobs giving \$8,000 to PLJ in February of 2015.

Yolanda Miranda has a very checkered past going back many years in East Los Angeles politics.

Miranda was the long-time treasurer for former State Senator Ron Calderon and his brother Tom Calderon.

Miranda, similar to Hadijinian, is also a known associate of former Bell Gardens City Councilman Mario Beltran who was accused by prosecutors of misusing contributions from Ron Calderon to pay for his legal defense in a 2006 criminal case. Beltran pleaded guilty to four counts.

In addition, Beltran was accused of filing a false police report when he solicited a prostitute at a seedy hotel in 2013.

Miranda was also the treasurer for Central Basin Municipal Water District (CB) Director Robert "Bob" Apodaca, who recently was sued for sexual harassment settling the case for \$670,000 using CB funds.

Finally, Miranda has worked often with Ric Mayer and Angel Gonzales,

two notorious figures in East L.A. political circles. Mayer and Gonzales ran the campaigns of embattled Central Basin Directors Leticia Vasquez and James Roybal.

PLJ campaign documents show that as of July 2014, Miranda was listed as Treasurer and Luis Gonzales, who listed his address on 911 Lincoln Ave. in Montebello, was an "officer."

A company called Blackstone Communications, who has been paid by Hadjinian and Delgado, occupies the same address on 911 Lincoln Ave.

By January 2015, PLJ named Jorge Carillo as the new "officer," listing his address on Wilcox in Montebello. Miranda remained treasurer.

It was in August when Kachan's company gave \$10,000 to PLJ to oppose Chacon, just one month after Hadjinian hastily voted to approve a controversial housing development owned by Kachan.

The development was beset with problems and many serious questions remained about the project but Hadjinian voted for it in an apparent "quid pro quo" related to Kachan's donation

At the time of the vote, Montebello Councilman Bill Molinari complained, "staff can't even tell me how many floors there are."

The PAC does not have to file another campaign report until Dec 31, 2015, so any campaign expenditures past this current report will not be known until then.

DOWNEY-When Gahr High visited Warren High last Thursday afternoon, there was a three-way tie for first place in the San Gabriel Valley League. High last Friday night at Excelsior Stadium. The game was supposed to feature two of the dynamic running backs in the league-Norwalk senior Chris Walker and junior Jordan Benoit of Artesia.

However, Walker was sidelined with an injury and Benoit, who has accounted for 76 percent of the Pioneers' touchdowns this season, was running at 75 percent and was in action for just a few plays at the beginning of the game before he became a spectator the rest of the night. - A 5,032 linear foot, 24-inch underground pipeline, of which 1,800 feet (0.34 miles) is located within the City's right-of-way along Studebaker Road, just south of Alondra Boulevard.

The City of Cerritos previously adopted Ordinance No. 589 granting a 25-year nonpublic utility franchise for the operation of the above-referenced pipelines, but Ordinance No. 589 is now expired. Under the proposed ordinance, SFPP, L.P. will pay to the City, during the life of the franchise, annual fees of \$0.67 per lineal foot of 16-inch pipeline and \$1.00 per lineal foot of 24-inch pipeline, which fees shall be increased annually by the Consumer Price Index for the Los Angeles-Riverside-Orange County Areas. In the event the fees are not paid, the franchise will be forfeited.

ones. "We are rethinking how to support weight-loss goals for a lifetime, while managing any chronic illness like diabetes or heart disease," says Alexander Khananashvilli, Founder and CEO.

Property values in La Mirada have grown by more than 4 percent during the past year according to a recent report by the Los Angeles County Assessor's Office.

The local housing market has also remained strong. The median sale price of a single family home in La Mirada from January through August 2015 was \$470,000. This represents a \$30,000 (6.8 percent) increase in median sale price from 2014.
