



LA MIRADA WILL CHANGE TO DISTRICT VOTING FOR MARCH 2017 ELECTION

The City of La Mirada has scheduled three Public Hearings to receive public testimony and gather input to consider modifying its elections from the current at-large system, where all voters elect all members of the City Council, to a by-district system, where only voters in a given district vote on the person to represent them. The number of representatives on the City Council will remain at five.

The Public Hearings will be held on October 11, October 25 and November 8 at 6:30 p.m. in the City Hall Council Chambers at La Mirada City Hall.

The City Council members made the decision they would elect by district rather than fight a lawsuit from the Latino voting rights group, the Mexican-American Legal Defense and Educational Fund and face the possibility of having to spend hundreds of thousands of dollars.

The city received the letter from MALDEF that stated, "We have received complaints from Latino voters in the city of La Mirada that the use of an at-large election system for the election of city council members results in Latino voter dilution. We reviewed the demographic and electoral information pertaining to your jurisdiction, based on our investigation we believe that the city of La Mirada is in violation of the California Voting Rights Act (CVRA) and must convert to a by-district election system."

La Mirada is comprised of 36% Latino

"It all started back in 2002," recalls longtime Cerritos resident Carol Rosenberg Smith. "When I moved from Bellflower to Cerritos, my schedule changed and I found myself needing to go back to a regular workout, so I joined Curves."

In order to produce large audience participation, the producer for the new Dr. Phil show had contacted all of the Curves locations and sent out invitations. The request was to bring 40 audience members, and the show would provide a bus at no charge to pick up for show tapings. The owner of the Curve in Cerritos did not want to send an employee so Smith was asked if she would go, offering a free Curves tee shirt as incentive. "Basically she wanted me to keep track of everyone

going and I would have done anything for a free shirt," said Smith.

In the beginning Cerritos Curves would gather 40 people each month, parking in the small parking center. The group expanded, the bus got bigger and attendees began to meet and park at the Los Cerritos Shopping Center. When Curves closed that location, the show kept sending a bus for audience members, but was deemed as "Carol's Bus".

Since early 2003, she has been bringing new viewers to the Dr. Phil show once a month. "We have had theater ambassadors join us, Curves members continue to go, my best friends, even my ex-husbands third wife goes with us."

As her participation in the show continued, Smith was able to meet various crew members. "Michael Stern, Audience

Meetings to be Held Concerning Local 91 Freeway Improvements

The Los Angeles County Metropolitan Transportation Authority (Metro) and the California Department of Transportation (Caltrans) District 7, in collaboration with the Gateway Cities Council of Governments (GCCOG), the City of Cerritos, and the City of Artesia are proposing to make improvements on the westbound SR-91 between Shoemaker Avenue and the I-605/SR-91 interchange.

The California Department of Transportation is initiating environmental studies for the proposed SR-91 project.

The project would widen westbound SR-91 from approximately Shoemaker Avenue to the I-605/SR-91 interchange.

All area residents know that the westbound SR-91 approaching the connector ramp for northbound and southbound I-605 currently experiences significant congestion, which is forecast to increase in the future absent physical and operational improvements to this westbound segment of SR-91.

The project will reduce congestion and improve freeway operations, improve safety, and improve local and system interchange operations while minimizing right-of-way, environmental and economic impacts.

The design option configurations for the project include the addition of travel lanes, modification of existing interchanges, removal of some existing non-standard design features, and other operational improvements.

Caltrans indicates that potential impacts associated with the project may

Adults may include your contact information (mail or email) so the letter recipient may reply. Children may use only their first names, no addresses or emails. Children may also

draw or paint a picture. And please do not send your card or letter in an envelope, loose cards and letters only.

Over 100 students applied for and interviewed for a spot in the Kaiser Youth Work Preparation Certificate Program.

The program aims to serve high school students in the Los Angeles area.

Students who are a part of this program complete a seven week work prep program where they learn valuable job skills such as interviewing, resume writing, people skills, etc.

They are also introduced to various health care fields beyond that of a doctor or nurse.

Only 30 students were accepted.

Former Cerritos College Administrator Donates Artifacts

Cerritos College’s fine art students can explore the ancient world on campus thanks to a donation of artifacts by former Cerritos College administrator John Grindel. Grindel served Cerritos College from 1995 - 2005 in several positions. Grindel is re-gifting the artifacts to the College. Having received them from a friend in years prior who knew of Grindel’s interest in Near-Eastern pottery as a professor of Near-Eastern history. “In turn, it is my intention to pass on these ancient artifacts to a group of educators who would appreciate the beauty and importance, and the history of such common utensils in the lives of everyday people,” said Grindel. Grindel's generous donation of numerous ancient Near-Eastern ceramics will be formed into the John Grindel

Antiquities Collection, and become a resource for art history, archeology, and anthropology instruction and student research. The collection includes 29 pieces from the Late Bronze Age and Iron Period (1500 BCE – 586 BCE) and pieces from the Greek and Roman era (332 BCE – 324 CE). Grindel’s generous donation will be named the John Grindel Antiquities Collection and will be on display in a dedicated section of the new Fine Arts Complex opening in January 2017. His collection will be a fresh resource for art history, archeology, and anthropology instruction and student research. The College will also add a new certificate program in museum studies in 2018. The artifacts will serve as a hands-on repository for learning proper care and display, and an archival resource for students in the museum studies program.

ARTESIA’S BENOIT CONTINUES TO BE A THORN IN JOHN GLENN’S SIDE, PIONEERS REMAIN TIED FOR FIRST

Last season, Artesia High running back Jordan Benoit was nearly a one-man show when the Pioneers faced John Glenn High, rushing for 345 yards and scoring five touchdowns on the ground that totaled 273 yards. Now a senior, Benoit was up to his old tricks against the Eagles again, this time on Artesia’s homecoming where it was all about the ‘city nights’.

Benoit scored five touchdowns again, four on the ground, and rushed for 155 yards on 23 carries as Artesia outlasted Glenn 48-27 last Friday night. Benoit has now rushed for 744 yards on 86 carries this season and has scored all but two rushing touchdowns the Pioneers have put on the board.

“It’s nothing really personal,” Benoit said about playing Glenn. “I feel like I have to try my best every time and run as hard as I can every time I get the ball. It just happens every time I run the ball.”

The win improved Artesia’s mark to 5-1 overall and 2-0 in the Suburban League. The five victories are two shy of the combined total from the previous two seasons and the Pioneers are off to their best league start since 2008 when Artesia won its first three league games. That was also the school’s last trip to the California Interscholastic Federation-Southern Section playoffs.

“We’ll take it,” said Artesia head coach Joe Veach. “We’ve had a lot of home games [this season] and you always hope to win all of your home games. We’ve played some teams that are going through some rough patches. But I think that we’ve gotten better each week on offense. We’ve moved the ball against everybody and we’ve played just enough defense, it seems like, that we

keep getting wins.”
Artesia was up 28-14 at the half when Glenn began the second half on a 10-play, 80-yard drive that ended with a two-yard touchdown run from junior running back Carlos Pulido. The Pioneers responded with a drive that took nearly five minutes off the clock and ended with a Benoit one-yard score. That’s when Artesia decided to make the game interesting.

Senior kicker Frankie Sierra was successful on an onside kick and ended the drive with a 37-yard field goal with 1:13 left in the third quarter. The big play of the drive was a 30-yard pass play from sophomore quarterback Heder Gladden to senior wide receiver Rian Hughing that was tipped by Glenn junior cornerback Gerardo Godoy.

The Pioneers went for another onside kick, were successful again, and the ensuing drive also ended in a Sierra field goal, this one from 24 yards out just 55 seconds into the fourth quarter, making the score 41-21. Artesia would then seal the game when Gladden scored on an 11-yard run just five plays after sophomore linebacker Leroy Gladden picked off sophomore quarterback David Sanchez on the first play following Sierra’s second field goal.

“Frankie’s a great kicker,” Veach said. “He’s such a good soccer player; he’s so skilled with his feet, obviously. After it was a two-score game, we wanted to take a chance if we thought it was there.”

This was the second game in a row that got away from the Eagles quickly in the third quarter. After playing Norwalk High to a scoreless first quarter and 7-7 at halftime the previous week, Glenn was outscored 19-7 in the third quarter as the Lancers went on to a 46-14 victory.

“Even in the second half, I felt there was a little momentum,” said Glenn head coach Vince Lobendahn. “Then they onside me and...if those are legal kicks, I’m impressed.”

From the way the game began, it appeared that this was going to be a back and forth shootout. Benoit scored from five yards out on the first possession of the game only to see the Eagles (1-5, 0-2) tie the game with 5:28 remaining in the stanza on a Sanchez six-yard run. But four plays later, Benoit hauled in a 37-yard pass from Heder Gladden and the Pioneers would maintain the lead the rest of the way. Benoit would add touchdown runs of 11 yards and one yard in the second quarter and has found the end zone four times from the ground twice this season.

“Jordan played good,” Veach said. “I thought we blocked well up front. I thought they gave us some looks that took away a lot of our offense, but also opened up some things.”

“Literally, he encompassed my whole defense,” Lobendahn said. “We had our corners, safeties, backers, linemen all taking away the fly and even when we were trying to take it away, he gets outside. And it didn’t look as bad this year. It showed up on paper as five [touchdowns]. But we felt we had some bottling happening and then boom, and inside counter or an outside quarterback keeper.

Benoit has reached 100 yards rushing four times this season but still leads the league in rushing and in touchdowns scored. In fact, his 17 total touchdowns are nearly three times more than the next player.

“Every Saturday after a game, I go on MaxPreps.com and check how many yards I have,” Benoit said. “And then the upcoming week, I’ll [say], ‘okay, for this week I want 200 yards and this [number] of touchdowns this game’.”

Glenn tried to make it game nearly halfway through the second quarter and received a three-yard touchdown pass from Sanchez to sophomore wide receiver Tim Stevenson. The last Glenn score of the game came with 81 seconds remaining when Sanchez tossed a 14-yard strike to sophomore wide receiver Keith Shanklin.

“They are so much improved from the last couple of years and I told the kids all week, ‘this is not the Glenn that we’ve played the last couple of years and if you think that way, they’re going to beat us’,” Veach said. “They’re doing a great job over there and their quarterback is a good, little athlete. He throws the ball where it needs to be.”

“We had to let the guys know this game isn’t over and it’s not going to be easy, and we had to come back in the second half and do what we’re supposed to do,” Benoit said about the talk in the locker room at half-time.

Sanchez completed 18 of 29 passes for 229 yards with Stevenson the recipient of seven of those completions for 61 yards. Shanklin and junior Carlos Manriquez each caught four passes for 93 and 63 yards respectively. The Eagles, who have assured themselves of at least their 19th straight non-winning season, will host Bellflower High tonight at Excelsior Stadium.

“They don’t have the double hit here but they have skills,” Lobendahn said of Bellflower. “You know they’re going to have that. Their record isn’t great, but they might be playing a lot better opponents than I’m playing. So I can’t see until I get it all

SUBURBAN LEAGUE GIRLS VOLLEYBALL

NORWALK, WHITTALL HANDLE CERRITOS WITH EASE, TIGHTEN SUBURBAN LEAGUE RACE

Over the past several seasons, the better Suburban League girls volleyball matches have come when Cerritos High, Mayfair High and Norwalk High all play each other. But very few people would expect Norwalk to sweep Cerritos, considering it had not happened in at least the previous 36 meetings.

Norwalk did that, and senior outside hitter Ashley Whittall was a major part of the Lady Lancers 25-10, 25-18, 25-21 victory last Thursday. Whittall went off for 31 kills, six more than the entire Cerritos squad. The win kept Norwalk right at the top of the league as it improved to 10-9 overall and 5-1 in the circuit at the time while Cerritos lost its first league match and Mayfair remained undefeated in league action. This was also the sixth time since 1998 that Norwalk had defeated Cerritos.

“Just getting to know [Ashley] over the practices and all of these games, it’s very hard to put so much trust in a player,” said Norwalk first-year head coach Hector Guevera. “To trust in her and believe that she believes in herself, we’ve noticed that and we see that in Ashley. That’s why we give her that freedom to call what she wants to hit.”

“I was expecting we would come out with intensity but we came out with a lot more than I thought we would,” Whittall said. “We knew it was going to be a big match. We always play up when we’re playing good teams.

“I just knew that this was a big game and I needed to be leading the team in kills and everything,” Whittall later said. “So, I just tried to step it up for everyone.”

After the Lady Dons held a slim 3-2

in the film room. We’re willing to go after people. I’ve got a few players who I’ll go after. I know where I can find some success on the defense. That’s what we’re looking to do. But, on the other side of the ball, we need stops to help my offense continue to get back out there.”

Besides Benoit doing his thing, Heder Gladden was double trouble for the Glenn defense, completing 13 passes in 21 attempts for 170 as well as rushing for 140 yards on 13 carries.

“Heder is a great athlete,” Veach said. “He wasn’t with us that much in the spring for a number of reasons. Then in the summer we were bouncing him back and forth from quarterback to receiver and even in the first two games, he didn’t start at quarterback. But ever game, he just gets better and better.”

On defense, senior Armando Pacheco and junior linebacker Xavier Yoakum each led the Pioneers with eight tackles. Now, Artesia will have the tall task of slowing down a hot La Mirada High team which has posted consecutive 62-0 shutouts against Cerritos High and Norwalk High.

“La Mirada is great and they’re a really good team,” Veach said. “They play good football and their coaches do a good job over there. But they’re kids just like our kids are kids and we have to go out there and play them. I think we can do some things.”

“It’s going to be tough, I’m not going to lie,” Benoit said. “They’re good almost every year, basically. But I think we have a good chance to run the ball against them. And we have a good quarterback, so we can pass the ball a little bit. As long as we execute, we’ll do good.”

lead in the first set, Whittall’s second kill gave the serve to senior defensive specialist Mercedes Orozco, where she reeled off five straight points. After Cerritos picked up a point, senior setter Annissa Uncapher served six consecutive points and the Lady Lancers were off and rolling. Whittall had 13 kills in the first set while the team served seven aces.

Norwalk was again off to a fast start in the second set, scoring six straight points early thanks to four aces from junior setter Danielle Gomez. The hosts were up 20-10 before the Lady Dons made a small surge to get back in the set. Sophomore outside hitter Samantha Oh had her fourth kill, then served five points in a row with three aces. But it was too little, too late as a Whittall kill and an Uncapher ace ended the set.

“It took us a while to show up,” said Cerritos head coach David Cuthbert. “Obviously Norwalk played really well today. But I think across the board, we’re really disappointed with how we played.”

What was causing havoc for the Cerritos defense was the unpredictability of Whittall. When the Lady Dons would prepare for her to slam the ball down the middle of the court, or even off to the sides, she would, at times, simply send a soft lollipop-style of a kill into an open area, or a tip at the net.

“A couple of times when she would do that, especially from the back row, Cerritos would back up their defense,” Guevera said. “She notices that and that’s why she does those tips. She’s a very smart player and we see that whenever she goes to hit from the outside, right side, middle; wherever she’s at, if she sees a line open, she’s going to go for it.”

“I don’t think we were confused; we just didn’t execute,” Cuthbert said of Whittall. “We knew exactly how to play and defend

her. We just didn’t do it, which is frustrating. She’s a good player and they’re going to be successful if she can play how she wants to play with very little in the way.”

Three more kills from Whittall, an ace from Gomez and a block from junior middle blocker Tais Guzman put Norwalk up 5-0 in the third set. But the Lady Dons quickly responded and tied the set after junior middle blocker Kelly Amalu had just her second kill. Norwalk would open up leads of three and two points respectively, only to see Cerritos come back to tie.

But with the score knotted at 10-10, Whittall had the first of four kills as part of a rally that put the Lady Lancers up 16-10.

Again, Cerritos refused to go away, getting to within two points twice. In the end, it was too much Whittall and too much of Norwalk’s serving, which had 21 aces.

“We emphasized that a lot during preseason and going into [league] because that was one of the things where we were becoming inconsistent in,” Guevera said of his team’s serving. “We wanted to drill that into our players’ heads.”

“We weren’t engaging,” Cuthbert said. “Volleyball is a team sport filled with one on one matchups; blocker against hitter, server against passer. And we weren’t engaging in the individual matches. We were just letting things happen. We looked a little vacant, we weren’t together, and we weren’t loud. All the things we expect our team to be, we just weren’t.”

Whittall wasn’t the only one providing all of the points as senior outside hitter Valerie Ortega pitched in with half a dozen kills while Guzman and senior libero Paola Nava each had a pair of kills.

“She didn’t play too much last year but this year, after playing a year of club [volleyball], she really has stepped it up and

became a well-rounded player,” Whittall said of Ortega.

Norwalk began the second round of league action with a 25-13, 25-19, 25-11 sweep at Bellflower High this past Tuesday, the team’s eighth non-tournament sweep in 2016. The Lady Lancers, which travelled to La Mirada High on Oct. 6, will visit John Glenn High on Tuesday before taking a week off in preparation for their rematch with Mayfair, a home encounter on Oct. 18.

“Our mentality right now is no matter who the team is, whether we’ve beaten them or not, we’re still going to bring a great game for them,” Guevera said. “We’re going to keep pushing and we’re going to get that ‘W’, no matter who it is, no matter who is on the front row or back row or who we’re going up against.”

“I know Mayfair is going to be another struggle again the next time we play them,” Whittall said. “But I’m pretty sure if we play how we played today, we can beat them or be really close with them.”

Oh led Cerritos with six kills and six aces while Amalu added another five. The Lady Dons would get back to their winning ways with a 25-4, 25-16, 25-4 win over Glenn this past Tuesday to improve to 10-2 overall and 5-1 in league action. They hosted Mayfair on Oct. 6 and will be home to Artesia High on Tuesday before going to Mayfair on Wednesday to make up a match that was postponed from Sept. 13. The next day, Cerritos will visit Bellflower.

“I think all of the games should be competitive,” Cuthbert said. “Obviously from the results from the first round, Mayfair has the advantage and we’re third in the pile. I think we can play far better than that. I think we match up well when we do things we’re supposed to do.”

Christian High on Thursday.

Cerritos High and Norwalk High are also in the running for a potential Suburban League crown as the former was 4-1 in league play and the latter 5-1 entering the action on Oct. 6. Mayfair High was undefeated and visited Cerritos on Oct. 6. They’ll meet again at Mayfair on Wednesday.

CROSS COUNTRY

The first Suburban League cluster meet was held at La Mirada regional Park last Thursday and the Norwalk High girls team had a solid performance, picking up 22 points with juniors Misty Diaz and Ruby Galindo claiming the top two spots at 19:21 and 19:38 respectively. Junior Jessica Robles came in fifth place at 20:32 while senior Alejandra De La O was right behind her at 20:37.

Cerritos High came in third place with 82 points with sophomore Jaide Lin the top Lady Dons runner at 21:30, good for ninth place. The next Cerritos runner was junior Brianna Katsuda, who placed 13th with a time of 22:16.

For the boys, Cerritos came in second place with 52 points and was led by junior Jaineel Patel, who came in third place at 16:37. Two spots behind Patel was freshman Cole Sawires Yager with a time of 17:05.

Norwalk High was a distant third with 99 points. The top Lancers runner was senior Edwin Munoz, an 11th place finisher with a time of 17:24.

The top John Glenn High runner was sophomore Antonio Calderon, who came in seventh place with a time of 17:11 while Artesia High junior Jesus Orbe came in eighth place with a time of 17:12. As a team, Glenn was fourth with 107 points. The second league cluster meet will be on Thursday at Cerritos Regional Park.

The hottest football team in the area is not Norwalk High or Valley Christian High, the two schools who have consistently advanced to the California Interscholastic Federation-Southern Section playoffs. It’s actually Gahr High, which is 5-0 and coming off its bye week.

The Gladiators return to the field when they host Lynwood High (3-2 overall) tonight at Dr. Hanford Rants Stadium. Gahr, which has had 3-7 marks the past three seasons, last won five games in 2012. But, Gahr has not opened a season with five straight wins since before 1998. Even when Gahr won 10 games in 2007 and advanced to the semifinals, it went 4-1 in the non league part of its schedule. Gahr is 9-5 in the last 14 meetings with Lynwood including last season’s 21-6 road win in the league opener. The last time the Gladiators defeated the Knights at home was in 2012, a 42-35 victory. The Gladiators are the ninth ranked team in Division 10.

In other football action, Cerritos High will have its bye following a 48-13 loss to Mayfair High last Friday in which the Monsoons held a 14-7 halftime lead. The

who are voting age however none of the five current members of the city Council is Latino and, with one exception, there have been no Latino city council members since the City’s incorporation.

Based on that, MALDEF concluded that the lack of success of Latino candidates results from the inability of Latino voters to elect candidates of choice due to racially polarized voting among the electorate.

The letter went on, “in the absence of a satisfactory response from the city MALDEF will be forced to seek judicial relief in the form of an action to obtain an order converting the election system from at-large to by-district together with other relief provided for in the CVRA including an award of litigation and witness costs and attorneys fees.

The council, on a 4-1 vote, approved a settlement with the MALDEF requiring districts for the March 2017 election, and paid \$30,000 to MALDEF for its expenses.

Councilman Andrew Sarega cast the lone no vote against the settlement.

Sarega and Councilwoman Pauline Deal’s terms expire in March 2017.

The City has placed four proposed maps (labeled Map 1, Map 2, Map 3, and Map 4) on its website for residents to study and comment on the boundaries.

HewsMediaGroup-CommunityNews, via a public records request, obtained the addresses of all current Councilmembers and pinpointed the addresses on the four proposed maps.

Only one map, Map 2, placed the current council in five separate districts the remaining three placed two councilmembers in the same district leaving one other district open.

Map 1 placed both Councilmembers Deal and Sarega in District 4, leaving District 1 open for a resident to run for a Council seat.

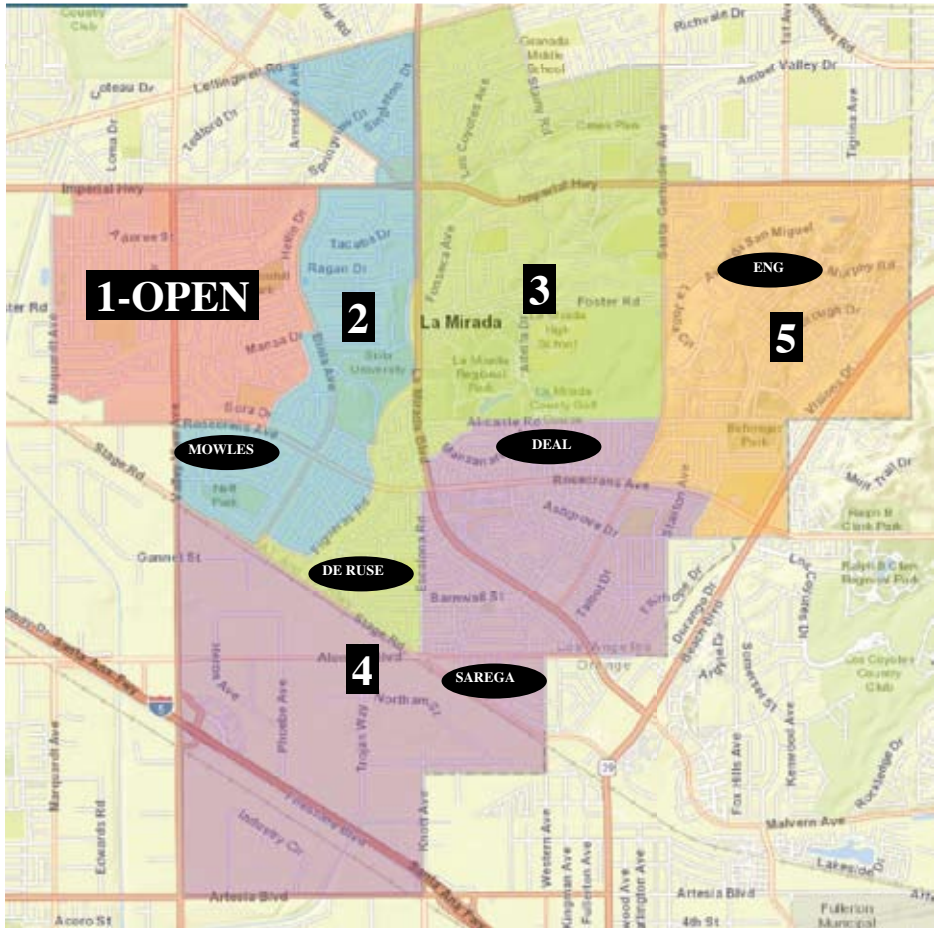
Map 3 placed Mayor De Ruse and Sarega in District 4, leaving District 2 open for a resident to run for a Council seat.

A proposed timeline calls for final adoption by Nov. 8.

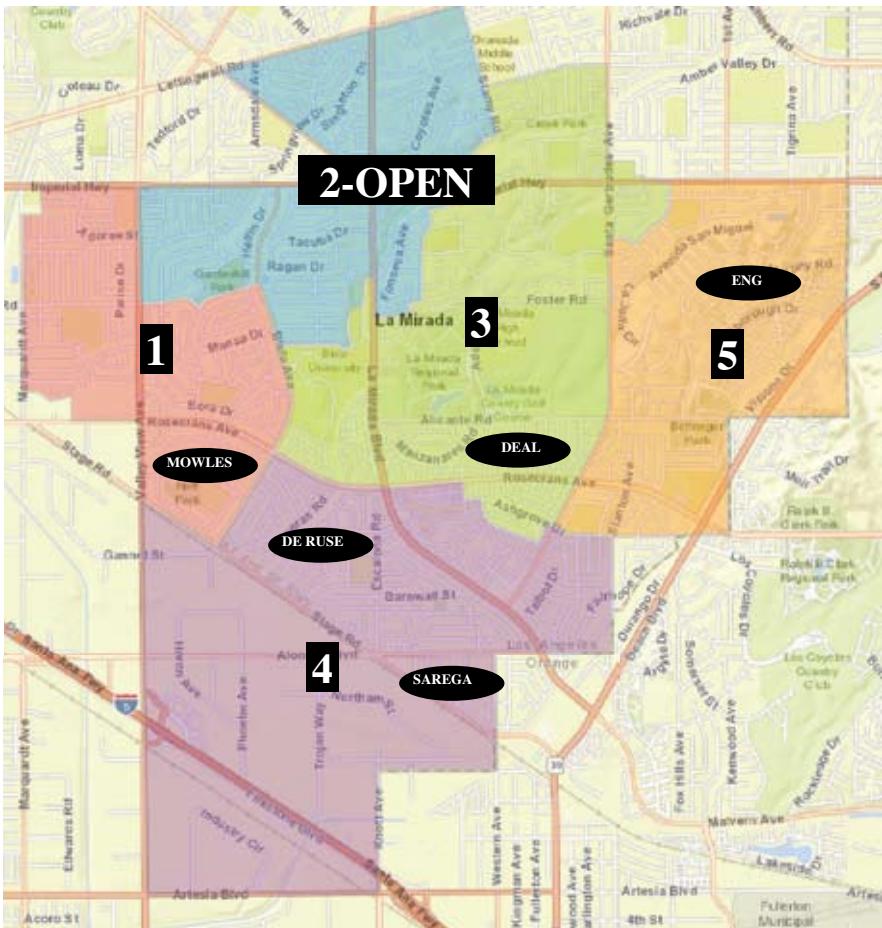

MAP ONE



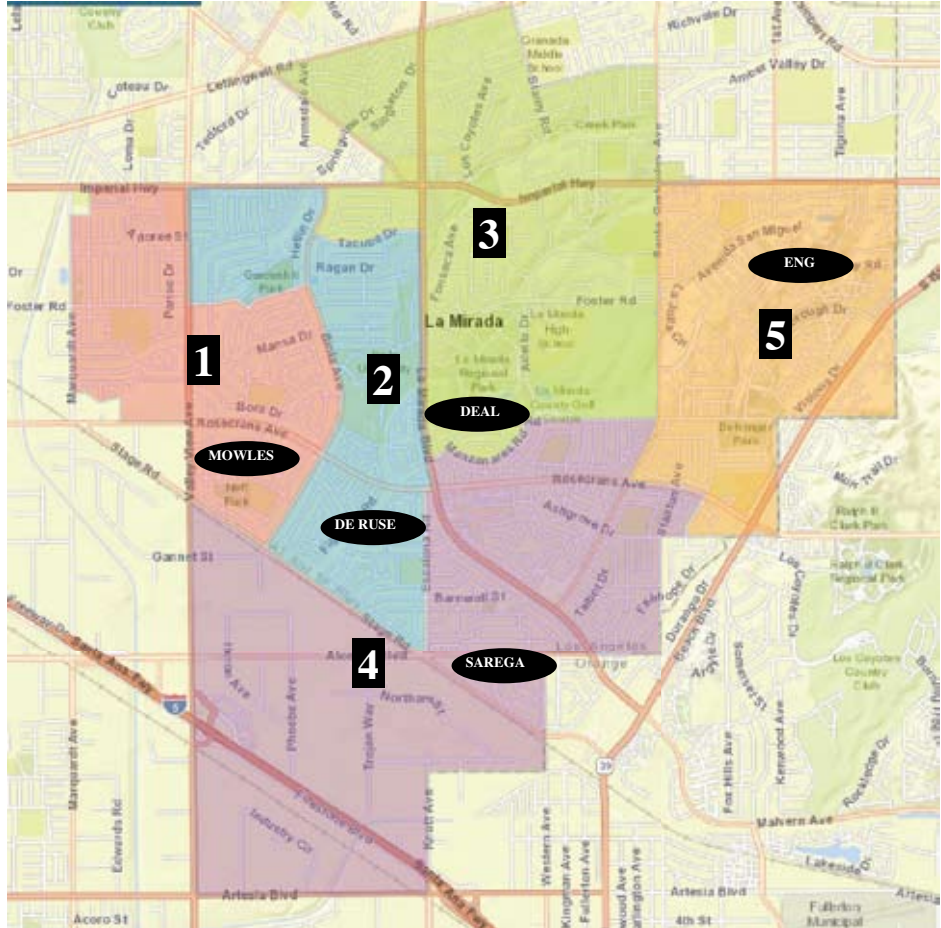
Map 1 placed both Councilmembers Deal and Sarega in District 4, leaving District 1 open for a resident to run for a Council seat.

MAP THREE



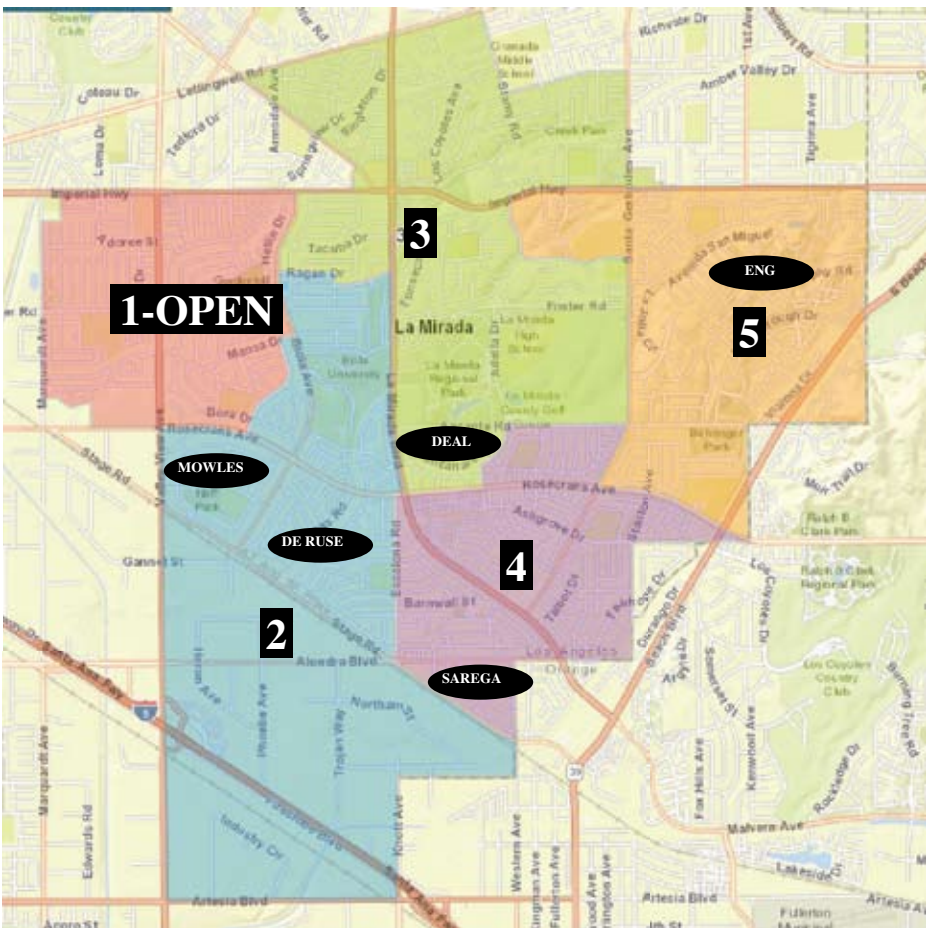
Map 3 placed Mayor De Ruse and Sarega in District 4, leaving District 2 open for a resident to run for a Council seat.

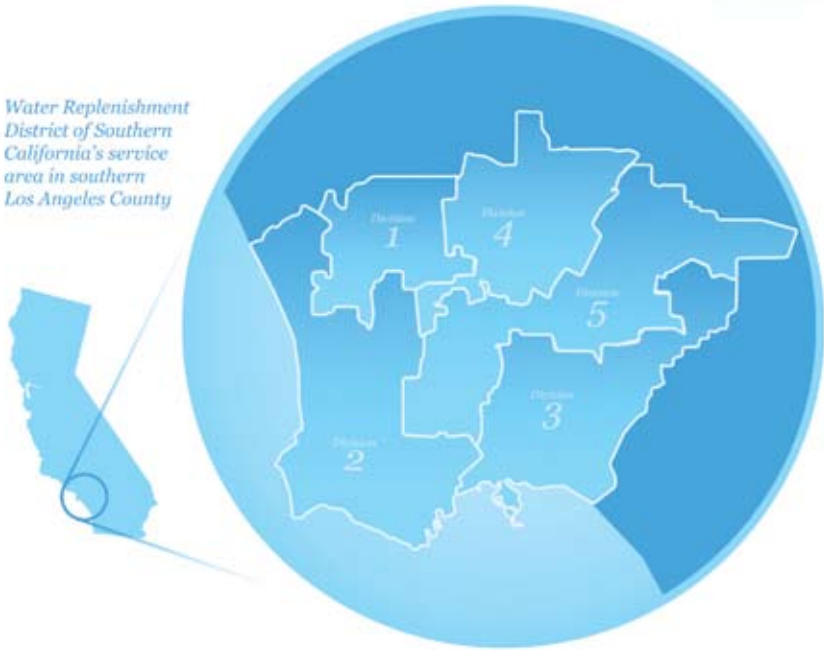
