



NEW CENTRAL BASIN WATER BOARD OUSTS PHIL HAWKINS AS PRESIDENT

Wasting no time with their agenda, William Gedney, Mark Grajeda and John Oskoui, the three new Central Basin Water District Board members (CB) appointed last Wednesday, have sided and allied themselves with Directors Leticia Vasquez and Bob Apodaca and have voted to throw the operations of the embattled water agency into questionable territory once again.

After only one month at the position, they removed President Phil Hawkins.

The move has many questioning the motives of Gedney, Grajeda, and Oskoui who were appointed to the Board per the "mandate" of AB 1794, authored by Assemblywoman Cristina Garcia (D-Downey).

Vasquez is a "party plaintiff" in a whistleblower lawsuit against Central Basin that has cost the agency hundreds of thousands of dollars to defend. And, as documented by HMG-CN, Vasquez has a very checkered past since her election in 2012.

Apodaca recently had to settle a sexual harassment lawsuit that cost the district over \$1 million dollars after legal fees were factored in. HMG-CN also exclusively reported that Apodaca's common law wife was paid \$10,000 for "floral arrangements" provided at special events.

ST. IRENAEUS' SCHOOL SUPPLY DRIVE HELPS CHILDREN IN GHANA, AFRICA

Fr. Rudy Alumam is priest from a diocese in Ghana, Africa, who is currently serving as a Parochial Vicar at St. Irenaeus Church in Cypress, California.

Fr. Rudy came to St. Irenaeus in July of 2015 through a special partnership with the Diocese in Ghana and the Diocese of Orange; he will be serving parishioners of St. Irenaeus until 2019.

Fr. Rudy is from a tiny impoverished village in Ghana called Ve, with an equally impoverished school system.

The Ve school system has 100 students in pre-school, 1,000 students in two elementary schools, and 250 students in middle school.

High school students have to travel to other towns for their classes.

Most families are too poor to provide school supplies, and often the children

come to school without breakfast. Parents are mostly agriculture farmers and struggle to feed their families.

Fr. Rudy wanted to help provide students in Ve with school supplies so they would have the tools necessary to improve their education hoping that by improving the student's education, they would have better opportunities in the future.

Armed with that passion, Fr. Rudy conducted a Ghana School Supplies Drive for two weekends at St. Irenaeus.

Father Rudy's wish list was extensive; college ruled spiral bound notebooks, college ruled composition note books, pens, pencils, crayons, coloring books, backpacks, scientific calculators, lightly used or new shoes, sandals, t-shirts, summer clothes, soccer balls and monetary donations for shipment.

HMG-CN INVESTIGATION DARK MONEY DONATIONS AFFECTING LA MIRADA CITY COUNCIL RACE

Campaign documents obtained by Hews Media Group-La Mirada Lamplighter from the La Mirada City Clerk's office show that large sums of obscure campaign monies have been given to a questionable committee to influence the normally tranquil La Mirada City Council race.

In addition, District 1 candidate Diane Gramajo took large donations from two well-known local elected officials in the

The normally tranquil La Mirada City Council campaign has turned into a gloves off affair and residents are not happy about it.

Investigations by Hews Media Group-La Mirada Lamplighter reported online Monday (in print above this story) about dark money donations to an obscure committee called Residents for a Better La Mirada (RBLM) that is attempting to

Haskell MS Principal Camille Lewis, Carmenita MS Principal Robert Castillo, Tetzlaff MS Principal Kester Song and selected teachers from each school were recognized at the Awards Ceremony.

The Schools to Watch—Taking Center Stage grades schools are high performing model schools that demonstrate academic excellence, responsiveness to the needs of young adolescents and social equity. These schools host visitors from California and around the world who are looking to learn practices they can use to improve their middle grades schools and close the achievement gap. Schools must complete an extensive application that is reviewed by middle grades experts. A validation visit is conducted at the school site at the end of fall. In order to retain their designation, each school must be re-evaluated every three years.

Haskell MS, Carmenita MS, and Tetzlaff MS will also be honored at the National Forum to Accelerate Middle Grades in Washington, DC at the end of June. ABCUSD is only one of two school districts in California where every middle school has been selected as a Schools to Watch. Both Fedde MS and Ross MS are also Schools to Watch/National Model Middle Schools.

GRACE HU OFFICIALLY ANNOUNCES RUN FOR CERRITOS CITY COUNCIL

GARAMENDI'S BILL TO INCREASE SOCIAL SECURITY BENEFITS

Congressman John Garamendi (D-CA) introduced H. R. 1251, the CPI-E Act of 2017. This bill would make Social Security fairer to seniors by requiring the program to use the Consumer Price Index for the Elderly (CPI-E) to calculate cost of living adjustments for retirement benefits. This would increase benefits and better ensure that cost of living adjustments in Social Security actually reflect the real rising costs for seniors and disabled people in America. From 1982 to 2011, CPI-E rose at an annual average rate of 3.1 percent, compared with 2.9 percent for the methods that are currently used. "Our senior and disabled citizens rely on Social Security benefits for a large portion of their income, and it's about time for Social Security benefits to reflect their lifestyles," said Garamendi. "Using a Consumer Price Index that actually reflects how retirees spend their money – especially in health care – is a no-brainer that will increase benefits and make Social Security work better for the people it serves." The legislation has already earned broad support, with 24 original co-sponsorships and key support from leading advocacy groups and labor organizations. "Social Security Works applauds Rep. Garamendi for championing Social Security and sponsoring the CPI-E Act of 2017," said Nancy Altman, Founding Co-Director of Social Security Works. "One of the most valuable features of Social Security is its inflation protection. By more accurately accounting for the costs faced by Social Security beneficiaries, this legislation better prevents the erosion over time of modest but vital earned benefits."

DOWNEY REDUCES STORM WATER POLLUTION USING BOX FILTERS AND MINI BIO-RETENTION AREAS

Staff Report

Under Proposition 84, the City of Downey will be participating in a region-wide effort to reduce storm water pollution in our local waterways. Forty-three Low Impact Development [LID] treatment systems will be installed throughout eleven cities in the Los Angeles River, San Gabriel River, and Los Cerritos Channel watersheds.

The City has constructed a bioswale along Firestone Boulevard and will install four tree box filter systems near the intersections of Barlin Avenue and Cheyenne Street, Bixler Avenue and Prichard Street, Faust Avenue and Foster Road, and Pangborn Avenue and Firestone Boulevard.

These streets are known to have high concentrations of metals.

These projects will begin under Proposition 84 Grant - the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006.

Prop 84 provides funds to the State Water Resources Control Board in the amount of \$82 million for matching grants to local public agencies for the reduction and prevention of storm water contamination of rivers, lakes, and streams.

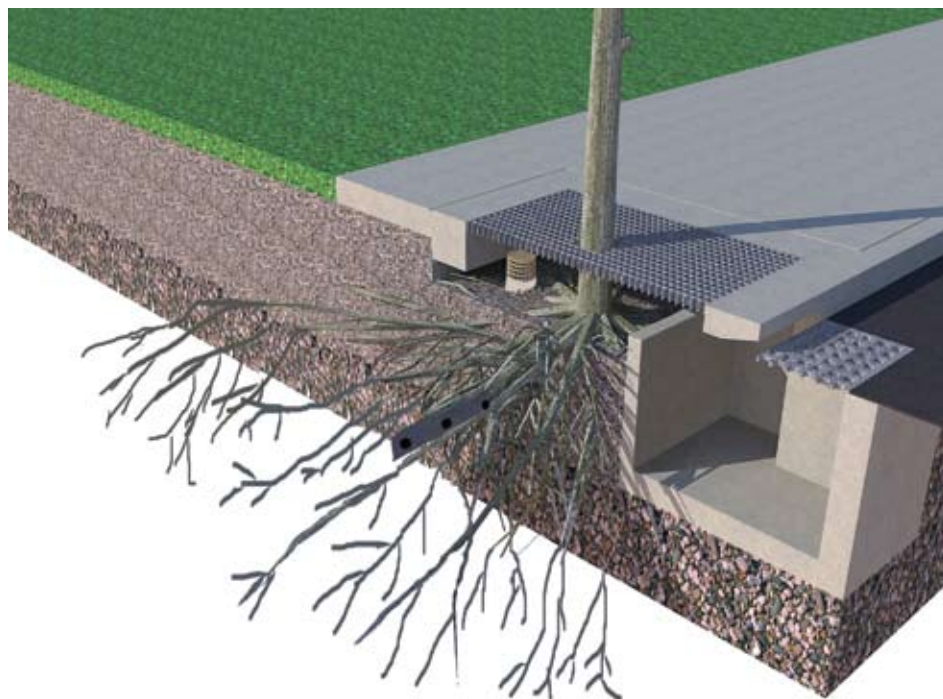
According to Urban Design Tools, the tree box filters are mini bio-retention areas installed beneath trees that control runoff.

The runoff is then directed to the tree box, where it is cleaned by vegetation and soil before entering a catch basin. The runoff collected in the tree-boxes helps irrigate the trees. The system consists of a container filled with a soil mixture, a mulch layer, under-drain system and a shrub or tree.

Storm water runoff drains directly from the surface through a filter media. Treated water flows out of the system through an under drain connected to a storm drainpipe / inlet or into the surrounding soil.

Through the \$82 million in funding through Prop 84, the Storm Water Grant Program was able to use approximately \$5.5 million [in grants] using Proposition 40 Urban Storm Water. Twenty-four implementation projects totaling approximately \$39.7 million and 18 planning and monitoring grants totaling approximately \$8.9 million were awarded during the Round 1 solicitation. Twenty-seven implementation projects totaling approximately \$38.7 million were awarded during the Round 2 solicitation.

The project was awarded to John L. Hunter and Associates, an environmental consulting firm. The firm provides

expertise to support mandated programs, which includes storm water runoff quality control, industrial wastes, used oil recycling, beverage container recycling, and water conservation.

Construction of the bioswale was completed in May 2016. Construction

influence the La Mirada city council race on March 7.

RBLM is located in La Mirada, its treasurer is La Mirada resident Ionel Imbre.

Campaign documents obtained by HMG-LML from the La Mirada City Clerk's office showed large donations from a shady La Habra based construction company to RBLM that was used to slam District 1 candidate John Lewis and District 2 candidate and incumbent Pauline Deal with negative direct mail advertisements.

Deal is running against incumbent Andrew Serega, while Lewis is running for the newly created District 1 against Tony Aiello, Diane Gramajo, and Jim Emmerling.

HMG-LML identified the construction company as Diamond Construction and Design, found that the company had a UPS Store PO Box in La Habra as their business address, and finally found that the mailing address is in Buena Park and the owner is Stelian Onufrei.

Diamond and presumably Onufrei donated \$6,500 to RBLM to oppose Deal and Lewis, with RBLM direct mailing "hit pieces" against the two candidates to La Mirada residents in District 1 and District 2.

Many La Mirada residents called and emailed HMG-LML angry with the

mailers and the content that blasted Deal and Lewis.

And those mailers could place RBLM and its treasurer Imbre in legal hot water.

They could also place Serega and Aiello in legal hot water and could severely hurt their respective campaigns.

COORDINATION?

HMG-LML has examined the campaign documents and three direct mail hit pieces sent out by RBLM against Deal and Lewis.

Also examined were the campaign documents and direct mail pieces sent out by Aiello and Serega promoting their own campaigns.

The similarities between the information on the campaign documents, the mail pieces and campaign flyers strongly indicate coordination between RBLM, Serega, and Aiello.

Coordination between an "Independent Expenditure" (IE) committee such as RBLM and candidate(s) is a violation of Fair Political Practices Commission laws under the Political Reform Act.

ALL THREE USED THE SAME PRINTER IN TEXAS-

According to campaign documents, the three direct mail pieces sent out by RBLM against Deal and Lewis were printed at Print Place located at 1130 Ave. H East in Arlington, Texas.

They were mailed from zip code 76161, which is a United States Post Office in Fort Worth, Texas.

Examining District 1 candidate Tony Aiello's campaign documents show his mail pieces printed at Print Place 1130 Ave. H East in Arlington, Texas.

And, similar to RBLM's mailers, Aiello's mail pieces were postmarked and mailed from the same US Post Office in zip code 76161.

Examining all of Serega's mail and campaign flyers show printing at Print Place 1130 Ave. H East in Arlington, Texas.

In addition, all direct mailed flyers were very similar in design, indicating the same graphics designer was used for RBLM, Aiello, and Serega.

The ramifications of a candidate(s) coordinating with an IE are very onerous.

Each violation can carry a maximum fine of \$5,000 under Section 18225.7 of the Political Reform Act.

If Serega and Aiello were found to coordinate with RBLM on campaign mailers and flyers, they, along with Imbre, could be fined as much as \$25,000.

Several emails into Serega have been unreturned. Texts into Tony Aiello today were unreturned as of publication time. Supporting documents can be found online at loscerritosnews.net.

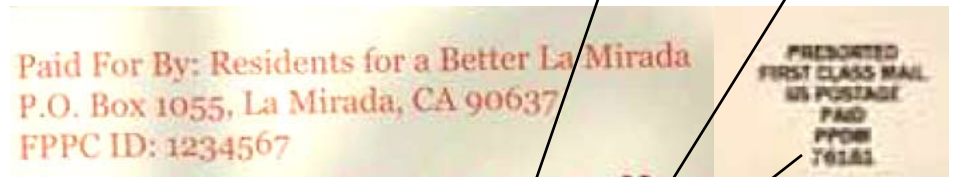

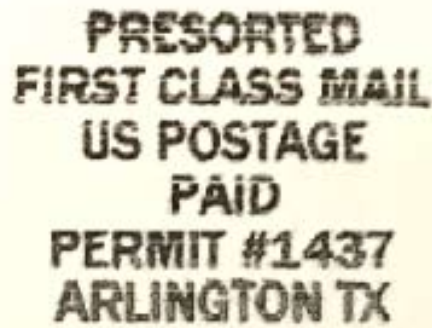

And the parishioners of St. Irenaeus responded.

Over 80 large boxes were filled with donations of notebooks, pens, pencils, crayons, scientific calculators, summer clothes, shoes, backpacks and soccer balls that Rudy had asked for.

But the supplies needed to be shipped from Cypress to Oakland, and finally to the village of Ve.

Parishioners Dave and Dawn Gallagher volunteered to lead the movement to get the supplies to Ve.

Weighing a total of 3,500 pounds, the supplies were loaded onto a truck with parishioners stepping up and donating funds to pay for the shipping, including 450 miles of ground transportation.

The total shipping cost was \$2,500.

It will take about six weeks for Fr. Rudy's school supplies to reach Ve; it will not be until late March before Fr. Rudy learns of the joy the supplies will no doubt bring to the village.

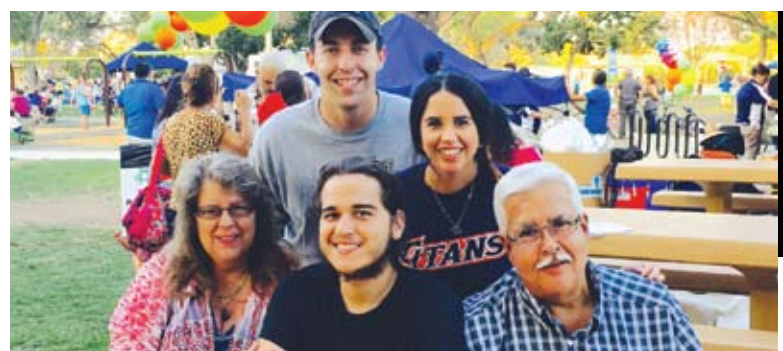

POLLARD'S LATE GOAL EXTENDS VALLEY CHRISTIAN'S SEASON, LADY CRUSADERS RALLY PAST JURUPA HILLS

It was only a matter of time before the Valley Christian High girls soccer team would really face adversity, as in actually trailing. The Lady Crusaders had not trailed in a game since Dec. 16, which was also their last loss.

So, there was reason to be a little concerned when V.C. was down 1-0 to Jurupa Hills High in a California Interscholastic Federation-Southern Section Division 6 quarterfinal playoff game last Friday night. But then came the equalizer, followed by sophomore midfielder Christina Pollard's game-

winner as time was winding down and the Lady Crusaders escaped with a hard fought 2-1 win.

How unusual were things against the Spartans? Since Dec. 29, V.C. had only yielded one goal, which game on Feb. 9 at Heritage Christian High. Also, the Lady Crusaders had not played in a scoreless first half since Jan. 4 when their game with St. Anthony finished in a scoreless tie.

"We've been trying to prepare our kids the last two weeks," said V.C. head coach Kim Looney. "This is not normal; this is not normal to win 5-0, 7-0. When you get to the quarters, it changes. We were getting ready for that. We spent a lot of time on tactical situations yesterday being down a goal, being tied, being in overtime."

"The whole last six minutes was so full of hesitation and anxiety," Pollard said. "We were really pushing and pushing 110 percent. For the last couple of minutes, I did struggle a bit. But I did redeem myself at the end and it was just full of excitement. I couldn't have done it without my teammate [freshman midfielder] Megan [Bouma]. It was just a team play and I just love my team very much."

With the score tied and six minutes remaining in regulation, Pollard received a flick off a free kick but missed an open left side of the net when her shot sailed to the left of the post. Then with a minute remaining, she took a hard shot inside the goal box, only to see it get saved by Marilu Armas. But seconds later and as stoppage time was approaching, Pollard took a pass from Bouma and connected on the biggest of her seven goals this season.

"I saw that the ball has been crossed

and Megan had the ball," Pollard said. "Then I thought to go in the box just in case she was going to cross it back. When she crossed it back, I had to focus on hitting the ball low and hard away from the goalie. Right when I did that, it just went straight in."

"Christina is a competitor by nature," Looney said. "She is very hard on herself and she expects a lot from herself and her team. There were three shots on goal. You can't yell at Christina. You just have to tell her she's there and she's going to get it in."

The first half was completely dominated by the Olympic League champion Lady Crusaders, the second ranked team in the division, as they took 11 shots on goal and nine corner kicks. In the ninth minute, junior forward Lauren Castillo saw her shot get deflected at the right post, which led to the fifth corner kick. The one and only shot the seventh ranked Spartans took in the first half came one minute before halftime. A free kick taken by Angie Dias inside the penalty arc was blocked by a V.C. wall of defenders.

"It was so frustrating because we kept on getting corners and corners; we kept getting chances after chances but we could never get our head to the ball," Pollard said. "Or when we did get to it, the goalie was right there in front of it. But we never gave up and we always kept trying."

"I'm going to commend their goalkeeper," Looney said. "We haven't seen a goalkeeper that good all season. She knew how to play everything. We were not prepared for the corner kicks not man-marking us."

The scoreless tie was broken in the 57th minute when Pamela Huaman fed a

beautiful pass to Taylor Skillern and for the first time in over 1,400 minutes, the Lady Crusaders were staring at a deficit. But that lasted three minutes because of a 'right place at the right time' situation by Bouma. In the 60th minute, a free kick from junior defender Caitlyn Wind was initially stopped by Armas. But when she couldn't completely contain the ball, it squirted away from her and there was Bouma to tap it in for the equalizer.

"We talked a lot about what does that mean," Looney said about trailing. "Get the ball out of the back of the net, settle down, listen to us as coaches. That is where I am most proud of them tonight, because they didn't stop. With 20 minutes left, down a goal, they didn't stop. They kept playing."

V.C. finished the game with 20 shots on goal to just three by the Spartans. The victory moved the Lady Crusaders into the semifinals where they visited West Valley High this past Tuesday and moved one step closer to its championship goals with a 2-0 victory. It's the first time since 2009 V.C. has advanced to the semifinals, as well as the divisional finals. Pollard and sophomore forward Kennedy Wesley accounted for the two goals. The Lady Crusaders will now take on top seeded Grace Brethren High on Saturday.

"I wanted to get to [the Jurupa Hills] game with this group," Looney said. "What happened in this game tonight...I honestly just left it up to the kids and God knew what was going to happen. To now go beyond that is a gift. It's a gift for me. These guys have done far more than I could have ever asked them to do."

VALLEY CHRISTIAN RALLIES IN FOURTH QUARTER TO EARN BERTH IN DIVISIONAL FINALS

Sometime prior to the Valley Christian High girls basketball game against Oxford Academy in the California Interscholastic Federation-Southern Section Divisional 4AA semifinals last Saturday night, former V.C. legendary head coach Eleanor Dykstra gave an inspirational speech to the team. Then the Lady Crusaders took to the court and fed off of those words in a big way.

A back and forth first half turned into a disastrous third quarter for the Lady Crusaders, who found themselves down by eight points. But senior Cheyenne McKinnie and her teammates fought back and pulled out a 40-36 victory. The Lady Crusaders, ranked third in the division, will now face Olympic League rival and top seeded Village Christian High tonight for the championship.

The win over the second ranked Patriots was especially special for V.C. head coach Dominic Freeman, who just in his third season, said he knew this day would come and is excited to see it right now. It's also extra special for McKinnie, who transferred from Long Beach Jordan High the same time Freeman took over.

"This is what I've always wanted since my sophomore year when I came here," McKinnie said. "I've always tried to work for this and now it's finally here."

"They're all over the place," Freeman said of his emotions. "This is so surreal. When I first got here, I knew about the tradition. But when you walk in, you go, 'man, you have some big shoes to

fill here'. They've had a lot of success here recently with our football and volleyball...all of our teams are doing great."

With 1:01 remaining in the third quarter, Oxford Academy's Mylee Madraza capped off a 7-0 run with her second basket of the quarter to give the Patriots a 34-26 lead. Then the game shifted in V.C.'s way and junior Jai'lynn Parham got the party going with the stanza's last basket. That was followed by an 8-0 run to begin the fourth quarter that was capped by a pair of free throws from freshman Kira Smith midway through the fourth quarter.

The only two points Oxford Academy would score in the fourth quarter came in the form of free throws from Austyn Masuno within a 21 second span. The latter free throw came with 3:04 remaining in the game. After that, the Lady Crusaders sealed the win with free throws from Parham and McKinnie.

"The will of the girls and the man upstairs," Freeman said. "We've been through some adversity this year and my young team has not handled it so well. But it was really nice to see them show up in this type of magnitude in a game. I knew they were ready because all of them were texting me this morning about coming in and getting some extra work."

The first quarter was primarily

dominated by the 6'2" Masuno, who scored six points and grabbed three rebounds. But V.C. wasn't about to be intimidated by her height as the quarter was tied four times and there were four lead changes with neither team leading by more than a basket.

The Lady Crusaders defense would continue to do an exceptional job on Masuno, who would be limited to four free throws the rest of the way but still managed to pull down 11 more rebounds. "We just tried to take away her left," McKinnie said. "We tried to force her right as much as possible because we know she loves to go left. We just tried to contain the shooters."

"We wanted to force her right; get the ball out of her hand," Freeman said. "We know she's the focal point. We're almost in the same boat with Cheyenne. But that's their heartbeat and we wanted to slow it down. We did just enough to squeak by with a win."

The second quarter would be nearly more of the same with three more lead changes and two more ties. A 7-0 V.C. run put the hosts up 20-16, which would tie for its largest lead of the game. After scoring two free throws in the opening quarter, McKinnie would come on strong and finish with a team-high 14 points. She also added eight rebounds and four steals.



"The first quarter I was off and I just knew I had to be strong for my team," McKinnie said. "I knew I had to create some type of offense for them."

Smith scored seven points and had four steals while sophomore Calla Anderson scored six points and pulled 10 rebounds off the glass. V.C.'s defense still hasn't allowed more than 40 points in the playoffs.

"It's a testament to these girls," Freeman said. "We told them there are some things we can control and one is our ability to play defense and effort. The girls just did a great job. I'm just so proud of them right now. They battled."

The Lady Crusaders improved to 21-8, their best record since the 2009-2010 season when they went 24-8 and advanced to the Division V-AA championship game. The last time the program won a CIF-SS championship was 2000. In all, V.C. has won 10 championships and has advanced to the finals nine other times.

The two foes in tonight's championship game split their season series with Valley Christian winning on the road, 55-52, on Jan. 13 behind 24 points from McKinnie and a career-high 17 points from sophomore Ariel Gordon before Village Christian returned the favor two weeks later in a 44-32 triumph.

"It's funny because we had a league meeting about two weeks ago and before we left, I told the coach, 'I hope this isn't the last time I see you this year'," Freeman said. "We had a good chuckle about it and we felt confident we might meet up and now we are."

NORWALK FALLS TO SAUGUS IN FINAL MINUTE, THEN OVERTIME IN FIRST TRIP TO SEMIFINALS

LA MIRADA-Vinson Pluma has been associated with the Norwalk High boys soccer program for over 20 years, both as a head coach and as an assistant. Never had the Lancers advanced to the semifinals of the California Interscholastic Federation-Southern Section playoffs.

The Lancers did that this past Tuesday when they hosted Saugus at Goodman Stadium on the La Mirada High campus. One minute was what stood between Norwalk and a trip to the Division 4 finals. But with time running down in regulation, Tanner Brown silenced the home crowd with the all-important tying goal. Then in the 93rd minute, James Johnson got loose on a mini breakaway and pushed in the game winner in a 2-1 win.

"The last goal was a mistake; it was mistiming," Pluma said. "I think that's what broke them into overtime because we didn't let anybody run through our middle. For that to happen, we just lost it mentally, so we just made a mistake. We were trying to attack when we should be defending and we could have gone to PK's in that case."

It didn't take very long for the

Lancers to get on the board, 30 seconds to be exact, as junior forward Andrew Vasquez notched in his ninth goal of the season with the assist coming from junior forward Alejandro Amador. After that, the Lancers offense would be stymied despite many chances before halftime and even better opportunities in the second half. Norwalk outshot the Centurions 7-3 in the first half and took four corner kicks.

Midway through the second half, senior forward Rudy Cruz raced down the left sideline, fighting his way off of Jayden Willsey, who eventually fouled Cruz just outside the penalty box. That led to a free kick from 20 yards out, taken by senior defender Anthony Galicia, whose shot curled up and over the left corner of the net.

Six minutes later, Amador and Cruz made three beautiful passes back and forth before Amador sent a long cross pass through the box to junior forward Allen Perez. But his attempt to make it a 2-0 contest sailed too high.

"I think we scored so early that maybe we lost focus," Pluma said. "They started hitting long balls to us and we didn't keep possession of the ball. We were trying to long instead of really keep possession of the ball going forward. That was our mistake as a team."

Despite having just three shots on goal in the second half, the Lancers seemed to be sensing a victory. But with less than a minute remaining in regulation, Brown launched a free kick from over 45 yards out that bounced

above junior goalkeeper Kevin Guzman, who appeared to have lost it in the sun, and into the net. The Lancers would then get one shot on goal in overtime. Guzman would make five saves, all in the second half.

"That almost takes your focus away from all of the great things that he did," Pluma said. "He wasn't sure how far the distance was and as the time was coming in.

"We had a few [shots], but then we were kind of rushing it. Instead of really building up as a team," Pluma continued. "When you're rushing like that, then you lose possession of the ball."

Norwalk, the co-champions of the Suburban League, finishes the season at 16-7-1. It entered the postseason as the 10th ranked team in the division while Saugus was unranked. Prior to the game, the Lancers were 2-3 in 1-0 decisions with the two wins coming in the second round against Glendora High and the quarterfinals against second ranked University High. Both of those wins came on the road. The Lancers had also been 5-5 in one-goal games.

"We beat some hard teams; we beat some really good ranked teams," Pluma said. "So for that to happen, it's just disappointing. We should have had [Saugus]."

"I'm proud of the boys," he later added. "Things happen, so...the big picture is they should have been the winners. It just didn't go that way. For me, you just take it with a grain of salt. It's not that crushing."

amount of \$3,000.

The obscure committee, calling itself Residents for a Better La Mirada (RBLM), received only one donation from a La Habra based construction company.

The committee used the money to slam District 1 candidate John Lewis and District 2 candidate and incumbent Pauline Deal using direct mailed "hit pieces."

RBLM lists its address on the 12800 block of Oakwood Lane in La Mirada, and its treasurer as Ionel Imbre. A search of public records show that Imbre owns the house.

Mr. Imbre's phone number is the contact number for RBLM listed on the Secretary of State's website.

It is unknown why Mr. Imbre is heavily involved with RBLM, and phone calls were met with, "I have no comment."

One-time \$6,500 donation; Who is Stelian Onufrei?

The construction company that donated money to RBLM, Diamond Construction and Design, lists its company address as 921 N Harbor Blvd. #622 in La Habra.

HMG-LML went out to the La Habra address and found it to be a PO Box in a UPS Store located in a strip mall.

Diamond donated a staggering \$6,500 to RBLM, which was the only donation listed in the documents.

The campaign documents showed that RBLM was responsible for the three political, direct-mail advertisement hit pieces against Lewis and Deal.

RBLM spent over \$2,000 on those hit pieces; logic dictates other pieces are coming.

All three pieces listed RBLM as the responsible party, and, as first reported by HMG-LML on Thursday, the hit pieces were mailed from Fort Worth, Texas, a move used by other shady campaign committees to hide proponents of the committee.

Investigating further, HMG-LML was able to locate the mailing address for Diamond.

An examination using a title search company showed that the address is a 2,089 square foot single-family dwelling located in Buena Park and owned by Stelian Onufrei.

Onufrei is also listed as the registered owner of Diamond in the County of Orange's business name listing. No other information could be found about Onufrei.

HMG-LML was also able to obtain the phone number to Diamond; a call to the number was met by a voice mail that said, "you have reached Diamond Construction and Design."

Looking on the state of California contractor's license website reveals

Diamond's contractors license (521295) violated the California building permit law in 2013, but since then the license is in good standing.

A message was left, but as of publication time, the call had not been returned.

In other documents, District 1 candidate Diane Gramajo generated over \$2,100 in monetary contributions for the period from various sources.

\$500 was from State Senator Tony Mendoza (D-Artesia) and his Committee to Elect State Senator Tony Mendoza for 2018.

Senator Mendoza, along with State Senator Ian Calderon (D-Whittier), also gave "in-kind" donations to Gramajo in the amount of \$3,000 sending out two direct mail pieces for Gramajo.

Gramajo, HMG-LML readers will remember, was involved in the La Mirada Football Booster scandal that embroiled La Mirada High, then football coach Mike Moschetti, and Gramajo in 2014.

Gramajo and Moschetti ran the entire booster club operation, which took in over \$1 million dollars in 8 years.

The HMG-LML investigation revealed that the booster club had violated several California tax laws with no oversight on where and how hundreds of thousands of dollars were spent every year.

Even more alarming, the booster club indicated on all donation documents that it was a registered 501c3 non-profit organization, going so far as using an inactive and non-existent identification number.

This deliberate move placed anyone who donated money to the booster club into a compromising tax position.

The investigation also revealed that the organization did not have a California Franchise Tax Board number and did not remit taxable sales or report the amount of sales from the lucrative "50/50" cash fundraisers the booster club held.

Finally, no year-end or internal financial statements were ever filed since 2006, and sources told HMG-LML that there were no bank statements available from the organization.

Gramajo never commented to HMG-LML before or after the story ran, but sources say the booster club remains in disarray.

District 1 candidate John Lewis' documents showed two small donations and a loan from Lewis to the committee for \$7,500.

District 1 candidate Tony Aiello's documents showed a \$2,500 donation from ATV in La Mirada and \$1,000 from the United Food and Commercial Workers International Union.

District 2 incumbent Pauline Deal and District 1 candidate Jim Emmerling did not open a committee to support their campaigns.

The other incumbent in District 2,

Andrew Serega, showed a \$50 contribution for the filing period, but it also showed donations totaling \$5,000 during prior filing periods.

HMG-LML has sent emails to Serega asking for comment about the mailers sent out against his only competitor, with no response. All supporting document can be found online at <https://goo.gl/zqjWRz>.

The process started during the Feb. 22 meeting where the Board voted 3-2 to investigate CB GM Kevin Hunt and his "questionable and covert" actions during the selection process of Messrs. Gedney, Grajeda, and Oskoui.

President Phil Hawkins, VP Pedro Aceituno and Director Art Chacon voted yes to investigate Hunt over the selection process, with Hunt allies Vasquez and Apodaca voting no.

A little over an hour later, after most Board members had left the building, Gedney, Grajeda, and Oskoui were hastily sworn in by Hunt inside the Board room without public notice.

Two lawyers that HMG-CN contacted said Hunt's actions were a violation of the Ralph M. Brown Act open meeting law because Hunt did not properly notice (place on a future Board agenda) the appointments to give the general public a chance to comment on the proposed new Board members.

The potential violation did not matter to Hunt, as the selection process ended up placing Gedney, Grajeda, and Oskoui on the Board.

One day later, CB published an agenda online scheduling the meeting for today.

Two agenda items called for "a reorganization of the Board and a review of the investigation into GM Kevin Hunt."

The new "voting block" Board followed through with the reorganization, removing Phil Hawkins, who was appointed president only one month ago, replacing him with the controversial Apodaca.

They also removed Hawkins from his Metropolitan Water District Board seat.

Aceituno remained at VP, while Vasquez and new Director Gedney were given seats on the Metropolitan Water District Board.

And in a move that could have future repercussions, Gedney, Grajeda, and Oskoui voted with Vasquez and Apodaca to stop the investigation into Hunt and terminate the contract with attorney Anthony Willoughby, who was heading the investigation.

On all items, Hawkins and Director Art Chacon voted no. HMG-CN contacted Assemblywoman Garcia and CB for comment with no response as of publication time.

NEW STEMI RECEIVING CENTER FOR PIH HEALTH

PIH Health Hospital / Whittier has been designated as one of the leading facilities as a STEMI, ST Elevated Myocardial Infarction Receiving Center for Los Angeles County. STEMI Receiving Centers improve the speed and quality of lifesaving care for people experiencing heart attacks.

From the time the hospital is notified that a patient is arriving with chest pain, the coordination of resources and the STEMI team begins preparation of their cardiac catheterization lab. PIH offers percutaneous coronary intervention (PCI), a lifesaving procedure to stop a heart attack in its tracks, enabling them to actually surpass the American Heart Association's 90-minute standard for opening a blockage.

"We rushed him into the cardiac catheterization lab, where we performed percutaneous coronary intervention which is a non-surgical procedure that uses a thin, flexible tube to place a small structure called a stent to open up blood vessels. This procedure reestablished Gustavo's circulation." This life-saving procedure essentially stops a heart attack in its tracks.

"This patient's quick access to cardiac experts, and the technology available in our specialized facility enabled our team to act quickly, which salvages more heart muscle, minimizes the hospital stay and may prevent future congestive heart failure," added Dr. Patel. "We were able to exceed the

American Heart Association's 90-minute standard for opening a blockage."

Lopez was released from the hospital three days later and is back to feeling well and enjoying life. "I'm extremely impressed by the STEMI Receiving Center and very grateful for PIH Health Hospital - Whittier, which provided an expert team and excellent service," said Lopez. "I'm so fortunate."

A heart attack happens when blood flow to the heart is blocked. Common symptoms of a heart attack may include chest pain or pressure in the chest [or the back, neck, jaw or shoulders], sweating, shortness of breath, nausea or vomiting, lightheadedness or sudden weakness, and a fast, irregular heartbeat. Symptoms for men and women differ. If you have symptoms of a heart attack, call 911—wait for an ambulance and don't try to drive yourself.

PIH Health is specially trained and equipped to provide state-of-the-art heart care and treatment to prevent further damage and complications. PIH also offers therapeutic hypothermia, a cooling treatment used to preserve brain cells following a cardiac arrest.
