NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

CITY OF ARTESIA

TO THE HONORABLE Miguel Canales: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of Artesia, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of City Council, in Artesia, California, and to demand an election of a successor to that office.

The grounds for the recall are as follows:

Artesia Doesn't Trust Politician Miguel Canales

BROKEN PROMISES: Canales promised to improve Artesia but instead he misspends our tax dollars, ruins our business district, ignores resident's concerns, and is in the pocket of special interests.

PUBLIC SAFETY THREAT: Canales's Pioneer Blvd project impedes emergency vehicles, leading to delayed response times that will cause property damage and loss of life.

DAMAGED LOCAL ECONOMY: Canales ruined Pioneer Blvd with his wasteful multi-million dollar project. Increased traffic and metered parking are driving consumers to other cities, costing the city revenue.








CONFLICT OF INTEREST: Canales is in the pocket of powerful developers, voting for their interests instead of residents.












