

DEMS SLAM PARTY CHAIR CHRIS ROBLES FOR HELPING ARTESIA CITY COUNCIL RECALL

Robles, who was exposed by HMG-CN, is the Chair of the San Bernardino County Democratic Party.

Hews Media Group-Community News exclusively reported last year on the fraudulent recall attempt in Artesia that targeted then-Mayor Ali Taj and Councilmen Miguel Canales and Victor Manalo.

The attempt was led by residents Rene Trevino, Dorothy Kane, Gurpal Sood, and controversial neophyte newsletter writer Melinda Kimsey.

Kimsey threw all journalistic ethics aside and joined the fraudulent recall in attempt to take over the City Council with Trevino.

Also throwing ethics out the window and causing anger between Artesia and Cerritos officials was Kimseys' newsletter copy editor and noted Cerritos Republican Janet Beach.

Beach is an appointed Commissioner on the Cerritos Fine Arts and Historical Commission and helped to approve articles related to the bogus recall.

Disgruntled former HMG-CN reporter Jerry Bernstein, who colluded with Kimsey during their employment stint with HMG-CN to try and put the paper out of business, also participated.

The group came to be known as the "Keystone Kimseys" in certain Artesia circles, known for their bumbling recall efforts and failures.

The first recall petitions submitted to the city showed strong evidence of questionable activity, with many residents crying foul about the subject of the recall and their actual signatures.

The recall was eventually invalidated due to questionable signatures.

So the Keystone Kimseys tried again, recruiting Chris Robles, a "recall expert," known trash hauler operative, and current Chair of the San Bernardino County Democratic Party to assist the campaign

and recall the three Democratic City Councilman.

There is no public record of Robles ever having managed a winning campaign. Several of the campaigns he worked on have been investigated and fined by the Fair Political Practices Commission (FPPC) because of his repeated violations, which included paying himself out of a client's campaign funds.

But that did not bother the Keystone Kimseys.

Another recall was questionably approved, without a fight from the City's law firm, and Robles began his campaign, hanging out in the City with signature gathering employees at a local Flame Broiler on Pioneer Blvd. that is reportedly owned by Sood.

But the Keystone Kimseys failed at their second attempt, further damaging the image of Artesia and hurting future vital economic projects.

In addition, a campaign committee

HAWAIIAN GARDENS COUNCIL APPROVES MAJOR RENOVATIONS TO CLARKDALE PARK

The Hawaiian Gardens City Council awarded a construction contract to Line Tech Contractors, Inc., in the amount \$479,900 for the Clarkdale Skate Park surfacing improvements.

Two additional parks, Lee Ware Park and Pioneer Park will also receive major upgrades.

On December 20, 2017, Hawaiian Gardens received four sealed bids for the reconstruction of the skate park. Line Tech Contractors of Los Alamitos submitted the lowest responsible bid.

The contract involves the installation of rubberized surfaces at all three parks, as well as improvements at Clarkdale, which will enhance the park significantly.

The design was previously adopted by City Council, who also requested input from skateboarders.

Improvements for Clarkdale will include new concrete obstacles, enhanced lighting, additional fencing, and the all ready installed security cameras.

The timeline for completion for Clarkdale and the rubberized surfaces has been slated to take no more than 90 days.

Line Tech will subcontract to a company who specializes in skate parks and equipment.

CENTRAL BASIN LEAKED CONFIDENTIAL RECORDS TO L.A. TIMES VIOLATING FEDERAL LAWS

Hews Media Group-Community News has learned that a Central Basin Municipal Water District (CB) employee or Director leaked federally protected and confidential personnel and health records of a former employee to the Los Angeles Times violating the Health Insurance Portability and Accountability Act (HIPAA) which is a federal offense.

According to sources, the records were illegally obtained by the offender prior to Feb. 2017, when three new directors were appointed, narrowing the list to a handful of people who could have acquired and eventually leaked the records.

Those same sources have told HMG-CN that CB's law firm Nossaman, for unknown reasons, is not involved in the investigation and that CB General

ROSE PARADE: KENNEDY HS WELCOMED KYOTO TACHIBANA HIGH SCHOOL GREEN BAND

The Kyoto Tachibana High School Green Band is one of the oldest marching bands in Japan and is known for their continuous dance-style marching technique that was pioneered at Kyoto Tachibana. This year's Kyoto Tachibana Green Band came with 191 students and graduates, including 10 boys and 181 women and girls. They came to perform in a Disneyland Parade in Anaheim on December 29, 2017, a Band Festival in Pasadena on December 30, the Rose Parade in Pasadena on January 1, and a Benefit Concert at the Anaheim Union High School District Performing Arts Center at John F. Kennedy High School in La Palma on January 2, 2018. This was the second time that the Kyoto Tachibana Green Band came to perform at the Rose Parade and the Benefit Concert at Kennedy High School with their first time being in 2012.

According to Henri Soucy, a John F. Kennedy High School Band Booster Alumni parent since 1995, this was the largest group of Green Band members to come to perform because graduates also came to honor their Director, Hiroyuki Tanaka, who is retiring as Band Director at Kyoto Tachibana High School after 22 years as Band Director. Mr. Hisashi Hiramatsu, who is 83 years old, was the first Band Director at Kyoto Tachibana in 1963. He also came with the Green Band and planned to be a guest conductor at the concert at Kennedy High School. He also walked the entire length of the Rose Parade of 5.5 miles with the Kyoto Tachibana Green Band.

Since there were so many students and graduates coming to perform, Henri Soucy asked for the help of many host families to



house them for parts of three days and two nights from December 30 to January 2nd. Henri was grateful for the 82 families who volunteered to take two, three or four students and provide food and lodging.

The culmination of the Tachibana High School Green Band's visit occurred on January 2nd with awards being presented to thank and honor their directors, current Director Hiroyuki Tanaka, and founding Director, Hisashi Hiramatsu. Both directors received John F. Kennedy High School lettermen's jackets embroidered with their names and the Kennedy "K."

After all the presentations were made, all the students and dignitaries went outside the Band Room area to participate in the planting of a Friendship Tree to commemorate the friendship of the Kyoto Tachibana High School Green Band and John F. Kennedy High School. Henri prepared a Cypress Juniper Blue Point tree for planting, and the two Japanese directors and selected students helped to finish the job.

The final event of the day was the Green Band Festival in the evening of January 2nd. The Performing Arts Center was filled with over 700 people as they came to enjoy the band's concert. The Tachibana Green Band members were spectacular as they performed a "Stage Marching Show" led by Drum Major Yui Nagao. Director Tanaka conducted five different Medleys and melodies, and guest Director Hiramatsu conducted the band playing the music for "Prayer." Former Kennedy Band Director Robert Anthony conducted the finale, "Stars and Stripes Forever" after the students had come out into the audience to say their emotional farewells to their hosts. The audience applauded the band's

outstanding performance, and everyone stood up from their seats hoping for an encore performance. The band responded by playing its signature Tachibana Green Band number to even more applause from the audience.

We were pleased to learn from Henri Soucy that donations received at this year's Green Band Festival at Kennedy raised \$3,000. The donations will be given to the family of Corey Iverson, the firefighter who died while battling the Thomas Fire last year.

This was the fourth time that my husband, David, and I have hosted Green Band students from Japan. We always have enjoyed hosting the students who are always very polite and appreciative of being able to come and learn more about life in the United States. We also learn from the students about Japan and are always impressed by the Green Band's musical performance in the Rose Parade and at the Benefit Concert at the Performing Arts Center at Kennedy High School. Host families are the first people to receive tickets for the next Benefit Concert, so we do encourage people to volunteer as host families.

CERRITOS CELEBRATES MARTIN LUTHER KING, JR.

For the 13th year the City of Cerritos has celebrated the lifetime accomplishments of Martin Luther King Jr. This celebration seemed even more fitting because it was 13 years that Dr. Martin Luther King, Jr. led the modern American Civil Rights Movement, from December, 1955 until April 4, 1968. African Americans achieved more genuine progress toward racial equality in America in those few short years, than the previous 350 years had produced. King is widely regarded as America's pre-eminent advocate of diplomacy and one of the greatest nonviolent leaders in world history.

The standing room only event was held on Monday, January 15, 2018 in the Sierra Room at the Cerritos Center for the Performing Arts. The entire Cerritos City Council, along with numerous Cerritos Commissioners, Senator Tony Mendoza and community leaders were in attendance. The morning began with an invocation from the Reverend Lester Barry, followed by a community sing-along of 'Lift Every Voice and Sing' by James Weldon Johnson with the national anthem being performed by Cerritos own Kaitlin Hunter.

Delta Gems, Pi Sigma Omega Cerritos chapter paid tribute to King with their rendition of 'Oh, Freedom' a post-Civil War African-American freedom song, often associated with the American Civil Rights Movement and their recitation of the poem 'To Be Young gifted, and Black' by Weldon J. Irvine, Jr. Cerritos sisters Akasha Greenish, three years old and Iona Greenish, eight years old recited poems 'I Love The Sea' and 'I Dream Of A World' to resounding applause.

Mayor Grace Hu welcomed all in at-

tendance reminding us that King believed in love and forgiveness, having a tough mind but a tender heart, saying "We use the power of words to achieve our goals. Those goals can lift up a community or tear them down."

The keynote speaker of the morning, Ethan Robinson Sr., stirred the crowd as he spoke. "We need to move forward as a people ... Not just one race ... Not just one state ... But as a country united. In my fifty plus years on this Earth I have never seen racial tension as high as it is today. Our city of Cerritos is a melting pot of ethnic background, culture, and of all ages. We need to be a shining example to the rest of our State and to the World that love and forgiveness cannot grow in a vacuum."

Robinson went on to encourage each person there to ask 'how you can be a maker of change'. "At the end of our life's journey," said Robinson, "Our epitaph begins with the date we were born and ends with the date that we die. The rest of life is all placed in that small hyphen between the two. The totality of your life is that hyphen between birth and death, make it mean something."

ED ROYCE WILL NOT SEEK REELECTION IN 2018

Uber-conservative House Foreign Affairs Committee Chairman Ed Royce (R-Fullerton) said this past Monday he will not seek reelection, adding his name to a growing list of senior Republican lawmakers who have chosen to retire in what is shaping up as a "Bluewave" for 2018.

Royce is one of eight House Republicans who have announced they will not run for reelection ahead of the midterm elections.

Others who have announced their retirements are Reps. Bob Goodlatte (Va.), Jeb Hensarling (Tex), Bill Shuster (Pa.),



Lamar Smith (Tex.), Diane Black (Tenn.), Jason Chaffetz (Utah), and Gregg Harper (Miss.).

In a statement, Royce said he wanted to focus on that committee work during his final months in office.

"In this final year of my Foreign Affairs Committee chairmanship, I want to focus fully on the urgent threats facing our nation, including: the brutal, corrupt and dangerous regimes in Pyongyang and Tehran, Vladimir Putin's continued efforts to weaponize information to fracture western democracies, and growing terrorist threats in Africa and Central Asia," he said. "With this in mind, and with the support of my wife Marie, I have decided not to seek reelection in November."

Even before his retirement, Democrats were eyeing his Orange County district. Democratic nominee Hillary Clinton won his 39th Congressional District by nine points over Donald Trump in 2016, and several Democratic candidates have launched campaigns for the seat.

The district includes voters in Chino, Chino Hills, City of Industry, Diamond Bar, Fullerton, Hacienda Heights, La Habra, La Habra Heights, Placentia, Rowland Heights, Walnut, & Yorba Linda.

was never opened to finance the recall attempt.

If any member of the Keystone Kimseys spent over \$1,000 on the campaign, they violated several Fair Political Practices Commission laws by failing to open a campaign committee.

Sources are telling HMG-CN that complaints filed last year alleging violations during the recall campaign are now under investigation by the Los Angeles County District Attorney.

Now in a what might be a fitting end to his checkered career, and a testimony to the Keystone Kimseys questionable motives, Robles was recently slammed by the Democratic party for "working professionally for Republican candidates in a campaign to defeat Democratic candidates."

Eric Bauman, Chair of the California Democratic Party wrote, "Robles was admonished for having campaigned for a Republican candidate against party-endorsed Democrats in the Ontario City Council election of November, 2016.

Specifically citing HMG-CN articles on Robles, "He also led a campaign to recall three popular Artesia City Councilmen, all Democrats, during the summer and fall of 2017 – a fact which has yet to be considered by the state party officers."

Robles could be expelled from the state party, not just admonished, for campaigning against state-endorsed candidates. Once expelled from the state party he would have also been expelled from the county party, leaving the office of chair vacant.

Robles is the "owner and president" of the Chino-based political consulting

company Vantage Campaigns, formerly of Hacienda Heights, and the Montebello-based Pericles Group.

During its research, HMG-CN found that the Vantage Campaigns website contained no identities or biographies of personnel, and calls to its listed phone numbers for comment from Robles were never returned.

The Bauman letter went on, "the position of chair is a voluntary one but Robles used it to enrich himself by promoting his consulting business over the county party and its candidates for office. Candidates who have been endorsed by the county party reported that Robles offered them his business card and told them he could help them only if they would hire his company and pay him.

"He has manipulated the county party into contracting with his consulting company for professional services, without approval of the membership, apparently an illegal conflict of interest."

The letter finished, "Although a large number of Democrats have been trying to remove Robles for almost a year, he has been more successful at obstructing their attempts than in any other action he has taken as chair. It remains to be seen how much longer he can cling to his untenable position."

Bauman signed the letter of admonition to Robles on behalf of the other statewide CDP officers Vice-Chairs Alex Gallardo-Rooker and Daraka Larimore-Hall, Secretary Jenny Bach, and Controller Dan Weitzman.

Bauman was Chair of the Los Angeles County Party from 2001 to 2017, and Vice-Chair of the state party since 2009, before being elected state party chair last May.

WHITNEY GIRLS LOST IN NEVERLAND ON HOMECOMING NIGHT, CAN'T KEEP UP WITH OXFORD ACADEMY

From the 2010-2011 to 2013-2014 seasons, six Academy League schools were chasing the Whitney High girls basketball program, which did not lose a league game during that time. For the past two seasons though, everyone in the circuit has been looking up at the Oxford Academy.

Those two met last Friday night on Whitney's homecoming, with the theme being "The Battle for Neverland". It was a battle early on until the Patriots went on a 17-3 run from the last half of the first quarter to the first couple of minutes of the second quarter. That was more than enough for Oxford to run away with a 52-37. It was the fifth straight loss to the Patriots, who had defeated Whitney by an average of 7.3 points the previous four times.

The Lady Wildcats led 6-2 following junior Justine Wu's three-point play two and a half minutes into the game. It would be Whitney's largest lead of the game. Wu would score with 3:37 remaining in the first quarter to make it 8-7. But that would be the last time the hosts would score until Wu completed another three-point play 15 seconds into the second quarter.

"I think we were ready for their press," said Whitney head coach Jeff Day. "We knew they weren't going to bother us on the front of it. I told them when they press us, we want to attack the press because we were going to get lay-up opportunities. We did not finish enough against their press. I thought that was a big thing."

It was no surprise to either team that Oxford held a considerable height advantage, considering they have been each other's rivals for many years. At 5' 6", Wu is Whitney's tallest player in the starting lineup and the Lady Wildcats don't have a player taller than 5' 9". In contrast, Oxford's pride and joy for the past two and a half seasons has been, and continues to be 6'2" junior Austyn Masuno. Three other starters are at least 5' 7", but despite the height factor, Whitney's defense contained Masuno most of the time, limiting her to three field goals and a team-high 11 points. In fact, in five meetings, Whitney has held Masuno, clearly the best player in the league, to 72 points but 18 field goals. She has helped her team beat Whitney by going a combined 36 for 43 at the free throw line.

While Whitney was doing its thing with Masuno, the Patriots were letting someone other than senior Christine Hamakawa beat them. Hamakawa, the sharp-shooting perimeter player that can do it all for the Lady Wildcats scored just a pair of three-pointers, one in the first quarter and the other in the fourth quarter. She attempted 11 shots in the game.

"With Austyn, we just told her to play within yourself, keep moving across the lane," said Oxford Academy head coach David Clifton. "I'll take two points from the foul line as much as I'll take two points from a field goal. It was frustrating when she was getting double and triple-teamed. But we had to just tell her to keep moving, keep moving, keep moving because when they triple-team you, somebody else

is open."

Whitney trailed by nine at the half and cut its deficit to six points after a three-pointer from freshman Julianna Lee with 5:24 remaining in the third quarter. That would be it for the Lady Wildcats, who scored five more field goals the remainder of the game and none since the 4:03 mark of the fourth quarter. Meanwhile, the Patriots went on a 14-6 run to lead 48-32, their

largest advantage of the contest.

"They didn't hurt us on the strong side shooting, really," Day said. "In the first quarter they did. They only made two threes in the game and I'll take that. I told my team we're [zero] for five with this defensive scheme. I think our defense has given us a chance to be in every one of those games. I asked them if we wanted to

WHITNEY BOYS HOLD ON FOR FIFTH VICTORY DESPITE BLOWING ANOTHER FIRST QUARTER LEAD

The Whitney High boys basketball team has played three home games in less than two weeks and each time, the Wildcats had built a first quarter lead. The first two times, against Sage Hill High on Jan. 3 and last Friday against Oxford Academy, the 'Cats lost those contests.

But, first-year head coach Glenn Gates, who cited mental fatigue for the breakdown after gaining those double-digit leads, can breathe a sigh of relief as Whitney had a 6-0 lead within the first minute of the game, lost the lead, then regained it in the fourth quarter to edge Calvary Chapel Downey 44-42 this past Tuesday evening. Whitney improved to 5-15 overall and 2-3 in the Academy League.

"It's tough," Gates said. "It's a developmental process and the kids are learning game by game, practice by practice. This is like the new way of playing. So, we have to change some things around. But the kids responded today, and I have to commend them for responding today."

A bucket from senior Heaven Flores with 2:42 remaining in the first quarter gave the hosts a 10-5 lead. But they wouldn't score for the next 4:30, missing seven straight shots and seeing the Grizzlies storm back to take a 13-10 lead almost two minutes into the second quarter. Whitney would finish off the half on a 10-4 run thanks to Flores, who scored a pair of baskets, and freshman Jeffrey Fernandez, who was perfect on all three attempts from the field.

But the erratic play continued for Whitney, which had scoreless streaks of close

to four minutes in the second quarter and nearly three minutes in the third quarter. The latter came after the Wildcats had built a 29-23 lead only to see it dwindle to a two-point deficit.

"What I thought we did well today was we played protecting defense," Gates said. "I thought we did a really good job defensively. To be truly honest, this week was about getting our defense better. And what I thought today was making good shots, bringing the shot clock down and playing solid defense."

However, the Wildcats ended the third quarter with a basket from junior Joshua Chung to tie the contest. Then 30 seconds into the final stanza, an offensive rebound and basket from junior Jonan Baladjay gave the hosts a lead they would not relinquish. Those two baskets were followed by two more and with 4:59 remaining in the game, Whitney was up 39-33.

Flores sealed the victory with 1:55 left when he drained a three-pointer off a pass from Baladjay. Aaron Jovel answered back with a downtown shot with 42.9 seconds left. But an inbound violation gave the ball to Whitney and the Grizzlies were unable to get another good shot off. Flores scored a game-high 15 points and had six rebound and two steals while Fernandez added 10 points on five of seven shooting. Baladjay chipped in with nine points, three rebounds and three assists and junior Adi Jahic pitched in with nine points, seven rebounds, four assists and four steals.

"Since we brought him up from the j.v. squad at the beginning of the year, I knew we had something," Gates said of Fernan-

JOHN GLENN GIRLS BASKETBALL STAY IN PLAYOFF HUNT, HOLDS OFF ARTESIA

The Artesia High and John Glenn High girls basketball programs have been struggling for quite some time with the former missing the playoffs for five straight seasons and the latter the past six seasons. In addition, Artesia has had a losing mark for 10 straight seasons while the Lady Eagles have been under the .500 mark for the past six straight seasons.

However, both entered their meeting this past Wednesday right at .500 and ranked in the California Interscholastic Federation-Southern Section Division 5AAA poll. The game was what one would expect, which was low scoring and unpredictable. In the end, the visiting Lady Eagles held off Artesia 38-33 to improve to 11-10 overall and 2-3 in the Suburban League.

Artesia (8-9, 0-5) opened the fourth quarter on a 6-0 run and when junior Odalis Ramirez sank a pair of free throws

with 3:33 remaining in the game, Glenn was clinging to a 27-26 lead. But in a span of 25 seconds, Glenn senior Kaylin Meno had a basket, followed by a steal and basket from senior Dalilah Mendoza and a free throw from Mendoza to basically seal the game.

The Lady Pioneers made one last push as senior Jessica Tibayan sank four straight free throws in a nine-second span. But the Lady Eagles were four of six from the line inside the final minute.

The Lady Pioneers were without the services of two of their best players, including senior Cassidy Valle-Marinas, who is their leading scorer, and suited up seven against Glenn. A week prior to the Artesia game, the Lady Eagles edged La Mirada High 35-34 before losing to Bellflower High 48-47 two days later.

do something different next time and they said no.”

Manager Kevin Hunt and the Administration and Ethics Committee (AEC) are "handling the investigation internally."

Further clouding the process, the investigation is being conducted by Hunt even though CB pays \$15,000 per year to manage the "Ethics Hotline" and investigate any accusations that are anonymously left on the phone-based Hotline.

The illegal leak could expose CB to yet another costly self-inflicted settlement or lawsuit similar to the massive \$670,000 payout to Sigrid Lopez to settle accusations that Director Bob Apodaca sexually harassed her.

The records leak to the L.A. Times occurred within the last few months, sometime in October 2017.

But the actual records are at least four years old and contained not only HIPAA protected records, but also a CB investigation into the employee who is the subject of the records.

At the time CB's Board consisted of only five elected officials: Bob Apodaca, James Roybal, Leticia Vasquez, Art Chacon, and Phil Hawkins.

When contacted by HMG-CN, Tony Perez, who was GM at the time said, "I can say unequivocally that I did not release the report nor do I know who leaked the report. I left the District over 3-years ago, but my recollection is that only the Board members had access to the report through the HR [Human Resources] Department."

Current CB Directors Art Chacon and Phil Hawkins went on the record saying they did not leak the report.

Chacon told HMG-CN, "I have an idea who leaked the report to the L.A.

Times but I will let the investigation run its' course."

Given Perez' statement that "only Board members had access to the report," that would leave current President Bob Apodaca, former Director James Roybal, or current Director Leticia Vasquez as the only Board members who had access to the confidential records.

HMG-CN sent in a request for to all three, as of time of publication, none had responded, Roybal now resides in Florida.

Cover-up?

The records were leaked to the L.A. Times sometime around Oct. 2017, yet the explosive issue has only been recently addressed by Hunt and the Administration and Ethics Committee (AEC).

The Chair of the AEC is CB Vice President Pedro Aceituno, with members listed as Directors Mark Grajeda and Leticia Vasquez; Director Phil Hawkins is the alternate.

Recent CB online documents showed that the January AEC meeting listed a closed session agenda item as "Significant Exposure to Litigation."

Just days later, CB pulled the agenda off the website and cancelled the AEC meeting for "lack of quorum." Two days later the cancellation notice was altered for "lack of committee items," even though the pulled agenda showed discussing "significant exposure to litigation."

HMG-CN has recently learned that GM Hunt is "in the final stages of completing the investigation."

Hunt also indicated CB's attorneys are "in contact with the Los Angeles County District Attorney's office regarding this matter."

HMG-CN sent an email to the L.A. Time reporter who received the leaked documents, as well as his boss, for com-

ment, as of time of publication, neither had answered.

Caltrans is notifying motorists to expect delays and use alternate routes.



WHEREAS, the Charter of the City of Cerritos and California Elections Code Section 1301 and 10403.5 authorize the City to reschedule its General Municipal Election as necessary;

THE CITY COUNCIL OF THE CITY OF CERRITOS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to the Charter of the City of Cerritos and California Elections Code Section 1301 and 10403.5, the date of the General Municipal Election of the City of Cerritos is moved from the second Tuesday in April of each odd-numbered year to the first Tuesday after the first Monday in March of each even-numbered year commencing with the March 3, 2020 California statewide primary.

SECTION 2. In accordance with the change of election date, the terms of office of those members of the City Council presently serving shall be extended for a period of approximately eleven (11) months until the certification of election results are declared by the City Council.

SECTION 3. Section 2.40.010 is hereby amended to read as follows:

Section 2.40.010 Date of General Municipal Elections

General municipal elections shall be held on the first Tuesday after the first Monday in March of each even-numbered year commencing in March 2020.

SECTION 4. The next general municipal election to be held in the City of Cerritos shall be scheduled for March 3, 2020.

SECTION 5. The City Clerk shall certify to the passage of this ordinance and cause same to be posted as required.


