CERRITOS COLLEGE TO HOST FORUM ABOUT NORM REEVES STORAGE LOT

Cerritos College will host its second community forum to update residents on its efforts to change the Cerritos College lot located at 166th Street and Studebaker Road.

On September 18, the Cerritos City Council approved the College's Temporary Use Permit (TUP) which authorizes the College to convert the property on 166th Street and Studebaker Road into an automobile storage facility.

The College Board passed a resolution on September 6 to address issues raised by residents and the City, including dust and light mitigation, hours of operation, loading of vehicles, security, and landscaping.

The College continues to work closely with the City of Cerritos.

The meeting will occur Monday, March 26, 2018, 5 p.m. The event will take place at the Cerritos College Science Building S-201 11110 Alondra Blvd., Norwalk, CA 90650.

On Wednesday, March 14th, students all over the United States left their classrooms for a National School Walkout to protest gun violence.

As the words of John Lennon's song 'Imagine' rang out across the Lakewood High School football field, hundreds of Lakewood High School students, signs in hand, joined with kids across the nation in protest and memory of

HMG-CN EXCLUSIVE: SCHEME TO FIRE PICO RIVERA CITY MANAGER RENE BOBADILLA DRIVEN BY LUST AND GREED

Last week, Hews Media Group-Community News was first to report that Pico Rivera City Manager Rene Bobadilla, who had his contract extended less than a year ago on a 3-2 vote, would be forced to resign by three city councilmembers that include disgraced El Rancho Unified teacher Gregory Salcido.

According to the sources, a lunch meeting was held two weeks ago at Pico Rivera's Dal Rae restaurant attended by Bobadilla, Assistant City Manager Ben Cardenas, Mayor Gustavo Camacho, Armenta and two "potential city vendors."

During the meeting, Armenta reportedly ordered Bobadilla to terminate the city's contract with LEBA Inc., the long-time operators of the Pico Rivera Sports Arena (Arena).

Bobadilla evidently objected to the termination because LEBA was not in violation of their contract, a 20-year agreement that expires in 2034.

Armenta angrily stood up from the meeting and said, "if that is the way you want it, then we will do something else." The two vendors left with Armenta.

Days later an emergency meeting was called to announce Bobadilla's formal termination with Armenta indicating that Councilmen Bret Tecero and Salcido, along with Armenta, would vote to terminate.

The statement that "the three were ready to terminate Bobadilla" was a blatant Brown Act violation that should get the attention of Los Angeles County District Attorney's Public Integrity Division.

The initial HMG-CN article caused such an outrage in the City that it forced the three Councilman to back off on the resignation and "wait" until the next Council meeting occurring tomorrow, March 13.

Now an HMG-CN investigation has uncovered new information into the circumstances surrounding the attempted forced resignation, and what was discovered will send shockwaves throughout

These plans are intended to further integrate resources of nonprofit agencies; faith organizations; county and state services; railroad and flood control agencies; healthcare organizations; environmental response organizations and local government services such as public works, library, community services, police, fire and emergency medical agencies.

The goals of the City of Downey Homeless Plan are:

- Development of an inventory of existing government and non-governmental services

STRONG LEADERSHIP NEEDED NOW SAYS SENATOR RICARDO LARA

A month after proposing a single-payer healthcare system for California, State Sen. Ricardo Lara (D-Bell Gardens) announced he was running for state insurance commissioner in 2018.

Since then, he has traveled up and down the state seeking support including the endorsement from the Hubert Humphrey Democratic Club (HHHDC) at its February General Meeting.

Lara said strong leadership is needed now at a time when President Trump is seeking to repeal the Affordable Care Act.

"I'm running to be California's next state insurance commissioner because I believe at my core that California needs a strong defender, and a counterpuncher, who will stand up to fight our bullying President, Donald Trump, and his increasingly reckless federal government on issues from healthcare access to economic security and more. That's important now more than ever," said Lara.

"Let us not have one election define who we are as Americans. Let us be rebels and fight for the American Dream."

In addition to proposing a single-payer system for the state, Lara, who is the son of immigrants, won approval for legislation that provides healthcare coverage for children who are in the state illegally.

Lara reported to the HHHDC that now more than 250,000 children have access to healthcare.

"It makes no sense to discriminate against immigrants," said Lara.

He has also pressed for coverage for adult immigrants willing to pay for their insurance.

"My mother would always say that we should not make fun of someone else's accent, to respect immigrants no matter where they come from, and to support the core values that tell us who we are."

Lara was clear that the state would not support any company that works on building a wall. "Any company that agrees to do that, will get no business from us," said Lara.

He is proud of the passage of Proposition 58 that again will allow bilingual education in our public schools.

"Most countries in the world think it's an asset for their residents to speak multiple languages. Some children speak three or four languages, so I was happy when Cali-

fornia voters by 70 per cent supported a change from the hateful policies of Pete Wilson that stressed the teaching of only English."

He is also proud of recent achievements made in the state legislature that include environmental protection and income parity. "Without a doubt, we are the most deliberative body in the country. Our residents should expect nothing less from the richest and most powerful state in the union."

Lara is willing to work with anybody "who is willing to come to the table, but my allegiance will always be first and foremost to the consumers, the patients, our working families, and our most vulnerable communities in our Golden State."

So far California Teachers Association, several other unions, local elected officials, and U.S. Senator Kamala Harris have endorsed Lara for insurance commissioner.

those that were needlessly killed in the Parkland shooting.

Exactly one month after 17 people were killed at Marjory Stoneman Douglas High School in Parkland, survivors of the massacre joined tens of thousands of students across the U.S. by walking out of school.

The National School Walkout was organized by Empower, a coalition of teen activists from all over the country. You may have actually heard of Empower before — it's the Women's March's youth organization. "We believe, as youth, it is imperative we have spaces where our voices are being heard. We DON'T need adults speaking on our behalf," Empower says.

The Lakewood Lancers event was organized by the ASB team, as one of the members stated,

"We will be held accountable for our future. In honor of the Parkland victims we organized a walkout. We recognize that safe schools must be a priority. We wanted to give everyone a safe space where they could advocate for this."

Each Parkland victim was commemorated by the reading of their name and the ringing of the bell while TAPS echoed in the background. Two stations were located on the football field where students could write a letter to their representative or compose heart felt letters to the victims' families and Parkland survivors. Across the campus were little yellow sticky notes with names of students that have been killed in school shootings since the beginning of 2018.

Lakewood High School Co-Principal Mario Jimenez stated "The students actually put their heads together and wanted to do something in memory of the Parkland shooting last month and to make a statement about violence in our schools. It is important for students to understand their rights in a structured and meaningful way. The student organizers were amazing. They wanted to do something that makes an impact on the student body, knowing that they can be agents of change. We hope the best thing that can come of this event is for our students to have a better understanding and be aware of the society we are leaving them."

It seems that this horrific circumstance has turned into a positive movement. Schools hold drills for fires, they drill for earthquakes and now schools across the nation are holding drills for lockdown situations in the case of an active shooter on campus. Moreover students are being educated and are becoming more aware if a fellow student is distraught or showing signs of potential harm to others.

One of the ASB organizers, a Lakewood High senior said, "We are here today to bring awareness of school violence and for students not to feel fearful. Our ultimate goal is to unify the school and that we speak as one voice about school safety."

The National School Walkout is the latest protest in a string of demonstrations, along with March 24th's March for Our Lives and April 20th's National School Walkout, designed to highlight the prevalence of gun violence and its effects.

the City and could once again stop the actions of Armenta, Tecero, and Salcido.

Several sources have come forward to HMG-CN describing a torrid romance and an alleged scheme to take over the lucrative Arena contract with different vendors and a new City contract.

Sources inside City Hall have confirmed a romantic relationship between Councilman Armenta and a former employee at the Arena. The woman, Julia Rodriguez, age 50, is reportedly in the United States on a work visa.

Rodriguez recently resigned from the Arena because her work hours had been severely cut.

On her way out, Rodriguez reportedly taunted the operators saying that her and Armenta, whom she called The Mayor, "would be taking control of the Arena and leaving them out on the street."

Before and after Rodriguez left, she was seen quite often at City Hall with Armenta, the two holding closed door meetings with staff.

An apparently emboldened Rodriguez, along with her daughter Dyana, another former Sports Arena employee, subsequently approached two individuals to be partners in their efforts to seize control of the Arena contract.

Later the two individuals attended the Dal Rae lunch, watching Armenta demand that Bobadilla find cause to terminate LEBA's Arena contract and immediately assign the contract to them.

HMG-CN has identified the two vendors as Xavier Ortiz and Eduardo Leon, both of whom have promoted events at the Arena in the past.

Ortiz is the registered owner of Think X Enterprises, Inc., Leon owns a promotion company called Eventos. It is unknown if they knew Armenta would go as far as he did during the Dal Rae meeting.

HMG-CN attempted to contact Rodriguez, Ortiz, and Leon, but those efforts were unsuccessful.

Good Government Activist Mike Alvarado told HMG-CN, "it appears that Armenta clearly crossed the line and may have committed at least two felonies. Threatening to fire an employee who is under contract with a city for refusing to aid and abet in the commission of a potentially illegal act is a form of extortion. Furthermore, Armenta suggesting and literally demanding that cause or evidence be fabricated to warrant LEBA's contract to be terminated is also likely illegal. Finally, demanding that city staff forgo a properly conducted and independent vetting process to award such a large and complicated government contract in order to favor one entity is also problematic and downright irresponsible."

Long-time Pico Rivera resident John Albitre told HMG-CN, "if Councilmen Greg Salcido and Brent Tecero knowingly joined in the firing or forced resignation of Bobadilla, could that be construed as an extension of possible crimes being perpetrated by Armenta?"

The City Council's next regularly scheduled meeting is Tuesday, March 13th. According to Councilman Bob Archuleta, the Bobadilla resignation item will be on the agenda, at the request of Armenta, Salcido and Tecero.

An angry Archuleta has made his intentions clear saying, "I personally am appalled this would even be on the table. I ask how many more Sheriff Deputies could we put on the streets keeping our community safe with the funds being needlessly squandered by the removal of our City Manager?"

Archuleta also told HMG-CN that, to his knowledge, LEBA has performed and fulfilled their duties at the nearly 40-year-old Arena without incident or concern to the city. Archuleta cites the relationship the city has with the operators as "outstanding."

The Cerritos Sheriff's Station lobby and parking lot are available as safe locations for buyers and sellers to meet to complete online transactions.

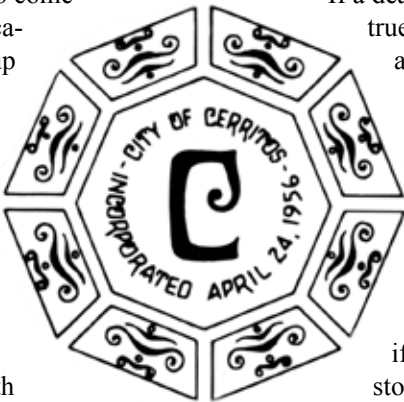
The Cerritos Sheriff's Station lobby is open 24 hours a day, seven days a week.

While online buying and selling can be easy and convenient, the practices also come with risks.

Allowing a stranger to come to your home or other location to pay for and pick-up an item can be a threat to your safety.

When meeting people to buy or sell items, heed the following tips:

- Meet at a reasonable time of day, preferably during daylight.
- Don't meet alone or with children present. Have someone accompany you.
- Don't hand over the item until you have the cash in hand.
- Avoid meeting at your home. If the item is too large to transport easily, consider placing it in the garage or on the porch/entry way. Arrange a meeting in a public place first (and bring a friend) to see proof of identity. If you're comfortable, allow the person to follow you home. If the buyer has brought someone, keep them together in your presence. The less they see or have access to your home and personal belongings, the better.
- If you agree to meet at a neutral location, consider a well-lit area with people



around and video surveillance cameras, such as the Cerritos Sheriff's Station lobby or parking lot. Don't meet in an area that's unfamiliar or uncomfortable to you. If the other party is not willing to meet you in a place you feel safe, don't meet.

- When purchasing items, inspect them for accuracy and be sure you're getting what you want. It's okay to change your mind and not purchase the item(s).
- If a deal seems too good to be true, it usually is. There are a lot of stolen items sold online. Drug users may sell things at extremely discounted prices just so they can get money for a fast high. Contact the Cerritos Sheriff's Station at (562) 860-0044 if you think something is stolen.
- Be careful with your money. Don't open your wallet and pull money out in front of the seller. Have the exact amount agreed upon in a specific pocket.
- If paying online, use credit cards or secure payment services instead of debit cards.
- When making online purchases in public, use your mobile phone network instead of WiFi.

JAY CHEN JOINS OTHER CANDIDATES FOR ROYCE'S SEAT

Since several Democratic and Republican candidates had announced last summer their intention to unseat Republican Congressman Ed Royce, they have held dozens of meetings and fundraisers to reach out to the voters.

Then Jay Chen entered the race.

Two days after Royce's Jan. 8 announcement that he would not seek reelection, Democrat Chen declared his candidacy and immediately began attracting lots of supporters.

As the only elected official in a field of mostly first-time candidates — including three who didn't live in the District when they entered the contest — Chen's experience in the District is important.

Congresswoman Judy Chu attended Chen's 40th Birthday Celebration & Kick-off Fundraiser Mar. 2 in Rowland Heights to say, "It's not often when a Congressional seat opens up, but now that it has, we need the right person, and that person is Jay Chen."

Chu announced her support of Chen because "he knows this District inside and out."

Chen has lived in Hacienda Heights for most of three decades and has developed a particularly strong base in the north part of the District that includes the Orange-Los Angeles-San Bernardino county lines. He was on the Hacienda La Puente Unified School District Board from 2007 to 2015. He currently serves as a trustee to the Mt.

San Antonio College Board.

Chu also thinks it is important that Chen has small business experience, as an owner of a real estate investment and management business, and his military background as a Navy reservist.

"One in three jobs is created by small businesses, and we need in Congress someone who understands the military. And as always—diversity is important, and Chen can reach out to the District since he speaks three languages: English, Chinese and Spanish."

Chu concluded, "I support Jay Chen wholeheartedly, and I can't wait to see victory in November."

Los Angeles County Supervisor Janice Hahn and Assemblywoman Sharon Quirk-Silva, along with numerous local leaders and officials, have also endorsed Chen.

He ran for Royce's seat in 2012, but was unable to unseat the incumbent. He thinks the time is right in 2018.

"It was a blessing in disguise," said Chen, "because it gave me an opportunity to get to know the District. Now, under the current Administration in Washington, we are shifting away from democracy. We should be standing up for democracy, but we're not, and the problem starts from the top."

He wants to ensure every American has access to quality healthcare, assist local businesses grow and create new jobs, expand access to college by making community college free, guarantee women equal pay for equal work and protect Social Security and Medicare from future cuts.

The District is 30 percent Asian/Pacific Islander and 33 percent Latino, and Chen sees ethnic voters as holding the key to victory.

"Democrats are only going to win if we can attract people who usually don't vote," he said.

At Mt. San Antonio College he has served as a fiscal watchdog, overseeing a historic expansion and upgrade of the largest single-campus community college in California. Recently Mt. SAC was selected to host the 2020 Olympic Trials for track and field, and was given a full seven-year academic accreditation.

In his race against Royce, the powerful chairman of the House Foreign Affairs Committee, Chen was outspent 5 to 1 but was victorious in Los Angeles County and set a record for most votes ever won against the 20-year incumbent.

A lifelong Democrat, Chen has earned the party's endorsement for all four of his races, and has been a county or state delegate each year since 2008. In 2011 he was selected as the Democrat of the Year for the 57th Assembly District.

The primary will be held on June 5. The top two finishers, regardless of party, will face off in November.

ing and forcing a Superior Court judge and Hews' attorney wait until the judge finally rescheduled the hearing.

In addition, Sarega filed in pro per, meaning he is acting as his own lawyer and not spending any of his own money.

The hearing was a "mandatory settlement conference" that took place at the Norwalk courthouse.

The courthouse is only 10 minutes away from Sarega's La Mirada home.

A mandatory settlement conference is a meeting between all parties involved in a case for the purpose of exploring possibilities for settlement. The presence of various parties at the mandatory settlement conference is just that, mandatory and not discretionary.

Mr. Sarega is obviously not interested in resolving his alleged concerns of the newspaper," said Scott Talkov, Hews' attorney, "if he did, he would have shown up."

In addition to missing the court date, Sarega has failed to answer discovery questions from Hews and Talkov further delaying the case and showing he has no intention of resolving his dubious claims.

Sarega filed the questionable lawsuit because of a series of hard-hitting articles that concluded with a Fair Political Practices Commission campaign finance investigation into Sarega that remains active and on-going after more than a year.

Sarega faces thousands in fines if found in violation of campaign finance laws, residents have also called for his recall from the La Mirada City Council.

"My attorney spent hours travelling

and waiting for Sarega," said Lamplighter Publisher Brian Hews. "He had no intention of showing up, he's too busy hanging around Randy Economy, who was convicted of methamphetamine possession, running a losing congressional campaign in a district Sarega does not live in. The hearing cost me \$1,000 and wasted the court's precious time and taxpayer's money. Sarega is cold-blooded in this lawsuit, he has no intention other than to make me spend money and try to put a venerable community newspaper out of business, an elected official trying to silence freedom of the press its outrageous."

The Lamplighter attempted to contact Sarega after he missed the latest court case but he did not respond to several emails.

CERRITOS SOFTBALL GETS BACK TO WINNING WAYS WITH COMPLETE TEAM EFFORT

NEWPORT BEACH-For a program coming off a 20-win season and a Suburban League championship, the last thing the Cerritos High softball team wanted to do was get off to a slow start. Having been blanked in their first two games of the season, the Lady Dons needed to get back on track.

After shutting out Dana Hills High 3-0 on Mar. 6, Cerritos made it two in a row with a 7-0 victory at Newport Harbor High two days later behind a complete team effort. The Lady Dons racked up 13 hits with every starter getting at least one hit.

“It’s something we’ve been working on,” said Cerritos head coach Kim Ensey. “We’ve been really consistent in the top five or six of our lineup all year. So, we’ve really been working hard at the bottom half of our lineup at producing runs. Between our small ball game and just simple base hits, the girls have really been producing at the bottom.”

Cerritos jumped all over the Sailors in the top of the first inning, scoring three runs on singles from sophomore center fielder Essence Gibbs, senior pitcher Jennifer Morinishi, freshman designated player Samiya Jones and senior first baseman Kiara Crockett-Pope. That was all the offense Morinishi needed. While the Lady Dons didn’t score again until the fifth, Morinishi was getting ahead in the count a lot while her defense was bailing her out of potential scoring chances by Newport Harbor.

“It definitely was something we needed to do,” Ensey said. “We needed that spark, starting with Essence having a great at-



bat to lead off the game. That’s why she’s there.”

Morinishi was ahead in the count 16 times and had an 0-2 count eight times. With runners on first and second and none out in the bottom of the second inning, she got Maxine McNerney to ground out back to her before striking out the next two batters. In the next inning, she got Alexis Amaro to ground into a double play and in the fourth inning, again with two on and none out, she got Kendall Kelly to pop-up followed by a pair of groundouts. Morinishi struck out eight batters and walked three.

“Well, it’s definitely been tough, coming back from an injury,” Ensey said. “She’s getting a little stronger each inning, but there’s still a lot of pain there. We expect big things from her in her senior year; nothing less. She’s a little bulldog, like I said last year. She fights in everything. If it were up to her doctor, she would have stayed out a little longer. But she leads this team very well.”

In the top of the fifth inning, senior catcher Alyanna Hernandez singled and was replaced by sophomore courtesy runner Daisy Martinez, who stole second and scored on a base hit from junior shortstop Niki Ibarra. Also coming home on the play was Gibbs. In the next inning with one out, junior left fielder Elise Gibbs, freshman second baseman Lauren Lejano and Hernandez all singled.

Cerritos is in the Torrance National Tournament through Saturday and had a pair of games on Mar. 15, the first against Basic High out of Henderson, NV. The Lady Dons then begin their defense on what it hopes to be their last league crown when they visit John Glenn High on Tuesday and Norwalk High on Thursday.

“It’s a really great tournament; I’ve

been a part of it for quite some time,” Ensey said. “It’s a really competitive tournament. I like that we get to play teams from outside of our state. I’m really excited for how we can do; the potential that we have. Last year we took third and this year I would hope that we can come around the same or higher.”

In other softball action, Artesia High fell to North Torrance High 6-3 this past Tuesday to drop to 2-2. The Lady Pioneers hoisted Paramount High on Mar. 15 and will face San Dimas High in the first game of the Santa Fe Tournament on Saturday. League play begins on Tuesday with a home game against Norwalk. Two days later, the Lady Pioneers will visit La Mirada High.

Gahr High began the season on a roll, winning its first three games by a combined score of 11-1. But then the Lady Gladiators lost three straight games before shutting out Capistrano Valley High 2-0 this past Wednesday in the third of four games in the Capistrano Valley Tournament. NEWPORT ELKS BASEBALL TOURNAMENT

Vasquez, Cerritos continue to stay hot, down Schurr to end first tournament

Who knows where the 2018 Cerritos High baseball team would be standing after the first few weeks of the regular season had it not been for a 10-0 loss to Segerstrom High in pool play action of the Newport Elks Tournament. But the Dons rebounded nicely and ended competition in the Costa Mesa Division of the prestigious event by slamming Schurr High 9-2 last Friday afternoon to finish with one loss in five games played in the tournament.

Including a doubleheader sweep over Costa Mesa High to begin the season, the Dons are 6-1 and have outscored their opponents 46-7 in the six victories.

“Last year we were in the lower level of the tournament and we went 5-0,” said Cerritos head coach Scott Parsonage. “We tried to bump it up and play some better teams. We showed up against Segerstrom, but we didn’t show up to play. Hopefully we learned from that.”

Sophomore Evan Vasquez worked a perfect top of the first inning and the Dons were ready to give him some support in the bottom half of the frame. Sophomore center fielder Raul Garcia was walked by Aaron Alvarado and Cerritos loaded the bases on consecutive singles from junior left fielder Matthew Aguinaga and Vasquez. But a ground ball for a double play and a groundout ended the early threat. In the next inning, Schurr’s Andrew Lujan smacked a home run over the right center fence for a 1-0 lead. The Spartans added to their lead in the third when Vasquez walked Brandon Alcantar with one out, went to third on a bunt from Justin Cervantes and an error and came home on a balk.

“That’s baseball for you,” Parsonage said of the home run. “You roll the dice and try to stay out of the middle there, but it is what it is. He didn’t elevate that ball enough and grounded into a double play. That’s a pitcher’s dream right there.”

But Vasquez settled down and retired 10 of the next 12 batters he faced, including a prefect fifth and sixth innings. Meanwhile, the bats came alive for the Dons over the next four innings. Martinez walked Garcia again to begin the third inning and with two outs, sophomore second baseman Alex Manibusan’s single made it 2-1.

In the next inning, freshman third baseman Nick Hill led off with a double, went to third when sophomore catcher Jonathan O’Neill put down a bunt up the third base line and sophomore first baseman Dee Vizcarra was walked to load the bases. One out later, Garcia singled and Aguinaga doubled to make it a 4-2 contest.

O’Neill’s one-out base hit in the fifth plated junior shortstop Matthew Pinal to make it 5-2 before the hosts put the game away with four more in the sixth inning. Sophomore right fielder Xavier Medina and Garcia each singled before Aguinaga bunted up the first base line and the baseball proceeded to go past first base and into right field for a rare bunt double. Two batters later, Manibusan’s base hit to center brought in Aguinaga and an error would allow Manibusan to score the game’s last run.

“I haven’t seen a bunt like that without a shift on for a double in my life,” Parsonage said. “That was pretty crazy. We don’t bunt too much in the fall because it’s fall. We get them to swing. But obviously we know when it comes to the Suburban League, they are nail-biting games some-

times and it comes down to getting a bunt down, making a pitch, making a play on defense and executing on offense. Failing one time could be the outcome of you not winning that game.”

Everyone in the lineup contributed for Cerritos with Aguinaga collecting three hits while Garcia, Manibusan and O’Neill all had a pair of hits. Garcia also scored three times and Aguinaga drove in three.

“That was huge,” Parsonage said. “That’s spread out even in the lineup and it’s hard to defend if you can do that. Hopefully at times we can add some of those hits in the same inning to get some runs and not spread them out so much. Our lineup is consistently changing; we just still haven’t found anything set in stone.”

Vasquez, who picked up his third win of the season, scattered three hits and struck out five while walking two. Senior Kaleb Ferrer came in the seventh to retire the side on seven pitches. In his three starts, Vasquez has allowed 12 hits and three runs.

“The best pitchers give up home runs sometimes,” Parsonage said. “The thing you want to do is give up the solo shot and not the three-run shot after you walk a guy or hit a guy. Today he didn’t have his changeup working. He was kind of burying it a little bit and that was pretty much the difference why he wasn’t as dominant or as effective as he usually is.”

Cerritos will travel to Long Beach Poly High on Saturday for a doubleheader before opening its final season in the Suburban league at La Mirada High on Wednesday.
