The subpoena is a result of a 2016 HMG-CN investigative exposé

Hews Media Group-Community News has obtained an onerous and wide-ranging federal subpoena sent from the United States Securities and Exchange Commission to the Montebello Unified School District requesting documents related to, among other things, the \$100 million "Bond Offering in December 2016."

The ongoing SEC inquiry was a result of a series of investigative articles published by HMG-CN beginning in 2016.

## INVESTIGATION OF EL RANCHO TEACHER FINDS PORNOGRAPHY ON HIS SCHOOL COMPUTER

Statements from teachers, parents and students indicate Greg Salcido is a racist, bigoted homophobe with violent tendencies.

Hews Media Group-Community News has exclusively obtained, through a Freedom of Information Act request, the investigation report of disgraced El Rancho Teacher and Pico Rivera City Councilman Gregory Salcido.

The investigation was conducted by Glendale-based Garcia, Hernandez, and Sawhney, LLP.

In January, Salcido was caught on audio slamming all United States military personnel as "dumbshits" and "not talented" during a class lecture.

In his diatribe, first reported by HMG-CN, that caused national outrage and spurred the investigation, Salcido was caught on cellphone video saying to his

The La Mirada 4th Annual Mayor's Prayer Breakfast was held Friday, April 13th at the Holiday Inn on Firestone Blvd.

To begin the morning Rabbi Dr. Mark Goldfarb sounded the shofar, followed by a musical presentation from Biola's own Kings Men Ensemble who's a capella voices rang throughout the hall. The opening invocation was given by Imam Yahya Asari of the La Mirada Masjid and the Presentation of Colors was performed by Southeast Academy High School.

This particular Mayor's breakfast was light hearted and had a very welcoming feel to it, like family gathering for a holiday. And the matriarch of this family was the spry and quick witted Ms. Myllie Taylor.

Taylor has lived in La Mirada since before it became a city. Taylor helped organize the incorporation of the City and served as co-Chair of the Friends of La Mirada Theater. She has served on several commissions, Chamber of Commerce and is the originator and first president of the La Mirada Hospital Advisory Council. Her dedication to the City is evident through her philanthropy and service.

To honor this legacy, the Myllie Taylor Service Award is presented to an individual, a community based organization, or a business that is located within the City and has shown extraordinary service or given selflessly of time and talent contributing to the betterment of the community. This

year's recipients were volunteer Marlene Olsen and the Kiwanis Club of La Mirada.

Keynote speaker this year was Janice Hahn, Supervisor of Los Angeles County 4th District. "The first moment I walked into the room this morning, Ms. Myllie said come here child, let me look in your eyes," Hahn continues, "Myllie said 'yep - I can see your father in your face.'"

Hahn spoke about faith in one's life. She began by giving two quotes, one was from former President Jimmy Carter, "We need to have something unshakable in which to have faith, like a mother's love, something that can't be changed by war or political events. We need a foundation on which we can build a predictable and dependable existence." The other quote was by Dr. Martin Luther King Jr when he said, "Faith is taking the first step even when you don't see the stair case."

Hahn was known in Congress for working across the aisle and trying to find common ground, "Let me tell you," said Hahn, "that is easier said than done. There really is an aisle in Congress, we sit on one side and they sit on the other side. The Republicans and the Democrats don't really have too many things that they can come together on."

She went on to elaborate that they meet in separate rooms, they don't eat together, and it is very difficult to meet in the middle and find common ground saying, "It is easy to find a way to disagree, but to

# STATE OF THE CITY: LA PALMA REMAINS ONE OF BEST CITIES IN ORANGE COUNTY

When La Palma residents attended the annual State of the City event Apr. 12 at the La Palma Community Center, they were hoping to hear that the City was in good shape. They were not disappointed.

Mayor Gerard Goedhart welcomed more than 100 residents to the event that highlighted the City's past year's achievements along with future projects.

Mayor Pro-Tem Marshall Goodman began by sharing the Five Years of Progress segment and said, "That again as published in the OC Register, La Palma is in the top 25 per cent of the best cities in Orange County, and in the top 23 per cent statewide."

The last five years had brought numerous fiscal challenges, to the small city of nearly 16,000 residents, with the dissolution of redevelopment and needed revenues, loss of major sales, rising pension and insurance costs and the loss of \$1million dollars from one company alone.

La Palma had to reduce its workforce by 20 per cent, make changes to labor union agreements, restructure, invest in new technology and modify the long-standing investment policies.

In 2016 the City asked residents to step up to the plate and approve Measure JJ that would add a one per cent sales tax to all purchases. The fiscal climate changed dramatically after the Measure passed.

La Palma was then able to make significant payments to lower its unfunded pension liability that improved its fiscal standing.

Councilwoman Michele Steggell proudly shared the City's 2017 accomplishments that included forming a La Palma Community Foundation and raising revenue for projects, such as the Every 15 Minutes program, that educates youth on the dangers of drinking or texting when driving.

A permanent solution on school boundaries, that will allow La Palma children north of Houston Avenue to attend La Palma schools, is soon becoming a reality. The Orange County Board of Education will now approve most student transfers.

After many years of neglect, La Palma was able to improve maintenance including the painting and repair of all of the exterior walls in the City.

La Palma has also overhauled its website as well as completed a billboard project that will bring more than \$200,000 each year to the City.

Steggell also announced that 101 businesses opened their doors in La Palma in 2017.

Councilwoman Kathy Flachmeier added that the City is considering allow-

ing cannabis sales in order to add more than \$1 million to the La Palma's coffers while at the same time monitoring the use.

Dog lovers will be happy to know that a dog park will soon be in place as well.

Upcoming projects include residential pavement of streets and improving City facilities with new technology.

Police Chief Terry Kim said that for the first time in nine year the police department is fully staffed. "We also have improved our systems and training," said Kim. He announced that in 2017 there were 6,332 calls while 341 were priority one calls. This is a 24 per cent increase from 2016.

"Yet our response time is only three minutes, violent crime has decreased by 49 per cent from 2016 and property crime has decreased by 2 per cent."

Kim is proud of the volunteer programs such as the Volunteers in Policing (VIP) program and the You Are Not alone (Y.A.N.A.) program that visits homebound or shut-in residents.

City Manager Laurie Murray was excited to report that La Palma is fiscally sound. "From a projected deficit of more than \$772,000 in 2016 to a projected surplus of \$458,000 in 2018 and growing, we have overcome our past fiscal challenges."

She reported that employee morale is high compared to five years ago, and the unions have recently approved a three-year contract with the City.

Projected revenue is \$14.3 million and estimated expenditure is \$14.1 million. General fund balances are more than \$28 million.

State Senator Josh Newman informed the audience that he was able to work with the state to secure funding for a task force to fund local projects for La Palma and nine neighboring cities that resulted in a grant of \$20 million over four years.

Much of the revenue will be directed to alleviate homelessness and to focus on gang prevention by hiring a school resources officer who will hold after school programs to mentor youth.

Assemblywoman Sharon Quirk-Silva also stressed the homelessness problem in Orange County and throughout the state. One option is to partner with the National Guard to open up armories for temporary housing of the homeless for up to ninety days.

Residents were pleased to hear that the City was fiscally sound and thanked the staff for being proactive during the bad times, and they were looking forward to brighter days ahead for living in one of the best cities in Orange County.

**ALL IN THE RUIZ FAMILY**

Born out of a simple idea and collaboration by Youth Center Board Member Mark Anthony Ruiz, who learned about fitness from having to relearn how to walk as a child, CrossFit Tribe in Los Alamitos will be hosting Keeping Kids On Track Fitness and Fun Day on April 28 to raise funds and awareness about the award-winning non-profit.

When Ruiz was a child he was affected by Guilliane Barre Syndrome, a rare but serious autoimmune disorder in which the immune system attacks healthy nerve cells in your peripheral nervous system. This leads to weakness, numbness, and tingling. It can eventually cause paralysis. The cause of this condition is unknown, but it's typically triggered by an infectious illness, such as the stomach flu or a lung infection, according to www.healthline.com.

"I had to relearn how to walk," Ruiz stated. Consequently, he has always been fascinated with the fitness and the way the human body moves. He said that fascination turned into a desire to help others become physically active. He went on to graduate with a degree in Kinesiology from Cal State Long Beach and to coach wrestling for 30 years.

"Your body is a machine," he explained. "Getting fit is making sure your machine runs for a long time and at optimal efficiency."

"The idea for the event was a collective effort that came from a simple idea that I wanted to introduce collegiate wrestling and the training that it takes to become a high caliber wrestler," Ruiz said. "We put our heads together and I reached out to Tito Ortiz to see if he'd be interested in coming aboard. The final collaboration with CrossFit Tribe made the idea a reality."

"One of our family mottos is, 'Try something new,'" Ruiz said. "I would encourage everyone reading this to adopt that motto, even if it's just for one day. Work-

ing out doesn't always have to be lifting weights, it can be having fun with your kids."

"This clinic and fundraiser is one of those opportunities not just to help The Youth Center, but to connect with your children and do something that may be brand new to both of you."

Ruiz proudly said that today his family is an active family. His nephew, a Division 1 wrestler and graduate from Arizona State University, helps coach the Los Al Mat Monsters along with several other collegiate and Olympic wrestlers. And, his three boys are very active not just in Mat Monsters' Wrestling but also in football, baseball, and golf.

"As time marches on, I'm discovering that the more active I am the more active my children are," he said. "The benefits of an active lifestyle, besides the obvious, are the moments I have bonding with my boys that I would have missed if we were sitting

in front of a television or the boys had their noses buried in their screens."

CrossFit Tribe Functional Fitness will be hosting Keeping Kids On Track Fitness and Fun Day for all ages from 10 a.m. to 2 p.m. on April 28 at their location at 10712-B Reagan Street in Los Alamitos, where for \$5 participants can choose from doing the warrior obstacle course, wrestling competition, a basic CrossFit or 10-station circuit workout.

"The workouts are boot camp style stations designed to push you off your fitness comfort zone while having fun and raising money for a good cause," Ruiz said. "They are designed for young children and all the way up to active older adults, and can be tailored for all fitness levels. You're really getting a great sampling of work outs for \$5."



Jason Lee, SEC Senior Counsel wrote, "the staff of the San Francisco Regional Office of the United States Securities and Exchange Commission is conducting an investigation [into the MUSD]. The enclosed subpoena has been issued to MUSD as part of this investigation. The subpoena requires MUSD to provide us documents."

Lee demanded, "any written, printed, or typed matter including interoffice communications, worksheets, financial records, accounting documents, bookkeeping documents, telephone logs, facsimiles, emails, voice mails, tape recordings, notes of meetings, purchase orders, spreadsheets, data compilations that are stored in any medium from which information can be retrieved, obtained, manipulated, or translated."

Lee's information demand concerned MUSD, Del Terra Real Estate Services, former MUSD Chief Financial and Operations Officer Cleve Pell, former CBO Ruben Rojas, former Superintendent of Schools Susanna Contreras Smith, and the accounting firm of Vasquez & Company LLP.

"All documents and communications concerning the selection of Del Terra to perform project management and/or construction management services for MUSD including any responsive bid package; all communications discussing, analyzing, and/or assessing a responsive bid; all communications concerning the process used to select the individuals or firms who were ultimately awarded contracts by MUSD; the process used to select any individual or firm to perform services related to MUSD's municipal securities program.

The letter continued with the SEC in-

vestigation demanding information about the employment moves related to Contreras-Smith, Pell, and Ruben Rojas.

In 2016 HMG-CN reported on the meeting when Contreras-Smith and Pell were "placed" on leave. The article cited Rojas as the driver behind the move against Smith and Pell.

The district's long-time attorney, Pico Rivera based David Kinney, was also fired.

Montebello School Board Places Superintendent and Chief Financial Operations Officer on Administrative Leave

"All communications concerning the placement of Susanna Contreras Smith, Cleve Pell, and/or Ruben Rojas on administrative leave; the removal of Susanna Contreras Smith, Cleve Pell, and/or Ruben Rojas from MUSD including any allegations of fraud, unlawful conduct, misconduct, and/or mismanagement; any complaints about their conduct and/or qualifications and any informal or formal investigation relating to three former officials.

The SEC is also investigating possible violations by the financial advisory firms for the Bond related to contributions to MUSD, a member of MUSD's Board or an MUSD administrator.

The inquiry could be related to Lalo Trujillo and his firm as reported by HMG-CN in 2016.

HMG-CN Exposé: Montebello Unified Bond Advisor Lalo Trujillo Lied to Board Members During Regular Meeting.

"All documents and communications concerning any instance in which one of the following entities or individuals was solicited to make a financial contribution of any kind including any underwriting firm that marketed its services to MUSD;

any financial advisor that marketed its services to MUSD; any other entity that marketed its services to MUSD related to the issuance of municipal securities and any employee, contractor, or agent of the foregoing entities."

Finally, the subpoena demanded, "any allegations of impropriety and/or unlawful conduct related to MUSD's municipal securities program committed by any member of MUSD's administrative staff or Board of Education; any allegations of impropriety and/or unlawful conduct related to MUSD's finances committed by any member of MUSD's administrative staff or Board of Education; any concerns identified by Vasquez."

Lee requested all material be sent to the SEC's Washington, DC office.

class, "we have night vision goggles and we can't control these people wearing robes and chanklas."

"It's a lie our military is talented," he said.

"Because we have a bunch of fricken dumbshits over there. They [the military] are not high-level bankers, they are not academics, they are not intellectuals....they are the lowest of the low, think about the people you know over there, stupid uncle Louis', they are not talented people, they are dumbshits. The data is in, we don't have a talented military, we have not been able to beat people with robes."

The Sawhney investigation received statements from 34 former and current ERUSD staff, administrators, parents, and students.

The group outlined several racist, bullying, and homophobic incidents perpetrated by Salcido.

The investigation also included several letters of reprimand and two letters of Notice of Unsatisfactory Conduct.

The shocking statements and findings will have many asking why the teacher's union did not terminate Salcido's ERUSD contract years ago.

In addition to the statements and letters, investigators seized Salcido's hard drive, on an ERUSD owned school computer, that contained pornographic pictures.

The hard drive also included "hundreds of emails" showing Salcido conducting his Pico Rivera City Council business on ERUSD time.

**Statement from parents and students**

One student said Salcido talked about suicide, "saying stuff like if you didn't do good academically these four years or if you have a low GPA you might as well just go jump off a building because your life is pretty much over."

In May 2012, Salcido admitted to smacking a kid in the head and was suspended.

Salcido was also found challenging

a student to a fight after school and off-campus.

One parent told the investigator that when his son went to sharpen his pencil in the back of the classroom, Salcido yelled "hey what are you doing back there jerking off?"

A Rio Hondo college recruiter told investigators "he just went off like a really upset man and said like why are you going to try to come in my class and tell my students false information, I don't even recommend my students go there."

The recruiter said, "Salcido berated me, if he can make a grown woman feel that bad, imagine what he does the children."

One student told investigators that Salcido refused to sign his permission slip allowing him to join a field trip to Rio Hondo College saying, "I don't sign shit for Rio Hondo."

One teacher filed a complaint against Salcido in 2011. "He came into my room he was very aggressive and began yelling at me. I was fearful because there was no one else in the room and he was two inches from me."

Shockingly, the principal at the time did not require Salcido to write an apology; the teacher "never received one."

The teacher also said that Salcido "berated kids all the time, made fun of them, and wouldn't let them in the class because of what they were wearing."

Yet another incident occurred when a mother complained Salcido was degrading her daughter because she was Anglo. "He was calling her 'Nazi' and saying he didn't like her and, according to the letter of reprimand, Salcido said 'shut up or I'll kill you.'"

Another student said Salcido "made inappropriate statements during lectures talking about pornography frequently, and making stupid comments like you guys probably watch it on your phones."

That same student said, "Salcido was a racist, he made fun of an Asian girl's eyes. If you were bisexual or gay he would single you out."

Finally, an assistant superintendent told investigators that when the district entered into a contract with the drug sniffing dog company Salcido refused to let the dog into his classroom telling the kids it was an "illegal search."

**Shocking photos on school computer**

Investigators also conducted a forensic examination of Salcido's computer and hard drive, and what they found was shocking.

The investigation recovered four disturbing images from a "deleted file space" including an image of a young boy standing behind a large sumo wrestler pulling on his thong; a large breasted woman wearing only a revealing bra and lifting her breasts; a nude woman kneeling on a bed; a nude woman with a small pasties on her breasts.

"Each piece of evidence on the computer speaks for itself and shows inappropriate images for a school computer."

"It also showed work time spent on city of Pico Rivera business."

The investigation's findings of facts include Salcido believing it should not be illegal to download kiddy porn, using racial slurs like 'Beaner' and derogatory nicknames referring to heavy students, and forcing students to perform humiliating calisthenics in front of the class to shame them when they are late.

Salcido also shirked his teacher duties "leaving campus most days during his professional development sessions to attend to his personal agenda...he has been doing this for years," the investigators stated.

Along with the termination of his teaching contract, Salcido is also the subject of a recall from his City Council seat in Pico Rivera.

## LAKWOOD PROPOSES SOCCER CENTER FOR BLOOMFIELD PARK

**BLOOMFIELD PARK** is a 15-acre facility located near the corner of Centralia Avenue and Pioneer Boulevard. The proposed soccer fields would be smaller-sized, designed to accommodate 5 on 5 and 7 on 7 games.

The City of Lakewood is exploring an "exciting possibility" of collaborating with Goals Soccer Center, Inc. to build a synthetic turf soccer facility at Bloomfield Park.

The center would be located on the currently under-utilized north end of the park.

If approved, the project would consist of multiple, illuminated soccer fields, an administration facility with café, and added parking to supplement the existing parking at Bloomfield Park.

The soccer fields would be smaller-

sized, designed to accommodate 5 vs. 5 players and 7 vs. 7 players.

Bloomfield Park is a 15-acre facility located near the corner of Centralia Avenue and Pioneer Boulevard. Originally a county facility, the park was annexed in 1964.

In 1999, Bloomfield Park received new playground equipment and numerous park improvements.

In 2008, the facility received a major makeover and added the Teen Resource Center. 2012 saw the completion of a renovated "Tot Lot."

A \$15 Day Pass is required to board AquaLink. A cash fare of \$1 per boarding is available for AquaBus.

AquaLink carries up to 75 passengers and will have direct service from Alamitos Bay Landing, 100 N. Marina Drive, to the Aquarium of the Pacific dock from 8 a.m. – 10:20 p.m.

AquaLink provides seamless travel along the Long Beach coastline making the one-way scenic voyage in about 25 minutes.

Refreshments are available for purchase aboard AquaLink. AquaBus carries 35 passengers and will service the Queen Mary, Hotel Maya, Aquarium of

the Pacific dock and Shoreline Village from 8:05 a.m. – 7:30 p.m.

"Every year we work to improve the customer experience and the addition of water taxi service to the Toyota Grand Prix of Long Beach as it was a unique and fun way to make that happen," said Grand Prix Association of Long Beach President & CEO Jim Michaelian.

Water taxi service is provided seasonally by LBT typically from April through October.

The Artesia City Council approved Artesia Live II, a mixed-use development proposed by Cornerstone Artesia Development, LLC, at its March 12, 2018 meeting. Artesia Live II is planned to be constructed at 18600 Gridley Road. The development would consist of a seven-story building measuring 85 feet in height to accommodate 130 residential condominium units, 3,605 square feet of retail use and a 20,211 square foot restaurant, all on an existing property of 1.3 acres.

The project was slated to bring in an estimated \$500,000 to Artesia City coffers annually.

That is not counting the projected 550 jobs the project will generate via the Marriott Hotel, the 600 jobs created during construction, or other fees paid to the City by the developer.

Cornerstone Artesia Development, LLC (Cornerstone) will invest \$45 million dollars into the 7-story residential and commercial building that will encompass 250,000-square-feet.

The development is the first of its kind in the City and will consist of the Marriott hotel, high-end condominiums, boutique shops, restaurants, and a two-level subterranean parking structure.

Contrary to the city of Cerritos' claims, Cornerstone went the "extra mile" making certain the project cleared City parking requirements by building surface parking and a two-level subterranean parking structure, for a total of 331 parking spaces.

And the project will follow green energy guideline for "green structures."

Features will include solar energy, electric car charging stations, a sustainable roof

top garden to reduce heat, and water conservation fixtures & LED lighting throughout the building.

Cornerstone also consulted with many engineering companies conducting traffic, parking, and noise studies; air quality and greenhouse studies.

Despite their efforts, Cerritos filed its lawsuit.

Cerritos' concerns about the project "relate to significant project impacts on surrounding residential and commercial uses, including traffic, traffic circulation, parking, privacy and aesthetics."

Among the City's concerns detailed in the lawsuit are:

The Traffic Impact Analysis pertaining to the project's impact on the intersection at Gridley Road and 186th Street does not accurately reflect projected traffic volumes due to the use of outdated impact assessment methodologies and software.

The potential modification of the existing center median on Gridley Road is not acceptable to the City of Cerritos.

The proposed drop-off lane on Gridley Road immediately to the west of the project area would create significant traffic conflicts between vehicles exiting the drop-off area and vehicles traveling northbound on Gridley Road, thereby increasing the probability for traffic accidents to occur.

The height of the development will have a significant visual, aesthetic and privacy impact on adjacent residential and commercial uses. The seven-story building is not compatible or comparable with the existing one- and two-story residential and commercial developments found in the surrounding area.

The number of on-site parking stalls provided for the project is significantly deficient. This could likely cause patrons and residents of Artesia Live II who are unable to find parking on-site to be forced to

utilize off-site parking in adjacent arterial and residential streets as well as at commercial sites in the City of Artesia and the City of Cerritos, including the Los Cerritos Center.

The City of Cerritos' petition seeks an injunction preventing the City of Artesia from carrying out the project; a rescission of the all project approvals; compliance with the California Environmental Quality Act and development consistent with the Artesia General Plan and State Planning and Zoning Law. The petition also seeks an award of attorneys' fees and costs.

The City of Cerritos submitted extensive written comments outlining its concerns to the City of Artesia throughout the project review process, but those concerns were not addressed.

Cerritos Mayor Grace Hu said, "While the City of Cerritos looks forward to the future development of the property at 18600 Gridley Road, the project as approved by the City of Artesia has significant issues that need to be addressed. The City of Cerritos remains concerned about the traffic, parking and privacy and aesthetic impacts that the project is likely to have on residents and businesses of both Artesia and Cerritos."

find something that you have in common takes work."

One of the things that Hahn decided to do was to get up early once a week in Washington D.C. and attend the Congressional Prayer Breakfast, "This is the one hour a week in D.C. where Republicans and Democrats come together, leaving political partisans at the door and we pray. We pray for each other, we talk about our

weaknesses and our faults, we pray for our families, we sing a hymn together and then one member of Congress gives their personal testimony, their journey of faith." Hahn went on to say, "We all need to find ways to pray together and to lift each other up." Hahn gave her testimony of faith as a newcomer, and she gave the story of her grandparents, John and Hattie Hahn who came to the states in 1920.

As the story goes her grandfather John Hahn had a heart condition, he and Hattie had six boys all under the age of ten, and when they moved to Los Angeles, she was pregnant with her seventh son. Before the furniture arrived, John had a fatal heart attack and died. Within three months of his death, Hattie's seventh son was born. And in a horrible turn of events, Hattie's uncle embezzled all of her money.

"Here was my grandmother, with seven little boys – a foreigner, a widow, an immigrant and now penniless. There was a moment of intense sorrow, of hopelessness, desperation, anxiety and fear. She had no idea how to survive." Hahn continued saying her grandmother did not see the staircase, and thought a better course of action would be take all of her little boys into the kitchen, tape up all the doors and windows and turn on the gas stove, "But there was a moment of the unmistakable presence of God. I believe in an unshakable faith that God spoke to my grandmother and told her everything would be okay."

Hattie told all of her seven little boys not to forget who they were and that they would grow up to be something special, "Thank goodness she did, because that seventh little boy that was born, was my Dad – Kenneth Hahn."

"From the moment I was born I believed that, even if I couldn't see the staircase, I needed to have the faith to take that step."

Stateroom B340 has a large volume of recorded paranormal activity with many stories of haunted encounters noted in the ship’s logs. Reports date back to the final ocean voyage in 1967 and include complaints from guests staying in B340 claiming that someone was knocking on the door in the middle of the night. # CITY OFFICIAL SLAMMED FOR DEMANDING REMOVAL OF U.S. VETERAN FLAGS

There are many things in today's society that stir emotions, whether it is violence, abuse, political lies or the constant attack on our constitution. The one thing that will rouse the hackles on just about everyone I know is to disrespect and dishonor our military.

There is a video that is trending on Facebook about the removal of flags that are flying outside of Jaguar Power Sports in Jacksonville, Florida.

Apparently a woman by the name of Melinda Power that works for the Jacksonville's Compliance Department did not agree with the military flags that are mounted and flown outside of the store. Power approached the store manager demanding that the flags be removed. Her request was ignored and she gave the owner a citation, adding if he did not agree to this action, he could go to court. Powers turned to a customer and veteran who witnessed the ordeal and added, "You did nothing for our country". This gentleman suffered gunshots from being on the battle front.

The owner of Jaguar Sports immediately, stepped outside of his store, created a video for Facebook and requested that everyone make the video go viral and it has. In the video he says "In this city that has a military base, and with everything going on, Jacksonville is citing business owners for flying military flags in a military town."

According to Military.com Jacksonville is home to multiple military facilities and with Naval Submarine Base Kings Bay nearby, gives Jacksonville the third largest military presence in the country.

This story was picked up and apparently there is a petition on Change.org demanding that Power be fired. She did post an apology on her Facebook paged saying in part "I have been asked to repost, I have the utmost respect for the Military. My father was a WWII; my husband was a Vietnam Vet and my son-in-law a retired Marine." Power goes on to say that the ordinance was changed 'as it should be'; she also goes on to say "I should never have been unprofessional and disrespectful."

The City has requested the store surveillance video showing the confrontation, and Jaguar Power Sports has been receiving a ton of support from veterans around the country and around the world, noting that the store has received comments and compliments as far away as Germany.

HMG reached out to the Mayor Lenny Curry regarding the display of military flags at the business, we received the following written statement:

"Employees of the City of Jacksonville are the servants of taxpayers who have a duty to enforce our laws and regulations. I expect every one of them to do that job in a manner that is respectful and reflects the privilege we all have to serve this great city. What I saw reported is 100 percent inconsistent with how I expect every city employee to interact with our citizens.

I have ordered a review of the actions of the employee and pending the completion of that review, the employee and her supervisor have been placed on leave. Today I will ask every manager of city departments to review our procedures with each city employee. Once a review of the actions in this matter is complete, appropriate corrective action will be enforced

for any wrongdoing.

As the son and grandson of military veterans, and the mayor of a city with a proud history of commitment to our nation's defense, I will not tolerate disparagement or disrespect of the men and women who serve or served. On behalf of the City of Jacksonville I apologize to veterans and service members who are rightly troubled by the events that have been reported.

While current ordinance does not address residents or businesses displaying military flags, I will not allow any citation of those who demonstrate their support for the Armed Forces. My team is working with the city's Office of General Counsel to bring clarity to the relevant city laws."

## SAN GABRIEL VALLEY LEAGUE SOFTBALL : GAHR WINS THE HOME RUN BATTLE, HOLDS ON TO STOP WARREN'S LATE RALLY

The wind was blowing out at Gahr High this past Tuesday afternoon and when that happens, you can expect to see lots of balls that are not retrievable. The host Lady Gladiators and Warren High combined for six home runs and 19 runs, the most in the rivalry in over 21 seasons, and despite allowing three runs in the top of the seventh inning, Gahr was able to hold on for a 10-9 victory.

The latest installment in what may be the best matchup the San Gabriel Valley League has to offer each season saw the Lady Gladiators improve to 15-4 overall and 3-0 in the league. After losing 10 straight games to the Bears from 2009-2013, Gahr has now won seven of the last 10 meetings including the past five.

"You just don't know what you're going to get," said Gahr head coach Shawn Quarles. "It's always going to be exciting. They're always going to fight. But Huskey wasn't done as in her next

at-bat, she followed Tapia's second hit with a two-run home run, this time over the left field fence to put the Lady Gladiators up 7-5. Then to no one's surprise, she was intentionally walked in the sixth.

"In my first at-bat, the blue was calling low and he actually got me because I swung at a low pitch," Huskey said. "In my second at-bat, I was just waiting for something up in the zone that I could do something with."

"That girl is just a stud," Quarles said. "If she's in a zone, there's not too many people who are going to pitch to her. She hits the ball square a lot of the time and she's just seasoned. She's played a lot of high level ball, and especially in situations like this, she's definitely going to help her team out."

With two outs in the fifth, senior first baseman Jade Wittman was hit by a pitch and scored on a double to center from sophomore designated player Johanna Rodriguez. Gahr wasn't done with the hitting as in the next inning, sophomore pinch hitter Sydni Jones smashed a solo home run over the left field fence after seeing just two pitches. Later in the frame, Davis, who was walked following the home run, scored the 10th run when Hill was safe on an error.

The Bears made it interesting in the top of the seventh when Karly Colenzo singled and was replaced by courtesy runner Arlene Martinez. Brooklyn Araujo would reach on a fielder's choice with Martinez safe at second on a fielding error. That set the stage for Annmarie Sillas, who hit a three-run shot over the centerfield fence.

That would be the end for Gahr junior

## SUBURBAN LEAGUE BASEBALL : ANGULO DOMINATES NORWALK AS JOHN GLENN COMPLETES HOME AND HOME

When the regular season is over, there will be some serious debate as to who the best pitcher in the Suburban League is. Yes, La Mirada High may be the favorites to win the circuit this season as it boasts one of the best teams in the nation. But John Glenn High isn't going away with the pitching staff it has.

Junior Joseph Angulo scattered seven hits and gave up an unearned un in the bottom of the seventh inning as the Eagles took care of Norwalk High 6-1 last Friday on the west side of town, completing the home and home weekly season series. For Angulo, who improved to 5-1, it was his fourth straight complete game in six starts this season.

"He was awesome," said Glenn head coach Jack Brooks. "He was fantastic. He got ahead, mixed well and he competes."

In the next inning, with two outs, Angulo was hit by a pitch and stole second and Chiquito was safe on Norwalk's lone error before an infield knock from junior center fielder Damone Hale made it 2-0. On the next pitch, junior catcher Alexis Martinez singled to center to plate Chiquito.

"Offensively we were much better;

pitcher Danielle Martinez, who threw 135 pitches, gave up a season-high 11 hits and struck out half a dozen. Martinez (6-3) was replaced by senior Vanessa Foreman, who needed nine pitches to get two strikeouts and a groundout for her first save of the season.

“The good thing is we scored a couple of runs to give us a little cushion,” Quarles said. “Dani hasn’t pitched in a couple of weeks, so I still wanted to see if Dani could come back and battle. She wasn’t on her best game, but she has tenacity and she fights. She’s the kind of girl who wants to get through it and finish the task.”

“I was just hoping we could get out of it,” Huskey said. “That’s why we have a pitching staff. We have two good pitchers that can get it done, not just one. So, we can rely on people to pitch and play defense and score runs.”

The Lady Gladiators, ranked third in the California Interscholastic Federation-Southern Section Division 1 poll, gave up a season-high nine runs as Warren (11-6, 2-1) also scored five runs in the top of the fifth. That tied for a season high in most runs allowed in one inning. Gahr yielded five runs in the top of the fifth in a 6-5 loss to Laguna Hills High on Mar. 12.

“I knew we had a tough game today because Warren is probably our best competition,” Huskey said. “I knew Dani was going to keep us in the game. So, I just had to have her back and score runs for the team.”

This was Gahr’s first home game in exactly two weeks but had opened league play with routs over Dominguez High (16-2) and Lynwood High (16-1) in which

it combined for 38 hits. Gahr is now 18-26-1 against the Bears since 1998, but 10-10 at home. Tapia, Huskey and Hill, the second, third and fourth hitters in the lineup, went a combined six for 11 with seven runs batted in.

some good two-out hitting,” Brooks said. “We ran the bases well. We were a lot better fundamentally.”

In the next inning, Glenn was looking to add more when senior right fielder Jose Llamas was safe on an infield single and advanced on a two-out base hit from senior third baseman Alex Alcaraz. But Llamas would be thrown out at home to end the inning, then be tossed from the game for allegedly uttering a profane word that was heard by the home plate umpire. Shortly after that, Brooks would be ejected without having a chance to argue why Llamas was

tossed from the game.

“That was embarrassing,” Brooks said. “He threw out [Llamas] before he finished his slide and he threw me out 30 seconds later for not questioning the call? When a player gets thrown out, it’s the head coach’s responsibility to go and talk to the umpire. I didn’t argue the play. It’s very disappointing.”

That would fire up the team as it added solo tallies in the fifth, sixth and seventh innings. Hale and Martinez would each go two for four with a pair of runs driven in. All nine starters in Glenn’s lineup had a hit, a run driven in or scored.

“You just have to stay poised; you can’t let that get to your head,” Angulo said. “You have to keep doing your thing.”

For Norwalk, which dropped to 8-7 overall and 2-2 in the league at the time, Urzua and Gil each had a pair of hits. This was Glenn’s 10th straight win over the Lancers but since 2005, it holds just a 15-13 advantage. Last Friday’s game also marked the final time that the city rivals will meet in a league contest as Glenn is moving to the 605 League next season. Following the game, Brooks and Norwalk head coach Bill Wenrick discussed possibly playing a single game next season to keep the rivalry going.

“It’s sad,” Brooks said. “I was head coach here. It’s sad that we had to disband, but that’s not on John Glenn. We wanted to keep the Suburban League alive. Norwalk and La Mirada and Bellflower didn’t want to allow another team in so that the Suburban League could go forward. It’s disappointing; it’s disappoint that this will be our last time playing them in a Suburban League game.”

Glenn remained the second ranked

team in the California Interscholastic Federation-Southern Section Division 4 poll and improved to 14-5 overall and 4-0 in the circuit after it doubled up Mayfair High 4-2 this past Monday in a makeup game that was rained out on Mar. 21. The Eagles welcomed last place and one-win Artesia High this past Wednesday and will visit the Pioneers today before entertaining La Mirada on Wednesday in a battle for first place of the final two remaining undefeated league teams. Norwalk travelled to Bellflower High this past Wednesday and the two teams will meet today at Norwalk before the Lancers host Artesia on Wednesday.

“We’re playing pretty good,” Angulo said. “We just have to keep the energy level up. As long as we do that, I feel pretty confident. We have a good ballclub behind us and I always feel good pitching when I have the defense like that behind me.”

**SUMMARY OF ORDINANCE NO. 578U OF THE CITY OF HAWAIIAN GARDENS, CALIFORNIA, ADOPTING AN INTERIM URGENCY ORDINANCE RELATING TO ACCESSORY DWELLING UNITS PURSUANT TO GOVERNMENT CODE SECTION 65858**

Pursuant to Government Code Section 36933 (c), the following constitutes a summary of Ordinance No. 578U (“Ordinance”), adopted as an interim urgency zoning ordinance pursuant to Government Code Section 65858 by the Hawaiian Gardens City Council on April 10, 2018, at its meeting held in the City Council Chambers, 21815 Pioneer Boulevard, Hawaiian Gardens, CA 90716.

The purpose of the Ordinance is to establish temporary development standards for new “accessory dwelling units” (“ADU” or “ADUs”) in the City of Hawaiian Gardens (“the City”). In substantial part, the Ordinance:

- Allows one ADU per lot in residential zones (R1:10,000, R1, R2, R3, or R4), provided the subject residential lot is at least 7,500 sq. ft., and provided there is a single-family home on the lot;
- Specifies both the minimum and maximum height and setback requirements for ADUs;
- Absent specified conditions, requires a minimum of one (1) off-street parking space for each bedroom in an ADU
- Requires property owners to be an owner-occupant of the ADU or single-family dwelling on the lot, and prohibits ADUs from being rented or leased for periods less than thirty (30) days;
- Prohibits ADUs from being sold separately from the primary single-family residence; and
- Adopts and imposes various building standards and requirements associated with structures meant for human habitation.

Any application for an ADU that does not comply with the Ordinance will be denied.


