

INVESTIGATION: RADICAL COMMUNISTS, LED BY EL RANCHO BOARD MEMBER JOSE LARA, RUNNING RUSSIAN INFLUENCE CAMPAIGN AT DISTRICT HIGH SCHOOLS

In the wake of the El Rancho Unified School District scandal, when ERUSD teacher Greg Salcido called all military personnel “dumbshits and lowest of the low,” a radical communist organization called Union del Barrio (UdB), with major assistance from ERUSD Board Member Jose Lara, is using Russia-type social media and intimidation tactics in an attempt to take over the beleaguered school district.

The actions of Lara and UdB - who helped elect Lara to his board seat - are contributing to an atmosphere of fear and hatred inside the district.

Lara wants to be the leader of UdB, even naming his Twitter account

@JoseDelBarrio.

Sources are telling HMG-CN that Board Vice President Orozco is also actively helping Lara and UdB.

Lara and the organization are recruiting radical left-wing teachers, indoctrinating high school teenagers, slamming other board members, and menacing moderate teachers and parents, all in an effort to inject the anti-establishment sentiment on campus of advocating violence and espousing hatred for the police and the military.

The UdB wants to take back Southwestern United States because it “belongs to Mexico,” and they are focusing, with the help of Lara, on ERUSD high school teenagers.

One of Lara’s main weapons is ex-

tremist Ron Gochez, who heads the Los Angeles chapter of UdB. Lara and Gochez taught together at Santee High School in Los Angeles.

In the same vein as Greg Salcido, Gochez regularly refers to police officers as pigs and the military as a terrorist organization; social media posts can be found of Gochez advocating violence.

Gochez calls Fidel Castro, Hugo Chavez and Ho Chi Minh his heroes, and openly advocates for the overthrow of the American government.

His hypocrisy is stunning, teaching UdB-influenced, anti-American Ethnic Studies in his classroom, while cashing in on a government paid \$103,000 annual salary.

His walls are draped with flags from

Cuba and the Soviet Union, along with tributes to Che Guevara and Malcolm X.

While at Santee, Lara and Gochez banned together to form the “Communist Center” next to Santee campus to recruit and indoctrinate teenagers, it was the start of their movement.

The volatile Gochez was eventually moved from Santee to Maya Angelou Community High in South Central Los Angeles.

And now Lara and Gochez are running the same playbook at ERUSD, using Gochez and his intimidation tactics to advance the radical views of UdB in an attempt to indoctrinate students and take over ERUSD high school campuses.

CRISTINA GARCIA 'WALKS,' DOES NOT VOTE TO CLASSIFY SEX CRIMES AS VIOLENT FELONIES

She also did not vote for a lifetime ban on people convicted of domestic violence from owning guns.

When it comes to classifying sex crimes and sex trafficking of children as serious felonies, along with taking away gun ownership from people convicted of domestic violence, most California legislators would not hesitate to press the Yes button on the Assembly floor.

That is except for 58th District Assemblywoman Cristina Garcia one of the “leaders” of the #MeToo movement and a politician the Local Hubert Humphrey Democratic Club endorsed.

In the footsteps of Republican Dana Rohrabacher, who told a group of Realtors early this month that homeowners should be able to refuse to sell their property to gays and lesbians, just yesterday Garcia shockingly recorded no votes on two bills, AB 2823 and AB 3129, affecting sex trafficking and gun ownership.

With her primary on Tuesday and the recent finding that she violated the Assembly’s sexual harassment policy, the timing of the votes could not have been worse and will outrage, among others, child protection, domestic violence, and law enforcement groups up and down the state.

Current California law classifies certain felonies as violent felonies and imposes an additional one-year term for a felony and a 3-year term for a violent felony.

AB 2823 amends existing law and enhances prison sentences placing human sex trafficking of both children and adults, in the violent felony category.

The bill also expands the scope of sodomy, oral copulation, sexual penetration, and rape offenses that are categorized as violent felonies.

Those offenses include if the victim was unconscious, if the victim was incapable of giving consent due to intoxication, and if the victim was incapable of giving legal consent because of a mental disorder.

The offenses also include if the act was accomplished against the victim’s

Lakewood is now the first city in California to have completed a major stormwater capture project funded by the California Department of Transportation.

At a June 2nd ribbon-cutting, Lakewood community leaders and project participants surveyed the now-operational technical parts of the project, including its

pump house and inflatable dam in the Los Cerritos Channel.

The dam captures dry-season and moderate wet-season flows in the channel and allows the water to be pumped to the new reservoir underneath Bolivar Park. The

Interview: Bob Archuleta-From Humble Beginnings to Obama Presidential Appointee

Even though Pico Rivera Councilman Bob Archuleta comes across as the classic political figure with a flair for public

speaking and a stellar political reputation having worked with two presidents — George W. Bush and Barack Obama — he comes from very humble beginnings.

He grew up in the area once known as South Central L.A. and as a young boy lived in Lincoln

Heights near Chinatown selling flowers on the corner to help his family make ends meet. Archuleta's family life was not one of fairy tales but of hardship. Abandoned by his biological mother, he was raised by his grandmother, who showed him love and gave him a strong foundation in the church.

"She was very poor, but the love I received from her, I have carried in my heart throughout my life and feel to this day," he said. After the death of his grandmother when he was 10, Archuleta was returned to his mother who he did not know, and ran away several times while in her custody.

"I didn't accept the fact that my biological mother was my real mother, and so I ran away again and again," he said.

But, Archuleta realized over time to

accept the situation he was in and make the best of it. She also had her struggles, and Archuleta had to do what he could to help out financially, so he found odd jobs as a young boy.

He started mowing lawns, washing cars and eventually selling flowers meeting people along the way. He vividly remembers one person encouraging him to stay in school, be humble, and always thank the good Lord for whatever you receive.

Archuleta's life took a turn for the better when he was recruited to play football and was offered a scholarship to attend Salesian High School in East Los Angeles. Still it wasn't easy.

He held various jobs at the school such as cleaning and mopping floors because the scholarship was only good during football season, and he needed to pay the remainder of the tuition. During his senior year, Archuleta worked the swing shift at a gas station a couple of miles away from the school. "It was tough working after school and keeping up my grades while contributing to my family," Archuleta said.

After graduation, at the time of the Vietnam War when the majority of young men were trying to get out of serving, Archuleta enlisted in the Army and volunteered to be a paratrooper in the 82nd Airborne.

He was following in the footsteps of his uncles who had served in the Army and Navy, and served three years on active duty and almost two years in the reserves.

After his service to the country, he attended the Rio Hondo Police Academy and worked for the Montebello Police

Department. After moving to Pico Rivera, he was asked by Rep. Grace Napolitano to run for the city council and was elected in 2007.

During his time, including serving as mayor, Archuleta worked on creating a multi-million dollar reserve for his city, lowering crime and graffiti, as well as renovating city parks and securing funds for two railroad underpasses.

This helped to create new jobs and secured a future for hard working families across the region.

Archuleta had the honor to serve and represent nearly one million veterans throughout L.A. County as a Los Angeles County Commissioner of Veterans Affairs. Under George W. Bush, he served within the Veterans Administration handling Minority Veteran Affairs and within the small business administration.

As a presidential appointee to the Obama Administration, he served as the vice chairman of the board that oversees the United States Military Academy at West Point.

The appointment was rigorous and called for complete vetting by the FBI, CIA, the State Department and the White House.

Archuleta was the first Latino ever appointed to serve as a member of the Board.

"Who would have thought that a boy from one of the toughest parts of Los Angeles would grow up to serve his country, work for two presidents and be elected and re-elected to serve his community," Archuleta said.

"Thank God for my wife, Rose, and my five children. They are also my dream come true."

The report describes the City's stringent water tests, which are conducted more frequently than required by the State Health Department. The Consumer Confidence Report provides detailed test results and explains the City's water supply, which flows to customers through a system of wells, reservoirs, mains and pipes.

water there is cleaned and then used for irrigation. Some water is even infiltrated into the ground beneath the park where it ultimately will replenish groundwater aquifers deep below. In heavy rains, the dam deflates to allow stormwater to flow quickly and unhindered.

The \$11 million in funding Lakewood received from Caltrans paid for the project, including two new picnic shelters, turf and an irrigation system for Bolivar Park. The picnic shelters are expected to open in a few weeks after the new turf grows enough to withstand play and foot traffic.

RESIDENTS URGED TO TAKE PRECAUTIONS: WEST NILE VIRUS

West Nile virus is a mosquito-transmitted disease that can cause debilitating illness and death to humans as well as birds, horses and other wildlife.

Twenty percent of infected people will exhibit flu-like symptoms, and one in 150 people infected will require hospitalization. There is currently no cure or vaccine for the virus.

The Greater Los Angeles Vector Control District (GLACVCD), a local government and public health agency dedicated to reducing populations of public health vectors and preventing human infection associated with mosquito-transmitted diseases, has issued the following tips to stay safe.

- Eliminate standing water around the home. It takes as little as five days for mosquito eggs to hatch into biting adults.
- Many children play sports or are outdoors from late afternoon to the evening hours, when mosquitoes are most active. Anyone outside during these hours should wear long-sleeved shirts and pants and use insect repellent containing DEET, Picaridin and oil of lemon eucalyptus.
- To help West Nile Virus surveillance and control efforts, report dead birds at westnile.ca.gov.

NEW CAMPUS IS A TARGET

The ERUSD is very proud of its newest campus, the Ellen Ochoa Prep Academy. But the efforts of parent and teachers to establish the school as an International Baccalaureate campus have been stymied by Lara and UdB's radical views.

And according to high-level ERUSD sources, the principal of Ellen Ochoa, Elias Vargas, is collaborating with Lara to advance their agenda.

But the Board learned of the alleged collaboration and voted to move Vargas to another campus.

That is when the social media machine began their Russia-type anti-American campaign churning out slanderous posts in an effort to discredit certain ERUSD Board members, labelling them as "imperialistic Americans advancing the white agenda."

It was right out of the Russian social playbook; fabricate stories about people, push the lies out on Facebook, Twitter, and Instagram and let the internet "trolls" comment with more lies and hatred.

ERUSD ETHNIC STUDIES

Three years ago, the ERUSD, led by current President Dr. Aurora Villon, established the first high school Ethnic Studies program in the United States. It was groundbreaking and was chronicled across the nation.

Lara and UdB saw the graduation requirement as an opportunity to advance their communist agenda immediately labelling the program "not radical enough."

Attendees of the meeting told HMG-CN that Lara clapped after the vitriolic speech.

"They hate this country," said one ERUSD parent, "they have a right to their opinion, but they can't hate the country. What is hurtful is they are indoctrinating students, it's getting bad."

Now the group is getting more brazen on ERUSD campuses taking advantage of vulnerable teenagers believing Lara and the UdB's message.

The more brash students are posting communist flags and communist leaders' images on campus walls. Just yesterday a Russian flag was draped over a building at El Rancho High School.

Lara and the UdB have pledged "to come out in force" at the ERUSD's next board meeting on June 19, and given what was said at public comment, many of the parents are fearful.

"Lara is a bully," said another parent who did not want to be identified, "he wants to make a name for himself. These people hate America, the military, and the police and Lara is leading them, it has to be stopped."

TWO BIG HITS SPELL DOOM FOR GAHR AGAINST ONE OF NATION’S BEST IN TITLE GAME

IRVINE-Having been denied a chance to play for a California Interscholastic Federation-Southern Section divisional softball championship the past three seasons because of playoff misfortunes, Gahr High finally made it to the big stage last Saturday night. Playing top-ranked Norco High in the Division 1 finals, the Lady Gladiators knew they would have to play their best ball of the season.

Two groundball outs within the first seven pitches thrown by senior Vanessa Foreman was the start Gahr needed. But after that, it went downhill and the Cougars, highly ranked in the state according to MaxPreps and one of the nation’s toughest teams, exploded for three runs in the top of the first and five more the next inning to knock off the San Gabriel Valley League co-champions 8-2 in front of a packed house at Deanna Manning Stadium at Colonel Bill Barber Park.

Gahr had previously defeated Norco in 2015, a 4-3 conquest at the Tournament of Champions in Bullhead City, AZ, and 6-4 on Apr. 6 of this season in the Michelle Carew Classic. But two hits would tell the story of this game.

After those two outs in the opening frame, Foreman walked Mikayla Allee, gave up a single to Kinzie Hanson and walked Paige Smith before serving up a first-pitch, bases-clearing double to Sierra Marshall for the first big hit.

“Sometimes the tide just goes the other way,” said Gahr head coach Shawn Quarles. “I really haven’t processed it all. I know she hit [Allee] and sometimes that’s

just what triggers it. They’re a tough-hitting team and sometimes if they get the momentum, stuff like that happens.”

In the next inning, Blanca Gonzalez reached on an infield single and scored on a one-out base hit from Toni Camarillo. That would be followed by an infield knock from Allee and a fielder’s choice from Hanson before Smith cracked a fly ball on a full count that deflected off the glove of junior left fielder Jazmine Hill’s glove and over the fence for a grand slam.

“Different day and on any given day, these teams can beat each other,” Quarles said. “This is the third time we’ve played Norco and we beat them twice. But that’s the problem. With a program like that, you’re going to exchange with them.”

After that, Norco would collect just a Hanson single in the fifth inning off senior Danielle Martinez, who had replaced Foreman following Allee’s single. Martinez retired 13 of the 14 batters she faced. But the damage was done as the Lady Gladiators had given up the second most runs this season and had their biggest deficit of the season.

Meanwhile, the Gahr hitters were stymied by the pitching of Sarah Willis and the Cougar defense. Willis gave up just three hits and struck out six. In the bottom of the first inning and with two outs, a high chopper from senior center fielder Madison Huskey was snagged by first baseman Katelyn Olson to end the inning. When Gahr came up again, Willis walked Hill but two pitches later, freshman third baseman Taylor Stephens line out to Willis, who then threw to Olson to complete the double play. After Willis hit senior first

baseman Jade Wittman, sophomore designated player Johanna Rodriguez grounded out to Willis.

In fact, Willis would have a hand in 12 of the 21 outs as she assisted on two more groundouts and snared a line drive hit by Wittman in the sixth inning with Stephens on first and two outs. But the Lady Gladiators would finally get to Willis in the fourth.

With one out, Hill singled to left and came home when Stephens doubled to the centerfield wall. She advanced on the throw home and scored the last run of the game on a wild pitch. The only other hit

Gahr got came when freshman catcher Grace Rivera led off the third with a single to the right field gap.

“We definitely didn’t want to go out of here with a shutout,” Quarles said. “We did everything we could to get some runs.”

The fact that Gahr was down 8-0, let alone 3-0 after the first inning was somewhat of uncharted territory for the Lady Gladiators this season. Only three other times did they trail by at least two runs in the early innings. In the fourth game of the season, Gahr trailed Santa Fe High 2-0 af-

GAHR FINALLY KNOCKS ON DIVISIONAL FINALS DOOR, BUT SCHOOL’S FIRST CHAMPIONSHIP COULD COME SOON

The Gahr High softball team had been building and building over the past several seasons to get up to Division 1 status of the California Interscholastic Federation-Southern Section. A hit here or there or an error here or there prevented the school from more trips to the divisional championship game.

But this past season, the Lady Gladiators finally made it to the big show in its first season in Division 1. Gahr began the postseason as the sixth ranked team, received a first-round bye and knocked off Oaks Christian High 4-3, third-ranked Mater Dei High 4-3 in eight innings and seventh-ranked Chino Hills High 1-0 in eight innings before drawing top-ranked Norco High, which also happened to be one of the nation’s best teams.

Head coach Shawn Quarles and his team felt confident in beating Norco for the second time this season. But three runs in the bottom of the first inning and five more the next inning were too much for the Lady Gladiators to overcome in an 8-2 loss. Still this was the season that Quarles was looking for-a chance to play for the school’s first softball championship.

“It feels good,” Quarles said. “It was good for the girls to get the experience. It was good for them to be able to enjoy this. We wished we would have come out on top. But, you can’t always have it. I’m glad the way they lost, in a classy fashion. But we wanted to be on top.”

It’s not like Gahr suddenly became a force to be reckoned with. In six seasons at the helm, Quarles has gone 126-46-2

with five straight San Gabriel Valley League titles. When stepped foot on the Gahr campus, the program was in Division 3. Last season, it moved up to Division 2. His predecessor, Mike Rogers, went 74-87 in six seasons with back to back league crowns and consecutive visits to the quarterfinals. Four different head coaches from 1998-2006 combined to go 148-93-2 with three SGVL league titles, but no trips to the quarterfinals.

Gahr has had one of the strongest softball programs around with eight 20-win seasons since 1998 and one season of 19 victories. But the question will always remain, why did it take this long to play for the big prize? It’s not due to a lack of talent.

Gahr’s pitching staff this past season, led by seniors Vanessa Foreman and Danielle Martinez, plus two others, had an earned run average of 1.39 and the four hurlers combined for 216 strikeouts. The team’s batting wasn’t as good as last season’s, but still effective. Gahr batted .334 and had four players with at least 30 hits.

Last season, the Lady Gladiators batted .424 as a team, had five players hit over .400 and 11 players hit at least one of the team’s 57 home runs. The pitching staff combined to have an earned average of 1.51 and strike out 189 batters. But after 26 straight wins, which currently ranks tied for eighth place in CIF-Southern Section history, Gahr was upended by St. Lucy’s High in the second round of the playoffs. Had the Lady Gladiators gone wire to wire, they would have been holding the second-most consecutive wins for a season, a mark that is currently held by Simi Valley High and only two

wins behind Ocean View High. Gahr has had more than enough talent to win several CIF championships. All you have to do is look at the astonishing numbers by previous members of the Gahr family. Since 2006, 13 players have batted at least .414, led by current University of South Carolina standout Alyssa Kumiyama, who hit .564 in 2017. Not far behind is senior Madison Huskey (.558 in 2017) and Malia Quarles, who is currently at UCLA and batted .545 last season.

But the off the chart numbers are not limited to the players under the current coaching staff. When Rogers oversaw the program, he had players like Roni Alvarado, Brianna Besenty, Eileen Flores, Celeste Gonzalez, Amanda Marquez, Lindsey Marquez, Nani Mejia, Brittney Miller, Alyssa Morales, Deja Portillo and Jasmine Ruiz, among others, doing their thing with the bat. Alvarado was also the main force in the circle from 2005-2008 before the likes of Brittany Nava (2006-2008) and six other pitchers kept the Lady Gladiators in contention of a deep postseason run. Shawn Quarles then took over and had stellar pitching from Naomi Dickerson, Deidra Genera, Hannah Kumiyama, Destiny Vasquez, Foreman and Martinez.

With players like the aforementioned from the past dozen seasons, Gahr should have had some bling on their fingers. But as Shawn Quarles pointed out the past few seasons, you need to be fortunate in the playoffs and have the ball bounce your way.

Gahr didn’t have one of its better offensive teams in 2018; it’s .334 team average was the lowest since 2012 when

that team batted .292. But this past season’s pitching was one of the best in school history with the rotation of Foreman and Martinez, who were considered two number one pitchers instead of 1 and 1A. The 1.39 combined ERA was the lowest since 2007 (0.94) and the 216 strikeouts were the most since 2007 when that team combined for 221.

This area has seen two other teams advance to the CIF finals. Cerritos High won Division 2 titles in 1999 and 2000 but has not been back to the semifinals since then. Valley Christian High played for a Division 5 championship in 2006 but has made only two quarterfinal visits since then and has not won 20 games since winning 21 in 2006.

It’s not easy going all the way to the divisional finals, let alone win one. But if Gahr keeps on getting the talent like it has been getting for the past 12 seasons, it’s only a matter of time before the school is hoisting a championship plaque and getting championship patches instead of taking home a runner-up plaque.

ter the second inning and lost 2-1. Against Norco, a 3-0 deficit after four innings turned into a 6-4 win and in the second round of the playoffs, Gahr trailed Oaks Christian High 2-0 after four and a half innings and rallied for a 4-3 victory.

“We just wanted to fight back,” Quarles said. “These girls have a lot of fight in them and they’ve never given up all year. So, we told them it’s just a matter of how you end the season. I knew they weren’t going to give up. They kept fighting until the end and I’m glad we ended the season in good spirits.”

This was the second time a Gahr softball team had advanced to a divisional championship game. In 1989, the Lady Gladiators fell to St. Joseph High and Lisa Fernandez 1-0 in the 5-A title game. Overall, the Gahr softball program has made seven trips to the quarterfinals and three semifinal appearances. In 2015, an unearned run by Grand Terrace High in the top of the seventh proved to be the deciding factor in a 4-3 contest in the semifinals. The next season, against Redondo Union High in the quarterfinals, Gahr was three outs away from moving on. But a four-run, top of the seventh inning turned into a 5-4 loss for the Lady Gladiators.

And finally, Gahr was primed to go wire to wire and potentially finish the season undefeated. But four runs in the bottom of the first and second innings by St. Lucy’s High in the second round spoiled that attempt in a 10-4 loss.

“This is a team of fighters and it’s just a great group,” Quarles said. “A lot of these girls I’ve had since they’re freshmen year. So, it’s touching. It’s sad to see a lot of them leave. It is what it is.”

will by threatening to use the authority of a public official.

And Cristina Garcia walked away and abstained from voting to place child sex trafficking and other heinous violations in the violent felony category.

Beat Somebody Up, Own a Gun

Currently, anyone convicted of a felony is prohibited from owning a gun and anyone convicted of certain misdemeanors is prohibited from owning a gun for ten years.

AB 3129 amends current law to prohibit a person convicted of domestic violence, who could own a gun after ten years, from ever owning a gun.

The text reads, “[AB 3129 would] prohibit a person who is convicted on or after January 1, 2019, of specified misdemeanors relating to domestic violence that currently result in a 10-year prohibition against possessing a firearm, from ever possessing a firearm.”

Once again, Cristina Garcia “recorded a no vote,” abstaining and allowing people convicted of domestic violence to own a gun.

Mike Simpfenderfer, who will run against Garcia in Nnovemebr told HMG-CN, "As a father of a daughter sexually assaulted when she was 13 years old and a brother of a sister drugged and raped by two classmates, Cristina Garcia's failure to stand up to sex traffickers, predators, perverts, and persons who threaten/beat others defined why it is time for a change in the 58th June 5th. Her failure to vote and protect us continues the red carpet treatment criminals receive."

Erin Lehane, spokesperson for Working Californians Against Corruption, told HMG-CN, “Because of her violation of

the Assembly’s sexual harassment policy, resulting in the Speaker stripping her of all committees, the only power Garcia now has is to push a button voting yes and no, and she can’t even be bothered to do that when actual lives are at stake in key legislation. The district deserves, in the least, representation that prioritizes

the safety of its most vulnerable residents.”

Teala Schaff, Garcia’s communications director, minced words while telling HMG-CN, “There are three options listed: Ayes, Noes and No Vote Recorded. She did not vote on those bills, i.e No Vote Recorded.”

DEADLY CITRUS TREE DISEASE FOUND IN NORWALK

An incurable plant disease called Huanglongbing (HLB) that infects and kills all types of citrus trees has been detected in a residential citrus tree in Norwalk. This is the first tree in the city confirmed to have HLB.

HLB has no cure and is spread by a small pest called the Asian citrus psyllid as it feeds on leaves and stems of citrus trees. Once a tree is infected, it will die and must be removed. The best way to protect citrus trees from the disease is to prevent the spread of the psyllid.

California homeowners – 60 percent of whom own citrus trees – play an important role in protecting citrus in our state and are being asked to protect their backyard trees by searching for signs of the pest and disease.

To prevent the spread of the Asian citrus psyllid and protect citrus trees from Huanglongbing, citrus tree owners in Norwalk should follow these tips:

- Inspect trees for the Asian citrus psyllid and Huanglongbing (HLB) monthly, and whenever watering, spraying, pruning or tending trees. If you spot the pest or disease, call: 800-491-1899. Psyllids are most noticeable when new leaves are growing on the tips of the branches.
- The Asian citrus psyllid is similar in size to an aphid. Adults brown, about 1/8th of an inch long, and feed with their bodies at a 45-degree angle.
- Young Asian citrus psyllids are yellowish orange and produce a white, waxy substance that can be seen on leaves.
- Adults, juveniles and eggs are typically found on tender, new leaves.
- Symptoms of HLB include blotchy, yellowing of leaves, yellow shoots, lopsided, small and bitter fruit, and premature and excessive fruit drop.

- As part of your tree care, visit your local nursery or garden center to get advice on products that can help protect your citrus tree.
- Do not move citrus plants, foliage or fruit into or out of your area, and especially across state or international borders. This could unknowingly contribute to the spread of the pest and disease.
- When grafting citrus trees, only use registered budwood that comes with source documentation, such as the budwood offered through the Citrus Clonal Protection Program.
- Be sure to dry out citrus tree clippings or double bag them before removing the plant material from the property.
- Control for ants on your citrus tree. Ants protect harmful pests like the Asian citrus psyllid. Place ant bait around citrus trees and follow the product’s label instructions.
