THE CRUMBLING OF ABCUSD SCHOOLS

Measure BB is a \$248 million general obligation bond measure that will provide ABCUSD students with improved and upgraded school facilities that are safe, secure and modern. ABC residents will vote on the bond in the upcoming election on November 6.

ABC is only one of nine school districts that has not passed a bond since the 1990's, and it shows.

Last week we toured the first three

schools, Artesia High, and Ross Middle & Hawaiian Elementary Schools. This week we toured Whitney and Cerritos High, and Cerritos Elementary.

Once again what we found was shocking and goes beyond any regular maintenance budget; substandard equipment in classrooms and infrastructure problems, even at the best high school in California, Whitney High.

Whitney High School

According to US News Report 2016, Whitney High School is ranked number one in the state of California, and ranked 19th nationally. HMG-LCCN was met by Whitney High School John Briquetet and Dean of Students Craig Spratt to discuss how Bond Measure BB can improve the facilities.

One of the areas that bond measure funds will be used for is to improve science class rooms.

"Our classrooms are in rough shape," says Briquetet, "they lack space; they lack equipment and sufficient technology. We are one of the best schools in the nation, but in order to continue to educate our students, we need to move into the 21st century."

Briquetet says that the school and the district have been able to offset some of this, but if the district cannot improve certain areas, they will begin to fall behind.

"I think the biggest impact is the science rooms. We are the number one school in the state, and we have done this with a severe lack of equipment," added Spratt, "think of what we could accomplish if we could offer our students upgraded and modern

Cerritos High School

By all measures, "the biggest need will be a new science wing. STEM careers are the acronym of the day and we are seriously under serving our students," said Cerritos High School Principal Patrick Walker, "There are many areas that we can address however; I feel this is our priority."

The initial design is completely outdated, not seeing any upgrades since the 1970's. Touring one of the most prominent classes in the District, the pharmacy technology, was the first stop on the tour.

Joel Duer, Pharmacy Technician Instructor stopped class to discuss the needs of this classroom,

"Every pharmacy classroom needs a sink, so that we can practice compounding, we don't have one. Most pharmaceutical classrooms have laminar airflow hood where you actually practice making IV's, we don't. And in training to be a technician you need to know the importance of an eye-wash station, we don't have one of those either."

Even though the class turns out certified college ready techni-

Cerritos Elementary

Constructed in 1969, Cerritos Elementary School was next on our list hosted by Principal Kevin Amburgey.

The tour was almost cancelled, due to a lack of staffing. At the last minute Amburgey was called to be a substitute for a sixth grade class. However, this turned into an opportunity to speak with students and get their input into the condition of their school.

As in most situations of the schools we have toured, a student had come into the main office announcing that the WiFi was down, reemphasizing the need for expanded and improved infrastructure to hold a higher demand of band width.

When the school was conceptualized, it was built in an 'open space' concept. The entire "400" building of the school, that holds eight classrooms, did not have a single wall built on the inside. The inside walls were not included, with the idea of classroom sharing, "The idea behind this open concept," says Amburgey, "was that you could share with other students, and

The Artesia Branch recently moved into Cerritos, with a ribbon cutting and grand opening held Wednesday, October 31, 2018 in a grand collaboration of both Cerritos Regional Chamber of Commerce and Artesia Chamber of Commerce.

TRICK-OR-TREATING FOR THE PEDIATRIC WARD AT FOUNTAIN VALLEY REGIONAL HOSPITAL

Dressing up and going trick-or-treating is the next best holiday for children other than Christmas morning, but if a child is in the hospital, it can be a very sad day. That is why Fountain Valley Regional Pediatric Department does Halloween in a big way.

Children and families were allowed to dress in costume and walk the hallways of the hospital that were lined with all types of characters passing out treats, toys, pencils, gift cards and even bits of 'healthy' candy. This year the theme for Halloween was 'Toy Story', with over 300 nursing staff dressing up in every character from the best animated film in history. Hallways and hospital rooms were filled with Woody the Cowboy, Jessie the Cowgirl, Buzz Lightyear, Mr. Potato Head, Squeeze Toy Aliens and even Rex the dinosaur [actually three] making an appearance.

Azita Pournathmeh, Director of Maternal Child Services was pretty in pink, dressed as tour guide Barbie, she told HMG-LCCN, "This is my second year at Fountain Valley and I am here as an ambassador of good health and well being, bringing gifts, trick-or-treating and just making sure our patients enjoy themselves. This is such a fun event for the children and their families."

"The parade has evolved enormously," said Adrian Feilden, Child Health Specialist for Tenant Health Fountain Valley, "it started in 2007 with an idea to normalize holidays for children that would not otherwise be able to celebrate because of health issues and here we are

12 years later. This year almost the entire hospital participated. It was tremendous!" After the parade the children had face painting, pumpkin decorating and fun activities.

Feilden went on to say that there are guidelines, because of some children's diagnosis, they cannot have sugar or certain food items, so treats needed to be chosen carefully. Many departments decided to dress in a theme of their own such as Where's Waldo, characters from The Wizard of Oz, Gnomes and even a coven of witches cackled as they handed out treats.

"When children learn they have to be in the hospital at Halloween, they feel very disappointed," added Feilden, "but when they learn they can still have fun, it really brightens their mood. Kids can bring their own costume or choose from one that has been donated." Joni's Angels, a non-profit organization, collects and distributes costumes to the kids if needed and they help prepare and lead the Halloween Parade.

Judit Ramirez is a former patient of the hospital, "I was a long-term patient because I had a tumor on my pancreas, but with the help of the nurses and Joni's

Angels, I was able to feel more at home and celebrate the holidays." Ramirez made a complete recovery and now at 19 years of age is back as a volunteer for the Pediatric Ward.

Fountain Valley Regional hospital and Tenent Health also held a Halloween Alumni event for those children and families from the neonatal intensive care unit (NICU), there was cookies decorating, popcorn balls, coloring activities, photos with Charlie Brown and the Great Pumpkin and train rides. Over 400 people attended the first alumni reunion.

Statement from Madeline Shapiro, President of the Rio Hondo College Board of Trustees

November 1, 2018

Rio Hondo College can take justified pride in our continuing trend of upward performance for student success, a growing slate of support programs for our students and a legacy of long-term financial health that is second to none in the California Community Colleges system.

These trends are the result of years of collaborative planning and implementation on the part of our community of dedicated administrators, talented educators and committed staff members, who place the needs of our students at the forefront of all we do.

Lately, as sometimes happens during political seasons, information has spread that can create confusion or uncertainty about our institutions and their performance. But, for Rio Hondo College, our numbers tell a clear story of successful outcomes.

Here are just a few of the highlights:

- **Student completion rates:** Completion rates in 2016-17 reached 73.4 percent for college-ready students who earned at least 30 units and 60.4 percent for college-ready students who completed a degree, certificate or transfer-related outcome. This information comes from the California Community Colleges system's 2018 Student Success Scorecard. We are confident our numbers for 2017-18 are even stronger.

- **Student persistence rates:** Persistence rates reached 78 percent for college-ready students who are enrolled for their first three consecutive terms, according to the Student Success Scorecard. Persistence rates for students deemed unprepared for college are nearly as high, at 77.8 percent – a testament to Rio Hondo College's depth of student support services.

- **Degree and certificate awards:** From 2013-14 to 2017-18, degrees and certificates awarded to college-ready students rose by 234 percent, from 1,263 to 4,224, according to the California Community Colleges Chancellor's Office Data Mart.

- **College-ready student outcomes:** Degrees awarded to college-ready students rose 84 percent during the same time period, from 982 to 1,824; certificates awarded to college-ready students climbed by 785 percent, from 271 to 2,400, according to Data Mart numbers.

- **Fiscal prudence:** Now in the first year of a new state funding formula, Rio Hondo College will receive additional state revenue over and above a cost-of-living adjustment, which is more than what the College received under the previous funding formula. To illustrate the College's fiscal prudence, the Board of Trustees' Oct. 10, 2018 agenda lists \$2.7 million in General Fund expenditures for supplies and operations, excluding salaries and benefits.

- **Lifetime medical benefits:** As of June 30, 2018, Rio Hondo College has met all unfunded liabilities for providing lifetime medical benefits to retirees and to an allowed dependent. At present, the College has \$50 million in an irrevocable trust for the lifetime benefits. This further illustrates the District's outstanding fiscal management in being able to provide for current and future retirees.

- **Chancellor's Office recognizes career programs:** Rio Hondo College, among other accolades, has received a Gold Star, Silver Star and seven Bronze Stars from the California Community Colleges Chancellor's Office for programs that advance social mobility for students. The Strong Workforce Stars honors gave special recognition to the College's extraordinary nursing and automobile technology programs.

These performance factors would be a cause to celebrate at any time. But they are especially significant in these days, when about half our students struggle with food insecurity, when housing continues to challenge many families and when so many of our students need an extra hand to meet the rigors of our higher education standards.

Rio Hondo College has stepped up to help its students on every front. We offer a host of services for students, including a campus-based food pantry. We also offer academic support that ranges from our Summer Bridge program, which helps students boost their performance, to our First Year Success Center, which guides students through their first year of instruction and ensures they remain focused on their degree goals.

One of our most recent initiatives expanded our Rio Promise tuition program to offer free tuition to new full-time college students for their first two years. This is a remarkable example of how a community college can break down barriers and help community members achieve their dreams.

I am also proud to say that we remain steadfast in continuing our efforts to refine how Rio Hondo College serves its students. Every day, the community of individuals who run this institution explore innovative ways to expand our instruction, adding new career programs and degree and certificate pathways.

As our student needs change, so too will Rio Hondo College grow and change with them, so that they can achieve their dreams, which in turn will strengthen our community, region and state.

EXTREME ACCOUNTABILITY FOR MEASURE BB THE CITIZENS OVERSIGHT COMMITTEE

Measure BB comes with strict fiscal accountability. If approved by voters on November 6, 2018, the District is required to form the Citizens Oversight Committee to ensure that all bond funds are expended in accordance with the legal requirements set by Education Code and the California Constitution.

Committee Appointment and Membership

The Committee shall consist of at least seven (7) members (and may be larger) to serve for a term of two (2) years, without compensation, and for no more than three (3) consecutive terms. The Committee shall not include any employer or official of the school district or any vendor, contractor, or consultant of the school district. The Committee must include all of the following:

- (a) One member who is active in a business organization representing the business community located within the school district;
- (b) One member active in a senior citizens' organization;
- (c) One member active in a bona fide taxpayer association;
- (d) One member shall be the parent or guardian of a child enrolled in the district.
- (e) One member shall be both a parent or guardian of a child enrolled in the district and active in a parent-teacher organization, such as the Parent Teach-

er Association or school site council

Purpose of the Committee

As stated in State law, the principal purpose of the Committee shall be to inform the public at least annually in a written report concerning the expenditure of the bond proceeds. In carrying out this purpose the Committee shall:

- (a) Actively review and report on the proper expenditure of taxpayers' money for school construction;
- (b) Advise the public as to whether the school district is in compliance with

the requirements of Article XIII, Section 1(b)(3) of the California Constitution, which provides that:

- (i) Bond funds are expended only for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the

- (iii) A list of projects to be funded was included on the ballot;
- (iv) An annual independent performance audit is performed; and
- (v) An annual independent financial audit is performed.

Annual Financial and Performance Audits

As required by State Law, there will be two separate audits by an independent auditor annually:

1. Financial Audit - This audit must be of the proceeds from the sale of the bonds until all of those proceeds have been expended for the school facilities projects.

2. Performance Audit - This audit is performed to ensure that the bond funds have been expended only on the specific projects listed in the bond measure.

Both audits must be prepared by an independent auditor (or auditing firm), which should have adequate qualifications to complete this task and render a reliable report.

In addition, the audits should be addressed to both the school district and the Committee when completed and should be provided to the Committee promptly after completion so that the Committee can evaluate the audit report and make a determination as to the compliance of the District with the applicable Constitutional, the bond measure and any applicable Committee and school district Policy requirements.

equipment. They could change quite literally change our world.”

The school has improved the technology, but what is greatly lacking throughout the district is the infrastructure to support it. “We are fortunate to have the equipment,” said Spratt, “however when you have 1,000 students on a Wifi network all at once, everything slows down.”

By the end of next year Whitney will have 1,400 students and computers on campus. When that many computers work simultaneously, the band width slows. Another area that greatly needs attention is the multi-purpose and media room. The schools security measures need to be addressed, a back chain fence goes right up against Cerritos Park East with no constant monitoring.

“We are also looking at classroom finishes, many of the walls are nothing more than cardboard,” said Briquet, “we have restructured our Guidance Team and need to add additional confidential office space. However the walls are so thin, that private conversations are a great concern. You can literally hear what is going on through closed doors.”

Many of the classrooms are severely cramped, with aisle space that is no more than three feet, causing students and staff to walk sideways.

⌘ Touring one of the science

classrooms was an eye opener; the sink was a large water container with a spigot over a trashcan, the room had very little storage space and although the rooms are equipped for 32 students, the classes continually has 35 students. Three students have to sit at the end of a row with desk space. “We are really lucky to have innovative students, they seem to work around it, but still we really need more space,” says Michael Mustillo, Chemistry Teacher and Technology coordinator.

“There are no gas outlets. We are teaching college level chemistry without any materials. Part of being creative is figuring out how we can get the labs done. It would be nice to have the proper materials to show students as they do in college. A lot of kids want to get internships and we want to give them the skill sets to do so. But our set up makes it difficult.”

Some of the lab rooms have sinks, but no gas, no chemical ventilation and the projector is still rolled around the classroom on a cart. One department chair has no storage space, so all of the novels for all of the students for the entire year are stored in temporary carts inside the classroom.

Bathrooms have dated sinks, towel dispensers and badly stained tiles.

Lockers are in need of repair and need new locks, and the campus is in need of a permanent shade structure.

“I have been at Whitney for three years and it is a fun place

to be,” says Briquet, “One of the great concerns I have though, is if we cannot make the changes Whitney may no longer be considered the place to go.

cians, students very rarely have the opportunity to practice on everyday equipment that is found in a pharmacy.

Leonardo Perez, parent and member of the Committee for Schools of Choice, has been in the medical field for over 20 years, “I have seen the transition from paper based charts to electronic medical records playing a major role in our health care. We have a top notch school district with highly rated programs but if we don’t have the infrastructure to keep up with what we are teaching than we can’t maximum the effect on these students and prepare them for real world experience. Because we do have an excellent school district and we want to maintain that, we need to make sure our students have the necessary equipment.”

Walker was correct in stating the biggest need is a science building. One science room is ‘boxed-in’ by three other classrooms; students literally have to walk into their class, by walking through another classroom, there is no outside door or passage way, making an emergency exit almost impossible.

Chemistry classes have no

lab tables, students participate in online simulated experiments, “With students not being able to have hands on experience, there is a curve of learning that is lost,” notes Duer.

One class actually sits at lunch tables with folding chairs, there is no access to sunlight and only one door leading into and out off the room. There are only two lab rooms that have any type of working equipment, and then the equipment does not work all the time.

Teachers must rotate the use of labs, the school has five more teachers than it has classrooms, so these teachers constantly rotate from room to room.

Electrical outlets have no GFI and several covers are loose making it an electrical hazard to plug in anything.

One of the Science co-chairs has been teaching for 21 years and has a Masters Degree. All the teachers and the department heads are crammed into a ‘boiler room’ type office, with bad lighting, no work space and no privacy walls.

“If he were anywhere else, the department head would have an office or at least walls,” stated Walker. Even with cramped quarters and broken down office equipment, the gentleman said he wouldn’t teach anywhere else, “I love this district, the faculty and staff are remarkable. It is sometimes a hassle, because we have more teachers than rooms. But we do what we can.”

The music / band room has a maximum occupancy of 58

people; however the band is 120 strong. Electronics take up half of the room, there is a serious lack of proper security or storage for instruments and the uniform closet space is maxed out. Through the bond measure, new rooms could be constructed to accommodate this growing award winning music department.

With a school that has 2,200 students, the lunch room only has four lines. “We hustle the kids through the lunch lines, but we are only able to accommodate 700 of these students, my concern is this – where and what are the other kids eating? We need to enlarge the facility to feed more students,” says Walker.

ABCUSD Trustee Board Member Chris Apodaca joined on the tour of Cerritos HS. “Every classroom we saw was full, we heard teachers state how they have to switch classrooms, and we don’t have the facilities for proper chemistry labs. That is cutting our kids short in their education, not only that, we are asking professionals who have been in the field for twenty years to work in deplorable conditions. Personally I feel we are failing not only our students, but our teachers and staff. It is disheartening and disappointing. Any one walking through our schools would not have a sense of pride. The facilities are faded and old and what we have seen today is just patch work.”

improve learning. However it didn't take very long to realize an open concept was noisy and distracting." Thus inside walls needed to be constructed.

After a period of time, around 25 year ago, the District came in and added inside walls. The outside walls are made of brick and are permanent, however the inside walls are very thin and temporary, only about two inches thick, "They are thin, do not keep the noise out, we can hear other teachers and what's more is that many of the walls were put in place directly beneath lights."

"This peculiarity leads to confusion. If one room turns the lights out for a film, the lights will turn off in another school room, or just leave one light on that spans both sides of the wall," said Amburgey noting the light in the ceiling that was half in his room and half way into another classroom.

As he was demonstrating this, the teacher next door came in to inform him that her lights were turning on and off, "so some of the money from Measure BB would go to build permanent walls for our classrooms. This is similar to most of our buildings."

The shade structure in the middle of the campus would

have an upgrade, to include a solid covering and an extension for students during inclement weather. Depending on the season, the Principal and custodian will move the lunch benches into the shade, because the structure does not provide adequate covering.

Principal Amburgey asked the class for a show of hands, "How many of you have fallen on the wood chips in the play area?" Without exception every student raised their hand. It would seem

that in the state of California that adding wood chips to play areas would be considered a drought tolerant solution; however, these chips are used underneath the playground equipment, "Many of our kids have received splinters, scraps or cuts from these wood chips, I have even pulled these chips out of shoes with pliers, because they have gone all the way through the shoe."

The school also has two portable classrooms, which need to be changed to permanent struc-

tures, modernize the media center and library, provide a new music room and redesign the sand pit used for races.

Surprisingly several students had actually read the Bond Measure BB; they had questions regarding property tax increases, property assessments, and how much the school would receive. The conversation of 'school being free' came up.

"School is free for you," said Amburgey, "do you pay anything to go to school? No, but it does

take money to run the schools, so where do we get that, from taxes."

He went on to ask students why someone would support Measure BB if they no longer had children in school. Students answered, "for their grandchildren."

"Yes that could be true, but if you live in a nice neighborhood with good schools, it increases your property value," answered Amburgey.

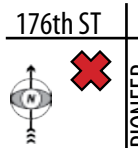

**DAVIS, GLADDEN POWER
ARTESIA TO FIRST OUTRIGHT
605 LEAGUE TITLE**

At times, the Artesia High football team didn't play as crisp of a game it wanted to against host Cerritos High in the regular season finale for both teams. But the only thing that mattered to the Pioneers was staying hot entering the CIF-Southern Section Division 12 playoffs.

Senior running back Travys Davis rushed for 270 yards on 12 carries and scored five touchdowns and senior quarterback added another 144 yards on eight carries and accounted for three more touchdowns as Artesia rushed past Cerritos 56-26 last Friday night at Dr. Hanford Rants Stadium. Artesia, which had already clinched at least a share of the 605 League title, enters the postseason with a 7-3 overall mark and 3-0 in league action. It's Artesia's first league title since 1992 and its first trip to the playoffs since 2008.

"It feels great; it's something we've been kind of waiting for a while," said Artesia head coach Don Olmstead. "We're trying to get somewhere where we're in a

more competitive league and I think you saw that tonight. It was a 14-point game at one point and you have to finish teams early or else every team in this league can come back and get you."

"It sounds amazing to me," Davis said. "Since [last] November, we've always worked hard in the weight room. This is our goal since two years ago since we first landed the [new] league. So, our goal was always 605, but we took it game by game, hopefully gaining experience as we went on."

Davis put the Pioneers up 14-0 on a 32-yard run and a 29-yard run within his first three touches inside the first 3:17 of the game. After a pair of interceptions by both teams, Gladden found senior wide receiver De'Jon Major for a 48-yard score with 1:44 left in the stanza. Artesia would have the ball for 3:36 of the first quarter and just less than that in the second quarter, but still scored two more touchdowns before halftime.

A 72-yard run from Gladden was followed up by a Davis one-yard run and towards the end of the half, Davis scored from five yards out to make it 35-12 at the time. The Pioneers wouldn't need the ball that much in the third quarter but added three more touchdowns. On the first play of the second half, Davis ran 76 yards for the lone play of that drive which lasted 20 seconds. After the defense held the Dons on downs, A Davis six-yard gain and a

**GAHR'S LAST HOPE FOR
PLAYOFF BERTH ENDS WITH
ANOTHER LOSS ON DOWNEY'S
HOME FIELD**

DOWNEY-Throughout most of the season, Gahr High's football team has had trouble holding second half leads, losing four games in which it led at halftime. The latest of those blown halftime leads came against Paramount High on Oct. 19, squandering a 34-19 advantage and falling to the San Gabriel Valley League champions 55-45.

Gahr ventured into Allen Layne Stadium on the Downey High campus last Friday, a place that hasn't been too kind for the Gladiators, or head coach Greg Marshall. This time, there would be no second half collapse as the Vikings led 21-7 at the break and rolled to a 42-27 win. Gahr, which was tied with Downey for third place, ends the season at 3-7 overall, 2-3 in league play. In addition, Marshall has lost seven straight times at Downey and since 1998, Gahr is 1-16 against the Vikings with nine of those losses coming on the road.

"Because they have a lot of good football players," Marshall said of the road woes at Downey. "Downey is good. They had a lot of guys missing and they were hard to handle. We have to play a very clean game and we have to be really good."

Downey struck first but the Gladiators tied the game with 7:51 left in the first half when senior quarterback Jordan Simpson threw an eight-yard touchdown pass to junior wide receiver Aaron Okaro. That would be all the scoring Gahr would get until the fourth quarter. The Gladiators would be held to 136 yards in the first half and had two third quarter possessions lasting a total of 2:28 and producing 39 yards. But Gahr, already down 35-7, scored on all three of its fourth quarter drives, be-

ginning with a Simpson 14-yard run with 8:37 left to play in the game. After the Vikings scored their final touchdown of the game, Simpson found senior wide receiver Marcelous Hayes for a 12-yard score with 3:37 remaining and a 66-yard strike with 65 seconds left.

Gahr senior running back Micah Bernard was frustrated by the Downey defense all night long, gaining 102 yards on just 11 carries. He only had four gains of 12 yards or better but ended the season with 716 yards, a big drop from the 2,411 he gained last season. The University of Utah commit also caught four passes for 48 yards.

"Well, he kept us together," Marshall said. "Obviously, with the nature of the game today, a lot of people are after him and he stayed and showed his loyalty to us. He's a loyal guy and he's a Gahr guy. He's had some pretty good years here."

Simpson completed 18 of 34 passes for 228 yards and added another 19 yards on 16 carries. Half of his carries went for negative yardage. Hayes caught five passes for 90 yards while Okaro was the recipient of four of those completions for 53 yards. But for the third straight game and fourth time this season, Gahr's defense allowed at least 40 points.

"In a normal defensive year, we would be in the playoffs," Marshall said. "And, we had to put a new offense in, so it was all brand new. The offense performed well under circumstance, but that was probably the worst defensive team we've had. [The offense] score more than enough points for us to be a playoff team."

Gahr was seeking its third straight trip to the playoffs following a pair of eight-win seasons. But Gahr's losing mark in league play was the program's seventh in the last nine seasons and to get to the playoffs in the tough SGVL, you need to win at least three league games. The Gladiators have been 3-2 or better in league action five times since 1998.

"Who would have thought we would have had a big lead on Paramount last week," Marshall questioned. "We couldn't hold on; we just didn't have enough bodies. Again today, we were just moving guys around in the second half."

**TOP TWO FOOTBALL TEAMS
IN 605 LEAGUE PREPARE
FOR RARE HOME
POSTSEASON GAMES**

The CIF-Southern Section football begin tonight and for a pair of area teams, the long droughts are over, and in a big way. Artesia High, winners of the first 605 League championship, has not been to the playoffs since 2008 while John Glenn High, the second place representatives from the 605 League, has not played an 11th game since 2002. As a bonus, both are ranked in the top four in Division 12. Here are quick previews of tonight's games, both scheduled for 7:30 kickoffs.

Ramona (7-3) @ #3 Artesia (7-3)-This one will be a good first round test for both teams who love to run the ball, and they do it well. If you haven't heard of seniors Travys Davis and Heder Gladden, then you must have not been following Artesia football this past season. Gladden, who is also the quarterback, led the Pioneers with 1,523 rushing yards and scored 21 times while Davis gained 1,254 yards and found the end zone 13 times. Add another 799 passing yards and 12 touchdowns and this makes the Davis-Gladden tandem as one of the best, if not the best, the Artesia program has seen. Gladden has scored multiple touchdowns in six games including five against Westminster High on Sept. 7 while Davis has also had a five-touchdown performance, which came last Friday against Cerritos High in a 56-26 win. When he's not throwing

to Davis, count on senior wide receivers Marcel Bowman and De'Jon Major to get into the action. The Pioneers have averaged just under 450 yards per game while averaging 42 points per game

But the Rams can score as well. The third place representatives from the River Valley League scored 374 points and are led by Donte Roby Jr., who led the team with 1,187 rushing yards and 15 touchdowns. Brian Alvarenga is second on the team with 761 yards on the ground with 11 touchdowns while Brandino Osayande picked up another 309 yards and eight touchdowns. Osayande is also the team's quarterback and threw for 1,122 yards and 14 touchdowns and only three interceptions. He completed 79 passes to seven different receivers with David Cornejo catching 35 of them for 482 yards. The Artesia offensive line will have its work cut out as Ramona's defense has sacked opposing quarterbacks 25 times with Elias Rocha leading the way with seven and a half.

Both teams have not played any common opponents. This is Ramona's fourth straight season of having a winning record. Before that, the Rams went a combined 21-91 from 2004-2014. This is Artesia's best regular season record since 2008, its first home playoff game since 2005, a 26-24 loss to Aliso Niguel, and the program's 23rd playoff game since

Gladden 41-yard touchdown run was all that was needed for a one-minute drive and a 49-18 lead. When the Pioneers were on offense again, Davis ran for 24 yards and Gladden threw a 41-yard score to junior wide receiver P.J. Holmes. That drive lasted 18 seconds.

"I think it was a combination of us being a little inconsistent in our blocking and also, Artesia's pretty freakin' good," said Cerritos head coach Barry Thomas. "They're going to the playoffs for a reason. They put up a [billion] yards this year because they have great athletes on both sides of the football. Obviously, the two guys in the backfield are electric, however, they have a bunch of guys on that team. With this week being over, I'm an Artesia fan now and I hope they go far. I think Don has a good thing going."

Davis had three runs of under 10 yards and four more of over 30 yards. His five-touchdown performance was a season high and he has scored multiple rushing touchdowns in four straight games and six of the last seven contests.

"He's unbelievable," Olmstead said. "That's what he is and we kind of knew that coming in, that Travys and Heder are going to play. I don't worry about them. It's the young guys up front that I'm worried about, being mentally ready every week in and week out."

"Well, of course it all goes to my linemen because they block for me," Davis said. "They tell me every game, 'Travys, I got you, Travys, I got you'. They pick me up after every touchdown or every time I'm on the [ground]. All my credit goes to them and all my receivers on the outside.

And all my credit really just goes to my father for putting me in camps and working hard throughout every season."

Cerritos got on the board near the midway part of the second quarter when sophomore safety Nicolas DeGiuseppe returned a Gladden interception 41 yards to the house. It was the second of two interceptions Gladden would throw. Then the Dons recovered the ensuing onside kick and in two plays, junior quarterback Stacy King scored from seven yards out. King would make things interesting with a five-yard score with 25 seconds remaining in the half to put the score at 35-18. The final score of the game came early in the fourth quarter when King threw an eight-yard pass to junior wide receiver Noah Garcia.

"I think [Cerritos] is kind of in the same boat as us," Olmstead said. "Everybody is kind of thin, so simulating the speed in practice is hard to do. That's why you see our defense struggle a little bit at the beginning of the game, because the speed of the game is hard to emulate in practice."

"There's nothing I can do about that," Thomas said of his team not quitting. "I can say it until I'm blue in the face. Any coach can tell you, the players are the ones who have to do it. That's a testament and to them as a group, there are some underclassmen who aren't afraid to tell seniors, 'hey man, keep going, keep going, keep going'. Them as a group, they just don't quit."

King led Cerritos with 99 yards on 21 carries but was seven of 20 for 100 yards through the air. Senior running back Tye Anderson added 55 yards on 16 carries. But the Dons had 10 rushes go for negative yardage.

The Dons wrap up the season at 3-7 and were winless in three league games. But, the team scored in bunches at times

and put up 327 points in 2018. However, the defense yielded over 50 points in four of the last five games and six times this season. Despite the roller coaster of the season and not making the playoffs for the 17th straight season, the program continues to improve and make strides.

"A lot of the things that are accomplished were accomplished behind the scenes," Thomas said. "Parent involvement; you're not going to see that on the stat sheet. You're not going to see 6:00 a.m. workouts, guys volunteering to come in and workout. Guys volunteering to come in after practice and workout. Guys asking that extra question. Guys helping each other out, keeping each other out of trouble on campus."

Artesia, the third ranked team in the division, will host Ramona High tonight at 7:30. This will be the first home playoff game for the Pioneers since Nov. 18, 2005 when they fell to Aliso Niguel High 26-24. Since Artesia's last trip to the playoffs, it had finished in fourth place in the Suburban League four times, going 3-3 in league action three times.

"I think the unfortunate part, when you look at CIF, is seven-league teams don't get rewarded," Olmstead said. "And that's where we've been at. We've finished fourth [four] of the last six years and we didn't go to the playoffs where in any other sport, we would have gone to the playoffs. That's all I wanted, an opportunity to get into the playoffs and see what we can do."

"Since we always came up short, we've always been like, 'we need one more game, we need to beat Norwalk, we need to beat this team, we need to beat that team,'" Davis said. "So, to walk into playoffs finally as...we're in, we're the number one team [in league] going in, it feels amazing."

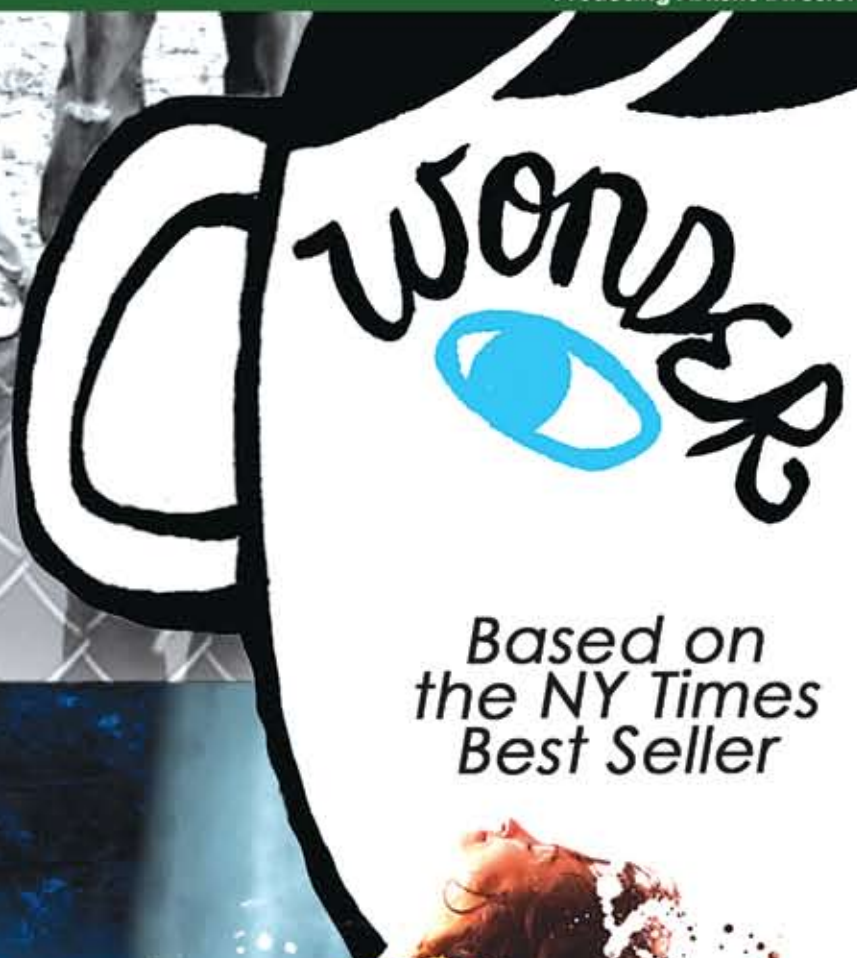

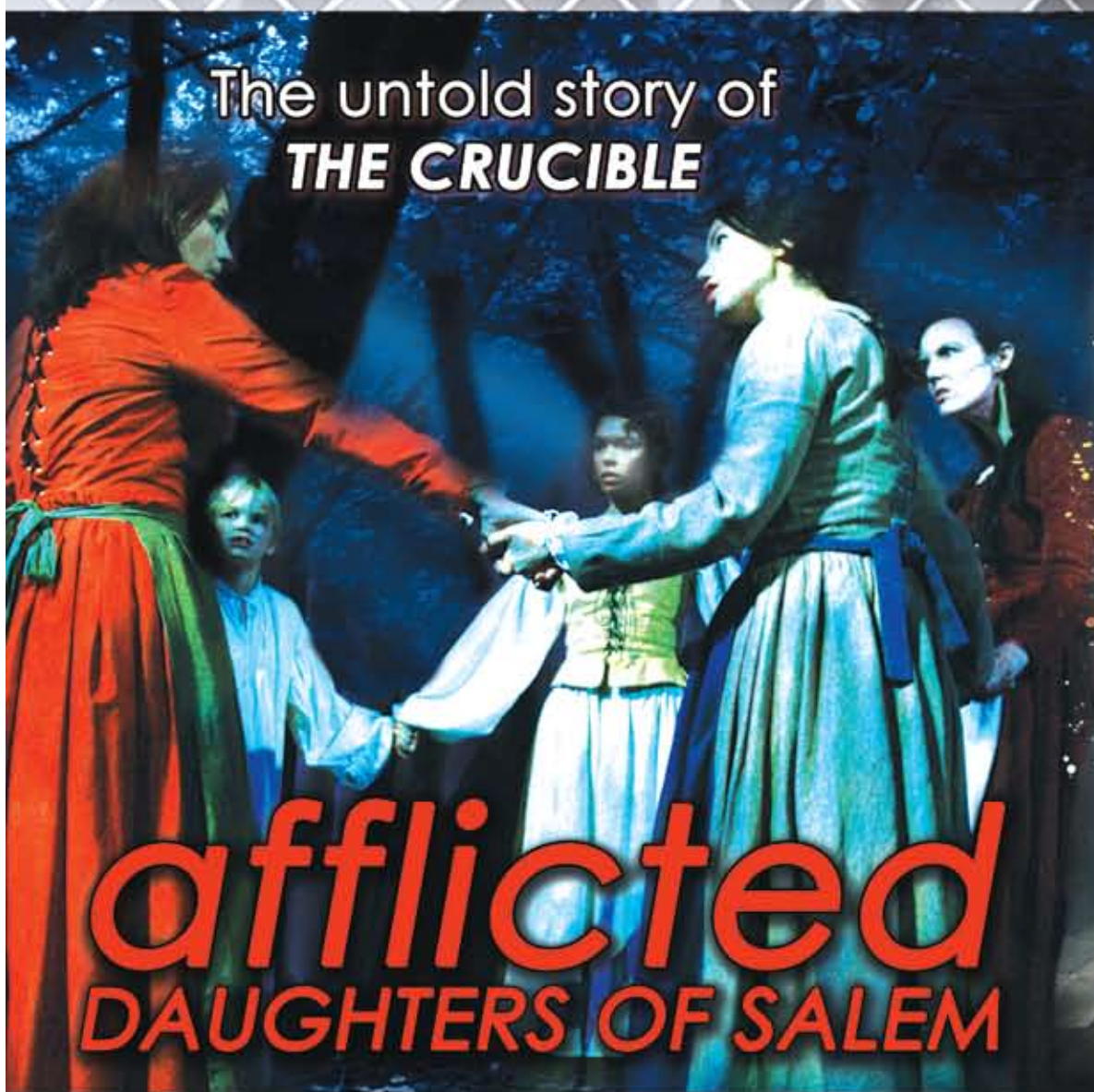
