Silva (D-Fullerton) threatening retribution if a local politician hired her former staffer Danny Fierro for campaign services.

Observers can now count assembly delegate election and its candidates among Garcia's intimidation and bullying exploits.

Delegate elections occur every two years, anyone who is a registered Democrat and lives in the district can run; the same applies to residents who want to vote for a candidate.

Fourteen delegates are elected by vote at a designated address, seven men and seven woman, with the top votegetters earning a spot in the Executive Board also known as the E-board.

Those elected attend delegate conventions and endorse candidates at the state level.

This year newly elected 32nd District State Senator Bob Archuleta, similar to what former State Senator Tony Mendoza did two years ago, put together a slate of candidates for the 58th district to run against Garcia's slate.

SOUTHLAND REAL ESTATE MARKET TAKES A DIVE

The data is in for December and it looks like the hot housing market in California is finally cooling down.

Sales of homes plunged 20.3% in December while prices basically remained the same.

The number of sales is the lowest level for the month of December since the Great Depression and is the biggest drop since 2010.

The median price remained stagnant rising by an average of 1.1% to \$515,000, \$22,000 below the June 2018 all time high of \$537,000.

Experts attribute the drop due to rising mortgage rates and economic uncertainty.

Agents in California were saying that they noted a "shift in market psychology" as early as last summer following almost 4 years of a red-hot market.

The data further shows a trifecta of bad news for realtors; the number of listings is increasing, sellers are reducing prices, and homes staying longer on the market

As sales decline more homes stay on the market with sellers not being able to command top dollar.

According to the website Redfin, the number of homes for sale rose 22% in LA County and 30% in Orange County.

But in a bit of good news, the data is lagging and sales could heat up in the spring.

The City of Downey launched their first bike share station Saturday morning, January 28th at Discovery Park. Thanks to a grant from Metro people can check out a bike, for a nominal fee, and return them at designated stations throughout the city.

For more than a century the bicycle has been an important part of the lives of most Americans. It is a viable and environmentally sound form of transportation, an excellent form of fitness and a quality family recreation activity. "Our diverse city is growing, and with that, we are staying ahead with the rapidly changing travel needs," said Mayor Rick Rodriguez, "The installation of this bike share program is one of these examples. Our investment in today's eco-friendly bike lanes and this program will pay dividends tomorrow through long-term impacts."

The City of Downey has been promot-

ing healthy living alternatives for many years along with the annual Ride and Stride event. Bike share programs and bike lanes help stop global warming by providing a real, healthy option to help reduce greenhouse gas emissions. Each bike on the road means one less car. Also bike lanes have a "traffic calming" effect, meaning roads that appear narrow result in slower vehicular speeds.

The Blind Children's Center is a nonprofit organization founded in 1938 by Southern California Delta Gammas. Each year the Center serves approximately 100 children who are blind or visually impaired and provides an array of support services for more than 350 family members. The Moskowitz Foundation donated \$10,000 last week to assist with the purchase of learning materials.

"Our goal is to optimize each child's development and opportunities to lead a meaningful life through a comprehensive program beginning with early intervention," says Scott Kassel Director of Development & Communications, "This is followed by an educational curriculum specifically adapted to the needs of each student." Committed to family focused approach where parents, siblings, grandparents, and caregivers are included in the educational process every step of the way, the programs are fully inclusive with sighted children integrated in each class, providing unique opportunities for social interaction and acquisition of critical skills."

The multidisciplinary team of experts utilizes leading-edge technology and adaptive devices to help students who are visually impaired keep pace in the sighted world. More than 750,000 copies of their publications have been distributed in 75 countries, and translated into 17 languages.

NEW COVERED CALIFORNIA Sign-ups plunge 24 percent

The number of new enrollees in Covered California health plans plunged by nearly a quarter this year, largely because of the elimination of the federal tax penalty for people without insurance, officials announced Wednesday.

The decrease was steeper than expected — and larger than the drop in new enrollment in the federal marketplace, healthcare.gov. It occurred even as Covered California, the state health insurance exchange, spent millions on advertising to entice people to sign up for coverage during the open enrollment period that ended Jan. 15.

Overall, about 1.5 million Californians selected a health plan for 2019 coverage, a figure similar to last year's, the agency said. But new enrollment fell by 23.7 percent, with 295,980 sign-ups, compared with 388,344 last year. Meanwhile, plan renewals remained strong, posting a 7.5 percent increase.

"Recent actions at the federal level

appear to be causing large drops in enrollment that will lead to more uninsured and higher premiums for all Californians," said Covered California Executive Director Peter Lee.

"The federal removal of the individual mandate penalty appears to have had a substantial impact on the number of new consumers signing up for coverage," he said.

New enrollment in the federal health insurance exchange, healthcare. gov, which serves 39 states, fell to 2.1 million, down 15.8 percent from the previous year, according to preliminary data from the Centers for Medicare & Medicaid Services.

Total enrollment dropped to 8.4 million from roughly 8.7 million in 2018.

The drop in enrollment, especially if fewer healthy people are signing up, could lead to higher premiums, said David Panush, president of California Health Policy Strategies, a Sacramentobased consulting company, and former external affairs director for Covered California.

"When you have fewer healthy people enrolling, that has an effect on the risk pool. And when

you have a sicker pool that means premiums go up, although so do subsidies," Panush said. "But for people on the nonsubsidized side, that's a big deal." In fact, premium rates already have increased because of the elimination of the penalty for not having health coverage, which took effect this year. Covered California said the average rate increase for 2019 would have been closer to 5 percent — instead of 8.7 percent — if the individual mandate penalty hadn't been axed as part of the 2017 Republican tax bill.

On his first day in office, California Democratic Gov. Gavin Newsom called for a state-based mandate, which would require all Californians to have health coverage. The Legislature would have to approve it, which isn't guaranteed even with a Democratic majority because the mandate was one of the least popular provisions of the Affordable Care Act.

Penalizing uninsured Californians in this way could raise roughly \$500 million a year, Newsom said when he unveiled his proposed budget earlier this month. That money, he suggested, could be used to create state subsidies for Californians who struggle to afford health insurance.

New enrollment fell even though Covered California spent \$40 million on ads during the latest open enrollment period, out of a monster \$107 million marketing budget. By comparison, the federal government spent \$10 million on advertising.

St. Irenaeus Health Ministry sponsored a powerful and informative workshop, Connecting & Communicating with Someone with Memory Loss: A New Way of Talking, on how to better communicate with a person who has memory loss on Monday, January 28th at St. Irenaeus Parish Hall.


About 65 people were in attendance. The primary speaker was Kari Walker, Director of Education at Alzheimer's Orange County, but there were also representatives from other organizations who spoke about free programs that they offer to give supportive assistance to caregivers and families of people who have memory loss.

These included representatives from the Family Caregiver Resource Center, who talked about a care plan and a threeweek class for caregivers, and The Council on Aging, who focused on health insurance counseling and HICAP (Health Insurance Counseling & Advocacy).

Walker talked about Alzheimer's disease as a communication disorder that requires a new way of talking.

She said that communication is an art that involves three main components: body language, tone of voice, and content, or actual words.

The person who has memory loss may no longer make sense of spoken words, but are most affected by body language, such as gestures, eve contact and posture (55%). Tone of voice is also an important factor of communication (38%). Therefore, giving physical cues, such as handing the toothbrush and paste to the person with memory loss is much more effective than saying, "Brush your teeth." Also, the manner with which you interact with the patient is vital. Kari

quoted Maya Angelou to make her point. "I've learned that people will forget what you said, people will forget what you did, but people will never forget how you made them feel."

Walker presented a brief overview of Alzheimer's disease, showing its progression and biological attributes. There are two types of this disease: Early Onset, which accounts for only 2 - 5% of cases, begins before the person is 64 years old and is more progressive, and regular Alzheimer's disease, which progresses relentlessly over 8 to 10 years and is terminal. Changes due to Alzheimer's disease include losses in: Memory of how to do everything; Language and communication; Executive functions, such as planning and judgment; Visual and spatial perception, leading to balance issues, and Behavior.

Walker called Alzheimer's disease

a disease of emotions because it causes confusion and discomfort, resulting in behavioral problems. Therefore, we need to find out how to alleviate the person's confusion and discomfort to calm them. Tools, such as redirecting the person to an activity that they enjoy, such as taking a walk, expressing interest in whatever the person is saying or doing, playing music that they like, and the importance of patience were discussed. Adjusting your approach can make a big difference in improving your relationship with someone who has memory loss. Kari recommended focusing on the person's remaining skills, not on their losses. Kari encouraged caregivers to go to a support group to learn strategies on how to cope and how to better connect to the person with memory loss.





SCAMMERS PRETENDING TO USE LAKEWOOD CITY HALL PHONE NUMBER FOR SOLICITATIONS

Several Lakewood residents have received phone calls thsi week with the Lakewood City Hall number showing on their caller ID screen.

When they answer the phone, the calls instead are from a solar energy company selling a fake product, or in some cases from a scammer posing as an IRS agent saying the resident owes federal taxes.

Lakewood city staff are working with the phone company to end the socalled "spoofing" of the City Hall phone number and to track down the scammers

In the meantime, residents are advised to hang up on any callers pretending to be from Lakewood City Hall who turn out to be calling about something unrelated to city business.

Or residents can ask to call the person back at City Hall. City Hall's number is 562-866-9771.

Usually scammers only use a spoofed number for a few hours and then move on to another number.

The following are things phone scammers often do but that the IRS will never do:

Call to demand immediate payment using a specific payment method such as a prepaid debit card, gift card or wire

over the phone. If you believe you have been remember the following:

ADMITTED TO DISTRIBUTING CHILD PORN SENTENCED STAFF REPORT

Gerald Patrick Beaver was found to have over 6,000 images and more than 450 videos of child porn on his laptop computer.

The discovery followed a search warrant served at his home, according to the U.S. Attorney's Office.

In his plea deal, Beaver admitted to distributing the illegal material to undercover investigators in New Zealand and Oklahoma over the internet using a file-sharing program.

"Those who trade in child pornography inflict great harm on the most vulnerable in our society by re-victimizing the children in the existing pornography as well as by fueling a market that requires new child victims," U.S. Attorney Eileen M. Decker said.

"The children depicted in these images that were illegally shared are victimized time and time again," said Jim Struyk, acting assistant director in charge of the FBI in Los Angeles.

ongtime Cerritos High boys basketball head coach Jonathan Watanabe was coaching the school's junior varsity team the last time the Dons won a league title. Cerritos was in the Mission Valley League at that time and after one more season in that league, the Dons would go through 20 seasons in the Suburban League without a league crown.

Now, Watanabe, who has close to 270 wins in 18 seasons at the varsity level, can finally call himself a league champion head coach as the Dons went wire to wire to take down Artesia High 62-45 this past Tuesday. The Dons improved to 15-11 overall and 8-1 in the 605 League. It's also the program's fifth league crown overall.

"It's a big weight off my shoulders," Watanabe said. "To have all these guys here (pointing towards stands behind the Cerritos bench) was awesome. We had over 30 alumni come back to watch this game because it's not just the guys on the court. It's all the guys that have established the program. We've been doing this for 18 years and it was just little by little, piece by piece and they were looking to getting closer. It's not just the guys on the court, it's a league championship for all the guys and all the time we put in."

The program had always been in the shadows of either Artesia, a seven-time league champion within the first nine seasons Cerritos jumped into the Suburban League, then either La Mirada High or Mayfair High, who combined to win the next 11 league championships until the Dons moved into the 605 League at the beginning of this academic school year.

"We should have won it last year, but we took a loss to La Mirada late in the second round," said Cerritos sophomore Alex Archer. "It's a little bit overwhelming, but we all knew coming in that we were going to be league champs."

The Dons were on fire on "Black Out" night, scoring the first eight points of the game and leading by nine points three minutes in after junior Jagger Uy hit the first of his two long range baskets. The Pioneers then reeled off the next seven points but after that, could not get any closer. Cerritos would be up 27-21 at halftime, then put the game away with the knockout punch in the third quarter. It was there that the hosts went on an 11-2 run through the first four minutes and outscored Artesia (17-10, 7-2) 18-6 in the third quarter. While the Cerritos defense limited Artesia to five field goals in 19 attempts in the first half, it held the visitors to two made baskets in 13 tries in the third quarter.

"We've been in a lot of these games," Watanabe said. "The Staples Center game (against Downey High), we've had a big Gahr game, and even the Whitney game was a big game with all the people there. So, we've been preparing for this. We tried to make sure the game wasn't too big for our kids; that they played the game. It was just a game and they came out and performed."

From the time when Uy hit his second three-pointer with 4:37 left in the third quarter to the end of the game, the Dons maintained a double-digit lead. It would grow to a game-high 27 points with under three minutes remaining before the Pioneers scored the final 10 points of the contest.

Uy led everyone with 15 points while junior Ethan Reyes and senior Donte Burnett added 13 and 11 points respectively with a combined six three-pointers. Archer grabbed 11 rebounds and had a pair of steals while senior Aditya Suresh pulled down eight boards. It's performances like that all season that has made Cerritos an



all-around team instead of one that relies on a player, or two, or three.

"I thought we were just a really good team," Watanabe said. "I thought this group...it's just share the ball, takes the best shots. Sometimes we overpass the ball a little too much. But that's a good thing.

"Out of all the groups, it's nice to have this group win [a league title]," he added. "We've enjoyed coaching this year and it's a group you can be proud of."

"We have a young team, but in that, we're a very tight knit group," Archer said. "It doesn't matter whether we make mistake or not, we're going to stay together no matter what."

Cerritos will have a home game in the first round of the CIF-Southern Section Division 3AA playoffs, which will be on Feb. 8 while Artesia, which was paced by seniors Jarren Bugay (14 points, eight rebounds) and Heder Gladden (11 points, seven rebounds).will either play in a Division 3A wild card game on Wednesday, or a first round game on Feb. 8.

Prior to the boys game, the Cerritos Lady Dons easily coasted to a 67-22 victory, improving their mark to 17-10, 7-2 and maintaining second place in league. The Lady Dons scored the first five points of the game, then went on a 13-0 run after the Pioneers scored their lone points of the first quarter.

Artesia (12-15, 0-9), which has lost 12 straight games, attempted just 22 shots and turned the ball over 35 times, leading to 23 steals by Cerritos. The Lady Pioneers would also score just two points in the fourth quarter.

Cerritos junior Alyssa Saragumba recorded a career-high 13 points on perfect shooting from the field while senior Iris Lee added 10 points and five rebounds as 11 different players scored. In contrast, four players scored for the Lady Pioneers, led by junior Seira Roberts, who had nine points and 10 rebounds.

Both Artesia teams concluded the regular season at Pioneer High on Jan. 31 while the two Cerritos teams hosted Oxford Academy on Jan. 31. In addition, the Lady Dons, ranked 10th in Division 3AA, will most likely host a first round game on Thursday.

The last time a Cerritos High girls soccer team won a league title, it was in the Suburban League while a good portion of the school's athletic program was in the final year of being a member of the Mission Valley League. It was the 1997-1998 season and the Lady Dons, coached by Chris Alexander, had stars like Heidi Bork, who scored 40 goals, and Lisa Herman, who tallied 25 goals.

Cerritos went 18-5 that season and won 11 of 12 league games, scored 119 goals and yielded 27. Now, 21 years later, the girls soccer program can call themselves league champions again. Trailing Artesia High by a pair of goals with less than 10 minutes to go before halftime, Cerritos quickly responded for three goals before the break, then added two more within the first eight minutes of the second half to knock off the Lady Pioneers 5-2 this past Monday. Cerritos, which then defeated Oxford Academy 3-1 this past Wednesday, ends the regular season 16-2-4 overall and 10-0 in the 605 League. It's also the school's sixth girls soccer league championship. "For these girls, it's a lifetime," chuckled Cerritos head coach Robert Adams. "We play the teams who are in front of us and the leagues who are in front of us. So, the 605 League is a great league; it's an honor to be able to play in it and win this first [title]. The girls are tremendous. It's very rewarding for them to be able to play through them and we would have tried to do the same thing regardless of whatever league we were in." "Winning the league title means so much to me," said senior forward Erika Rizal. "I've been with these girls all four years and it means so much. I love these girls so much and I can't believe we won a league title, finally." Artesia and Cerritos had always been fierce competitors when they were in the Suburban League, often playing crucial late season games which would determine third place, fourth place or a spot in the CIF-Southern Section playoffs. But in this game, Artesia needed to win its final

two games of the regular season to claim the league title. And early on, it was going Artesia's way. One minute after Adams was issued a yellow card for arguing to the referees about the chippy play, senior midfielder Michelle Abarca followed up on a rebound from a misplayed ball to give Artesia a 1-0 lead 25 minutes in. Seven minutes later, the Lady Pioneers added on when freshman forward Dulce Alamilla took a long-range shot that curled just inside the upper left corner of the net.

"We were not surprised by what Artesia would try to do and what they're capable of being able to do," Adams said. "We made some mistakes and Artesia certainly punished us for those mistakes."

For the Lady Dons to be trailing in any league game is a story as they had entered the game outscoring league foes 82-0 and had yielded 14 goals on the season to that point. But, as quickly as Artesia scored, the host rebounded in fine fashion.

"Those goals...that's a good team," Adams said. "Artesia is going to push forward, they have some talent to be able to do that and by doing that, it helped us a lot. Would we have liked to shut Artesia out? Obviously, that's our goal every single game, just to keep a clean sheet. But if you're going to give goals up, it helps tests the character and it helps push the team a little bit that way too. And it woke everybody up." "Having no goals against [us] was definitely one of our goals," Rizal said. "This Artesia game...we knew that it might end it, but that was always our goal, every single game. As they scored two goals, I'm like, 'we have to pick it up'. I have to encourage these girls to pick it up. And right on, we started scoring two goals."



Calderon, already standing by the top of the penalty box. Diep managed to get past Calderon, who has injured on the play, and easily knocked the ball through the net to tie the game. Then in stoppage time, Diep added what would be the game-winner off a pass from Couto.

"We're not really known for that kind of range," Adams said. "Persephone is a was supposed to do. Once our leadership started scoring and relaxed some of our younger players, we were able to start punishing them from more than one spot."

"I think all throughout the four years, we've always built up every year with our hard work and I definitely think we deserved this league title," Rizal said. "Even though it's in the 605 League, these girls worked their butts off in practice and in each game and I'm so happy to be leading them as captain this year for all of them." Cerritos, which had always gone on the road for either a wild card or first round playoff game because it would finish in third or fourth place, will host its first playoff game since 1998 on Wednesday while the Lady Pioneers, who blanked Pioneer High 1-0 this past Wednesday, finished the regular season at 11-5-5, 7-2-1 and will either play in a wild card game on Monday or a first round game on Wednesday. The CIF-Southern Section will reveal the playoff brackets on Saturday. "Regardless of whether they're for first, second, third, fourth, a CIF spot, Artesia and Cerritos have been linked together for 25 years," Adams said. "And we play really important games often. Because of that, it is a rivalry. I think it's a respectful rivalry. They're very good and they're very good on their field, too."

A minute after Artesia scored, Rizal took a pass from senior defender Julia Couto and scored for the 13th time this season. Five minutes later, sophomore forward Kylee Castro sent a pass to freshman midfielder Persephone Diep, who raced towards Artesia senior goalkeeper Julia freshman with a tremendous amount of talent. And, one of her skills is she has long range and is not afraid to take those shots. So, she did, and we caught the goalkeeper out."

The Lady Dons, ranked second in Division 4, kept the momentum going seven minutes into the second half when Diep was stopped by sophomore goalkeeper Jizelle Velazquez, who had replaced Calderon in the first half. But when the ball trickled loose and was straddling the goal line, junior forward Jayda Anusasanananta was there to tap it in for her 14th goal of the season. Then one minute later, sophomore midfielder Marisa Couto scored on a rebound after a shot from Diep hit the crossbar. In all, Cerritos took 14 shots on goal as opposed to six from Artesia.

"We have a big group of seniors and they're all really heavy contributors," Adams said. "Julia knew exactly what she was doing, and Erika did exactly what she

Summary of Ordinance No. 707

The proposed Ordinance would create a sidewalk vending permitting process requiring applicants to provide personal identification, list the items they intend to sell, and submit evidence of health permits and a business license. Pursuant to the proposed ordinance, no sidewalk vendor would be authorized to vend in the following locations: within 15 feet of any street intersection; within 10 feet of any fire hydrant or other emergency facility; within 10 feet of any driveway or driveway apron; upon or within any roadway, median strip, or dividing section; within 500 feet of a permitted certified farmers' market, a swap meet, or an area designated for a temporary special permit; in any City parking lot; and within or upon any landscaped areas. In addition, the ordinance would impose a number of regulations on health, safety and welfare grounds.

Gardens Mayor pro tem Lisseth Flores, Bell Gardens Councilwomen Jennifer Rodriguez, Montebello City Clerk Irma Barajas, and Frine Medrano.

Garcia and Archuleta's slates were well-publicized, with each sending out full color flyers with the date, time, and location of the election, while urging residents to vote for their candidates.

The bullying started when Garcia obtained Archuleta's flyer.

Garcia was not happy when she learned who was running on Archuleta's slate, immediately going into bullying mode, the same type of behavior the Assembly Rules committee admonished her for and why Assembly Speaker

Anthony Rendon temporarily pulled her from several committees while ordering her to anger management classes.

Several sources are telling HMG-LCCN that Garcia and her supporters were "way out of hand, disrespectful and rude, and yelling at Archuleta candidates and supporters at the voting facility in Commerce."

"They were yelling Cristina Garcia, Cristina Garcia inside the voting area and harassing Archuleta supporters while they were voting," said one person who did not want to be identified for fear of retribution, "extremely rude and intimidating."

Two people said they were asked who they were voting for as they entered the parking lot, if they said Archuleta, they were told to park down the street.

In addition, Garcia was accused of

cheating at the election. Candidates were told they would not see the ballot, yet one Archuleta candidate sent a picture of a document that Garcia's people were handing out prior to the election.

The Garcia document was identical to the delegate ballot.

But it is the alleged behavior of Garcia herself that might catch the attention of Speaker Rendon and the Assembly Rules Committee.

Sources said that Garcia texted Archuleta's candidates, including Bell Gardens Mayor pro tem Lisseth Flores, berating them for running on Archuleta's slate.

Apparently Garcia's bullying and intimidation worked, with the source stating that after the texts, "Flores disappeared, she did not attend any candidate meetings after the call."

Out of the candidates that ran, eleven of Garcia's candidate won, with Archuleta candidates taking four spots.

But one of the coveted Executive Board seats, also known as the "E-Board," went to Archuleta candidate Artesia Councilman Ali Taj, who garnered 277 votes, the most among all candidates.

Coming in second was Garcia candidate Artesia Mayor pro tem Miguel Canales with 267 votes.

Garcia candidate Blanca Pacheco had 252 votes and took her seat on the E-Board as the top female vote-getter.

Commerce Councilman Ivan Altamirano, former Artesia Councilman Victor Manalo, and Montebello City Clerk Irma Barajas rounded out the Archuleta winning candidates.

Other Garcia winning candidates were Tonia McMillian, Jason Stinnett, Melissa Bahmanpour, Matthew Scammahorn, Martha Estrada, Martha Camacho-Rodriguez, Carlos Avalos, Mary Ann Tipton.

One local elected official who did not want to be identified was livid at Garcia's actions, "very vulgar and impolite bullies. The election was a reflection of Garcia's leadership style, she bullies and intimidates people so her minions naturally do the same thing. Look, she had Jason Stinnette as one of her delegates, no wonder no one likes to deal with her in Sacramento."

Mike Simpfenderfer who ran against Garcia in the November 2018 election did not mince words, "the Garcia drama continues. Former Garcia staffer Danny Fierro has endured her nonsense bullying we saw again Saturday. The first Assembly investigation documented the abusive, offensive, drunken language that is all too familiar. She's threatened to disclose the names of men from the Assembly she was having sex with to get her way. The second Assembly investigation verified the continued drunken behaviors and the fact she was overly familiar with Danny Fierro's body. One can only commend Sen. Archuleta's leadership to nominate responsible delegates who reflect responsible values and behaviors."


