



Exclusive: Search Warrant Shows Sup. Kuehl, Mayor Garcetti Deputy Under Investigation

News outlets ignored HMG-CN's first exclusive story, the search warrant corroborates the original story.

Just months ago, Hews Media Group-Community News exclusively reported that Los Angeles County Sheriffs Detectives issued search warrants and searched the headquarters of LA Metro and the offices of a nonprofit run by a civilian oversight commissioner critical of Alex Villanueva and his leadership. The nonprofit, Peace Over Violence, which operates Metro’s “Off-Limits” sexual-harassment counseling hotline was the subject of the search, but HMG-CN

also reported that other high-level executives at Metro were the subject of the warrant and searches but officials from both organizations would not comment further and the sheriff’s would not comment on the contents of the search warrant. And, as usual, major news media outlets ignored HMG-CN's story. Now, corroborating the story, HMG-CN has obtained the search warrant, issued March 1, 2021, which indicates law enforcement officials believe multiple felonies were committed. The search warrant stated that, “there is probable cause to believe that the property described [below] may be found at the location [below] and that it was used to commit felonies. “[The property] is possessed

MLS Players From Pico Rivera Are Paying it Forward With Soccer Field in City

Cristian Roldan was named the 2013 Gatorade National Player of the Year in soccer while attending El Rancho High School in Pico Rivera. Roldan spent his college career at the University of Washington, in his two seasons with the Huskies, Roldan made a total of 41 appearances and

tallied 10 goals and seven assists and helped lead the team to a Pac-12 title in 2013. His brother Alex also attended El Rancho, helping the Dons into the playoffs all four years and winning a state championship. With his time with the Dons, he earned first-team all-league three times, and was named league MVP in after his senior season. Alex, like his brother, spent his college career in Washington state at Seattle University. In his four seasons with the Redhawks, Roldan made a total of 82 appearances and tallied 18 goals and 17 assists. Both Cristian and Alex now play for the Seattle Sounders FC in Major League Soccer as midfielders and both are now paying it forward in Pico Rivera. In early 2021, the city contacted the Roldan family, arranged a meeting with Mayor Raul Elias, Councilmember Lutz, Parks and Recreation Commissioner McEachren, and City staff to bring a 5-on-5 mini-soccer field to Pico Rivera in partnership with the U.S. Soccer Foundation and Musco Lighting. Mini-soccer fields are

Document COVID Stories With the Historical Society of Long Beach

By spring of 2021, CoVID-19 had invaded every country on this planet. It brought death, social disruption and disturbance. The exact numbers continue to be unclear, with over 175 million people infected worldwide and more than three million deaths attributed to the virus. Southern California experienced the full impact of this pandemic. This is not the first time that the City of Long Beach experienced dramatic events due to a pandemic. The Great Pandemic of 1918-1921, known as the Spanish Flu, struck the world in the after math of World War I, infecting millions in the span of a year. Three waves of this flu struck the world with an estimated 50 to 100 million people thought to have died, representing as much as five percent of the world’s population. Long Beach recorded 93 cases, including 49 children January 1919. City leaders suspended all public meetings, sending police officers into stores and markets to encourage patrons to ‘keep moving’. “Hard won experience from this latest virus,

I kept my head down and walked away. Then he started yelling a lot of

profanity. He told me, ‘You don’t belong here and go back to your country.’” The couple attempted to ignore the guy and continued their walk. As they reached their vehicle the same man who had verbally assaulted them, yanked open the passenger side door and began beating Echano. Hawaiian Gardens City Councilwoman Myra Maravilla said, “We want to send a message that any hate toward anyone is not acceptable. We are here to extend our hand in friendship and assistance to Mr. Echano and his wife to stop senseless violence.” Many local elected officials attended including State Senator Bob Archuleta, Maravilla, Yokoyama, Aresia Mayor Rene Trevino, Artesia Mayor pro tem Melissa Ramoso; former Cerritos Mayor Mark Pulido; See AAPI EVENT page 8

Hawaiian Gardens WWII Veteran Turns 100



STATE SENATOR Bob Archuleta, himself a veteran, congratulates Paulo Martinez on his 100th birthday. Born in 1921, Martinez graduated from Poly High School in 1940. Waiting for his draft summons, he went to work for Consolidated Ship Building, a company that launched Liberty cargo ships that supplied the military in the Pacific. Martinez entered active service in 1942 and was assigned to radio operator school in Missouri, where he eventually taught Morse Code and used the old fashioned telegraph key. Martinez was sent to Fort Monmouth, New Jersey to become a high-speed radio operator and became a T- 5 Corporal, assigned to the Signal Air Warning Battalion in Tampa. Later he was sent overseas to Dutch New Guinea and later to Luzon in the Philippines until the end of the war. Martinez was honorably discharged January 16, 1946.

This week marked a significant milestone for our community and our country as we reopened our City Council Chambers to full capacity after 15 months of closure.

Before our reopening, we wanted to remember the 301 residents we lost during the pandemic. A small ceremony was held outside of City Hall. As we celebrate the reopening of our state and the return to all the activities missed, I am encouraged

by the latest figures released by the Los Angeles County Department of Public Health. The vaccination rate for Downey residents 16 years of age and older is now 66.2%; adults 65 years of age and older, it is 87.8%. Downey is surpassing L.A. County vaccination rates.

On another note, the City of Downey is celebrating 65 years since its incorporation as a city in 1956. Strong cities don't just happen. It was the commitment of outstanding leaders to reinvent Downey from an aerospace community to a Biomedical hub with a thriving business sector that led to what Downey is today, an inspirational city. We continue to be a leader in Southeast L.A. County.

Our city has the highest number of churches per square mile, close to 30 non-profit clubs and organizations, and 220 neighborhood watch groups. The residents of this city are committed to a strong Downey.

Through this app, you will be able to immediately report illegally dumped items, street repairs, trash, graffiti removal or needed neighborhood light repairs.

HMG-CN OP/ED LA County's Bizarre Peacock Problem

Every resident of Los Angeles County has their own ideas about what would make it a better place to live.

Some people want to see more police on the streets in the hope that an enhanced presence would reduce crime levels.

Better schools is a common request, as is better availability of high-quality healthcare.

From public transport to more welfare, the problems and requests you'd usually hear from most people who live in the county are the same as you'd hear from citizens anywhere else in America.

That's not the case at the moment, though. Go out into the streets with a clipboard today, and you'll find dozens of people asking the authorities to do something about all the peacocks.

We should point out that not everybody hates peacocks.

So long as they don't attack you or otherwise inconvenience you, they're beautiful creatures to look at. Peacocks are often popular birds to go and see in the zoo or another animal enclosure because of their colorful tail feathers and the way they're so proud to display them.

That's where the saying "proud as a peacock" comes from. The attractiveness of peacocks is the reason that NBCUniversal uses a peacock logo.

The sight of peacocks in the streets of LA County isn't new. It's a little odd that they're there - and you don't tend to realize how odd it is until you leave the area and explain it to someone who's never lived here - but the birds have been stalking the sidewalks for a century now.

During that time, they've become a little "streetwise." Much like pigeons in London's famous Trafalgar Square because they've learned that humans might be interested in feeding them, peacocks have come to expect food from

their human neighbors.

If they don't get it, they have an unpleasant tendency to start shrieking in an ear-piercing register. If that doesn't get them anywhere, they might even turn violent.

It's increasingly common for LA County residents to return to their cars and find them damaged, but what at first looks to be the work of a vandal turns out to be the work of an angry peacock.

This, among other reasons, is why the area's officials have finally had enough.

They want residents to stop feeding the birds - and they're considering making doing so an offence.

On June 9th, the Los Angeles County Board of Supervisors gave its unanimous approval to a motion for drafting an ordinance to implement a ban.

That means the ordinance hasn't been written yet, and the ban isn't in place, but it's almost certainly coming.

To put the matter simply, they think the peacock issue has gone too far.

The birds were a charming curiosity when they were first introduced to the area by the eccentric entrepreneur Lucky Baldwin in the late 1800s, but they've fed and bred since then.

Nobody knows quite how many of them there are now, but it's thought to be several hundred. It might even be more than a thousand.

When they're not shrieking at people and damaging cars, they're attacking gardens and, in some cases, household pets.

Even when they mind their own business, the droppings they leave behind are an annoyance for local business owners to clean up every morning.

The next step for the LA County Board of Supervisors is to receive a report from the LA County Department of Animal Care and Control.

That should happen within ninety days, after which the ordinance will be written, and a ban will almost surely be put in place.

The consequences for violating the order may potentially be severe. If someone is caught feeding the peacocks,

they could be fined one thousand dollars even for a first offense.

For repeat offenders, punishments might escalate up to a maximum of six months in jail.

Residents of Arcadia have flouted informal bans and prohibitions on feeding the peacocks before and have become accustomed to defying authorities on the matter.

Whether or not they're still willing to do so when the risks are so high remains to be seen.

While many residents will welcome the fact that the Board of Supervisors is taking action, the consequences of that action are uncertain.

Withdrawing food from the peacocks when they've spent so many generations becoming accustomed to it might turn out to be counterproductive.

They might become angrier, which would lead to even more damage and incidents of them attacking people. It also doesn't do away with the peacocks.

If they're not handed food, they'll find it by scavenging. That's a nuisance for local businesses when they throw out the daily trash.

The authorities haven't countenanced the idea of physically removing the peacocks - a process that's likely to be extremely difficult - so they're still going to be on the streets whether they're being fed or not.

The Board also doesn't approve of citizens taking matters into their own hands by shooting or poisoning the birds, which has been known to happen on occasion.

Even with a ban, there will be peacocks on the streets of LA County. It's just that the peacocks will be hungrier than they have been in the past.

We know that many of our readers love the peacocks and enjoy feeding them, so if you can't bear the idea of not being allowed to do so anymore, this is your opportunity to have your voice heard. Get in touch with your local authorities to register your opinion as soon as you can. Once the ninety days are up, it's unlikely that any minds will be changed.

In March of 2020, La Palma-Cerritos Branch of the American Association of University Women (AAUW) chose four middle school girls to attend Tech Trek, a one- week Science, Technology, Engineering and Math (STEM) camp sponsored by AAUW California at Whittier College in the summer of 2020.

The girls were nominated by a science or math teacher, have a 3.0 GPA or higher, an interest in math and/or science, interviewed by the branch’s Tech Trek Committee. However, Covid-19 shut it down.

Recently, four girls who were chosen by the AAUW to attend: Janelle Vargas of Fedde MS and Julianna Castellon of Haskell MS in ABCUSD, and Sophia Chicas and Sidney Lumsdaine of Walker Junior High in Anaheim UHSD.

The week-long virtual camp will be centered on a morning project-based robotics/engineering/coding class that will meet daily. It will result in a personalized creative project by the end of the week. After a lunch break, campers will hear from inspirational women speakers in the STEM field for one hour. Following the speakers’ one- hour presentations, the girls will participate in a required 90-minute workshop, and an optional 90-minute hands-on or interactive STEM workshop.

The required sessions will provide the girls with opportunities to explore the fun properties of water, build a spectrophotometer to explore lights and waves, design and build a wind turbine to raise money literally, in the air, and discover dimensions they never knew they had. There also will be optional evening sessions.

Discovery Cube now open for safe hands-on lifelong scientific learning

Forward-thinking initiatives inspire educators, students, and all committed to lifelong learning at the Discovery Cube children’s science museums in Sylmar and Santa Ana.

For more than 35 years, they have offered Southern California’s families and kids’ hands-on scientific education through four core initiatives including STEM proficiency, early childhood education, healthy living, and environmental stewardship.

“We are really excited about our newest exhibits that debuted for the first-time last month, like Festivals of STEM, at Discovery Cube Los Angeles,” said V.P. of Marketing Erin Warady, who has been with them since 2020. “Sponsored by the Chevron Corporation, Festival of STEM features five STEM-themed areas and 10+ hands-on activities and adventures highlighting the invention and inspiration of STEM-based innovators and industries.”

At the height of the pandemic in spring 2020, they launched the Discovery Cube Connect, an interactive web-based STEM platform which connects parents, educators and students with hands-on STEM activities and resources.

“All content on the Discovery Cube Connect site has been rated and reviewed by parents and educators, available free of charge for young learners at home or in the classroom,” Warady added.

During the pandemic, both museums in Los Angeles and Orange County have undergone extensive renovations including new health and safety measures plus adoption of COVID-safe guidelines and protocols, according to Warady.

“Each campus location

has several new 'safe science' installations including a MERV13 HVAC filtration system with UV lights, hands-free restrooms, onsite cleaning crews, contactless ticketing system and upgrades to the paint, carpet and much more,” she said. “Both museum locations underwent extensive interior and exterior renovations, totaling more than \$10 million, which were unveiled during our reopening in May 2021. Part of reopening highlights include several new, state-of-the-art STEM exhibits, immersive science adventures and interactive gameplay for kids K-6 grade.”

The Orange County campus has four new STEM-themed areas with more than 15 new interactive exhibits while Los Angeles debuted five new themed areas and 10+ new interactive exhibits. Both locations also feature many of the STEM favorites as before including, Inspector Training Course, Early Learners, Planetary Research Station and more, according to Warady.

Popular exhibits in Santa Ana’s location include the Physics Lab which features hands on wooden race cars on a track, the Science of Hockey Lab which explores what it’s scientifically like to be on ice, the Organic’s Waste Lab (OWL) which demonstrates the environmentally conscious usefulness of compost for plant growth, the Dino Quest exhibit with life-sized outdoor dinosaur and skeleton models for up close explorations, and the Early Learner’s exhibit which allows young children hands on exploration activities such as rock climbing and telescope viewing.

Upcoming events at Discovery Cube in Santa Ana include Camp Discovery, running

from June 28 to August 6 from 9 a.m. to 3 p.m., offered both in person and virtually this year. At this camp, kids learn about animals, dinosaurs, outer space, and all things STEAM (science, technology, engineering, art, and math). Back by popular demand is the Code Constructors Camp, a full-week virtual camp which demonstrates what it is like to learn code and be a programmer. Also, a family-friendly event offered is The Mega Bubblefest and Laser Show held July 2 at 10 a.m. to July 18 at 5 p.m., at the Santa Ana location.

Something unique the Discovery Cube is offering families and groups are onsite sleepovers which includes access to exhibits, interactive activities, 3D movie, snack, and continental breakfast with complimentary access to the Cube the following day.

Science is also brought to life through field trips or offered on location in classrooms at schools throughout Southern California through the Discovery Cube’s educational outreach programs, which offer scientific problem-solving and exploratory learning opportunities. Their unique Environmental Program, in partnership with Orange County Waste and Recycling, offers a free on school site assembly for 5th and 6th graders, educating on the importance of going “Green.”

by a person with the intent to use it as a means of committing a public offense or is possessed by another to whom he or she may have delivered it for the purpose of concealing it or preventing it's discovery.”

“[The property] tends to show that a felony has been committed or that a particular person has committed a felony.”

The warrant gave five days to gather the requested records under eight categories, indicating a wide-ranging investigation involving POV, L.A. County and City Elected officials, and executives at Metro, including the recently departed CEO Phil Washington.

The warrant demanded any and all contracts between Peace Over Violence and the Board of Supervisors and more significantly:

Any and all contracts concerning POV and any organization under the control of the county and or the Board of Supervisors including Metro;

An exhaustive list of call log categories from POV’s Off-Limits hotline;

Any written or digital communications between POV and Metro;

Internal [Metro] evaluations or audits concerning the Off-Limits hotline;

Alex Wiggins’ personnel file, Wiggins is the former Chief of Security Systems and Law Enforcement for Metro.

An all-inclusive item asking for any reports, forms, documents, notes, photographs, written and digital communications of any internal investigation conducted by Metro involving POV;

Any and all communication between the following persons:

Phil Washington, who is now the CEO nominee of the Denver Airport, and was

the subject of an article by the Denver Post where the Mayor of Denver, Michael Hancock, is on the record saying Washington was not a named in the warrant.

Alex Wiggins, former Chief of Security Systems and Law Enforcement for Metro and Imelda Hernandez, Manager of Transportation Planning who worked under Wiggins.

The document also show Metro’s law firm, Kendall Brill and Kelly, LLP attempting to quash the warrant several times in LA Superior court.

Artesia Councilwoman Monica Manalo, former Artesia Mayor Dr. Victor Manalo; Buena Park Mayor pro tem Sunny Park; Cypress Councilwoman Frances Marquez; Advocate for Asian Americans Joann Fields, and Advocate Neil Estrada.

Estrada was among several community members who gathered and mobilized the Solidarity Walk. “I grew up in Cerritos,” said Estrada, a businessman who now lives in Orange County. "My parents used to take that walk daily. To see that one of our own got hurt in a city with a large Asian American and Pacific Islander population, it's a shock. This is a rallying cry.”

Stop AAPI Hate is a coalition aimed at addressing anti-Asian racism across the U.S. Founded by A3PCON, Chinese for Affirmative Action, and the SFSU Asian American Studies Department.

Marquez added, "Our Asian American Pacific Islander communities are experiencing increased incidences of discrimination and racially motivated violence across the country and in Orange County. It is on all of us to take action and stand in solidarity with our AAPI

neighbors.”

Senator Archuleta called Echano the face of bravery and honor, unity, and family “We need to take the steps forward to say this is not right. We have joined with all the cities, one million people in the 32nd Senate District, is getting the message that we will not stand for this type of violence. We are a melting pot. We are the Fighting 32nd. We will not allow anyone to be mistreated. Communities are standing in solidarity.”

designed to be an all-in-one solution to help communities create fun and active play spaces in an effort to revitalize public areas.

The proposed mini-soccer courts come complete with lighting, fencing, goals, benches, lockable storage and American with Disabilities compliant access.

The fields are small, customized hard-court spaces perfectly suited for organized soccer programs and public pick-up games.

The site has yet to be chosen but once selected the fields can be completed in two days.

Once completed, the City can host youth development programs offered through the U.S. Soccer Foundation, with the fields open to the public for year-round use.

The City reviewed several areas where a mini-soccer field, or fields, could be built, including Smith Park’s skate park area, an empty Southern California Edison easement lot, or the old basketball court area behind the Pico Park facility.

The areas were presented to the Parks and Recreation Commission for review

at their regular meeting on June 11, 2021 where they voted to recommend the installation of the mini-soccer field(s) at the Pico Park site.

The total project cost is estimated at \$220,000 with the funds coming from a one-time cost savings from the ‘20-‘21 budget

has health officials reinforcing the ideas that the nation must always be ready for such sudden and dramatic emergencies,” wrote the Historical Society of Long Beach [HSLB].

So the HSLB decided it was important to collect stories from those who lived and worked in Southern California to share their stories for a permanent archive. “We want to capture people’s stories in their own words. We encourage residents to process and reflect on the situation and to share their experiences in their own voice,” added a HSLB representative.

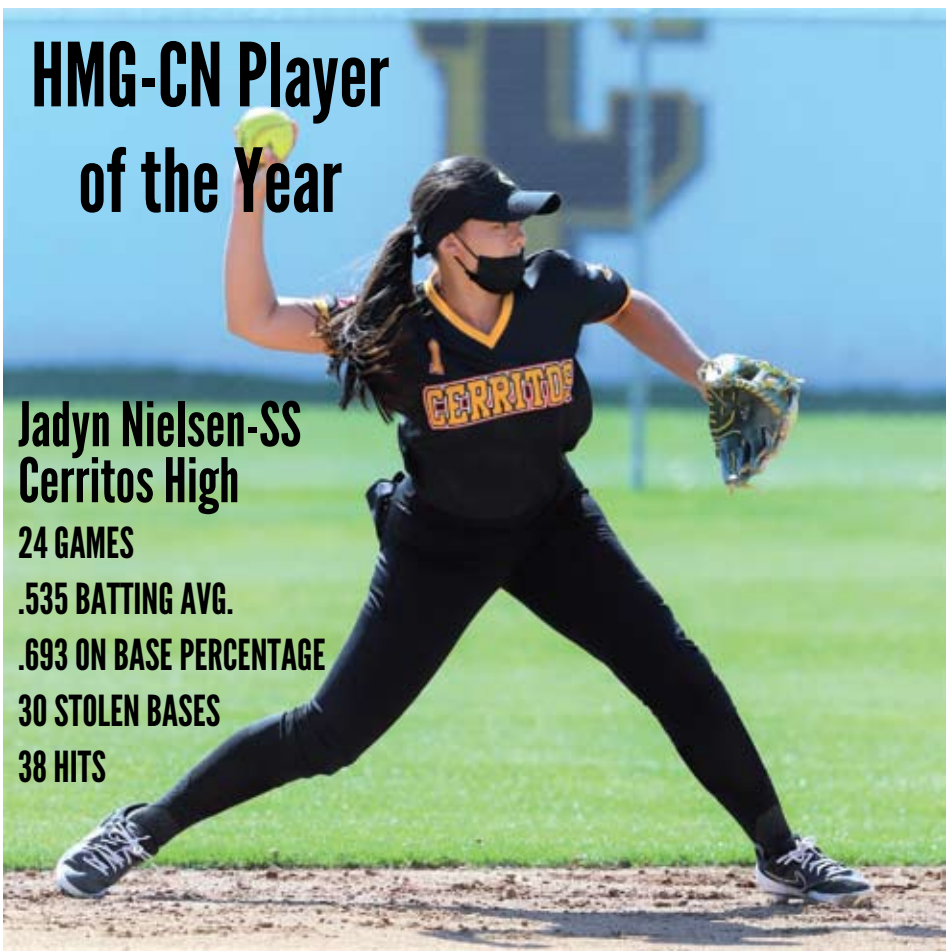

Bats Go Silent For Artesia Punishers 16-Under Squad, Endure Another Two and Out Tournament

ANAHEIM-After winning one of five games in the Triple Crown Sports Zoom into June Tournament the previous weekend, the Artesia Punishers 16-Under travel softball team was looking to rebound in last weekend’s Premier Girls Fastpitch Southern California Qualifier. But just like the Zoom into June games, the Punishers found a hard time with their bats, and their own defense, and lost both games played in the double elimination tournament at Yorba Linda Park.

The Punishers were slammed by the (Anaheim) Orange County Batbusters-Lara/Portesi 10-0 last Friday afternoon, then were bounced out of the tournament by the (Moreno Valley) Athletics Mercado-Carroll 2K5 6-1 the next morning.

This was the final chance the Punishers had to earn a berth in the PGF National Championships next month.

“To be honest, I don’t even think they were in it today,” said Artesia Punishers head coach Leo Amaya on the game against the Batbusters. “I have no...I have nothing to say about it. I’m stuck.”

In the top of the first inning, starting pitcher Mia Mastan (Peninsula High) walked Kiara Cisneros, who then stole second on the next pitch, to begin the game. Brielle Norman-din would reach on the first of five errors, allowing Cisneros to score. The Punishers avoided further damage when Mastan struck out Casey Fazzini on three pitches, then got Willa Poplawski to fly out to center fielder Nathaly Ochoa (Bellflower High), who immediately fired the ball back to second baseman Autumn Herbig (Kennedy High) for an inning-ending double play.

Unfortunately, the Punishers couldn’t feed off the momentum as they wasted a one-out Herbig single in the bottom of the first, then yielded three unearned runs in the second inning, all with two outs. The fielding woes continued in the third when Liana Gonzalez was hit by a pitch, stole second, went to third on an error and made it 5-0 on a two-out base hit from Madison Estep.

“It was felt from the first inning all the way to the last inning,” Amaya said. “We were just making error after error after error. There’s no sugarcoating it or nothing, it was just straight from the first inning.”

Any chances of the Punishers possibly getting back in the game were crushed in the fifth when the Batbusters

batted around and added five more runs to their tally on four hits, one walk and one hit batter. Meanwhile, Ashley Dean retired seven straight following the Herbig hit until Ochoa singled in the third. But she would get caught stealing. After that, Dean would walk Mastan with

one out in the fourth and allow shortstop Anaiyah Yniguez (Bellflower High) to reach on a fielder’s choice.

Following the game, Amaya tried to give his team some encouraging words, even though the Punishers would have had to win four games last Saturday in the loser’s bracket and two games to garner a berth in the Platinum Division of the PGF National Championships, three to make it to the Premier Division.

“I just told them to attack this one inning at a time,” Amaya said. “One inning at a time is gold; just try to get on base. Like I said last [week], just pass the bat. This time it just wasn’t happening.”

Against the Athletics Mercado, the

first seven batters were retired by Jan-essa Santos before right fielder Bryanna Solache (Bellflower High) and pitcher Giselle Peralta (El Monte High) each singled. But that that scoring threat was squandered and the Athletics would take advantage by scoring three times in the bottom of the second, then two more in the fourth and the last run in the fifth.

“Overall, in [the second game], the girls did really good, to be honest,” Amaya said. “They just made one error and they were catching the balls where we were hitting the ball and [they] were hitting the ball in the gaps where nobody was. It was actually a really good game; our girls did really good.”

The Punishers thought they had something going in the top of the fourth when Herbig reached and advanced to third on a one-out single from Mastan. But back to back strikeouts ended that opportunity. They avoided the shutout in the next inning when Solache led off with a walk and eventually scored when left fielder Madison Morgan was safe on a one-out error. The Punishers would be limited to two base hits and had seven base runners.

The next major tournament the team will participate in will be the USA Softball Tournament of Champions, which begins on July 8. The Punishers will be one of 42 teams in the 16-Under age group and will play a pair of pool play games on July 8, one on July 9 and two more on July 10. The single elimination playoffs will kick off on July 11 with the tournament ending on July 12. The Champions Cup is regarded as another major college showcase tournament.

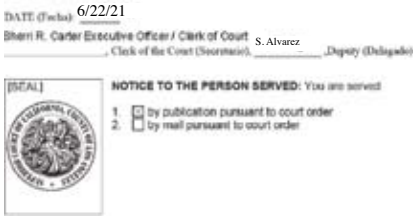
