Billboard in Pico Rivera Honors Slain Cows

A billboard was erected in Pico Rivera near the slaughterhouse where 41 cows escaped June 22.

38 were captured, one was fatally shot by a sheriff's deputy, and two were rescued.

The outdoor advertisement read "Remember The Pico and is located on the corner of Beverly Boulevard and Di Maria Road, near the Manning Beef

The Animal Alliance Network, the nonprofit organization that came up with the idea and secured the billboard.

Other animal welfare and vegan organizations joined Animal Alliance including Peace 4 Animals and World Animal News, which helped design and sponsor the ad.

Featured on the right of the billboard is June B. Free, one of the surviving cows who escaped and is now at the Farm Sanctu-

The other was named Susan. Both names were chosen in honor of Farm Sanctuary

'GAME CHANGER'

California Budget **Eliminates 'Asset Test' for Medi-Cal** and Medicare

A provision in California's newly approved state budget will eliminate the asset test for the 2 million Californians enrolled in both Medi-Cal and Medicare, the federal health insurance program for people 65 and older and people under 65 with certain

Instead, their financial eligibility will be based solely on income, as it is for the millions of other people in Medi-Cal.

The elimination of the test will be a game changer for aging or impaired Californians who need long-term care but are caught in a common conundrum: They don't earn enough to cover the high costs of ongoing nursing home care and can't rely on Medicare, which does not cover extended nursing home stays. They can get that care through

Rep. Sánchez Requests \$10M for Local **City Projects and Organizations**

Representative Linda Sánchez is working to secure nearly \$10 million dollars for local cities and organizations, including 2 million for tiny La Palma to repair their street medians. The

money is coming from the 2022 Subcommittee on Labor, Health and Human Ser-Educavices, tion, and Related Agencies bill.

A \$475,000 request made for better accessibility and lighting at the city of La Mirada's ten-acre Neff Park. The funding would be used to replace deteriorated asphalt walkways with concrete, place new concrete walkways to enhance accessibility to all areas, improve lighting throughout the park, and extend wood rail fencing around

the perimeter of the park. These improvements would improve public safety at the park and help meet requirements under the Americans with Disabilities Act (ADA). The park includes three historic buildings, a gazebo, a basketball and tennis court,

> horseshoe pits, a newly renovated playground, and picnic areas. In addition, the park hosts community events.

> Sánchez requested \$2 million to rehab La Palma's arterial

street medians; a redesign that will address California's ongoing drought and water restrictions. The project includes the removal of existing landscaping/ irrigation, hardscape removals and replacement, installation of a new drip irrigation system, plant-

Bellflower Moving Forward on Economic Development

The northeast corner of Bellflower Boulevard and Cedar Street is buzzing with construction activity as Belle Fleur Centre begins to take shape on the 1.5acre site.

Look for the opening of a Starbucks in late summer/ early fall. The Orchard at Belle Fleur Centre will follow, a multitenant food, court a few months later in early 2022.

Former Alpha Beta Supermarket and retail buildings have been demolished at 10129 Artesia Boulevard, just west of Woodruff Avenue and south of the 91 freeway.

The 2.8 acre blank canvas is now ready for new development.

Bellflower is looking for local "makers." As the retail landscape continues to change and evolve, the economic vitality of main streets and downtown districts throughout the nation continues to be challenged.

Looking to add another tool to the economic development toolbox, the City hired Ilana Preuss of Recast City to look at Downtown Bellflower and recommend how City leaders could incorporate "Small Scale Manufacturing" into the

Get to know "Bellflower Made." Like many small-town downtown districts, Downtown Bellflower has seen its fair share of ups and downs over the decades. In the past ten years, huge strides have been made to encourage new development, add rooftops, and improve the pedestrian environment.

As traditional retail continues to struggle, the City is making a concerted

effort to find additional ways to maintain its recent positive momentum. Small Scale Manufacturing is part of this effort, and this is just the beginning.

To foster this group of businesses, the City is reviewing its zoning to make it easier for Makers to locate Downtown; seeking training resources for entrepreneurs and microbusinesses; and stepping up the promotion and branding of Downtown Bellflower.

The City unveiled a second mural completed by muralist Dave Can Patten in Town Center Plaza located in Downtown Bellflower.

This colorful tower displays illustrative characters in his signature style, which highlights the neighboring businesses.

Van Patten's whimsical style will be featured in a third mural set for late 2021.

The Nest Tambien adds an excellent new flavor to Downtown Bellflower. The Nest Tambien, a second restaurant for owner Antonio Appling following the success of The Nest: A Breakfast Joint, celebrated its official Grand Opening this month. Be sure to visit the newest brunch spot on Bellflower Boulevard.

The City is happy to see The Stand Up Comedy Club's recent soft opening events. It's the newest late-night entertainment spot to open in Downtown, which offers craft drinks, barbecue favorites and a variety of headlining comics. Cerritos Receives \$6.2 Million Check

Congresswoman Linda T. Sánchez (D-Lakewood) delivered a check in the amount of \$6.2 million to Cerritos last Friday as part of the funding the City received through the Coronavirus State and Local Fiscal Recovery Fund established by the American Rescue Plan.

The American Rescue Plan was passed by Congress and signed into law by President Joe Biden in March and delivered more than \$43 billion in relief to local and state governments in California to help speed up the country's recovery from the economic and health effects of the COVID-19 pandemic.

"The City of Cerritos is grateful to the federal government for these relief funds and to Congresswoman Sánchez for her ongoing work for our community," remarked Cerritos Mayor Grace Hu. "These monies will be used for our ongoing efforts to support COVID-19 response efforts and to continue to provide our residents and businesses with excellent services well into the future."

"This pandemic hit our communities hard," said Congresswoman Sánchez. "As we mourn the loss of over 63,000 lives here in California alone, it is critical we deliver relief directly to working families, small businesses and local governments so they can continue working to get us back on track. I am glad to be here in Cerritos to highlight over 6 million dollars the City received through this relief package."

West Nile Virus Confirmed in Los Angeles County

Confirmed in Bellflower, Studio City and Tarzana.

The Greater Los Angeles County Vector Control District (GLACVCD) has confirmed West Nile virus (WNV) positive mosquito samples in Los Angeles County.

The positive mosquito samples were collected from mosquito traps in Bellflower (90706), Studio City (91602), and Tarzana (91356). The District is currently still awaiting results for additional samples.

While this confirmation serves as the District's first positive West Nile virus mosquito pool this year, virus activity has been increasing steadily throughout California, including other vector control jurisdictions within the County. Additionally, the District submitted a dead bird located in Valley Village which has been confirmed positive for WNV.

"West Nile virus is detected every summer by local public health agencies because it is endemic to Los Angeles County," said Susanne Kluh, director of Scientific-Technical Services at GLACVCD. "This virus is spread through our bird population and transmitted to humans with the bite of an infected mosquito."

Because there is no human vaccine for West Nile Virus, residents must be proactive against mosquito bites by wearing insect repellent. Many mosquito repellents are available to prevent bites, but they do not all work equally well. The Centers for Disease Control and Prevention recommend products with the active ingredients DEET, Picaridin, IR3535, or oil of lemon eucalyptus as being safe and effective against mosquitoes that can transmit disease when used according to the labels.

"Our agency will continue monitoring disease activity and keep residents informed so they can protect themselves form mosquito bites during dusk and dawn.," said Anais Medina Diaz, public information officer for GLACVCD. "But it is very important to remember that at this time the virus could be anywhere, even though we may not have detected it yet."

One in five persons infected with the virus will exhibit symptoms. Symptoms can include fever, headache, body aches, nausea, or a skin rash. These symptoms can last for several days to months. One in 150 people infected with the virus will require hospitalization. Severe symptoms include high fever, muscle weakness, neck stiffness, coma, paralysis, and possibly death. If residents feel they are experiencing symptoms, it is strongly recommended to consult their primary care physician.

Mosquito control is a shared responsibility and residents must take a role in reducing the threat of WNV in their neighborhoods by taking these additional steps:

Eliminate standing water in clogged rain gutters, rain barrels, discarded tires, buckets, watering troughs or anything that holds water for more than a week.

Ensure that swimming pools, spas, and ponds are properly maintained. Change the water in pet dishes, bird baths and other small containers weekly. Request mosquitofish from your local vector control district for placement in ornamental ponds.

Wear EPA-recommended insect repellent when outdoors where mosquitoes may be present. Report neglected (green) swimming pools in your neighborhood to your vector control district.

'Seniors Fighting Back' - Teaching Older Adults Self-Defense Skills

In light of the recent attack on Cesar Echano, a 70-year-old Filipino-American, and his wife who were verbally and physically assaulted during an outing at a local Cerritos park, Supervisor Janice Hahn is offering free Seniors Fight Back [SFB] classes.

Empowering older adults and the community through self-defense classes, the Seniors Fight Back team will hold the Cerritos edition of self-defense classes.

Last month, Echano and his wife, Ruth, walked along a trail at Don Knabe Community Regional Park, a weekly exercise they've done for years. Suddenly, a man approached and began verbally harassing

"I don't know why but he confronted us," Echano said. "He was laughing and asking me why I was looking at him. I kept my head down and walked away. Then he started yelling a lot of profanity."

The creation of SFB grew out of the fear that some of the older adults in communities have been feeling. The class is lead by Ron Scolesdang, a professional

MMA fighter; the course will include noninvasive and invasive segments.

The mission is to teach older adults to have the awareness to avoid a potential physical or life-threatening situation while also preparing older adults with practiced physical strike maneuvers to reduce the severity of an attack.


All moves are for people who have no prior fighting or martial arts experience. There will be assistant instructors that will aid with practice moves.

On Saturday July 31, 2021, there will be three self-defense classes for older adults; the first class beginning at 9:00 am with two more at 10:00 am and 11:00 am at Don Knabe Community Regional Park.

"The world is a broken place, and it is unfortunate the horrors that our elders experience," said a Hahn representative, "we hope our participants leave the event feeling empowered and find comfort that there are people looking out for them."

Seniors Fight Back (SFB) was founded in April 2021 in Southern California by individuals that wanted to help the AAPI community amid rising anti-Asian hate crimes, particularly against the elderly.

Downey Space Center Reopens

The Columbia Memorial Space Center welcomed its first guests in over a year, Friday, July 9.

CMSC closed its doors over a year ago, as did museums across the Southland.

The Center reported that 85,000 people participated in over 600 online or virtual programs.

"The mission of the Columbia Memorial Space Center is to ignite a community of creative and critical thinkers," Executive Director Benjamin Dickow in his report to the City Council, "Making access to the Space Center as easy as possible to all members of the community helps to fulfill that mission."

The standard \$5 entrance fee was waived on their opening weekend. "The public may have been disconnected from the Space Center facility after it has been closed for such a long time, "stated Dickow. The waiver also included the senior discount, and children under three were free. Students and teachers were also free under past admissions policies.

The council approved the fee waiver at the first council meeting to be opened to the public on June 22.

New exhibits include a virtual display dedicated to the 40th anniversary of the Columbia Space Shuttle. The Columbia Shuttle made 27 missions to space. It exploded on February 1, 2003, upon reentry to the Earth's atmosphere, killing its ninemember crew. "We have changed up our floors a bit," said Center Supervisor Sarah Medina, "We will have several make-andtake activities such as paper airplane and capsule building as well as a fun stomp rocket activity."

The Challenger Learning Center is currently closed, but the Center will be offering group Challenger virtual experiences

"We will be moving to in-person programming slowly," stated Medina, "We have an early childhood program that is filled for the summer, and that will be held in-person, although many of programs will remain virtual."

Constructed in 2009, the two-story fa-






cility is part of the former National Aeronautics and Space Administration site. Companies such as North American Rockwell and Boeing designed and built spacecraft during the 1960s and 70s.

The free admission status will result in an \$11,000 income loss, based on figures from 2019. But some of that should be recouped from the sale of items from the gift store and new programs. The Space Center continues to pursue grant funding through its nonprofit foundation.

CENTRAL BASIN WATER CLOSES YEAR ON A HIGH NOTE

COMMERCE, CA ~ The Central Basin Municipal Water District (CB) ended its fiscal year on a positive note with a position of strong fiscal stability, a reorganization that has yielded a significant reduction of operating expenses of \$1.8 million and improved customer satisfaction.

A significant achievement given the District's previous governance, operational and fiscal challenges, and attacks by Assemblywoman Cristina Garcia (D-Bell) and Assembly Speaker Anthony Rendon (D-Lakewood), along with Rendon's Assembly Attorney Alf Brandt, to take over the agency under dubious reasons.

The actions of the three were preceded by corrupt Finance Director Andrew Hamilton, who, among other questionable maneuvers, called CB's bond rating service to inform the Moody's contact that CB was in terrible financial trouble.

The communications resulted in a downgrade of CB.

In addition, after years of dysfuction, some caused by Asm. Garcia's bill that added directors to the board, others by the corrupt actions of former disgraced GM Kevin Hunt, the District's Board of Directors has coalesced around their vision of an improved and efficient agency, working together to support the new direction of the District.

"The District's Board is very pleased

at the recent planning and turn of events leading to a positive fiscal and operating position," said Art Chacon, CB Board president. "Our new general manager and staff have done a stellar job in turning around a District tapping into the potential to improve the reliability and quality of water for our customers."

This positive development for CB did not happen overnight but began with the arrival of the District's new general manager, Dr. Alejandro (Alex) Rojas.

Rojas came to CB as a turnaround specialist tasked to use his prior pubic administrative experience to promote and secure the District's fiscal stability.

Upon arriving, Rojas implemented a district reorganization resulting in a nearly \$1.8 million reduction in annual operating expenses; furthermore, he developed a cross-functional operations team made up of internal employees and external contractors making the District more efficient while improving organizational performance.

Additionally, the District reduced fixed costs for customers by approximately \$300,000 per year and approved \$1.5 million in grants for recycled water system expansion which will be used to improve local water supply reliability specifically to local disadvantaged communities.

Rojas' moves generated the highest level of average monthly operating and unrestricted cash reserves since 2016, \$12 million, ending the year with \$22 million in unrestricted and restricted cash reserves.

"I am very pleased and appreciative of the Board's support for the District's concerted plans to vastly improve our fiscal position, programs, services and customer satisfaction," said Rojas. "Most significantly we have managed to reduce the cost of imported water by 14% for customers during a drought. The District also kept its recycled water rates unchanged, further reducing the cost of water for its customers."

Despite a projected statewide drought, the CB Board of Directors took action during its monthly May 24 Board meeting and approved a 14% reduction in imported water rates for customers in its service area while other districts are raising their rates.

Many California counties are currently under a severe drought forecast precipitated by low water levels and little snow in the Sierras. This has been the second dry year in a row, and 2021 might bring some additional changes.

"It's important to remember that one of the principal reasons Central Basin is able to lower water rates is that we have taken prudent measures to regain fiscal control of our budget," Rojas continued. "Our goals for the District have been to lower the cost of imported water, ensure our long-term fiscal stability, improve customer service, diversify our revenue streams, and grow our recycled water services. With our final report we believe we have accomplished that goal."

"As a Central Basin customer, we are incredibly pleased the District is working with all its customers to ensure its service areas have a reliable and diverse source of high-quality water at affordable rates, particularly at a time when local governments have been impacted by the pandemic," said John Oskoui, Assistant City Manager, City of Downey. "The Board's actions reflect a new direction for Central Basin which has started to form collaborative partnerships with its customers and take the necessary steps to ensure the District's long-term fiscal stability."





Downey's Stay Gallery Reopens

"We are happy to have our doors open again and invite everyone to visit and perhaps relate to the stories and experiences that the artists have allowed us to share."

SOCAL HOME PRICES ZOOM TO ANOTHER RECORD

L.A.County's median home price rose nearly 24% to \$790,000; sales climbed 69% in June.

Southern California home prices zoomed to yet another all-time high, but analysts see the extreme bidding wars of the last year beginning to ease.

Experts say many factors are behind the increase: fast-expanding buyer markets, and low mortgage rates are just two.

June's median home price of \$680,000 eclipsed the previous record of \$667,000, set in May.

The demand could make for a hot Southern California market through the rest of the year and beyond.

In San Diego County, the median home price rose nearly 25% to \$750,000; sales climbed 34%.

In Ventura County, the median home price rose 23% to \$736,000, sales climbed 48.%.

In Los Angeles County, the median home price rose 23.1% to \$790,000 in June, while sales climbed 68.9% year over year.

In Orange County, the median home price rose 18.6% to \$900,000, while sales climbed 67%.

In San Bernardino County, the median home price rose 21% to \$442,750, while sales climbed 42%.

In Riverside County, the median home price rose 20% to \$510,000, while sales climbed 44%.

With more houses steadily being listed for sale, many realtors say the historic seller's market could ease down before the end of the year.

Homeowners are seeing it is a sellers market, so every time positive news hits, more will list their homes.



Lakewood Adds New Sheriff's Traffic Deputy

In the city's budget that started July 1, funds were allocated for an additional Deputy Sheriff dedicated to traffic safety—the second such deputy for the city.

More hours of coverage means that distracted drivers, speeders, California stops, drivers under the influence who have never heard of a taxi, really dumb unsafe speeding drivers around schools - that is a hefty ticket - might see those flashing red lights in their Tesla rear view mirror.

If residents see L.A. County Deputy Sheriff Pasquale Mastantuono, give him a wave. Lakewood receives little revenue from traffic tickets as the tickets are written by deputies revenue goes to LA County and the court systems.

Despite that, the Lakewood pays for two traffic safety Deputy Sheriffs in order to reduce accidents and keep Lakewood drivers, pedestrians and bicyclists safe.

Norwalk Could Add Another Motor Deputy

The City experienced a 54% decrease in the number of total collisions from 2018 to 2021 with an additional deputy.

The Norwalk City council requested an assessment of the possibility of adding another motor deputy. In conducting the assessment, the Los Angeles County Sheriff's Department's Traffic Analysis Report for the years of 2018 through 2020 and the current data for 2021 were reviewed for the months of January through April of each year.

In previous years, Norwalk had contracted for one commercial enforcement deputy, one traffic deputy and one traffic enforcement motor officer. A second motor sergeant was added to the contract in November of 2020. All of these units work primarily during the day with some flex schedules.

The City experienced a 54% decrease in the number of total collisions from 152 in 2018 to 82 in 2021. This significant decrease also reflects in the number of injury collisions. When the productivity and type of enforcement in 2020 and 2021

was factored in, staff began to conclude that the increase in law enforcement significantly impacted the rate of collisions in the city.

Data from the Public Safety Departments' two radar trailers, which are moved throughout the City based on complaints of speed from residents, were significant in the collection of the speed data. In addition to the trailers, these same locations are provided to the LASD traffic units for enforcement efforts. There were four locations where the trailers were frequently deployed. Bloomfield Avenue between Civic Center Drive and Foster Road; Disney Avenue between Rosecrans Avenue and Mapledale Street; Orr and Day Road between Cecilia Street and Beaty Street and the intersection of Adoree Street and Kalnor Avenue.

It was evident from reviewing the data that traffic enforcement efforts have positively reduced the number of traffic collisions in the City. There were significant gains made with the addition of the second motor deputy, and data strongly supports the continued benefit of the addition of a third motor deputy to reduce traffic collisions. If approved, the planned deployment officer will start later in the day and work into the evening hours to cover commuter traffic.

Funding for a third traffic motor Sheriff's deputy is included in the adopted Fiscal Year 2021 / 2022 budget

Sánchez Secures \$450,000 for Whittier's **Central Library Remodel** and Improvement Project

WASHINGTON - Last week, Congresswoman Linda T. Sánchez announced that she secured inclusion of \$450,000 for the City of Whittier's Central Library Remodel and Improvement Project

"It is my honor to fight for our dis-



trict in Congress, and I am proud to advocate for this much-needed funding for Whittier's Central Library Remodel and Improvement Project," said. Sánchez.

"I will continue to fight for our district to ensure that we get the federal funding we

need to make Southern California communities stronger."

This funding will be used for enhancement to the Children and Youth Services section in Whittier Central Library, including updated furnishings, additional seating, technology stations, a children's story area, and special computers for early learners.

Whittier Central Library opened in 1959 and has welcomed millions of visitors since.

The library collection on opening day was 80,000 items; the collection has now grown to over 220,000 items, an increase of 175%. However, the building has not been updated with the changing role of the library. The facility has overcrowded shelving; lack of seating for Library users, inadequate electrical capacity including wiring, power outlets, data lines, and space for the current and new technology; lack of community meeting place for the wide variety of library programs which are now offered by the Library; inadequate space for housing and displaying local history materials and collection; poor lighting; and a critical shortage of workspace.

Rep. Sánchez submitted several Community Project Funding requests to the Appropriations Committee.

A \$475,000 request was made for better accessibility and lighting at the City of La Mirada's ten-acre Neff Park. The funding would be used to replace deteriorated asphalt walkways with concrete, place new concrete walkways to enhance accessibility to all areas, improve lighting throughout the park, and extend wood rail fencing around the park's perimeter.

Sánchez requested \$2 million to rehab La Palma's arterial street medians; a redesign that will address California's ongoing drought and water restrictions. The project includes the removal of existing landscaping/irrigation, hardscape removals and replacement, installation of a new drip irrigation system, planting of new trees along with new landscaping/hardscaping in 48 median islands. Re-grading of the medians is also included to capture irrigation and storm runoff to meet state/federal storm water regulation compliance. Three newly designed median islands on Moody Street from Malaga Avenue to Orangethorpe Avenue would be added, with the completed project presenting a consistent median island design for all of the City's roadway medians.

Let's Call it What It Is: The Delta Variant is the Murdoch Variant

There's a renewed Covid crisis in this country because powerful forces, led by Rupert Murdoch's Fox News, want there to be one.

The United States is the only country in the world that's simultaneously trying to recover from the Covid-19 pandemic while battling a homegrown, deep-pocketed political and media crusade determined to keep the pandemic going.

Call it the Murdoch variant. And it's proving to be deadly.

While a staff of fully-vaccinated hosts rage against an extraordinarily safe and efficient vaccine, Fox News is doing what no other outlet has done in the history of cable news, or even broadcast television has done — it's deliberately getting people killed during a public health crisis by feeding eagerly gullible red state viewers a mountain of lies.

With the debate about masks now largely eliminated from the cultural war battlefield, as a majority of eligible Americans got vaccinated and no longer have to wear them, Fox News and the extremeright media are left with only one target the miraculous vaccine itself.

The same right-wing crew that this winter demanded Trump receive credit for helping develop the vaccines, has done a U-turn. They're now urging loyalists not to get the vaccine, thereby prolonging the pandemic.

The anti-vaccine campaign follows the network's strident anti-mask, and antisocial distancing crusade. Last year, Fox pumped poisonous, anti-science rhetoric onto the airwaves and worked hard to divide the country, making it impossible to have a common sense national conversation in a time of crisis. This NPR headline surprised nobody from May, 2020: "Study Finds More COVID-19 Cases Among Viewers Of Fox News Host Who Downplayed Pandemic."

Today's pro-Covid movement, which dresses itself up as being anti-vaccine, highlights the deliberate lunacy that has gripped the conservative movement. It's shocking, but not surprising. It reflects the willing embrace of a dark, QAnon conspiracy view of the world where conservatives are the target of demonic Democratic scheming. And where a safe vaccine might kill vou.

"This is becoming a pandemic of the unvaccinated," CDC Director Dr. Rochelle Walensky said last week. There remain tens of millions of Americans who have no plans of ever getting vaccinated. For the most part, they're not "vaccine hesitant." Those "hesitant" people make up a much smaller portion of the population and for a variety of personal, historic, and religious reasons they lean against getting the shot. The defiant tens of millions though, are part of a larger movement that gladly risk infections and spreading the disease in order to own the Libs. Period.

Between June 28 and July 11, "Fox personalities and guests made a total of 216 claims undermining or downplaying vaccines in segments about coronavirus immunization," Media Matters reported.

And this, since July 11:

- "Fox's Jeanine Pirro claims door-todoor vaccine outreach is about confiscating guns."
- "Tucker Calson on COVID vaccine: "Maybe none of this is really about COVID. Maybe's it about social con-
- "Fox contributor Lara Trump says the COVID vaccine has been about controlling people "from day one"

And it's not just Fox. "Republicans are getting the same message of skepticism about the vaccines and the vaccination campaign from other parts of the right-wing media apparatus, from digital outlets to talk radio to podcast shows to Sinclair Broadcast stations to the new generation of social media influencers," Media Matters' Matt Gertz noted.

In 2020, the crass political calculations were obvious — desperate to get Trump re-elected amidst a crippled economy and a once-in-a-century health crisis, Fox News knew the only chance was to downplay the virus and pretend Democrats were overreacting, even though Trump himself nearly died from the contagious disease.

But with Trump now out of office, and even making vague suggestions that people get vaccinated, what's the political advantage of Fox News becoming a ghoulish hotbed of anti-vaccine hysteria? It's pure nihilism.

Pretending that American school children haven't been forced to get vaccinated for lots of serious ailments for the last century, Fox News has embraced a wholesale anti-vax conspiracy approach, portraying Covid jabs in the arms as signs of encroaching totalitarianism, condemning the shots in the most hysterical terms.

This was a Fox News host when Biden said there might be "door to door" outreach about the vaccine in certain communities: "Do you want someone knocking at your door that you don't know, that's a stranger?" Another host suggested the vaccine ambassadors would be shot for trespassing.

For decades, Democrats have had to deal with a billion-dollar propaganda outlet and have wrestled with how to communicate with the country when the largest cable 'news' channel lies to its viewers every day, around the clock. And for years, Beltway journalists rolled their eyes and claimed Fox News didn't pose any real danger, that the network was simply spinning on behalf of the GOP, and if Democrats wanted to govern the country they had to figure out a way to make better arguments.

Now with the pandemic, Fox News' deliberate sins are coming into clearer focus. No longer taking place against a partisan backdrop, the network is still lying nonstop. But instead of falsifying claims about Democrats or candidates or legislation, Fox News is lying without pause about a health emergency, and getting people killed in the process.

The Murdoch variant spreads.

The Reagan Library has a small curatorial team made up of a curator, a registrar, an exhibit specialist, and a graphic specialist who developed the overall storyline of the exhibit, and then made the calls to bring all the artifacts together, accord-

"At first the idea was really just to share the story of the FBI's history with our guests," she said. "But as we began to work with the FBI, we also realized the importance of showcasing the impact of FBI agents on our freedoms, our safety and to help bring to light that the FBI is always recruiting for more agents and personnel. We tell both stories within our exhibit.

The agency got its famed start in 1906 when President Teddy Roosevelt and his Attorney General Charles Bonaparte agreed it was necessary to prevent crime in the United States at the federal level. At that time corruption was widespread. Through Bonaparte, a small investigative group

was put together, and in 1909 under President Taft, the group was named the Bureau of Investigation. It was later officially renamed the Federal Bureau of Investigation in 1935, according to www.reaganlibrary.gov.

Today's FBI fights terrorism far and wide with both perseverance and persistence. According to Former FBI Agent David Marquis, "Terrorists can run, but they can't hide...If you kill and/or iniure an American or kidnap an American during the commission of a terrorist attack, the U.S. government will find you and do our very best to bring you to justice."

Included in the Reagan Library's exhibition is the origins of the FBI, what makes it unique among other federal agencies and how it has evolved over the years. On display are artifacts from the first Director of the FBI, J. Edgar Hoover's estate and office. Guests can learn about how to become an agent, plus participate in a handful of interactives including a brief qualification on how to become an agent, according to www.reaganlibrary.gov.

"The FBI Academy is the toughest boot camp, hardest grad school rolled into one. It is not college. It is life and death."- quote from the television show, Quantico.

Included in the exhibition is how the FBI formed its Top 10 Most Wanted List and what it has accomplished over the years. Another gallery showcases stories and evidence from top cases including those of Al Capone, John Dillinger, the DC Beltway Snipers, the Mafia, the Unabomber and 9/11. Displayed artifacts include a bullet-ridden car in where Bonnie and Clyde met their fate, John Dillinger's death mask, the raft and paddle used in the only escape from Alcatraz, Donnie Brasco's undercover documents, and trial evidence from the DC Beltway sniper case. Artifacts from more recent cases are from the infamous "Unabomber" and Oklahoma City Bombing - including parts of the bomb-laden truck from the crime scene.

Yet another gallery covers the changes the FBI has made over the years and shows their advance in technology and artifacts recovered from 9/11 and the 1993 World Trade Center bombings. The FBI in film and pop culture with props, posters, and costumes from shows such as Bones, X-Files and The Americans are also displayed.

"An entire gallery in our exhibition [is] dedicated just to this [inspiring young people about working for the FBI]," she said. "In that gallery we focus on Quantico – the training center (both classroom and physical) for agents. [There's] a buildout of 'Hogan's Alley' - known as 'the most dangerous city in America' – it is a built-out town within Quantico (with an actual working hotel, subway sandwich shop, bank, post office and more). [Here] everyday FBI agents are sent in to 'react' to whatever they find (bank robbery, hostage situation, kidnapping, etc.).

"The main role of the FBI is that they are the lead federal law enforcement agency for investigating and preventing acts of domestic and international terrorism," added Giller. This is especially challenging in today's technological world where online attacks are prolific.

According to FBI Director Christopher Wray, on the cyber front the country is seeing hack after hack, and breach after breach repeatedly, and more of what is called a 'blended threat,' where

cyber and espionage merge together in all kinds of new ways. The country still confronts traditional espionage threats, with dead drops and covers, but economic espionage dominates the FBI's counterintelligence program

the 9/11 terrorist attacks in New York City.

"We [The Reagan Library and Museum] interviewed 8 former FBI agents in preparation for this exhibit, and every one of them said the same thing – today's world is scarier than when they joined the FBI," Giller said. "They all pointed to cybercrime, the use and availability of technology and terrorism as the reasons why."

"We spoke to a current agent in the Los Angeles office who oversees the Cybercrime Division and he said that his main responsibility is to ensure that the 19 million people that live in Southern California are protected," she added. "So that's one of the main ways that the FBI has evolved."

"They have also evolved as 'things' improve – meaning as forensics have improved, tracking has improved, etc.," Giller explained. "They've kept up with the times and improved the way they do

Certain actual cases have evolved the FBI as well. One example is when the FBI started, and how agents did not carry weapons then. If they were going to go into a serious situation, they brought local law enforcement.

"After a shootout with a mobster in the 1930s, all agents started carrying guns,' Giller said. "In 1986 there was a huge shootout in Miami between FBI agents and bank robbers. The case is known as 'The 5 minutes that changed the FBI,' because in 5 minutes 150 rounds were shot. The FBI agents had handguns and the bank robbers had rifles. After that shootout, all FBI agents now carry rifles and have personally fitted body armor."

Putting their lives on the line for the country is part of the remarkable work the FBI does day in and out. Former President Ronald Reagan held the FBI in high esteem as he held all of law enforcement. On July 26, 1983, he declared FBI Day and spoke at the 75th anniversary of the agency. He was made an honorary agent during his presidency, and the Reagan Library possesses a plaque honoring him in the exhibition.

The Reagan Library rotates in special exhibitions twice a year with each typically lasting 6 months each. Prior exhibitions include one on Pompeii, the Vatican, the Titanic, Abraham Lincoln, and Baseball. These exhibits have helped drive attendance through repeat visitations where patrons also can go onboard Air Force One, see the library's exact replica of the Oval Office, and eat in the onsite café.

"Suddenly you've spent your day here and were able to really enjoy the experience," Giller said. She explained that about 75 percent of the exhibitions are rented through touring exhibitions companies, but about 25 percent are self-curated.

"The FBI is self-curated," she said. "We often survey our guests to see what types of exhibition topics they'd be interested in coming back to see, and when we tested the FBI, it did really well."

"The FBI is dedicated to the well-being of all United States citizens," Giller explained. "We want the public to learn about their history and learn all the things they do to keep us safe every day. To young people- we hope we can inspire them to perhaps become agents someday."

"The FBI is special in that hires people from all walks of life - teachers, accoun-



tants, lawyers, forensic specialists, former military, etc.," she said. "Diversity, for them, is key.'

"The FBI and all its employees, whether they're special agents or support employees, are dedicated to the well-being of all United States citizens," added Espie "This exhibit expands knowledge of the FBI, respect of the FBI, and it will reaffirm and, potentially, educate individuals regarding the FBI's jurisdiction and accomplishments during the course of its great history.'

in the four losses, and the Surf City Tourney's Summer Showcase, held July 10 and 11.

There, the Punishers went 3-0-2, scored 13 runs and allowed four.

"The team is playing a lot better; we seem to be gelling," said Artesia Punishers head coach Joe Fletcher. "We're kind of peaking at the right time. We're still kind of mixing and matching the roster a little bit. But I think we have a pretty good mix now. So, we'll try to get prepared for that and

go in and try to play our best softball and see how far we can go."

The Punishers, who haven't had a history of success at the PGF National Championship, went 1-2 in bracket play in 2019, a year after finishing in third place in the Platinum Division.

It was their third place finish that gave the team a free pass from attending any qualifiers in 2019, and because of the pandemic last season, most of the teams were invited to the 2021 PGF National Championship.

Fletcher says the team's pitching and defense are the strengths and those two components have picked up since the beginning of the summer.

At the same time, he feels the team still needs to work on the execution from the offense.

"We're a very dangerous team when the bats are on fire, just like most teams," he said. "The offense has improved, so we feel we're in every game and making the plays, offensively, will give you a better chance to win. Sometimes in showcases, they have a tendency not to necessarily use all of our offensive strategy. We want the girls to hit and have the [college] coaches see them hit. But obviously now in PGF, we'll have more hit and runs, bunts and steals to be more offensive-minded."

"I think, number one, the girls being together a little bit more," Fletcher later said. "We had a couple of newer players, but there's a lot more hunger and intensity. I think they understand we're trying to get to Nationals and trying to make a deep run. So, the sense of how we're playing and what we're playing for is starting to get more in focus. Now, the prize is right there, so we're ready to go after it."

First baseman and outfielder Bailey Jacobsen (Cypress High/Chaminade University) was on the Punishers Gold team in 2019 but was injured in the Summer Showcase a few weeks ago.

Fletcher said her status for the PGF National Championship is unknown as of one week out.

Catcher Mya Diaz (Anaheim High/ Hope University) is the only other current player that was on the roster from 2019 team.

For the Punishers to go deeper than they did in 2019, Fletcher says it's going to be the typical adage of playing

to their capability.

"We can go and make a deep run," Fletcher said. "The attributes of a being strong, quality team are there. We just have to put it together at the right time. Like any championships, we have to get some fortunate breaks that help you out. A play here and a play there can make a difference between winning 5-4 or losing 6-5. So, we feel we have a squad that can definitely go and represent strongly and make a run and see what happens.

"We're looking forward to going and playing our best softball," he later added. "It feels like it's been five years since we've been able to play. But the girls are excited; the opportunity is here. We've been talking about it for eight or nine months and getting prepared for this. So, hopefully that excitement and the work we've put in will display itself and we can make a deep run."

Former Gahr High infielder selected by the Minnesota Twins in MLB Amateur draft

Once again, a former Gahr High baseball standout has been selected in the Major League Baseball Amateur Draft, and this one is even closer to home. UCLA infielder Mikey Perez, son of longtime Gahr baseball head coach Gerardo Perez and UCLA softball head coach Kelly Inouye-Perez, was selected in the 15th round (459th overall) by the Minnesota Twins on July 13.

ing of new trees along with new landscaping/hardscaping in 48 median islands. Regrading of the medians is also included to capture irrigation and storm runoff to meet state/federal storm water regulation compliance. Three newly designed median islands on Moody Street from Malaga Avenue to Orangethorpe Avenue would be added, with the completed project presenting a consistent median island design for all of the City's roadway medians. This project will be built in preparation for the use of reclaimed water for irrigation to reduce the use of potable water.

A \$322,000 request was made for Bellflower's Constitution Park which will add new recreational amenities, including play and fitness equipment, and a sports court. The funding request for this project will serve to address the final phase in the plan to revitalize the park. The city has already seen a reduction in illegal activity within the park and an increase in positive, recreational pedestrian traffic.

Sánchez requested \$300,00 for Montebello to build the Henry Acuna Park Dog Park. Montebello's first dog park will feature an enclosed area for dogs to exercise, socialize and play off-leash under the supervision of their own owners. The area that the dog park would be constructed would feature fencing, double-gated entry, benches, dog waste stations, a water station, shade and adequate drainage. The area is approximately 32,630 square feet, located near the center of the park and is adjacent to an existing playground and picnic areas.

For Norwalk, Sánchez requested \$1.72 million for various sites in the city. The Smart Cities Digital Divide Free Wi-Fi project is designed and developed for Norwalk underserved neighborhood students, employees, workers, and small businesses. The City is looking to create areas within public parks and facilities near these locations. The Smart Cities Solution will provide students, employees, and small businesses with a free opt-in "Smart & Safe" Wi-Fi Zones. This is a critical Wi-Fi resource necessary to simply exist in this COVID pandemic and post-COVID era to intentionally diminish the digital divide.

Sánchez requested \$2.5 million for the Pico Rivera Water Authority for a PFAS Groundwater Treatment Project. These funds are to be used toward the design, environmental and construction of Phase 1 of the Pico Rivera Water Authority's PFAS Groundwater Treatment Project. Work on this project started in November 2019 and is expected to be completed by April 2022.

Due to industrial activities in prior years, the groundwater aquifers are contaminated with PFAS - commonly known as "forever chemicals." In order to provide potable drinking water to surrounding communities, the Pico Rivera Water Authority must pump and thoroughly treat water to eliminate this contamination.

Sánchez requested \$200,000 for the Boys & Girls Club of Whittier for their Main Clubhouse. The current two-story clubhouse does not meet all safety requirements and is inaccessible to some community members. The funding would be used to make modifications that improve accessibility, safety, and equity. The modifications will include a fully ADAcompliant elevator, accessible restrooms, ADA-van accessible parking, accessible pathways, and related equipment and labor. The main clubhouse serves more than 5,000 high-need individuals and will better serve the community, including to parents with infants in a stroller, seniors and elder family members, and persons with physical impairments.

Sánchez requested \$1.5 million for Los Angeles County Department of Public Works to complete Rosemead Boulevard street improvements. The Rosemead project will construct 2.6 miles of protected bikeways and walkways along Rosemead Boulevard which divides the Whittier Narrows Recreation Area and is a major northsouth route for vehicular traffic. The project will enhance safety for pedestrians and bicyclists along Rosemead Boulevard and improve non-vehicular access to the various recreational destinations within the Whittier Narrows Recreation Area such as Legg Lake, playgrounds, multiple soccer and softball/baseball fields, walking trails, the Whittier Narrows Nature Center, the San Gabriel River Bike Path, the Lario Trail, and the Rio Hondo Bike Path.

The Whole Child – Mental Health and Housing Services could get \$500,000 for Interim Housing & Supportive Services Center for Homeless and Veteran Families. The Whole Child (TWC) would receive funding for construction of an Interim Housing and Support Services Center for Homeless Families to be located in Santa Fe Springs, California. Specifically, the funding would be used toward construction of a 40-unit interim housing and 6,000 square foot supportive services center. Interim housing units would provide six to nine months of safe temporary housing, a crucial first step away from homelessness, and supportive services would be available to help families solve issues that caused their homelessness and to locate permanent housing.

Sánchez requested \$450,000 for the Whittier Public Library Foundation to remodel the Central Library.

Whittier Public Library Foundation is requesting \$250,000 in funding for Teen Center and Homework Center and \$200,000 for Children's Section be used for enhancement to the Children and youth services section in the Library. The facility has overcrowded shelving; lack of seating for Library users, inadequate electrical capacity including wiring, power outlets, data lines and space for the current and new technology; lack of community meeting place for the wide variety of library programs which are now offered by the Library; inadequate space for housing and displaying local history materials and collection; poor lighting; and a critical shortage of work space.

later in 2013, moving to El Rancho Unified School District in Pico Rivera.

The superintendents were given huge salaries \$220,000; nearly \$280,000 with all the bells and whistles.

Jose Reynoso was hired in 2016; he did not last long. The suicide of Jenifer Lenihan, allegedly based on administrative abuse and bullying, ended his career. Deputy Superintendent Alex Rojas took over and stayed until May of 2017.

At that time, the Board engaged Luis Rojas and his construction management firm, Del Terra, and his energy firm, Evergreen Energy. Interestingly, the Board also hired Fairbank, Maslin, Maullin, Metz & Associates, Inc. and paid them nearly \$24,000 to frame the next ballot question in January 2018.

Fairbanks is known as FM3; they are experts, part of the Megataxers that schmooze School District Boards.

FM3 promotes nothing but taxation; according to their materials they, "helped secure voter approval for a total of 123 bond measures for California K-12 public school districts with a combined total of approximately \$46.8 billion."

Did they say \$46.8 billion? Is that with or without Tax Rate Statements?

If without, the cost to local residents would be closer to \$100 Billion!

FM3 noted that "Assembly Bill 195 mandates that ballot details for local bonds include precise figures about authorization amount and the rate and duration of the resulting property tax increase."

AB 195 language is the kind of information that should be displayed prominently while the tax measure is in the process of passing, and has a major effect on the bond's viability.

FM3 set the Megataxing spin machine in motion advising BUSD to, "identify ballot language for the District's bond that complies with AB-195 while simultaneously maximizing its public support and electoral viability."

Under Superintendent Art Cunha, and the guidance of FM3, the Board made their move. In November of 2019, they passed "RESOLUTION 06-20" to approve \$50 Million in school bonds at a cost to resident taxpayers of \$96 Million.

The authors prepared the Official Documents for the primary election in March of 2020, at the meeting, the Board decided to have the tax measure on the ballot in November of 2020.

But they forgot to change the date from March to November on the documents. Resolution 06-20 called for the Clerk of the Board of Education to certify the Resolution, Full Text of the Measure and Ballot Label. The Official Documents languished for months.

While Proposition 39 allows 55% of voters to approve a tax measure for school and community college districts, the Constitution provides taxation only "for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of school facilities.'

In the BUSD Resolution, the Board asserted they were "authorized to order elections within the District for the purposes of considering bond measures to finance and refinance the ongoing capital improvement needs of the District, pursuant to the State Constitution and the California Education Code."

The Board was desperate, they formally recognized the sale of bonds as subject to the California Education Code, specifically, the Strict Accountability in Local School Bond Construction Act of 2000, Education Code Section 16264.

Altered Documents

BUSD officials subsequently noticed that Resolution 06-20 was not amended for the November 2020 election.

So they altered it to place the tax measure on the ballot.

HMG-CN obtained "Resolution 06-20__," a resolution that looks just like the original 06-20, but had an extra underline at the end. The documents showed the schedule was changed and election date was amended from March to November, but most shockingly, the certification sections were altered. Dolores Rivera went from type written to hand written, and Certified a True Copy was altered from "Clerk of the Board of Education" to "Board Member".

The Clerk approved the original under Board Resolution 06-20.

Dolores Rivera, former President and now Member of the Board, delivered the altered document to the County. Rivera and Paul Solano certified that the Resolution "is a full, true and correct copy of the Resolution adopted by said Board of Education on the 12th day of November,

More Shenanigans

Resolution 06-20_, under Accountability Measures, provided that, "in the event the full text of the bond proposition is not reprinted in the voter information ballot in its entirety, the Registrar is hereby requested to include the following statement in the ballot in compliance with the Education Code:

"If Measure __ is approved, the Board of Education of the Bassett Unified School District will appoint a citizens' oversight committee and conduct annual independent audits to assure that bond funds are spent only on the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities, and for no other purposes."

But officials had no intention complying with the Education Code, starting the full text of the ballot measure with an "Abbreviation of Bond Proposition" noting, "the following to appear on the

ballot." The ballot label and question stated:

"BASSETT SCHOOLS SAFETY. **COLLEGE/CAREER READINESS** MEASURE." To improve school facilities, by replacing leaky roofs, improving access to technology, repairing and upgrading security/fire/earthquake systems, modernizing, acquiring, constructing, repairing classroom, restrooms, and facilities, shall Bassett Unified School District issue \$50 million of bonds, within legal interest rates, averaging \$2.66 million annually for 36 years (estimated), at projected rate of 6 cents per \$100 of assessed value while bond are outstanding, be adopted, with all funds staying local."

California's Education Code requires that the actual ballot, not the sample ballot, contain a statement that, "the board will appoint a citizens' oversight committee and conduct annual independent audits to assure that funds are spent only on school and classroom improvements and for no other purpose."

BUSD spent nearly \$25,000 to construct a non-compliant ballot label. Not a word about citizens oversight or audits.

They had followed FM3's advice to, "identify ballot language for the District's bond that complies with AB-195 while simultaneously maximizing its public support and electoral viability."



The animals managed to escape through an open gate on June 22.

Stampeding through residential streets, causing some property damage, one cow had to be killed by a sheriff's deputy after "charging at a family."

Another was recovered two days later in El Monte, the cow travelling five miles, and given to Farm Sanctuary in Acton thanks to the efforts of famed songwriter Diane Warren.

"Seeing these cows escaping their horrible fate broke my heart," Warren said then. "They knew what awaited them. These are smart, empathetic, beautiful souls."

On June 30, the last of the cows was spotted running under the Freeway in El Monte. She was also captured and given to Farm Sanctuary.

Farm Sanctuary representative Meredith Turner-Smith told local media that both animals are doing well in their new

"They are going through a routine 30-day quarantine period to ensure that they are healthy. Afterwards, they'll join the main cow herd with our other rescued cow residents," she said.

Turner-Smith said, "Susan continues to recover from an acute injury and June is still standing guard over her. They keep an eye on our staff, but are no longer displaying the fear-based response, typical of animals rescued from the trauma of the animal agriculture industry, of stomping hooves or throwing dirt behind them. They are eating food and drinking water. Like all animals, June and Susan wanted to live — and they fought hard for that right."

Medi-Cal, but they would have to wipe out their savings first.

Right now, people can't qualify for Medi-Cal if they have saved more than \$2,000. For couples, it's \$3,000. Complicated rules dictate what counts as an "asset" and what doesn't: A house doesn't count and neither does one car, but a second car does. Engagement rings and heirlooms are fine, but other jewelry counts toward the limit.

Not only will the assest test be elimnated, everyone 50 and over will be eligible, regardless of immigration status. And new mothers will be allowed to remain on Medi-Cal for one year after giving birth, up from 60 days.

California has a strong Medi-Cal takeup rate, with 95% of eligible people enrolled, said Laurel Lucia, director of the health care program at the Center for Labor Research and Education at the University of California-Berkeley. But of the remaining uninsured people, about 610,000 qualify for Medi-Cal, she said.

'We are doing well, but so many people are eligible and not enrolled," Lucia said. "The barriers to Medi-Cal enrollment and retention are really multifaceted, so the solutions have to be as well."

This is an especially volatile moment for the program, which covers 13.6 million Californians. The state is trying to improve the quality of care by renegotiating its contracts with managed-care insurance companies. At the same time, Gov. Gavin Newsom and the state Department of Health Care Services are proposing a massive overhaul that would provide more services to homeless people and incarcerated people and boost mental health care.

The changes to Medi-Cal that were approved in the budget include an expansion that Democratic lawmakers have been seeking for years: covering unauthorized immigrants over 50.

State officials estimate about 175,000 people will enroll in the first year, with an additional 3,600 people signing up every year thereafter, eventually costing the state \$1.3 billion annually.

And, starting next July, new mothers will be able to stay on Medi-Cal for up to one year after giving birth. By 2027, the additional coverage is expected to cost the state about \$200 million a year.

Assembly Republican Leader Marie Waldron (R-Escondido), who said she supports expanding eligibility for the program in limited circumstances, was the author of a bill to allow incarcerated people to enroll before they're released that was ultimately folded into the budget and will take effect in 2023.

The elimination of the Medi-Cal asset test for older Californians and those with certain disabilities, which takes effect July 1, 2022, marks a dramatic change to the program. Officials estimate it will cost the state roughly \$200 million a year once fully implemented because of the increased enrollment.

The federal Affordable Care Act eliminated the asset test for most Medicaid enrollees, basing financial eligibility exclusively on income, but left out people who qualify for both Medicaid and Medicare.

This is especially important when it comes to expensive long-term care, like nursing homes, which can cost \$10,000 a month, said Patricia McGinnis, executive director of California Advocates for Nursing Home Reform.

Medicare covers nursing home care only in limited circumstances and for up to 100 days. After that, patients must find another way to pay, either out-of-pocket or through Medi-Cal. Because many people don't qualify for Medi-Cal if they have too much money or other assets, they have to spend through their savings and shed their belongings before they can get on the program.

"Thousands and thousands of people have become impoverished to afford nursing home care," McGinnis said. "You want free medical care? You're going to have to spend every penny you have to get it."

A state Assembly analysis estimated that 17,802 additional Californians would have become eligible in 2018 if the asset test hadn't been required. Of those, 435 were in long-term care, and over the course of the year, 263 spent their money or gave away their assets to qualify for Medi-Cal

Assembly member Wendy Carrillo (D-Los Angeles), the author of the asset test bill that was folded into the budget, sees eliminating the requirement as part of a larger movement toward universal coverage, in line with efforts to expand Medi-Cal to older unauthorized immigrants or establish a single-payer system.

"We need to aggressively and proactively work on legislation that gives more people coverage," Carrillo said. "And until we have universal health care, these are the steps necessary to ensure that."
