# Cerritos and Local Elected Officials Dedicate Anti-Hate Mural at Knabe Park

The L.A. County Board of Supervisors, the L.A. County Department of Workforce Development, Aging and Community Services and the Commission on Human Relations jointly announced the launch of the "L.A. vs Hate" initiative to report and end incidents of hatred and hate crimes in L.A. County.

"Even before the pandemic began, hate crimes in L.A. County were on the rise, reaching their highest point in a decade in 2020," said Fourth District Supervisor Janice Hahn. "All of our residents need to know they are valued, that they belong, and that the County is taking action to protect them and respond to this growing threat. By stressing to our local communities the importance of reporting hate and connecting hate victims with supportive services, the L.A. vs. Hate campaign is one way that we will achieve that goal."

The City of Cerritos unveiled a giant building-sized comic strip on the wall of the community building at Don Knabe park on Friday, August 13. "We are stronger together," said Hahn, "we are united in addressing and ending these unprovoked hateful acts – and that is what this mural is all about."

Local artist and cartoonist Mari Naomi painted the scene, "This artwork means so much to me, it's my attempt to bring the community together, to educate, and to encourage us to protect each other. I intended the hero's panel to highlight significant Asian and Asian Americans who have dedicated themselves to helping others."

Cesar Echano was the victim of a hate crime earlier this year at Don Knabe Park where the 100 foot mural was recently installed. On Friday, he returned to the scene of the crime and spoke at the unveiling of Naomi's' work.

"When I saw this mural, it made me feel good inside. I feel stronger and I feel more healed."

Naomi remarked that it was t magical seeing him healing and holding optimism for the future, "If he can summon up courage and joy after such a traumatic event, it gives me hope that the rest of us might be able to as well. Let's protect each other, together we are stronger!"

### Consultant Hired to Look at Smith Park Pool

Pico Rivera's Smith Park Aquatic Center was constructed in 1981 and includes an Olympic size pool, two locker rooms, a staff office, a pump room where the water systems associated with pool filtration and heating reside, and a chemical room. Typically, pools of this size require annual specialized maintenance, and major repairs to the infrastructure or replacements of large equipment every 10 to 15 years.

In the fall of 2019, two boilers were no longer able to adequately heat the pool water; in the summer of 2020, the was pool closed due to Covid-19 pandemic; later one of the two pool pumps failed and is unrepairable with the remaining pump later faltering leading to inadequate water turnover; summer of 2021, the pool remains closed.

At wit's end, City Staff recently hired an aquatics consultant, Aquatic Design Group Inc. for \$13,500, who specializes in aquatic architecture, design, and

### **Cerritos to Consider Trash Rate Increase**

In September 2020, after seeing three years of disallowed rate increases, the Cerritos City Council, led by Mayor Naresh Solanki, Mayor pro tem Chuong Vo and Councilman Bruce Barrows, voted to give Cerritos' city trash hauler CalMet a 16% resi-

dential increase.

The increase was a combination of the last three years of nonapproval to raise the rates.

In 2017 a new agreement with CalMet dictated the maximum rates the company could charge Cerritos residents.

The agreement included a provision for CalMet to submit

The city of Hawaiian Gardens has announced the Window Safety Bars Extraction Program to help improve home aesthetics and resident safety.

The program provides financial assistance for the removal of security bars on windows with the exchange of security camera installation. Applicants

who decide to remove their security bars from their windows, but reject security camera installation, may be eligible for other program services, including security doors, gardening and any other aesthetics upon approval.

Assistance to residential properties include single family properties, mobile homes, duplexes and condominium properties.

### Norwalk Will Receive Funding for Mercy Affordable Housing Veteran's Project

The City of Norwalk will receive \$3 million in funding from the State that is earmarked for homelessness and affordable housing for the City.

In February 2020, just weeks before the pandemic lockdown, the Norwalk City Council adopted an ordinance that approved a development agreement with Mercy Housing; Mercy has offices all over the country, including three in California. Mercy Housing California (MHC) is the largest regional division of Mercy Housing, Inc., with offices in Los Angeles, San Francisco, and Sacramento. MHC has developed and operates 134 affordable communities with more than 9,190 homes serving lower-income seniors, families, and people who have experienced homelessness.

The development agreement was in conjunction with a project that includes constructing a four-story, 60-unit affordable residential apartments that will provide much-needed affordable housing for veterans and their families, including supportive services located at 13629-13705 San Antonio Dr. and 11950 Foster Rd.

The project will basically take the corner at San Antonio and Foster.

During the last meeting, the City Council voted to receive state funds in the amount of \$3 million; the money will be utilized for the Mercy Housing Veteran's Affordable Housing Project.

Governor Newsom's 2021 budget included \$3 million earmarked for homelessness and affordable housing for Norwalk.

One property Mercy developed and now manages in L.A. County is the Baldwin Rose Apartments in El Monte. The property has 54 affordable housing units, including 22 units for homeless veterans and 32 units for low-income families with a Veteran Head of Household. There is also one manager's unit. The community provides one, two and three-bedroom apartment homes, including 19 accessible apartments for mobility-impaired households and 4 apartments for hearing/visually impaired households.

Mercy also provides case management for Veterans provided by New Directions. New Directions started over 25 years ago and has grown into an organization with a budget in excess of \$10 million annually. They assist over 1,000 veterans and family members annually.

The residential units will serve extremely low, very low, and low-income households and provide them with quality residential living, which may not otherwise be available to such households. The entire development will be affordable housing to help meet much-needed housing unit goals that have been set by the Regional Housing Needs Assessment (RHNA) number.

Mayor Jennifer Perez stated, "The City has made strategic investments in our efforts to resolve homelessness in our City. The Veteran Housing Project now has the funding necessary to move the project along. We look forward to the City's partnership with Mercy Housing to serve veterans and their families."

The Mercy Project also satisfies the City's Strategic Plan Goal 2, which is to improve living conditions for residents in greatest need.



# Norwalk Plans for ARPA Funding

STAFF REPORT

The Norwalk City Council recently approved the \$28 million American Rescue Plan Act Allocation Plan.

On March 10 President Biden signed into law the American Rescue Plan Act (ARPA).

The Act will provide a \$1.9 trillion stimulus to the United States economy, with the City of Norwalk receiving \$28 million in two equal installments of \$14 million

The first allocation was already received this year and the second will be received in May 2022.

The U.S. Department of Treasury broke funding requirements into seven categories. Given those constraints, City staff evaluated all viable options for funding with input from professional associations including the Unites States Conference of Mayors, International City Management Association, and League of California Cities.

On July 26, City staff presented preliminary recommendations to the Fiscal Ad-Hoc Committee.

The committee adjusted the list of recommendations for funding allocation to prioritize infrastructure and other capital investments that would maximize long-term benefits to the community.

This past August 3, City staff presented the amended draft recommendations to the City Council for feedback.

Some of the funding recommendations include community health and crime reduction programs, small business & nonprofit assistance, promotion of healthier living environments, affordable housing funding, and funding for stormwater infrastructure, among other things.

Mayor Jennifer Perez stated, "The ARPA funds will not only help us enhance our economic recovery and economic revitalization efforts, they will enable us to deliver enhanced services to improve public safety, infrastructure, technology and recreational programs. We look forward to making these improvements a reality and building the foundation for a thriving, healthy community."

Funds must be obligated by December 31, 2024 and expended by December 31, 2026.

### **Booster Shots by Sept. 20**

With infections from the coronavirus' Delta variant rising, the Biden administration said it plans to provide booster shots starting the week of Sept. 20 to adults who have received the two required doses of the Pfizer or Moderna vaccine. People will be eligible to receive the boosters eight months after their second dose, officials said.

The administration is requiring nursing homes that receive federal Medicare or Medicaid funding to mandate vaccinations for all staff or risk losing those dollars. And the president threatened to take legal action through the Dept. of Education against governors that attempt to prevent school districts from enacting mask mandates.

Biden noted that vaccine requirements "have been around for decades" and have protected Americans from a host of viruses. He urged the private sector to go further in requiring workers to be vaccinated.

Ahead of his remarks, the Department of Health and Human Services announced the plan for booster shots, explaining why a third shot is considered necessary.

In a statement the DHHS stated, "The current protection against severe disease, hospitalization and death could diminish in the months ahead, especially among people who are at higher risk or were vaccinated during the earlier phases of the vaccination rollout. A booster shot will be needed to maximize vaccine-induced protection and prolong its durability."

Boosters will first be given to healthcare workers and nursing home residents.

Health officials said they expect boosters will also be needed for those who received the one-shot Johnson & Johnson vaccine. That vaccine did not roll out until March, and administration officials said they needed more data were to assess when boosters for those shots might be necessary.

### T-MOBILE DATA BREACH AFFECTS MILLIONS

Records on nearly 50 million people, were exposed, carrier says.

(AP) The names, Social Security numbers and info. from driver's licenses or other identification of more than 40 million people who applied for T-Mobile credit were exposed in a recent data breach, the company said Wednesday.

The same data for about 7.8 million current T-Mobile customers who pay monthly for service also appear to be compromised. No phone numbers, account numbers, PINs, passwords or financial information from the nearly 50 million records and accounts were compromised, T-Mobile said.

T-Mobile also confirmed that approximately 850,000 active T-Mobile prepaid

customer names, phone numbers and account PINs were exposed. The company said that it proactively reset all of the PINs on those accounts. No Metro by T-Mobile, former Sprint prepaid or Boost customers had their names or PINs exposed.

T-Mobile said that no customer financial information, credit card information, debit or other payment information or Social Security numbers were in the inactive file.

T-Mobile had said earlier this week that it was investigating a leak of its data.

The company now says it will immediately offer two years of free identity protection services and is recommending that all of its postpaid customers — those who pay in monthly installments — change their PIN. Its investigation is ongoing.

an annual request to adjust the maximum allowable rate that can be charged. In 2018 they submitted their request for a 5% residential increase and a 4.3% commercial increase; that request was denied on a 3-2

In July 2019, CalMet submitted a second request but this time the company submitted an extraordinary rate adjustment as allowed by the contract.

CalMet proposed a 14% increase to commercial bins while freezing residential rates at current levels, but sensing that would not pass, at CalMet's request, the item was removed from the agenda.

This year CalMet submitted a proposal for a 16% residential increase, 13.7% commercial bin increase, and an 18% commercial roll-off increase.

According to staff reports, CalMet would earn an additional \$1.3 million providing the city nearly \$193,000 in franchise fees, but residents would see their bill go from \$17.60 to \$20.42, an increase of \$2.82.

CalMet's former residential rates in Cerritos were one of the lowest of surrounding cities surveyed; with the new rate increase it is right about in the middle, \$4 less than Whittier, \$3 less than La Mirada and Downey.

The rate increases were approved on a 3-2 vote with Councilpersons Grace Hu and Frank Yokoyama voting no.

Now CalMet is asking for another in-

A press release from the City stated, "Cerritos City Council to review proposed CalMet Services rate adjustment. The Cerritos City Council will review a request from CalMet Services for an adjustment to the maximum allowable solid waste management rates in the City of Cerritos at its meeting on Thursday, August 26 at 7 p.m. in the City Hall Council Chambers."

of the AAPI anti-hate movement, the building-sized comic strip depicts Asians as targets, and the journey from hate to healing.

"This public art project is meant to be an ongoing project. My hope is that this artwork brings about healing and a sense of solidarity in the AAPI community and sparks a dialogue for non AAPI residents about what we can all do to be allies," said Hahn, "we may not be the first mural but we are the biggest!"

Norma Garcia, LA County Parks and Recreation, called it a big, bold beautiful, strong message "... to the 50 million residents that come to our parks, we want you to come without fear of hate or discrimination or fear of racism."

Derek Hsieh of L.A. County Department of Mental Health added, "To have an event where you bring the victims back to a place of violence, but bring them back with the support of the community, is a very powerful thing."

The LA vs. Hate campaign has three components: a marketing campaign to provide awareness of the dangers of hate and the importance of reporting hate; the ability to report acts of hate and bias-motivated bullying; and to connect victims with needed resources via case managers by calling 211-LA.

engineering, to provide a comprehensive assessment of pool conditions.

The very detailed assessment is anticipated to be completed by the end of September and will include: Evaluation of the pool vessel, deck, and mechanical and chemical systems, as well as provide lifecycle analysis for each; identifying and summarizing findings for water leaks in the pool, decking, and equipment; include findings with the goal to repair or renovate the pool for safe public use.

Lastly the consultant will prepare three options for mitigation, and probable cost estimates for each: 1) Renovation of existing pool; 2) Removal and replacement of existing pool; and 3) Removal and replacement of pool with enhanced features.

"We've got to get it fixed." said Councilman Gustavo Camacho. "It needs to be done by summer of 2022. It's not only a great place to refresh yourself, but it's a safety issue. Learning how to swim is very important."

The report is expected in 50 days.



### Local Resident Graduates from Officer Candidate School | Watch Out

As the son of Vietnam War refugees helped by U.S. military, Julien Truong Son Pham knew he also wanted to serve and help others.

The 32-year-old from Norwalk recently graduated from the U.S. Navy's Officer Candidate School (OCS) this month and is awaiting his assignment, which most likely will take him far away from his native Norwalk.

"I joined the U.S. Navy because historically, it is our country's oldest military relative to others that have a longstanding history and tradition that I would like to contribute and be a part of," he said. "The Navy serves as a global peacekeeping entity that provides maritime security as well as responding to natural disasters around the world. Without the Navy, other countries would fall ill to internal and external struggles as well as have limited access to new resources that the U.S. Navy can provide when a natural disaster occurs."

Though his parents Caroline Luong and Hung Pham are no longer alive and couldn't witness him graduating OCS, he remembers their gratitude to U.S. forces that protected their family during the Vietnam War. He clearly recalls his mother telling stories of how they were helped in their time of need.

"Although they weren't part of the waves that came into America, they were victims that were forced to relocate in a different country," Pham said. "Essentially, my parents and myself wouldn't be here if it wasn't for their help. Becoming a Naval Officer is my way of continuing that ability to help others when they can't help themselves."

However, they did see him graduate from the Marine Corps boot camp in San Diego. He said his mother's reaction seeing him cross the stage was filled with emotion and excitement for completing such a physically demanding program.

"I can only imagine that's what she would experience too as I walked across stage accepting my commission as a Naval Officer," he added.

However, while he was in the rigorous 13-week OCS being put to the test that Pham was supported by his aunt and uncle Cynthia and Peter Pham, and partner Rosalva Guzman.

"Officer Candidate School is unlike any other program that I have participated in," he said. "Unlike Marine Corps boot camp that I attended in 2007, OCS is not only physically and mentally demanding but immediately tests your leadership capabilities as soon as you arrive."

"OCS has helped me exceed my limi-

tations," Pham explained. "In moments of great stress from the staff members yelling and the high expectations they demand, it has helped transform my mind-set to one that does not give up the ship and to persevere."

His greatest challenge physically was simply staying awake, while mentally, it was keeping his focus on his overall goals.

"In the civilian world, I've grown accustomed to my sleeping schedule as well as maintaining my physical strength to keep up with OCS standards," Pham said. "Mentally, I reminded myself why I was here, and using that motivation to succeed and move forward on my journey to become a United States Naval Officer."

He said that right from the beginning leadership qualities were tested. All approximately 80 candidates in his class were expected to hold a leadership billet in some capacity supporting their class.

Their daily routine continually challenged them as well.

"Our everyday regiment consisted of waking up at 5 a.m. and immediately muster outside for physical training," he said. "From running to doing high interval intensity training, I would say that my 32-year-old self is in one of the better conditions of my life!

Training also involved graded classes in division officer fundamentals, navigation, naval history and more. If a candidate failed, they are subject to removal from the program. Throughout Pham's time there, he saw as many as 20 candidates who failed and were asked to leave.

Now that he's graduated from OCS, Pham is waiting on medical paperwork to be cleared so he can be redesignated from his original goal of being a Naval Flight Officer to a different occupation. It was only his second day in OCS when he was medically disqualified and was asked to choose a different career. He's currently applying to be an Aerial Vehicle Operator (a drone pilot), work in Intelligence, and be an Information Professional.

"With the current backlog of applicants also waiting to be medically cleared, I am hoping my experience is expeditious as myself and others eagerly await to move forward with our career," he said.

To future generations interested in joining the Navy, he says it's a life-changing experience that no other civilian occupation can give an individual.

"As a Sailor, we are all brothers and sisters in arms that have a common goal," Pham said. "The Navy entity provides us with a single identity with a single purpose -- to serve and to go to places where only a few will answer to reestablish global and environmental security."

# Watch Out for Valley Fever

Incidents are up for 2021, scientists say its climate change.

According to the California Department of Public Health, Valley Fever, also known as "cocci" or Coccidioidomycosis, is an illness caused by a fungus found in the soil in many parts of California, especially the Central Valley and Central Coast.

Valley Fever cases are rising in California and across the arid Southwest, and scientists point to climate change and population shifts as possible reasons.

California public health officials documented 7,768 reports of confirmed, suspected and probable new cases of the fungal disease as of Nov. 30, 2019, up 12% from 6,929 in the first 11 months of 2018.

In L.A. County, 657 cases have been reported so far this year; Orange County, 167; Riverside, 271; San Bernardino, 138; San Diego, 194; Ventura, 166.

For some, it can be severe and even fatal. This fungus lives in the top two to twelve inches of soil in many parts of the state. When soil is disturbed by digging, or is disturbed by environmental conditions such as high winds, fungal spores can become airborne and inhaled.

Construction workers and others who dig outdoors are most at risk. California's AB 203 requires construction employers, through an awareness program, who work in counties with high rates of Valley Fever to train their employees on minimizing their risk.

The Occupational Health Branch has investigated outbreaks in working groups and developed recommendations for preventing work-related Valley Fever. Recognizing common signs and symptoms include fatigue, cough, Fever, shortness of breath, headache, muscle aches or joint pain, rash on upper body or legs, and symptoms similar to influenza that linger longer than usual.

The CDC reported that persons with CoVID-19 can have a wide range of symptoms, including cough, difficulty breathing, and fatigue. These symptoms are also common among patients with Valley Fever.

To decrease the risk for infection, persons living, working, or traveling in areas where Valley Fever is endemic, especially those at increased risk for severe disease, should limit exposure to outdoor dust as much as possible.

### **Cut Your Water Use 15%**

### **Initiative Will Legalize Sports Betting in California**

A coalition of California cities this week submitted language to the California AG's office for a ballot initiative for the November 2022 statewide election. The measure is called the California Sports Wagering and Consumer Protection Act.

The initiative would legalize sports wagering in California. Economic surveys estimate illegal sports gambling generates over \$10 billion in revenue entirely outside the regulatory system. This illegal enterprise contributes to criminal activity and leaves bettors without legal protection, accruing all its benefits to out-of-state and criminal enterprises while Californians pay

The Act attacks black-market gaming, increases public safety, protects consumers from unscrupulous operators, and raises substantial revenue to fund services like improving COVID-19 relief, homelessness, mental health, and public education.

"Let's bring sports wagering out of the shadows, regulate the industry, and use a portion of the proceeds to benefit all Californians. Right now, the illegal and offshore operators reap those rewards and they're bleeding us dry," said Gardena Mayor Tasha Cerda.

"The revenue we generate from making sports wagering legal, while we're making it safer for consumers, will ensure that those who are most in need will receive food, housing, and other vital and necessary basic life services," said Helen Fisicaro, Vice Mayor of Colma in San Mateo.

The measure guarantees strong oversight of monies collected. Among its watchdog provisions, the measure requires sports wagering operators to perform annual audits and publicly report their findings to state regulators.

"California residents continue to suffer

impacts from the pandemic," said San Jose City Council Member Raul Peralez. "We built strict accountability into the measure. We need to be able to move forward on what voters have asked for and will demand from us."

The initiative limits sports wagering to highly regulated entities that are experienced in gaming operations like state & federally recognized tribes with compacts or state-licensed gaming establishments, and professional sports leagues will be allowed to have operations at their facilities. The initiative also replaces unregulated, and untaxed operators with a safe and legal online and mobile sports wagering market.

The initiative also establishes strong enforcement mechanisms to keep sports wagering away from underage Californians and sets aside funding for problem gambling programs.

"A legal sports wagering market will bring protections for consumers and children," said Mayor Cerda. "This measure confines sports wagering to highly regulated and safe facilities, requires age verification for digital wagering, and outlaws advertising or marketing of sports wagering to children and young adults."

State elections law requires the proponents to gather 997,139 valid signatures to qualify the California Sports Wagering and Consumer Protection Act and must do so by April 2022 in order to appear on the November 2022 general election ballot.

A spokesperson from the Commerce Casino told HMG-CN, "We are still reviewing this new initiative. Right now, our focus is to defeat the tribal casino monopoly initiative that is being promoted by wealthy tribal casino operators at the expense of California residents with no revenues for taxpayers or safety precautions to protect California consumers."

Have a day or half-day to enjoy a quick excursion? A chance to get away from the routine to experience new scenery and stimulation?





What a difference a year makes. This time last season, Gahr High head coach Greg Marshall was embarking on his 18th season and was hoping to take a team heavy in seniors back to the playoffs for a second consecutive season and fourth out of the last five. But the pandemic hit, the CIF-Southern Section cancelled the fall sports playoffs and an abbreviated season consisting of no more than six games was put together in



the spring. Marshall was proud that his seniors, some of whom had been in the program all four years, were able to get some games in.

"I think we were very fortunate to get those in, and I think a lot of that because we had so many seniors who were able to put it together so fast," Marshall said. "If I had [the 2021] group, I wouldn't have felt comfortable playing four games. We might have gotten two in."

In the past four months since the Gladiators last played, Marshall said the program has been trying to get back to some type of normalcy and added that about 25-30 kids showed up during the recent optional workout period. That number grew to around 60, including freshmen, when it came time to hand out



### Valley Christian Back in Action With New Coach and a Deeper, More Athletic Team

Kevin McCarthy becomes V.C.'s fourth head coach in as many seasons and seventh since the legendary Mike Wunderley took his 2002 team to the Division IX championship game in his final season. The Defenders opted not to play this past spring as several football players also compete in spring sports. In 2019, under the tutelage of former head coach Bill Garner, V.C. went 7-4 and won the Olympic League before falling to Pasadena High 47-31 in the Division 11 first round playoffs.

McCarthy had been an assistant coach for V.C. the past seven seasons and took over the new position when Garner stepped down due to personal reasons in the preseason of the 2020 season.

"The program is 85 years in the making," McCarthy said. "There's a lot of tradition here. The ease of transition did come by knowing the players, also having much of the staff stay on. We didn't go through a big transition initially. Coach [Kirk] Diego, he and I have been together for 15 years. But the transition had been pretty smooth, having been here for that period of time and having had some success, winning CIF in 2016."

Of the 34 players on varsity this season, 13 of them were in the program in 2019, either playing on the varsity team or the junior varsity squad. In fact, McCarthy says this season's team is deeper, more athletic and adds that it's the best team that he has seen athletically since the 2016 team.

### **OFFENSE**

Two seasons ago, V.C. put together 320 points and scored at least 31 points in five games, winning four of them. Historically, scoring has never been a problem and this season, the Defenders will have a trio of quarterbacks to choose from, including senior Colin Abrahams, who was 35 for 57 with 513 yards and four touchdowns in 2019. Seniors Rocco Caldarella, who caught 32 passes for 404 yards and scored three touchdowns as a sophomore and Logan Lemonnier, a transfer from Cypress High, are the other two candidates. McCarthy said all three have different skill sets and he isn't ready to name a true starter.

"The new kid throws the ball really well and Rocco is one of our best athletes," McCarthy said. "As far as running the ball, we've had some success with our quarterbacks running the ball



[and] he's pretty good at that."

Speaking of running the ball, senior John Nelson, who has been with the program all four years, will likely be the team's main running back, according to McCarthy. However, look for junior Aaron Chang, sophomore Dylan Sawai and freshman JoJo Apisala to see a lot of touches. Catching the ball will be Caldarella, seniors Ellis Negron and Carson Slager (22 receptions, 260 yards, one touchdown in 2019) and juniors Nick Bozanic, Micah Maurer and Kaden Struiksma.

McCarthy added that the team is deep in both the running back and wide receiver positions and that ideally, the run/pass ratio will be 50-50.

The one area that isn't as complete right now are the two tackle positions on the offensive line. Senior Jesse Perez, who stands at 6'5" and is 280 pounds, will be at center while 6'2", 270 pound senior Christopher Chang will occupy right guard with sophomore Jack Van Hofwegen playing on the left side. Junior Jacob Smith most likely will get one of the tackle spots while the other one is still up in the air. But sophomore Max DeMaster is also in the mix.

"My goal, which is kind of the joke amongst the people here, was that I wanted to get to 75 players in the program," McCarthy said. "And we're in good shape. We're up to about 65 with the j.v. and the varsity. What we have is a depth of quality and we're getting more bodies out. We'll start the season with probably 31 or 32 varsity players, which is how many we had the year we won [the CIF championship]. It's a good position to be in."

### DEFENSE

When one sees a V.C. game, most likely it's going to be a high scoring affair. While the offense rarely struggles to put points on the board, the defense gives up a lot. In 2019, the Defenders allowed 297 points with at least 34 in the first, third and fifth games. However, the defense can show signs of an excellent game as V.C. yielded six points each in the second and fourth games of that season.

Junior Aaron Chang and Negron will lock down the two defensive end positions while senior Lee Kingwood and Christopher Chang will be the two interior linemen. The linebackers will be Apisala, Maurer, Sawai and Slager (29 tackles in 2019) while the secondary will see Bozanic and Nelson as cornerbacks and senior Sam Reeves and junior Nick Turnbow as outside safeties and Caldarella in the middle (34 tackles, four interceptions in 2019).

"I think our defense is probably

gear for the players. But hard times have hit the Gladiators recently with some of the players coming down with Covid. Still, Marshall plans on playing dome games this season.

#### **OFFENSE**

After being blanked by Dominguez High 27-0 in last season's opener on Mar. 25, the Gladiators scored 68 points in the next three games. Because of Covid and players transferring out, Marshall has had to do some tweaking in the offense, meaning what he wanted to run a few months ago will be different when the season begins, including the quarterback. Marshall's plan A for a signal caller transferred out in the last week of July. So, junior Tyvon McGirt, who caught a 60-yard touchdown pass last season against Bellflower High, gets the starting nod with senior Joshua Rubio as his backup. When he is not under center, Rubio will be one the featured running backs along with junior Jaquan Miller. Also in the backfield will be senior Kye Clemmons and sophomore Royal Nwosu with juniors Micah McNeil and Jalen Montgomery slated to be the tight ends.

Marshall is projecting his offensive line to be senior left tackle Adam McNeil, freshman left guard Branden Meza, junior center Tristen Contreras, sophomore right guards Marcell Frazier or Noah Taylor and sophomore right tackle Anthony Fierro.

"It's a young line, so we're going to throw the ball which will be easy to pass protect and try to drive them off the line," Marshall said. "Switching quarterbacks, we have to be able to run the football. Everything has changed. I'm not saying it can't be done or won't be done; I think it will be [done]. But we go from spring to summer, you have an idea of what all the kids can do, and you put them in position to be successful. Now I have to redo that and I'm not going to ask kids to do something they can't do."

### DEFENSE

Historically, Gahr's defense hasn't been one to write home about. It's rare to see the Gladiators allow less than 20 points in many games. Last season, Gahr allowed an average of 30.5 points a game with its best performance coming in the lone win against Bellflower, a 34-16 decision. The leader of the defensive line will be junior David Mataele, who was a starter last season, along with junior Tuini Mataele, and the two will be on the ends. Marshall is also projecting Contreras, Fierro and junior Jason Jackson to be on the ends at some point. The secondary stacks up with Rubio and McGirt as safeties and sophomores Evan Spurlin and Isaiah Wilcots as cornerbacks. The linebackers will be a combination of brothers as the McNeil's will be on the inside while Jalen Montgomery and sophomore Kalen Montgomery are slated to be on the outside.

#### **SCHEDULE**

Gahr was scheduled to host Mayfair High tonight in the season opener. But after the recent Covid issues, Marshall took that game off the books and the Gladiators, who will now play as many as nine regular season games, will begin the season on Aug. 27 against North Torrance High. The Saxons are one of five teams that had a winning record, making this season's schedule another tough one. Gahr lost to North Torrance 28-25 in 2018 and 41-7 in 2019 while it fell to Sunny Hills High 38-0 the week following the loss to North Torrance. The meetings against Garden Grove High and Heritage Christian High will be the first for the Gladiators in at least 23 years.

"Sunny Hills and Garden Grove are going to be major tests," Marshall said. "We saw enough of North Torrance; we scrimmaged them last year. It's like, 'oh, they look like us'. Heritage Christian, we got on the phone and had that conversation...we're both in the same place. So, those two games, I think, will be competitive. Then as we go into Garden Grove and Sunny Hills, we're starting to step up to league-type schools and we'll see where we're at."

Once San Gabriel Valley League play begins, it will be another big test to see if the Gladiators can crack the top three needed for an automatic playoff berth. They make their even-numbered year visit to the city of Downey where they have not defeated Downey High since at least 1998 and have two wins against Warren High, a 54-21 win in 2012 and a 21-7 victory four years later. Since 1998. Gahr has a winning record against one league team-Lynwood High in which it holds a 13-5 advantage. Against the other four league opponents in over that same time, Gahr has a combined 17 victories.

"This year it's going to be
Downey and Warren at the top of the
league," Marshall said. "Dominguez
had some kids come in, I think, so
they'll be pushing [for third place]. I
think Paramount is kind of down and
Lynwood didn't even have a football
team last year. We're going to probably
be in the bottom half, realistically,
going in. The top group is almost
unmanageable for us this year. But then
we're going into a conference the year
after, so I'm okay. Let's get through this
year playing those guys and hope I never
have to play them again."

### HOMECOMING

If there is a homecoming game this season, Lynwood would be the opponent and it would be one of the best chances for the Gladiators to pick up a victory. In addition to the Gladiators defeating the Knights 13 times since 1998, they have not lost to Lynwood in their previous three homecoming meetings going back to 2008. Overall, the Gladiators are 9-10 since 2001 when hosting a homecoming game. But in the last six games, three each with Paramount and Warren, Gahr has been outscored 287-144, winning once (2017) and losing in the last outing to Warren, 51-0, on Oct. 25, 2019,

In closing, Marshall said a successful season, which has always been the case, will be the kids having a positive experience rather than winning or losing.

"It's about creating memories,"
Marshall said. "If they can have a
good memory of this; of going through
this challenge, then it's positive; it's
good. That's what high school sports
is supposed to be about. I'm confident
they're going to have a good experience
and create some good memories from
this whether we win or lose."

ahead of our offense as far as teaching," McCarthy said. "Randy Williams does such a good job and offensively, we never know what we're going to be until we get contact."

#### **SCHEDULE**

Had there been a full season in 2020, the Defenders were slated to open at home against San Marino High before travelling to Lancaster High and Portola High. This season, V.C. begins on the road against St. Paul High then hosts Menifee-based Santa Rosa Academy before going on the road to face Crean Lutheran High. The fourth game is at Beckman High and V.C. has never played the latter three in school history and has not squared off against St. Paul in at least 23 years. The fifth game of the season is the rivalry contest at Ontario Christian High where V.C. holds a 12-9 advantage since 1998 but has lost the last two against the Knights.

Although the coaches have changed over time, the final game before Olympic League play begins is a throwback game of two of the top former coaches in the history of the CIF-SS. V.C. entertains Artesia High for the first time in at least over 23 years and if those two schools faced each other in the 1980s or early 1990s, it would have been Wunderley against Artesia legend Norm Flowers.

"St. Paul is a huge step us for us," McCarthy said. "They're a Division 5 team and they were in the CIF final two years ago: traditionally very good. But the challenge with coming out of Covid was just trying to find a week zero game. I really wanted to keep that week five bye to give us a week of rest before league starts. I looked around, looked around, looked around and St. Paul was available. We might be biting a little off more than

we can chew. But we're going to take a shot."

Since 2002, V.C., the school of champions, has won the Olympic League eight times and has finished in second place seven times. Over that time, the Defenders have compiled a 51-18 league mark and went undefeated seven times. Of those 18 league losses, four have come to Maranatha High and Village Christian High and another three to Whittier Christian High.

"Heritage Christian is always really good and Maranatha is always really good," McCarthy said. "They both have gone through coaching changes, but I don't expect any type of drop-off from them. Village Christian has been improving and Whittier Christian, again, is competitive with us every year. We've been pretty lucky with winning the league five out of the last six years that I've been here and most of that is a biproduct of just preparation. But any one of those schools could win league this year with the two coaching changes at Heritage and Maranatha. There's no telling what those schools are going to look like. For all intense purposes, we're going through a coaching change also."

#### HOMECOMING

The last time Valley Christian hosted Village Christian for its homecoming, which came in 2015, the Defenders came away with a 58-6 victory and since 2005, Valley Christian has won all four homecoming games against the Crusaders. Since 1999, Valley Christian holds a 19-2 record on homecoming night, losing to Francis Parker High out of San Diego 46-7 in 2013 and Heritage Christian 25-10 in 2018. And of the 21 homecoming games since 1999, three have been against teams outside the Olympic League.

West Coast.

According to the governor's office, a 15% cut in water use would save 850,000 acre-feet of water — enough to supply more than 1.7 million households for a year.

Newsom said residents have responded to drought conditions before, and he was confident they would take steps again to ease their water use. He urged residents to limit outdoor watering, use recycled water when possible outdoors, take shorter showers and only run dishwashers and washing machines when they are full.

Should conditions worsen, Metropolitan officials could later decide to take further action, including imposing financial penalties for excessive use on Metropolitan's 26 member public agencies and retail suppliers that provide water for 19 million people in six counties.

Keeping neighbors safe also involves being prepared for emergencies. enhance the look of a home, while having a particularly strong deterrent effect. The bars are secured to the home's structural frame with screws or bolts, ensuring that they can't be easily pried off.

While burglar bars can hinder attempts to get into your home, they can also hinder your exit during an emergency. There have been several fatal house fires where bars over the windows or doors prevented occupants from escaping or hampered attempts to rescue them.

A report by the U.S. Fire Administration says there are several ways to remove window bars to access a home, but that all will result in significant delays to rescue efforts. Firefighters may use axes or other tools to destroy the bolts holding the bars in place, or they may cut through the bars with saws or torches. In extreme circumstances, the report says firefighters can attach a chain to the bars and use a fire engine or other fire apparatus to tear them off the building.

Since a barrier over the window can increase the risk of injury or death, it is essential to make sure the burglar bars have a quick release mechanism before installing them. This release, operated from within the home, causes the bars to swing or slide away so occupants can escape.

He is a proponent of the Cali-Baja Mega Region and Ethnic Studies that former El Rancho Unified School District Board Member Jose Lara espoused.

Previously under the supervision of the State Superintendent, the Board has a L.A. County Administrator.

In mid-2012, then-Governor Jerry Brown stepped in and loaned the District \$55 Million courtesy of the California Infrastructure and Economic Development Bank, whom former disgraced Montebello Unified COO Ruben Rojas worked for.

As a result, Superintendent of Public Instruction Tom "the bonds" Torlakson wrested control away from the Board and appointed Kent Taylor as Superintendent, a free-wheeling contractor.

By December of 2012, he was removed or resigned, moved on to Lennox to end his career, and eventually took his life.

Next, Don Grann was hired, but he was too busy playing with Wiseburn School District in El Segundo. Vincent Matthews replaced Grann, Matthews the soon-to-be champion of Non-Citizen voting for school boards. The Bonds later appointed Thelma Melendez de Santa Ana as Superintendent, hailing from Montebello Unified School District. As former Assistant Secretary of Education during the Obama Administration, she may have succeeded in running IUSD. Just ask Joe Bowers, another Cardinal. So much for State control.

That at least explains how George Pla and Cordoba Corporation slipped in as Construction Manager for Measure G.G. in June of 2016. On the same agenda, Cordoba Corporation was engaged as Construction Manager of the Los Angeles World Airport Project, along with McKissak and McKissak. Cordoba delivers, especially on local, state and federal projects. Cordoba and McKissak have everyone on their payrolls.

In November of 2019, Debra Duardo, Superintendent of Los Angeles County Office of Education, appointed Erika Torres as Administrator of Inglewood Unified. Unlike the stone-cold Queen of Angels stationed at Echo Park, this Mom Duardo has ears and eyes on everyone throughout the nearly eighty school districts in Los Angeles County. Just ask Superintendents Vivian Echkian or Mark Skvarna.

Recently California updated the Dashboard, indicating IUSD now serves 7,950 students in 19 schools; they lost four schools and 3,000 students.

Rauth, and bond counsel Carlos Villafuete and David Casnocha's.

The Board also engaged Clifford Moss for Community Outreach.

In July 2020, the Board had the first reading of a Resolution Ordering an Election and Establishing Specifications of the Election Order. The agenda reflected, "If approved by the County Administrator - not the Board - the Resolution calls for an election within the District for the purpose of approving general obligation bonds, requests that the Los Angeles County Registrar of Voters conduct the election on behalf of the District, and authorize the preparation of election materials, including ballot arguments and tax rate statement, to be included in the ballot pamphlet." The election material, measure arguments, and tax rate statement are printed in the voter information guide or pamphlet containing the sample ballot.

One month later, they had a second reading to make sure they got the verbiage right. This Resolution had the Ballot Label attached as Exhibit A and the Full Text of the Measure attached as Exhibit B

Duarte Unified's Ken Bell and Azusa's Bradley Patterson, used their campaign contributions to pay Clifford Moss. Now, IUSD was paying them directly for outreach, crossing into the grey area of using taxpayer funds to pay for campaign outreach.

DUSD's and IUSD's Resolutions were mostly the same, except for the amount; \$79 million versus IUSD's \$240 million.

IUSD's section eight stated, "The maximum rate of interest on any Bond shall not exceed the maximum rate allowed by Education Code Sections 15140 to 15143, as modified by Government Code Section 53531."

As we pointed out in our last article, DUSD's Resolution did not disclose the actual rates of interest. IUSD did the same thing in their Resolution.

DUSD's had ten sections, IUSD's eleven, Megataxer cookie cutter documents.

### Can a County Administrator Approve the Bond?

At DUSD, the President of the Board signed the Resolution and was attested. At IUSD, the County Administrator Erika F. Torres, Ed.D, MSW signed off.

There are questions whether the law allows a County Administrator, instead of the Board, to sign off on Resolutions to implement a tax measure authorizing the issuance of bonds, in this case, a huge bond.

L.A. County Counsel once again missed the questions, just ask Richard Michel, the voice crying in the

are outstanding, be adopted, requiring oversight, and all funds invested in local schools?"

Similar to DUSD and Bassett, the ballot label does not comply with Education Code section 15272; absent are the words "appoint a citizens'... committee" and "conduct annual audits"?

Election Code section 13119 provides for the "Shall the measure be adopted?" The language is there, but not ending with the question as dictated by the Code.

IUSD's Ballot Label violated the Election Code.

Further, Section 13119(b) requires the disclosure of not only the amount of money to be raised annually, but also the rate and duration of the tax.

IUSD's Ballot Label violated the Election Code, whe the lawyers used "at legal rates" and "while bonds are outstanding" in the Ballot Label.

The worst sentence construction in the world appears on ballot labels, intentionally. Just ask FM3.

Section 13119(d)(1) says "For purposes of this Section (13119), the following term have the following meaning: Local governing body means the governing body of a city, county, city and county (thank you San Francisco), including a charter city or charter county, or district, including a school district."

The law clearly does not authorize a County Administrator to impose \$469 Million in taxes on residents.

Finally, Election Code section 9500 states that "the county elections official shall transmit a copy of the measure to the county counsel who shall prepare an impartial analysis showing the effect of the measure on existing law and the operation of the measure.

County Counsel's impartial analysis, penned by Mary C. Wickham, now Judge Wickham, stated:

"Approval of Measure I ('Measure") would authorize the County Administrator ("County Administrator") of the Inglewood Unified School District ("District"), which placed the Measure on the ballot by Resolution No. 05/2020-2021, to issue general obligation bonds in an amount not to exceed \$240,000,000."

The impartial analysis completely ignored Section 13119 regarding the Governing Board of the District and inserted County Administrator. The impartial analysis does not contain the statement indicating that the measure was placed on the ballot by the governing board of the district.

Geoffrey Chaucer in Canterbury Tales wrote, "doctors & druggists wash each other's hands;" the same can be applied to the County Administrator and County Counsel.

Similar to the other bonds, minimal donations came from IUSD residents, most of them were from the Megataxer Network; architects, contractors, engineers, inspectors, and material suppliers.

Roy Rivas signed on as Treasurer and David L. Gould as Assistant Treasurer. No one knows who Roy Rivas is; Gould runs his shop out of Long Beach, hiding committee information behind his office address.

True to the Gould Way, the Campaign Statement does not show a Controlling Officeholder, Candidate, or Responsible Officer of Sponsor.

The Megataxer Network stepped up: Ohrbach Huff Suarez & Henderson, LLP gave \$5,000. Lawyers.

School Business Advisors in Newport Beach contributed \$1,000. Consultants.

C.A. Architects popped for \$10,000.

Dannis Woliver Kelley tossed in \$4,000. More lawyers. Harvey Ellis Devereaux (HED)

Architects, \$10,000,
Cerritos-based Atkinson, Andelson,

Passed using compromised board members, bogus ballots labels, statements and tax measures, questionable impartial analyses by L.A. County Counsel, and a conflict of interest between two L.A. County agencies.

### Metropolitan Water Calls on Residents to Conserve Water

#### BY JESSE CORREA

In response to worsening drought conditions, the board of Southern California's regional water wholesaler will consider declared a Water Supply Alert this past Tuesday, that calling upon residents to voluntarily conserve the precious resource.

According to MWD officials, SoCal's water supply has been severely impacted by extreme drought in both the Sierras and the Colorado River, saying storage reservoirs are at an all-time low.

The action calls for water agencies and consumers in Southern California to voluntarily reduce usage.

On Monday, the U.S. Bureau of Reclamation declared the first-ever mandatory water cutbacks for Arizona, Nevada and Mexico next year due to a shortage on the Colorado River.

The federal government's declaration comes as Nevada's Lake Mead, the river's biggest reservoir, measures at its lowest level since the reservoir was created by construction of the Hoover Dam in the 1930s

MWD GM Adel Hagekhalil said Lake Mead's low levels should be a wake-up call

"The Colorado River is sending us a clear message: conserve, reuse and recycle," Hagekhalil said. "The river has been a lifeline for Southern California for more than 80 years. This shortage announcement moves the river into a new era and reinforces the need for Southern Californians to use less water to preserve this critical supply."

He noted that the next chapter in the history of the river must be "one of collaboration and historic action to stabilize a supply that is so vital to seven states and two countries."

Metropolitan's action on Tuesday urging conservation would also support Gov. Gavin Newsom's call last month for Californians to voluntarily reduce water use by 15% amid worsening conditions across the

### **Southland Home Prices Continue to Set Records**

The July median is up 17.5% but see a cool-down.

SoCal home prices soared to new heights in July, although the pace of increase slowed, with the six-county region's median sales price reached nearly \$682,000 in July, up 17.5% from a year earlier but lower than the 20%-plus gains recorded since April; sales rose nearly 10%

The housing market has been red hot with the pandemic boosting demand, a desire for more space and rock-bottom interest rates.

But recently there have been signs things are slowing down

In July, 17% of consumers thought it was a good time to buy a home in California, down from 31% a year earlier.

In Riverside County, the median sales price rose over 23% to a record \$525,000, while sales climbed nearly 7%.

In San Bernardino County, the median sales price rose 21% to a record \$455,000, while sales climbed 4%.

In Los Angeles County, the median sales price rose 18.7% to a record \$795,000, while sales rose 20%.

In Orange County, the median sales price rose 16.6% to a record \$904,000, while sales climbed 5%.

In San Diego County, the median sales price rose 15.2% to \$730,500, while sales climbed 4.3%.

In Ventura County, the median sales price rose 16.5% to \$735,000, while sales climbed 10%.

### Artesia Begins Its Safe Neighborhood Program

The City of Artesia held its National Night Out event August 3, 2021. NNO provides residents and public safety officers with the environment to foster stronger relationships through positive interaction. This year the City introduced the Safer Neighborhoods Program at the event. City Council also proclaimed August as Safer Neighborhoods month to increase community awareness of the program.

The awareness campaign will be promoted through several different events and on social media. Encouraging residents to become more involved in their local Neighborhood Watch is a major goal of the program.

Residents are encouraged to participate with yard signs. These signs come in two sizes so that homeowners and apartments can display them correctly. The signs include contact information for City Hall and information regarding the Neighborhood Watch Program. In addition, city staff coordinated with Public Safety officers to resume monthly in-person block captain meetings.

Designed for community members who may not attend formal Watch meetings or may be hesitant to do so, scheduled officer drop-ins already exist at adult park programs, enabling residents an informal way to advance relationships with Special Assignment Deputies.

The City is working with Los Angeles County Supervisor Janice Hahn to provide wellness vans that will conduct regular visits to A.J. Padelford Park and Artesia Park. These vans will provide mobile health services to check interested residents for diabetes, blood pressure, vitals and other health concerns.

As part of their efforts to improve public safety, the City will offer a Home Security and Alarm Rebate program for Artesia homeowners. Those who purchase an eligible alarm system can receive a rebate of up to \$250. The program is currently advertised
