# Norwalk Holds First Hybrid Community Forum of 2022

On March 31, 2022, the City of Norwalk held its first hybrid Community Forum event of 2022. The event took place at Paddison Elementary School, the first time that the event had been held at that location.

The conflict is tripled, with two other elected officials, current Mayor pro tem Chuong Vo and Councilmember Naresh Solanki, took \$10,000 and \$1,500 from the CAS, respectively.

And the Johnson money spigot did not stop.

Additional documents show that Johnson recently took \$1,000 from embattled LASD Sheriff Alex Villanueva.

In a Los Angeles Times opinion piece this past Sunday entitled, "The sheriff saga gets odder — and more destructive," the editorial board wrote, "Alex Villanueva's irresponsible comments offer a window into his dishonest character."

Villanueva's donation sets up yet another blatant conflict of interest; Cerritos pays upwards of \$14 million annually to the LASD, whose own station is in the city.

Johnson is also a field representative for Villanueva; with the station in Cerritos, some have leveled charges of incompatible offices between the LASD and Johnson if she is elected.

Those same documents show a \$4,900 donation for the International Brotherhood of Electrical Workers-IBEW Local 11 Political Action Committee based in Pasadena.

The total special interest money Johnson has garnered is upwards of \$21,000 for a job that pays \$29,000 annually. The remainder of her donations are small and total \$10,000.

# **Special Interest-**

Johnson cashed \$5,000 in checks from top executives of the Newport Beach-based developer Picerne Group who built the high-end Aria apartments in Cerritos. Another \$5,000 came

The Central Basin Municipal Water District (District) has made unprecedented improvements in operational performance, fiscal responsibility, customer satisfaction, and cost controls. As a result of these significant achievements, the District has made great strides toward building community trust and establishing itself as a strategic leader in the region.

Over the past year, the District's goals have been to lower the cost of imported water, strengthen long-term fiscal stability, improve customer service, diversify revenue streams, and grow recycled water services. A review of these accomplishments demonstrates the District's strong commitment to the region at a time when inter-agency collaboration and investment in local projects is critical to addressing potentially prolonged drought conditions.

"The District's Board is very pleased with the thoughtful planning and execution that has led to such a positive fiscal and operating position. Our new general manager and staff have done a stellar job of leveraging the District's potential to improve the reliability and quality of water for our customers."

# To date, the District's substantial accomplishments have included:

- Regaining fiscal control of the Central Basin Municipal Water District budget through lower costs while diversifying revenes.
- Reducing fixed costs for customers by approximately \$300,000 per year using efficiencies of scale within the organization.
- Approving \$1.5 million in grants for recycled water system expansion to improve local water supply reliability – specifically to disadvantaged local communities.
- Approving a 14% reduction in imported water rates for customers, despite a projected statewide drought, to ensure affordability.
- Investing in recycled water projects across the District's service area, with a focus on increasing investments in Under-Served or Disadvantaged Communities (DAC) that have contributed to Southern California's water infrastructure through property taxes but have not received sufficient re-investment in local water infrastructure systems.
- Generating the highest level of average monthly operating and unrestricted cash reserves since 2016 \$12 million dollars ending January 31, 2022 with \$28.2 million in unrestricted and restricted cash reserves.



• Receiving an unprecedented improvement in the District's credit rating (A3) by both Standard & Poor's and Moody's, which raised the quality of the District's credit rating after a review of the District's progress over the past 16 months and an analysis of the District's refunding of outstanding bonds which will save \$2.5-\$3.0 million dollars without extending the term of the bond obligation.

"The upgrades primarily reflect the district board's continued progress towards achieving stable financial performance and metrics in fiscal years 2020 (audited) and 2021 (estimated results). In addition, with the appointment of a new general manager and general counsel during the past year, we recognize the improved management administration and the effects of better-than-projected financial performance. We believe these corrective board actions set a trajectory for the district meeting its financial obligations and that the actions comply with the district's rate covenant requirements."


The California Department of Water Resources (DWR) recetly awarded the District funds for the expansion of recycled water systems in DAC identified areas. The District has identified nine public facilities in the cities of Bell, Bellflower, Compton, Huntington Park, South Gate, and Whittier that would benefit from converting parts of their irrigation systems from using drinkable water to recycled water. One of the benefits of these projects is reducing the region's reliance on imported water by using locally-produced recycled water, increasing overall reliability and reducing the need for potable water from other sources.

"It's important to remember that one of the principal reasons Central Basin was able to lower water rates is that we have taken prudent measures to regain fiscal control of our budget. We set goals for lowering costs, expanding service, diversifying revenue, and ensuring financial stability, and we have accomplished those goals."

# Second Death of Infant Expands Recall of Formula

On Feb. 28, 2022 the FDA reported the death of an infant from powdered infant formula.

Now, contaminated powdered infant formula may have contributed to the death of a second baby, so federal officials have expanded its recall of formula produced at the Michigan facility of Abbott Nutrition, the makers of Similac, Alimentum, and EleCare.

The recalled formula was distributed in the U.S. and Israel and is a specialty product for certain infants who benefit from lowered mineral intake.

The CDC announced on Monday another illness of Cronobacter sakazakii from exposure to powdered infant formula produced at Abbott Nutrition's Sturgis, Mich. facility – an infection that may have been a contributing cause of death for the child. The child who died was reported to have been fed Abbott Nutrition's Similac PM 60/40 product with lot code 27032K800 prior to infection, the FDA reported Monday.

The FDA and CDC's powdered infant formula was expanded to include Similac PM 60/40 with lot code 27032K80 (can) and 27032K800 (case).


It was not included in the recall announced two weeks ago.


In the Feb. 17 recall, Abbott recalled its Similac, Alimentum, and EleCare powder formulas with an expiration date of April 1 produced at the Sturgis, Mich. plant, where evidence of Cronobacter sakazakii was found in non-product areas. Evidence of Salmonella Newport was not found, the FDA said.

Liquid formulas and powder formulas produced at other facilities were not included in the recall.

Atotal of five children have been hospitalized after being exposed to the recalled formula -- four reports of Cronobacter sakazakii infections have been reported to the FDA and the CDC, and one complaint of a Salmonella Newport infection. At this time, Cronobacter may have contributed to death in two patients, the FDA said.

Cronobacter bacteria can cause severe sepsis or meningitis, with symptoms including poor feeding, irritability, temperature change, jaundice, grunting breaths, and abnormal movements. Consumers should not use the recalled Similac, Alimentum, or EleCare powdered infant for-





mulas, which can be identified by their 7-to-9-digit code and expiration date on the bottom of the package and include all of the following:

The first two digits of the code are 22 through 37. The code on the container contains K8, SH, or Z2. The expiration date is 4-1-2022 or later.

Parents can also visit similacrecall.com to check if their product is part of the recall.

# **Supervisors Suspend All Travel to Texas and Florida**

The LA County Supervisors voted unanimously Tuesday to suspend all official travel to Texas and Florida due to highly publicized policies directed at LG-BTQ+ youth and families.

The move came in response to measures taken in both states. In Texas, Gov. Greg Abbott ordered that gender-affirming treatments provided to transgender youth be investigated as child abuse. The declaration has led health providers in that state to suspend the treatments.

In Florida, Gov. Ron DeSantis recently signed into law the Parental Rights in Education Bill, which restricts instruction about sexual orientation and gender identity in early grades. Critics have dubbed the measure the "Don't Say Gay" law.


In their motion, Kuehl and Solis said the Texas order "flies in the face of all that we know about best practices when it comes to supporting children and young adults to discover who they are and feel secure in their sense of self. This order is discriminatory, harmful and just plain cruel. It will perpetuate a culture of bullying, secrecy, shame and fear."

Abbott's declaration followed an opinion issued by that state's AG declaring that gender-affirming treatments fall are child abuse under state law. Abbott then ordered the state to investigate any instances of minors undergoing "elective procedures for gender transitioning."

In Florida, DeSantis has defended that state's legislation, saying it "a commitment to education, not indoctrination."

"As the parent of three kids that are aged 5 and under, thank you for letting me and my wife be able to send our kids to kindergarten without them being sexualized" he said

# **Hydrogen Home** of the Future Soon to be in Downey

It will use clean energy 24 hours a day & 365 days a year, by drawing power from solar panels and converting excess energy into hydrogen, which can be stored and converted back into electricity.

n efforts to support clean energy, Southern California Gas Company (So-CalGas) recently began assembly of a H2 Hydrogen Home prototype in Downey.

The award-winning and first of its kind project features an approximately 2,000 square-foot home with solar panels, a battery and an electrolyzer that converts solar energy into hydrogen with a fuel cell that supplies electricity throughout the home. The hydrogen is blended with up to 20 percent natural gas for the use of a tank-less water heater, clothes dryer, gas oven, fireplace, and barbeque

According to SoCalGas, the home will function and feel exactly like a regular home but use reliable and clean energy 24 hours a day, 7 days a week, 365 days a year, by drawing power from solar panels on sunny days and

converting excess energy into clean hydrogen, which can be stored and then converted back into electricity.

"Hydrogen as a clean en-

ergy source has been safely produced, transported, and used for many decades across a wide range of industrial applications," SoCalGas spokesperson Brian Haas explained. "Practices of its safe handling are well established. From our side, SoCalGas has bestin-class practices, processes, and procedures for the safe operation of our natural gas transmission and distribution assets and will leverage this experience for hydrogen."

The H2 Hydrogen Home's anticipated completion date will be sometime around late summer this year.

"We believe this is the first of its kind as configured in the United States," Haas said.

"Specific to the H2 Hydrogen Home, green hydrogen is a means to fill gaps caused by the intermittency of renewable electric generation, coupled with daily and seasonal variability of demand, and even protect against the threat of wildfires," Haas added. "A key part of our strategy to achieve is pursuing [our] climate objectives with an increased focus on the use of clean fuels like hydrogen and renewable natural gas."

According to the National Renewable Energy Laboratory's LA100: The Los Angeles 100% Renewable Energy Study" ("LA100 Study"), dispatchable power generation assets "form an insurance policy to keep the lights on when things go wrong, including bad weather, hot weather, and fires that take down transmission lines."

The home itself acts as a miniature micro-grid, storing and providing low-carbon power when energy is needed, and demonstrates how this energy system could be constructed on a larger scale to power residential and business neighborhoods, according to SoCalGas.

"For the past decade, So-CalGas has invested in hydrogen research and development, recognizing it as a critical component of our transition to net-zero emissions," said Maryam Brown, SoCalGas President.



tinued study and investment in this technology, we can continue further decarbonizing of other industries that have thus far been difficult to make progress in such as airfreight, port operations, and air transportation."

Earlier this year President Biden signed the Infrastructure Investment and Jobs Act (commonly known as the Bipartisan Infrastructure Bill) which includes \$9.5 billion for clean hydrogen hubs. Last month, Archuleta convened the Select Committee on Hydrogen Energy to discuss the hubs further.

"California is a world leader when it comes to hydrogen investments and technologies, and the goal of this committee is to highlight how California can become even more of a leader if we are to secure these federal grants,"

"Not only is California the nation's largest state by both population and economy, [we are] also the leader in hydrogen, having already invested \$242 million to support hydrogen research, development, and deployment projects." Archuleta added. "With a proven track record in the hydrogen space, California is uniquely positioned to develop a regional U.S. clean hydrogen hub and to position the U.S. as a global leader in

clean hydrogen technology." According to California Assemblymember of the 58th District Cristina Garcia, the H2 Hydrogen Home is a tangible example of the innovative technologies and clean energy systems that we will need to meet our net-zero carbon goal by 2045.

"As we shift toward a future of renewable electricity in California, we will rely on a variety of energy solutions. including hydrogen and advanced fuel cells to create a more resilient grid," she said. "I am proud that this first in the nation example will be showcased in the 58th dis-

Downey Councilmember and former Mayor Claudia Frometa also proudly said, "ever since the days of the Apollo Space Systems, Downey has been at the forefront of new and developing technologies. Now we are

excited to be a part of this historic moment in furthering the development of green hy-

The cost of the H2 Hydrogen Home has yet to be revealed as it is not completed. It has been in development since 2020 in collaboration with Canadian company ATCO, who spearheaded a similar project called the Clean Energy Innovation Hub. SoCalGas is striving to develop it in the most cost-effective way possible with the idea that costs could be reduced if the technology were to be adopted,

according to Haas. "One of the main objectives of this demonstration is to be able to assess questions like potential future cost savings if this technology were deployed at scale," he added.

Since March 2021, SoCal-Gas has been the largest gas distribution utility in North America to set a net zero target for greenhouse gas emissions in its operations and delivery of energy by the year 2045. Their mission is to build the cleanest, safest, and most innovative energy company in America.

"As the largest local gas distribution company in California and the nation, it is important for us to lead, recognizing that cooperation among utilities, policymakers, businesses, and the communities we serve is essential

to successfully decarbonize the energy system of the future," Haas said.

"We see green hydrogen as an essential tool for hardto-decarbonize sectors, like cement and steel manufacturing," he added. "These are industrial processes that produce important goods but cannot easily be electrified. By switching from coal, natural gas, or other fossil fuels to green hydrogen, the greenhouse gas emissions from those processes will be dramatically reduced."

With an eye on the future SoCalGas is actively engaged in more than 10 pilot projects related to hydrogen. They have partnered with the Green Hydrogen Coalition, Los Angeles Department of Water and Power (LADWP) and other key partners on HyDeal L.A., an initiative to achieve at-scale green hydrogen procurement at \$1.50/kilogram in the Los Angeles Basin by 2030. SoCalGas is also testing and demonstrating transporting hydrogen using existing infrastructure and is collaborating with California's other gas utilities and with research institutions to develop a hydrogen blending standard for regulatory review.

# Gibbs Near Perfect While Cerritos Offense Blasts John Glenn

When Cerritos High paid a visit to John Glenn High last Friday evening, senior pitcher Erin Gibbs said she wasn't thinking about a no-hitter or a perfect game. All she was thinking about was getting through each inning and ending the game early.

In what she called her best throwing game of the season, Gibbs carried out what she wanted to do, throwing a perfect game through the first four innings as the Dons crushed the up and coming Eagles 15-0. It was the second time in three days that Cerritos had scored 15 runs against a 605 League opponent.

"I would say that the energy we had and the support I have from my teammates really helped me out," said Gibbs. "I knew I just had to go out there and hit my spots and that everything would take care of itself."

"It was a good performance," said Cerritos head coach Todd Denhart. "Obviously, she's not where she was a year ago. But it was better [than other games this season]. She was hitting her spots, moving the ball in and out, up and down. And I don't want to take anything away from [Glenn]. That's a good team; they're on the rise."

Gibbs threw six pitches in the bottom of the first inning, 10 in the second, eight in the third and 14 in the fourth. Of the first 12 batters she faced, she was ahead in the count seven times, includ-

ing a 0-2 count five times, all of which ended in a strikeout. Gibbs struck out at least two batters in the final four innings and ended the game with 11 strikeouts out of the 17 batters she faced.

out of the 17 batters she faced.
"I just felt like I didn't really have
the performance I wanted on

Wednesday," said Gibbs.
"Just coming back and knowing what I needed to do...I had a really good bullpen [session] before the game. So, knowing that, I just had to work with my catcher and hit my spots."

"Just pounding the strike zone more than she has previously," said Denhart of the first three innings. "We talk about it; not working harder than you have to. She was throwing balls in the strike zone, and she was getting swings and misses."

Gibbs did not reach a two-ball count until she had a 2-2 count on junior short-stop Beatriz Galvez with one out in the top of the fourth, then got her to foul off two pitches before striking her out. In the next inning, he had two strikes on sophomore catcher Julia Cole, who then laced a double to the right field gap to end the perfect game. Cole was the only Glenn player to hit the ball hard as she sharply lined out to sophomore right fielder Presley Hendrix to lead off the second

"It was just a missed rise ball that didn't get high enough," said Gibbs. "My rise ball had been working all game, so it was just one missed spot and I had to just come back better the next time."

"The girl had a good at-bat," said

Denhart. "She takes a decent pitch and puts the bat on it. She hit the ball the last time up, too. That's baseball, that's softball."

After two straight strikeouts on a total of eight pitches, Gibbs had her tough-

est challenge of the game, throwing 11 pitches to sophomore third baseman Aileen Lopez

before walking her on the 12th pitch. But she ended the game with a four-pitch strikeout to sophomore first baseman Anais Perez. Gibbs threw 66 pitches in the game and improved her season record to 7-1.

She now has a pair of one-hit games and a trio of two-hit games this

Offensively, Cerritos only needed the two runs it scored in the first inning to back Gibbs. With one out, Glenn freshman pitcher Carissa Galvan walked junior center fielder Camille Lara before senior second baseman Katelyn Caneda launched her first home run of the season. Galvan settled down in the next inning before the Dons sent 12 batters to the plate in the third inning to turn the contest into a rout.

Cerritos had five hits in the inning, including the first home run of the season from senior shortstop Jadyn Nielsen. She would later add a two-run single to cap off the seven-run frame. But the Eagles didn't help themselves in the inning as they committed three errors leading to five unearned runs.

"Unfortunately, when this team gets behind early, there's no fighting," said Glenn head coach Larry Leal. "That's one of the problems with this team. [Cerritos] hit the ball over the fence and that was it."

The Dons continued to hit Galvan hard in the fourth inning, as a two-out single from Hendrix loaded the bases for junior left fielder Catherine Quibrantar, whose two-run single plated sophomore third baseman Toafaoalii Pua and freshman catcher Alianna Calderon. Galvan then walked Nielsen to load the bases before Lara mare it 13-0 with a single to the right field gap.

Galvan is getting a lot of time in the circle in her first year of high school but is now 2-7 and some would wonder why Galvan was still in the game, especially after yielding seven runs in the third. But Leal said she was going to go the distance no matter what, unless she got injured.

"We were calling her pitches and she has a really, really good rise ball, but it wasn't working," said Leal. "She just wasn't hitting her spots today."

After a 16-0 home win against Oxford Academy this past Tuesday, the Dons improved to 10-1 overall and 6-0 in the 605 League. Cerritos, which had previously cancelled non-league games against Gahr High and Warren High, was to have visited La Mirada High on Apr. 7. But that game was also cancelled, leaving the team with five remaining in the regular season.

The first of those is today against Whitney High, followed by a meeting at Pioneer High on Tuesday and the rematch with Glenn on Thursday, the final regular season home game for six seniors. However, it took the Dons less than a month (Feb. 16-Mar. 4) to play their first five games and two weeks (Mar. 18-Apr. 1) to play their first five league games.

"We've had some stuff go on here that is beyond our control," said Denhart. "I think the team as a group has done a good job of adapting. They've been putting the work in at practice and hopefully we don't hit any more speed bumps the rest of the year.

"I hope we haven't peaked yet," Denhart later added. "I'd like to peak a little bit later in the year, kind of like we did last year. But I don't know. Maybe we have; we'll find out. Hopefully, we don't peak, then take a bow. Maybe we peak and level off, hopefully. We're playing okay right now."

It's a different story for Glenn, which is trying to build off last season's 10-6 campaign and the program's first trip to the CIF-Southern Section playoffs for the first time since 1990. The Eagles, who were shutout by arch-rival Artesia High 13-0 this past Tuesday, dropped to 11-10 overall and 2-3 in league. When the team is on, it is on as Glenn began the season with 68 runs scored in the first four wins. But the Eagles went through a three-game losing streak in which they allowed 47 runs and was shocked by Pioneer 12-11 in walk-off fashion on Mar. 18, begging the question which Glenn team is going to show up on gameday?

"That's what we ask them after every game," said Leal. "Right before they're warming up, we ask them, 'who's going to play today? Who's ready to play?" They all say they are, but obviously they didn't today."

Glenn hosts Pioneer today and Oxford Academy on Tuesday as it hopes to stay in the hunt for second place.

"That's what we're looking for," said Leal. "We were looking forward to this one, at least in competing, but it didn't work out. We're really looking forward to the Pioneer rematch, but we try to get ready for every game."

# Gahr Navigates Through Speed Bumps to Earn First Round Win in Prestigious Tournament

CYPRESS-For at least one night, Gahr High baseball head coach Gerardo Perez was glad that his team did not have a speed bump.

The 4-10 record the Gladiators brought into the 32nd National Classic Baseball Tournament this past Monday is a bit misleading, considering six losses have been by one run, four of which were against CIF-Southern Section Division 1 teams.

Gahr has blown leads in half of its losses with the game-winning runs coming in the sixth inning twice and in the seventh inning another two times. Perez has had to play musical chairs with his players because of injuries but he and his team felt relieved when the

Gladiators knocked off Las Vegas-based Desert Oasis High 5-3 at Cypress High. The Diamondbacks are one of Nevada's top programs, winning the 2019 4A state championship.

"When we have everybody healthy and everybody in the right place, I think we can handle speed bumps a little bit better along the way," said Perez. "We have pitchers starting for the first time, or the second time all year. We have guys closing for the first time all year."

Starting on the mound was junior pitcher Jaden Alba, who got roughed up by Dana Hills High on Mar. 26. Behind the plate for the second time this season was sophomore Chris Johnson and senior Steven Thompson Jr. was closing his first game of the season. But one of the biggest changes was junior Kyle Panganiban who was starting for senior Ethan Kang in center. Kang, who according to Perez is the best center fielder in the area and is recovering from a heel injury he had last Saturday. Kang is expected to be ready next week when San Gabriel Valley League action begins.

"It's a good team win; we all pulled on the same end of the rope," said Perez. "I think we had some dominant pitching, to be honest with you, and that's a pretty good Desert Oasis team."

After stranding the bases loaded in the top of the first inning, Gahr struck first in the next inning when junior second baseman Alahni Salcedo

singled to right and scored on a basesloaded groundout from Panganiban. The Diamondbacks tied the game in the bottom of the third when Alba hit Robin Vergara on the first pitch and scored on a groundout from Gavin Mansell.

But Gahr would get the inning it needed in the fourth when Johnson reached on a fielder's choice and moved to third on a double down the left field line from senior left fielder Alex Hernandez. Two pitches later, Panganiban went opposite and laced a triple down the right field line to make it 3-1. He would score when junior shortstop Angel Cortez singled.

The final run for the Gladiators came in the seventh when senior pinch runner Jacob Mendez scored on a groundout from Hernandez. Gahr had nine hits with Salcedo going three for three and Panganiban two for three with three runs batted in.

Alba, who had a 1-1 count on Tyler Stott, was replaced by Thompson Jr. who struck out the batter as well as Joel Castro to end the inning. At one point, Alba and Thompson Jr. had retired 10 in a row.

"I think he was absolutely as good as...he was able to dominate a game with his fastball command," said Perez. "I'm not getting caught up on the strikeouts because he was really efficient."

Perez added that he wanted to error on the side of caution after the last pitch Alba threw, who told the longtime Gahr coach he 'kind of felt something'. Thompson Jr. had been starting for senior pitcher Cristen Banda, who has pitched less than three innings all season.

The Gladiators would drop a 3-2 decision to El Dorado High this past Tuesday and was outmatched by St. John Bosco High 14-3 this past Wednesday.

Gahr would face the loser of the South Hills High/San Dimas High game on Apr. 7 to wrap up the tournament, then jump into San Gabriel Valley League play on Monday against Downey High.

The two teams will meet again on Wednesday at Downey.

"With our schedule, which is really the toughest schedule, probably, in our division by far; with the number of injuries, and I don't make any excuses, but for us to withstand what we've gone through, I give our guys credit for still being a team, for still hanging in there and for still being positive," said Perez.

# Young Whitney Softball Team Going Through Growing Pains Under New Head Coach

Stephanie Machado knew her Whitney High softball team was going to take a lot of lumps this season. The first-year head coach and former Cerritos High standout replaced Burt Ogata, who lost all 13 games last season as the Wildcats were outscored 186-20 and forfeited a pair of games.

This season, Machado has already accomplished one of her goals-to get at least a win; Mar. 10 in an 11-9 victory against Costa Mesa High. And, the Wildcats have already scored 52 runs in 11 games. Whitney HAS dropped a 17-2 decision to Pioneer High this past Tuesday, followed by an 11-0 loss to Artesia High the next day to fall to 1-10 overall, 0-6 in 605 League play. Still, Machado isn't too disappointed of the results because the team has made strides since last season.

"For me, I think these girls are just learning the game better, learning the positions, learning the fundamentals," said Machado. "Today, we had somebody get the lead out at [second base] whereas in our first game with Cabrillo [on Feb. 13], that wasn't really on their mind. So, that's one thing I've been really proud of. Today's game in particular, we had just a few errors compared to one of our [two] Cabrillo games where we had 20."

Pioneer scored four times in each of the first two innings, three in the third, four in the fourth and twice in the fifth inning as the Wildcats were held to a pair of hits through four innings. Whitney had an opportunity to score in the bottom of the second as Hailey Gauthier walked junior left fielder Bianca Contreras, freshman pitcher Monicka Manni reached on a fielder's choice and Gauthier walked sophomore outfielder Ryleigh Shorts to load the bases; a strikeout ended that.

Whitney broke through in the fifth inning as with one out, center fielder Rebecca Simbol, the lone senior on the team, was hit by a pitch. Sophomore first baseman Kristen Sutton was safe on a fielder's choice and sophomore catcher Mariana Botello was hit to load the bases. Freshman third baseman Madison Velazquez went to first on a fielder's choice with Simbol out at home before a first-pitch single from freshman shortstop Chiugo Anyama plated both runs.

While Whitney has been part of five mercy rule games, it has scored at least 11 runs in three games, lost to Oxford Academy by a run on Apr. 1, fell to Cabrillo High in the season-opener by two runs and lost two other games by three runs. Knowing that the league this season is divided with Oxford Academy, Pioneer and Whitney all looking up at the playoff teams-Artesia, Cerritos and John Glenn High, Machado knows her team can hang with Oxford Academy and Pioneer when the 'Cats face both of them on the road on Thursday and Apr. 26 respectively for the final two games of the season. In the first meeting loss to Oxford Academy, Whitney had leads of 6-4, 8-5 and 10-7 before the Patriots scored five times in the top of the seventh.

"Our goal for this game was to minimize our errors," said Machado. "In general, our goal per game is less than 10. And for them, we wanted to score. We knew [Pioneer] would be tough because they had a close game with Artesia and Glenn. We weren't really thinking about winning. For us, it was to minimize our strikeouts, minimize our errors and score some runs. We did that.

"Game by game, we're just trying

to improve, especially when we have bouts of difficult teams together," she later added. "For us, if we can play really well against these teams, and we're hoping when we play Oxford, we can keep that same level...not have so many errors when we play them. Again, game by game getting better a little bit each time."

The Wildcats will visit Cerritos today and host Artesia on Tuesday.

In other softball action, **Artesia blast-ed Glenn 13-0 last** Friday and Whitney 11-0 this past Wednesday to move to 7-10 overall and 4-2 in the 605 League. The Pioneers travel to Oxford Academy today and host Pioneer on Thursday.

After splitting four games in the Michelle Carew Classic, Gahr High opened San Gabriel Valley League action with an 8-0 road win against Downey High this past Monday to improve to 12-8. The Gladiators visited Warren on Apr. 7 and will go to Dominguez High on Monday before hosting Paramount and Downey on Tuesday and Thursday, respectively.

La Mirada High moved to 14-6 after wins over Hillcrest High (4-1) and Chino High (10-1) last Saturday in the La Mirada Classic. The Matadores visit Bellflower today before facing South Hills High on Saturday in the first of two games.

frequently mentioned topics brought to the City's attention. Traffic enforcement, homelessness, street repairs, new development projects, and the state-mandated organic/food waste recycling program were all on the slate.

Residents were in attendance both virtually and in-person to have their questions answered by city staff. Key highlights from the presentations included:

Traffic enforcement improved this year compared to the end of 2021, which led to an overall reduction in vehicle collisions during this time.

The Homeless Operation Prevention and Engagement (HOPE) team has visited 599 locations, cleaned 39 encampments, and referred 413 individuals for support services.

Concrete work and asphalt replacement will be completed in Zone 28 (the neighborhood within Excelsior Dr., Norwalk Blvd., Alondra Blvd., and Pioneer Blvd.) by the end of April 2022. Work will also begin in other parts of the City this summer.

The Norwalk Entertainment District, Norwalk Transit Village, and Heart of Norwalk projects continue to seek feedback from the community to determine how these projects can best suit the com-

Plans for developing a Holiday Inn, Sprouts Farmers Market, and a second Chick-fil-A continue to move forward. The Sprouts is expected to open in the fall of this year.

A representative from Athens Trash Services clarified the SB 1383 organic/ food waste mandates that residents and businesses must comply with statewide. Athens created a recycling guide on its website to help residents determine how to use recycling bins properly.

The city says that additional community forums will occur throughout the year, announced in the Norwalk Now and the city's social media pages.

A recent HMG-CN investigation found that KC Towers was connected to the Picerne Group. High-level sources at Cerritos City Hall told HMG-CN there are plans for a large housing development in Cerritos at Bloomfield and South Street.

The HMG-CN investigation evidently hit home; during her closing remarks at a recent debate, instead of talking about her platform for Cerritos, Johnson criticized HMG-CN for reporting about the donations and that "everything was transparent."

Johnson never explained why such obscure companies would donate thousands to someone who has no municipal governing experience and was rejected by her fellow ABC School Board Trustees when she was pining for President of

Johnson has been surrounded by controversy during her political career, the latest when L.A. County Supervisor Janice Hahn demanded she resign from the Artesia Cemetery District's Board of Directors after an HMG-CN investigation into the board's finances revealed irregularities. As Board President, Johnson handed a lucrative contract to a friend of the board and violated the California Public Contract Code.

AN ORDINANCE OF THE CITY COUNCIL OF ARTESIA, CALIFORNIA, AMENDING VARIOUS PROVISIONS OF THE ARTESIA MUNICIPAL CODE REGARDING OVERSIZED VEHICLE PARKING AND FINDING THE ORDINANCE NOT SUBJECT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

If adopted, the proposed ordinance will apply citywide and prohibit oversized vehicles from parking on City streets (subject to certain exceptions). Covered vehicles include those weighing more than 6,000 pounds, exceeding 22 feet in length or 7 feet in height as well as camping trailers, campers, fifth wheel travel trailers, house cars, mobile homes, semi trailers, trailer coaches, and recreational vehciles. Certain oversized vehicles are exempted from the oversized vehicle parking prohibition, including: (1) vehicles parked in connection with the performance of a service at a nearby property; (2) oversized vehicles belonging to a federal, state, or local authority or public utility conducting official business; and (3) vehicles belonging to residents or guests of residents that are parked in accordance with a City-issued parking permit.

In addition to the foregoing, the proposed ordinance prohibits electrical, water, gas, telephone or utility connections between a property and an oversized vehicle from encroaching into the public right-of-way. The proposed ordinance also includes other minor amendments to the Artesia Municipal Code and the City's local amendments to the Los Angeles County Traffic Code (codified in Title 15 of the County's Code and adopted by reference by the City) to remove overlapping parking standards and ensure consistency across the City's oversized vehicle parking regulations. Copies of the proposed ordinance and the Los Angeles County Traffic Code are on file in the office of the City Clerk and available for public inspection.

Environmental: The proposed ordinance is not subject to the California Environmental Quality Act because: (a) the ordinance does not qualify as a "project" under CEQA because the ordinance will not result in a direct or reasonably foreseeable indirect physical change in the environment (State CEQA Guidelines section 15060, subd. (c)(2), (3); and (b) the ordinance falls within the common sense" exemption set forth in State CEQA Guidelines section 15061, subdivision (b) (3), which exempts activity from CEQA where "it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

If you challenge the proposed ordinance in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in the notice, or in written correspondence delivered to the City of Artesia City Council at or prior to the public hearing. high school students bustling in from their classes to what they thought was just another school assembly, another reason not the be in class.

The students were chatting and laughing or checking their phones for messages. Then the banner was removed. What was revealed were two vehicles that had crashed into one another headon. Across the hood was a young girl, arms draped over a smoking engine, the driver, a young man crying and holding his head as he sat behind the wheel. The second vehicle held three young girls. Two were crying and the third, covered in blood, sat deathly quiet. The Grim Reaper stood silently by.

Within a few minutes, students could hear simulated 9-1-1 calls over a loud-speaker, a police car with flashing lights and a screaming siren arrived on the scene. Again, over a loudspeaker, students could hear the policeman describe to dispatch the horror he was seeing. Still, the Grim Reaper stood silently by.

More police cars, two fire trucks and emergency vehicles, and three ambulances came to the scene, the whirl of an air ambulance filled the sky and a coroner's transport arrived on the scene. Firemen struggled to free the three girls who were whisked away, one through the helicopter. The young man, who was driving, was given a Field Sobriety test and was arrested. A yellow blanket was placed over the young girl thrown out through the windshield. The Grim Reaper began to pace.

The cries from the injured faded as they were taken aboard the ambulance and the screams of sirens faded. As the young girl, who had died, was taken away in a silent ambulance, Death silently followed with dozens of others who had died in similar situations.

The Grim Reaper pulled students from class every 15 minutes to become one of the 'living dead throughout the two-day program. These students then take part in an overnight retreat without contact with family or friends. They hear from people involved in or affected by drunken driving crashes during the retreat.

The event ended with a mock funeral school assembly on Thursday, featuring a video of the previous day's event and excerpts from living dead students. Law enforcement and medical responders also shared how they are affected by people's choices related to alcohol and drugs.

Although this was a staged crash involving students who were classified as "critically and fatally wounded" and transported via ambulance to local hospitals, and an "injured" student, arrested for drunk driving. It was a sobering reminder that every action has consequences.

Teenagers are constantly reminded about the choices they have to make involving alcohol and how many others are affected by their decisions. They know intellectual statistics. However, many teens share the belief it will never happen to them. This powerful program is designed to create awareness among students that they are not invincible. This program helps open the emotional doors for them to experience firsthand how their actions affect the lives of so many other people.
