New Aquatic Center Opens In Whittier

This past Saturday, October 29, Los Angeles County Supervisor Janice Hahn held a community Grand Opening celebration for the new Greater Whittier Regional Aquatic Center.

The new public aquatic center, which was spearheaded by Hahn and made possible with \$26M in funding allocated by her office, is in the unincorporated West Whittier-Los Nietos community on what was formerly a parking lot for Pioneer High School.

It is be operated by the Los Angeles County Department of Parks and Recreation and open to the public six-days-a-week year-round.

"Public pools are so important for neighborhoods," said Hahn. "And this one is stateof-the-art. Kids are going to learn to swim here, seniors and people of all ages can exercise, and the entire community will be able to cool off on a hot day.

Is a Registered Sex Offender Running for **Compton Community College Board?**

With Los Angeles city council dominating the news, the mainstream media has not been paying attention to other races in the area.

One, in particular, is the slate of candidates running for Compton Community College Board, including Central Basin Director Leticia Vasquez-Wilson and Skyy Fisher.

Readers of HMG-CN know all about Vasquez-Wilson and her antics and constant disruption of proceedings while Director of Central Basin.

Her most recent action, with her crony Director Martha Camacho Rodriguez following her, was to vote no for a 14% water rate decrease for Central dorsing.

CCCFE President Local 3486 Jeanette Morales wrote an email leaving a link to the Local's website flyer showing endorsements; the flyer did not endorse Fisher.

Morales did not respond when told about the 2Urban-Girls endorsement story; neither did 2UrbanGirls.

In 2014, HMG-CN was first to report that a man named Skyy Fisher, who was on the board of Compton Community College at the time, was arrested on charges of oral copulation on an unconscious person.

Fisher denied all the charges.; his spokesperson at the time was Jasmyne Cannick, a very good friend of Vasquez-Wilson.

At Meeting, ABC Board President Soo Yoo Said Her Racist Facebook Posts Were 'Out of Context'

Yoo packed the board room with supporters who ignored Yoo's racist posts, chastised speakers, and viciously attacked LCCN.

ABCUSD President of the Board and Assembly candidate Soo Yoo once again blasted the Los Cerritos Community News at a board meeting, this time taking the unprecedented step of reading a Trump-style hatefilled statement against this newspaper during her president's report.

"I want to address the false accusation that I am a racist," Yoo angrily stated, "it's all fabricated and false news. Hews News made false accusations and took my words out of context to frame me as a racist."

LCCN had recently published an article - backed by screenshots of Facebook posts by Ms. Yoo - posts that she called out of context.

LCCN also wrote, corroborated by residents who were present at the meetings, that Yoo said, "Blacks should get over slavery," "Mexicans should stop spending money

on Quiceaneras," and telling 13 and 15-year-old Latin students to "solve the drug problem among Latinos."

After riling up the partisan crowd against LCCN, the subject of her report changed and became a right-wing transpho-

bic racist rant.

"Realize that our state is failing the next generation," said Yoo, "pushing a far-left agenda of race, gender issues, and intervening in parent's rights."

Board Member Sophia Tse tried to intervene, but Yoo brushed her off with a malicious finger wave telling Tse to "stop." Noted Yoo crony Clerk of the Board Michael Eugenio, was also heard telling Tse to be quiet.



AG Rob Bonta, WRD Board Celebrate Anniv. of the Clean Water Act

The Water Replenishment District's (WRD) Board President John D. S. Allen, Director Vera Robles DeWitt, and Director Joy Langford proudly welcomed California Attorney General Rob Bonta at the Albert Robles Center (ARC) on October 27th celebrating the 50th anniversary of the Clean Water Act (CWA) which became law on October 18, 1972.

ARC is WRD's landmark facility that ensures a completely locally sustainable source of water for groundwater replenishment. This facility produces up to 14.8 million gallons of purified water per day, which is used to replenish groundwater aquifers in the Central and West Coast Groundwater Basins.

In response to visiting ARC, Attorney General Rob Bonta shared, "To see how WRD has leveraged funding that originated from the Clean Water Act is impressive. WRD built ARC to create a local and drought-resilient water supply. This facility is a clear demonstration of how the Clean Water Act promotes environmental justice. WRD's innovative planning will curtail the challenges that climate change poses for decades to come."

"We are proud to share ARC's success with Attorney General Rob Bonta," said WRD Board President John D. S. Allen. "This facility is the cornerstone of WRD's decades-long effort to build a sustainable water supply for the communities we serve."

When WRD was first established, 100% of the water supply used to replenish groundwater basins was imported. With the completion of ARC, 100% of the water used to replenish the groundwater basin at the spreading grounds is a combination of groundwater and recycled water.

The Clean Water Act paved the way for California's Clean Drinking Water State Revolving Fund which provided an \$80 million low-interest loan and a \$15 million grant to pay for ARC's approximately \$140 million cost of construction.



The Greater Whittier Regional Aquatic Center features two pools (a 50-meter by 25-yard competitive swimming pool and a 25-meter by 25-yard practice swimming pool), concrete bleachers for approximately 500 spectators, and a new building with changing rooms, showers, restrooms, and classrooms. The building also features a beautiful mosaic, commissioned by the LA County Department of Arts and Culture, by Rebeca Mendez titled "Underwater Sunlight," which covers the ceiling of the center and resembles the surface of a pool as seen from underwater. Outside the aquatic center is a new public park space with workout equipment and a playground.

The aquatic center is open Monday through Friday from 6:00am to 8:00pm and on Saturdays from 8:00am to 4:00pm. Programming will include swim lessons for all ages, swim team, aqua aerobics, water polo, lap swim, and "Everybody Swims" hours on Saturdays.

The Greater Whittier Regional Aquatic Center was made possible with funding allocated by Supervisor Hahn --\$17.9 million of Measure U, \$5.5 million of Proposition A excess funds through the Regional Park and Open Space District, \$3.1 million in Proposition 62 funding-- and a \$3 million State Parks Competitive grant.

RACIST POSTS BY SOO YOO - Ms. Yoo Denied Posting, Then Said 'They Were Taken Out of Context'

Yoo continued, "I cannot understand how such laws pass, it does not make sense, a majority of the people that I have talked to in the school district do not agree with the leftist agenda."

At the end of her report, Yoo reverted to blasting LCCN, producing a copy of LCCN's recent article and again using Trump-style red-meat tactics to attack LCCN "for publishing false information;" her statement in direct contradiction to the Facebook screenshots attached to the article.

The partisan crowd in the room booed, yelled and clapped when she finished her report blasting LCCN; but it did not stop there.

At public comment, Cerritos resident Sam Bedachi said, "Soo Yoo was a great president," then said, "no selfrespecting dead fish would allow themselves to be wrapped in LCCN."

"That was pretty funny," said one LCCN reader, "I always chuckle when people, in their own words, are telling you they read the paper."

Next was Mel Cortez, who criticized Soo Yoo for everything she had done and asked for a board censure and for her resignation. Cortez cited the three racist statements by Yoo concerning Blacks and Latinos. Cortez was booed and laughed at by the partisan crowd during and after his speech.

After Cortez, speaker after speaker praised Yoo, one lady from Fullerton saying, "I just came to speak about the situation" and "was not invited by Soo Yoo even though I know her." Later in her speech, the woman was admonished for campaigning for Yoo and criticizing her opponent Sharon Quirk-Silva.

It is the Clerk of the Board as a parliamentarian to manage meetings; Michael Eugenio is the Clerk. But Eugenio did not tell the lady to stop campaigning for Yoo; Boardmember Ernie Nishii was forced to shut her down.

Next was Sylvester Ani. Ani, an African-American and substitute teacher at ABCUSD, was extremely angry about the misinformation spewed at the meeting, including trying to excuse Yoo for her racist comments.

"A man played a recording earlier this evening where Ms. Yoo was heard saying, 'Black people need to get over slavery.' I was at that meeting, I heard it. Black people are going to have a problem with that statement Are you going to tell Jewish people to get over the holocaust?"

Ani continued, "we have folks talking about your candidacy for a race unrelated to this district and board meeting. If that's where your interests are, let



Companies Recalling Dry Shampoo Due to Cancer Risk

Unilever recalled popular brands of aerosol dry shampoo, including Dove, after discovering they were contaminated with a chemical called benzene that can cause cancer. The recall also covers brands such as Nexxus, Suave, Tresemmé and Tigi, which makes Rockaholic and Bed Head dry shampoos, according to a notice posted on the Food and Drug Administration's website Friday.

Unilever's recall pertains to products made prior to October 2021. The move once again raises questions about the safety of aerosols in personal-care products. In the past year and a half, a number of aerosol sunscreens have been pulled from shelves, such as Johnson & Johnson's Neutrogena, Edgewell Personal Care Co.'s Banana Boat and Beiersdorf AG's Coppertone along with spray-on antiperspirants like Procter & Gamble Co.'s Secret and Old Spice and Unilever's Suave. The recalls were set off by findings of benzene in such products by an analytical lab called Valisure, based in New Haven, Connecticut, starting in May 2021.

This isn't the first time spray-on dry shampoo has been identified as a problem. P&G tested its whole portfolio of aerosol products following Valisure's findings. The company then recalled its Pantene and Herbal Essences dry shampoos in December, citing benzene contamination.

"We are actively investigating this area," said Valisure Chief Executive Officer David Light.

The problem with aerosols has largely appeared to be from the propellants used to spray the personal-care products from the cans. Unilever said this was the case with its dry shampoo recall. The company did not release the amount of benzene found in the products, though said it was recalling them out of an abundance of caution. The FDA said "daily exposure to benzene in the recalled products at the levels detected in testing would not be expected to cause adverse health consequences." Yet the agency also said exposure to benzene can result in leukemia and other blood cancers.

Spray-on personal-care products like dry shampoos often contain propellants like propane and butane, which are petroleum distillates made by refining crude oil. Benzene is a known contaminant of petroleum products. The FDA has confirmed propellants are a potential source of benzene contamination.

While the FDA hasn't set benzene limits for cosmetics like dry shampoo, it does say the products shouldn't contain "any poisonous substance."

Top-selling dry shampoos including Not Your Mother's and Church & Dwight Co.'s Batiste contain high levels of benzene, the cancer-causing chemical that led Unilever to yank its product from shelves, according to a new independent study.

Valisure, a New Haven, Connecticutbased analytical laboratory, tested 148 batches from 34 brands of spray-on dry shampoo and found that 70% contained benzene. The chemical can cause certain blood cancers, such as leukemia.

An independent lab found that 70% of dry shampoos tested had potentially dangerous levels of benzene, a carcinogen.

\$55 Million for His District Senator Archuleta Delivers \$8.5 Million for Pico Rivera Project

Senator Bob Archuleta continues to bring resources needed to area cities.

Archuleta was joined by Pico Rivera Mayor Monica Sanchez, Councilmembers Gustavo Camacho and Andrew Lara along with Pico Rivera staff to celebrate the receipt of \$8.5 million.

The money is earmarked for the remodel of Rio Hondo Park with new soccer fields, a baseball field and a children's play area.

Archuleta also secured \$8.5 million for the Pico Rivera Aquatics Center for a full remodel.

In other areas, \$2.1 million went to Montebello for the downtown sewer improvement project; \$2.1 million to the city of Bellflower for their Youth and Senior Center; \$500,000 to Whittier for lighting installation at Murphy Ranch little league; \$2.9 million to Lakewood for their Equestrian Center improvements; \$3 million to Downey for the new Family YMCA; \$5 Million for the A.J Padelford Park expansion in Artesia to bring more open space and parkland to the city.

A.J. Padelford Park is located in the low income community of Artesia and is in desperate need of an expansion.

The park size has not changed since its development in 1973 and provides 0.47 acres per 1,000 residents which is significantly below the Los Angeles County average of 3.3 acres per 1,000 residents.

In addition to Artesia and other cities, Archuleta has secured over \$55 million for other projects throughout his district.

were in the majority.

Cannick defended Fisher in a statement, "There is absolutely no truth to the reports or rumors that the complaining witness in the case against Mr. Skyy Fisher is a minor or child. The arrest warrant describes the complaining witness as a "26-year-old male" and the alleged crime as pertaining to "violations of Penal Code section 288A(F)(1) P.C. Oral copulation of an unconscious person, Mr. Fisher expects to be fully exonerated and vindicated in this matter."

Skyy Fisher had been a lightning rod on the Compton Board.

He sparked an outcry when he called deceased Florida teen Trayvon Martin a "faggot black dude" and school Superintendent Karen Frison a "bitch" during a published podcasted interview.

At the time of the arrest, several community leaders called for the resignation of Mr. Fisher.

Two years later, Skyy Fisher was sentenced to six years, San Diego Superior Court Judge Runston Maino rejected Mr. Fisher's motion for a new trial and sentenced him to the middle term available under state law.

Later, a Skyy Fisher, who lives in Compton, registered on the Megan's Law website as a sex offender.

Several texts and emails into Skyy Fisher asking about the incident, using information from his skyyfisher.com website, went unanswered.

Emails into Vasquez-Wilson and her lawyer-husband Ron Wilson also went unanswered.

sex offender, can be found on the Megan's Law website.

HMG-CN informed Vasquez-Wilson that Fisher did not deny the email and texts from HMG-CN, but she did not respond, tacitly condoning Fisher's conviction and registration.

Banuelos also did not respond.

An examination of campaign documents show that Vasquez-Wilson, who recently moved into Carson, does not show any individual donors, with Vasquez-Wilson loaning her campaign \$30,000; \$20,000 on 9/10/22 and another \$10,000 on 9/24/22.Jan-Sept 2022 expenses show Vasquez-Wilson bombarding Area 5 residents with nearly \$12,000 in mailers and lawn signs.

Vasquez-Wilson kept up the pace showing another \$13,000 in campaign expenses for late Sept. thru Oct. 22.

Documents for other candidates show an average of \$6,000, with several individual donors for each candidate.

Based on her history, if she wins the seat, meetings will be full of Vasquez-Wilson cronies speaking ill of other members during public comment, and a no vote for nearly every agenda item, no matter the subject.

In 2021, Vasquez-Wilson, with Director Camacho Rodriguez, who votes with Vasquez-Wilson 99% of the time, showed that she could vote against an item that is hugely beneficial to constituents.

Both directors voted no to decrease water rates for Central Basin customers by 14%, which Central Basin President Art Chacon spearheaded; the **item passed 5-2.**

Cerritos High head coach Brad Carter had been waiting all season for a game that involved a diversity of scoring. Against John Glenn High last Fri-

were two safeties, two kickoff returns for touchdowns, an interception returned for a touchdown and four rushing touchdowns.

Most of those came in the opening quarter as the Dons crushed the Eagles 52-

20 in a contest that was over almost as soon as it began. Seven seconds into the game, Cerritos junior defensive back Diego Martinez recovered a fumble on the opening kickoff and Glenn wouldn't be the same. Four plays later, sophomore running back Kalib Moran scored on a one-yard run.

A deep kickoff from junior Moises Mendoza pinned the Eagles deep, which resulted in Cerritos junior lineman Jeremiah Bagaygay tackling Glenn junior punter Gabriel Vergara in the end zone for a safety. That was followed by a 65yard kickoff return from sophomore Dikshanta Adhikari on a reverse from junior quarterback Jake Bautista and just like that, it was 15-0 just over three minutes into the game.

The onslaught continued when junior defensive back Gabe Gaudi returned an interception 15 yards for a touchdown, then tackled Glenn senior running back Manny Sigala in the end zone for another safety within 11 seconds of each other. Moran would score again, this time from nine vards out and before the midway part of the quarter, it was 31-0.

"It was fun to see us start fast," said Carter. "Again, it was like a snowball. There was a safety, there was a [kickoff] returned for a touchdown, there was a pick-six. So, it was all positives for us and those were all great plays by everybody."

On the second play of the second quarter, Moran tacked on an 18-yard rushing touchdown and when the Dons got the ball back, Bautista added a 34yard score and a 45-0 lead. Glenn would avoid the goose egg when Sigala ended a nine-play, 57-yard drive with an eightyard touchdown run. But on the ensuing kickoff, Adhikari was at it again, returning the pigskin to the house 87 yards.

"Honestly, it was all up front," said Adhikari. "The blocking was great. I just saw the hole, ran full speed and just got there both times."

Although the Dons were up 52-6 at

controlling the clock with their 18:31-5:29 advantage. However, Cerritos was still outgaining Glenn 163-99 as Moran had 71 yards on seven carries and Bautista, who completed three of four passes, had to-

taled 81 vards in offense.

"He's a great teammate, man," said Adhikari of Moran. "We rely on him, and he just does his job. He never complains. Whatever coach needs him to do, he's out there and he'll get it done."

The second half was played under running clock conditions with the Cerritos backups running 16 plays for 60 yards while the Eagles got fourth quarter touchdowns from sophomore Tuiono Tuifua, who caught a 15-yard touchdown pass from senior quarterback Emmanuel Enriquez, and a 25-yard run from junior Adrien Aleman with 2:05 left in the contest.

Moran finished the game with 90 carries on eight touches while on defense, at least 20 players had at least one tackle, led by sophomore linebacker Devyn Chantha (five and a half), senior lineman Shayaan Ahmed (four and a half) and Bagaygay (three and a half).

"It feels good," said Adhikari. "We worked hard all season to earn this, and we just came out here, executed and everybody did their job to get the win."

There were other story lines besides the outcome of the game and craziness of the opening quarter. The win was the fourth straight for the Dons, who ended the regular season at 5-5. But it marked the third straight season Cerritos went

CIF-SS FOOTBALL PREVIEW TRIO OF AREA TEAMS HOST FIRST ROUND GAMES AS PLAYOFFS GET UNDERWAY

It's not often that more than one or two area football teams are home for the first round of the CIF-Southern Section divisional playoffs, but that's what lies ahead for Cerritos High, Norwalk High and Valley Christian High. The brackets were released this past Sunday and the latter two area teams are highly ranked, meaning if everything stays true to form, expect deep runs from Norwalk and Valley Christian. All three games are Friday at 7:00.

Rio Hondo Prep (8-1) @ #3 Norwalk High (9-1)-After seeing their eight-game winning streak snapped by Gahr High on Oct. 21, the Lancers bounced back with a 46-0 shutout against Firebaugh High last week for their third whitewash of the season and the fifth time Norwalk has allowed less than seven points. Despite the unexpected upset loss to Gahr, the Lancers were destined to grab one of the top four seeds.

"Based on the season we had, we felt pretty good about our work and the kids worked really, really hard," said Norwalk head coach Ruben Guerrero. "We thought whatever division we were in we should have been close to the top."

The Lancers racked up nearly 3,500 yards on the ground this season, thanks in part to seniors Michael Mueller (1,501 yards, 23 touchdowns) and David Herrera (1,080 yards, 17 touchdowns). However, Herrera missed nearly the final three games after an elbow injury in the first quarter of the Bellflower High game on Oct. 14 and his status for the first round game is uncertain. Still, Norwalk has always plugged in a replacement and this time, seniors Caden Barnhill and Anthony Martinez, who combined for 413 yards and nine touchdowns, will be asked to complement Mueller. Barnhill is also the quarterback but attempted 12 passes all season.

"If David can't go, we've kind of come together as a group and we've all come to the conclusion that everybody on this team has worked very, very hard to get here," said Guerrero. "It's going to take everybody; it's going to take a joint effort to have success here in the postseason."

Defensively, the Lancers are paced by senior Daniel Castillo (87 tackles, three sacks), junior Jesse Lopez (67 tackles, three sacks), Mueller (47 tackles) and Martinez (44 tackles). The Lancers also have picked off opposing signal callers 15 times. Rio Hondo Prep finished in second place in the Gold Coast League and began the season with seven straight wins. Last Friday, the Kares defeated Campbell Hall High 19-7, the fifth time they have held their opponents to less than 10 points. Rio Hondo Prep also has two shutouts and have yielded 101 points. Ryan McCulloch and Noah Penunuri have combined for 1,247 yards and 12 touchdowns with the former also catching 15 passes for 210 yards and three touchdowns. Nathan Curtis leads the Kares with 17 receptions for 397 yards and seven scores and on defense, it's Mc-Culloch (54 tackles, 12 sacks), Penunuri (37 tackles) and Curtis (30 tackles) leading the way. The Kares also have a dozen interceptions.

While it's not uncommon to see teams with three victories advance to the playoffs, the Defenders pulled off a rarity by grabbing the No. 2 seed as an at-large team despite winning one Ironwood League game and finishing in fifth place out of the six-team circuit.

To say that first-year head coach Nick Walker is ecstatic would be an understatement. Since he found out who and where the Defenders would be playing, he had not been off the phone most of this past Sunday. In fact, the prospects of going to the playoffs were talked about prior to last Friday's game at Village Christian High, a 23-0 loss.

"It's just god working in mysterious ways and giving us that actual opportunity," said Walker. "Like we told the boys, there's a possibility. We've seen crazier stuff happen and with that, we told them to be ready and [they] might get the Hudl information Sunday afternoon. They got it about noon today."

Walker cites the strength of schedule for the main reason why the Defenders are in the playoffs. League champion Aquinas High, whom V.C. lost to 50-14, is the fourth-seeded team in Division 5. El Dorado High, which began the season with a 35-0 win over the Defenders, went 7-3 and got an at-large berth in Division 6. Aliso Niguel High, a 35-14 winner in the third game of the season, advanced as an at-large team in Division 8 while Chino High, which edged V.C. 17-14 a week after the Aliso Niguel game, drew top-seeded Capistrano Valley Christian High in Division 11. "We played some really good teams, from El Dorado to Aliso Niguel to Aquinas to our league," said Walker. "Hats off to our league because we're a powerful league and I think we all deserve it. No game was given. Everybody worked hard and worked their tails off and put their best foot forward." In between the two shutout losses, the Defenders defeated Gahr High 42-9, Artesia High 46-0 and Big Bear High 35-21 for their three victories. However, in the other five games, V.C. failed to score 20 points, and for the season, it allowed over 25 points five times. The Vagueros were tied for first place in the Garden Grove League and their

LA MIRADA FOOTBALL SNUBBED FROM PLAYOFFS DESPITE PLAYING TOUGH SCHEDULE

When La Mirada High head football coach Mike Moschetti looked at his 2022 schedule in the offseason, he knew it was one of the toughest the program had ever had. In addition to their yearly meeting with Mater Dei High and four other nonleague games, the Matadores were situated in the Gateway League of the new Suburban Valley Conference and had to play Downey High and Warren High, among others.

As tough as the schedule was, the Matadores went 4-6, won two of five league games and any chance of an at-large berth was washed away when Moschetti saw the CIF-Southern Section divisional playoff brackets this past Sunday and his team wasn't on any of the 14 brackets.

"We knew going into the last two weeks that we needed to beat either Warren or beat Downey," said Moschetti. "Finding out today...it really hit us after the loss against Downey that we weren't going to make it. And it hurts. I think we had 41 consecutive years of being in the playoffs. I know we were the number one team in the state of California for consecutive playoff appearances.

"As the head coach, it's something that I have to live with," he continued. "I truly believe that I can always do better as a head coach and that's going to fall on me. I'm the guy that snapped the playoff streak."

This is the second straight season in which teams were grouped into their respective divisions once the season was over based off power rankings from Cal-Preps.com. La Mirada was ranked 110th out of 372 Southern Section teams. Warren, which won the Gateway League with a 9-1 mark, is ranked 19th and is in Division 2, second place Downey (8-2) is ranked 53rd and is in Division 4 while third place Mayfair High (6-4) is ranked 97th and is the top-seeded team in Division 7. The league automatically sends the top three teams to the playoffs.

La Mirada began the season with a

27-24 win at El Toro High before losing three straight games, including a 28-13 setback to undefeated Yorba Linda High, the fourth-seeded team in Division and a 35-0 loss to the nation's number one team, Mater Dei. In between those two games, the Matadores gave up a fourth quarter touchdown and fell to Servite High 10-

7. It was the only win of the season for the Friars. In league action, the Matadores came up short against Mayfair, 16-14, then lost to Warren (37-8) and Downey (43-21). The combined record of La Mirada's opponents this season was 54-46.

"That's something that we're going to have to look at," said Moschetti of future

non-league scheduling. "In the past, and even going into this year, I thought that playing a tough schedule will help your power ranking, even going into the new league...if we could find a way to win enough games, that we could possibly be an at-large team. We try to build our program of challenging these kids and we've played everybody over the years from Orange Lutheran to Bishop Amat to St. John Bosco to Mater Dei. It's something that we've always talked about as a program. But there's no reward for it, now, playing Mater Dei, Yorba Linda and Servite and scheduling an El Toro team that was really good a year ago and a Sunny Hills team that won a championship a couple of years ago."

The last time La Mirada had a losing record in a full 10-game schedule came in 2018 when the Matadores won two games but finished in second place in the Suburban League. The year before, they went 5-5 in the regular season before losing a first round Division 2 game.

Among the players that La Mirada graduates in June will be quarterback Nehuel Garcia, who passed for over 1,300 yards, their top three running backs, Tanner Roberts, Denver Stillman and C.J. Zackery, who combined for 16 of the

team's 17 rushing touchdowns, and their top two receivers, Xavier Hicks and Zackery.

"Looking back at the year, it's disappointjust ing," said Moschetti. "You could look at that Yorba Linda score and it says 28-13 and we dominated that game. I think they had 37 yards rushing. We moved the ball up and down the field. We had all the momentum

and that's a game we should have won. Servite...I don't think there's another type of public school around like we are that will schedule two Trinity League teams. We scheduled Servite after they played in a CIF Championship and not knowing what was going to happen this year."

Moschetti added that he doesn't understand how the new system works, and he doesn't know the formula and how it works. But he does understand how the power rankings work and realizes that the CIF-SS is doing a good job of getting equal teams playing each other in the playoffs.

"I don't like the old way where you're just put in a division," said Moschetti. "I like the aspect that if teams dominate, then they go up. The old way of teams winning three or four CIF championships in a row is never going to happen. La Habra coach [Frank] Mazzotta and I are really good friends and I have I have nothing but respect La Habra High School and their football program. They won four CIF championships in a row (2007-2010), but those days aren't going to happen again. Maybe in Division I it will. But I'm talking about Divisions 2, 3, 4; it's not going to happen again, and it's good."

In Division 3 action, Cerritos High had no problem with Bishop Montgomery High, 14-4 to improve to 13-6. The Dons will host fourth-seeded St. Margaret's High today.

lone setback came in the eighth game of the season when they fell to La Quinta High 12-10. Rancho Alamitos, which ended the season with a 10-0 win at Santiago High, has a 10-point win vs. Los Amigos High, a three-point win at La Sierra High, and one-point victories over Bolsa Grande High and Ocean View High on its resume. The Vaqueros scored 219 points while giving up roughly 10 points a game.

"When I looked [at the film], they're good," said Walker. "Don't get it wrong. At 9-1, they have a good team. They're disciplined and they play hard football. The fact to the matter for us, and it's been our motto all season, is execute. Refuse to lose, be the best that you can be, give 110 percent and I can't be mad at anything besides that."

When V.C. is on offense, Walker said his team needs to block, which has been 'a big de facto this year' in the close losses. Junior quarterback Joe DeYoung, who has come on strong as of late, will be the key factor to the success on this side of the ball.

"Joe has to complete his passes," said Walker. "His confidence is through the roof right now and he's playing good football. He had an off night [at Village Christian] and we'll give him that because he's played all season pretty decent. He's coming off a 326 yard passing day against Big Bear."

When the Defenders are on defense, Walker said his team needs to get to quarterback Chris Hurley and states that junior strong safety Isaiah Jordan will be the key if he can, 'make the correct reads and stop the run and tackle'. Other key components on defense will be seniors Casey Bouma, Nick Bozanic and Major Brown and sophomore JoJo Apisala.

"They're going to do what they do," he added. "They're really good ball players, but if Isaiah Jordan can put it all together and be that defensive stopper, I believe that we'll be in a good position." Dane High 50-46 last week. They have scored 279 points, but also surrendered 268 points.

But the strength of the offense lies with its running game, led by sophomore Kalib Moran (120 carries, 616 yards, 12 touchdowns), Bautista (53 carries, 320 yards, four touchdowns), junior Josh Park (53 carries, 259 yards, three touchdowns) and sophomore Dikshanta Adhikari (39 carries, 117 yards, two touchdowns). Moran is also the leading receiver with 24 catches for 309 yards and a touchdown while on defense, sophomore Nathaniel Crawford and junior Jeremiah Bagaygay lead the way with 87 and 59 tackles respectively. Both also have five sacks and have accounted for half the sacks the defense has. "I think Nate Crawford is going to be in the run box when you're in the middle," said Carter. "He's going to be in the middle of all the runs and I think is going to have a good game. Jeremiah Bagaygay is going to have an explosive game and then Nate Crawford's brother, Bailey; he's only a freshman, but he's really turned into a great lineman for us. It is a rare but indisputable fact that active shooter situations can now occur anytime, anywhere.

Experts say active-shooter incidents are on a slight rise and occur on average once a week in the United States, averaging 20 incidents annually occurring in the past decade alone. Common places include homes, churches, workplaces, and schools. Such incidents have been up by 50 percent since last year.

"In 2021, the FBI designated 61 shootings as active shooter incidents. In these incidents, 103 people were killed and 140 wounded, excluding the shooters. For 2017–2021, active shooter incident data reveals an upward trend. The number of active shooter incidents identified in 2021 represents a 52.5 percent increase from 2020 and a 96.6 percent increase from 2017," according to the FBI.

The FBI defines an active shooter as an individual actively engaged in killing or attempting to kill people in a populated area. Recent active shooter incidents have underscored the need for a coordinated response by law enforcement and others to save lives.

To prepare, the City of Lakewood is hosting an Active Shooter & Casualty Care Workshop presented by the Los Angeles County Sheriff's Special Enforcement Bureau (SWAT & Tactical Paramedics) on Nov. 5 from 10 a.m. to 11:30 p.m. Pre-registration is requested.

Attendees will learn how to respond in active shooter situations and what to do in the following first crucial moments. Discussion topics include responding quickly during an incident, what law enforcement does upon arrival, and treating life-threatening or other traumatic injuries.

Norwalk Introduces Ordinance to Curb Illegal Street Racing

Staff Report

To deter large gatherings, the ordinance will make it a misdemeanor for people to spectate a street race

Norwalk, CA - On Tuesday, October 18, 2022, the Norwalk City Council unanimously approved, by title only, an ordinance to regulate spectators at illegal speed contests or exhibitions of speed. Ordinance No. 22-1736 will make it unlawful and a misdemeanor for any person to be present as a spectator at a street race or illegal exhibition of speed. The ordinance specifies that spectators are considered people either on a public street or highway, or on private property generally open to the public without the consent of the owner, operator, or agent thereof.

"Across the region, we have been plagued by illegal street races and street takeovers," stated Mayor Rick Ramirez, "This ordinance is target-



ing spectators because it will curb the appeal for drivers to engage in risky behavior for the sake of gaining attention."

Currently, California Vehicle Code Section 23109 prohibits engaging in, facilitating, or aiding or abetting in a motor vehicle speed contest and an exhibition of speed on public streets and highways. However, this ordinance, if passed, will also further "...make it unlawful and a misdemeanor for any person to be present as a spectator... on private property generally open to the public without the consent of the owner, operator, or agent thereof, at an illegal speed contest or illegal exhibition of speed" in the City of Norwalk.


The City of Norwalk wishes to adopt this local ordinance, which has been similarly adopted by other local agencies, as it has been an effective tool to combat these dangerous activities and limit spectator involvement.

The presence and/or gathering of spectators at illegal street races and exhibitions of speed threatens the health and safety of the public and is a public nuisance. Spectators interfere with pedestrian and vehicular traffic and make it difficult for private business owners to enjoy the use of their real property within the City.

The ordinance will now be scheduled for adoption at a future City Council meeting.v
