Cerritos Refuses to Sign Letter of Support for Light Rail Line From Artesia to Union Station

Cerritos elected officials want the half-billion station; Metro said it was not feasible, so Cerritos withheld support in a letter to ask for DOT funds.

Work continues on the transformational light-rail line from Artesia to Union Station, with cities and their elected officials and staff along the line participating and contributing mightily, seeing the tremen-

dous short and long-term economic and social benefits to the entire area and its residents and businesses.

That is, except for the city of Cerritos and Mayor Bruce Barrows.

As he did years ago when he suddenly pulled Cerritos out of the ten-city light-rail consortium, Barrows is leading the charge, along with Councilmen Naresh Solanki and Chuong Vo, to get a nearly three-quarter of a billion station - instead

CA. Bill Banning Harmful Chemicals From Candy, Cereals Passes Assembly

Last Monday, the California Assembly approved A.B. 418 by a vote of 54-11 to ban five harmful chemicals from candy, cereals and other processed food.

Fourteen Assemblymembers walked and did not vote at all, including Asmewomen Blanca Pacheco and Blanca Rubio.

The bill bans brominated vegetable oil, potassium bromate, propylparaben, Red dye No. 3 and titanium dioxide in food products sold throughout the state.

Pacheco and Rubio's votes are odd considering, with the exception of Red dye No. 3, regulators in Europe previously banned the other four substances outright.

Proponents have sounded the alarm for years over these chemicals' potential adverse health impacts, both short-term and long-term.

"Californians shouldn't have to worry that the food they buy in their neighborhood grocery store might be full of dangerous additives or toxic chemicals," Democratic Assemblymember Jesse Gabriel,

the legislation's sponsor, said in a press release in February.

The chemicals are in different foods; some are associated with neurological problems, some are reproductive problems, and some have been

A new county-wide task force met for the first time this week to tackle what has become one of the area's worst problems, keeping people in their homes so they don't fall into homelessness. Comprised of all five LA County Supervisors and elected officials from 88 cities, the Los Angeles County Affordable Housing Solutions Agency(LACAHSA) is a collaborative attempt to address the housing and homelessness crisis.

In a statement, Supervisor Janice Hahn wrote, " On

Wednesday, we launched a brand new region-wide effort to tackle the affordable housing crisis with the inaugural meeting of the Los Angeles County Affordable Housing Solutions Agency, or LACAHSA. I am one of 21 board members, including my fellow Supervisors, Mayor Bass, Long Beach Mayor Richardson, Bellflower Councilmember Victor Sanchez, and housing experts, who are charged with building this agency from the ground up.

"Housing affordability is one of the most dire problems we face. This new agency is a chance to lock arms across jurisdictions to build more affordable housing and preserve what affordable housing options we do have.'

LACAHSA has three major objectives: to hold the affordable housing that already exists, build more affordable housing, and to prevent people from losing their homes and falling into homelessness.

To do so, the agency plans to scale up financing tools that will allow people to stay in their homes, including compensating developers for keeping rents affordable.

Norwalk Residents Voice Concerns With SEAACA, S.E. Area Animal Control

At the Norwalk City Council's May 16 meeting, Southeast Area Animal Control Authority [SEAACA] presented its business plan to the council, stating they care for abandoned animals and are dedicated to providing spay and neuter services at a reasonable cost for pet owners.

But it was after the presentation that the fireworks started.

Over twenty Norwalk residents angrily expressed frustration towards SEAACA related to its euthanization policies, hours of operation and fees.

During the public com-

ment section, multiple Norwalk residents said that SEACCA is unorganized and lacks communication within the system.

One Norwalk resident talked about an alarming experience with SEAACA. The resident said he previously fostered a pregnant female dog who was put on the euthanization list without reason.

"No one knew that she was pregnant," he said. "The same day that she gave birth to her six puppies, she was still on the list to be euthanized."

The resident said the dog ended up with eleven puppies, now in loving homes. He said that if SEACCA didn't take care of the situation, the female dog would've been euthanized.

"All of what SEAACA presented looked lovely, but the reality was different," said Lisa Lampin, a resident of Norwalk. "The reality is that dogs need to be spayed and neutered. It's \$500 and people don't have that kind of money. The policies are not what they look like on the website."

Lampin said that owners resort to dumping animals because of the \$300 fee SEACCA requests for surrendering that animal - which is a difficult price to meet for low-income households.

Starbucks Store Removes Customer Seating, Who's Next?

A Starbucks store in Studio City has removed its seating for customers due to "safety concerns."

A sign on the door of the store, located on Ventura Boulevard and Vineland Avenue, says it's a temporary move. It's not clear what sparked the decision or how long seating would be unavailable.

Six Los Angeles area Starbucks stores are now closed, with the coffee giant citing safety issues. The closures took on heightened significance because of an ongoing unionization effort at Starbucks' U.S.

The move follows the closure of six other Starbucks locations across Southern California last year when the company said crime, vagrancy and vandalism in and around those stores was creating an unsafe environment for employees and customers.

LA City Councilmember, Nithya Ra-

man, who oversees that district, spoke about the issue, "I have so much empathy for those baristas. That was my first job, a barista at Starbucks and I understand what it's like to deal with customers who are unruly or hard to handle. I have so much empathy for their situation. Gas Rises for Seventh Consecutive Day

The average price of a gallon of selfserve regular gasoline in Los Angeles County rose Thursday for the seventh consecutive day after dropping six of the previous seven days, increasing threetenths of a cent to \$4.873.

The average price has risen 4.5 cents over the past seven days, attributed to higher demand prompted by the Memorial Day weekend.

The average price dropped 2.4 cents during its run of six decreases in seven

days, according to figures from the AAA and the Oil Price Information Service. Despite the streak of increases, the average price is 5.3 cents less than one month ago and \$1.218 lower than one year ago.

The Orange County average price rose for the sixth time in seven days, increasing a half-cent to \$4.839. The Orange County average price is 4.6 cents less than one month ago. It has dropped \$1.62 since rising to a record \$6.459 on

Pico Rivera Presents State of the City

Pico Rivera Mayor Erik Lutz and other elected officials returned to the Pio Pico Woman's Club to present the State of the City report; it was the first time since 2020.

City officials offered a positive outlook on the current state of Pico Rivera and plans for the future.

Under the leadership of City Manager Steve Carmona, the city's financial health continues to be in top condition, per the California State Auditor's Report.

Sales tax revenue accounts for 49% of the city's revenue, followed by Property Tax, Utility Users Tax, Licenses and Permits, and other miscellaneous sources.

With that revenue, city officials continue to use a significant portion on the City's Public Safety and for the contract with the Los Angeles County Sheriff's Department, which accounts for a quarter of the city's budget, keeping in place their commitment to safety and ensuring the Pico Rivera Station has all available resources.

The State of the City report also highlighted the city's financial rankings with the State Auditor and the bond rating by Standard and Poor's (S&P).

The California State Auditor's report, which ranks the financially riskiest cities in California, ranked Pico Rivera amongst the highest, the city improving its overall score from 82 to 84 out of a total of 100 possible points. With 430 Cities in California rated, Pico Rivera was again labeled a "low-risk" city, coming in at 284.

In addition to being one of the least financially riskiest cities, the city obtained a AA Bond Rating by S&P after an evaluation of the city's creditworthiness for the potential issuance of Pension Obligation Bonds.

An S&P Global issue credit rating is a forward-looking opinion about a city's creditworthiness related to a specific financial obligation. S&P also commented on the city's stability noting a robust local economy and fiscal outlook and strong financial management policies and practices, including an enhanced risk-adjusted reserve policy, strong budgetary performance, and a resulting moderate leverage debt capacity.

The report also highlighted the city's housing growth. Over the next couple years, several housing developments will be completed, including the 255-unit Mercury Project at the former El Rodeo site, and a 45-unit townhome development on Durfee Avenue.

Two housing development projects were recently completed, a nine-unit townhome development and a 12-unit townhome development.

Officials also noted other major projects coming to the city in the next few

The highly anticipated Fiber Optic Network Project, a project to construct a privately-owned fiber optic system that will be open access, low cost to the consumer and available to every resident and business within the city, will begin construction later this year.

Updates on other projects, including the Smith Park Aquatic Center, Rio Hondo Park, the PAD Park, and the Dog Park, were provided to the attendees.

City Manager Steve Carmona commented, "It's a privilege to bring this report to the Pio Pico Woman's Club and show all our progress in the last few years. Like many cities, we are still recovering from the pandemic. However, the city continues to grow with new housing developments, and we continue to improve the city's infrastructure. It's exciting to talk about all the progress the Pico Rivera is making to this special group."

Chair Joan Pylman, and her committee chose two outstanding students to receive this year's awards. The students were selected according to their academic achievement with a 3.5 GPA or better and active participation in service activities at Cerritos College or the community.

The first student selected was Sofia Heejae Chun. Sofia had a 4.0 GPA at Cerritos College and majored in Theater Arts. She was active in several clubs at Cerritos College and was President of the Helping Hands Project Club. She was also Secretary of the Cerritos College Artists Club. She became an immigrant in the United States when her family moved to the City of Cerritos in the United States in 2019. She graduated from Cerritos High School in 2021 and attended Cerritos College to learn about universities. She has been accepted at five universities so far.

Sofia's passion for helping other immigrants is because she is also an immigrant. Sofia was born and lived in South Korea in 2002 and moved to Jakarta, Indonesia in 2009 for one year. She lived in Manila, in the Philippines until 2015, where she learned English. She moved back to South Korea for one year in 2016. Later, in 2016, she moved with her family to Ho Chi Minh City, Vietnam, where she learned Spanish and some Vietnamese. Sofia learned American Sign Language while she was at Cerritos College.

The second student who received the Academic Achievement Award was Leidy Barrios. Leidy was a "Re-entry" student who has been married to her husband, Johnny Gomez, for 22 years; they have two sons, 21- year- old Benjamin and 11-year-old Adrian. Leidy has worked as a teacher assistant and worked hard at Cerritos College to maintain a 3.8 GPA in her studies. She is the first in her family to receive an Associate of Arts degree in Early Childhood Education. She hopes to earn a B.A. in Child Development at Cal State Dominguez Hills and become a teacher.

Leidy was born and raised in Guatemala City and immigrated to the United States in 1997 when her birth mother, Maria del Carmen, invited her to live in the United States. Her mother had moved to the United States in 1988 and asked Leidy, her brother, and her sister to join her when she had a green card. Leidy said that she wanted to thank her mom for making it possible to have a better life in the United States. When she first came to the U.S., she learned English at La Mirada Adult School with English as a Second Language classes. She completed high school classes and graduated with a High School Diploma. Netflix Will Add an \$8 'Fee' for Sharing

Netflix on Tuesday outlined how it intends to crack down on the rampant sharing of account passwords in the U.S., its latest bid to reel in more subscribers.

To combat password sharing, Netflix said it will limit U.S. viewership of its programming to people living in the same household.

Those who subscribe to Netflix's standard or premium plans will be able to allow another person living outside their household to use their password for an additional \$8 per month, a \$2 discount from the company's standard stand-alone basic plan.

Without providing details how it authenticates subscriber identities or accounts, Netflix assured that everyone living in the same household of a U.S. customer still will be able to stream TV series and movies "wherever they are — at home, on the go, on holiday."

The long-anticipated move seeks to end a practice that the company allowed to go unchecked for years while its streaming service was attracting subscribers in droves. At that time, management had little incentive to risk riling customers by reining in password sharing.

While Netflix looked the other away, an estimated 100 million people worldwide were getting passwords from family and friends to freeload on Netflix TV series such as "The Crown" and films such as "All Quiet On The Western Front." Those passwords were funneled through Netflix's 232.5 million worldwide paying subscribers, who generated the bulk of the company's \$32 billion in revenue last year.

But after a year of lackluster subscriber growth that included its largest customer losses in more than a decade, Netflix is putting its foot down.

In February, it began blocking freeloading viewers in Canada, New Zealand, Portugal and Spain, following similar moves in Latin America.

Before the crackdown on password sharing, Netflix began introducing features, such as the ability to transfer the profiles set up on subscriber accounts to make it easier for people to retain their viewing histories after they are no longer able to watch shows for free.

Netflix's effort to force more of its viewers to pay for access to its programming follows the launch of a \$7 monthly plan that inserted commercials into its service for the first time.

Netflix has picked up an additional 9 million worldwide subscribers since the ad-supported option debuted, although not all of those signed up for the low-priced plan.





that shoots metal B-B's using a pressurized air cartridge.

"It looked like a real gun," said one resident who contacted Los Cerritos Community News, "as soon as I saw the gun, I ran out of the building."

According to witnesses, Griffith said

he was going to shoot up the building and then fired a B-B into the ceiling.

Witnesses told LCCN that frightened customers and employees inside the building screamed and scattered, thinking it was an active shooter situation, only to finally see it was a B-B gun.

Many were shaken and wanted to leave for the day; some called in today, still affected by the incident.

Residents who contacted LCCN said Griffith "seems to be mentally ill and has caused issues throughout the community, including trying to fight Commerce City Hall employees."

Sheriffs from the East L.A. Station arrived and took Griffith into custody around noon.

Griffith was arrested and charged with brandishing an imitation weapon under penal code 417.4 PC.

417.4 states, "Every person who, except in self-defense, draws or exhibits an imitation firearm in a threatening manner against another in such a way as to cause a reasonable person apprehension or fear of bodily harm is guilty of a misdemeanor punishable by imprisonment in a county jail for a term of not less than 30 days."

A person who violates 417.4 is charged with a misdemeanor punishable by custody in county jail for a mandatory minimum of 30 days and up to 6

The judge in this case slapped a GPS ankle monitor on Griffith and hit him with a restraining order mandating he stays 100 yards away from city hall.

Cerritos Adds Another Piece to the Its Sculpture Garden

In August of 2019, Los Cerritos Community News reported the bronze sculpture in front of Extra Space Storage in Cerritos entitled Strength of the Maker was stolen; the sculpture had been in that spot for over 20 years.

John Grant, a Cerritos resident who uses Cerritos Storage reported the theft to LCCN and was very disappointed and angered about the theft.

The sculpture is an icon to us here in Cerritos, it will be missed," said Grant

"It looks like, from the markings around the base, that they pulled up a truck, pulled the sculpture down and took it," a spokesperson for the Cerritos Sheriff's told LCCN.

The sculpture was valued at \$34,000. If area residents are missing the sculpture they can now find it at the Cerritos Sculpture Garden. Cerritos recently acquired and installed the Strength of the Maker art piece in the Garden.

Cerritos purchased a new statue using funds paid by Extra Space Storage as part of a settlement offer for the storage company's "failure to maintain and prevent the original art piece from being removed."

Strength of the Maker was created by Colorado artist Denny Haskew and depicts a Native American man bending a bow across his back.

The bronze sculpture is meant to represent the strength of a higher power that created nature and man.

It measures 60 inches high and 60 inches wide including the bow.

Haskew, a member of the Potawatomi citizen nation, is known for creating art that reflects the Native American and southwestern culture.


His work has been described as intensely personal and honest, reflecting recurring themes of spirit, love, forgiveness, healing, endurance and strength. Haskew has another piece, "Luminaire," located at the Transpacific Development Company office building in the Cerritos Towne Center.

In creating the piece, Haskew, a member of the National Sculptors Guild, states, "Strength of the Maker right from its title...to the strength shown even in the toes, is a statement of how I view my very inner belief. Nature and all things natural have always been of the utmost importance to me all my life. Believing in a God, the Great Spirit, Buddha, Mohammed, the Mysterious One and any other beings of greatness is important. I feel they all exude the same message, a life of oneness, of love, of honesty and a source of emotional strength. 'Strength of the Maker' is my visual version of how I see my Maker."

A limited edition of the "Strength of the Maker" sculpture has been selected for permanent display in the Native American Museum of the Smithsonian Institution in Washington DC. It has won five best of show or first place prizes in the top art shows in the country.



JOHN GLENN'S UDENGWU SHAKES OFF SLUGGISH START, ADVANCES TO STATE PRELIMINARIES WITH ONE THROW

MOORPARK-After throwing a career-best 193-00 in the discus event at last Saturday's CIF-Southern Section divisional championships, John Glenn High senior Mikel Udengwu knew it wouldn't be as easy to punch his ticket to Friday's CIF state preliminaries in Clovis. While he was excited to advance to last Saturday's Masters Meet at Moorpark High with the top mark in Division 3, he admitted that it's the hardest to throw and get the qualifying mark when you're expected to win.

Udengwu knew there was going to be more pressure to get the qualifying mark of 171-00 for state, and on top of that, he had been sick since the day after the divisional finals and wasn't himself. The medicine he was taking to solve a sore throat, which hit its peak around last Wednesday and Thursday, was making him dizzy and that's why Udengwu scratched on three of his first four throws before sending himself to state on his fifth attempt with a throw of 181-10.

"It feels good; it's something I really wasn't expect-

ing coming into the season because my [personal record] was around 130 [feet] last season," said Udengwu. "My very first mark was around 130, and then I don't know...last week was 190 and now I hit a 181. It's just a crazy feeling, but I knew with hard work, I was going to get there, though.

"I just had to use my confidence," he later said. "That's the one thing that really carries me to the next level; just being confident in myself and know that I'm going to succeed."

He added that his balance was off because when he scratches, it's because he just throws out of the sector. He rarely has problems spinning back into the sector or going out. On top of that, he didn't sleep well last Friday night.

"It means a lot [for the school and community]," said Glenn head coach Andy De La Torre. "I probably got to [the city of] Norwalk when I was about 10 years old. So, I've been around the city for about 14 years now and I think it's big. Typically, Glenn isn't a school that's looked at for athletics. Personally, I lived in Norwalk and went to La Mirada [High], so it's just one of those things where even at La Mirada when you would see Glenn on the schedule for any sport, you really didn't think too much. But when I got here, that's something that I wanted to change. I wanted people to see us...when they see us on the schedule, they would say this is a school we shouldn't take lightly. That's the biggest thing for us."

Udengwu had the top mark from the divisional finals and was the last of a dozen competitors to throw at the Masters Meet. Three of the first nine didn't have a mark after their first throws and the top score from the other six was 169-2, set by Zach Lewis of Pacifica High. Then Udengwu's friendly rival in the competition, Brandon See of JSerra High, threw a 180-6 before Redondo Union High's Kai Deines had a 165-10 before Udengwu's turn.

After the first three rounds, the competitors are re-seeded based off the top throws. Knowing that he had to have some type of mark to continue for the final three rounds, Udengwu, who scratched on his second attempt, tossed his discus a mere 12-1 to stay alive. He would be the first to go for the fourth round and


after scratching again, qualified on his fifth throw. He would end the event with the second best mark as Justice Mephors of J.W. North High threw a 184-7 on his fifth attempt. Mephors entered the day with the fourth best mark from the divisional finals and had scratched on three of his first four attempts.

"There was a point after the four throws I went to the ring and I spun my practice spin around 15 times," said Udengwu. "On my throw of 181, I was sweating just because I was like, 'I need to get a mark, I need to get a mark'.

"I thought it would ease up because now I'm first again," he later added. "It's usual for me not being at the top of the list. But I still scratched, so I was so confused. I tried to slow down and just get into my rhythm, and I still scratched. I was just lost, to be honest, and I really didn't know what to do."

"I think he tried too hard in his first throw," said Glenn throwers coach Ray Neimann. "I asked him to just get a nice mark; throw 80 percent or so and get a decent mark, and then after that mark is set...past 171 [feet], then go for the gold. I think he tried a little too hard with the medicine [he was taking], the strep throat and issues

he was having. I think he's been a little dizzy and that's why he scratched so many times."

Udengwu said last year's results prepared him for this year as he had no issues during the warmups at the 2022 divisional finals, then scratched on his first two throws before getting a mark to keep his junior season

After getting 181-0 with one more attempt, knowing he had qualified for state, he said he was pushing harder on the last attempt to get a personal record. But he scratched again to become the first of two throwers to scratch four times.

"Once I saw the white flag go up, I was like, 'alright, let's just see what the distance is'," said De La Torre. "Then we heard the 181-0 and I was like, 'alright, sweet'. I didn't care whether we took first, second or sixth. All we wanted to do was get a qualifying mark to go on to compete [in the state prelimi-

Jake Stafford of JSerra High (176-0), Christopher Nora of Oak Hills High (175-1) and Jesse Goldman of Harvard-Westlake High (171-8) were the other state qualifiers but as it relates to Udengwu, he has built a competitive rivalry with See and has gotten the upper hand lately. They were the top two Division 3 finishers in the CIF-SS finals with marks of 193-0 and 179-04 and had the second and third best marks at the Masters Meet.

"To be honest, I didn't think it would be me versus him at the beginning of the season," said Udengwu. "But now, I've embraced it. It's an honor to be one and two in California, so hopefully we do good in state and I'm up for the challenge.

"He has had a lot of dedication and stuff," said Neimann. "I coached him in football and we did well. He's just a good worker; he understands the concepts and so he applies those to work. That's what it is.

"He's a role model for the kids, especially at Glenn because they don't understand what it takes to be dedicated and what success will come once you dedicate yourself and be diligent to what your passion is," he continued.

As far as preparation this week, Neimann said they were going to make sure he eats well and gets his [sore throat] cured up. Neimann also believes that Udengwu will throw over 200 feet in Clovis. Udengwu will go into Friday's preliminaries with the third best mark in the state, trailing Mephors and McKay Madsen of Clovis North High (191-03). He is one of 25 discus throwers to have advanced to the state preliminaries and if he stays within that range, Udengwu is poised to bring a medal back to the high school.

linked to cancer.

Over 10,000 chemicals are allowed for use in food sold in the U.S., 99% of which were approved by the food and chemical industry but not the FDA, tasked with ensuring the safety of America's food sup-

Expert's best advice is to limit exposure as much as possible when it comes to diet.

Still, at this time, while some evidence is stronger than others, there isn't conclusive proof that any of the chemicals cause adverse health conditions for humans -- just that there could be a risk.

Brominated vegetable oil: In high quantities, it has "often been linked to neurological changes, like balance problems and memory problems in humans. Brominated vegetable oil is used primarily to help emulsify citrus-flavored soft drinks, preventing them from separating during distribution.

Potassium bromate is a chemical additive commonly used to enhance the texture of baked goods. It's often added to bread, rolls and other baked goods. The International Agency for Research on Cancer classifies potassium bromate as a possible human carcinogen.

Propylparaben: Propylparaben has been proposed to be a reproductive toxin that can cause hormonal dysregulation; there have been documented studies where it caused earlier or delayed menstruation.

While the research has hinted at those links to disruptions in the hormone systems in humans, the evidence is weak, and research is ongoing.

Red dye No. 3: Red No. 3, which gives that reddish or pink color to food, is banned in cosmetics as it is a known carcinogen, a substance capable of causing cancer. In addition, it has been linked to hyperactivity and other neurobehavioral effects in children. Research in California linked it to behavioral problems in children.

Titanium dioxide: a possible carcinogen, the food color additive can be very irritating to mucous membranes like the eyes, nose and throat

and has been linked to cancer in rodents. There is no research on that link in humans.

The concern with titanium dioxide centers on its tendency to break into nanoparticles that can accumulate in the lungs and elsewhere in the body.

AB 418 will now move to the Senate; if enacted, California would be the first state to impose such a prohibition.

of a much cheaper option - and is spending hundreds of thousands in Cerritos' taxpayer dollars using a costly law firm and a lawsuit against Metro in an attempt to secure the costlier station.

Undaunted, Supervisor Janice Hahn held a meeting on May 8, bringing together leaders from the ten cities along the line in an attempt to put on a united front and garner additional dollars for the line from the Department of Transportation.

After the meeting, Hahn wrote, "Metro's future West Santa Ana Branch line is going to serve ten cities in Southeast LA and the Gateway Cities region, from Artesia all the way to Union Station in Downtown Los Angeles. So on Monday, I brought together elected leaders from those communities for an update from Metro staff.

"Construction on this line isn't set to begin for some time, but we're already charging full steam ahead in advocating for this project. The West Santa Ana Branch is my biggest transit priority because it's going

to bring high-quality transit to 1.4 million residents. 44% of those residents are at or below the poverty line, and 18% don't own a car. This project is about equity.

"I'm thankful for the partnership of these city leaders in seeing this project through."

Hahn was not referring to the city leaders of Cerritos.

Los Cerritos Community News has obtained an internal memo from Cerritos City Manager Art Gallucci, who has one foot out the retirement door, to all Cerritos City Councilmembers outlining the May 8 meet-

Gallucci wrote, "On Monday, May 8, Mayor Barrows, Mayor pro tem Solanki, and I attended an in-person briefing hosted by Janice Hahn, which focused on discussing the Metro proposed West Santa Ana Branch Project.... Supervisor Hahn solicited the support of all cities in an effort to establish a united and enthusiastic front in pursuit of federal monies... specifically, cities were asked to memorialize their support of the project by way of signing a letter to the US Department of Transportation to request federal funding."

Cerritos then made its demands for the more expensive station, holding the support and signing of the letter as hostage.

"Metro deemed the [more expensive station] financially unfeasible and will not be considering the aerial alignment. Discussions commenced, and there was no determination at the meeting....[all station choices] will need to be explored by City Council and staff.

LCCN contacted Supervisor Hahn, informing her of the letter; that is when Hahn confirmed that Cerritos did not sign the letter of support; Cerritos was the only city not to sign.

Just days later, Metro and Cerritos were due in court for a trial-setting conference; once again, Cerritos delayed the lawsuit; the parties are due in court in mid-June.

Cerritos' law firm has once again delayed the lawsuit, moving a pre-trial hearing from May to June.

SUBJECT: SUMMARY OF WSAB BRIEFING HOSTED BY SUPERVISOR JANICE HAHN

On Monday, May 8, 2023, Mayor Barrows, Mayor Pro Tem Solanki, and I attended an in-person briefing hosted by Los Angeles County Supervisor Janice Hahn, which focused on discussing the Metro-proposed West Santa Ana Branch (WSAB) project. During the briefing, which was attended by City Managers and Councilmembers of cities along the WSAB corridor, Supervisor Hahn provided information on the current status of the WSAB project, discussed rebranding efforts to rename the project, outlined action items for respective cities along the corridor, and solicited support by corridor cities in an effort to establish a united and enthusiastic front in pursuit of Federal monies to facilitate the construction of the WSAB project. Specifically, corridor cities were asked to memorialize its support of the project, by way of signing a letter to the U.S. Department of Transportation, to request federal funding for the WSAB project from the Federal Transit Administration's Fiscal Year 2024 budget, for continuing preliminary engineering, environmental analysis, and other project related tasks.

In response to the request for the City of Cerritos to sign the referenced letter, showing its full support of the WSAB project, the City's concerns were conveyed to the consortium of cities and representatives at the briefing. Concerns were raised regarding the above-grade, aerial alignment proposed for the 183rd Street and Gridley Road intersection due to the impacts of the bridge and associated infrastructure on residents of the cities of Cerritos and Artesia, as well as financial implications to commercial centers and businesses in both cities. While Metro recently completed its analysis of constructing a cut-and-cover alignment at this intersection, in lieu of an aerial alignment, such analysis concluded that the insurmountable costs associated with a cut-and-cover alignment at this intersection, or any other intersection along the WSAB corridor, deemed the project financially infeasible, and therefore will not be considered or pursued by Metro. As a result of such determination, discussions of assessing the above-grade aerial alignment compared to an at-grade alignment at this intersection commenced. While no determination was made during the briefing, it is anticipated that any assessment of now considering at-grade in lieu of cut-and-cover or aerial alignment, will need to be explored by the City Council and staff, inclusive of determining the feasibility of recouping funds from Metro that otherwise would be used to fund an aerial alignment at the subject intersection in Cerritos, and determining the feasibility and cost differential for a future at-grade station location versus a future aerial/above-grade station location.



NOTICE IS HEREBY GIVEN THAT the City Council of the City of Artesia will hold a Special City Council Meeting at the City Council Chambers located at 18747 Clarkdale Avenue, Artesia, CA, at 6:30 p.m. on Monday, June 5, 2023, to conduct a Public Hearing to consider the adoption of Ordinance No. 23-943 amending Articles 20 and 44 of Chapter 2 of Title 9 of the Artesia Municipal Code related to design review and commercial cannabis use and cultivation. The following is a summary of the proposed Ordinance:

- Proposed revisions to Article 20 propose an administrative design review related to commercial cannabis uses in certain circumstances. Under the proposed revisions, if an approved commercial cannabis business seeks "minor modifications" to an existing structure, then it would be reviewed by the Community Development Director. In order to approve an administrative design review, the Community Development Director would still need to make required findings. Any appeal of an administrative design review would go to the Planning Commission for consideration. Modifications that implicate 60 percent or more of the building façade would also still go to the Planning Commission for review.
- Proposed revisions to Article 44 are to strengthen the language and reaffirm that commercial cannabis businesses may only be located south of California State Route 91 in the Commercial General, Commercial Planned Development, Artesia Boulevard Specific Plan, Artesia Boulevard Corridor Specific Plan, and South Street Specific Plan zones subject to permit requirements and operating regulations. The proposed revisions also acknowledge State law relating to the right to limited cannabis cultivation for personal use.
- The Council will also consider a finding that this project is not subject to CEQA pursuant to State CEOA Guidelines sections 15060(c)(2) and 15061(b)(3) will not result in a direct or reasonably foreseeable indirect physical change in the environment; and the activity is covered by the general rule that CEQA applies only to projects that have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment, the activity is not subject to CEQA. The Planning Commission considered the proposed ordinance at a special meeting held on May 15, 2023, and unanimously recommended that the City Council adopt the

Pico Rivera's Parks and Recreation Department was recently recognized by the California Parks and Recreation Society (CPRS) for the Roldan Mini-Pitch in an award ceremony held last month in San Diego.

The Department submitted the Roldan Mini-Pitch project to the annual CPRS awards for "Best Design in Park Planning" for the California Parks and Recreation Society and was subsequently awarded the Award of Excellence, the highest award to receive at the State level for CPRS.

The Roldan Mini-Pitch opened at Pico Park last Spring much to the delight of area residents. The Mini-Pitch reMany attendees at the CPRS Conference held in San Diego last month were impressed with the transformation of the dilapidated area into a full use recreational space. In addition, the design and concept were also complimented by many Cities.

The idea of the mini-pitch came about when city staff met with resident and MLS Soccer star Cristian Roldan of the Seattle Sounders to bring a 5-on-5 mini-pitch soccer field to the city.

Since the initial meeting held in 2021, the wheels were set in motion, and the court became a reality when it opened in 2022.

In addition to the Award of Excellence, the Department was presented with the 2022 Innovative Programming

Many residents mentioned that money is an issue for most people, leading them to undergo euthanization for their pets. They said it's difficult to spend hundreds of dollars to surrender an animal living paycheck to paycheck.

"Last week they killed eight dogs, and today, eight dogs," alleged one angry resident. "These dogs are not given the proper time, care and attention."

"We are still seeing animals that are staying longer in our care," said Denise Woodside, executive director at SEAA-CA. "As we continue to expand our team, it is our goal to continue to expand availability hours."

In other news, the Norwalk City Council announced an update on the City's Urban Forest Management Plan. Award by CPRS – Aquatics Section for the city's Summer Pool Days program. With the Smith Park Aquatic Center closed last summer, city staff was adamant about hosting an aquatics program for residents who wanted to enjoy a day of swimming. 
