## Hahn Secures \$6.5 Million to Convert Building to Homeless Shelter

**SHELTER:** This week, Supervisor Janice Hahn, Long Beach Mayor Rex Richardson, and Councilmember Mary Zendejas announced their plan to purchase the former site of the Long Beach Rescue Mission to use as a permanent, year-round shelter for people experiencing homelessness; the building located at 702 W Anaheim. Hahn secured \$6.5 million for the project from Measure H tax dollars, an initiative approved by voters in 2017 specifically for homelessness.

## Biola University Will Get \$92 Million for Film School and Studio

It is the largest in the school's 115-year history, and it will help fund a \$92 million 52,100-square-foot film school studio facility.

LA MIRADA — Biola University's film school will be named after a co-founder of In-N-Out, the college said this week, after an unspecified but "significant" contribution after the Baldwin Park-based burger chain.

According to Biola, the gift on behalf of Esther L. Snyder is the largest in the school's 115-year history, and it will help fund a \$92 million 52,100-square-foot film school studio facility and establish the In-N-Out Burger Scholars Fund to support educational opportunities for foster and at-risk youth.

Esther Snyder, with her husband Harry, founded In-N-Out in Baldwin Park in 1948. She died in 2006, but left a long legacy of giving, according to

the company.

The film school will be dubbed the Snyder School of Cinema and Media Arts.

"This naming of the Snyder School and the inspirational vision of Mrs. Esther Snyder will be a testimony to students and alumni for generations that humility in leadership, Christ-like love of others, entrepreneurial tenacity and upright business principles are virtues worth living," Biola President Barry H. Corey said in a statement.

The new film studio will include a soundstage with additional edit suites, production offices, motion capture, Foley and scoring stages, mixing rooms, color correction lab, classrooms, faculty and staff offices and a full theater, according to the university.

Biola plans to break ground on the project in October, aligning with In-N-Out's 75th anniversary.

"Our family values the distinctly Christian education Biola University offers and are honored to play a part in continuing to offer students oppor-

tunities to make really impactful film pieces that change people's lives," Lynsi Snyder-Ellingson, granddaughter of Esther L. Snyder and owner/president of In-N-Out Burger, said in a statement released by the university. "God is a huge part of the In-N-Out story, and I have no doubt my grandmother would be grateful to know her name is associated with a school recognized for excellence in craft and character."

## DIRECTOR LETICIA VASQUEZ FILES WORKER'S COMPENSATION LAWSUIT AGAINST CENTRAL BASIN

Los Cerritos Community News has learned that Central Basin Director Leticia Vasquez, using her husband "Sweet James" Ron Wilson as her free attorney, filed a workmen's compensation claim in January 2022 against the very agency she was elected to serve.

Los Cerritos Community News obtained the documents via a public records request.

The lawsuit came as a surprise to Central Basin given that Vasquez is not considered an employee of the agency but an elected official, a circumstance which is certain to be litigated and cost the agency thousands in fees.

Vasquez asserts the injuries started on the day she was sworn in, January 7, 2013, and persisted for nine years until January 10, 2022; she is demanding over \$2 million in compensation.

Vasquez is claiming stress, harassment, assault, and racial discrimination, which has caused "depression, sleep disorder, high blood pressure, chest pain, stomach pain, headaches, migraines, shortness of breath, pain, and numbness in neck, both shoulders, both arms, both wrists, both hands, biot[h] [sic] legs, and both feet."

The lawsuit is a blatant money grab of taxpayer dollars by Vasquez and her litigious hus-

band.

In 2021, a very relaxed Leticia Vasquez was seen on video casually strolling through Central Basin offices with her associate Joey Martinez looking to harass and confront employees saying on the video, "we're here to start a ruckus."

Vasquez is seen bending over to get into drawers and carrying reams of documents, with no sign of medical braces or distress.

Just months earlier, Vasquez is seen calmly walking around Downey's water facility claiming the water was "undrinkable." Once again, Vasquez showed no

achieving more equitable representation in local government."

Currently, city council members' salaries are capped based on the population size of their cities, and the maximum pay hikes set by state law have not increased since 1984.

That means that for cities with fewer than 35,000 people, monthly salaries generally top out at \$300, according to Dodd's office.

Don't think that applies in Cerritos. "This is an incredible step toward equitability," said Rohnert Park Mayor Samantha Rodriguez, who testified in favor of the bill.

According to data compiled by the Bay Area Equity Atlas, a tool to track racial and economic equity in the region, while white people accounted for 40 percent of the Bay Area's population in 2021, they held 66 percent of local elected offices.

Additionally, Asian and Pacific Islander and Latino populations together made up about half of the Bay Area's population but accounted for just 24 percent of local elected officials.

"Many councilmembers get paid minimally, if at all. This can provide opportunity for working people who have had to balance jobs, childcare and school with public service," Rodriguez said.

Dodd's office said the bill is supported by the League of California Cities and the NAACP.

Newsom's office did not immediately respond to a request for comment.

outwardly sign of injury.

In 2017, LCCN obtained a surveillance video of Vasquez living at her husband's house, which was out of the district. The video was shot over several days, with one clip showing Vasquez hustling down four flights of stairs and hopping into her Toyota four-wheel-drive truck without using the assist step to enter: [youtu.be/eLZ1ypTNqwY](https://youtu.be/eLZ1ypTNqwY)

And in 2014, LCCN posted the now-infamous picture of Vasquez sitting comfortably at the CCA-Legislative Days conference in Sacramento.

The worker's compensation lawsuit is one of two lawsuits Vasquez has against Central Basin; public records show that the agency has spent nearly \$170,000 in legal fees while Vasquez' husband is free.

Emails into Vasquez and Wilson went unanswered.

## California DMV Changing Disabled Parking Placard Renewal Process

The California DMV is changing the way drivers are renewing their disabled persons placards to help avoid fraud.

Anyone who has had a disabled parking placard for six years or more will need to renew their permit by June 30 in order to continue using it.

According to an audit done by the state on the California DMV, state officials found that the "DMV does not sufficiently ensure that applications for placards or plates are legitimate."

They said that the placard applications they reviewed did not provide enough specific information regarding the disabilities of the drivers and that they did not regularly update placards for those who are deceased.

In 2017, the California State Legislature passed Senate Bill 611 a couple of months after the audit with the hope of correcting some of the shortcomings of the DMV.

Placards automatically renew every two years and now the DMV will be requiring placard holders to provide a signature every six years verifying that they still require their placard and are still alive.

This will be the first year the new process will be used and officials will hope it will result in more efficient records and limit the amount of permits being misused.

## Downey Man Arrested After Body Found on 60 Freeway

A Downey man was arrested Wednesday night, June 14, on suspicion

of killing a woman whose body was found on the eastbound 60 Freeway in Diamond Bar earlier that day.

Authorities found Sercan Naldoken, 32, at John Wayne Airport and took him into custody, a California Highway Patrol statement said.

The coroner's office identified the victim as Lisa Renee Conduff, 56. She lived in Downey.

The CHP did not say how it identified Naldoken as the suspect and whether he knew the victim. The agency didn't disclose how the woman died, either, or if it believes the suspect was catching a flight to flee.

A CHP officer saw an Acura sedan on the right shoulder of the eastbound 60 Freeway, east of Diamond Bar Boulevard, around 10:45 a.m. and stopped behind it to offer help, said Officer Joseph Davila, a CHP spokesman. There was no one in the car. The officer looked around and found the body.

It wasn't clear who had driven the car.

Naldoken was being held Thursday at the Inmate Reception Center in Los Angeles in lieu of a \$2 million bail amount.

# Hahn Surpasses 1000 at Gun Buyback Events Since May 2022

Los Angeles County Supervisor Janice Hahn held a Gun Buyback this past Saturday in Long Beach, and has now collected 1,107 guns since May 2022.

The effort aims to give people a safe opportunity to remove guns from their homes and, in turn, make their families and neighborhoods safer.

"I have made a concerted effort to get guns off the streets of our neighborhoods and give people a safe opportunity to get unwanted guns out of their homes," said Hahn. "Every gun that we collect means a gun that can't be used to kill someone or in a crime, and I am especially grateful to have gotten assault weapons and ghost guns off the streets."

Hahn held her fifth Gun Buyback

event in at MacArthur Park in Central Long Beach in partnership with the Long Beach Police Department.

The event brought in 293 guns including assault weapons and ghost guns.

At each event, residents can bring in any firearms they have and turn them in exchange for gift cards purchased by Hahn's office.

The guns are surrendered completely anonymously with no questions asked. Since May of last year, Supervisor Hahn has held gun buybacks in Lynwood, Long Beach, Wilmington, and Norwalk.

truck traffic on Bloomfield and from Excelsior to Alondra Blvd., removing a part of Bloomfield Avenue between 10:00 p.m. and 7:00 a.m. with the exception of Shoemaker Ave. between Excelsior Dr. and Alondra Blvd.

The ordinance plans to migrate major truck traffic away from neighborhoods near Norwalk and Pioneer Blvd. to move toward the industrial area off Shoemaker Ave, allowing another route for trucks to take onto the 91 Freeway.

The city will maintain the truck route plan with signs marking the designated streets. The truck route does not apply to school buses, commercial vehicles, or vehicles granted a permit by the City Engineer.

Norwalk Deputy City Manager Richard Rojas says it's the preference of the

city to have trucks utilize a different north route, such as using the I-5 Freeway. Residential neighborhoods won't be affected by truck noises if this happens.

In other news, the city council previously authorized an amendment to the budget to fund projects at city parks, including installing playgrounds at five parks, resurfacing, lighting upgrades and remodeling of restrooms and snack bars.

A technology enhancement is planned as Wi-Fi will be implemented at all city parks with the development of a city technology master plan.

Additionally, the city council announced its plan to adopt a City Climate Action Plan. The plan includes rooftop solar installations for businesses and residents, an expansion of electric vehicle charging stations and the addition of Zero-Emission Buses to be completed by 2030.

(Winchester) Athletics-Jendro 4-3.

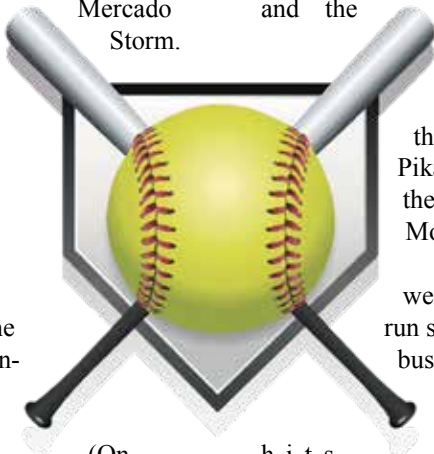

## SUBURBAN VALLEY CONFERENCE

### NEW CONFERENCE WITH COMPETITIVE LEAGUES A WIN-WIN FOR ALL

In a way, the Suburban Valley Conference, which makes up the Gateway League and the Mid-Cities League, can be linked to the formation of the 605 League. Prior to the 2018-2019 school year, there was the Suburban League and the San Gabriel Valley League, made up of six and seven schools respectively.

But when three Suburban League schools departed and joined forces with Oxford Academy, Pioneer High and Whitney High to form the 605 League, that left the Suburban League with four schools with Firebaugh High later joining. Now that the first athletic year of the Suburban Valley Conference is over, there are more positives than negatives as eight of the 11 schools called themselves league champions in 12 of the major sports.

The leagues, which can also be nicknamed the Upper League and Lower League, were put together based off power rankings from the 2021-2022 school year with the Gateway League being the upper half with teams in their respective sports having the better numbers. Not only did it make the Gateway League much more competitive than the SGVL and Suburban Leagues were, but it allowed the teams in the Mid-Cities

League a better chance of finishing in the top three and automatically advancing to the CIF-Southern Section playoffs.

Here is a look at what happened in each of the 12 major sports, four in each of the three seasons, and how those teams fared in the previous four years since the inception of the 605 League. Note that there is some shifting of champions of the Mid-Cities League to the Gateway League in favor of a last place or second to last place team.

**FOOTBALL**

While La Mirada High and Mayfair High dominated the Suburban League before and during the 605 League, it would be even tougher to win the Gateway League in 2022. That would be true as Warren High became the first league champions with Downey High and Mayfair finishing in second and third place respectively. Downey won the Division 4 championship while Mayfair advanced to the Division 7 semifinals.

La Mirada would miss the playoffs for the first time in over four decades while in the Mid-Cities League, there was a three-way tie for first place. Gahr High claimed a share of its first league title in over 25 years while Bellflower High and Norwalk High joined the party. It was Norwalk's first league crown since 2013, the

season it advanced to the CIF Finals. Bellflower would advance to the Division 11 championship game while Lynwood High, which went 1-3 in league action, fell in the Division 14 title game. When the season begins in August, Norwalk moves to the Gateway League while Paramount High, which went winless in five league contests, goes to the Mid-Cities League.

**GIRLS VOLLEYBALL**

Downey had been the queens of the SGVL for many seasons with Warren and Gahr predominately earning automatic playoff berths while Mayfair and La Mirada were the at the top of the Suburban League in two of the three seasons, not including the 2020 campaign. But in 2022, Warren, Downey and Paramount finished 1-2-3 while La Mirada won all 10 Mid-Cities League matches with Bellflower and Norwalk tying for second place. None of the six teams made it out of the first round of the playoffs. For this season, La Mirada moves to the Gateway League while Mayfair, which finished in fourth place goes to the Mid-Cities League.

**GIRLS TENNIS**

Warren had been the SGVL champions but as members of the Gateway League, the Bears shared the title with Downey while Norwalk claimed third place. In the Mid-Cities League, the top three

were Mayfair, La Mirada and Paramount with none of the six moving to the second round. For this upcoming season, Mayfair jumps to the Gateway League and Bellflower moves down.

**BOYS WATER POLO**

There were only five schools that competed in this sport with Downey winning the league and the Division 4 championship while second place Paramount went to the Division 6 semifinals and Gahr won the third place tie-breaker over La Mirada and Warren.

**BOYS BASKETBALL**

Since the 605 League started, there have been five different league champions as Dominguez High, La Mirada, Lynwood, Mayfair and Warren finished in first in their respective leagues. But as members of the SVC, Downey and La Mirada tied for the Gateway League crown while Lynwood went undefeated in Mid-Cities League action. To make things better, La Mirada advanced to the Division 2A championship game while Lynwood did the same in Division 5AA. Dominguez finished in third place in the Gateway League while Warren and Gahr went to the playoffs from the Mid-Cities League. It was Gahr's first trip to the playoffs since 2019. For the 2023-2024 season, Lynwood moves up and Paramount moves down.

**GIRLS BASKETBALL**

Lynwood had dominated the SGVL for the longest time until Downey made things interesting as of late while Mayfair was nearly untouchable in the Suburban League. This past winter, Lynwood won the Gateway League and advanced to the quarterfinals with Paramount and Downey coming in second and third place respectively. The Mid-Cities League title was won by Dominguez and Gahr with the Gladiators getting to the Division 5AA championship game. Norwalk would finish in third place. Dominguez and Gahr were the bottom two teams of the SGVL for the 2021-2022 season while Mayfair, which won the Suburban League that season, went 1-7 in the Gateway League. For the 2023-2024 season, Gahr moves up while Mayfair moves down.

**BOYS SOCCER**

Prior to the 605 League, the Suburban League would be owned by Artesia High and Norwalk for the most part. Since then, Norwalk would still be the top dogs of the Suburban League, winning three of four league titles with La Mirada claiming the other. But this past winter, it was Warren, Lynwood and Downey getting the top three spots in the Gateway League while Norwalk stumbled to last place. In the Mid-Cities League, it went La Mirada, Bellflower and Mayfair. All six failed to get past the first round in the playoffs. For Norwalk, it would miss the playoffs for the first time since 2005. For the 2023-2024 season, Norwalk and La Mirada will trade leagues.

**GIRLS SOCCER**

While not much was expected from the Gateway League with

La Mirada, Downey and Warren all competing for the top spot, which is nothing new to all three, the Mid-Cities League did great things for Bellflower, Gahr and Norwalk. Gahr would win its first league title since 2003 and Norwalk would get to the playoffs for the first time since 2014. Only Gahr would be the only one of the six to get to the second round and because of that, the Gladiators move to the Gateway League while Paramount is now in the Mid-Cities League.

**BASEBALL**

The anticipated three-game series between Gahr and La Mirada to determine the Gateway League champion did not disappoint with the latter winning the first two of three meetings in the final week of the season to win the circuit by two games. Both would advance to the quarterfinals in Division 1 and Division 2 respectively while Warren finished in third, six games behind La Mirada. Gahr and Warren had been the top two teams in the SGVL recently.

The new conference/league was a welcome site for Norwalk, which won all 15 Mid-Cities League contests and went to the quarterfinals for the first time since 1999. Second place Mayfair also went to the quarterfinals and Paramount came in third place for its first playoff appearance since before the 605 League was formed. Next season, Bellflower and Norwalk trade leagues.

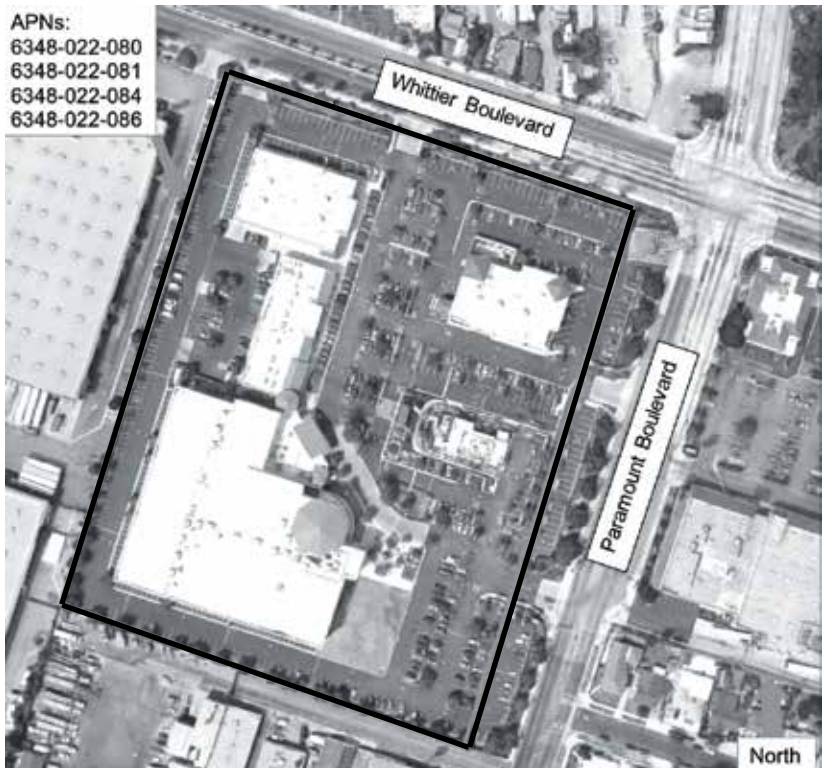

### Bellflower Firework Enforcement Teams Will Be Out in Full Force

The Bellflower Municipal Code Section 8.16.010 states in part: "It is unlawful for any person to fire, set off, discharge or use, or cause or permit to be fired, set off, discharged or used any fireworks except that safe and sane fireworks may be fired..."

4th of July festivities is coming and Bellflower and County enforcement teams will be out in full force.

Individuals caught possessing or discharging illegal fireworks will receive a \$2,000 citation.

Additionally, enforcement teams can also hold property owners equally responsible for allowing or not stopping their tenants and guests from discharging illegal fireworks, with a citation subsequently sent to the owners in the mail.

These enforcement efforts resulted in 106 citations last year and Bellflower is again planning for this zero-tolerance approach.

To report illegal fireworks periodically occurring from a property in the days leading up to the 4th of July, contact the Bellflower Sheriff Substation to add that location to an enforcement list (562) 925-0124.

On the 4th of July, contact the Lakewood Sheriff Station, so that location can be dispatched to the undercover enforcement team 562-623-3500.

Bellflower strongly encourages all property owners to take a more active role in ensuring that family members and guests on their property refrain from using illegal fireworks this Fourth of July.
