## Hawaiian Gardens Settles Harassment Lawsuit Caused by Current Employee Fred Licon

Licon was also found by a judge that he misappropriated and misused union funds in October 2020, he is still employed.

In May 2021, Los Cerritos Community News was the only media outlet to report that Brianna Gonzalez, an employee of Hawaiian Gardens, was suing the city, alleging the city did not do enough to protect her and other women from being sexually harassed by the former president of the workers' union, Fred Licon.

Gonzales sued for sexual harassment – quid pro quo, hostile work environment, and failure of the city to take all reason-

able steps necessary to prevent harassment.

Licon is the former AF-SCME union president with a checkered past, found guilty of misusing union funds in 2020.

Nine days ago, LCCN, speaking to sources close to Gonzalez, exclusively reported that Hawaiian Gardens had settled the lawsuit with Gonzalez.

Now LCCN, via a public records request, has obtained the Settlement Agreement and Release of All Claims between the two parties, and it is not pretty.

Hawaiian Gardens residents, some of who had called for Licon to be fired after he was found misusing union funds and again after Gonzalez sued, are not going to be happy, with Licon adding yet another black mark on the city, his em-

## Report Alleges Graft and Corruption Inside Anaheim City Hall

A "criminal conspiracy" regarding \$1.5 million in COVID-19 relief funds; the report initially cost \$750K ended at \$1.5 million

An outside investigation into political corruption in Anaheim was made public Monday and found a "potential criminal conspiracy" regarding \$1.5 million in COVID-19 relief funds, alleging that the city's former mayor and the ex-head of the Anaheim Chamber of Commerce participated in "influence ped-

dling."

The report was done by an outside firm originally budgeted at \$750,000 but ironically ended up costing \$1.5 million.

The report named Harry Sidhu and his cronies at the Chamber, done after a political corruption investigation by the FBI became public that accused Sidhu of several misdeeds, including the sale of Angel Stadium.

Sidhu, who resigned, has denied wrongdoing.

Even though the price doubled, the report by the JL Group does not contain any blockbuster revelations. Still, it depicts a corrupt group of politicians and lobbyists influencing decisions

inside city hall.

The most serious allegation was the misuse of COVID-19 funds which occurred after the City Council approved Sidhu's plan in March 2020 to direct \$6.5 million to Visit Anaheim. But \$1.5 million was illegally diverted to a company controlled by the Anaheim Chamber of Commerce, headed at the time by Todd Ament.

The report stated that "there was a conspiracy between then-Mayor Sidhu, Ament, and the CEO and president of Visit Anaheim, Jay Burress. Sidhu directed Burress to divert \$1.5 million to the Anaheim Chamber's controlled nonprofit and

## Invasive Fruit Fly Prompts Quarantine in LA Neighborhood

The discovery of an invasive fruit fly prompted a rare quarantine of produce of a neighborhood in L.A. County, the California Department of Food and Agriculture (CDFA) announced last week.

This is "the first Tau fruit fly quarantine ever in the Western Hemisphere," according to the CDFA.

More than 20 Tau fruit flies were found in Stevenson Ranch, an unincorporated area near Santa Clarita. The Tau is described by the CDFA as a "serious pest for agriculture and natural resources."

Tau fruit flies are about the same size as a housefly. The adult females lay eggs in produce, and the larvae "tunnel through" and feed on it.

A quarantine was imposed that encompassed 79 square miles.

"To prevent the spread, residents living in the quarantine area are urged not to move any fruits and vegetables from their property," the CDFA said. "They may be consumed or processed at the property where they were picked. Otherwise, they should be disposed-of by double-bagging in plastic and placing the bags in a bin specifically for garbage."

The CDFA is working with the U.S. Dept. of Agriculture and L.A. County to eliminate the species and prevent it from spreading to new areas, treating them with "a naturally derived organic-approved material known as Spinosad."

"Finally, fly traps that incorporate a pheromone lure and a minute amount of pesticide will be used in a wider part of the treatment area," the CDFA said.

## Downey Mayor Looks to Open Homeless Center in City

In a letter to the media, Downey Mayor Claudia Frometa wrote that the city, "due to an increasing homeless activity," will study opening a Homeless Center in the city.

"We are seeing increased transient activity throughout our city; this has become a greater concern over the last several weeks. Clean ups will continue in coordination with LA County Dept. of Mental Health, LA Homeless Services Authority (LAHSA), PATH and DPD."

Frometa indicated the city approved a Homelessness Solutions Manager position to assist with the efforts.

"As this situation continues to

worsen, there are currently 60,000 homeless people in the City of Los Angeles, and another 12,000 in surrounding cities in Southeast Los Angeles, Downey must become proactive and aggressive in its efforts to curtail homelessness activity and its impacts on the quality of life for our residents and impacts to our businesses."

Frometa stated that the City Council, alongside the City Manager, we will be discussing efforts to open a Homeless Center with services in Downey.

"We can no longer stay idle and hope the 'clean' up efforts work. As we look at alternatives and common-sense approaches to address this growing concern, my goal is to protect the quality of life for our residents and tackle the safety concerns."

## CA. Voters May Face Ballots About Oil Wells Near Schools

California voters may be asked twice on the same November 2024 ballot whether to keep or to ditch a law mandating new oil wells be a certain distance away from homes, schools and parks.

Last year, lawmakers approved so-called buffer zones around oil wells, which dot communities around Los Angeles and the state's Central Valley, as part of a package of bills aimed at tackling climate change and pollution. The oil industry quickly moved to undo the law by gaining a spot on the 2024 ballot.

But on Wednesday, environmental advocates put forward their own proposed ballot measure aimed at getting voters to require buffer zones.

Environmental justice groups have made multiple attempts over the years to establish a minimum distance between oil and gas wells near places like homes and schools. Newsom signed the law last year

that banned new gas and oil wells within 3,200 feet (975 meters) of sensitive areas.

The oil industry quickly filed for the referendum to ask voters to overturn the law, and the group collected enough signatures earlier this year to put it on the ballot.

The oil industry's tactics to collect the 623,000 signatures needed to get their favored measure on the ballot have come under fire. The California Secretary of State's office said last year it was investigating complaints alleging signature gatherers were spreading misinformation about the measure.

The Legislature is weighing whether to change the referendum process so Californians don't get confused about whether they're voting to uphold or to overturn a law. The legislation would have voters decide to either "keep the law" or to "overturn the law." That would mean a departure from a "yes" vote to keep the law or a "no" vote to overturn it.

Back in 1986, McDonalds created a character called CosMc and featured the character in a series of McDonald’s commercials and print ads from '86-'92.

CosMc is a yellow-colored part alien, part robot appeared in the second phase of McDonaldland the franchise’s fictional world inhabited by Ronald McDonald and his friends.

The lesser-known character, which began appearing in McDonald’s ads in 1986, had six arms and relocated from his home in space when he discovered McDonald’s burgers and fries.

On July 27, McDonald’s revealed it would be launching a spinoff restaurant chain based on CosMc.

## Whittier Union Brings Free Public Transportation to Students

WHITTIER – Whittier Union High School District is kicking off the 2023-24 school year with the renewal of the GoPass program, offering students consistent and reliable transportation to school by providing unlimited rides at no cost on the Metro bus and rail.

The program began its pilot year in Whittier Union in October 2021 after the District was approached by City of Whittier Mayor Pro Tem and Metropolitan Transportation Authority Board member Fernando Dutra.

The Fare-less System Initiative aims to increase student ridership, student success, and improve student health.

According to Metro, students with access to public transportation have a higher rate of graduation and are also shown to be healthier due to a more active lifestyle.

“This program not only helps students get to school but provides them access to after school activities such as extracurriculars, sports, jobs and more,” Director of Student Support Services Amy Larson said.

After receiving a subsidy from the state, Whittier Union pays less than \$3 for each student enrolled and receives free annual electronic passes for each student.

While not every student has a need for the program, Larson said there are

many students that heavily rely on their free Metro passes.

The pass allows each student unlimited rides on Metro bus and rail, as well as bus lines including Norwalk Transit, Montebello Bus, City of Commerce, LADOT Dash, Culver City Bus and the Santa Monica Big Blue Bus.

“It’s really a privilege that Whittier Union gives us access to this program,” California High School junior Nadia Medina said. “I don’t have a car, so it’s really nice to

have a way to get to the places I need to go and to be able to get to school on time.”

Students continue to rely on the GoPass service during the summer vacation months to get around the city. Those interested can contact the Whittier Union Student Support Services office at (562) 698-8121 ext. 1180 for more information on how to receive a Metro pass.

“The GoPass program truly benefits our students and ensures that transportation is not a barrier to their school attendance,” Superintendent Dr. Monica Oviedo said. “At Whittier Union High School District, we pride ourselves on providing the necessary resources to help our students succeed every day.”

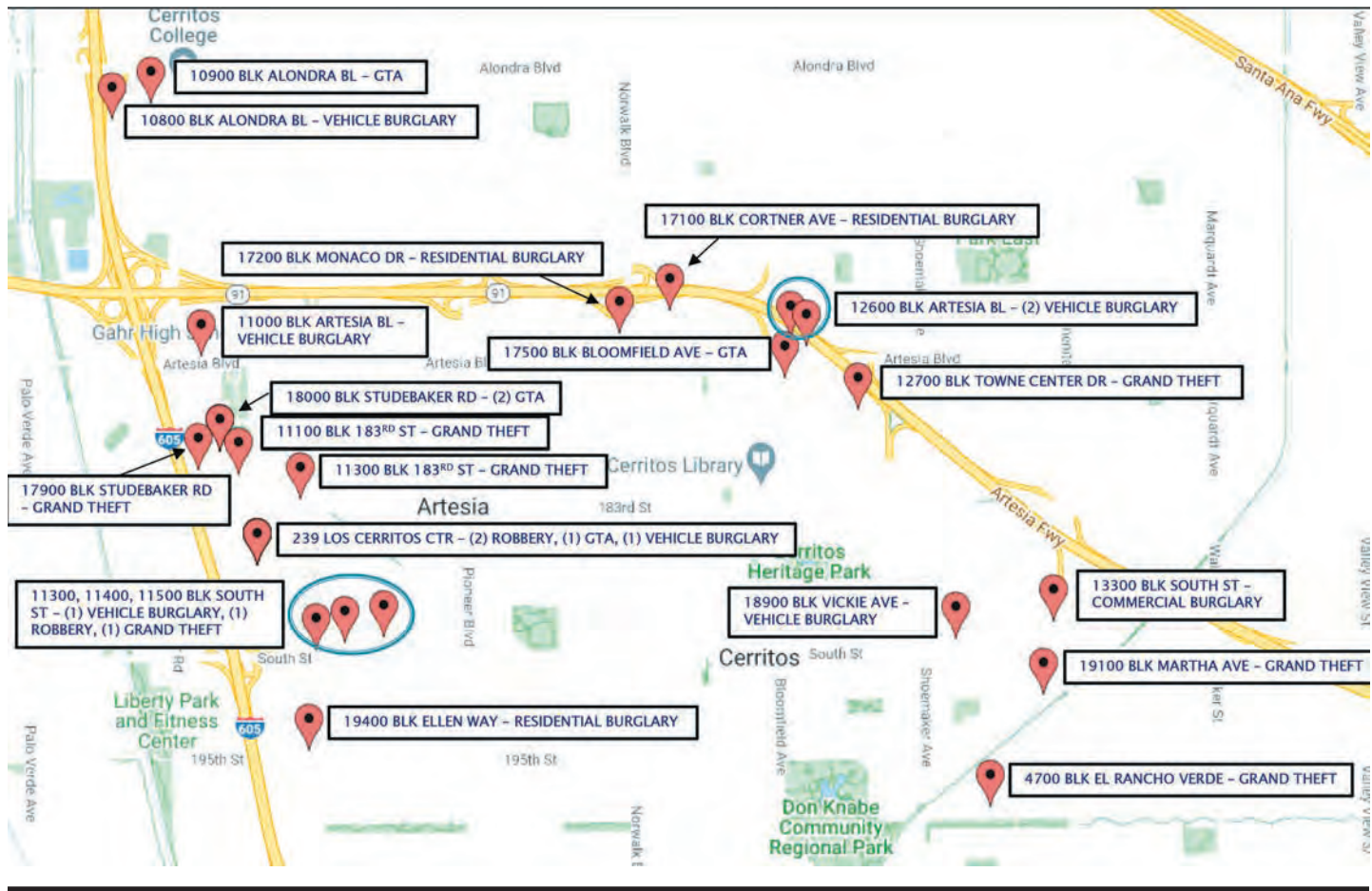

## Man Stabbed on Metro Green Line

## LA Zoo to be Revamped Under Plan Approved by the City

LOS ANGELES, CA — The City Council green-lighted a revised plan Wednesday that will guide the physical transformation of the L.A. Zoo and explore the feasibility of expanding transit service to get there.

According to Raman, the revised plan restores and protects some of the most “vulnerable trees,” Coast Live oak trees, by leaving an undeveloped hillside in a proposed Africa exhibit area.

The plan also commits “to reduce vehicle miles traveled for visitors who are coming into the park while also

aligning with the city’s existing efforts to preserve wildlife crossings and natural areas.

Raman said the city’s Department of Transportation and Metro are making plans to expand transit services to the zoo.

The final design and renovation costs remain unknown, but city officials said it would be paid for with private and public funding. A report from the Zoo Department stated the initial phase of construction is estimated at \$650 million.

# I Got Cancer Cerritos Resident Dealing With Cancer for Twenty Years

**L**ife with cancer can present tough questions about the quality of life versus longevity.

Benny Wasserman, 89, of Cerritos, had to decide long ago how he'd approach his cancer diagnosis and treatment. He's been dealing with prostate cancer for 20 years now.

By his early 70s, he had been having urinary difficulties, which ultimately brought attention to elevated PSA levels and by the age of 82, he was formally diagnosed with prostate cancer. He will turn 90 in April 2024 and will celebrate his 65th wedding anniversary in June. The couple has three sons, one geriatric physician and two attorneys, with nine grandchildren and two great-grandchildren, plus six nieces and two nephews.

With the help of his physician son guiding him, he long since has had a minimalist approach to his cancer.

"I learned that it was possible to stay away from biopsies and its own potential to harm," Wasserman explained. "I was able to stay away from unnecessary bi-

opsies and medications because of my son's input and expertise. I was very fortunate to have my son, a geriatrician of 25 years, at my side. He was able to agree, and at times disagree, with my Kaiser urologist and oncologist's decisions."

"I have never had surgery or chemo," he said. "I have had other kinds of treatments, mostly hormonal."

"I also learned how important it was that a patient learns as much as he can about his illness and possible treatments and their consequences," Wasserman explained. "It's important also to review the scientific literature and studies on the suggested medications. Every individual may or may not react to the possible side effects. These sometimes can be tough choices."

"Again, there is this balancing act between quality of life and longevity," he said. "No one but the patient can make that decision for you, not even my son."

But once his son saw his PSA had reached 50, it was all about treatment, according to Wasserman. With the latest medications available, they agreed to start on Casodex, and ended up on Lupron.

"I had to decide what could I live with and what would I be willing to give up by accepting side effects such as the hot flashes 24/7," he explained. "It hasn't been easy to accept multiple sleep disruptions during the night. I am now glad that I stuck with the Lupron, which kept the PSA down for as long as it has."

He added that though every individual reacts differently to medications, in the end it is still worth allowing them to do what they have done in scientific studies.

When his PSA began to climb from what it had been for a long time at 7 ng/ml to 11, his doctor asked him if he wanted a biopsy, something Wasserman found curious.

"I found it curious that he would ask me instead of telling me," Wasserman said. "What did I know about things like this?"

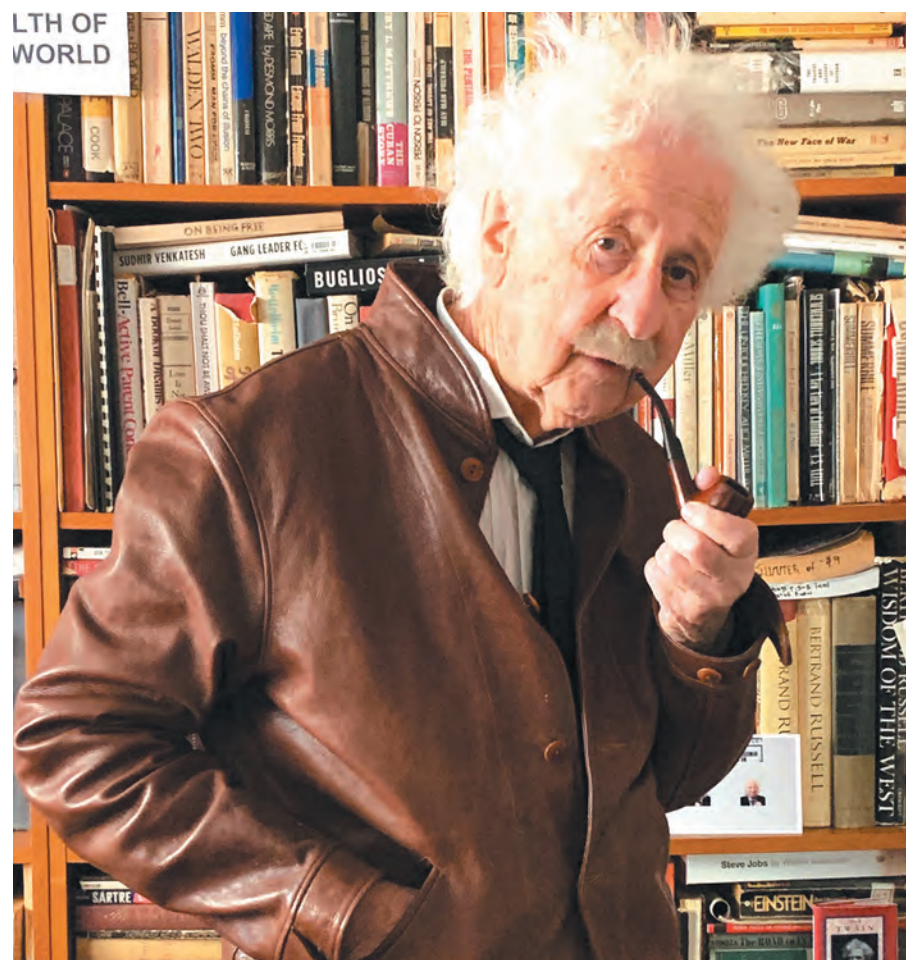
The doctor explained that some patients wish to know they have prostate cancer, as it turns out there is the slow-growing type and the more aggressive type. According to Wasserman, the research on this subject is still controversial, saying that the PSA isn't all that reliable.

Another test is the digital rectal examination (DRE), to feel the prostate for anything abnormal. Wasserman's urologist indicated that his prostate was beginning to enlarge and harden, meaning he might have prostate cancer.

"The literature was saying that once a male reaches age 75, it is probably the slow-growing type, and men would die of other causes before they would die of prostate cancer," he added. "All this time, I was consulting with my son, Michael, a geriatric physician. He suggested that I not even retake the PSA test. So, I didn't."

Then when I was in my late 70's, I started having urinary

problems. For this, I was prescribed Finasteride, a medication for the prostate to alleviate urinary difficulties. And it worked."

When Wasserman turned 82, after another six or seven years, his doctor had him take another PSA test, and it read 50. At this point, a biopsy was suggested, and after his son consulted with his doctor, both agreed it was probably prostate cancer.

"My son still felt there was no need for a biopsy," he said. "But it was time for some kind of treatment. Both decided that I take the medication, Lupron

Depot by injection."

"The results were phenomenal," Wasserman said. "Both PSA and testosterone levels went to practically zero. But the only problem was the side effects, the worst being hot flashes. The first injection was given to me in December 2016, and I took blood tests every three months. By the ninth month, the reading had returned to what it was before."

At this point, on the recommendation of Wasserman's grandsons, he tried a concoction of a variety of cannabis after obtaining a license from a doctor.

20-YEAR cancer survivor who has found his own wisdom, Benny Wasserman, 89, of Cerritos, enjoys doing Einstein impersonations. He hopes others make the most of life each day by doing what they love, too.

There were testimonials on the Internet that suggested that some individuals had their prostate cancer go into remission.

"This doctor had nothing to do with prescribing any particular kind or type of cannabis," he explained. "As far as I was concerned, it was a hit-or-miss proposition. I was given four different kinds of THC and CBD and suggested dosages. I took them religiously for three days. And then I began to hallucinate. That was the end of that."

It was then, by December 2017, that Wasserman decided to take the Lupron again.

"Again, the hot flushes came on," he explained. "This time I began to lose a lot of sleep and I was getting weaker and weaker. I decided I would no longer take the Lupron even if it meant that I would die sooner than later."

For me, it was again all about quality-of-life vs longevity."

"Emotionally, I try not to complain," Wasserman explained. "I am more than content with the care I have gotten from all the doctors and nurses at Kaiser Permanente for the care I have gotten for the past 40 years. I've had triple bypass heart surgery, an aortic aneurysm repaired and bowel obstruction

surgery." However, by June 2018, another blood test showed his PSA was at 100.

"Because I refused to retake the Lupron Depot, another urologist suggested I take a similar drug, Casodex," he added. "Not just a single dose, but a triple dose."

It was shortly after that year Wasserman got results of bone scans which showed cancer had spread in small lesions to the ribs, sternum, spine, and pelvic region and beyond to his hip joint on the left side of his body. A lesion in the right shoulder persists was shown to be more worrisome for metastasis.

"It is only recently that I have been taking radiation (Radium 223) intravenously once a month for six months to reduce the excruciating pain in the bones when they start to deteriorate," he explained. "At this moment, it seems that it has somewhat stabilized. For now, I'm not in any kind of pain, except for my spinal stenosis in my lower back."

"At [nearly] 90 years of age, I also have other health issues."

It's a horse race as to which one will take me down."

Wasserman is back on Lupron. While it is not a cure for advanced prostate cancer, he says people might choose it along with their doctor as part of their treatment plan to suppress testosterone which may cause testosterone-dependent prostate cancer cells from growing.

"The worst side effects from

Lupron, which has shown to be quite effective, are hot flushes, sweats, and tiredness which occur every half hour [every day, seven days a week]," Wasserman explained. "Not everyone who uses this drug, though, gets those side effects."

"At first, I felt the side effects were intolerable," he said. "I stopped taking it, and I started taking other drugs, but their side effects were much worse. All I can say is that I got lucky and learned to live with the side effects."

"It's also all about benefits versus discomfort. I continue to get Lupron injections every three months along with Radium 223," he said. "I have fans not only in my home to keep me cool when I get these hot flashes but also handy neck fans. It's called adapt and adjust as best you can at my age."

Wasserman believes in being grateful for all he has every day. His simple pleasures have been and continue to be reading, writing (he has written one page a day for the past 40 years) and he spends time playing the guitar or keyboard every day though he says he's not very good at either.

He plays a fair game of ping pong or shoots a few basketballs in his backyard with anyone who wishes to take him on. He also has a pitching machine for golf-ball-sized wiffle balls in his backyard and enjoys going to the batting cages at Home Run Park in Anaheim every Friday morning at 10 a.m. to hit 90 mph baseballs.

"I'm getting ready for 90 mph at 90 years old on my birthday," he added.

So far, he's enjoyed solid relationships with relatives and friends throughout his cancer experience. His wife and three sons have been super supportive by making sure he continues to use his body and mind as much as he can, and though he says he's slowed down, he hopes to reach age 90 on April 2, 2024.

Wasserman worked for TRW, an aerospace company now owned by Northrop Grumman, and was not employed when diagnosed with prostate cancer. He was forced into retirement at the age of 58 in 1992. For the last 25 years, he's been an Einstein impersonator doing gigs all around the world.

Though not a man of faith with either religion or spirituality, Wasserman has always been a positive person who looks to the future and is thankful for all he has.

"It's not easy to appreciate the life you have left when you are losing energy and feel increasingly tired every day," he said. "We all go downhill and fade away differently. We can fall apart physically but still retain our mental capabilities if we are lucky."

"Sometimes, somehow, you just have to keep pushing forward," he added. "Open your eyes wide and keep your eyes on the ball."

He hopes others will make the most of each day with things they love to do the most.

Although the Lancers won just one Suburban League crown during that time, it advanced to the CIF-Southern Section quarterfinals twice, the semifinals twice and lost in the 2013 Southeast Division championship game. By virtue of sharing the Mid-Cities League title with Bellflower High and Gahr High, the Lancers move to the Gateway League where tougher competition awaits them.

Norwalk was its usual self in 2022, running the double wing offense as it has done for over 15 years and winning at least 10 games for only the third time since 2009. After seeing the program take a dip from 2018-2020, head coach Ruben Guerrero has put Norwalk back on the Southern Section map.

“You always want more when you’re in this position being a competitive person,” said Guerrero. “You always want more, but as I’ve had time to kind of just soak it all in and kind of reflect... we had a really good season; a successful season. I’m very proud of the kids in what they did and what they accomplished. They did some things we hadn’t seen around here in a while. I’m glad we were able to bring something to Norwalk High School that hadn’t been here in a while. I think that was our first playoff win [since 2013], moving on to the second round.”

Guerrero said the difference between his first and second seasons as head coach was the senior class, which was motivated to go farther in the playoffs than in 2021, when Norwalk was bounced in the first round and ended up 6-5. But with the graduation of 26 seniors from last season’s team and the move to the new league, it might be difficult to duplicate what the Lancers did last season.

“I know we lost a lot of players, but we’ve got some kids that have been in the program for a few years, and again, the message is the same,” said Guerrero. “What do you want out of this thing? You



will always get out of this what you put in. So, we have some kids that have said, ‘you know what coach, we want to pick up where the other guys

left off’. So, we feel really good. It was a special bunch [last season] and now we’re just trying to find a way to have as much success and carry on the legacy that they set up for us.”

### OFFENSE

Stop me if you’ve heard this before—Norwalk scored over 450 points, including at least 44 in eight games, and was held to one touchdown in the two losses. But as the 2023 season approaches, gone is quarterback Caden Barnhill, who completed six passes for 104 yards and a touchdown, and gone are running backs David Herrera and Michael Mueller, who combined for 3030 yards and 40 touchdowns. With that said, senior Rylee Sosa, who was Barnhill’s backup, will assume the quarterback duties with junior Nicolas Barrera as his backup. Sosa, who played in a few games as a junior, has paid his dues sitting behind Barnhill since the Covid-shortened 2020 season. But Guerrero says he knows the offense and has been running it since he was a freshman.

“He’s ready,” said Guerrero. “He’s been working his butt off in the weightroom, he’s been a vocal leader around here and he’s getting the guys in the huddle when we’re in practice. He’s showing every sign of being the captain out on the football field for us and that leader we’re looking for. We have a lot of confidence in him.”

Replacing the two 1,000-yard running backs will be seniors Caleb Mitchell and Anthony Rodriguez on one side of the backfield and junior Ezra Mueller solidifying the other side. Those three combined for 305 yards and five touchdowns last season. Sophomore Diego Cerritos figures to be the leading backup to the three returning backs. When Sosa or Barrera throws the pigskin, which won’t be much, seniors Alex Alvarez and Jorge Ortiz will be the tight ends.

The offensive line will consist of senior left tackle Rafael Rivas, senior left guard Jonathan Hernandez, senior center Adrian Lopez, junior right guard Bobby Mosqueda and junior right tackle Anthony Lemus.

“I think it’s just going to be a matter of how fast these guys can get up to speed as far as the experience needed to run our offense the way it can run to its fullest potential,” said Guerrero. “They’ve been working very, very hard. It’s not like they haven’t been in games on Friday nights. The only thing I look for is that learning curve, right? How soon are they going to get over that learning curve?”

### DEFENSE

The defense was just as impressive as the offense last season, allowing 189 points and posting three shutouts. There were four other games in which Norwalk yielded 21 points or fewer points. In fact, after giving up 61 points in the first two games, Norwalk allowed 42 points in the next five games. At defensive tackle, it will be senior Jonathan Anguiano, a three-year varsity letterman who had 30 tackles last season, and junior Papo Leiataua (27 tackles, two sacks) while Lopez will lock down the nose tackle position. In the rotation for the defensive line will be

senior Dominick Inzunza.

The secondary stacks up with senior Hector Cruz at one corner with Mueller (11 tackles, three interceptions) at the other corner. At safety will be senior Jacob Lopez and Mitchell (13 tackles) while the linebackers will be seniors Jesse Lopez (67 tackles, three sacks), Jonathan Orozco and Ortiz and junior Joel Espinoza.

“It is shaping up pretty well,” said Guerrero of his defense. “We’ve had a few changes, but the kids have really handled them well. They’ve really, really worked hard to come together as a unit because we had player turnover with graduation. It’s a group that’s coming together. They get fired up to fly around on the field.”

### SCHEDULE

Two things stand out when it comes to Norwalk’s schedule this season. First, it will play four home games after being home nine times last season, including both playoff games. Second, the Lancers will play 10 straight games after their bye before hitting the field for good, giving the young team that extra week before the regular season. Once the regular season begins, Norwalk will face a pair of teams that advanced to the playoffs last season. South Gate High went to the CIF-Los Angeles City Section Division 1 quarterfinals. After that comes the city rivalry game with John Glenn High, a team the Lancers have dominated for much of the history of the Mayor’s Cup. The only repeat opponents will be La Canada High, a 49-28 win in the second game, and of course, Glenn, which was a 59-6 contest.

“We’re preparing for that Gateway League, so if you want to be the best, you have to play the best,” said Guerrero of the first four weeks. “We’re just looking to level up the ballclub with everyone else.”

Once the Lancers get through with Glenn, they hit the teeth of their schedule as their next four opponents went to the playoffs last season. Downey High was in Division 4 last season while Warren High was in Division 2.

“This time last year, I could probably say my perception of [moving to the Gateway League] has changed,” said Guerrero. “But we’ve worked really hard at just developing our program and trying to get into a place where [we] put Norwalk back on the map. We’re going to put our best foot forward and just go for it. A lot of the kids who are returning... they’re pretty excited. [They] get to level up in our competition and I tell them that’s a result of all their hard work.”

“We’re going to see some familiar faces and old foes,” he later added. “But again, if you look at it, it is a slate of tough opponents. We’ve come to grips; we’ve come together as a coaching staff, we’ve come together as a team and we see this as an opportunity. We see this as an opportunity to show all the hard work that’s been going on at Norwalk High School for the last couple of years and the kids are fired up.”

### HOMECOMING

For just the second time in over 25 seasons, Norwalk’s homecoming game will be against a non-league opponent as Locke High, which won two games in 2022, is the foe. The other non-league homecoming opponent was Long Beach Jordan High in 2018, a 17-7 loss. The Lancers have won their last two homecoming games by a combined score of 100-8 after losing two straight. This will also be the fourth time since 1998 that the homecoming game is played in September and the second earliest. The game against Jordan was on Sept. 7. Since

### FORMER CITY RIVAL AND NFL PLAYER HOPES TO TURNAROUND STRUGGLING JOHN GLENN PROGRAM

Just when you thought the John Glenn High football program might be turning the page and getting back to being competitive the way it was in 2018 and 2019 when the Eagles went to the CIF-Southern Section playoffs, things have gone south. Glenn has won five games since Nov. 1, 2019. But new head coach Elijah Penny, a former Norwalk High standout and more recently of the New York Giants, takes over as the program's 11th head coach since 1998.

"I look at it as a great challenge, not

only for myself, but for the coaches who are on staff as well," said Penny. "I'm enjoying the process of watching these kids

just develop day in and day out. It's a huge testament already to the coaches who are here just helping me develop the kids at the pace they're moving at. I would say overall, it's definitely a blessing."

Penny said since he was hired, the players have bought in to the program well, work how the coaches work and have responded to every challenge thrown their way.

One of the two victories last season was a forfeit against Long Beach Cabrillo High in the second week, which was a 32-13 decision on the field. A week five home contest against Hawthorne High was cancelled and came a week after falling to Norwalk 59-6 and a week before its scheduled bye week.

Penny also added that the toughest part of him being Glenn's new coach has been relaying certain verbiage back to the kids as his last experience with football was in the NFL. But he wants to reiterate he has a great coaching staff, which includes Freddy Easter, former CIF champion Saeed Galloway from Dominguez High, Darrick Rice, a former defensive coordinator at Norwalk when Penny played there, plus former Norwalk



standouts Billy Moore and older brother Robert Penny along with Kurt Davis from the University of Nevada, Las Vegas.

#### OFFENSE

Glenn scored 122 points last season, but 49 of those came against Firebaugh High in the second game of the season and 35 in the last two games combined against Artesia High and Cerritos High. Of the 14 seniors lost, the Eagles have to replace Emmanuel Enriquez at the quarterback position and Penny has tabbed junior Raymond Acosta, a tight end last season, as the starting quarterback with sophomore Luis Vergara and freshman Israel Lewis as the backups.

Acosta was once a tackle in his earlier high school days and after seeing some film on him and watching him throw over the summer, Penny thought he was somebody who was just as talented as Enriquez.

"During seven on seven's this [past] spring and the tournaments that we've been to, Ray has been tearing it up and looking good," said Penny. "I'm excited for him and his transition...I believe that Ray is a football player. We call him a quarterback because he's a big guy. He throws with a huge arm, and he likes to hit too."

Last season, people were raving about

Tuiono Tuifua being the next best star running back to put on a Glenn jersey. Then he got injured early in the season and the ground game wasn't the same. Now, he returns as a junior and still considered as one of the premier backs in the 605 League. Penny says his progression in the offseason has been going well and he's been one of the players who has been picking up things fast. Even the former coaches from last season and current administrators who stop by to watch practice can't believe how much bigger, faster and stronger Tuifua has gotten.

Joining him in the backfield will be senior Devin Lewis and sophomores Terry Henderson and Darron Walker. Although Penny played in a double wing when he was at Norwalk, there will be some hints of that this season at Glenn, but nowhere near the consistency of Norwalk. All four running backs will also catch some passes.

Listed as wide receivers will be senior Alfonso Vega, whom Penny compares him to Julian Edelman because he makes a lot of tough catches, and juniors Noah Castanon and Jacob Ramirez. Sophomore Andres Escobar is another wide receiver to keep an eye on and senior Marcus Jackson will be the tight end.

The offensive line will have five new starters with senior left tackle Adrien Aleman, junior left guard Johdan Escobar, junior center Joshua Frausto, sophomore right guard Ivan Galindo and senior right tackle Damian Garcia.

"We definitely have some double wing in there just because of where i

**FINAL COMMENT**

“What I’ve discussed with the team and what we’ve come to as a big group is we’re taking this season in parts,” said Guerrero. “You can’t engulf any one thing at one time. So, we’re going to take it in parts. We have goals...that we can take step by step. Right now, we’re focusing on our first opponent and then we’re working on our preseason. Once we get to the preseason and get through that, then we start looking at league. Once we start looking at league and we get through that, our goal is to be in the position to compete in the Gateway and also have an opportunity to be in the playoffs.”

come from and my history,” said Penny of this season’s offense. “But then again, we have other formations. We’re going to spread the ball out; open it up and pass the ball more. So, we’re definitely going to be a more balanced-attack team.

“What I like about my offense is that we obviously get to run and smash opponents and break their will with our run game,” he continued. “The extra blockers at the point of attack is always good for us, especially when we have talented runners like we have. The things I don’t like about the offense, or I dislike about it is that once you get down and you’re running the ball, your playbook is limited. But like I said, the staff that we have here...I had coaches up all night just scheming different things out of different formations. For those moments, we’ll be prepared.”

**DEFENSE**

Glenn gave up 385 points, including over 50 points in five of the last six points and trying to prevent numbers like that will be Aleman, Johdan Escobar, Garcia and sophomore Abraham Beltran on the defensive line with Ramirez and Walker in the secondary joined by Andres Escobar at one safety and freshman Samuel Reeves. Vega is listed as one of the top cornerbacks as well.

Probably the strength of the defense will be the linebackers, headlined by seniors O.J. Romero and Gabriel Vergara, Henderson and Tuifua.

“I love the fact that we’re able to get into different fronts and the kids [have been responding] to is,” said Penny. “We have so many packages that we’ve been practicing for different scenarios. The good thing about our defense is that the kids...they adapt well to when we make our adjustments and stuff like that. I love everything about our defense; I really don’t know what I don’t like.”

**SCHEDULE**

The Eagles softened up their schedule this season to make just about every game a comparable matchup. All non-league opponents except for Norwalk are new from last season’s schedule and four of the 10 opponents went to the playoffs last season-Bassett High, Norwalk, Cerritos and Pioneer High. Bassett was the only one that won two playoff games and Rancho Dominguez High and University High are from the CIF-Los Angeles City Section.

“We’ve seen a lot of Bassett on tape; they do a lot of things well,” said Penny. “But we’ve seen our guys progress at a fast pace, and we really don’t try to get caught up into too much of what teams did last year because this is high school ball and you have a totally different team from the team you had last year.”

Despite the domination by Norwalk in the Mayor’s Cup over the history of

the rivalry game, Penny refuses to act like it’s another game for Glenn. He says it’s going to be a good game for the city in general and believes it’s going to be good entertainment for everybody in Norwalk from the alumni of both schools to the students, staff and faculty.

If the Eagles can get to 5-2, or 6-1 before their bye week, they will be sitting in a good position to grab one of the two automatic playoff berths from the league or have a good enough record to get an at-large berth to the postseason.

“It is very important,” said Penny. “I believe it will give the boys the right kind of confidence that they need going into the playoffs. And that’s our plan. We plan on being in and playing in the playoffs. I believe that right after Norwalk, on paper, they are pretty good matchups and I believe that’s the most important stretch of the season.”

**HOMECOMING**

Glenn will be seeking the program’s seventh homecoming win since 1999 when it hosts Godinez High on Sept. 29. The Eagles last won a homecoming game in 2017 when they dismantled Cerritos 64-25. It marked the most points scored in a homecoming game in over 25 seasons. Godinez will also be the third non-league homecoming opponent in the last four seasons and fourth since at least 1999.

**FINAL COMMENT**

“Just taking over the program has truly been a blessing,” said Penny. “I’m just truly excited for what the future holds. Like I said, the kids have bought into the program. They’re confident, they’re fast, they’re physical and right now, we’re in the midst of teaching them discipline. Once I feel like we get the discipline all the way down, then I’m sure we’ll find some success.”

to the park. Supervisor Hahn agreed, and last week, two tennis courts were adapted into ten dedicated pickleball courts.

"This is an example of democracy in action," said Williamson about her petition. "The people spoke and our elected official listened."

The grand opening began at 9 a.m., where residents were greeted with fresh fruit topped with lime, Tajin and chamoy, and coffee and donuts.

With many in attendance, the courts were opened for free play at 9:30 a.m. The ten new courts were divided among patrons and designated based on skill level. Beginners could join in on practices and gain experience as instructors were available to teach and supervise the game and players. Those with more experience playing were able to play on other courts available.

Residents were also given the opportunity to play pickleball for a chance to win prizes and to put their names in for a raffle where pickleball equipment was raffled off.

The courts can be booked for 2 hours at \$10 per person; during the day, they are available for free play from noon to 4 p.m., with drop-in play available for \$10. The schedule and information regarding how to reserve a court is available at [ipickle.com/cerritos](http://ipickle.com/cerritos).

According to the Supervisor's Office, there are plans to open more courts in the area, including La Mirada. In Jan. 2023 four pickleball courts were opened in La Mirada, but residents are asking for more.

"Pickleball is all the rage and it's easy to see why," said Hahn. "It's a fun game that people of all ages can play. Our parks should be keeping up with how our residents want to spend their time and right now our residents want more pickleball."

## L.A. Metro Continues to Increase Ridership

This week, Metro reported a 13.3 percent year-over-year increase in ridership in June with nearly 24 million boardings, marking the seventh consecutive month of year-over-year ridership growth. Metro's monthly bus and rail ridership is now at 81 percent of its 2019 pre-pandemic level. Average weekend ridership is now at 91 percent of pre-pandemic level and 76 percent for average weekdays.

In June, Metro had nearly 24 million passengers board its bus and rail services. An average of almost 867,000 rides were taken each weekday, with Saturday boardings averaging 647,000 and Sunday boardings averaging 543,000.

More than 5 million trips were taken on the rail system in June, an increase of 14.2% over June 2022.

Metro has taken proactive steps to ensure its transit service is safe, friendly, fast, and frequent by:

- Implementing a new multi-layered public safety approach to increase the visible presence of both armed and unarmed security and customer care personnel on the system.
- Executing a Drug-Free Metro campaign focused on drug-related crimes with increased enforcement by law enforcement partners targeting the hotspots throughout the system resulting in cleaner, safer transit experiences for riders
- Engaging more than 300 Metro Ambassadors to help customers navigate the transit system.

- Hiring more than 1,000 new transit operators to ensure adequate staffing levels for buses and trains.

- And fully restoring bus service making many lines faster and more frequent.

Metro also continues to provide more accessible and affordable transit through its fareless and reduced-price transit pass programs. Metro's GoPass program offers free transit passes to K-12 and community college students in participating schools, and Metro's Low-Income Fare is Easy (LIFE) program, gives free rides and discounted fares to people with low incomes.

ployment tenure and the local AFSCME Union, while costing taxpayers hundreds of thousands of dollars.

The evidence presented by Gonzalez' attorney must have been compelling, with the city settling for \$325,000 plus unused sick and vacation pay owed to Gonzalez.

In return, Gonzalez agreed to dismiss the lawsuit against the city and agreed to release any and all claims.

The parties signed the agreement on June 11, which stipulated that Gonzales had to resign once her lawyer received the check, payable within thirty days.
