Pico Rivera Approves Innovative Solar Energy Program for Residents and Developers

In early 2017, the Pico Rivera City Council established a Community Choice Aggregation (CCA) program and named it Pico Rivera Innovative Municipal Energy (PRIME) with the promise to increase the amount of locally supplied renewable energy to Pico Rivera residents and provide price stability and long-term electricity cost savings; PRIME began

In honor of Swift's track on "Midnights," "You're On Your Own, Kid" fans made friendship bracelets to trade with others attending the shows. The friendship bracelets contained phrases from Swift's songs, memes, or fan traditions. The excitement and sheer joy was palpable throughout the stadium as fans cheered upon entrance and were trading bracelets in the merchandise and entrance lines and at their seats.

Swift greeted over 70,000 fans at 8:15 P.M. when she graced the stage and did not leave the stage until 11:45 P.M.

True to its theme this year of "Build-

ing Bridges Across Communities", various cultural groups like the Samoan Cultural Dance performing the Tupulaga, the Club Magkaisa of Cerritos High School wowing the crowd with their Tinikling and Paso Doble, the Maranao Dance of Tata Malong Malong presented by Iligan City and Lanao Del Norte of Southern California, the throbbing acrobatic dance of the Junior New Systems, a finalist in "America's Got Talent" who came all the way from the Philippines with their six-inch high-heeled shoes and the Move Essentials composed of five women in their el-

Artesia Will Study Raising the City Sales Tax

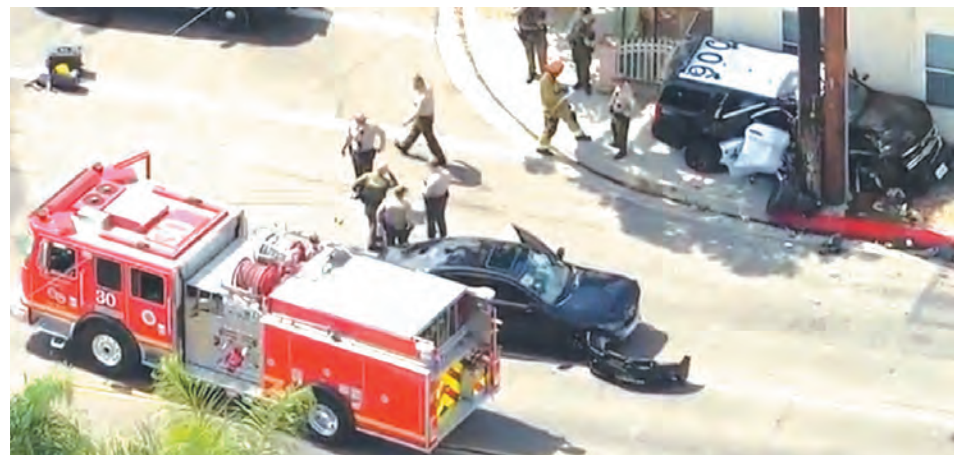

Facing a structural deficit, Artesia approved a study at its last City Council meeting in July, whether to join many other cities in Los Angeles County that have raised their sales tax, approving a sales tax survey and analytical analysis that will cost the city almost \$130,000

The City Council approved agreements with the Lew Edwards Group and FM3 Research to provide services "to assist the city with polling, community outreach, analytics, and elections support related to an up to three quarter-cent sales tax;" the contracts were for

Back-to-School Supplies for Families With Critically Ill Children

The Miracles for Kids "Back-to-School Basket of Miracles" event brought together over a hundred volunteers and donors to assemble and deliver 332 gift baskets containing 876 backpacks full of school supplies for area families.

Supervisors Want to Let the Public Know-Gun Violence Restraining Orders Saves Lives

This week, the L.A. County Supervisors unanimously approved a motion by Supervisor Chair Janice Hahn and Supervisor Hilda Solis which aims to raise awareness of gun violence restraining orders among LA County residents as tools to prevent gun violence.

In 2016, California's red flag law was signed into law, allowing law enforcement and members of the public to file Gun Violence Restraining Orders (GVROs) if they have reason to believe a person is a danger to themselves or others.

The GVRO can prevent a person who poses a significant risk of harming themselves or others from having or purchasing a gun, ammunition, or magazine for a specified length of time.

"Gun violence restraining orders save lives, but right now most LA County residents don't know about them," said Hahn. "We are setting out to change that."

GVRO's are disproportionately underutilized in L.A. County. In 2022, only 66 were granted; 65 were filed by law enforcement while only one was filed by a member of the public; San Diego County had over 400 GVROs granted.

To improve public information and awareness of GVROs, the LA County Office of Violence Prevention has created a new webpage for members of the public.

The new webpage can be found at www.publichealth.lacounty.gov/ovp/GVROs.htm. It includes information about what GVROs are, who can file for them, videos about how to file GVROs in both English and Spanish, a list of legal aid organizations that can assist, and data about gun violence restraining order filings in LA County. The webpage also includes information about possible warning signs for both suicide and potential mass violence.

The motion stressed the importance of using GVROs to prevent suicide. 90% of suicides using a gun are fatal, compared to 4% of suicide attempts not using a gun.

70th Anniversary Party at McDonald's in Downey

LBPT~The Downey McDonald's located at 10207 Lakewood Blvd., is launching a major promotion on Aug. 18, its 70th anniversary.

Next week's event is part of a campaign called "As Featured In," which highlights product placement of "fan-favorite menu items" in movies and TV shows. Specifically, it publicizes Season 2 of Marvel Studios' "Loki," which will begin streaming Oct. 6 on Disney+.

The campaign starts Monday with a combo that includes the choice of 10-piece Chicken McNuggets, a Quarter Pounder with Cheese or a Big Mac, along with fries, a soft drink and a packet of "newly-branded Sweet 'N Sour Sauce" featured in "Loki."

McDonald's calls the Aug. 18 event in Downey a "pop-up fashion experi-

ence" that will show off branded merchandise created by London-based skateboard and streetwear company Palace, according to a news release.

The news release did not mention the restaurant's 70th anniversary as being part of the event.

The first McDonald's restaurant in the chain's history was founded by the McDonald brothers, Richard and Maurice, in 1948 in San Bernardino.

That building, at 1398 N. E Street, no longer exists but an unofficial McDonald's museum stands in its place. It was created by the late Albert Okura, founder of the chicken chain Juan Pollo.

The McDonald brothers didn't team up with Chicago businessman Ray Kroc until 1954, leading to the chain's worldwide expansion.

Public Safety Cameras Installed at La Mirada's Creek Park

La Mirada has implemented its public safety resource cameras project, the first of its kind in La Mirada.

The city recently installed twenty cameras at eight separate locations within Creek Park, "reflecting the City Council's interest in ensuring parks remain safe for local families and visitors."

City crews routinely respond to graffiti vandalism and property damage in Creek Park, including within the lighted tunnel under Imperial Highway.

Reports of other minor criminal issues and nuisance activities occurring in the park are also periodically received.

"Sheriff's Deputies, Public Safety Officers, and Sheriff's Volunteers conduct regular patrols of City parks," says City Manager Jeff Boynton. "The addition of cameras at Creek Park is intended to serve as a force multiplier, providing an extra tool for the Public Safety Team to address issues occurring within the park."

The cameras feature 4K resolution and are focused on publicly accessible areas within the park and not on private property.

Video footage can be viewed on any device by the Public Safety Team in real time and is stored for 30 days.

The cameras feature environmental sensors to detect various disturbances, such as loud noises, and can promptly alert the Public Safety Team of potential issues. While the cameras may be viewed at any time, they will not necessarily be actively monitored at all times and park visitors are reminded to call 911 for emergencies.

"Cameras are a useful public safety resource and video footage captured from home and business security cameras has been helpful in solving criminal cases," says Los Angeles County Sheriff's Sergeant Oscar Rodriguez. "Cameras can also deter criminal activity and the placement of these cameras in Creek Park is an additional step to help keep the community safe."

Creek Park is the first park in La Mirada to feature public safety resource cameras. Next year, the City Council will review the usefulness and effectiveness of the public safety resource cameras in Creek Park and explore whether to potentially expand this program to other parks in La Mirada.

\$100,000 and \$29,500, respectively.

California state law sets a cap of 10.25% on the amount of sales tax a county and a city may levy together; currently, Artesia sits at 9.50%, meaning it can only raise the rate by a maximum of 0.75% or three-quarters of a cent. If approved by Artesia voters, the city would continue to receive a portion of the 1% Bradley-Burns City/County tax pool and any additional revenue resulting from an additional 0.75% lo-

cal sales tax. The new tax, projected to add \$2.5 million to city coffers, would "stabilize the city's financial health and ability to provide enhanced parks and recreation services to the community, in addition to improving roads, streets, medians, alleys, parks and community centers."

If passed, Artesia would join the 10.25% club that includes Bellflower, Commerce, Hawaiian Gardens, Lakewood, Norwalk, Pico Rivera and Whittier.

Only Cerritos and La Mirada remain at 9.25%.

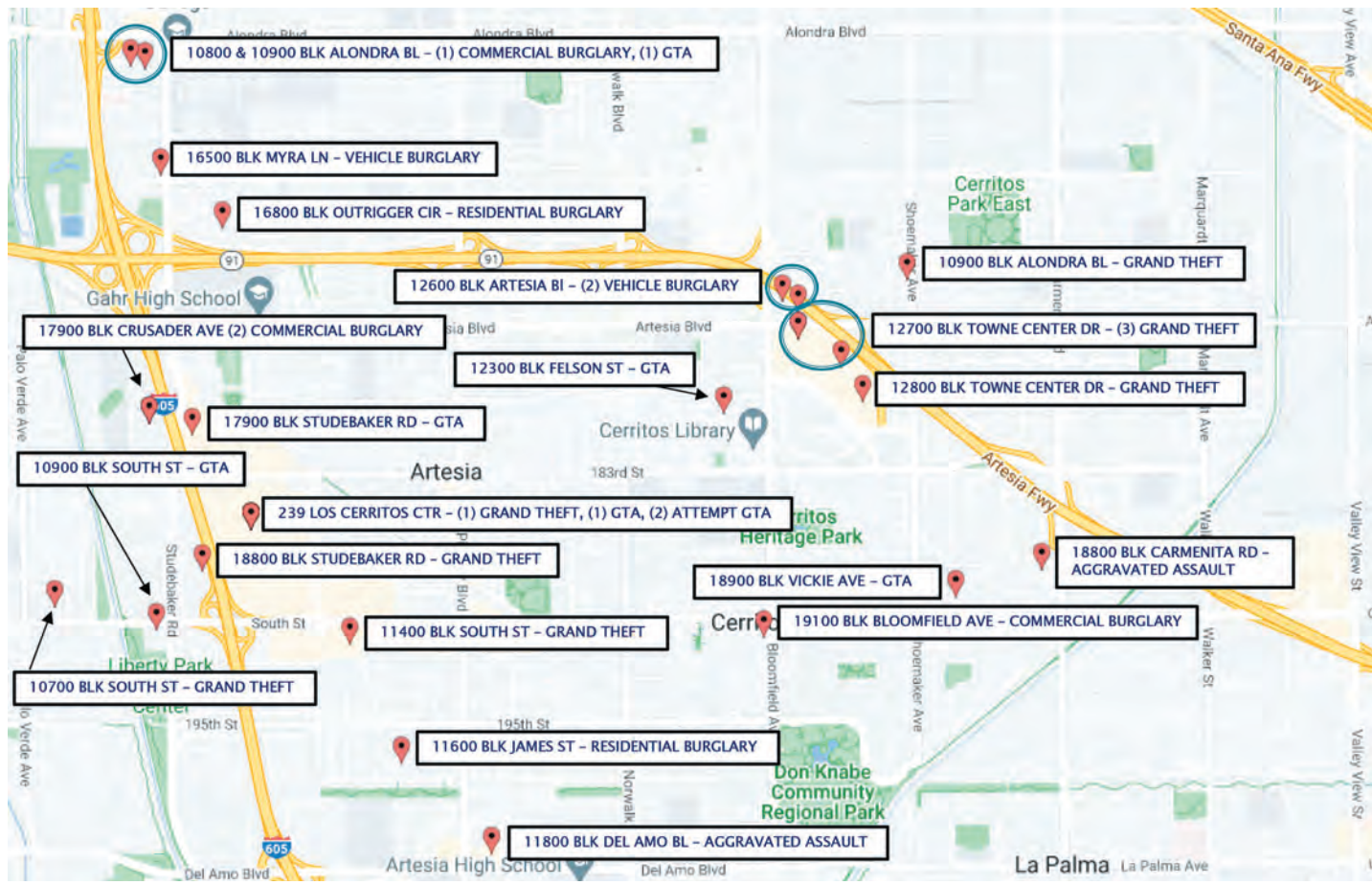

PEOPLE LOSING MORE MONEY TO SCAMS

FTC reports consumer losses to fraud totaled \$8.8B in 2022, a 30% increase from 2021.

(AP)~With the help of technology, scammers are tricking Americans out of more money than ever before. But there are steps people can take to keep their money and information safe.

The biggest losses were to investment

scams, including cryptocurrency schemes, which cost people more than \$3.8 billion, double the amount in 2021.

Younger adults ages 20-29 reported losing money more often than older adults ages 70-79, the FTC found. But when older adults did lose money, they lost more. Many retirees have assets like savings, pensions, life insurance policies or property for scammers to target.

With the rise of the digital economy, scammers now reach targets by social media and text, as well as phone and email. Online payment platforms, apps, and marketplaces also have increased

opportunities. Still, many of their tactics and strategies are similar.

“The first thing they’ll do is get you into a heightened emotional state because we can’t access clear thinking when we’re in that state,” said Kathy Stokes, director of fraud prevention for the AARP’s Fraud Watch Network. “It could be fear, panic, or excitement — ‘I just won a million dollars from Publishers Clearing House.’”

Once the sense of urgency is established, defenses are down.

“When approached with urgency, give it an extra three-second pause,” said Amanda Clayman, a financial therapist who works with digital payment network Zelle around issues of fraud. “When someone is trying to get us to take action quickly, that’s usually a red flag indicating we should do the opposite.”

Simply being aware of typical scams can help, experts say. Robocalls in particular frequently target vulnerable individuals like seniors, people with disabilities and people with debt.

“If you get a robocall out of the blue playing a recorded message trying to get you to buy something, just hang up,” said James Lee of the Identity Theft Resource Center. “Same goes for texts — anytime you get them from a number you don’t know asking you to pay, wire, or click on something suspicious.”

Scammers also will often imitate someone in authority, such as a tax or debt collector. They might pretend to be a loved one calling to request immediate financial assistance for bail, legal help or a hospital bill.

So-called “romance scams” often target lonely and isolated individuals, according to the FTC’s Will Maxson. These scams can take place over longer periods of time — even years.

“I think anyone who has participated in the digital economy has received

multiple attempts daily that have some sort of scheme, whether that’s, ‘Your account has been locked’ or ‘Your package delivery is delayed,’” Lee said. “Again, just take a breath and verify.”

Lee urges people never to click an unusual link in a text or email and instead go to the site in question directly, or call the number listed on the official site.

“It’ll take 30 or 40 seconds longer, but go ahead and do that because it could save you a lot of money every time,” he said.

Some indications to be extra wary could include an unrecognized sender, unusual wording or a tell-tale misspelling.

In 2022, consumers lost more than \$326 million from scam texts alone, according to the Federal Trade Commission.

providing power in September 2017.

There are over 200 cities and counties in California, with CCA energy providers generating more than 11,000 megawatts to over 14 million customers.

Using PRIME, the Pico Rivera City Council, at its last meeting, approved a new solar and battery program that will make solar energy and battery backup systems accessible to all Pico Rivera residents.

The system features zero upfront cost and no credit check, making it easier for all Pico Rivera households to install solar power and battery backup.

The council voted to approve the new entity, PRIME Power Choice Solar and Battery Program (PRIME-Power Choice) and authorized City Manager Steve Carmona to start negotiations for the proposed program.

"This innovative power solar and battery program reaffirms Pico Rivera's commitment to green initiatives, environmental stewardship, and the betterment of its community," said Carmona. "The program's launch is a significant step towards a more sustainable and inclusive energy future, bolstering Pico Rivera's position as a leader among environmentally progressive cities."

PRIME-Power Choice and Pico Rivera will be working with local solar power providers and installers through a partnership with CalChoice, Participate Energy, LLC (P.E.) and Tesla Energy Operations, Inc.

"Our partnership with our leading solar energy company partners has designed a unique power solution, breaking down the financial barriers that have previously prevented many households from accessing renewable energy resources. This pioneering program aims to ensure that every resident has the opportunity to take advantage of clean, renewable energy", Carmona continued.

The new power generating system, known as a distributed microgrid, will offer significant savings on utility bills using rooftop solar. At the same time, the battery backup systems will provide residents with a reliable energy reserve during power outages.

CalChoice will help the city navigate the regulatory hurdles inherent in establishing a distributed microgrid program. P.E. is responsible for funding, procuring, and managing the PRIME-Power Choice program, including ongoing operations.

Tesla manufactures solar and battery equipment and will be responsible for designing, building, and installing residential roof solar and battery; Tesla will be responsible for the system's operation and maintenance. The city, through PRIME, will put its creditworthiness behind the program, so credit scores are not

an issue, and most everyone can qualify. Additionally, PRIME will purchase the energy generated from solar and battery equipment and sell it to Power Choice participants at a competitive rate.

The customer contract between P.E., Tesla and PRIME offers no upfront costs, with a \$115 monthly lease for the Tesla solar and battery system and a contract term between 25-30 years.

Program participants are responsible for keeping solar panels clear from obstructions and clean. i.e., trees trimmed and washing dirt off the panels. However, P.E. and Tesla are responsible for monitoring and maintaining the systems at no cost to the customer. This includes no-cost replacement of batteries, which have an operating life of 10 years.

Under PRIME-Power Choice will also comply with California's 2020 mandate that all new single-family homes, condos and apartment buildings less than three stories high must be solar-powered. Along those lines, Pico Rivera will require new home builders to agree to purchase solar and battery equipment directly from Tesla, which will be installed by Tesla.

The program also addresses the current headaches with leased solar systems when homeowners move out. PRIME-Power Choice customers can either purchase the system before the sale of the home or transfer the contract to the new homebuyer. Unlike standard solar financing programs, PRIME-Power Choice does not require an underwriting process or securing the loan against the title of the property; the new owner can take over the contract and move in with a fully functional solar energy system with significantly lower electricity rates.

Once the program is operational, developers and homeowners can apply on the city's website at poweredbyprime.org. Upon completion, the information will be sent directly to Tesla, who will direct the developers and homeowners to the Tesla.com website; Tesla will be responsible for all installation-related work, including permitting.

In addition to having the ability to sell excess power, Pico Rivera will generate other including \$0.40 per watt for each installation of solar and battery systems, a \$0.02 kWh fee operating the service, and \$15 per month per battery installed.

Pico Rivera Mayor Erik Lutz told LCCN, "Our goal is to make sustainable energy inclusive and accessible to all our residents. Residents wanting to participate in this program can do so through a no-consumer credit check process and zero upfront cost. With this new program, we're not just providing affordable power solutions; we're also empowering our community to participate in sustainable living, helping to build a more sustainable future for all."

Cerritos Will Add Bronze Statue to Collection at Sculpture Garden

At last night's meeting, the Cerritos City Council approved the purchase of "Moulding Our Future" a highly regarded bronze statue that is currently in the private collection of the artist Denny Haskew, who is seeking to downsize his holdings, as well as expand the opportunity for the general public to view his artwork.

Moulding Our Future was sculpted by Haskew in Loveland, Colorado in 1989.

Moulding Our Future is cast in museum-quality silicon bronze; its approximate size is 86 x 48 x 44. It is a small limited edition art piece (1/9), and no other pieces can be cast from the mold as it was destroyed years ago.

Moulding Our Future is the last remaining sculpture for possible placement in the Cerritos Sculpture Garden.

The purchase of Moulding Our Future would mark the purchase of another significant and prominent art piece by Haskew for the enjoyment of the community and future generations of Cerritos residents.

This sculpture is the last remaining art piece in the limited edition of 9 and

is available for \$48,000 plus shipping and insurance costs of approximately \$2,000.

Moulding Our Future "features a simple moment between mother and child. A moment all may identify with, as a parent looking onward in strength and resolve, that all her efforts will go toward making their child's life as good as possible. As the child, excitedly taking in every new bit of the world uninhibited by the worries mom may have, protected within her embrace."

Moulding Our Future has been placed in the public art collection of the city of Loveland, Colorado and Grand Junction, Colorado, in several prominent private collections nationally and internationally.

The artwork has also won the following awards:

- Sculpture Award, Red Earth Invitational, Oklahoma City, Oklahoma, 1990.

- People's Choice Award, Hillside Sculpture Invitational, Sedona, Arizona, 1993.

- Award of Merit, Sculpture at the River Market, Little Rock, Arkansas, 2012.

The installation and site design for the statue will now be determined by City Staff, who will proceed to develop

YOUNG VALLEY CHRISTIAN SQUAD WITH NEW HEAD COACH TO BE TESTED WITH STRONG SCHEDULE

After getting to the CIF-Southern Section Division 12 title game last season despite winning three regular season games, Valley Christian High made yet another coaching change with its football program as Brendan Chambers becomes the third head coach in as many seasons and seventh since 2017. Last season, Chambers was an assistant at St. Margaret's High and before that, he the head coach at Saddleback Valley

Christian High for seven years.

"I'm very excited to be taking over the program with such rich tradition," said Chambers. "I love the opportunity to speak life into these young men and be able to do that in a Christian school setting. It's huge for me. What makes things different about Valley Christian is the tradition they have. They've been around for...this is their 89th year, so players' parents have played in this program who have played for [former head coach Mike Wunderley].

"Hearing just the tradition is something that gets me excited," he continued. "When I was at Saddleback Valley Christian, we never had that. It's a new school about 15-20 years old. So, to have former players be dads supporting their sons is huge. It brings a lot of values and traditions that makes Friday night lights special."

Chambers, who was hired in April, said when he was at C.V.C., he had a little insight about the Defenders and the school because former V.C. head coach Erick Streelman (2007-2012) was his receivers coach for a season and taught him a lot about V.C. Based on some of those talks, Chambers became aware of the longtime rivalry with Ontario Christian High. For added measure, Chambers is also connected with former V.C. boys basketball head coach Tom Lewis as the two were on the same coaching staff at C.V.C., and former



V.C. standout Trent Berkenkamp is on this season's coaching staff.

One advantage Chambers has for his first season with the Defenders is that V.C. graduated only half a dozen players from last season's team. Even with the departure of a few other players, Chambers still sees some good things on the horizon for the program. The varsity team will have 30-35 players with about the same number as the junior varsity team.

"It definitely is good to have a lot of returning players," said Chambers. "There are some kids who have left the program and did so before I took over. But I think the guys that we have are Valley guys and are buying into the culture of the program and the culture of the school. And I think the good news as a head coach is we only have 10 seniors in this class and only 11 juniors. So, we're just really, really young...and some of our best players are underclassmen and it's going to take them a little while to get going. But once they get going, I think that we're going to be all right."

OFFENSE

The Defenders scored 349 points last season, including four games of at least 40 points. They were shutout twice and held to 14 points three other times. On top of that, three games decided by three points or fewer, one of them was a 35-34 overtime win at Portola High in the quarterfinals. V.C. returns both of its quarterbacks from last season-senior Joe DeYoung (131 for 258, 2,219 yards, 17 touchdowns, 11 interceptions) and junior Keiran Edmundson (13 completions, 301 yards, five touchdowns, three interceptions) with the former taking over the starting gig a few games into the season. While both quarterbacks have been battling in the offseason as they did prior to last season, Chambers has tabbed DeYoung as the starter for this season.

"Joe played very well down the stretch [last season]," said Chambers. "Both of them have done a great job. Joe has a super strong arm, and I wasn't here last year, but just some of the stuff I've heard and watched on film...he looked like he was a little bit timid running the football. It doesn't look that way at all [this season]. He's looking to run the football a little bit. He's very accurate with his throws; doing a great job with his progressions and reads. And Keiran is doing a great job understanding the offense. It's a whole new system they have to learn, and Keiran has come a long way with his progressions as well and has been very accurate with the football, too."

One of the players not returning who was a major force in V.C.'s backfield last season is JoJo Apisala, who carried the ball 129 times for 849 yards and scored 13 touchdowns. DeYoung now becomes the leading returning ground gainer (17 carries, 55 yards, one touchdown), but replacing Apisala and the team's second leading rusher, Major Brown, will be senior Dylan Sawai and sophomores Tyson McNeese and Lucas Witt. Senior Isaiah Jordan may see some time running the ball but will be primarily used as a slot receiver. Last season, he caught 30 passes for 411 yards and scored three times.

In addition to Jordan, expect DeYoung to be throwing to senior Grant

Hefner, who was a tackle last season but is expected to be a tight end this season, junior Austin Abrahams, sophomores Oliver Boateng, Sean Bouma, Cole Hefner, another tight end, and Dylan Teays.

"We're just really young," said Chambers. "I think there's some talent there for sure, but a lot of inexperience at the varsity level. We'll kind of see how that goes."

The most experienced department on the offensive side, which is a plus considering the inexperience of the skill players, is the line and will be handled by junior left tackle Noah Klistoff, who was on the right side last season, senior left guard Tyler Hayes, senior center Jack Van Hofwegen, junior Logan Johnson or sophomore Isaac Morales at right tackle and junior right guard Noah Voecks. Johnson, Morales and Voecks were on the junior varsity team last season which went 9-1.

"I definitely love the offensive line; I love the depth of the offensive line," said Chambers. "We're about seven or eight deep and we're all over 200 pounds. At a small school like us, you always try to find guys like Grant that are bigger and say, 'hey, you have to go down and play offensive line'. And that's not the case this year. We have a bunch of guys who actually want to play offensive and defensive line. We're actually lighter at the skill position, which I think is a huge advantage because every high school wants an offensive line. We're all fighting for offensive [linemen] because it's hard to find them, and especially quality ones."

DEFENSE

As explosive as V.C.'s offense was, the defense couldn't hold its own in many games, allowing 383 points, including five games of at least 35 points. In fact, the Defenders were involved in eight games in which the decision was over 20 points, losing five of them. Grant Hefner will be playing at one end of the defensive line with Hayes, McNeese, Morales, and Van Hofwegen among those who are in the mix. Chambers says he and the coaching staff are still figuring out but just like the offensive line, there is depth on the defensive side.

The secondary will be led by Abrahams (57 tackles last season), Jordan (47 tackles), Teays at cornerback and junior Jayce Shields, another cornerback. Despite losing Apisala, who had 135 tackles last season, V.C. is still strong in the linebacking department with Sawai (40 tackles), Witt, Cole Hefner (82 tackles) and junior Jack Nichol.

SCHEDULE

The Defenders enjoyed their friendly confines eight times last season but in 2023, they will be home only four times in the regular season. The first four opponents are the same as last season, where V.C. began with a 1-4 mark. The game with Chino High was a 17-14 loss and in the other two setbacks against El Dorado High and Aliso Niguel High, the Defenders allowed 25 points each. Eight of V.C.'s opponents went to the playoffs with Ironwood League opponent Aquinas High advancing to the Division 5 semifinals. The 1-5 league record last season marked the third time since 1998 that V.C. had won one league game and the fifth place finish was the third time since 1998 that the program had lost at least four league games.

"It's going to be a tough one for sure," said Chambers of the season opener. "They're a very, very good team;

LA MIRADA HOPES TO PUT LAST SEASON IN THE PAST WITH NEW BEGINNINGS, SAME CHALLENGES

It was not the campaign La Mirada High or its followers expected as the Matadores were part of a new, tougher Gateway League, which was in its first season. The Matadores finished in fourth place, then were left out of the CIF-Southern Southern playoffs for the first time in over 40 years. To add insult to injury, former head coach Mike Moschetti left to take the same position at St. Paul High.

But it doesn't stop there as at least 30 players either graduated or transferred out and the team will have to play another season off campus as La Mirada's new stadium won't be completed for several months. With all that going on, former Orange High offensive coordinator of the past two seasons Lucas Mealy takes over knowing there is going to be a big challenge for the 2023 season. This will be his first head coaching job anywhere.

"Obviously, it's a dream come true in the sense of the program that I'm at," said Mealy. "I don't think very many people will get an opportunity to be part of such a very special program like La Mirada High School. The community that's involved in it, in my opinion, is second to none. You look at all these teams that come into place when they talk about high school football like Texas or down south, and it's one school, one city, one community, one town-type feel. I really do believe La Mirada is that same way."

Before that, Mealy was at Fountain Valley High and St. John Bosco High and had a brief stint at Cerritos College. He admitted that becoming a head coach was something he wasn't looking for right away. He loved being an offensive coordinator but over the past couple of years, he saw some things that made him believe he might be ready to become a head coach.

The history of La Mirada's program played a part in Mealy coming to the corner of Adelfa Dr. and Foster Rd. But he said the biggest thing was the school and the Norwalk-La Mirada Unified School District administration support and the community support. Mealy grew up in the city of Norwalk, which has two high schools, and where he coached the last two seasons, that city has three high schools.

"I think having one high school in one city is a huge, huge thing, at least

from my perspective with the support that you get from the community with the rallying of the community," said Mealy. "People care about this; everything about the school, whether it's football or another sport or an activity or the school itself. People care about it and to me, that was the biggest selling point."

Mealy, who was hired in April, which is somewhat late if a school is making a head coaching change, and especially for a successful program like La Mirada's, said when he got here, the numbers and morale were a little bit down. To him, the biggest thing was to try to get the kids excited and to promote the team to the school. By doing that, there are three or four players from the basketball team, about half a dozen from the baseball team and some from the track and field team. One bright spot for the program as it looks towards the next few seasons is that there are 16 seniors on a roster of 55 as of early August. Also, the only leftover from last season's coaching staff is Mike Ramirez, who was La Mirada's freshman head coach last season.

"I know the talent in La Mirada is great," said Mealy. "I know that if we can get to the point where we can



keep the kids from La Mirada in La Mirada, we're going to have a lot of success. But ultimately what I was trying to do is get kids to want to be a part of the program again, and I started that by going out and getting kids who were already on campus. We kind of used the motto 'it's a new era'. So, a lot of kids came out and I

think the kids are having fun and flying around."

He later went on to say that he loves a challenge and that a lot of programs use the word compete, but at La Mirada, it strives to win in everything it does.

"We want to win on the field; we want to win in the weightroom," he added. "Obviously, I think those two go hand in hand with football. But we teach our kids that we want to win every day. We want to win in the classroom, we want to win with our relationships, we want to win in the community... whatever we're doing, we want to have the mindset of winning and overcoming that obstacle."

OFFENSE

The Matadores scored 200 points last season, but 74 came in non-league games. And this season will certainly

look like a new team as a ton of last season's offense is no longer around. La Mirada is going to go with an air raid, spread style offense, which means up tempo and no huddle with three wide receivers, a tight end, one running back, and play as fast as they can, according to Mealy. Followers of the program may recognize the last name of the projected starting quarterback as sophomore Santino Garcia is the younger brother of Nehuel Garcia, who graduated this past May. Mealy says Santino Garcia has a very bright future and is a natural leader who has to get bigger in the weightroom. His backup will be senior Martin Aguilera, who is also a slot receiver. Mealy said nearly 100 percent of Garcia's or Aguilar's job will be done from the shotgun formation.

The top returning running back is sophomore Jordan Lauago, who touched the ball just five times last season, gaining three years. He also caught nine passes for 142 yards and Mealy calls him a 'very special football player for us'. Mealy also believes Lauago will be a really dynamic player for the Matadores who has a lot of explosion with great hands and has a natural ability for finding the hole with great acceleration. Other running backs expected to get some touches will be juniors Gavin Dionne and Max Rankin.

Those three players also figure to

really well-coached and they have some guys coming back. They're going to give us trouble and like I said, we're going to be put to the fire early. We're going to see how we respond. I think it will be a closer game than last year.

"It's definitely a tough test," he continued. "It's probably one of the tougher games we'll play in the five games we play before league. Once we get to league, obviously we have some really good opponents in there."

The coaching staff recently was talking about how the first five games are no joke with four of those opponents going to the playoffs in higher divisions and Gahr High tying two other teams for the Mid-Cities League title. Chambers joked about having a second bye week between the Aquinas and Big Bear High games so the Defenders can regroup and finish the season because the first three league games will be extremely tough. Last season, Chambers saw St. Margaret's get trounced by Ontario Christian 35-7.

"I expect to go out there and compete in league," said Chambers. "I think we're going to kind of lay the foundation for this program and the culture under coach Chambers. I know it's a tough league. Aquinas is a very good football team. Ontario is a great football team, right? My biggest thing is how we finish—second place, third place, and making a playoff run like we did last year. Those first five games are going to be time for us as coaches to evaluate what we have and get those guys an opportunity to go out there and be successful and see where the pieces to the puzzle lie as we get into league play."

HOMECOMING

The Defenders fell to longtime rival Ontario Christian 40-18 in last season's homecoming game, just the program's third homecoming loss since 1998. This season, V.C. faces Sierra Vista High, its first non-league opponent since 2013 for this festive game and someone it hasn't faced in at least 25 seasons. The Dons, who hail from Baldwin Park, have had five winning seasons since 2004. Sierra Vista lost to Lancaster 28-16 in the first round of the playoffs last season.

FINAL THOUGHTS

"I want them to enjoy their time in this program," said Chambers. "They've been through a lot of turmoil—third head coach in three. And we had some kids that didn't really want to play this year. My biggest thing when I first met with them was that this program is going to be built on love and love is the cornerstone and that I'm going to treat them as human beings and not just a roster number."

catch some passes from Garcia as will seniors Ernie Ortiz and 6'4" Christopher Cuevas, a tight end from the basketball team, junior Isaiah Robbins, sophomore Aaron Castro and Aguilar, when he's not playing quarterback.

Protecting those skill players on the line will be junior left tackle Ryan Molina, sophomore Genesis Afu or Noah Marquez at left guard, senior center Zachary Stein, senior Adrian Otero, who stands at 6'6", 305 or junior Mark Galindo at right guard and junior right tackle Elan Gomez with junior James Scott backing him up.

"What I like is these kids have done a great job of understanding what we're trying to do," said Mealy. "It was a complete change schematically. Not only did they buy in and accept it, but they also have proved to be able to do it on the field. I think that's a big thing. We're going to have some explosive plays this

year [and] we're also going to have some mistakes. That's part of running this type of offense; is when you run as many plays as possible, there are more opportunities for big plays and there's also more opportunities for mistakes."

DEFENSE

La Mirada allowed 247 points last season and had three games in which opponents put up over 30 points on the Matadores. The top four players leading the charge to be a starter on the defensive line will be seniors John Bynum and Pedro Gomez-Magallanes, junior Noah Duran and sophomore Donovan Davis. Also in the mix are senior Lorenzo Lutich and junior Charlie Dowlin.

Mealy says the secondary is one of the strengths of the team with seniors Gregory Leon and Frank Torres and Aguilera at safety. Mealy says Leon and Torres are the vocal leaders on defense and Torres can also be a linebacker. Other players who figure to be in the secondary are junior Chris Perez, sophomore Levi Reyes, Lauago and Rankin while the linebackers will be seniors Sean Gomez and Ary Montes, a transfer from Perris High where he had 103 tackles last season, Dionne and Torres at times.

"We attack; our defense plays with an attitude, and I firmly love it," said Mealy. "Don't get me wrong, but in practice, it makes it difficult because the offense is going against a real good defense day in and day out. But they fly around, they attack, and they play with an attitude. They swarm the ball and try to make as many plays on defense as possible. We don't just sit back and let things come to us. They go take the things they want, and I love that about our defense."

SCHEDULE

La Mirada will once again have one of the toughest schedules around, not just outside of the Gateway League, but overall. Seven opponents went to the playoffs last season and two of them are defending division champions—Yorba Linda High from Division 3 and Downey High from Division 4. Yorba Linda defeated the Matadores 28-13 in the second game last season and that was followed by Servite High's lone victory last season, a 10-7 decision with the game-winning touchdown coming in the fourth quarter. Those two opponents are repeats for La Mirada and after being home four times in 2022, the last three to end the season, four of the five home games this season will be played at Norwalk High with the other one at John Glenn High. Mealy added that the first two opponents are well-established programs who do what they do and do it well. There will be no rest for the weary for La Mirada before it gets to its bye, then hit another gauntlet that is the Gateway League.

"Cypress has a returning quarterback who is special," said Mealy. "They have a linebacker who is coming back who is really special and a couple other key pieces. We know Cypress is going to be a huge challenge, no doubt about it. They have some unique stuff offensively and I think our coaches will have a gameplan for them. But with that being said, we know that they are really well-coached."

Mealy coached against Yorba Linda the past two seasons and saw his team lose by a combined score of 86-50. He says that those players are a physical group of kids and when they get off the bus, they're ready to 'rock and roll'. He also said the bye comes at the right time as it will help the Matadores get an opportunity to rest and to prepare themselves for what will be a tougher Gateway League than last season.

Norwalk, the tri-champions of the Mid-Cities League, comes over to the Gateway League to replace Paramount High for at least this season and will be

a reunion as the two were longtime Suburban League rivals. Since at least 1998, La Mirada has lost twice to Norwalk with those defeats coming in 2008 (41-24) and 2013 (42-35).

"You look at Dominguez and they will always be a talented football team," said Mealy. "Norwalk runs some unique stuff, which takes a lot of time preparing for. They do similar to what Yorba Linda and Cypress do and they do it really well. And they're going to make you, from a defensive perspective, make you consistently beat them over and over again. As soon as you don't, they'll take that big play."

HOMECOMING

It's rare to find someone's last home game of the regular season the same as its homecoming game, but that's what will happen when the Matadores host longtime nemesis Mayfair High. Last season, La Mirada lost a heartbreaking 16-14 decision to the Monsoons when a last second field goal was missed. Mayfair has won six straight in the series and since 2004, own a 12-7 advantage. In fact, three of the last four losses to the Monsoons have been decided by a combined eight points. Last season, La Mirada defeated Paramount 40-20 for its homecoming game.

FINAL COMMENTS

"The fortunate thing is we have the juniors from last year who have become seniors and we have a great group of seniors," said Mealy. "They stuck around and gave me their trust that I will lead them to doing great things their senior year. I know a lot of kids over the years just haven't come here because of the stadium situation. Kids don't want to take the bus to John Glenn every day. I don't blame them. Kids don't want to be a part of what they think might be a rebuild, which we don't think it's going to be a rebuild. But from the outside looking in, there's no doubt about it. It looks like it's going to be a rebuild. We know what the expectations are for this program and we know what we have to do to accomplish them."

Without any breaks or intermissions, Swift's high energy performance was nothing short of exceptional. Aside from 2-minute costume changes that set apart each era, neither Swift nor her fans got a break from singing.

The Eras Tour is set to showcase each of Swift's 10 albums, which are individually marketed as an era as Swift morphs her sound and fashion each time creating a theme and story for each album. Every album, except for her debut album "Taylor Swift", earned a spot at the tour. However, her latest releases, "Lover", "Folklore", "Evermore" and "Midnights," which have never before been performed live on tour, earned more time in the spotlight compared to previously performed and toured albums "Fearless", "Speak Now" and "1989".

Unfortunately, the only way to hear a live performance of any of the songs from the debut album is for a song to be chosen as the secret song for the night. Each show receives two special songs that were unique to each concert. Each surprise song is chosen from different eras, performed once, and, according to Swift's own rules, is not performed again on tour. The only exception to that rule were the first three nights at L.A., due to recordings that were taking place.

On night 1 of L.A. Swift performed vault track "I Can See You" and "Midnights" track Maroon". The Aug. 5 show received debut track "Our Song" and "1989" track "You are In Love". Night

three at Sofi earned "Death by a Thousand Cuts" from "Lover" and "Your on Your Own Kid" from "Midnights". "Dress" from her sixth album "Reputation" and "exile" from "Evermore" were the surprise songs for night four in LA. Night five earned "1989" track "I know Places" and "Reputation" track "King of My Heart". The last night, however, won with the best pairing of surprise songs, "1989" song "New Romantics" and "Reputation" track "New Years Day", along with the announcement of "1989 (Taylor's Version)".

Lights were a major factor in this performance. Any form of light ranging from lighted wristbands to fireworks and even fire, Swift utilized lights to tell a story. Engulfing fans into each era, wristbands, which were placed at each seat, lit up the stadium to the color associated with the era.

The "Lover" era, which began the concert, the wristbands lit up into a lovely rose pink and as the era went on, the lights turned into hearts all across the stadium. Similarly, the stadium glowed an incandescent gold hue as the "Fearless" era took over. Upon exiting the "1989" era with "Bad Blood", Swift shocked the audience as flames burst from the stage perfectly in sync with the song.

Known by fans as the "Great War", surviving the presale and general sale on Ticketmaster was a heist of its own. Enduring website crashes, postponements and resellers, earning tickets to the Eras Tour was more difficult than anticipated. However, the debacle of Ticketmaster was only slightly acknowledged by Swift during the show.

"Some of you put an extensive amount of effort to be with us here this Friday night, is that correct," Swift asked the audience during the introduction of "Champagne Problems" at the Aug. 5 show.

Despite this hassle of getting tickets, which were still selling during the concerts on Stubhub and Vivid for over \$800 for nosebleed seats, fans were still cheering, singing and dancing along to every song.

Swift's concert is not just a concert, it is a theatrical performance. The show is wholly entertaining and not one moment goes by without a spark of ingenuity. Spanning from country, pop, synth-pop and folk genres, Swift was able to successfully and impressively captivate each fan, and blend the songs perfectly.

Swift puts on a performance well worth the money spent. A performance so incredible that at L.A.'s Aug. 5 show, Swift received an almost 5-minute ovation after fan-favorite song "Champagne Problems." During L.A.'s Aug. 8 show, Swift received a 10-minute ovation for her performance of the same song.

Swift has two more albums to record: "Reputation" and debut album "Taylor Swift". As her masters were sold off in 2019 to Scooter Braun, who then sold the masters off to Shamrock Capital in 2020, Swift no longer owns the rights to her music from "Taylor Swift" through "Reputation". The rerecordings are largely important to fans as it symbolizes Swift earning back her name, while also earning her own work that charts her experience with growing up, heartbreak, love and loss. Through the rerecordings, not only will Swift earn her own songs back, she earns back her own name.

International shows will begin on Aug. 24 as she heads to Mexico City, and will be traveling throughout 2024. Swift will return to the U.S. during Oct. and Nov. 2024 for the Eras Tour.

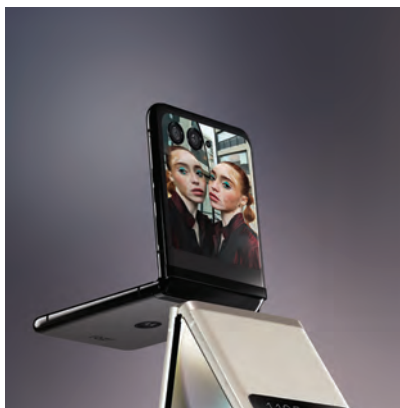
