Signed Under Penalty of Perjury

Cerritos Councilman Chuong Vo Has Not Asked Appointee to Resign After He Lied on School Board Application

Sean Wang, who was appointed to Cerritos' Let Freedom Ring Committee by Vo, wrote on the application that he lived in Hawaiian Gardens in July of this year.

This past July, Dr. Chris Apodaca resigned from his ABCUSD District 7 position, citing family reasons and setting off the process of the ABC Board appointing an area resident to the vacant seat.

One of the requirements dic-

tated that the applicant must live in Hawaiian Gardens.

Several people applied including eventual appointee Francisco Noyola, former Hawaiian Gardens Mayor Mike Gomez, Luis Rodriguez, and a candidate named Sean Wang.

Documents obtained by Los Cerritos Community News, signed under penalty of perjury, show Wang indicated that he lived at 22401 Ibex Ave. a very unkempt tiny two-bedroom, one-bath home in Hawaiian Gardens; Wang also checked a box saying he was a resident of Hawaiian Gardens.

Pico Rivera Council Approves Smart Waste Collection Pilot Program at Smith Park

The Pico Rivera City Council, at its Tuesday meeting, approved an innovative Smart Waste Collection Pilot Program at Smith Park to be funded by Senate Bill 1383 Fee Funds, monies the city has collected from residential and commercial waste accounts since July 2021 for the specific purpose of improving waste diversion rates.

The council voted 5-0 to award the contract to Bigbelly, Inc. for the purchase of fifty smart waste bins for nearly \$287,000.

Bigbelly trash bins are a type of smart, solar-powered waste management system that aims to improve the efficiency and sustainability of waste collection in urban and public spaces.

The bins are designed to solve the many problems associated with traditional trash collection, such as overflowing cans, inefficient routes for collection trucks, and high operational costs.

They are used in cities across

the U.S. and the world, from Portland, Oregon to Dubai, Saudi Arabia.

When a Bigbelly bin reaches a certain level of waste, the solar-powered compactor activates and compresses the trash, reducing its volume. The com-

California Bill to Allow Amsterdam-Style Pot Cafes Hits Newsom's Desk

The bill passed its final legislative hurdles passing with a 33 to 3 Senate vote a 66-9 Assembly vote.

Assemblymember Matt Haney's (D-San Francisco) bill AB 374 to allow local California governments to license Amsterdam-style cannabis cafes passed its final legislative hurdles passing out the California State Senate with a 33 to 3 vote and the Assembly with a final 66 to 9 vote. The bill has enjoyed broad bi-partisan support throughout the legislative process. While cannabis cafes in the Netherlands offer a social experience where coffee, food, and live music are enjoyed together with cannabis, these businesses are currently illegal under California law. Haney's AB 374 will allow struggling cannabis businesses to diversify away from the marijuanaonly "dispensary" model and will bring much-needed tourist dollars into empty downtowns.

"Lots of people want to enjoy legal cannabis in the company of others," said Haney. "And many people want to do that while sipping coffee, eating a scone, or listening to music. There's absolutely no good reason from an economic, health, or safety standpoint that the state should make that illegal. If an authorized cannabis retail store wants to also sell a cup of coffee and a sandwich, we should allow cities to make that possible and stop holding back these small businesses."

California is known world-wide as the birthplace of cannabis culture with its early adoption of medical cannabis and its expertise in cultivation, but Amsterdam competes with California for cannabis dollars and for the title of the world capital of cannabis. Over 700 cannabis cafes operate across the Netherlands, and over 1 billion dollars are spent in Dutch cannabis cafes every year.


California on the other hand, is still dealing with the unintended consequences of decades of a "medical marijuana-only" policy. California's "dispensaries" have replaced the social aspect of the Amsterdam cannabis scene with pharmacy-like businesses that only allow customers to order cannabis at a counter, purchase



After the three driest years on record, the storms of 2023 brought welcomed moisture to the region. The La Mirada City Council recognized Community Services Supervisor Paul Castillo, L.A. County Sheriff's Deputy Daniel Garcia, and community members Tech Enciso, Manny Peña, and Adam Quinones and presented them with Community Spotlight Awards for actions they took to help a La Mirada resident.

On August 3, resident and Community Gymnasium member Crisanto De Leon suffered a cardiac emergency and collapsed to the floor. Castillo, Enciso, Peña, and Quinones rushed to aid Mr. De Leon while others called 911 for emergency assistance.

After assessing his condition, it was determined CPR was required. Rescue breaths were delivered to him and Castillo and Enciso took turns performing

chest compressions.


Peña stepped in to relieve Enciso in performing chest compressions while Quinones quickly retrieved the AED machine that was later used to deliver an electrical shock to help re-establish an effective heart rhythm.

Shortly afterwards, Deputy Garcia arrived and alternated with Castillo in performing chest compressions.

After multiple rounds of CPR, Mr. De Leon was slowly resuscitated and ultimately stabilized by paramedics.

If not for the quick actions of Community Services Supervisor Paul, Deputy Garcia, Enciso, Peña, and Quinones, Mr. De Leon's condition would have worsened, putting his life in jeopardy. Their immediate response, acting without hesitation, and putting their life saving skills into action made the difference.

Since When Is It Wrong To Demand Facebook And Twitter Remove Falsehoods?

A decision last Friday by a three-judge panel of the U.S. Court of Appeals for the 5th Circuit puts in jeopardy one of the few tools that exist to deal with false speech on the internet.

The court ruled that the White House, the FBI, the surgeon general's office and the Centers for Disease Control and Prevention cannot communicate with social media platforms to encourage them to remove false speech. Although it narrowed a federal district's broader injunction issued in July, the appeals court left in place a restriction of important speech by the federal government.

False speech over the internet and social media can do great harm, even causing the loss of life. One aspect of the case involved the federal government's concerns with false information being spread about COVID-19 and vaccines on social media. Federal officials rightly feared that false claims by anti-vaxxers would reduce vaccinations and put lives in jeopardy.

The lawsuit against the Biden administration was brought by Louisiana and Missouri along with a website owner and four people who opposed the government's COVID-19 policy, among other issues. A federal district judge in Louisiana issued an injunction against the White House and many federal agencies.

The 5th Circuit ruling reversed the injunction against several agencies, including the departments of State, Homeland Security, Health and Human Services and the National Institute of Allergy and Infectious Diseases. But it left much of the injunction in place for four agencies.

The court in its decision relied on a 1963 decision that involved the government threatening obscenity prosecutions against booksellers. Government coercion violates the 1st Amendment. But there is no evidence that the Biden administration threatened any social media company with prosecution or any enforcement action.

The court said Biden administration officials "threatened — both expressly and implicitly — to retaliate against inaction. Officials threw out the prospect

of legal reforms and enforcement actions while subtly insinuating it would be in the platforms' best interests to comply." But telling someone that the failure to act could lead to new laws and regulations is not coercion. Never did the government warn the social media companies that they were violating the law and would face punishment if they did not accede to requests to remove content.

The court said the administration violated the 1st Amendment by encouraging the platforms to engage in content-moderation of false speech. It concluded that the officials "significantly encouraged the platforms to moderate content by exercising active, meaningful control over those decisions."

There is nothing, however, in the opinion that shows the government exercised "control" over the content on social media. Encouraging platforms to remove false content does not violate the 1st Amendment.

The panel declared that "social-media platforms' content-moderation decisions must be theirs and theirs alone." That is certainly right, but it is ironic to read this reasoning since the same court last year upheld the constitutionality of a Texas law that prohibits internet and social media platforms from engaging in content moderation. There is no way to reconcile that decision with the 5th Circuit panel now proclaiming that social media companies get total say over the content on their platforms.

A petition for review of last year's case is now pending before the Supreme Court. Likewise, the Supreme Court will be asked to review Friday's ruling on an expedited basis; the 5th Circuit panel said its decision would not go into effect for 10 days to permit Supreme Court consideration.

The Supreme Court should take both of these cases and make clear that internet and social media companies have the right to decide on the content on their platforms. The Texas law prohibiting content moderation is thus unconstitutional. But it should be constitutional for the government to encourage removal of false speech from social platforms, so

long as no coercion occurs.

The challenge is to find ways to combat the spread of false information that can harm public safety without jeopardizing freedom of expression. The government identifying false speech and notify-

ing social media companies is a sensible way to address this problem.

Whittier Union Teachers Visit Poland, Auschwitz

Three Whittier Union history teachers received an up-close look at living history when they participated in the Auschwitz Legacy Program, a one-week trip to Poland in July that included tours of the infamous Auschwitz-Birkenau concentration camp and the Warsaw Ghetto, as well as access to archives of letters and personal items saved from Holocaust victims during World War II.

John Bellanti of Whittier High School, Gena Arriola-Salas of Pioneer High School and MaryAnn Fajardo of Frontier High School joined a group of 30 educators and Holocaust researchers from across the United States as part of an education initiative created by the Auschwitz-Birkenau Memorial Foundation to keep the memories of victims

For Bellanti, Arriola-Salas and Fajardo – who all include WWII and the Holocaust in their lesson plans – the trip was extremely educational.

Each teacher discovered new information, such as the existence of the Ringelblum Archives, a collection of letters written by Jewish families in Warsaw that were hidden in milk cans and are now preserved at the Jewish Historical Institute in Warsaw. During the trip, the three teachers found themselves in areas and locales where Holocaust victims arrived, slept and washed up. At the Auschwitz Museum, seeing handprints on the walls and unused cannisters of Zyclon B provided images that the teachers said will stay with them forever.

The teachers toured the Warsaw Ghetto extensively, an area where more than 450,000 Polish Jews were held before many were taken to concentration

The encampment was leveled by Nazis during the Warsaw Ghetto Uprising in 1943.

The tour group viewed the remaining segment of the iron wall and remnants of the ghetto, which is now mostly apartment complexes.

The group also spent a day in Krakow touring centuries-old synagogues that were spared destruction by the

One possible outcome of the trip abroad is a joint effort by Whittier Union and the Foundation to arrange for a virtual tour of Auschwitz-Birkenau for Whittier Union's Advanced Placement European History or World Civilization students, which aims to give students a better perspective of the history contained within its walls.

The trip also afforded Bellanti, Arriola-Salas and Fajardo the opportunity to meet with representatives of Holocaust museums in Los Angeles, Colorado and Michigan, which could lead to a series of professional development seminars with history teachers throughout the District.

"It is an honor to have three of our educators selected to travel with the Auschwitz-Birkenau Memorial Foundation and participate in this indispensable yet heartbreaking journey," Superintendent Dr. Monica Oviedo said.

"The true beneficiaries will be Whittier Union students, who will gain tremendous knowledge and a unique perspective about the Holocaust. It is more important than ever that the lessons learned from World War II are passed on to a new generation, so that no one will ever forget what happened in the ghettos and concentration camps of Europe."

speed but it was a tough sell.

To help get the word out, the USPS enlisted the aid of an ad agency. These efforts included: Ethel Merman singing of the virtues of ZIP Codes to the tune of Zip-a-Dee-Doo-Dah; ZIP Code a catchy15-minute film starring the Swingin' Six musical group — it won a silver medal at the 1966 International Film and TV Festival; Mr. ZIP, the new code's mascot, which worked wonders in bringing it to public attention.

The full-court press paid off: By the end of the decade, the use of ZIP Codes had become established practice.

Today, the code has expanded to ZIP+4 and its uses have spread well beyond the USPS. Scientists, businesses, demographers and others use the codes to interpret and organize data.







LA County's Safe Surrender Program was launched by Supervisor Hahn's predecessor Supervisor Don Knabe in 2001. Parents or guardians may legally, safely, and anonymously, leave a baby three days old or younger with an employee at any Los Angeles County hospital or fire station, no questions asked. They will not face arrest or prosecution for child abandonment.



paction process can increase the bin's capacity several times compared to a regular trash bin.

The bins would be connected to the appropriate city department via wireless communication, which allows city waste collection personnel to monitor the bins in real-time using a web-based platform or a mobile app.

The monitoring will allow city employees to see which bins need emptying so they can prioritize routes, reducing the need for unnecessary collections and preventing overflows, making the waste collection process more cost-effective and environmentally friendly.

Bigbelly bins are made with triple, double, and single "stream systems." The triple bin system consists of waste, recyclables, and organics; the double bin includes waste and recyclables; and the single bin consists of solely recyclable bins.

The different bins will be strategically placed inside Smith Park. The triple bins will be placed near concession stands; the double bins will primarily replace single waste bins, and the single bins will replace the current bins found near the baseball field dugouts.

In its council report, Pico Rivera Staff found that implementing a smart waste collection program would drastically reduce the number of collections from fourteen to two per week, an 85% reduction in collections.

The collection reduction would save nearly 1,600 labor hours that would be reallocated toward other park maintenance activities, such as cleaning bathrooms, field maintenance, irrigation repair, and litter pick-up.

The labor savings are estimated to be \$160,000; with a reduction in other equipment and material costs, the city would save an additional \$23,000.

The Bigbelly bins will improve recycling rates from 17% to 60%. Additionally, it will reduce the annual plastic bag usage by nearly 30,000.

Finally, the program is expected to reduce annual waste to landfills by 69%, increase recycling rates by 112% and reduce vehicle mile traveled, known as VMT, by nearly 10,000 miles, removing 7.6 tons of harmful auto emissions from the environment.

Pico Rivera City Manager Steve Carmona told LCCN, "The City of Pico Rivera is taking a bold step towards sustainability with its smart waste collection pilot program at Smith Park. By implementing solar-powered trash compacting bins that not only comply with state recycling mandates but also offer a three-fold capacity increase, reduced collection frequency, and enhanced security against pests, we are making a resounding commitment to a greener future."

Carmona continued, "These innovations, coupled with solar panels for sustainable operation and fullness sensors for optimal waste collection, will not only reduce landfill waste but also drive operational efficiency, leading to significant cost savings. Pico Rivera is proud to be a dedicated steward in the region, showcasing our unwavering commitment to sustainable practices."

Daffodils With a Difference

here are so many reasons to love daffodils. These spring-blooming bulbs aren't fussy about where they are planted. They come back to bloom again year after year and are not bothered by deer, rabbits, or other garden pests. But there's also a whole world of beautiful daffodils beyond the classic yellow ones. Daffodils are available in unusual flower styles and unexpected colors that can bring a whole new look to spring gardens.

Get an early start on next year's daffodil season with Barrett Browning, a variety with pure white petals and brilliant red-orange trumpets. It is an excellent choice for naturalizing. Pink Charm also boasts white petals but has a large coralpink trumpet with ruffled edges. It is considered one of the best pink daffodils and is known for its vigor and reliability.

Add eye-catching color with the dependable heirloom Red Devon's brilliant yellow petals and flashy orange cups. For a more subtle approach choose the pastel hues of British Gamble. Its white petals are a perfect backdrop for the ruffled peachy-pink trumpet on these enormous, 5" blossoms.

Change the shape of things with some split trumpet daffodils. Cassata is a strong grower with a ruffled lemon-yellow cup that lies almost flat against broad

white petals. Cum Laude boasts big, bright, extra frilly flowers with peachy accents. Lemon Beauty's flowers feature pure white petals, and its split trumpet resembles a bright yellow star.

Double daffodils add elegance to gardens and spring floral arrangements. They also stretch the season by blooming several weeks later than most other types. La Torch's upward-facing fragrant double flowers are a mix of yellow petals and bright orange ruffles. Delnashaugh is a late-blooming double with layers of pure white petals interspersed with apricot-pink ruffles. Lingerie's extra-large blooms have thickly ruffled centers of white and golden yellow petals.

Some daffodils produce a bouquet of blossoms on each stem. Pueblo grows just twelve inches tall, and its primrose yellow flowers gradually fade to creamy white. Beautiful Eyes has two to three flowers per stem, with white petals, bright orange cups and a gardenia-like fragrance.

Take it down in size by planting a few miniature daffodils. Tuck them into rock gardens, under shrubs, along paths, in containers, and mix them with other spring flowering bulbs and perennials. Tete a Tete has perky, bright yellow blossoms and grows just 7" tall. Tete Boucle is similar in size, but its double flowers display layers of yellow, gold, and green

petals

Jet Fire is another outstanding miniature daffodil. It has bright orange trumpets and golden yellow swept-back petals and is a great small-scale naturalizer in the landscape. Minnow is an adorable little gem with pale-yellow petals and bright yellow trumpets. Sundisc's petite flowers have pale yellow petals and an almost flat, deep yellow trumpet. Miniature daffodils are a particularly good choice for perennials gardens, where they won't overwhelm neighboring plants.

NORWALK'S M&M BOYS KEEP JOHN GLENN GROUNDED IN ANOTHER MAYOR'S CUP ROUT

Last season, Norwalk High senior Caleb Mitchell was part of a rushing attack grouped in with 'the others' as he saw David Herrera and Michael Mueller each rush for well over 1,000 yards and combine for over 40 touchdowns. Mitchell carried the ball 16 times, gained just under 100 yards and scored once.

Last season, junior running back Ezra Mueller was in the same situation, rushing for about 25 yards more than Mitchell while scoring twice. Now, with his brother and Herrera having graduated, it's his time and Mitchell's time to shine. And in the biggest game of the season, at least to those in the City of Norwalk, Mitchell and Mueller did not disappoint.

Mitchell rushed 15 times for 252 vards and scored four touchdowns and Mueller added another 154 yards on 14 touches with a score as the Lancers will keep the coveted Mayor's Cup on their campus for another year following a 44-8 win at John Glenn High last Friday. Norwalk improved to 2-1 and has scored over 40 points in all three games.

"They've just been working very, very hard," said Norwalk head coach Ruben Guerrero of his new star running backs. "They've done an amazing job at learning, not just the offense, but the intricacies of it. Where they could be successful... that learning curve has shortened and they're taking off. They're doing a lot of cool, fun things right now."

"It's kind of a big deal," said Mitchell of playing for the Mayor's Cup. "I love this sport; I love football and knowing we have a game like this where we have rivalries and have fun and play the sport, I think it's a big part of being a senior and showing up for my teammates."

Norwalk, which now owns a 40-17 series advantage with the 1965 and 1982 results unknown, got the ball to begin the play and drove 80 yards on six plays, ending with a Mitchell 24-yard touchdown run. It would be the first of six drives for the Lancers in the game, all resulting in touchdowns. After the Eagles were stopped on downs on their first drive, Mueller scored from 33 yards out and with a Mitchell two-point conversion run, it was 15-0 not even nine minutes into the contest.

Glenn's first opportunity to make some noise came on its second drive as junior wide receiver Jacob Ramirez hauled in a 27-yard pass from sophomore quarterback Luis Vergara as he was falling backwards towards the sideline. The play came on third and nine from Glenn's 28vard line and was made possible after a potential fumble recovery from Norwalk senior lineman Jonathan Anguiano was reversed to an incomplete pass. But the Eagles ended that drive with a bad snap from center for a 15-yard loss, an incomplete pass, a false start penalty and a punt.

Norwalk's lone drive of the second quarter was the longest one of the game, lasting 15 plays and 8:16 as sophomore running back Diego Cerritos cashed in from a yard out. Add a two-point conversion run from senior running back Anthony Rodriguez, and the Lancers increased their lead to 23-0.

Adding insult to injury, Glenn was driving for a potential score before halftime as senior running back Tuiono Tuifua gained 28 yards on four straight plays, getting the ball to the Norwalk 42yard line. But the half ended with Mueller

sacking Vergara on consecutive plays for losses of 14 and eight yards respectively.



LA MIRADA, WITH TANDEM OF MERAZ AND OJEISEKHOBA, OUTLASTS GAHR IN LEAGUE OPENER

One of the perks for any athletic team winning a Mid-Cities League title is that you are nearly certain to move to the more competitive Gateway League the following season. The La Mirada High girls volleyball team went 10-0 last season in the Mid-Cities League, the program's first league championship since 2014 and as a result, got bumped up for this season.

In the Gateway League opener this past Tuesday, the Matadores did not lose a beat in their new circuit, posting a 25-19, 25-27, 20-25, 25-21, 15-9 victory over an improved Gahr High squad. While it wasn't the prettiest of victories, it was enough to improve La Mirada's mark to 11-5 overall, 1-0 in league.

"I knew it was going to be hard," said La Mirada head coach Kimberly Mahan. "Obviously, we're in a tougher league. I knew Gahr's defense is good; they pick up balls and they don't give up. They have a lot of heart and I think that's where we, at the beginning, started off strong and then we kind of went down because I think the girls thought, 'okay, we have this'. [Gahr] wanted it more than us."

Gahr was up 3-0 in the fifth set as senior setter Cassandra Zoellers served an ace, followed by kills from sophomore middle blocker Jessalyn Ecevedo and junior opposite hitter Kyla Jones. La Mirada responded with four straight points, including an ace from junior defensive specialist Angelyna Conde, her seventh of the match. There would be two more lead changes moments later, but the Matadores would take the lead for good at 8-7 on senior defensive specialist Emilie Galvan's first kill. The match ended with senior outside hitter Alyssa Meraz serving the final five points.

"Serve receive; we didn't trust our teammates," said Gahr head coach Charity Dennis. "We just gave up on serve receive and it made a difference. It was hesitations. There wasn't a lot of movement. In practice yesterday, we were moving well, then we felt a lot of pressure today for some reason. There was a failure to move, failure to get our angles, failure to stay disciplined and low on serve receive and it ended up making a difference."

"I think it was our serving," said Mahan. "We must have had a lot of serves at the end where they weren't really passing. It was hard for setter to get the second ball. They have a great libero, so their libero tipped a lot of our balls."

The theme of the match would be serve receive for both teams, allowing for the momentum swings which made it possible for it to go five sets. Through the first rotation of the opening set, there were eight ties and three lead changes. That would change to begin the second rotation as La Mirada junior middle blocker Natalie Ojeisekhoba was beginning her big day with a kill to tie the set at 11-11. That paved the way for Conde to serve five straight points, the first two coming off Meraz kills and a pair of aces from Conde.

The margin increased to seven points at 21-14 as the Gladiators were unable to put together more than two

straight points at any time in the set, which ended on an ace from senior outside hitter Natalie Peter, the seventh by the Matadores to that point.

"I know we had five missed serves in the first set, so that kills us," said Mahan. "Angelyna Conde has a strong serve, so I think we do well in that rotation, and she does a good job on defense. We still won, but like I said, our energy went down, and we weren't as excited as them."

La Mirada jumped out to a 7-1 lead in the second set and had a six-point advantage four other times before Gahr began to rally during the second rotation. After La Mirada junior outside hitter Geraldine Aiono's kill put her team up 20-17, a serving error gave Gahr possession, and junior defensive specialist Layla Garcia served five straight points.

The Matadores had two opportunities to go up two sets, but Gahr responded both times, got the serve back following a kill from senior outside hitter Leilani Choe, who then had an ace and received a Jones kill for the match equalizer.

It was all Gahr in the third set, which never trailed, building leads of 12-6, 17-9 and 20-11. But in the fourth set, there were seven ties and seven lead changes all within the first rotation. The last of those lead changes came by virtue of Aiono's fourth kill and made it 9-8. The lead grew to 16-11 after Conde's fifth ace and Ojeisekhoba ended La Mirada's scoring with three kills amongst its last four points. She would have 17 kills and two blocks while Meraz led everyone with 23 kills.

"Natalie is amazing," said Mahan.
"She usually goes up and pounds that ball. It was harder to run the middles and that's where we struggled, because I have two string middles and it starts with the pass. So, Alyssa does do a lot. She had shoulder surgery in March, so she's coming back from that."

"It was just a failure to make changes in that fourth set," said Dennis. "We started strong, and we were playing together as a team, and then they went on a run. Their energy went up; La Mirada's energy went up. They were playing tough, and we started to shut down."

Last week was the beginning of league play for the area girls volleyball teams and so far, there haven't been any surprises as far as what we can expect by the time the second week of October comes around.





with Mueller gaining 120 yards while the defense was holding the Eagles (2-2) to 25 yards.

"We challenged them this week," said Guerrero. "Since our first game, that got away from us, we've been challenging the defense and they've been answering. They answered last week, and they answered tonight. They're getting better week in and week out. Every practice they're getting better and it's starting to show, and we're starting to become a more complete team again. That's what's fun and awesome to see."

The third quarter wasn't much better for Glenn as it went three and out to begin the second half and following a Mitchell 74-yard score on Norwalk's third play of the ensuing drive, two more consecutive bad snaps ended Glenn's next drive. Mueller would recover a fumble on the second of those bad snaps and the turnover led to a 54-yard touchdown run from Mitchell.

Then, on the second play of the final stanza, Mitchell picked off Vergara, leading to his last score of the night, a 64-yard run as the running clock was put into play to begin the quarter. Mitchell also added three more tackles to his defensive performance, as did Mueller along with his two sacks and fumble recovery.

"Ezra had been really kind of shining and Caleb was like, 'when is it going to happen'," said Guerrero. "He's been very patient, and a spark happened, and he just took off tonight.

"We made some adjustments," he continued. "[Glenn was] pretty stout. I have to give my hats off to Glenn and the defense because they were pretty stout there for a second. We had to change a couple of things up and when we did, he was able to spring forward for big runs."

"I was just thinking that I'm next [and] I have to step up," said Mitchell. "Not only for myself, but for my teammates and I have to show up and show out."

Glenn wasn't going down without a fight as it got the ball at its 15-yard line and on four straight running plays, got to the Norwalk 30-yard line. The big play was a 45-yard run from Tuifua. Following a Norwalk penalty Vergara would avoid his team being shutout as he threw a touchdown pass to senior wide receiver Nathan Serrano.

"I did not mind [getting shutout]," said Penny. "I did not mind at all. I just saw the kids still competing hard; still playing hard against a tough program. It's a program that's been established and a program that's been good. I was excited just to watch them compete. But the touchdown did feel good because our young quarterback continues to step up and play hard. That's all I could ask for as a coach."

Norwalk senior quarterback Rylee Sosa nor junior signal caller Nicolas Berrera did not attempt a pass and besides the big nights from Mitchell and Mueller, junior fullback Papo Lieataua had 15 yards on four carries while Cerritos gained five yards on three touches. Cerritos also had three tackles.

For Glenn, Vergara was six of 10 for 86 yards while freshman quarterback Sameul Reeves completed his only two passes for 20 yards. Tuifua carried the ball a dozen times, gaining 80 yards while sophomore Terry Henderson added 17 yards on five carries. He also had four and a half tackles while freshman linebacker Andre Romo had three and a half tackles and senior Oracio Macias three

"Watching him on film, he was someone we really noticed," said Guerrero of Tuifua. "And yes, definite, definite improvement from that squad. They're doing a good job and getting the guys going and later on in the year, I see good things happening for them. But [Tuifua] is a good little runner and we did notice him on film this week."

"That's the beautiful thing about this whole game, this whole season and beyond this," said Penny. "The younger kids are getting experience and man, once these guys get into it with their bodies and add on a couple of pounds and muscle and we have our offseason program going...I'm these kid's biggest cheerleader. I'm just going to be so excited once I see the full development of our kids and just watch them grow."

In fact, with Penny now in charge of the Glenn program, and because he played for Norwalk, he is using the double wing as part of his offense, but obviously not as much as the Lancers.

"It was kind of surprising to see them at the beginning of the year run to that," said Guerrero. "But when they went to it, it's very familiar, obviously, because we run it and they run it. But we came to the realization that you know, that's what Coach Penny knows and that's what he went with. We felt comfortable because we had success against it defensively last year. We kind of used what we knew from then until now and it helped us out tonight."

Norwalk will go on the road to face Linfield Christian High on Friday, hoping to continue its solid offensive barrage that has produced 148 points and just over 1,000 yards, all but 72 coming on the ground. Linfield Christian lost to Tahquitz High 28-10 last Friday and has split its first four games. In their two wins, the Lions have scored 94 points but in the two setbacks, they have managed 27 points.

Quarterback Thomas Paschal has passed for 450 yards and five touchdowns but has thrown three interceptions. Micah Little leads the rushing attack with 313 yards on 27 carries with four touchdowns, and as a team, Linfield Christian is averaging almost eight and a half yards per carry.

"We had a common opponent last year in Rio Hondo Prep and we saw that was a tight game," said Guerrero. "So, we know it's going to be a tight game [on Friday]; pretty evenly matched, and we're going to have to go and reassess where we're at. We'll go see them on film tomorrow and we'll try to draw up a plan that will help us be successful next week. But by no means are we looking past them. This game tonight is number three on a list of 10, and that's what the kids and I came in with this week. We're past number three and now we're looking at number four on that list of 10. We're going to go through those 10 and see where we're at, at the end of the year."

For Glenn, it will travel to Mark Keppel High on Friday, hoping to keep the Aztecs winless as they play their fifth game of the season. Mark Keppel was blanked by Azusa High 39-0 last Friday and has scored just 22 points in four games while yielding 164 points.

Prior to last Friday's game, the Aztecs were averaging just over 100 yards a game on offense and have turned the ball over at least nine times.

"We'll definitely look at it as a game to get our guys back on track, get back rolling and then get back into things that we do," said Penny. "Mark Keppel has kind of been struggling a bit lately, but our guys...we can't go in there with that kind of mindset like we're going to beat them. I tell my guys every week, we're 0-0. It's fresh; it's a restart."

Yet a check of Cerritos' city website shows Wang is on the city's Let Freedom Ring Committee, appointed by Cerritos Councilman Chuong Vo; Wang also proudly proclaims he lives in Cerritos and is on the LFR Committee.

To be on any committee in Cerritos, a person must be a Cerritos resident, yet Wang lied on his ABCUSD application twice under penalty of perjury, indicating he was from Hawaiian Gardens.

Seven weeks after it was revealed Wang lied on his ABCUSD application, an August 29 public records request to the Cerritos City Clerk has revealed that Wang has not resigned, indicating that Councilman Vo, a Torrance Police officer, has not asked Wang to resign even though Wang committed perjury by lying on his AB-CUSD application.

In addition, an examination of the attendance by Wang and other LFR Commissioners shows a pattern of chronic absenteeism except for two committee members, Monica Ballentine and Candy Yee.

Two members have missed the last five meetings; Wang, appointed in May of this year, missed the previous meeting in Au-

Emails to Cerritos City Councilman Chong Vo asking if he knew of Wang's application went unreturned; Vo would not answer if he would ask Wang to resign from the LFR Committee.

Members can also become part of the Youth Council Cabinet, which is composed of the chair, vice chair, secretary, communications officer and special events coordinator — providing additional leadership opportunities.

Members can also attend and participate in Metro events, activities and connect with others from across the county.

nothing else, and then leave.

"California's small cannabis businesses are struggling," said Haney. "Issues like over-saturation, high taxes, and the thriving black market are hurting cannabis businesses who follow the rules and pay taxes." In 2020, California's legal cannabis sales reached \$4 billion, while the state's illicit market sales were projected to have exceeded \$8 billion.

While consuming cannabis on-site at cannabis retailers is technically legal in California, selling non-cannabis-infused products is not. AB 374 is simple because it allows cannabis retailers to diversify their business by selling non-cannabis-infused foods and selling tickets to live per-

"To be clear, we're not saying that coffee shops should be allowed to sell cannabis," said Assemblymember Matt Haney. "We're saying that cannabis shops should be allowed to sell coffee. It shouldn't be illegal for an existing cannabis business to move away from only selling marijuana and instead have the opportunity to grow, and create jobs by offering coffee or live

Cannabis cafes will only be allowed to open in cities and counties that pass legislation to allow them. If the Governor signs AB 374, the bill will come into effect on January first of 2024. Local governments will then have the opportunity to create a permitting process and regulations for local cannabis cafes. West Hollywood has already passed legislation creating a licensing system, and a similar bill is currently working its way through the San Francisco legislative process.
