

Bill Bans Hedge Fund Home Buying

The funds drive up competition and prices by paying cash, leaving would-be home buyers with few options.

A bill introduced in 2023 by Senator Jeff Merkley (D-Ore.) and Representative Adam Smith (D-Wa.) - the proposed End Hedge Fund Control of American Homes Act - would stop institutional investors from buying single-family properties and force them to empty their residential real estate portfolios over a 10-year stretch.

Pico Rivera Approves Pilot Test for ShotSpotter Gunshot Detection System

The sensors are placed on rooftops, utility poles, streetlights, or other elevated structures.

The Pico Rivera City Council has approved a one-year pilot program to implement the ShotSpotter system to detect and locate gunfire in areas of the city. vated structures.

When a potential gunshot is detected, multiple sensors near the sound record the audio. The recorded data is sent to ShotSpotter's centralized servers, where it undergoes analysis by both algorithms and "trained acoustic experts" to confirm whether the sound was a gunshot.

Characteristics like sound waves, acoustic patterns, time delays between

ShotSpotter is operated by SoundThinking, Inc. and is officially called a Gunshot Detection, Location, and Forensics System.

The system is used by several cities in the U.S., including Chicago, New York, San Francisco, Washington, D.C., Detroit, Miami, Oakland, Milwaukee, Sacramento, Boston, and Atlanta.

ShotSpotter works by using sensors placed strategically across an area. The sensors continuously listen for impulsive sounds, similar to gunshots, using sophisticated acoustic technology to distinguish between gunfire and other loud noises.


The sensors are placed on rooftops, utility poles, streetlights, or other elesensors, and other data points are analyzed to verify the gunfire.

By analyzing the differences in the arrival times of the sound at various sensors, ShotSpotter can triangulate the location of the gunshot event "very accurately," usually within a few meters.

If an actual gunshot incident does occur, ShotSpotter can detect if there are multiple firearms involved, if any of the firearms are high-capacity type firearms, or if the firearm is a fully automatic weapon. Once the sounds of gunfire are confirmed, L.A. County Sheriff's Deputies are notified via a digital application to their smartphone or similar device. The alerts provide

Imaginarium Now Until Jan. 7 at Pomona Fairplex

Despite the intense forecast, the Imaginarium in Pomona garnered many visitors during last week's storm.

The Pomona Fairplex is home to the seasonal Imaginarium light display until Jan. 7, 2024.

With various walk-in and interactive displays, the Imaginarium is a captivating display of lights where attendees can enjoy the light display at their own pace.

According to their website, the Imaginarium boasts over five million lights with a path of 1.5 miles solely dedicated to the display of lights complete with fake snow and ambient sounds.

The display has characters and props that interact with passersby as the characters talk, move, or make noise. The displays are separated in sections with specific themes. Only a few lights

were dedicated to the holidays, but the Imaginarium successfully combined themes of fantasy and whimsy with characters from fairy tales like mermaids, dragons, and fairies.

To enjoy the light show in full, allow for at least an hour and a half to walk the 1.5 miles, take pictures, and enjoy each interactive room. There are dedicated areas perfect for photoshoots, such as interactive rooms that create illusions with lights and mirrors that make the space seem infinite. Many areas are awe-inspiring and require a little extra time to soak in, such as the mermaid display over the lake and the "Alice in Wonderland" display.

Food stands were available and offered foods like smores, hot dogs, funnel cakes, tacos, and ice cream. However, there were limited areas of seating, so snacks would need to be taken on the go. Throughout the path of lights, there are some folding chairs

available to overlook the view. However, seating is minimal and inconsistent.

The experience of the Imaginarium is fun and captivating -- a perfect activity for those enjoying Winter break. The display offered the perfect opportunity for Instagram-worthy photos, and offered captivating illusion rooms.

Each ticket includes entrance to the lights, interactive activities, and a circus that performs three times a day. Unfortunately, due to inclement weather last week, the circus, highwire walkers and car display were unavailable.


To get the best experience, keeping tabs on the weather is helpful since the lights are all set up outdoors. According to the website, the Imaginarium will post an online banner if the weather does not allow for a safe experience, and the display will not be open. If the display is closed for the day because of the weather, the Imaginarium offers the opportunity to reschedule but does not offer ticket refunds.


The Imaginarium does provide a phone number to call for customer service, which leads to a robotic voice that gives general information; however, calling the Fairplex is the best way to get in touch with a person to answer more specific questions.

Tickets are sold online at imaginarium360.com, and can be purchased in advance or on the day. Tickets are \$29 for adults, \$25 for seniors and children, and \$27 for military, all tickets with an additional \$3 charge for a service fee. Parking at the Fairplex is an extra \$17 per vehicle, but it does provide close parking to the event's entrance. The display of lights is open daily from 5 P.M. until 10 P.M.

Renew Cerritos Annual Parking Permit Online

Cerritos residents can renew their annual parking permit for 2024 or request an overnight parking permit 24-hoursa-day, seven-days-a-week, online at safercerritos.com.

City parking permits are free of charge and must be clearly displayed on the driver's side dashboard of the vehicle (left corner) from 3 a.m. until 5 a.m. A vehicle displaying a valid California DMV Disabled Person Placard does not require an overnight parking permit. A parking permit does not exempt a vehicle from the City's street sweeping ordinance (10.12.065 CMC).

The parking permit criteria allow two-car garage households with five vehicles and four licensed drivers to qualify for a second annual parking permit. Three-car garage households with seven vehicles and six licensed drivers qualify for a second parking permit.

The End Hedge Fund Control of American Homes Act is a bicameral bill aiming to increase the amount of for-sale supply in the housing market.

Hedge funds and other institutional investors stand as a major detriment for home buyers, as they use their huge capital reserves to scoop up available properties. This reduces the already-slim inventory in the marketplace, creating a more acute affordability crunch. Additionally, their abilities to outbid normal borrowers and offer all cash make house hunting more difficult.

Additionally, because these corporate entities have a goal of generating high profits for their investors, they inflate the housing prices — increasing the cost of living for their occupants and potentially for local properties through comp assessments and appraisals.

Large scale hedge fund investors are accelerating their harmful takeovers in recent years. Data from 2021 show the fastest year over year increase in hedge fund home purchases in 16 years. For example, in 2021, large hedge fund investors bought 42.8% of homes for sale

in the Atlanta metro area and 38.8% of homes in the Phoenix area.

As currently written, the bill has a two-pronged approach: First, it would ban hedge funds from buying single-family homes going forward. Second, those hedge funds would have to sell at least 10% of the homes in their portfolios every year over a 10-year period. At the end of those 10 years, the portfolios must be empty.

Institutional investors — such as hedge funds, private equity firms, and endowments — owned an estimated 574,000 properties as of June 2022, according to the Urban Institute. For reference, Realtor.com data revealed a total of 754,846 active property listings in November 2023. Injecting over half a million single-family homes back into circulation would be a major boon for house hunters.

"You have created a situation where ordinary Americans aren't bidding against other families, they're bidding against the billionaires of America for these houses," said Senator Jeff Merkley of Oregon, who introduced the bill with Representative Adam Smith of Washington. "And it's driving up rents and it's driving up the home prices."

In separate legislation, Representatives Jeff Jackson and Alma Adams of North Carolina, both Democrats, introduced the American Neighborhoods Protection Act on Wednesday. That bill would require corporate owners of more than 75 single-family homes to pay an annual fee of \$10,000 per home into a housing trust fund to be used as down payment assistance for families.

With a divided Congress, the bills are unlikely to pass into law this session. But Mr. Smith said legislators needed to start a conversation.

Join Cerritos Neighborhood Watch

Residents are encouraged to join the Neighborhood Watch in Cerritos, a joint effort by community members and the Cerritos Sheriff's Station/Community Safety Center to fight crime and protect property. One of the oldest crime-prevention programs, it serves as the eyes and ears of the Sheriff's Department and has proven instrumental in keeping communities safe.

Contact Community Safety at (562) 916-1266 to see if a Neighborhood Watch group has been formed in your neighborhood. If there is an established group, you will be provided with the name and phone number of the Watch Captain.

If there is no active group yet in your area, the Community Safety Division will help you and your neighbors start one. Ideal Neighborhood Watch groups are typically small – usually 15 to 20 households – to simplify communication among participants. A designated block captain will be responsible for acting as the liaison between a neighborhood and the Cerritos Sheriff's Station/Community Safety Center.

While the Community Safety Division and Sheriff's Department will assist in many ways, the success of Neighborhood Watch depends largely on citizen involvement. Participants will receive Neighborhood Watch signs to post, alerting potential criminals that others are watching out for your home. Members of the watch group monitor their neighborhoods, communicate regularly with deputies and meet with neighbors routinely to stay current on new information. If a residential crime pattern is identified in the area, deputies will notify the group of what to look out for and suggest prevention strategies.

U.S. Postal Service Reveals Additional Stamps for 2024

WASHINGTON, DC —This week, the U.S. Postal Service announced four new stamp subjects for 2024. This group, along with the stamps announced in October, make up only a partial list, with more to be revealed in the weeks and months ahead. All stamp designs are preliminary and subject to change.

DUNGEONS AND DRAGONS

This stamp release marks the 50th anniversary of Dungeons & Dragons, described by its owners as the World's Greatest Role-playing Game, that has become a cultural phenomenon. By inviting participants to imagine themselves as wizards, warriors and other adventurers in exciting and treacherous fantasy worlds, Dungeons & Dragons opened doors to whole new universes of creativity for generations of players. The pane of 20 stamps features 10


different designs that highlight characters, creatures and encounters familiar to players of the game. Greg Breeding, an art director for USPS, designed the stamps and pane with existing illustrations.

JOHN WOODEN

Legendary coach John Wooden (1910-2010) led the University of California, Los Angeles (UCLA) Bruins to a record-setting 10 Division I men's basketball national championships. Often considered the greatest coach in the history of American sports, Wooden coached the Bruins to 88 consecutive wins and four perfect (30-0) seasons. The stamp features a portrait of Wooden. In the "UCLA blue" background, a player defends a shot. The numbers on the two players' jerseys, 4 and 10, evoke the Bruins' four perfect seasons and the 10 national championships during

Carnival Nights celebrates one of America's favorite pastimes. The stomach-twisting thrill rides, the indulgent snacks and sweets and the general spirit of lighthearted fun make the nation's carnivals and fairs a place for visitors of any age to enjoy. Ten new stamps in a pane of 20 feature photographs that convey the energy and color of a summer carnival at night. Greg Breeding, an art director for USPS, designed the stamps with existing photographs.

ANSEL ADAMS

One of the most renowned and influential artists of the 20th century, Ansel Adams (1902-1984) made thousands of

awe-inspiring photographs that collectively create a rich visual portrait of the American landscape. A masterful photographer and dedicated environmentalist, Adams sought to imbue each of his black-and-white prints with the power and wonder he felt in the presence of nature. These 16 stamps feature some of Adams's most famous images in his signature "straight photography" style, an approach defined by its precision and directness. Derry Noyes, an art director for USPS, designed the stamps.

BOYS BASKETBALL: JOHN GLENN REBOUNDS FROM WORST LOSS OF SEASON WITH SIXTH DOUBLE-DIGIT VICTORY

Nothing has come easy for the John Glenn High boys basketball program over the course of the past 25 seasons. Even when things are going good for the Eagles, there's always something that takes away from the positives, whether players defecting during a season, or coaches being quietly forced out because parents don't agree with the coaching styles.

This season sees Chris Palisin as the program's third head coach since the 2020-2021 campaign and 11th since the 1998-1999 season. And Palisin has Glenn going in the right direction with a relatively new team as the Eagles knocked off Alliance Health Services Academy 38-24 last Friday, snapping a two-game losing streak and coming after a 65-15 shellacking to the hands of Norwalk High.

"It was a tough game because Santa Claus is coming and a lot of kids are sick and there's not a big crowd and we're coming off a rivalry game which didn't go our way," said Palisin. "So, we wanted to get a good start, and energy was important to us. We were trapping out of our zone early and that was what we were looking for as far as a spark to get the game going and play the pace that we wanted to."

Glenn improved to 9-5 and while the Eagles have scored 50 points only twice, they have allowed 40 points or fewer nine times. After spotting the Wolves a

2-0 lead just over two and a half minutes into the game, Glenn scored the next 13 points of the stanza, then got a three-pointer from freshman Samuel Reeves eight seconds into the second quarter to go up 16-2. Glenn's lead would not dip below 10 points as it was playing more of a defensive game, forcing AHSA to turn the ball over 14 times in the first half, getting nine steals with three each coming from Reeves and sophomore Bundana Adams.

"Very important because we were very limited today with only seven players," said Palisin. "We were missing two starters, so it was very important, delay the clock a little bit and then run our stuff."

The Eagles held a 24-10 halftime lead and only took 19 shots from the field with four of the seven players who suited up scoring at least three points. Both teams would score in the third and fourth quarters respectively as Glenn would lead by as much as 16 points twice. In fact, the Wolves would score consecutive points just once in the game.

Adams led everyone with 17 points and had 7 rebounds, six steals and three assists. He has quietly become the team's leading scorer through the first 14 games and has scored at least 20 points three times. His performance comes three days after a season-low two points against Norwalk.

"He's a sophomore and he's our captain and usually you don't make sophomores captains," said Palisin. "But in our situation here with a rebuild, he's earned

it. He's quick, talented, and still has a lot of growth, as we all do. But he sparked us with some defensive plays and his leadership on offense."

Also having a great game coming off the bench was Reeves, who had 10 points, five rebounds, four steals and an assist. He tied his career-high in points, which came in the second game of the season against Vista Meridian High on Nov. 15.

"The best thing about freshmen is they become sophomores," said Palisin. "But I'll tell you what, he didn't play like a freshman tonight. He's been working on his three's and those were big three's, and he was very coachable, being a leader with the team and connecting with me."

Senior Justin Rodriguez, the only returning player left on the team, had eight points, six rebounds and five steals while sophomore Jesse Caldwell led the team with eight rebounds. The Eagles pounded the glass for 33 rebounds with everyone getting at least two rebounds.

Glenn is in Division 5AA this season and while its schedule may not look that impressive with the teams it has been playing, you need wins no matter who it's against. Glenn has six wins of 10 points or more, one by seven points, one by five points and one by three points, and of the five losses, the first two were by a combined four points. Since the 1999-2000 season when Glenn finished 9-14, the program has had four other teams win at least nine games. The Eagles went 10-17 in the

2006-2007 season, 14-13 two seasons ago, 11-17 last season and this season's team.

"We're beating Division 5 teams," said Palisin. "I don't see any problem with that. We're a small school, we're rebuilding, we don't have a freshman or junior varsity team. So, we scheduled a lot of non-league Division 5's so our kids can earn confidence. We always want to win, but we see nothing wrong with Division 5 schools that we've been playing. It's been ultra good for us; very competitive games."

The Eagles have one more game this month, a Dec. 28 home game with New Designs University Park, then it's off to 605 League action where they will entertain league favorite Artesia High on Jan. 3. If Glenn doesn't finish in the top three in league, which would be good enough for an automatic playoff berth, it would need to win at least five more games to be considered for an at-large berth.

"Besides working on our fundamentals, which we always stress here with me, is our communication on the court and our connection with me on the court," said Palisin on what his team need to do to be successful. "It's good, it's bad, it's up and down, and you're going to get that with a young team. But going into league, which has extremely talented teams, crowds and great coaches, our communication and chemistry and our connection with me... we better be on a sprint to get better, or it's going to be challenged very much so in league."

a passing team but lately, the Gladiators have been successful on the ground and this past season, Kalen Montgomery led the area with 1,339 rushing yards and scored 25 times. He scored at least one touchdown in each of Gahr's 11 games, including all three in the season opener at Valley Christian in a 21-20 victory. Last season, Montgomery compiled 564 yards and scored half a dozen touchdowns.

Co-Defensive Players of the Year-Cerritos allowed close to 300 points in the school record 15 games it played, but many times, a plethora of defensive players helped the Dons stay in a lot of games. Two of them are senior linebacker Jeremiah Bagaygay and junior linebacker Nathaniel Crawford. The former had 98 tackles and led the team with 12 tackles for losses and seven sacks. Crawford led the area with 129 tackles and had a pair of sacks. He was one of three players on the team with over 100 tackles.

Coach of the Year-A Hollywood script was written when Cerritos first-year head coach Demel Franklin did the improbable and guided the Dons to their first trip to the CIF-SS semifinals, their first divisional championship and had them come two points away from playing for a state title. The Dons went 9-6, but won seven of the last eight games, including a come from behind 19-13 overtime win against Yucca Valley in the Division 12 championship game. Before this past season, the last time Cerritos won nine games was in 2001 when that team went 9-2 but lost in the first round of the playoffs.

Player of the Year-Norwalk had a banner season; if the Lancers can get the same production from junior middle blocker Samantha Munoz, then the team should do the same. Munoz led team with 189 kills and 55 blocks and was the team leader in kill percentage (45.5) and second in hitting percentage (.308).

Coach of the Year-Norwalk girls volleyball hasn't had much of a history, especially with 11 head coaches since 1998 and a dozen trips to the postseason in that time. but in her third season at the helm, former Norwalk star Paola Nava guided the Lancers to their best season in school history. Norwalk went 24-12, tied Mayfair High for the Mid-Cities League title and advanced to the Division 7 quarterfinals, the first time in school history the Lancers have gotten that far. The 24 victories are the most in the history of the program since the 2013 and 2015 teams won 16 matches.

Shooting Keeps Winning Streak Going, Easily Defeats Serrano



There was thunder and lightning along with rain outside the Valley Christian High gymnasium last Thursday, but inside, it was the boys basketball team which provided the electricity as the Defenders hosted Serrano High. They began the game on an 8-0 run, then added a pair of 11-0 scoring streaks plus a 5-0 run late in the first half as V.C. blasted the Diamondbacks 68-40.

The contest wasn't as close as the final score indicated as V.C. was up by 39 points with 37.4 seconds left in the third quarter before Serrano scored eight straight points to keep the game from going into a running clock situation.

"We have a lot of weapons; it's just about executing," said V.C. first-year head coach Dijon Thompson. "That's what I'm trying to get the players to do, is execute. We're coming off back to back [games]. We have a lot of back to back games in January. So, we're trying to train our bodies and trying to train our minds for January when that happens so we don't have those mental lapses."

Those weapons begin with seniors Jacob Bayla and Gavin Stahl, who each scored six points in the opening quarter as the Defenders led 19-5 after the first eight minutes. Bayla had four rebounds and a block while Stahl drained a pair of three-pointers. In the second quarter, Bayla added a three-pointer, two rebounds, two assists, a steal and a block to his total while Stahl had three boards and another trifecta as part of the 16 points the team would score.



While those two combined for 20 first half points, sophomore Josiah James was heating up with seven of his nine points in the stanza. And another weapon was senior Bryce Shepherd, who had 11 points on five of shooting from the field in the third quarter. Stahl ended with a game-high 18 points with five three-pointers and half a dozen rebounds while Shepherd added 16 points and was seven of 13 from the field.

"They're very important weapons," said Thompson. "Bryce is our defensive specialist, but his points definitely help us. Gavin is definitely our shooting specialist, so any threes we can get from him definitely are positive. But just him being out there stretches the floor. And Jacob is our floor leader; he does everything for us."

Bayla ended with 13 points, 10 rebounds and three assists while James (nine points, six rebounds) and senior Myles Harvey (six rebounds) also had solid performances. The Defenders won their fourth straight game and four of their seven wins have been by at least 15 points with two others by four points or less. On the other side of the ledger, they have lost three games by a point, four points and three points.

"It's a confidence booster," said Thompson. "We definitely need those, especially to enjoy the holidays. We've

had a lot of close games for us. We kind of need to see these types of games. So again, we just need to start working on discipline and stuff like that. But we needed it."

Thompson, who is the program's fourth straight head coach in as many seasons and sixth in the past seventh, says he has been impressed with the effort through the first dozen games. "These guys have been coming to practice willing to work," he said. "They're being coachable and all my seniors are trying to leave with a legacy."

In other boys basketball action, Artesia High lost two of three games in the Osceola Holiday Winter Classic in Orlando to wrap up 2023 with an 8-5 record. The Pioneers will begin 605 League action on Wednesday at John Glenn High.

Cerritos High played Mira Mesa High this past Wednesday in the first round of the 37th Holiday Hoops Classic inside Sundevil Arena at Mt. Carmel High and got past the Marauders 56-52. There were 11 lead changes throughout the game, the last coming when senior Tobenna Ozoagu converted a three-point play with 2:09 left in the game. That put the Dons (6-8) up 47-45.

Cerritos held the lead from the 6:26 mark of the first quarter until the 5:05 mark of the second quarter, leading by as many as five points with the largest deficit being three points. Ozoagu led

everyone with 19 points and added seven rebounds and four assists while senior Osinachi Agaranna added 17 points, 12 rebounds and two blocks. Junior Benson Cho was also solid with eight rebounds, seven points and two assists as the Dons faced Mission Hills High on Dec. 28. access to Google Earth maps with turnby-turn directions that geocode the closest address to help officers reach the correct location. The entire process occurs within 60 seconds or less.

To obtain the best area to test the system, Pico Rivera gave ShotSpotter over two years of gun-related crime data in the city for analysis. The data was used to determine the optimal location of gunshot detection sensors covering the areas most impacted by gun-related crimes.

ShotSpotter will coordinate with Pico Rivera and the Sheriffs to determine the final best test area.

The Pico Rivera City Council approved the pilot test on a 5-0 vote.
