EXCLUSIVE: Central Basin Director Vasquez Trying to Gerrymander Districts

When told the move was illegal, Director Juan Garza said, "We make the law, we can bring the item back even if it's illegal."

Central Basin (CB) Director Leticia Vasquez-Wilson, who is facing a tough re-election campaign against her board ally Martha Camacho-Rodriguez, with dedicated support from her lap-dog-Directors Juan Garza, is attempting to illegally redraw Central Basin voting districts to retain her seat in the November 2024 election.

The scheme began a few weeks ago when Vasquez-Wilson, with the support of Garza, demanded that an item related to "redrawing district boundaries" be placed on the agenda in September of this year.

CB attorneys were forced to contact an outside law firm to prepare a memorandum concerning redistricting law; Vasquez-Wilson and the others were told the memo would be ready

by the November board meeting.

But that was not quick enough for Vasquez and her husband, Ron "Sweet James" Wilson, who filed a questionable contempt of court proceedings against CB - despite the fact they both knew the redistricting was illegal - to force placement of the redistricting item on the October board meeting agenda.

At the hearing, CB attorneys informed the presiding judge the item would be placed on the November agenda; the case was moved until February 2024, when CB will show proof that the item was placed on the November agenda.

By early November, the outside law firm completed the memo, which was included in the Board Packet sent out weekly by GM Alex Rojas.

The memo was clear; if there were an attempt to redistrict, the action would be met with lawsuits challenging the maneuver.

Despite the memo, Vasquez-Wilson and Garza demanded the item be

La Palma Will Consider Digital Two-Sided Billboard on 91 Freeway

Outfront Foster Interstate, LLC, is requesting approval of a double-sided digital display billboard to be located on a portion of the real property at 6951 Walker Street.

The proposed billboard will have an overall height of ninety-two feet on the Walker property.

The base structure for the billboard sign will consist of a three-part pipe sleeved together for

a single pole superstructure. The first 30' feet of pole superstructure will a 60" inch diameter pipe buried underground in a concrete footing.

The billboard display size is dictated by City Code which states, "The maximum size of each digital billboard face display area shall be 25 feet in height and 60 feet in width, with the area of each face not to exceed an overall maximum of

The Bike-Friendly Transformation of Artesia

Artesia is undergoing a remarkable transformation into a bike-friendly community.

Spanning just 1.6 square miles with a population of about 16,000 residents, Artesia is a diverse city with a thriving Little India district coexisting

alongside multi-ethnic Asian, Latino, Black, and white neighborhoods.

Despite being surrounded by car-centric areas in the Gateway Cities sub-region, Artesia is determined to create a sustainable and active transportation infrastructure.

Artesia is not some

kind of bike paradise (yet), but the city is already surpassing its surrounding neighbors with new bike lanes, green pavement treatments, a new bike path, and more on the way. In early 2022, Artesia adopted the Artesia Active Transportation Plan, marking a significant

Considering how the Cerritos High football team had outscored its past three opponents in the first half 77-6, a defensive tussle in the CIF-Southern Section Division 12 championship game wouldn't have been thought of. While the Dons had to stave off fourth quarter rallies each time in the playoffs, it would be the opposite on the biggest stage in the history of the Cerritos football program.

In their 19-13 overtime victory over Yucca Valley High last Saturday night at Atkins Stadium on the Artesia High campus, the Dons ran 14 plays in the first half, gaining just a measly four yards, turned the ball over twice but was

Applications are due Friday, December 15. The selected applicant would represent the La Mirada on the GLACVCD Board and provide information to the City Council about GLACVCD activities and

programs. GLACVCD is a public health agency that is a result of legislation incorporated in the California State Health and Safety Code. The GLACVCD provides ongoing mosquito and vector control for its residents.

Recalled Cantaloupes Linked to 3 Deaths

Three people have died amid more than 150 cases of salmonella infections linked to cantaloupes, according to CDC and Canadian health officials.

Two deaths occurred in Minnesota, and 99 reported U.S. cases span 32 states. An additional person has died in Canada, where so far 63 people have had lab-confirmed cases of salmonella linked to contaminated cantaloupes.

Both whole and precut cantaloupe products have been recalled that were sold at multiple retailers under multiple brand names. The cantaloupe recalls currently listed by the CDC are:

Whole cantaloupes that might have a sticker on them that says "Malichita" or "Rudy," with the number "4050" and "Product of Mexico/produit du Mexique."

Some Vinyard brand pre-cut cantaloupes, melon and fruit medleys sold in Oklahoma.

Some ALDI whole cantaloupe and pre-cut fruit products such as pineapple spears that were sold in specific states.

Some Freshness Guaranteed brand and RaceTrac brand pre-cut cantaloupes, including melon and fruit mixes, sold in specific states.

Recalled products should be thrown away or returned where they were purchased, the CDC advises. Surfaces and items that may have come in contact with recalled items should be washed with hot, soapy water or in a dishwasher.

Most infected people will develop symptoms between 6 hours and 6 days of exposure. So far, the cantaloupe salmonella outbreak has affected people ranging in age from infants to people 100 years old, the CDC says.

milestone in its pursuit of becoming a bike-friendly city.

The plan outlines 17 priority bikeway projects, demonstrating the city's commitment to enhancing its cycling infrastructure.

In a recent development, Artesia unveiled new bright green bike lanes on 166th Street between Pioneer and Norwalk Boulevards.

This half-mile long project, spanning across Artesia, Norwalk, and Cerritos, incorporated a road diet to improve safety for pedestrians, cyclists, and motorists alike.

Additionally, Artesia is in the process of constructing the Historical District Recreational Trail along the soon-to-be-renamed West Santa Ana Branch rail right-of-way. placed on the November agenda for discussion.

According to CB counsel, California Water Code Section 71540 makes any redistricting subject to the rules found in the Elections Code for Special Districts.

According to the Code, redistricting can only occur after the census, which is every ten years, or when a "sufficient change in population" has occurred.

Census data are presumed to be accurate for ten years. Consequently, Vasquez-Wilson would have to prove a sufficient change in population using a costly tax-payer-funded analysis.

Research by LCCN found established SCOTUS case law in 1983 that mandates using an established methodology to prove the population shift. Vasquez-Wilson intends to "redraw district boundaries," evidently without analysis, which would likely be challenged in court, again costing CB rate-payers thousands in legal fees.

Despite the overwhelming evidence, Vasquez-Wilson and Garza insisted on discussing the item and were again advised by staff and legal counsel that they would be open to lawsuits if they proceed.

Unconcerned, Vasquez-Wilson motioned "to bring back the item as an action item to and redraw the district boundaries."

GM Alex Rojas responded, saying, "We can't agendize an item that we have been advised is illegal and non-compliant with election law."

In a reckless statement harkening back to the uber-corrupt days of Art Aguilar and Ron Calderon, Juan Garza snapped back, "We make the law, we can bring the item back even if it's illegal."

Vasquez-Wilson made the motion to bring back the redistricting item as an action item, which lap-dog Garza, of course, seconded; the motion failed with Vasquez-Wilson and Garza voting yes, President Art Chacon voting no, with the remaining board members abstaining; Rodriguez and Gualtieri were conspicuously absent. According to sources, Vasquez-Wilson's failed scheme cost CB thousands in legal fees.

Assemblyman Announces Legislation to End Time Change

Staff Report

Last week, Assemblyman Tri Ta (D-Rossmoor) announced new legislation to end the practice of changing clocks twice a year. If passed, this measure would keep California on year-round standard time.

“Changing clocks twice a year is not only frustrating, but it’s dangerous for drivers and contributes to our state’s mental and physical health crises every year. When voters passed Proposition 7 overwhelmingly in 2018, they did not expect the Legislature to stall the will of the voters by refusing to take up this important measure,” said Assemblyman Ta. “This legislation makes good on a promise that California voters decided on long before I was in office. It’s been 5 years, and now that I’m here in Sacramento, I’m going to hold government accountable and take action.”

In 2018, Proposition 7 passed in California with nearly 60% of the vote, calling

on the Legislature to end twice-yearly time changes. According to several studies, time changes are linked to increases in vehicle accidents, seasonal depression, and other severe health issues.

Dr Andrew Binder, MD, FAASM, FCCP, member of the Board of Directors of the California Sleep Society, who is excited and relieved to see this issue finally getting the attention it needs, says “I applaud Assemblyman Tri Ta for introducing this legislation. Children and teenagers are especially impacted by the disruption caused by time changes. Our natural sleep rhythms and internal clocks are best suited for year-round standard time and after the passage of Proposition 7, now is the time for the Legislature to act. I urge Assemblyman Ta’s colleagues in the Legislature to follow the science and join him in passing this important bill so Californians can lead healthier lives.”

This bill would require a 2/3 vote of the Legislature and would go into effect in 2025 if passed.

La Mirada High has had stellar seasons recently, and the Matadores are looking for another trip to the CIF-Southern Section divisional finals. Whitney High is looking for an encore performance with a new head coach while John Glenn High is seeking better things under their first-year head coach.

Could the Artesia boys basketball program be gaining some momentum like the Artesia teams of early part of the 2000s when the Pioneers won three straight league titles, back to back CIF state championships and went 144-21 in a five-year span from 2002-2007? Time will tell, but if last season's performance, minus the second round exit in the playoffs, is any indication, then Artesia is headed for another banner campaign.

"Any loss is a hard loss," said head coach Jeffrey Myles of the early playoff loss last season. "Every season we go into with the expectations to make a deep run in the CIF playoffs and try to win CIF. Losing in the second round was heartbreaking. But we lost to a very good Buena team on

the road on a Friday night in a hostile environment. Buena won 30 games last year and went to the state finals. So, it's not like we lost to a bad team; they were a very good team, and we were right there with them and had our opportunity to win. But it just wasn't our time yet."

Artesia has had consecutive seasons of getting to at least the second round after seven straight first round exits. With the departure of senior Aaron Banks, who was the league's most valuable player, and seven other players, Myles will look to senior Zion Staples to carry most of the load, along with a solid group ready to do more. Staples is a likely candidate grab the same accolades that Banks did last season. But look for senior Josh Martinez to improve more as the only other returning starter. They will be joined in the projected starting lineup by juniors Jaylen Reed and Judd Sajise and sophomore Kobe Young, who is one of eight new players to varsity.

"During the offseason, we grind, we workout, we condition, we lift weights, we hit the beach for workouts, and we work on skill developments to try to help our players be the best basketball players they can be," said Myles. "The summer is about just playing games and getting experience and playing some teams you probably won't play in the regular season."

Outside of Martinez and Staples, senior Tyler Robinson, junior Cayden Del Rosario, Reed and Sajise played limited minutes, prompting Myles to treat this season's squad like a dozen new players. He said he couldn't pinpoint one or two top newcomers because every day, someone steps up or takes a step back, adding that after the top two options, he doesn't expect anyone to take a backseat to those players.

As for the season, which began with the Pioneers winning four of their first six games, Myles believes the recipe for success will be how quickly the new guys mesh together.

"The 605 [League] has gotten better this year and none of us expect it to be like last year," he said. "We expect to be in a dog fight every game and hopefully by league, our guys are up to the challenge, and I believe they will be. Someone once said, 'heavy is the head that wears the crown', and right now, we have the crown, and we know everyone in the league is coming for it. So, if we want to win the league and go back to back to back, we have to play every game like it's a championship

game and we have to implement what I've been preaching the last few years...ALWAYS COMPETE!!!"

Longtime head coach Jonathan Watanabe has pretty much seen it all in his illustrious career. But this season will be different as he and the Cerritos nation will be playing with heavy hearts as senior Ethan Soriano passed away earlier in November. This would have been Soriano's first season on the varsity squad and the program will be dedicating the 2023-2024 season to him.

"Ethan is the ultimate teammate, always putting the needs of the team above his own," said Watanabe. "He is the epitome of hard work and perseverance."

"I see myself being a leader both vocally and through example as I hope my work ethic will inspire my teammates to keep getting better," said Soriano before the season began. "However, I will stay passionate for any role to make sure the team wins."

Last season was a rebuilding one for the Dons, who went through their second straight losing season, the first time that has happened since 2011-2012 and 2012-2013. Watanabe attributes that to the youth and inexperience as there were three varsity returners and half a dozen more with

no varsity or junior varsity experience. But it must be mentioned that Cerritos began the season losing 10 of its first 11 games before the turnaround, and advanced to the second round of the playoffs.

Cerritos figures to be much stronger with seniors Osinachi Agaranna, Tobeanna Ozoagu, Shay Pema and Luke Rigor returning. In all, the team will field eight seniors, eight juniors, one sophomore and one freshman. Watanabe says the other five returning varsity players have gotten stronger and quicker, improved offensively and defensively and have a good understanding of the system and expectations to be successful, both on and off the court. He was speaking about juniors Jaylen Barsana, Benson Cho, Nathan Ju, Jaden Ribac and sophomore Yuuki Yamamoto.

"With all these returners, one of our biggest strengths has become our depth," said Watanabe. "We are comfortably able to rotate 10-12 players into the game with very little drop off."

Senior Evan Monteclaro, a transfer from Buena Park High, and juniors Nathan Dawit, a transfer from Servite High and Demetrius Washington, the MVP of the junior varsity team last season are listed as the top varsity newcomers who will make a big impact.

Watanabe sees Artesia as the team to beat again once league begins, but also knows the circuit is tougher. He adds that Whitney will still be good, especially if junior Morgan Marks can stay healthy. Among other tidbits he had about the league, he believes it's going to be "a fun and exciting league season".

The Dons will once again be put to the test in the first month and a half to the season, playing the likes of Cypress High, Gahr High, La Habra High, La Serna High, Los Alamitos High, Orangewood Academy and Servite High. They will also make their usual trek to San Diego to take part in the Mt. Carmel Tournament. The game against La Serna, which was this past Monday, was played at Crypto.com Arena, the 11th straight season the Dons have played a non-league game in that facility.

"A lot of coaches create a schedule allowing them to win 20+ games so they can have a "successful" season," said Watanabe. "At Cerritos, we are not concerned about the number of games we win in preseason. We are focused on getting better and winning championships. We schedule teams at or above our level of play to help our players and our team improve."

That still wasn't enough to make a coaching change as Chris Palisin becomes Glenn's third head coach in the past four seasons

Player defections throughout last season forced the numbers to dwindle and when the season was over, the Eagles were left with three returning players for the 2023-2024 campaign. Since taking over, Palisin says the practices have been teaching moments, both good and bad, and the team was able to have a shortened fall season, which is positive for a rebuild. Since the Eagles are in rebuilding mode, they are stressing team daily with no individual more important than the team concept. With that said, he could not list a projected starting lineup or any individual players.

"My staff and I are building relationships and trust, and we expect positive effort and attitude daily," he said. "Sportsmanship and team energy is stressed."

Palisin admitted the 605 League is strong and experienced this year and added that Glenn's non-league schedule will be important to gain experience and confidence to build the young team's confidence and passion for league competition.

"We understand we will be a huge underdog this season with a total rebuild," said Palisin. "We will embrace and strive daily to help our student-athletes fulfill their maximum potential."

After reaching the CIF-SS divisional finals the past two seasons, La Mirada can only go one way, which is up. The Matadores have moved to Division 1A for this season with an opportunity to go to the Open Division once the playoffs begin. Head coach Randy Oronoz says the past two seasons have been special and the Matadores have played in 14 playoff games during that span which has given them a ton of experience in big games.

"The offseason for us is really simple," said Oronoz. "The team gets a ton of shots up and skill work in the gym and really tries to dedicate themselves to their individual development."

With that said, Akmal was quick to point out that there were two weeks in between his hire date and the start of the season and there were many obstacles that needed to be overcome. He added that everyone involved is doing their best to expedite the change in the system and most of the players are up to the challenge.

Look for juniors Christian Carreon and Morgan Marks to improve from last season and try to fill in the shoes left behind by David Song and Ethan Wong. Marks missed a chunk of last season with an injury while Carreon was a consistent bench player. His projected starting lineup would be Carreon, Marks, seniors Sakeef Sekender and Joseph Whitaker and junior Alex Cheng.

Whitney will be built around their junior class of seven players and Akmal says freshmen Jezreel Dela Cruz and Jack Diancin have been solid and are quick learners and gamers.

"We're also looking for our sophomore class to take a big leap this season," said Akmal. "I'll be moving them around a lot between varsity and junior varsity just to get them more experience and playing time together. We'll need their height and skill sets when we get into league."

Speaking of league, Akmal says the main goal is to make the playoffs and go on another run just like last season. He admits Artesia and Cerritos are always going to be tough teams to beat and Pioneer High and Oxford Academy tend to get up for games against Whitney.

CERRITOS HIGH FOOTBALL MOVING ON TO SOUTHERN CALIFORNIA REGIONALS

Last season, Valley Christian High's football team fell to Lancaster High 44-42 in the CIF-Southern Section Division 12 championship game. This season, in the same division, Cerritos High claimed the title, getting past Yucca Valley High 19-13 in overtime last Saturday night at Atkins Stadium on the Artesia High campus.

Now, the Dons move on to the CIF State Southern California Division 6-AA Regional finals where it will host Wasco High on Friday at Artesia. Game time is slated for 7:30 p.m. The winner will face the winner from the Northern California Regional finals, either Palo Alto High or St. Vincent de Paul High the following week for the state championship.

"It started hitting me yesterday and I started having anxiety [attacks]," said Cerritos first-year head coach Demel Franklin following the win over Yucca Valley. "I went to the cemetery to visit [former Cerritos offensive line coach Webster] Peters, who we lost. We had a conversation, and I knew he was with us. So, he helped calm me down. I saw him again today. It started hitting me yesterday; I'm not going to lie. I was nervous."

Cerritos, which has won nine games for the first time since 2001 when that team went 9-2 and advanced to the quarterfinals, enters the contest on the program's hottest streak in over

25 seasons with six straight victories. During that stretch, the Dons have been winning with stellar performances from both sides of the ball.

The three-time defending 605 League champions have outscored their opponents 260-104 during the winning streak. Offensively, Cerritos is led by senior running back Josh Park (692 yards on 107 carries and 13 touchdowns) and juniors Dikshanta Adhikari (151 rushes, 807 yards, five touchdowns) and Josiah Ungos (117 carries, 526 yards, four touchdowns).

Spreading the wealth around also applies to the passing game where senior quarterback Julian Morales and sophomore Justin Sagun have combined to throw for 1,121 yards and 13 touchdowns. Of those numbers, Adhikari, Park and junior John Lim have combined for 48 receptions, 479 yards and half a dozen touchdowns. Sagun has also picked up another 313 yards on the ground with two more touchdowns. Cerritos has gained 4,703 all-purpose yards and those six players have combined for nearly 3,500 of those yards.

On the defensive side, junior linebacker Nathaniel Crawford is the leader

of the pack with 117 tackles, but not far behind is sophomore linebacker Tyler Ky with 104 tackles. Other defensive stars are senior linebackers Jeremiah Bagaygay and Gabe Gaudi (90 tackles each) and sophomore linebackers

Bailey Crawford (57 tackles) and Jacob Hoosac (68 tackles). Bagaygay also has six sacks.

Wasco, a small town 24 miles northwest of Bakersfield, won the CIF Central Section Division V crown by defeating Bishop Union

High 42-41. The Tigers have won three straight games and six of their last seven after beginning the season alternating wins and losses through their first four outings. Wasco won the Division IV championship in 2012, defeating Bakersfield Christian 29-22, capping off a 13-0 season. The previous season, Wasco lost to Washington Union 55-12 in the Division IV finals.

The Tigers are not as high scoring as the Dons, just six points shy of 300. In fact, they have given up more than they have scored. Wasco has had three games in which it has eclipsed 35 points but has yielded at least 25 points half a dozen times.

Cerritos' run defense will be put to the test again as the Tigers have rushed for over 3,000 yards and the Dons will be keying in on No. 4, Noah Lopez, who has rushed for 1,171 yards and scored 15 touchdowns and No. 21, Michael Dominguez, who has gained 943 yards with 10 touchdowns. Wasco doesn't pass much as David Manzo has completed 18 of 39 yards for 390 yards.

down a touchdown to the Trojans. But, in the final 6:07 of the fourth quarter, sophomore quarterback Justin Sagun found junior running back/wide receiver Dikshanta Adhikari for a pair of touchdowns to send the game into overtime. There, after the Trojans were stopped at the 14-yard line, Sagun tossed a short three-yard pass to senior Jeremiah Bagaygay, who was wide open in the left side of the end zone to give the program, and the City of Cerritos a historic victory.

With the Desert Valley champions up 13-6 with 2:50 left in the fourth quarter, the Dons got the ball at their own 25-yard line. After a pair of plays totaling 15 yards, Sagun threw three straight incomplete passes before first-year head coach Demel Franklin called his final timeout with 1:20 remaining.

"We just needed to score," said Adhikari. "We had to get it together, play together and just score. That's all that was said. [Franklin] just expected us to score and we did it."

Coming out of the timeout, Sagun connected with Adhikari for a 27-yard gain on fourth and 10, then a 15-yard play and finally a 13-yard touchdown pass with 30.7 seconds remaining. Adhikari found himself wide open on the left side, but the play was intended for Sagun to roll out to his right. However, Yucca Valley sent its linebackers all the way out, forcing Sagun to go the opposite direction where he found Adhikari. Franklin said he wanted Sagun to throw backside and find senior running back/wide receiver Josh Park, but instead saw Adhikari on the opposite side of the end zone.

"It was just a game of chicken," said Franklin. "They were daring us to throw the ball and we started throwing the ball. We knew they were not going to cover us. I could have gone to that earlier, but if one thing goes the wrong way, then we're now chasing 21 points. It was kind of designed to keep it close and I just had to pray that it was going to work out."

"[Sagun] had to scramble and do what he did," said Adhikari. "He threw me up a great ball in the end zone and I caught it for the touchdown and celebrated with the team. That's it."

The game started in the most ominous way for the Dons, who have now won seven straight games. Their first four plays went for negative yardage and when the scoreless first quarter ended, the 605 League champions had minus seven yards on eight plays. But the Trojans were struggling as well, running eight plays and getting 13 yards in the fast-moving stanza that took 16 minutes of actual time to complete.

The pace picked up in the second quarter and on third and five from the Yucca Valley 43-yard line, sophomore linebacker Bailey Crawford sacked Michael Ramos Jr. for a six-yard loss, forcing the Trojans to punt. Four plays later, on the ensuing Cerritos possession, Walker Rauschenberg recovered a fumble near midfield and Yucca Valley went 51 yards to put the first points on the board, a one-yard sneak from Ramos Jr.

The drive, which lasted five and a half minutes, was extended when Cerritos was offside on fourth and seven as Anthony Morando was lining up for a potential 28-yard field goal. Then on the next play after the touchdown, Rauschenberg picked off sophomore quarterback Julian Morales and the Trojans ran out the clock to end the half.

Even though the Cerritos defense was doing its job, holding Yucca Valley to 80 yards 30 plays, most of them rushing plays, the Dons were still stymied with four yards on 14 plays, punting three times and turning the ball over twice. Cerritos had one first down in the half

and got as far as the Yucca Valley 40-yard line.

"So, it was me being hesitant to throw the ball," said Franklin. "I knew coming in, and I told my staff, that we were going to throw the ball on these dudes. We were going to take chances. When we threw that interception, it made me a little gun shy. We could have thrown the ball all night if that's what we wanted to do, but I wanted to try to be conservative and keep it tight."

"We saw they were just putting all their attention on [our running backs]," he later said. "It's cool; we would use them as decoys, and we would run everybody off that. That's why [senior running back/wide receiver Josh] Park had big plays and Dikshanta had big plays."

"It was most definitely a different game," said Adhikari. "Every game, we had no trouble against running the ball. We would run; me, Josh, back to back to back. No backs in the backfield were tired. But we came out this game, started passing more and that started to work too. We were just able to come out for the win."

Three plays into the second half, senior Diego Martinez intercepted Ramos Jr. But Cerritos couldn't take advantage as senior Moises Mendoza was wide left on a 39-yard field goal attempt with 7:41 left in the stanza.

After both teams traded punts, the Trojans closed out the quarter by going 47 yards on seven plays, covering the final 3:36. The key play of the drive was Bagaygay sacking Ramos Jr. for an eight-yard loss on third and eight from the 15-yard line. That forced Caden Beasley to try a 33-yard field goal on the first play of the fourth quarter, which was short.

"We were contemplating switching to

a different [defensive] front because they started kind of getting some consistent runs," said Franklin. "But [Nathan] Endo believed in what he was doing and that's my defensive coordinator."

Cerritos continued to pick up more steam, converting a key play on fourth and four from its 38-yard line when a missed tackle allowed Park to take a short reception from Sagun and turn it into a 37-yard gain. Four plays later, Adhikari's 27-yard touchdown reception put Cerritos on the board, although the extra point was missed. The Trojans came right back and extended their lead to 13-6 when leading rusher Myles Harper, who entered the game with over 1,700 yards, galloped 50 yards for a touchdown. But junior cornerback John Lim blocked the extra point, giving the Dons hope with just under three minutes left and a pair of timeouts.

In overtime, Myles had runs of 10 yards and one yard before Ramos Jr. threw three straight incomplete passes from the 14-yard line, all towards the left side of the end zone. Cerritos got the ball at the 25-yard line and Park immediately gained 12 yards. Adhikari followed that with a three-yard gain, then Park had runs of a yard, six yards and no yards before the game-winning touchdown.

"We're down there and I see [Yucca Valley] loading the box," said Franklin. "I told Sagun, once everyone got into the huddle, run a bootleg, fake the handoff, and run left and hit Bagaygay. Tell him to just touch the end and run to the corner. I said you could run or throw; I don't care, but he's going to be wide open."

Yucca Valley, which won the Division XI title in 1996, was seeking its second title. Harper led everyone with 170 yards on 25 carries while Stephon Rogers added 59 yards on a dozen touches. Ramos Jr.

completed five passes for eight yards and was sacked twice.

"He's a lot tougher than what I thought," said Franklin of Harper. "We met him at the [CIF-SS] luncheon [last Monday] and I saw that he wasn't that big. But he's a very tough kid on both sides of the ball. I tip my hat off to them."

"They just started out fast," said Adhikari. "We came here to play, for sure. But they came out with a little more energy than we expected them to. But we went into the halftime, made a few adjustments, came out and got our offense to start getting on all [cylinders]. We started running the ball and throwing a little bit and stuff started to work."

Sagun was 12 of 17 for 158 yards with Adhikari catching five passes for 94 yards. Park had three catches for 45 yards and Lim two more for 22 yards. Defensively, Bagaygay and sophomore linebacker Tyler Ky each had five and a half tackles while senior linebacker Gabe Gaudi and sophomore linebacker Jacob Hoosac each had five tackles.

The Dons will host Wasco High on Friday in the CIF State Southern California Division 6-AA Regionals with the winner to face either Palo Alto High or St. Vincent de Paul High the following week for the state championship.

"I don't even know how to feel right now," said Adhikari, who moved to Cerritos when he got into middle school. "I'll go home and definitely look back at this moment."

"It just feels unreal; we've been dreaming about this moment for so long," he continued. "Now we're finally living it and hard work got us here. We ran the ball hard; we played hard both sides of the ball. We just came out and played."

1,500 square feet, including border and trim.”

The proposed digital display billboard face will be approximately 14’ feet in height by 50’ feet in width for a total size of 672 square feet.

The overall cabinet housing the digital display which includes the prefabricated aluminum shroud/trim around the LED face of sign is sixteen feet by fifty feet for a total size of 800 square feet.

At 800 square feet the sign face is well within the code limits of 1,500 square feet per sign face.

Brightness of display billboards must comply with all applicable laws

and regulations concerning brightness and illumination, including, without limitation, per the California Vehicle Code.

The proposed billboard will be equipped with the technology to comply with this regulation and the proposed conditions of approval require compliance with such regulations as well.

The terms with Foster dictate a first payment due at the start of operations at \$10,417 per month or \$125,004 a year for a double-sided digital display billboard.

The amount of revenue anticipated to be generated from this project, in terms of sales tax dollars, would place this revenue generator in the city’s top five producers.
