



Santa Fe Springs Enters Last Phase of Residential Street Lighting Upgrade

The Santa Fe Springs City Council, at its Mar. 19 meeting, voted to begin the final phase of the city's \$3.6 million residential street lighting system upgrade project; the project is funded by the City's Utility Users Tax (UUT) Capital Improvement Fund.

The upgrade has three phases involving transitioning from traditional lighting to LED lighting.

LED streetlights are lighting fixtures that utilize light-emitting diodes (LEDs) as their light source. LED technology has been used more recently due to its energy efficiency, longevity, and environmental benefits.

LEDs use significantly less energy than traditional lighting sources, reducing electricity bills and lowering carbon emissions. LED street lights have a longer

lifespan compared to conventional bulbs, typically lasting 50,000 to 100,000 hours or more reducing maintenance costs and the frequency of replacements.

LED streetlights are more durable and resistant to vibrations and shocks compared to traditional lighting technologies, making them suitable for outdoor environments.

Phase 1 included converting all SCE-owned residential streetlights from the existing high-usage fixtures to new LED lights. The project was completed under an SCE program at no cost to the city. Phase 2 included converting the majority of the city-owned residential streetlights from high-usage fixtures to LED lights, which was completed by the city's Public Works staff.

Phase 3 includes the design and conversion of the remaining

ABC Unified School District School Board President Mrs. Sophia Tse and Superintendent Dr. Gina Zietlow provided an update to the District's city partners on Monday, March 18, 2024. City Council members and senior city staff from Artesia, Cerritos, Hawaiian Gardens, Lakewood, and Norwalk learned more about the District's finances, how funding is used, hiring staff, and the challenges the District faces, including declining enrollment.

About 15 percent of the District's students come from cities outside of the ABCUD boundaries, attending on inter-district permits.

"It was great to have all of our city partners here at the District," said Superintendent Dr. Zietlow. "We simply can't do all we do for kids without the support from our cities and communities, and I want to thank them for all they do."



LA MIRADA WILL END YEAR WITH \$5 MILLION SURPLUS

Showing remarkable resiliency, La Mirada's finances "are stable and generally in line with expectations" according to a presentation by Finance Manager Melissa Pascual at a study session this past week.

The La Mirada City Council reviewed the mid-year financials and were pleased that the city would "likely conclude" 2023-'24 with a nearly \$5M surplus.

"The City's mid-year budget review reflects a commitment to prudent fiscal management practices and a conservative approach to revenue forecasting," said City Manager Jeff Boynton.

Total General Fund revenues are projected to nearly \$50 million, which is within one percent of the budgeted amount. Property tax revenues remain strong and are expected to reach over \$9 million. Residential, commercial, and industrial real estate values have continued to rise this year and La Mirada's total assessed valuation is at an all-time high.

The City receives a small portion of the one percent tax rate paid by property owners to L.A. County, as most property tax is allocated to school districts and county services.

Sales tax revenues are expected to reach \$12.3 million, reflecting a conservative estimate. Some decreases in sales activity have been experienced across various business sectors, including business-to-business sales and construction. Recent and planned developments including retail and restaurant openings are expected to increase sales tax revenues over the next year.

Revenues from the Theatre and Community Services programs are projected to reach \$11.25 million. La Mirada Theatre for the Performing Arts is having another strong season with two blockbuster productions, Jersey Boys and The Little Mermaid, still to come this spring. Rental

income at the Theatre was lower due to roofing and HVAC improvements that were completed during the summer. Many groups who previously rented the Theatre for dance recitals, corporate events, and cheer competitions are returning now that the work is complete.

Recreation programs are also having another positive year. Participation in the City's youth sports leagues, recreation classes, and senior programs remains strong. Expanded aquatics programming is being offered this spring with many swim lesson classes available at all skill levels. Additionally, Buccaneer Bay remains a popular and affordable destination for summertime fun.

Total expenditures are projected to reach \$44.92 million this year, which is more than three percent below the budgeted amount.

The City projects to spend about \$16.50 million this year on capital improvement projects. Numerous projects have been completed including the street slurry seal project in the neighborhoods near Windermere Park and Escalona Elementary School, rehabilitation of eastbound Imperial Highway from the west limit to Biola Avenue, drainage improvements along La Mirada Boulevard, replastering of the lazy river and coating of the original waterslides at Buccaneer Bay, exterior painting of the City's historic buildings at Neff Park, and many more. Other projects, including new solar panel carport structures and EV charging stations at the Civic Center, are in progress. Most capital projects are designed in one fiscal year and constructed in subsequent years.

Work has already begun on developing the Fiscal Year 2024-25 budget, which will be presented at a City Council Study Session meeting in May. The new fiscal year begins July 1.

residential streetlight systems and requires conversion prior to installing LED light fixtures. The scope of work includes the design for the replacement of existing antiquated streetlights located in five residential areas and two industrial areas, converting approximately 350 lights from the existing lights to LED lights. Additionally, 36 antiquated residential post-top street light poles will be replaced with new, aesthetically pleasing city-standard concrete light poles. The designer will develop plans, specifications, and estimates to solicit a construction bid.

By converting existing street light systems to energy-efficient LED lighting, the city can save money, provide better lighting for the community, reduce energy use, and decrease the city's impact on the environment.

Norwalk's Dulce Canella Serves Great Mexican Desserts

Dulce Canella, located on the corner of Excelsior and Pioneer in Norwalk is a dessert spot that puts a wonderful Mexican twist on its menu items.

The shop is filled with Mexican-inspired decorations like mini donkey piñatas and sombreros hanging on their walls.

Dulce Canella offers a wide variety of delectable desserts such as churros, mini pancakes, fried Oreos, Twinkies, ice cream sundaes, and milkshakes.

But not only are there many dessert options, there are toppings and flavors that are endless too.

The Mini Combo is a good place to start if you don't know exactly what you want.

This order is fairly affordable, \$11, and comes with enough for two-six churros, 15 mini pancakes and you can choose up to three toppings to add on.

Everything is made fresh on the spot which is why the wait time is a little longer than other dessert spots but it is well worth the wait.

The churros are nice and crunchy and the mini pancakes are light and fluffy.

A good combination of toppings for the

churros is the cajeta (caramel) and lechera (condensed milk).

These two items paired with the churros bring a taste of Mexico to life and are deserving of a five-star rating.

If you prefer to control how much of the topping is put on your desserts you can ask for them on the side, although when they do it for you it's more aesthetically pleasing.

The mini pancakes were good but not as great as the churros.

If you like a variety of items in one order you may also want to try the Sampler or Mini Sundae.

Another option on the menu is the nine different milkshakes. These range from \$5-7 depending on the size you get. The medium size shake was a decent size but the cookies and cream flavor was a bit too overpowering. For this reason it deserves a three out of five stars.

Dulce Canella does offer a small food section that includes chicken strips and fries with multiple combo options and offering cheese and loaded chicken fries.

Overall the vibe of the location is welcoming and heartwarming. This place deserves four out of five stars.

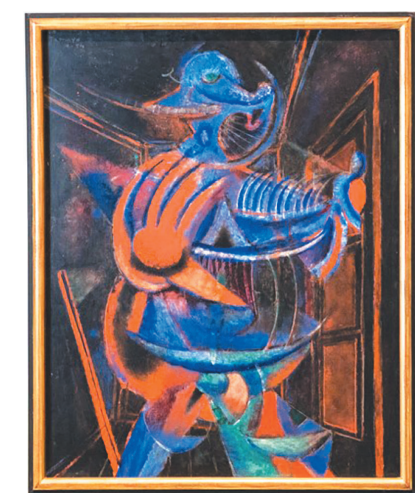

GAHR SOFTBALL STUMBLES IN TAIL END OF TORRANCE NATIONAL TOURNAMENT

TORRANCE-The way the Gahr High softball team began the 13th Torrance National Tournament was nowhere near the ending the Gladiators wanted as they resume Gateway League action this week. Gahr won its two pool play games over Santa Monica High and Banning High, respectively, but struggled in a 4-1 loss to Rio Mesa High last Friday night, followed by a 3-1 loss to Torrance High last Saturday morning and finally a 6-1 setback to Redondo Union High about four hours later.

To put the tournament into perspective, Gahr had 15 hits in its two wins, but combined for 13 hits in the three losses. After winning their first three games of the season and four of the first six games, the Gladiators began this week at 7-6 overall with seven runs scored in the six losses.

"Rio Mesa is definitely a good club," said Gahr head coach Rey Sanchez.

"We had one bad inning in that game where we gave them the four [runs]. We had our opportunities in that game. We were [also] not at full strength. We were missing [seniors] Larissa [Flores] and Alyssa [Aguilar] because they were away at Calculus Camp. That changes our landscape of our lineup quite a bit. We needed some other girls to kind of step up and we didn't get that in this tournament."

Sanchez continued to say that the two games last Saturday at West Torrance High was the fourth location of the five-game tournament for the Gladiators. They were supposed to play their pool play games on Mar. 9. However, Banning has a scheduling conflict and couldn't play Gahr until late in the evening on Mar. 11 at Torrance. Then the game last Friday was another late contest, plus an 8:00 a.m. contest last Saturday followed by the 12:00 game, which was for seventh place in the Gold Division, for winners of the eight pools.

Sophomore pitcher Olina Burgueno, who was making her first start of the season, yielded a pair of runs in the top of the first inning, and four more two innings later. She pitched in three of the five innings played, allowed seven hits, struck out two and walked one. Half of the runs were unearned as Gahr committed four errors.

Offensively, the Gladiators cracked the scoring column in the bottom of the third when designated player Ciera Contreras singled to right and scored when junior second baseman Malaia Huskey singled to center two batters later. Only two other runners would reach base of the final 10 for the game.

"We didn't get the key hits when we needed them," said Sanchez. "We had a few opportunities; we just didn't execute. We weren't at our best and it was a weird tournament. I know we're better than that. We'll get it right; we're going to get it right. We just hit a little bump in the road, and I know we'll figure it out in the end. We'll be fine."

Gahr went to La Habra High this past Tuesday in a makeup game originally scheduled for Mar. 7 and defeated the Highlanders 6-4 to move to 8-6 overall. They visited Mayfair High on Mar. 21 and will entertain La Mirada High on Tuesday before facing Norco High on Wednesday in a first round game of the Michelle Carew Classic. The winner of that game will face either Grand Terrace High or Great Oak High on Thursday.

"Mayfair has a really good pitcher," said Sanchez. "There are no easy games for us in our league. Mayfair got us last year at their place. Their pitcher threw a really good game at us. I know it's going to be a good battle. They've really improved, and our girls have to be ready to go. I'm sure it's going to be a tight game."

In other softball action, Artesia High shutout Oxford Academy 10-0 this past Tuesday to improve to 7-5-1 overall, 2-0 in 605 League action. The Pioneers host John Glenn High on Friday, then play a pair of games next week against Cerritos

High with Tuesday's game on the road and Thursday's rematch at home.

Norwalk High is sitting at 10-5 overall as it was scheduled to visit Firebaugh High on Mar. 21 and will go to Paramount High on Tuesday before hosting Bellflower High on Thursday.

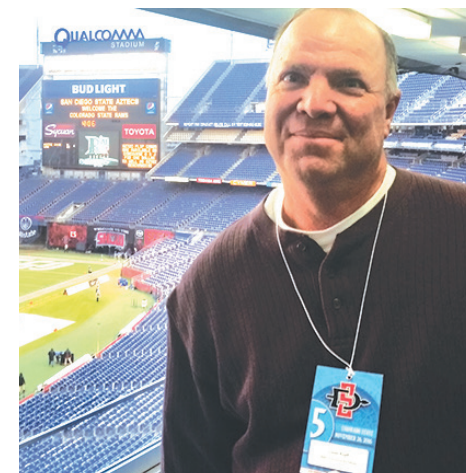

CERRITOS BLOWS GAME WIDE OPEN IN FOURTH INNING TO GIVE WHITNEY ITS WORST LOSS OF SEASON

This was supposed to be the season where the Cerritos High softball team potentially takes a step back, sees its reign in the 605 League come to an end and finishes in third place, or below. This was supposed to be the season where the Whitney High softball team moves towards the upper half of the league and advances to the CIF-Southern Section playoffs for the first time since 2019.

The latter is still in sights but as it relates to the former, it continues to be business as usual as the Dons blew out Whitney 11-0 this past Tuesday for their third straight shutout this season and fourth in the past five games. In addition, Cerritos notched its ninth straight victory over the Wildcats since the league was formed and have outscored the Wildcats 141-7 in those games with five shutouts.

"I don't know if anything has changed," said Cerritos head coach Todd Denhart. "We're 2-0 [in league] but talk to me in 10 days because we can be 2-3. Oxford Academy is 17-0 [overall] and the number one team in Division 7, which I know is Division 7. But they're in Di-

vision 7 because of their last four years. They have four freshmen over there [with] one in the circle. If you get a kid in the circle, things can change in a hurry."

Whitney, which dropped to 7-4 overall, 0-2 in league, suffered their worst loss and failed to score for the first time this season. In the first nine games, the Wildcats scored at least 11 runs six times.

"Definitely, the hard work is paying off," said Whitney head coach Stephanie Machado. "It's been a slow process, but each year, we're just trying to get better day by day, game by game. We knew coming in that Cerritos would be a hard team and we were really happy to stick with them for three and a half innings. That to me is a win in my books."

The Dons grabbed a 1-0 lead in the bottom of the first inning when senior

first baseman Natalie Gardea tripled to right field and scored on a groundout from junior catcher Alianna Calderon. In the next inning, junior shortstop Michelle Meza and sophomore second baseman Ava Ceron each singled and advanced on a passed ball. Meza would come home on a groundout from senior center fielder Presley Hendrix and Ceron made it 3-0 on a single from junior left fielder Anaya Granflor.

Whitney was putting something together in the top of the third inning when Cerritos senior pitcher Kylee Manibusan walked sophomore catcher Olachi Anyama and gave up a base hit to senior second baseman Kristen Sutton, the number nine hitter in the lineup. Senior center fielder Andrea Victoria then reached on a fielder's choice with Anyama out at third. However, Sutton would be caught stealing which proved

to be a critical out because Manibusan walked junior pitcher Monicka Manni. Instead of bases loaded with one out, there were runners on first and second with two outs. Senior third baseman Mariana Bortello would ground out to end the threat and the 'Cats would get one runner on base over the next two innings.

"We've been looking at being more aggressive, especially with teams like Cerritos," said Machado. "You have to take what you can get, and I was noticing that being the lefty catcher, [Calderon] was turning the opposite way. So, Kristen took that chance. To me, she got under the tag from my angle. But that's not what was called. I think I would still make that call just because with a team like Cerritos, you have to make your chances because they're not going to make the errors."

Cerritos added a run in its half of the third inning, then sent 11 batters to the plate in the fourth inning, scoring seven runs on four hits and three errors to make sure the Wildcats wouldn't have a chance to extend the contest to a sixth inning. Junior Lana Javier, who recently was called up from the junior varsity team, had a

LA MIRADA TINKERS WITH LINEUP AGAINST DEPLETED JOHN GLENN TEAM IN TOURNAMENT VICTORY

The more things change, the more they stay the same. That was the situation when the John Glenn High and La Mirada High softball teams met in the first round of the annual La Mirada Softball Tournament last Saturday morning at Glenn.

The former Suburban League combatants were facing each other for the first time since May 7, 2018, and the results were still the same despite both teams missing key components. The Matadores scored six runs in the bottom of the first inning and two more in the next inning for the only runs in an 8-0 win. La Mirada would then lose to Tesoro High 2-1 later in the day while the Eagles were slammed by Bishop Amat High 13-1 later in the day.

"We had to take care of business," said La Mirada head coach Brent Tuttle. "We kind of knew what was going to happen. When the seeds came out, we were the number one seed; they were the number 16 seed. I just told them we have some girls that don't play a lot and we let [junior pitcher] Montse [Reyes-Cardenas] hit today. We worked on getting the ball deep and hitting the ball. We don't take the bats away from kids, so we let them do what they have to do and just come out here and treat it like [any] game."

La Mirada has been without the services of freshman Riley Hillard all season and junior Amanda Urbina since the first week of the season while the Eagles are missing junior pitcher Carissa Galvan, who injured her elbow during her travel ball season. Her doctor told her she could pitch until she feels she can't handle it. With that said, she was reevaluated following Glenn's game against Valley Christian High on Mar. 1 and was told she was going to be out the next four weeks.

Adding to the injury woes for Glenn is senior third baseman Aileen Lopez, who injured her knee before the regular season and needs surgery. She will not play at all this season. Senior catcher Sienna Contreras, who injured her back against Cerritos High last Friday and didn't play against La Mirada, and junior right fielder Erin Perez, who injured her knee last Wednesday and will be out another week to two weeks are two other players currently shelved.

The only chance the Eagles had to do anything against freshman pitcher

Alison Ortega was in the top of the first inning when Ortega walked senior shortstop Kristy Galindo and advanced on an infield single from senior center fielder Diana Bravo, who has also been nicked here and there. The two would steal third and second base respectively before Ortega struck out eight straight batters.

Junior pitcher Quira Castillo replaced Ortega and got Bravo to fly out to left field for the first out of the fourth inning, then struck out the next five batters to end the game.

"I've told the girls over and over that this game is mental," said Glenn head coach Javier Galvez. "We've been preparing all year, just talking to the girls [about] different situations, even the way we approach the game when we're hitting around the field. They know that with the injuries we have, somebody has to step up and we don't have that many girls on the roster. But I feel that a lot of the girls who are being asked to play certain positions are stepping up and doing a great job at it. They're trying their best."

On the third pitch that she saw, freshman second baseman Reese Hillard doubled to get the ball rolling in the bottom of the first inning. Junior pitcher Joslyn Guerrero, making her first start of the season, then walked junior left fielder Angelina Ratzlaff, junior shortstop Alyssa Avila and senior first baseman Amber Valdez, the last two on eight straight pitches, making it 1-0.

A single from freshman center fielder Megan Avila and a walk to senior right fielder Melanie Perez increased the score to 3-0 with the bases still loaded. The inning concluded with a sacrifice fly from sophomore catcher Dani Lopez, a single from junior third baseman Angelyna Conde, who would leave first base early, and a double from Ortega, who would leave second base early for the final out.

In the next frame, a walk to Reese Hillard and singles from Ratzlaff and Avila loaded the bases again before base hits from Valdez and Avila plated Hillard and Ratzlaff to cap the scoring. La Mirada collected a dozen hits with the first five in the lineup going a combined eight for 10 with seven runs

and four runs batted in.

La Mirada, ranked seventh in the CIF-Southern Section Division 1 poll, is more than halfway through the season and has seen some of the top teams in the section and some of the top players in the state. Of their three losses, the Matadores lost by three runs to Huntington Beach High, ranked fourth in the division, and a run each to #2 Orange Lutheran High and Tesoro High, ranked ninth in Division 2.

"What I told our kids was now, we have to be able to beat the exceptional pitching," said Tuttle. "We tied a really great Great Oak pitcher, probably the best pitcher in the state. It was 0-0 and both pitchers were going at it, and our two losses were to [Orange Lutheran], who has Brianne Weiss, one of the best pitchers in the state, and the other one was to Huntington Beach, who has Zoe [Prystajko]. So, we lost to two quality pitchers. That's where we need to get over the hump."

Tuttle has never been shy about putting together one of the toughest non-league schedules around. Through the first 16 games, half have been against Division 1 teams and four more from Division 2. But what makes this season unique is the record the Matadores have despite missing Urbina and Riley Hillard. The latter broke her right hand at practice the week before the regular season began and has not played a game yet. She is slated to get her cast off this week and make her season debut as early as Saturday. Urbina, who dislocated her left wrist on a swing, then hyperextended a nerve, has been out since the first week of the season. She is listed as day to day.

"A lot of people don't know that we're 11-2-2, but we have probably two of our biggest bats out of our lineup," said Tuttle. "That's what I'm proud about this team, is that the kids are stepping in and helping out; grinding out and getting the job done while two of our biggest bats are out of the lineup. If we get both of them back in our lineup, it's going to be scary lineup for pitchers to go through."

Since Apr. 16, 1999 when Glenn defeated the Matadores 6-3 at Glenn, La Mirada went on a 31-game winning

streak over the Eagles, posting 23 shutouts with 15 of them by at least a 10-0 score. The streak was snapped on Apr. 27, 2015 when the Eagles edged La Mirada 1-0. Then the Matadores won seven straight games by a combined score of 68-7 until last Saturday.

"I guess I really didn't think about it because we practice here every day," said Tuttle. "So, we know all those girls. Both teams like each other. There were no weird feelings because it's like playing your little sister. They knew coming in that it was going to be a tough game for them. We knew what type of game it was going to be. But we went out and did what we had to do, and they did what they did. It was just a fun game."

After two decades of near futility, Glenn has gone 40-23-1 the past three seasons, thanks in part to a stellar freshman class from the 2021 season that made school history by advancing to the quarterfinals for the first time ever. But now, only four of those freshmen, now seniors, are on the team and only Bravo played last Saturday.

"It was a good corps of girls," said Galvez. "We had a great run last year. Obviously, we had about seven of those who were playing last year as starters and were injury free. I think the setback this year are the injuries. A lot of our squad this year are junior varsity players that we had to move up, and they're still developing."

Glenn, which lost to Pioneer High 17-2 this past Tuesday to fall to 2-7 overall and 0-2 in the 605 League, will visit Artesia High on Friday, go to Whitney High on Tuesday and host Whitney on Thursday. In between, the Eagles will have two more games in the tournament on Saturday.

After getting past Downey High 2-0 this past Tuesday, the Matadores (12-4-2, 2-0 in the Gateway League) were home to Warren High on Mar. 21, will play two tournament games on Saturday before going to Gahr High on Tuesday and entertaining Mayfair High on Thursday.

"The Gateway League is going to be tough," said Tuttle. "Downey is better this year and Gahr has always wanted [to get] us. I told the girls we're going to get the best of all of them. We're going to see their number one pitcher every time and they're going to give us their best effort just because they want to beat La Mirada. That makes their season. We try not to take any game lightly."

two-run triple. She would score when senior third baseman Toafaoalii Pua reached on an error, singling the end of Manni's time in the circle.

"I like her; I like her in the circle," said Denhart of Manni. "She's a little competitor, she's hitting her spots and I think we made a couple of adjustments in the second and third time through the lineup. We capitalized on a couple of errors, and it is what it is. I don't think she did a bad job. I like her."

Anyama replaced Manni and was greeted with a single from Gardea and a double from Calderon. Pua was making a rare appearance in the leadoff spot while the next five batters in the lineup went a

combined seven of 15 with seven runs scored and four RBI.

"I tried to shuffle the lineup around today," said Denhart. "I don't know if I'll do it again. [Pua] has never led off and I actually sent her a text early this morning [telling her], 'when you see the lineup, don't freak out. You're leading off today'. I'm just trying to get her [more at-bats]. Glenn pitched around her [on Mar. 15] and it's easier to do that if you don't have somebody hitting behind her that anybody fears, which I understand."

Whitney, which was denied a win, for now, this past Monday when its game at Loara High was called in the top of the fifth inning due to lightning and the Wildcats up 14-2, host Pioneer High on Friday and will be home to John Glenn High on Tuesday before enjoying some well-deserved time off until Apr. 9.

The seven victories are two more than last season's production and this is the best season the program has had since 2019 when the 'Cats went 15-9. If they get at least four more wins, they will end the regular season with a winning record and put themselves in a position for an at-large berth in the playoffs.

"The [Division 6] in general was a surprise for us," said Machado. "We only had five wins last year, so getting pushed up a division was a little bit weird. We set our games based on the year before, so that's why we picked other fellow Division 6 teams. If we can get a few [more] wins, this is the chance to do it because we do have six seniors that we've been kind of molding for the last few years."

Cerritos, which defeated Oxford Academy 13-3 this past Wednesday, went to 8-1, 3-0 as it will host Artesia High on

Tuesday in the front end of a home and home series with the Pioneers. The second game will be on Thursday, before the Dons take a break from league action until Apr. 9. The fact that Denhart's team is 8-1 is something in itself considering it went into a scrimmage game against North Torrance High with a dozen players. But some injuries have made the team smaller and only 10 players suited up against Whitney.

"I don't use the whole next person up mentality," said Denhart. "But yeah, if somebody gets hurt, somebody has to fill in. People are going to get their opportunity and they need to take advantage of it. Hey, it's their job and if they don't take advantage of it, we go to the next person."

played the right way," he later said. "Again, it's trusting the process and continuing despite maybe having some bumps in the road, but we still persevered. The system worked and we continued to this day and it's what we have right now."

Artesia (19-3-3), who was ranked 10th in the division, controlled the first 30 minutes of the contest, both in field possession and shots taken finally leading up to Remigio's winning kick.

The Artesia girls soccer program began in the 1996-1997 season and the next season, it went 11-9-0 but finished in fourth place in the former Suburban League. At that time, only the top three advanced to the playoffs. The Pioneers finally made their playoff debut during the 2008-2009 season and finished 10-10-2. After that, the program went through seven straight winnings season, advancing to the playoffs each time, including a quarterfinal appearance in the 2012-2013 season.

However, the program went the opposite direction after former head coach Octavio Marquez stepped down to take over the boys soccer program following the 2015-2016 season. Artesia would go through four losing seasons and missed the playoffs four times since then. This season, the Pioneers posted 17 shutouts, four by 1-0 scores and all three losses were by a combined 10-0 score with all three ties ending scoreless. Two of the three losses came to league champion Cerritos High.

"Last year we missed the playoffs, and we actually had a decent team last year," said Umana. "But things didn't happen the way [we wanted]. But I really feel things happen for a reason because we have a new, revamped group this year."

"Since the very beginning, even coach [Umana] said that he knew there was something special with this team," said Remigio. "I have a lot of trust in him, and I felt like he was right. Also, I want to thank all the staff that pushed us and helped us and also our families who are always supporting us."

For FY 2024-2025, the City expects to receive approximately \$550,000 in CDBG funds. Additionally, the City has an estimated \$93,320 in unspent funds available for programming. The total available funds for programming as part of the FY 24-25 Annual Action Plan is approximately \$643,320.

Priority Funding for CDBG activities are given to activities that:

- Provide decent affordable housing;
• Maintain and promote neighborhood preservation;
• Affirmatively further fair housing choice for all;
• Provide public services for extremely low, low- and moderate-income residents;
• Construct or upgrade public facilities and infrastructure; and
• Planning and administration.

Pursuant to the provisions of the California Environmental Quality Act (CEQA), the proposed Annual Action Plan is exempt under State CEQA Guidelines §15061(b)(3) common sense exemption.
