Virtual Golf Facility Coming to La Mirada

The 17,000 s.f facility will be located behind the IHOP on La Mirada Blvd.

A virtual golf concept called Golf Plus is scheduled to open this summer in La Mirada; the establishment will offer Korean comfort food in addition to golf.

Management recently applied for a liquor license with the city for the on-site sale of beer and wine.

Golf Plus will be located within the La Mirada Theatre Center on the south side of Rosecrans Avenue, east of La Mirada Boulevard, behind the IHOP restaurant, with easy access from any area within the center.

The facility will be located inside the former PDGA and LA Fitness building.

Golf Plus will be an entertainment and recreational facility that offers virtual golf experiences. Instead of playing golf outdoors on a traditional course, players will use simulators to play golf indoors.

These simulators will feature high-definition screens, sensors, and software that simulate actual golf courses. Players can use their clubs to hit actual golf balls into a screen, simulating the ball's trajectory and landing on the virtual course.

Golf Plus will allow golfers to play on most courses worldwide, regardless of weather conditions or time of day.

According to their website, the La Mirada outpost will be its flagship location, boasting 17,000 square feet of

Cerritos Rallies To Capture Fifth Straight Title

CYPRESS-Cerritos High did not want a repeat of what occurred six days shy of the one-year anniversary of an unfortunate loss. It was on Apr. 25 of last season that the Dons lost to Oxford Academy 6-4, snapping a string of 34 straight league wins, including the first 32 of 605 League action.

After defeating the Patriots 7-2 on Apr. 16 in the front end of a pivotal home and home series, a win last Friday on the same field of last season's loss would have clinched a share of at least a tie for another league crown. Mission accomplished for the fifth consecutive season as the Dons survived a sloppy affair by the two best teams in the circuit and gave first-year head coach Matt Joyce a 14-4 victory. Coupled with a 22-1 pummeling over Pioneer High this past Tuesday, Cerritos is now 19-5 overall, winners of all nine league

games and another outright league crown.

"The one thing that stood out to me when I got this job is somebody told me how last year, they lost their first game in league, I think in the last four or five years since the existence of the 605 League," said Joyce. "I really, really did not want to lose a league game this year. I told the boys we had three major goals. Get to playoffs, win league and [get a] playoff win. We're two out of three.

"I'm really excited where we're at, where we're going, our momentum and everything," he continued. "I'm really happy; I'm proud of them. They deserve it."

Cerritos, the 10th-ranked team in the CIF-Southern Section Division 4 poll, opened the scoring in the top of the first inning when sophomore second baseman Justin Sagun reached on the first of six

Red Lobster Looking For Buyer, Could File Bankruptcy

(CNBC)—Beleaguered seafood chain Red Lobster is seeking a buyer as it looks to avoid filing for bankruptcy.

The company has considered filing for bankruptcy to help it restructure its debt and get out of a number of costly and lengthy leases, but it's also sought a buyer in recent months.

At least one firm had been interested in buying the chain, but a deal never came to fruition.

It's unclear how the chain will ultimately resolve its financial woes. Red

Lobster could secure a buyer, it could declare bankruptcy or its lenders could take control of the company.

Even if Red Lobster finds a buyer, it would be hard for it to avoid filing for Chapter 11 as it is trying to get out of many leases and those contracts can be difficult to break outside of bankruptcy, the people said.

The longtime chain, known for its cheddar bay biscuits and unlimited shrimp, is looking for a new home at a time when capital is expensive and large restaurant groups are feeling cautious as the broader casual-dining segment lags.

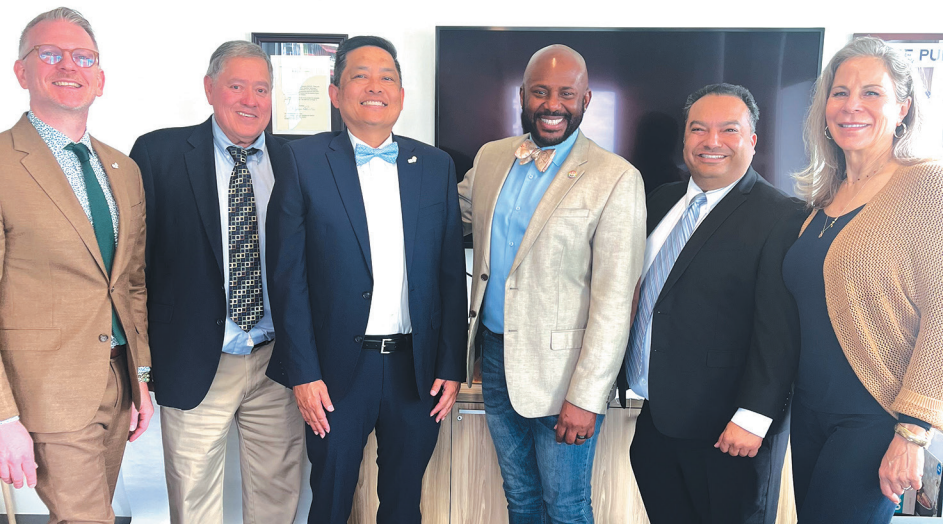

SCAG Board Visits Legislators in Sacramento

The Southern California Association of Governments Board visited Sacramento to this past week to advocate for its cities.

SCAG is a Joint Powers Authority under California state law, established as an association of local governments and agencies that voluntarily convene as a forum to address regional issues.

Under state law, SCAG is designated as a Regional Transportation Planning Agency and a Council of Governments.

The SCAG region encompasses six counties - Imperial, Los Angeles, Orange, Riverside, San Bernardino and Ventura- and 191 cities in an area covering more than 38,000 square miles.

Metro to Use AI-Cameras on Buses to Ticket Illegally Parked Vehicles

Los Angeles County Metropolitan Transportation Authority is getting some help to issue parking tickets to vehicle owners parked in bus lanes.

Artificial intelligence-powered cameras are being installed on Metro buses, according to the Los Angeles Times.

The program is meant to improve bus times, increase ridership and address mobility concerns.

"Blocking bus stop zones can create accessibility issues for passengers with disabilities, who rely on level boarding between the bus stop curbside and boarding the bus," Metro's board of directors said in a 2023 report.

Existing generative AI tools such as ChatGPT can help create ideas quickly. Similar technology could theoretically analyze traffic quicker than a human can to improve gridlock in real time.

After a parking violation occurs, it will be submitted to the L.A. Department of Transportation, where a person will determine whether or not a ticket should be issued.

Dig, Divide, and Boost Your Garden's Beauty

Overcrowded, poor flowering, and floppy perennials can be invigorated with a shovel and a bit of your time and energy. Dividing perennials is an excellent way to improve their appearance and create new plants to use in other spaces in your landscape.

As the old garden adage states "divide spring flowering perennials in late summer or early fall, divide fall bloomers in spring, and summer blooming perennials in either spring or fall." Some gardeners prefer to enjoy the spring blooms and divide soon after the flowers fade. Most gardeners have found the best time to divide is when they have the time and can provide proper post-transplanting care.

Reduce the stress on plants by dividing perennials on a cloudy, overcast day when the plants won't dry out so quickly. Make sure the plants are well-watered a day or two in advance of dividing.

Dig up the whole plant using a garden fork or sharp spade, like Corona Tools' DigMaster Nursery Shovel (coronatools.com), with its narrow, hardened steel blade. A shovel with a long handle and narrow blade makes it easier to access plants in small and hard-to-reach spots in the flower garden.

Carefully lift the plant out of the soil. Depending on the plant and the tenacity of its roots, you may be able to gently pull the roots apart with your hands. Otherwise, use a sharp spade or knife, such as a Hori Hori garden knife, or a reciprocating saw to cut the plant into smaller sections. Some gardeners place two garden forks back-to-back in the center of the clump and pull the forks apart to make the divisions.

Discard the dead center, if needed, in the compost pile. Make sure each division has at least three to five healthy shoots and adequate roots. The larger the division, the quicker it will fill in the space and possibly need dividing sooner than smaller divisions.

Replant the divisions as soon as possible. In the meantime, store them in a cool, shaded location and keep the roots covered and moist.

Prepare the soil before planting. You can plant one of the divisions in the original spot once the soil is amended. Use the others to fill in bare areas or start new garden beds. Dig a hole large enough to accommodate the roots. Plant the division at the same depth it was growing. Some gardeners set it slightly higher so it can settle in place. Either way, make sure the roots are not exposed and the crown, the part where the roots meet the stems, is not buried.

Gently firm the soil around the plant and water thoroughly. Check the soil moisture every few days and water deeply and often enough to keep the roots slightly moist. Reduce your watering frequency as the plant begins to develop a more robust root system.

Start by dividing just one or two overgrown plants. As you master the technique, you will find it easier to divide perennials when needed to keep your gardens looking their best.

errors and came home when senior third baseman Carter Chi singled to right field. In the next inning, Carter Senglaub, which would be a recurring theme, hit senior designated hitter Elijah Pannell, then fielded a bunt from senior catcher Jonathan Masella. But his throw to get Pannell out at second was late and after a sacrifice bunt from senior left fielder Noah Gapuz, a base hit to left from junior right fielder Braxton Reed made it 2-0.

The Patriots would take the lead in their half of the second without the benefit of a hit. Junior pitcher Christian Wright hit three batters, walked two with another reaching on an error. He would not get out of the inning after throwing 27 pitches in the inning.

"Christian has been great all year and he came out and it just wasn't his day," said Joyce. "That's the thing about a team, is we got to be able to step up in those situations. We went with [senior] Jack Lake and then [senior Johan] Gibbs, who I haven't pitched in a while because he's been having issues with command. I brought him in there and he did a great job."

The pitching change paid off as Lake faced four batters, threw 14 pitches and struck out one while Gibbs worked the final four frames, fanning nine batters and walking three while giving up Oxford Academy's only hit of the game. That would be a leadoff single to Elijah Spessert to begin the fifth.

While Gibbs and Lake were keeping the Patriots at bay, the Dons regained the lead in the top of the fourth on the strength of two more errors, a walk, and a sacrifice bunt. But the big blow came in the fifth when Cerritos sent a dozen to the plate, scored eight runs and collected four hits. Gapuz had a one-out, two-run double to the right field gap and junior shortstop Dalton Chi later had a two-out, bases-clearing double to right field. Cerritos would get just eight hits in the game with Gapuz, Gibbs and Reed all collecting two hits.

"Every pitcher we saw today, we saw on Tuesday," said Joyce. "That's a problem, for them. And we have computers; we can hit. I don't know, if you look at our [schedule], how many times we've scored over 10 runs. If we get opportunities like that where we're seeing a guy a second or third time, watch out, we're going to hit."

"When we get down early in a game, I honestly do not get worried because I know we're going to break one open," he continued. "We hit that way, our offense is deep, and we have a ton of speed. Speed kills."

Cerritos and Oxford Academy have clearly been the cream of the crop since the league was formed prior to the 2019 season. The Patriots have finished no worse than second place and the teams have faced each other on the last week of the regular season three times. Before the 605 League, both teams had been in the middle of the pack in the Suburban League and Academy League, respectively, for the three to four years before moving to the new league.

"Honestly, they might have two of the best coaches in the league," said Joyce. "Those guys know the game. They played the game at a high level, and they got their boys coached up. Like I told you earlier, and I know I probably rubbed some people the wrong way, we're far more talented than every team in this league talent-wise. But [Oxford Academy] is coached up and they're really good."

After hosting Pioneer on Apr. 25, the Dons will finish the regular season the same way they began it on Feb. 10 by going to Valley Christian High. In the season opener, Cerritos blanked the Defenders 7-0 as they scored twice in the bottom of the fifth and three times in the next inning as Gibbs picked up the win.

"We're not going to change much," said Joyce. "I will probably try to get some guys in that have worked real hard, but we're going to run out with our starting nine."

Southeast Gateway Line Clears Final Hurdle Before Construction

Metro Board certifies final Environmental Report for Phase 1 of 19-mile line through Southeast LA and Gateway Cities.

Yesterday, the LA Metro Board unanimously certified the Final Environmental Impact Report (EIR) for the first segment of the future Southeast Gateway Line.

With the certification, the 14.5-mile segment of the project can now move on to the construction phase, expected to begin by the end of 2024.

When completed, the 19-mile Southeast Gateway Line will serve 1.4 million residents between Union Station in Downtown LA and Artesia, running through Vernon, Huntington Park, Bell, Cudahy, South Gate, Downey, Paramount, Bellflower, and Cerritos.

"No more waiting and wondering, this project will go forward," said Supervisor and Metro Board Vice Chair Janice Hahn, who represents the region.

"The era of Southeast LA and the Gateway Cities being left behind by new

Metro rail projects is over. The cities along the line are ready, future riders are ready, and now we can finally get to work building this transformational project,"

The 14.5-mile phase of the project that can now begin construction covers the line's segment between the A Line's Slauson Station and Artesia, and will have eight stations.

44% of residents along the line live

below the poverty level. Construction and operation of the Southeast Gateway Line will create between 37,000 to 46,000 jobs and generate \$5 billion per year in economic activity for the region.

This \$7.1 billion project is Metro's top priority for federal funding.

Certification of the Final EIR brings the agency one major step closer to federal funding to go along with over \$2

billion in local and State funds already committed to the project.

Every city along the Southeast Gateway Line has entered into a Master Cooperative Agreement with Metro, showing their support for the project and desire to get it built as soon as possible. Several local elected officials from those cities attended the Metro Board meeting today and expressed support for the project:

Artesia Mayor Ali Taj stated, "Many of our residents will depend on the Southeast Gateway Line to move around, and I look forward to welcoming visitors from across our region to Artesia. I've been on board since day one and we are more than ready to finally get to work in collaboration with Metro to get this line built."

"This community has been long waiting for rail transportation equity and this a big step today for that to happen. Southeast Gateway Line signifies new job and educational opportunities, and it will change the lives of many in our cities." - Karina Macias, Mayor of Huntington Park.

"I represent over 100,000 people, and I can tell you that this project will be an impactful line. As a city we are there to support this project." - Maria Davila, Vice Mayor of South Gate.

In 2008, Cerritos received the nation's oldest and most prestigious award, being named an All-America City by the National Civic League.

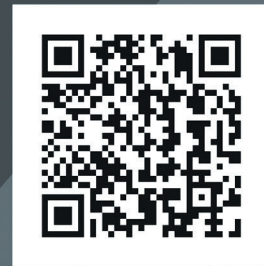

NORWALK WASTES BANDA'S STELLAR PITCHING PERFORMANCE AS PARAMOUNT WINS MID-CITIES LEAGUE

When the Norwalk High softball team won the Mid-Cities League last season, it was the first outright league title in over 25 seasons for the Lancers. After sharing the Suburban League crowns in 2009 and 2016, Norwalk needed a win over Paramount High last Thursday to ensure a share of the Mid-Cities League's top spot.

But Clarissa Noriega outdueled senior Jalynn Banda in the circle, limiting the Lancers to just three hits, tied for the third worst offensive output of the season, in a 3-0 shutout. The win gave the Pirates their first league title since 2004 when they won the San Gabriel Valley League with a 9-1 mark. The previous season, Paramount tied Warren High for first place in the SGVL at 8-2.

"They're a great team," said Norwalk head coach Fred Perez. "They came out and handled their business. They have a great group out there."

"We're super excited," said Paramount head coach Rocky Colenzo. "This is the first time we've won [a] league [title] in a lot of years. We have a very young and talented team that just came out and played their heart out today. They knew what was on the line; they knew they had to come out and beat Norwalk in their own house, and it's really tough to play here with the music and the turf. We faced one of the best pitchers in the league. She's the pitcher of the year and we were able to score three runs on her."

Paramount had edged the Lancers 4-3 on Mar. 26, ending Norwalk's 12-game winning streak in Mid-Cities League action and 14 overall dating back to when the Suburban League was still around.

Norwalk began the final week of the regular season two games back with two to play.

Banda began the game retiring the first seven batters she saw before Mia Flores reached on an infield single. The Pirates thought they had something going when a sacrifice bunt from Valeria De La O resulted in her reaching on an error with two on and one out. But Banda struck out Leah Magana and got Alice Quiroa to hit into a fielder's choice to end that threat. However, Norwalk wouldn't be as fortunate in the top of the fourth inning.

Jasmin McHenry led off with a triple to the left field gap and Banda walked Laritza Esparza on a seven-pitch at-bat. After striking out Noriega, a groundout from Daniela Flores plated McHenry and the only run needed in the contest. Banda would strikeout the next three batters and four of the next five before running into more trouble.

She walked McHenry with one out in the sixth and served up a single to Esparza. Both would steal their respective bases and after striking out Noriega again, Banda walked Flores to load the bases. But Abbey Sotelo reached on a throwing error on a 1-2 count, allowing McHenry and Esparza to account for some insurance.

Offensively, Norwalk was unable to do much as five runners reached base with only one of them getting to third base. With one out in the bottom of the first, Noriega walked senior shortstop Amarie

Encarnacion, who stole second. But the Paramount hurler would strikeout the next three she faced and retired four straight before senior third baseman Kendall Nakano blooped a double in front of the right fielder.

Noriega sat down another eight in a row before hitting Nakano with one out in the sixth but responded with three straight strikeouts. With two outs in the last inning, junior catcher Jezrael Acosta doubled to the left field gap and sophomore second baseman Jaslene Pelayo singled to center. But on the play, McHenry threw a perfect strike to Quiroa who tagged Acosta at home plate on a close call to end the game.

"The last two to three weeks, all we've been practicing is running first to third [and] second to home," said Perez. "I was confident in her; I sent her, and I thought it was a good opportunity to get that first run on the board. But the call didn't go our way."

Still, the story of the game was in the circle. Noriega needed 88 pitches to strikeout nine, walk one and give up three hits while Banda labored throughout the game but still struck out 15 batters, allowed four hits and walked three. She threw a first-pitch strike 16 times and came back from falling behind 2-1 to strikeout four batters early in the game.

"It was a great pitching duel," said Perez. "On our end, we had to make sure we put the ball in play; we had to get hits. It's hard to score anything if you're not

getting people on base.

"She pitched like she usually does," he later said. "Paramount did a great job laying off those two-strike pitches. They had long battles with her; they made her pitch a lot of extra pitches. But Paramount did great job at the plate. I'm very proud that I was able to coach her. I've seen her from her freshman year all the way to her senior year and just seeing her develop during those years has been amazing. I haven't seen anybody with that many pitches and able to execute them."

"We had a gameplan coming in; we've faced these hitters for years and we know their swings," said Colenzo. "[Noriega] was trying to keep the ball down and away; not giving them too much to hit, and she's just got ice in her veins. She's a very seasoned pitcher and came out and pitched her heart out."

Norwalk bounced back to defeat Bellflower High 13-3 this past Tuesday to improve to 17-7, 7-2 and went to Dominguez High on Apr. 25 to end the regular season. The CIF-Southern Section playoff brackets will be released on Saturday morning and Division 4 postseason play begins on Tuesday with wild card action and Thursday with first round action. Norwalk lost at home in the first round last season but advanced to the quarterfinals in 2016, 2018 and 2022. The Lancers would need to win twice in the playoffs to record just the second 20-win season in program history.

"It was a good season," said Perez. "Our goal is to make sure we finish up our two games with wins. But we had some injuries and we had other key players who were lost, too. We're just trying to make up for putting players in different positions where they don't usually play."
